# W ave function statistics and multifractality at the spin quantum H all transition

The statistical properties of wave functions at the critical point of the spin quantum H all transition are studied. The main emphasis is put onto determination of the spectrum of multifractal exponents  $_{q}$  governing the scaling of moments hj  $\hat{f}^{q}$ i L  $^{qd}$   $^{q}$  with the system size L and the spatial decay of wave function correlations. Two- and three-point correlation functions are calculated analytically by means of mapping onto the classical percolation, yielding the values  $_{2} = 1=4$  and  $_{3} = 3=4$ . The multifractality spectrum obtained from numerical simulations is given with a good accuracy by the parabolic approximation  $_{q}$ ' q(1 q)=8 but shows detectable deviations. We also study statistics of the two-point conductance g, in particular, the spectrum of exponents X  $_{q}$  characterizing the scaling of the moments hg<sup>q</sup>i. Relations between the spectra of critical exponents of wave functions (  $_{q}$ ), conductances (X  $_{q}$ ), and G reen functions at the localization transition with a critical density of states are discussed.

I. IN TRODUCTION

In the fram ework of the random matrix theory pioneered by W igner [1] and D yson [2], the statistical properties of spectra of complex systems are described by random matrix ensembles. W ithin the D yson's classi cation, three symmetry classes are distinguished (orthogonal, symplectic, and unitary), depending on whether the system is invariant under the tim e-reversal transform ation and on its spin. It has been understood that this classi cation is very general and applies to a great variety of physically distinct systems (see [3] for a recent review).

W hile the Dyson's classi cation is complete for the bulk of the spectrum, more symmetry classes may arise in the vicinity of a special point on the energy axis. Such non-standard symmetry classes have attracted a considerable research attention during the last decade. One group of them is formed by three chiral ensembles [4] describing the spectrum of a massless D irac operator near zero energy. The same symmetry is shared by tight-binding models with purely o -diagonal disorder at the band center [5]. More recently, four more symmetry classes were identi ed [6], which characterize a dirty superconductor or a m esoscopic superconductor-norm al metal system. The Hamiltonian matrix has in this case an additional block structure in the particle-hole space induced by the form of mean-eld Bogoliubov-de Gennes equations for a superconductor. It was argued [7] that the extended classication scheme including 10 classes (three W igner-D yson, three chiral, and four Bogoliubovde Gennes) is com plete.

The classi cation of random matrix ensembles can be equally well applied to disordered electronic systems. In particular, two-dimensional systems of non-standard classes are of large interest, in view of their relevance to high- $T_c$  superconductors, which have an unconventional (d-wave) symmetry of the order parameter and therefore

possess low-energy quasiparticle excitations. In this paper, we will consider a system of class C, which is the Bogoliubov-de Gennes class with broken time-reversal but preserved spin rotation invariance. The corresponding Ham iltonian satis es the symmetry  $H = _{y}H_{y}$  (with  $_{y}$  the Paulim atrix in the particle-hole space) and has the block structure

where  $h = h^y$  and = <sup>T</sup>.

Similarly to the conventional W igner-D yson unitary class, a two-dimensional system of class C undergoes a transition between the phases with dierent quantized values of the Hall conductivity [8{10}]. More precisely, since the quasiparticle charge is not conserved in a superconductor, one is led to consider the spin conductivity determ ining the spin current as a response to the gradient of the Zeem an magnetic eld. The quantization of the Hall component of the spin conductivity tensor was named the spin quantum Hall (SQH) e ect. It was shown [9] that the SQH e ect can be realized in superconductors with  $d_{x^2} = y^2 + id_{xy}$  pairing symmetry explored in recent literature [11].

W hile the SQH transition shares many common features with its norm al counterpart, it is qualitatively different as concerns the behavior of the density of states (DOS) at criticality: while the DOS is uncritical for the conventional quantum Hall (QH) transition, it vanishes at the SQH critical point. A network model describing the SQH transition was constructed in [8], and critical exponents for the scaling of the localization length were determ ined num erically. In [9] a mapping onto a supersymmetric spin chain was performed, providing an alternative m ethod for the num erical study of the critical behavior. Remarkably, som e exact analytical results for this problem have been obtained by mapping onto the classical percolation [10,12,13]. Speci cally, it was found  $^{1=7}$ , while the average that the DOS scales as ()

It is known that critical wave functions at the conventionalQH transition have multifractal nature [14,15]. Recently, there has been a grow th of activity in the direction of quantitative characterization of the corresponding spectrum of fractal dimensions [16{20]. Zimbauer [17] and B haseen et al. [18] proposed a certain supersymm etric -m odel with a Wess-Zum ino-Novikov-W itten term (in two slightly di erent versions) as a candidate for the conform all eld theory of the QH critical point. The theory implies an exactly parabolic form of the multifractality spectrum. This was con immed by a thorough num erical study of the wave function statistics at the QH transition [20].

The aim of this paper is to study the wave function statistics at the SQH critical point. We will dem on strate that the exponents  $_2$  and  $_3$  governing the scaling of the second and third m om ents of the wave function intensity (see Sec. II for the form alde nition) can be calculated exactly by analytical means. Quite surprisingly, we 2 characterizing the spatial nd that the index = decay of the wave function correlations is equal to 1=4, in contrast to the r<sup>1=2</sup> decay of the di usion propagator. This leads us to a general analysis of relations between di erent critical exponents characterizing the wave function statistics in the qualitatively new situation of the localization transition with a critical DOS.We com plem ent our analytical results by num erical sim ulations, which allow us, in particular, to investigate whether the multifractality spectrum of the SQH critical point is exactly parabolic or not. The answer to this question, as well as the exact values of  $_2$  and  $_3$  we have found, is of central in portance for identi cation of conform altheory of the SQH transition, which is the issue of a considerable research interest at present [21{23]. Som e of our results were reported in a brief form in [24].

The article is organized as follows. In Sec. II we rem ind the reader of som e basic concepts related to the multifractality of critical wave functions. In Sec. III we describe the network model of class C and use it to calculate num erically the DOS at the critical point of the SQH transition. In Sec. IV we present an analytical calculation which involves a mapping onto the percolation theory and allow sus to calculate the averages of products of two and three G reen's functions and thus the exponents  $_2$  and 3. Section V is devoted to a num erical evaluation of the full multifractal spectrum . This allows us not only to check the analytical results of Sec. IV but also to investigate whether the spectrum is exactly parabolic (as for the conventional QH critical point) or not. In Sec.VI we present a num erical study of statistical properties of the two-point conductance. W e further include a scaling analysis of the relation between the multifractal spectra

of the two-point conductance and of the wave functions at a critical point with a vanishing DOS. These analytical arguments clarify the connection between the numerical ndings of Sec. VI and the results of Sec. IV, V on the wave function multifractality. Finally, Sec. VII contains a summary of our results and a brief discussion of some remaining open problem s.

# II. WAVE FUNCTION MULTIFRACTALITY IN SYSTEMSWITH NON-CRITICAL DOS

Multifractality of wave functions (r) is known to be a halm ark of the localization transition. It has been extensively studied in the context of conventional Anderson and quantum Hall (Q H) transitions with non-critical DOS (see [14,15,25] and references therein), and we rem ind the reader of som e basic results. Multifractality is characterized by a set of exponents

A nom alous dimensions q distinguish a critical point from the metallic phase and determine the scale dependence of wave function correlations. Among them,

 $_2$  plays the most prom inent role, governing the spatial correlations of the \intensity" j  $\hat{f}$ ,

Equation (4) can be obtained from (3) by using the fact that the wave function am plitudes become essentially uncorrelated at jr  $r^0$ j L. Scaling behavior of higher order spatial correlations, hj  $^{2q_1}(r_1) \, ^{2q_2}(r_2) ::: \, ^{2q_n}(r_n)$  ji can be found in a similar way. Correlations of two di erent (but close in energy) eigenfunctions and the di usion propagator  $(r;r^0;!) = hG_{E+!}^R(r;r^0)G_E^A(r^0;r)i$  (G<sup>R</sup>;<sup>A</sup> are retarded and advanced G reen functions) possess the sam e scaling properties,

where  $! = i_{j}$ ,  $L_{!}$   $(!)^{1=d}$ , is the density of states, and  $\dot{r}$   $r^{0}j < L_{!}$ . In two dimensions the multi-fractal spectrum  $_{q}$  plays a key role in the identication of the conformal eld theory governing the critical point, which led to grow ing interest in the eigenfunction statistics at the QH transition [16{20}].

Applying naively these results to the SQH transition, one would conclude that the r  $^{1=2}$  scaling of the di usion propagator found in [10] im plies = 1=2. How ever,

we show below that this conclusion is incorrect. This dem onstrates that one should be cautious when trying to apply the relations between critical exponents obtained for system s with a non-criticalDOS to those with a critical one (like the SQH transition), as will be discussed in Sec. IV C and Sec.VI.

# III.NETW ORK MODEL AND THE DENSITY OF STATES

As a model of the SQ H system, we use the SU (2) version [8] of the Chalker-Coddington network describing the QH transition [26]. Dynamics of the wave function de ned on edges of the network is governed by a unitary evolution operator U. At each node of the network the scattering from two incoming into two outgoing links is described by a matrix

with = =4 corresponding to the critical point. Each realization of the network is characterized by a set of random 2 2 spin matrices  $U_e$  associated with alledges e of the network. In view of (1), U satis es the sym - metry U =  $_yU_y$ , implying that  $U_e$  2 SU (2). Diagonalizing U for a square network of the size L L yields  $4L^2$  eigenfunctions  $_i$  (e) and eigenvalues e  $^{i_i}$ , where  $i = 1;2;:::;4L^2$  and = 1;2 is the spin index.




FIG.1. Scaling plot of the density of states for system sizes L = 16();32(2);96(). Dashed and dotted lines indicate power laws (dashed:  $^{1=7}$ , dotted:  $^{2}$ ), = 1=2 L  $^{7=4}$  denotes the level spacing at = 0. Inset: same data on a linear scale and the result from the random m atrix theory [6] (solid curve).

We begin by displaying in Fig.1 the num erically calculated DOS () for di erent system sizes L. It is seen

that after a proper rescaling all data collapse onto a single curve. Speci cally, the energy axis is rescaled to =, where / L  $^{7=4}$  is the level spacing at = 0. (This scaling of is related to the critical behavior 1=7 discussed below via the condition ofDOS ()  $1=L^2$ .) The scale invariance of () at critical-() ity is rem in iscent of the analogous property of the level statistics at the conventional Anderson or Q H transition (see [25] for a review). At the critical DOS scales  $^{1=7}$ , in agreem ent with analytical predictions as () [10]. On the other hand, at one observes an oscillatory structure qualitatively analogous to the behavior found in the random matrix theory (RMT) for the class C [6].

Let us note that, strictly speaking, deviations of DOS from the RMT at are not param etrically sm all. On the other hand, the num erically found DOS follows very closely the RMT curve for two oscillation periods. In other words, the energy scale below which the RMT works (the e ective Thouless energy), while being parametrically of order , turns out to be several times larger. This indicates that there is a num erical sm allness in the problem, and the SQH critical point shows \close-to-m etal" features (sim ilar to the Anderson transition in 2 + dim ensions with sm all ). The sm all value 1/7 of the DOS exponent is another manifestation of the same fact.

The states with energies are localized with the localization length 4=7 [10]. For sm allest energies the correlation length is of the order of the system size. In view of their critical nature, these states are expected to be multifractal,  $L^{2q}hj_i$  (e)  $j^{2q}i$  L q. For

the multifractality holds within a region of the extent (outside which the wave function is exponentially sm all); hence

By the same token, spatial correlations are expected to be governed by the multifractality on scales below  $\cdot$ . In particular, we have for correlations of two di erent eigenfunctions with energies i; j

(r is the distance between e and  $e^0$ ), and similarly for higher-order correlators. In Sec. IV and V we will dem onstrate the multifractality explicitly and calculate the exponents  $_{\rm q}$ .

# IV.TWO-AND THREE-POINT CORRELATION FUNCTIONS:MAPPING ONTO PERCOLATION PROBLEM

In this section, we present an analytical calculation of two-point and three-point correlation functions, which

allow s us to nd the fractal dimensions  $_2$  and  $_3$ . We use the mapping onto the classical percolation, follow-ing the approach of [13], and demonstrate that it can be extended on products of two and three G reen's functions.

#### A.Two-point functions

Consider a correlation function of two wavefunctions,

where e,  $e^0$  are two di erent edges of the network. Introducing the G reen function

where  $G_{R;A}$  are retarded and advanced G reen functions,  $G_{R;A}$  ( $e^{0};e;e^{i_{1}}$ ) = G ( $e^{0};e;e^{i_{(1 \ i0)}}$ ). We will calculate (10) at zero energy, 1;2 ! 0, but nite level broadening,

A s discussed in the end of Sec. III, the scaling behavior of (11) and (13) at r (where r is the distance between e and e<sup>0</sup>) is governed by the multifractal properties of wave functions (speci cally, by the exponent <sub>2</sub>). The general strategy of calculation of the correlation functions (11), (13) is analogous to that used in [13] for the one-point function TrG (e;e;z). Therefore, we outline only brie y those steps which generalize directly the calculation in [13], and concentrate on qualitatively new aspects.

The G reen functions in (11), (13) are straightforwardly represented in the form of a sum over paths

where  $s_j$  is the corresponding matrix element (cos, sin, or sin) of the S-matrix between the edges  $e_j$  and  $e_{j+1}$ . Equation (14) generates a convergent expansion in powers of z when jzj < 1; otherwise the identity

is to be used (in all our calculations z is real, so that z = z). As shown below, each of the double sum s over paths obtained by substituting (14), (15) in (11) or (13) can be reduced to a single sum over classical paths (hulls) in the percolation problem. This remarkable reduction crucially relies on the following two statements:

- Only paths visiting each edge of the network either
   O or 2 tim es are to be taken into account; contributions of all the remaining paths sum up to zero,




FIG.2. Possible con gurations of paths passing four times through a network node. The symbols c and  $\,$ s denote the elements  $\cos^2$ ,  $\sin^2$  of the S-matrix at the node.

- 2. Using the statem ent 1, it is easy to see that each node m ay be visited 0, 2, or 4 times. The second statem ent concerns the nodes visited four times. A sillustrated in Fig. 2, there are three possibilities how this m ay happen; the corresponding contributions have weights (i)  $\cos^4$ , (ii)  $\sin^4$ , and (iii)  $\sin^2 \cos^2$  from the scattering matrix at this node. The statement is that one can equivalently take into account only the contributions (i) and (ii) with the weights  $\cos^2$  and  $\sin^2$ , respectively.

In Ref. [13] both statements were proven for the case of the average of a single G reen function hG (e;e;z)i. W e show below that they are valid for all the two-point functions entering (11), (13), as well as for averaged products of three G reen's functions (considered in Sec. IV B). Let us emphasize that such a generalization is far from trivial. This point is well illustrated by the fact that products of four (or m ore) G reen functions determining the exponents  $_{\rm q}$  with q = 4;5;::: can not be m apped onto the percolation within our approach (see Sec. IV C and Appendix).

W e now proceed by proving the statem ent 1. It is convenient for us to recall rst the corresponding proof for the case of a single G reen function, hTrG (e;e;z)i, considered in [13]. For an arbitrary edge f the paths entering (14) can be classified according to the number k of times they pass through f. The contribution of paths with  $k \in 0$  has the form

where  $B_1$  is a sum over all paths going from f to e and then from e to f, and A (f;f) denotes a sum over paths which begin and end on f and do not return to f in between. Since A (f;f) is a linear combination of SU (2) matrices with real coe cients, it can be represented as A (f;f) =  $\frac{1}{4}$  (f;f)  $\frac{1}{4}$  (f;f), where A (f;f) 2 SU (2) and  $\frac{1}{4}$  (f;f) j is a real number. Substituting (19) in (17), one nds that only the term with k = 2 survives, which completes the proof of the the statem ent 1 for the case of an average of one G reen function.

(we will need below both cases  $e^{00} = e^0$ ,  $e^{000} = e$ , and  $e^{00} = e$ ,  $e^{000} = e^0$ ). Using (14), we classify the contributions to (20) according to the numbers of returns  $k_1$ ,  $k_2$ 

to the edge f for the corresponding two paths. W e want to show that only the contributions with  $k_1 + k_2 = 0$ ; 2 are to be taken into account. If one of  $k_i$  is zero, the proof is obtained in the same way as for a single G reen function (see above). We thus consider the remaining contributions, which are of the following form :

The only property of the factors  $b_1$ ,  $b_2$  which is important for us at this stage is that they are independent of  $k_1$ ,  $k_2$ . The sum (22) is therefore reduced to the form

W hile the set term in brackets is non-zero only for  $k_1 + k_2 = 2$  (i.e.  $k_1 = k_2 = 1$ ) as required, the second one seems to spoil the proof. Let us perform, however, a summation over  $k_1$  at xed  $k_1 + k_2 = k$ . Using Eq. (19), we nd then that the coe cients in the second term cancel for any even k = 4 (for odd k all terms are trivially zero):

Applying now the statem ent 2, the proof of which is given in Appendix, we represent each node as a superposition of contributions of the types (i) and (ii) (Fig. 2) with weights  $\cos^2$  and  $\sin^2$ , equal to 1/2 at the SQ H critical point. The network is then reduced to a weighted sum over all its possible decompositions in a set of closed loops (such that each edge belongs to exactly one loop). These loops can be viewed [10,13] as hulls of the bond percolation problem. Non-zero contributions to the correlation function (20) come from pairs of paths retracing exactly twice a loop or a part of it. This yields for z < 1

The key role in the calculation of (46) and (47) is played by the proofs of applicability of the statements 1 and 2 (Sec. IV A) to the products of three G reen functions. #### ${\tt C}$ . ${\tt D}$ iscussion

The situation we encountered while calculating twoand three-point functions is qualitatively di erent from what happens at conventional localization transitions. Speci cally, in the conventional case average products of only retarded or only advanced G reen functions are negligible compared to mixed averages containing both  $G_R$  and  $G_A$ , e.g.  $hG_RG_Ri$ ;  $hG_AG_Ai$ hG<sub>R</sub>G<sub>A</sub>i. For this reason, the wave function correlators, which are proportional to  $h(G_R G_A)$  ( $G_R G_A$ ) i, are determined by hG<sub>R</sub>G<sub>A</sub>i (and sim ilarly for higherm om ents). In contrast, we have found in the SQH case that the correlators of the hG<sub>R</sub>G<sub>R</sub> i (or hG<sub>A</sub>G<sub>A</sub> i) type are approximately equal to  $hG_RG_A$  i and cancel it in the leading order (so that  $h(G_R G_A)(G_R)$  $G_A$  ) i scales di erently). E valuation of three-point functions m ade the overall picture even m ore com plex: while we obtained again an identical scaling of, say,  $hG_RG_RG_R$  i and  $hG_RG_RG_A$  i correlators, this time the cancelation was not complete, and the correlation function h(G  $_{\rm R}$   $\,$  G  $_{\rm A}$  ) (G  $_{\rm R}$   $\,$  G  $_{\rm A}$  ) (G  $_{\rm R}$   $\,$  G  $_{\rm A}$  ) is called in the sam e way.

To shed more light on the reason for these di erent types of scaling behavior, it is instructive to reverse the logic and to exam ine how the di uson scaling (32) can be obtained from wave function correlations (35). (5). On the other hand, Eq. (60) has a familiar form of a two-point correlator in a conform al eld theory (or, more generally, in ekd-theoretical description of standard critical phenom – ena), where hO<sub>i</sub>(r<sub>1</sub>)O<sub>i</sub>(r<sub>2</sub>) i scales as jr<sub>1</sub>  $r_2 j^{2x_1}$ , with x<sub>i</sub> being the scaling dimension of the operator O<sub>i</sub>.

For larger q, when qx +  $_q < 0$ , the energy integrals are dom inated by the vicinity of = 0. Consequently, the correlation functions  $_{s_1;...,s_q}^{(q)}$  start to depend in a singular way on the infrared cuto () and are expected to scale in the same way as D  $^{(q)}$ , Eq. (63) (with a num erical prefactor depending on indices  $s_i$ ), similarly to the conventional Anderson localization transition.

The value of q separating the two regimes is thus determ ined by the equation qx + q = 0. For the SQH transition (x = 1=4) its solution is, in view of Eq. (57), q = 3. Rem arkably, this is also the largest value of q for which the mapping onto percolation described above still. works (see Appendix). We believe that this is not a mere coincidence. Indeed, within this mapping average products  $s_1^{(q)}$  of G reen functions are expressed in terms of probabilities of the percolation theory, and are therefore 1. On the other hand, Eq. (63) of order unity for r yields, in the regime qx + q < 0, a result which is much larger than unity at r 1, 1 and diverges in the absence of the infrared cuto, ! 1.Wesee no way how such a behavior might be produced by the percolation theory.

F inally, we discuss a relation between our consideration and the eld-theoretical approach to the wave-function multifractality [29{32,18,23]. In the renormalizationgroup language, (q) de ned by Eq. (64) are scaling dimensions of operators of the type O  $^{(q)}$

To calculate the scaling behavior of such correlation functions, one applies the operator product expansion (OPE) [30{32]. Generically, the identity operator will be am ong those generated by the OPE. M oreover, under the condition (q) > 0 [Eq. 64)] it will be the most relevant operator and will dom inate the expansion, leading to the gap scaling  $^{(q)}$  r  $^{q}$   $^{(1)}$ , in agreem ent with (65). On the other hand, if (q) < 0, the operator O  $^{(q)}$  will give a dom inant contribution to OPE, leading to a multifractal type of scaling,  $^{(q)}$  / r  $^{q}$   $^{(1)}$  (r= )  $^{(q)}$ , as in Eq. (63). W hat is, how ever, non-trivial from this point of view, is that the scaling of the wave function correlator (61) has the multifractal form (63) independently of the sign of (q). This means that in the regime (q) > 0 the leading (gap scaling) terms (65) cancel in the particular combination of the functions  $^{(q)}$  corresponding to D  $^{(q)}$ , and subleading terms determ ine the result (63). A sin i-lar cancellation of leading scaling terms in the context of classical percolation was recently discussed in [28].

#### V.WAVE FUNCTION STATISTICS: NUMERICAL RESULTS

## A . M ultifractality spectrum

The analytical treatment of Sec. IV yielded results for the anomalous dimensions at two distinct values of q,  $_2 = 1=4$  and  $_3 = 3=4$ . In order to obtain more complete information about the wave function statistics, namely the multifractality spectrum at arbitrary q, we have performed numerical simulations. A question we are particularly interested in is whether or not the spectrum is exactly parabolic. A denite answer on this question will imply, along with exact values of  $_2$  and  $_3$ , an important constraint on the conform altheory of the critical point, which is a subject of current research [21{23].

Before we come to the presentation of our ndings, we give a few remarks about technical aspects of our num erics. We compute wave functions by num erically diagonalizing the 4L<sup>2</sup> 4L<sup>2</sup> unitary time evolution operator U of the Chalker-Coddington network described in Sec. III. U sing advanced sparse m atrix packages [33], we selectively calculate only states with energies in the vicinity of = 0, which are critical over the whole ex-L). Speci cally, we consider, for tent of the system ( each realization of the network, four lowest eigenstates (i.e. with eigenvalues e i closest to unity). The num ber of wave functions in a statistical ensemble we obtain this way ranges from about  $10^7$  for L = 16 to 2 1<sup>4</sup>0 for L = 384.

To determ ine the multifractality spectrum  $_{\rm q}$ , we calculate for each wave function  $_{\rm i}$  the generalized inverse participation ratio (PR)

and analyze the scaling of the average  $h^{\rm p}{}_{\rm q}{\rm i}$  with the system size L . The data can be tted very wellby the power law




FIG.3. Scaling of the average IPR with the system size L for several values of q = 0.5(), 1.5(3), 2(M), 2.5(/), 3(0), 3.5(.), 4(). The system size dependence of the amplitude  $c_q$  (L)  $hP_qi(2L)^q$  is presented, with q = 2(q = 1) + q shown in Fig.4. The scattering of the data is due to the lim – ited size of the statistical ensemble used. The solid line is a guide to the eye corresponding to the vanishing of nite size corrections ( $c_q$  (L) = const).

To demonstrate this, we show in Fig. 3 the system size dependence of  $hP_{qi}(2L)^{q}$ , with  $_{q}$  obtained from the t. The plot is organized in such a way that a pure power law (68) would correspond to a horizontal line. This kind of plot is very sensitive to any corrections to a pure power-law behavior of  $hP_{qi}$ . Since no system atic curvature is observed, corrections to scaling are extrem ely sm all. This allow sus to determ ine the anom alous dimensions  $_{q} = _{q} + 2(1 - q)$  with great accuracy.




FIG.4. Upper panel: A nom alous dimension  $_{\rm q}$  (solid line) describing the scaling of the average IPR hP<sub>q</sub>i. The functional form  $_{\rm q}=q(1 \ q)$  highlights the deviation from exact parabolicity (69) indicated by the dashed line. The circles correspond to the exponent  $\sim_{\rm q}$  obtained from the scaling of the typical value P<sub>q</sub><sup>typ</sup>.

The obtained results for  $_q$  are shown by a solid line in the upper panel of Fig. 4. We choose to plot  $_q=q(1 \quad q)$ , since this would give a constant for an exactly parabolic spectrum, which is uniquely determ ined by ,  $_q = q(1 \quad q)=2$ . A coording to our analytical calculations (Sec. IV),  $_q=q(1 \quad q)$  is equal to 1/8 for both q=2 and q=3; this value is marked by the dashed line in the gure. It is seen that the num erical results agree perfectly well with the analytical ndings at q=2 and q=3. Furtherm ore, the parabolic dependence may serve as a num erically good approxim ation in the whole range ofqwestudied,

N evertheless, we believe that Eq. (69) is not exact. Indeed, at 0 < q < 2 the num erically found  $_q$  show clear deviations from exact parabolicity (69), which are of the order of 10% near q = 0. Since this is precisely the regime in which nite-size e ects have been found to be very weak and  $_q$  was determ ined with a high accuracy, we interpret the observed deviations as very strong evidence for nonparabolicity of the exact multifractal spectrum of the SQ H transition. In particular, the deviation of the limiting value  $_q=q(1 \quad q)\dot{q}_{1\ 0} = 0.137 \quad 0.003$  from 1/8 well exceeds the estim ated num erical uncertainty.

W e also calculated typical inverse participation ratios,  $P_q^{typ} = explin P_q i$  and the corresponding dimensions  $\sim_q 2(q 1) + \sim_q .^3$  It follows from the general analysis of the wave function multifractality [34] that  $\sim_q = -q$  for

 $<sup>^3</sup>$  In our earlier publications [34,20,36] we used the symbol  $_q$  to characterize the scaling of the typical value  $P_q^{\rm typ}$ , and  $\sim_q$  for the average hPqi. In the present paper we have chosen to interchange the notations.

 $q_r$ , where  $q_c$  corresponds to the zero of the singua larity spectrum f() (de ned below). In the present case we nd from the  $_{q}$  data  $q_{c} = 3.9$  0.1 (the parabolic approximation (69) would imply  $q_c = 4$ ). For  $q > q_c$ the average hPgi is determined by rare realizations, and  $_q$  <  $\sim_q$ . Furtherm ore, already for q sm aller than but close to  $q_c$ , nite-size corrections to  $P_q^{typ}$  become large [20], leading to large errors in determ ination of  $\sim_{\rm q}.$  For the SQH problem, we nd that the scaling of  $P_{\alpha}^{typ}$  exhibit small nite-size corrections as long q 2:5, so that the corresponding exponents  $\sim_q$  can be found with a high accuracy. The results are shown by circles in Fig. 4 (upper panel) and are in full agreem ent with the values of  $_{\rm q}$  obtained from the scaling of hP $_{\rm q}$ i. For larger q (q 3) the nite-size corrections to  $P_{\alpha}^{typ}$  (which we estimate to L<sup>y</sup>with y be 0:4) becom e appreciable, strongly reducing the accuracy of determ ination of  $\sim_{\alpha}$ .

The lower panel of F ig. 4 depicts the singularity spectrum f() obtained by a numerical Legendre transform of the scaling dimension  $_q$ ,  $f(_q) = q_q _q$  with  $_q = d_q$ =dq. The dashed line represents the parabolic approximation corresponding to (69),

W e see again that the parabolic approximation is numerically rather good; nevertheless, it is not exact. Deviations from (70) are demonstrated in the inset which shows an enlarged view of a region around the maximum  $_0$  of f(). The deviation of  $_0$  2 = 0.137 0.003 from 1/8 corresponds to non-parabolicity of  $_{\rm q}$  discussed above.

# B.IPR uctuations




FIG. 5. Distribution function P  $(\ln P_2)$  for system sizes L = 16;24;32;48;64;96;128;192;256;384 (from right to left). For values of L large enough, the form of the distribution becomes independent of L. Inset: W idth  $_2$  (L) =  $h(\ln P_2 \quad h\ln P_2 i)^2 i^{1-2}$  of the distribution P ( $\ln P_2$ ) versus the system size L. Some scattering of the data for the largest system sizes is due to the limited number of samples.




FIG.6. R m.s. deviation  $_q = h(h P_q hh P_q i)^2 i^{1-2}$  of the IPR logarithm. The dashed line is a t to Eq. (71), the dotted line corresponds to the asymptotic lim it  $_q = q = q_c$ with  $q_c = 3.9$ . The inset shows an enlarged view of the low-q region.

W e devote the rem ainder of this section to a brief discussion of the IPR distribution function P (Pg), specifically, its evolution with the system size L and dependence on q. In analogy with Anderson and quantum Hall transitions studied earlier [34,20,35{37], we expect the distribution P (Pq) to become scale-invariant in the large-L lim it. Figure 5 dem onstrates that this is indeed the case. It represents the evolution of the distribution of ln P<sub>2</sub> with the system size L. The mean of the distribution is shifted as 2 ln L. A part from sm all statistical uctuations at the largest system sizes, a clear tendency towards an asymptotic form is observed. To characterize the width of the distribution P  $(\ln P_q)$ , we calculate the variance  $\frac{2}{q} = var(\ln P_q)$ , as shown in the inset of Fig. 5 for q = 2. The results extrapolated to L ! 1 (the nitesize corrections are again of the type L y with y 0:4) are presented in Fig. 6. The behavior of  $_{q}$  is qualitatively sim ilar to that found for other localization transitions. A som ew hat unusual feature of the SQH transition is that in a rather broad range 0 q 3 the variance  $\frac{2}{\sigma}$ is rem arkably well described by the form ula

which has been derived for a metallic system [38,25], or for the Anderson transition with a weak multifractality, e.g. in 2 + dimensions [34,36]. In the latter case this formula is valid for q q. The accuracy of Eq. (71) is one more manifestation of the \close-to-metal" character of the SQH critical point already mentioned in Sec. III, which leads to a relatively large value of q. ' 4. At larger q, the behavior of q becomes linear (as was also found for the conventional Anderson transition [36,37]), in agreement with the theoretical prediction  $_{\rm q} = q=q_{\rm c}$  for q q. [36]. This is because in this regime the distribution P (P<sub>q</sub>) is dominated by a slow ly decaying power-law tail P (P<sub>q</sub>) / P<sub>q</sub><sup>1 xq</sup>, where x<sub>q</sub> = q<sub>c</sub>=q for q > q. [34].

# VI.STATISTICS OF TW O POINT CONDUCTANCES

So far, we have investigated properties of an open system. To de ne the two-term inal conductance g, one opens the system by attaching two leads. A coording to the Landauer-Buttiker form ula,  $g = Trt^y t$ , where t is the transm ission m atrix between the leads. In the fram ework of network m odels, the transm ission m atrix determ ining the two-point conductance between the edges e and  $e^0$  has the form [16]

where P = 1 jeihej feihe<sup>0</sup> j projects out the states on the edges e and e<sup>0</sup>.

Statistics of the two-point conductance  $g(r;r^0)$  has been extensively studied, both analytically and num erically, for the conventional QH transition, exem plifying a localization transition with non-critical DOS. It was shown that the moments  $hg^q(r^0;r)i$  obey a power-law scaling [39,16,17],

For the SQH critical point, only the average conductance hg (e<sup>0</sup>;e)i has been considered previously. G ruzberg, Ludwig, and R ead [10] found that

Beam ond, Cardy, and Chalker [13] used the mapping onto percolation to calculate hg ( $e^0$ ; e) i at the band center = 0 (z = 1), with the result

with P ( $e^0$ ;e) as de ned in Eq. (33). Comparing (76) with (29), we see that hg( $e^0$ ;e)i is equal (up to the sign) to the diusion propagator ( $e^0$ ;e) = hTrG<sub>R</sub> ( $e^0$ ;e;1)G<sub>A</sub> (e; $e^0$ ;1)i.

In this section, we will study statistical properties of g(e<sup>0</sup>;e) at the SQH transition. Note that though the de nition of hg (e<sup>0</sup>; e) i rem inds closely that of the di usion propagator (e<sup>0</sup>; e), the identical scaling of the both quantities is not at all self-evident. In contrast, they scale di erently at conventional localization transitions, as can be easily seen by comparing Eqs. (73), (74) with (5). It is worthwhile to rem ind the reader the physical reason for this di erence (see also a related discussion in [16]). The product  $hG_{F}^{R}$  ( $r^{0}$ ;r) $G_{F}^{A}$  (r; $r^{0}$ ) i has a meaning of the particle density (or, in an optical analogy, the radiation intensity) at a point r<sup>0</sup> induced by a source inserted into the system at a point r. In an in nite system at criticality this quantity turns out to be infrared divergent: if a source is switched on at a time t = 0, the detected intensity will increase with time without saturation, since the radiation cannot propagate away fast enough. Therefore, in order to make  $hG^{R}G^{A}i$  nite, one needs to allow the propagating wave to get out of the system, i.e. to introduce absorption. One possibility is to make the absorption weak but uniform over the whole system , leading to hG<sup>R</sup><sub>E+i</sub> ( $r^0$ ; r)G<sup>A</sup><sub>E</sub> (r; r<sup>0</sup>)i (r<sup>0</sup>;r;2i), which is the same as introducing a small uniform level broadening (or equivalently, a sm all frequency ! with an analytical continuation to the imaginary axis, ! = 2i). A lternatively, one can allow for a particle to be absorbed at the points r and  $r^0$  only, but with a probability of order unity, yielding the two-point conductance  $g(r^0; r)$ . C learly, two de nitions are essentially di erent (which is already obvious from the very fact that depends on , diverging in the lim it ! 0, while g does not require any parameter like and is bounded, g 1). Therefore, the di erent scaling behavior of , Eq. (5) and hqi, Eq. (73), is not surprising.

Returning to the SQ H transition, we are thus naturally led to a question: why do and hgi scale identically in this case? The reason is that the zero-energy di usion propagator ( $e^{0}$ ; e) is in fact de ned at = 0 (i.e there is no need to introduce absorption or a nite frequency to regularize it), see Eqs. (32) and (58), (60). This can be traced back to vanishing of DOS at = 0. It is not a surprise that in this situation, when the absorption is irrelevant, (e<sup>0</sup>;e) and hg(e<sup>0</sup>;e) i (which only di er in the way the absorption is incorporated) scale in the same way.

Let us consider now higher m om ents

For the SQH case, the condition (77) in plies q < 3=2. (W e m ake an assumption that our consideration, which is strictly speaking performed for integer q, remains valid for intermediate, non-integer values of q.) A coording to the above argument,  $hg^q$  i scales in this regime in the same way (78), so that (see also [23]),

Note that, in contrast to TrGG, the two-term inal conductance g is bounded from above, g 2 (the factor two is due to spin summation and is not essential). Physically, it simply means that for such rare realizations when TrGG is large, g is limited by the contact resistance. It follows that the exponent for hg<sup>q</sup>i should be a non-decreasing function of q. In other words, the exponent X<sub>q</sub> saturates after reaching its maximum at some q<sub>0</sub>. We not from (80) q<sub>0</sub> ' 3=2; for larger q the exponent saturates at the value X<sub>q</sub> q<sub>0</sub> = X<sub>q0</sub> ' 9=16 (these moments are determined by the probability to nd g 1).

Equation (80) in plies, in particular, a norm aldistribution of  $\ln g$  at r 1 with the average  $\ln g(r)i = X_t \ln r$ and the variance var $[\ln g(r)] = b \ln r$ , where  $X_t$  ' 3=4 and b' 1=2. These values correspond to the parabolic approximation (69); more accurate predictions can be obtained by using the num erical results for q,

(here a prim e denotes the derivative with respect to q).




FIG.7. D istribution of the two point conductance at 3 different distances between the contacts, r = 5:7(), 14:1(+), 133(5); the system size is L = 196. The dashed line indicates a log-norm al t with parameters hlngi = 4:72 and var(lng) = 3:15.

W e turn now a to a num erical study of the two-point conductance. W hile we did not attempt a high-precision num erical determ ination of the spectrum of corresponding exponents  $X_q$  (as presented in Sec. V A for the multifractal spectrum of wave functions), we have veried some of the key predictions of the above analytical considerations. Figure 7 illustrates evolution of the distribution function P (g) with the distance r between the contacts; it is seen that at su ciently larger the distribution

becom es log-norm al as expected. In Fig. 8 we show the scaling of the average hgi and the typical  $g_{typ} = exphingi$ values of the two-point conductance, along with analogous quantities hy f i and f  $f_{yp}$  = exphin f f i for a TrG (e;e;1)G (e;e<sup>0</sup>;1). For the closed system, Gf average values, hgi and h $\mathcal{G} \neq i$ , the num erics fully con m the theoretical results (76), (29) telling us that the both quantities scale as r<sup>1=2</sup> and, m oreover, are equal to each other. A non-trivial character of the equality hgi = hf f i is well illustrated by the data for typical quantities: g<sub>typ</sub> and  $f_{\rm Vp}$  are not equal. N evertheless, they are found to r<sup>Xt</sup>, con ming share a common scaling:  $g_{typ}$ ;  $f_{fyp}$ our argum ents presented above. Furtherm ore, the num erically obtained value of the exponent,  $X_{t}$  ' 3=4, is in agreem ent with the theoretical prediction (81).




FIG.8. Scaling of the two-point conductance with distance r between the contacts: average value (empty symbols), hgi, and typical value (led symbols),  $g_{typ} = exphln g_i$ , in system s of sizes L = 128(2) and L = 196(). A los shown is scaling of the two-point G reen function, hG  $\hat{f}$  i and  $\hat{f}$   $\hat{f}_{yp} = exphln \hat{f}$   $\hat{f}$  i (L = 128(4); L = 196()). The lines correspond to the  $r^{1=2}$  (dotted) and r  $^{3=4}$  (dashed) power laws. D eviations from power-law scaling at large values of r are due to the nite system size.

#### VII.SUMMARY

Let us sum m arize the m ain results of the paper.

- 1. We have extended the mapping of the SQH network model onto the classical percolation and calculated two- and three-point correlation functions at the SQH transition. This allowed us to determine analytically the fractal exponents  $_2$  and  $_3$ governing the scaling of the second and third moments of the wave function intensity, with the results  $_2$  = 1=4 and  $_3$  = 3=4.
- W e have perform ed a thorough num erical study of the multifractal spectrum <sub>q</sub>. The obtained spectrum is given with a good accuracy by the parabolic law (69) but shows clear deviations from parabolicity, Fig. 4.
- 3. Statistical properties of generalized inverse participation ratios  $P_q$  at the SQ H transition are similar to those found earlier for other localization transitions. In particular, the distribution function P ( $P_q$ ) becomes scale-invariant in the limit of large system size.
- 4. We have analyzed statistics of the two-point conductance g at the localization transition with a critical density of states. Speci cally, we have presented scaling arguments which link the exponents  $X_q$  governing the spatial decay of  $hg^q i$  to the wavefunction multifractality spectrum  $_q$ , see Eq. (79). This yields, in particular, for the typical conductance at the SQH critical point  $g_{typ}$   $r^{X_t}$  with  $X_t$  ' 3=4 (see Eq. (81) for a more accurate value), as con m ed by numerical simulations.

In recent years, a considerable progress has been made in understanding of conformal eld theories related to problem s of two-dimensional fermions subject to quenched disorder  $[32,17,18,21\{23,40\{46\}]$ . In particular, a relation between the wave function multifractality in two-dimensional disordered system s and the operator content of corresponding conformal eld theories has been discussed in a number of publications [32,42,18,23]. It remains an open question whether the multifractal exponents  $_{q}$ , X  $_{q}$  for the SQ H transition can be computed by the conformal eld theory methods. Note that our results are against the proposal of Ref. [23], where the result q = q(1 - q)=4 was obtained. Apparently, this indicates that the theory considered in [23] and obtained [22] from a particular network model with netuned couplings, does not belong to the SQH universality class.

# APPENDIX A : PROOFS TO THE MAPPING ONTO PERCOLATION

In Sec. IV A two statements were formulated which allow us to calculate averaged products of two (Sec. IV A) and three (Sec. IV B) G reen functions. Here we give some more details on the proofs of these statements. In the end of the Appendix we will also explain why our calculation cannot be extended on products of q 4 G reen functions (and thus on higher moments of wave functions).

#### Statem ent 1

The rst statement says that only paths visiting each node 0 or 2 times are to be considered. Its proof for the case of two-point functions was given in Sec. IV A. The analysis of the case of three-point functions (considered in Sec. IV B) goes along similar lines, and we present its brief outline only. In analogy with (22), we have to consider an expression of the type

Therefore, the sum (A2) is equal to zero, which com - pletes the proof of the statem ent 1 for the three-point G reen functions.

#### Statem ent 2

The second statement allows us to reduce the nodes visited 4 times to a superposition of contributions (i) and (ii) of Fig. 2, with the factors  $\cos^2$  and  $\sin^2$ , respectively. We will give the proof for the (most non-trivial) case of a product of q = 3 G reen functions; the proof for q = 1 and 2 is obtained in the same way. More specicilarly, we will consider the correlation function (47); the correlator (46) is treated analogously.




FIG.9.C on gurations of paths for the correlation function (47) for a node visited four times.

Each of three G reen functions in (47) generates a sum over closed loops (e ! e,  $e^0$  !  $e^0$ , and  $e^{00}$  !  $e^{00}$ , respectively). For a given lattice node, let us label the corresponding incoming edges as (1,2) and the outgoing ones as (3,4). We are considering a contribution of paths visiting this node in total four times. This generates four path segments starting each on one of the edges (3,4) and ending on one of the edges (1,2), and not passing through any of these edges. We are going to show that for any conguration of these four segments the statement 2 holds. It is easy to see that there exist two essentially dierent types of such con gurations (shown in Fig. 9); all others can be obtained by permutations of e;  $e^0$ , and  $e^{00}$ , and/or by lattice symmetry operations.

Consider rst the con guration (a) of Fig. 9. We have to sum over all ways to connect the four path segments by various con gurations of scattering events at this node shown in Fig. 2. Speci cally, only such connections are allowed which generate exactly 3 closed bops, each containing one of the edges e,  $e^0$ , and  $e^0$ . There are three possibilities how this can be done, since the segment that does not contain any of the edges  $e;e^0;e^{00}$  can be connected in a loop with any of the remaining three. In one of these cases the con guration of paths at the considered node is of the type (ii) of F ig. 2, in two other cases it is of the type (iii). We thus get the following contributions:

Here A (2;3) is a sum over all paths from 3 to 2 passing through e,  $A^{0}(2;3)$  is a sum over paths 3 !  $e^{0}$  ! 2, A (1;4) is a sum over paths 4 !  $e^{0}$  ! 1, and  $A^{0}(1;4)$  is a sum over paths 4 ! 1 (Fig. 9a). A lso, we have denoted s = sin and c = cos.

To perform the integration over U  $_{\rm i}$ , we use the follow-ing form ulas of integration over SU (2) m atrices:

Here matrices  $V_{1,2}$  are assumed to be of the form  $V_i = \mathbf{y}_i \mathbf{y}_i$ , where  $V_i \ge SU(2)$  and  $\mathbf{y}_i \mathbf{j}$  is a real number (we rem ind that A (i; j) are exactly of this type, see Sec.IV A).

Applying repeatedly the nules (A7){(A9), we perform integration over all matrices  $U_i$  (i = 1;:::;4) in Eqs. (A4){(A6). We nd then that all three contributions (A4){(A6) are proportional to  $TrA^{y}(2;3)A^{0}(2;3) TrA^{y}(1;4)A^{0}(1;4)$ , with coe cients  $\frac{1}{4}s^{4}$ ,  $\frac{1}{8}c^{2}s^{2}$ , and  $\frac{1}{8}c^{2}s^{2}$ , respectively. The total coe cient is therefore

We see that the same result would be obtained if we would assign the weight  $s^2$  to the rst contribution (which is of the type (ii) of Fig. 2) and discard the remaining two terms (which are of the type (iii)). This establishes the validity of the statement 2 with respect to the con guration (a) of Fig. 9.

The con guration (b) of Fig. 9 is analyzed along the same lines. We have again three contributions, one of the type (ii) of Fig. 2 and two of the type (iii),

A fter integration over  $U_i$  according to the nules (A7){(A9) they all produce an identical structure,  $\operatorname{Tr}A^{y}(2;3)A(2;4)A^{y}(1;4)A(1;3)$ , with the coe cients  $\frac{1}{4}s^4$ ,  $\frac{1}{8}c^2s^2$ , and  $\frac{1}{8}c^2s^2$ , respectively. Again, retaining only the (ii)-type contribution (A11) and assigning the weight  $s^2$  to it, we would obtain the same result. This com pletes the proof of statem ent 2 for the three-point correlation function (47).

# W hat about q > 3?

A natural question is whether the present approach can be generalized to higher-order correlations of wave functions governed by multifractal exponents g with q > 3. The answer is negative. In fact, both statem ents 1 and 2 do not apply (or, in a more careful form ulation, 4, as we are going to explain our proofs fail) for q in brief. Concerning the statem ent 1, consider a generalization of the expression (A1) to q = 4, and choose  $k_1 + k_2 + k_3 + k_4 = 4$ . Obviously, there is just one k such term (all  $k_i = 1$ ) in the sum , and it is easy to see that it is generically non-zero. Therefore, no cancellation of term  $s w \pm h k > 2$  happens in this case, i.e. the statem ent 1 does not work. Turning to the statem ent 2, consider e.g. a correlation function  $D^{\infty}(e;e^{0};e^{00};e^{00};)$ analogous to (47) but containing a product of four traces of G reen functions. Trying to prove the statem ent 2, we will then have to consider the path con gurations very sim ilar to those shown in Fig. 9 but with all four paths containing one of the edges  $e, e^0, e^{00}$ , or  $e^{000}$ . At the next step the paths should be connected via the scattering processes at the node { this time to generate 4 closed loops. However, for each of the con gurations shown in Fig. 9 there is only one way to do this, so that only one contribution will arise in place of three term s (A 4) { (A 6)or (A11) { (A13). C learly, the statem ent 2 is not valid in this situation. Therefore, the mapping onto the classical percolation is not applicable for higher m om ents, q > 3. This is in correspondence with the fact that q = 3 separates two regimes of qualitatively di erent behavior of correlation functions, as discussed in Sec. IV C .
