Large M om ent Form ation and Therm odynam ic Properties of D isordered Spin Ladders with Site D ilution

Low temperature properties of antiferrom agnetic two-leg spin-1/2 ladders with bond random ness and site dilution (or doping with nonmagnetic impurities) are studied using the real-space renormalization-group technique. We nd that for non zero dopant concentrations the systems are driven into a phase dom inated by large e ective spins, i.e. the Large Spin phase. The susceptibility follows a universal Curie-like 1=T behavior at low temperature, regardless of the dopant concentration (as long as it is nonzero) and the strength of bond random ness. Very sim ilar behavior has been found in ladders that are doped with m agnetic impurities that carry spin-1.

I. IN TRODUCTION

Q uantum e ects in one-dimensional spin systems have attracted prolonged interest from both theoretical and experimental physicists. These include quasi-long range order, topological order, and uctuation induced excitation gap (e.g., the Hakane gap) that are purely quantum mechanical e ects enhanced by the low-dimensionality of the systems. Among these quantum phenomena, the e ects of disorder have been studied by many groups. It was found that disorder can qualitatively change the low temperature physics and produce rich disorder-dom inated phases in these systems. O ne class of such systems which have received considerable attention are random antiferrom agnetic spin chains. Most of the theoretical studies of random spin chains are based on the real space renorm alization group (R SRG) method developed by M a, D asgupta, and Hu¹ in this context, and B hatt and Lee² in the study of doped sem iconductors. This R SRG method was extended further by Fisher³ and allows one to obtain results which are essentially exact for the random spin-1/2 chain. The application of this method to the other random spin chain models by a num ber of authors^{4,5,6,7,8,9,10,11} has given us a better understanding of the behavior of these systems at low tem perature.

A nother example of 1D spin system that is of considerable recent interest is the two-leg antiferrom agnetic spin-1/2 ladder.¹² It is known to have an excitation gap similar to the Haldane gap of integer AF spin chains, and short-range spin-spin correlation. C om pared to the spin chains, only relatively few theoretical studies have been devoted to the study of disorder e ects in spin ladders. Several authors have investigated the e ects of bond random ness^{1,14,15} It was found that the ladder is remarkably stable against weak bond random ness.¹³ Stronger random ness introduces a large density of low-energy excitations into the system ,^{14,15} which can lead to divergent spin susceptibility in the lim it T ! 0.¹⁵ How ever, the spin-spin correlation remains short-ranged,¹⁵ contrary to what occurs in strongly disordered AF spin chains.^{3,8}

In real system s, bond random ness is typically induced by in purities away from the ladder, which distort the lattice structure (and hence coupling constants) without a ecting the spins that form the ladder. Experim entally, another way to introduce and control disorder in the system is to introduce dopants that go directly into the ladder, so that the ions that carry the half-spin (typically the Cu ion) are random ly replaced by nonmagnetic ions (like Zn), or ions with other spin sizes (like Niwhich carries spin-1). Such disorder not only induces lattice distortion, but also changes the lattice structure of the spin ladder through site-dilution etc, and thus has more dramatic e ects. A num ber of experim ental^{16,17} and theoretical^{18,19,20,21,22,23,24,25,26,27,28} works have been devoted to study the doped</sup>two-leg spin-1/2 ladder, for example $Sr(Cu_1 \times Zn_x)_2O_3$, where some Cu ions are replaced by nonmagnetic Zn ions. It was found experimentally that even a small amount of nonmagnetic doping is enough to change the low-tem perature behavior of the system's drastically, and gives rise to divergent susceptibility at low temperature. Theoretically, it is understood that a single Zn impurity induces an e ective, localized spin-1/2 moment in the vicinity of the dopant; such localized moments immediately destroy the spin gap.^{19,22,25} W hen there is a small but nite density of dopants, these e ective spin-1/2 m om ents interact with each other, and currently there is no consensus on what the asymptotic low-temperature behavior is. Signist and Furusaki²⁰ argued that the system can be mapped onto an e ective model that is made of these e ective half spins induced by the dopants form ing a spin-1/2 chain, with random antiferrom agnetic (AF) and ferrom agnetic (F) couplings; this model is known to form large e ective spins and 1=T. 0 n the other hand, G ogolin et al.^{27,28} used the bosonization m ethod exhibits Curie susceptibility at low T: to map the problem to a D irac ferm ion with random mass, and concluded that the low T susceptibility behaves as

 $1=(T \log^2 T)$, which is the same as the random singlet phase;³ no large moment formation was found in their work. Existing exact diagonalization¹⁹ and quantum M onte Carlo calculation^{19,21,23} do not have large enough system

size to unambiguously resolve this discrepancy.

In this work we study disordered two-leg spin ladders with both bond random ness and site dilution (corresponding to Zn doping), using the RSRG m ethod. As discussed earlier, in principle Zn doping introduces two types of disorder. Technically the presence of bond random ness is useful to us in our study as it introduces a separation of energy scales and justi es the usage of the RSRG m ethod. Using this m ethod we are able to study system s with sizes 100 times larger than those accessible in quantum M onte Carlo studies. In addition to the nonmagnetic (Zn) doping, we also study theoretically for the rst time m agnetic doping by replacing the Cu ions with N i ions (or doping with S = 1 im purities), a situation already realized experimentally.²⁹

O ur results are sum marized as follows. As the RSRG procedure is carried out, elective spins (or moments) larger than 1/2 start to form; these large moments persist and grow without bound as the energy scale is low ered, regardless of the dopant concentrations (as long as it is non-zero) or the strength of bond random ness. Thus the presence of dopants drives the system into a new phase which is controlled by large spins, i.e. the Large Spin phase; the susceptibility at low temperature remains universal and follows 1=T behavior as T goes to zero. The 1=T C urie behavior comes from the spins coupled together forming larger elective spins. Such behavior is very similar to that of random AFF spin chain studied by W esterberg et al.⁵ as anticipated by Sigrist and Furusaki. While for any nite temperature range it is very di cult to distinguish between 1=T and 1=(T $\log^2 T$), we further ind that the C urie coelected together that predicted by Sigrist and Furusaki based on analogy to the random AFF spin chains.

The remainder of the paper is organized as follows. In Sec. II we introduce the model we use and review the application of RSRG to this model. In Sec. III we present our num erical results, compare them to previous works, and discuss the signi cance of our results. In Sec. IV we sum marize our work and discuss the implications of our results.

II. THE MODEL AND REVIEW OF PREVIOUS RESULTS

The model we consider in this work describes a disordered antiferrom agnetic two-leg spin-1/2 ladder. The H am iltonian for this model is given by :

where S_{ijj} is a spin-1/2 operator when there are no dopants, and the positive coupling constants J_{ij} (couplings along the chains, or legs of the ladder) and K_i (couplings between the chains, or along the rungs of the ladder) are distributed random ly according to some probability distributions $P_k(J_{ij})$ and $P_2(K_i)$. N is used to represent the number of sites for a single chain. The dopant concentration is given by z, namely we put 2N z nonm agnetic in purities (Zn doping) or m agnetic in purities (N i doping) on the ladder; for nonm agnetic in purities we simply remove the spins at the in purity sites, while form agnetic in purities we replace the spin-1/2 operators by spin-1 operators at the in purity sites.

We use the real-space renorm alization-group (RSRG) method to study this problem. Application of the RSRG procedure with proper extensions to the ladder systems has been discussed at length in Ref. 15, and we refer the readers to that article for details. For the purpose of later comparison, here we brie y review some of the relevant results of that work, which studies the e ects of bond random ness without non-magnetic orm agnetic (spin-1) dopants going into the ladder.

W hen the RSRG procedure is carried out in ladders with no dopants, it was found that ferrom agnetic (F) couplings are generated, and some e ective spins with sizes bigger than 1/2 are form ed because these ferrom agnetic bonds m ay become the strongest bond in the system at some stage of RG.¹⁵ However, the percentage of these large e ective spins remains low at all stages of RG, and in the low-energy limit, their percentage decreases as the energy scale is going down, due to the fact that the overall strength of the ferrom agnetic bonds become smuch weaker than that of the antiferrom agnetic bonds, even though they have roughly the same num bers. Such behavior m ay be understood in the follow ing way. W ith nearest neighbor couplings only, the ladder has a bipartite lattice structure which means the system can be divided into two sublattices (A and B), and spins sitting on sublattice A are always coupled to spins sitting on sublattice B, and vice versa. In the absence of dopants, the number of spins in the two sublattices tend to be parallel while those in opposite sublattices tend to be antiparallel, and there is a total cancellation when the number of spins are the same in the two sublattices. The disappearance of large e ective spins in the low energy limit is simply a refer to of this cancellation effect.

As we will see below, the situation becomes very dierent in the presence of dopants. In this case the dopants go onto lattice sites random ly, thus there are uctuations in the numbers of dopants going onto the two dierent sublattices, even though on average they are the same. Such uctuations destroy the perfect cancellation discussed above, and as we see below, lead to large moment form ation in the long-distance, low-energy limit, which in turn changes the therm odynamic properties of the system qualitatively.

III. NUMERICAL RESULTS

W e present num erical results for the spin ladder with the length of the ladder up to 100 000 (200 000 total spins). We decimate the strongest bond in the system de ned as the bond with the largest energy gap, $_0$, between the ground state and the rst excited state. The decimation process is repeated until the num ber of spins left is less than 1% of the original num ber of spins in the system. The initial distributions are taken to be in power-law form $:^{31}$

Here 0 < 1 is the measure of bond disorder (the bigger , the stronger the random ness strength), and is the anisotropy parameter; in the limit ! 0 the two chains decouple. The nonmagnetic or S = 1 magnetic dopants are distributed random ly throughout the system.

We start by discussing the e ects of nonm agnetic dopants on the spin ladder. Due to the generation of F bonds in the RSRG procedure, e ective spins with sizes bigger than 1/2 are formed as RSRG is carried out. The question whether or not these large e ective spins proliferate at low energy is very in portant. In the undoped case (with bond random ness only), we have show n^{15} that these large e ective spins do not proliferate for the reasons discussed in section II. The situation becomes completely dierent when a nite percentage of dopants are introduced into the ladder. This is shown in Fig. 1 (a) and (b) where we plot the fraction of spins larger than 1/2, and in Fig. 1 (c) where we plot the average spin size for di erent dopant concentrations as a function of cuto $_0$, for = 0 and = 0.6, both with = 1. For dopant concentrations bigger than 1% there is a very clear indication for large spin proliferation at low energy. The fraction of spins larger than 1/2 grows without bound as the energy scale is low ered. This picture is also supported by the results for the average spin size which show no sign of decreasing. This is in sharp contrast with zero doping, which is also included for comparison. The behavior for lower dopant concentrations (< 1%) is m ore interesting. In this regime we see a clear turnover in the graphs where the fraction of spins larger than 1/2initially increases with decreasing energy scale, reaches a maximum, then it decreases before it begins to rise again (see Fig. 1 (b)). Our interpretation of this behavior is the following. For very low dopant concentrations, the e ects of the dopants are very weak, and the system behaves like an undoped spin ladder at higher energy scales down to a certain energy scale c. Below c, the e ect of these dopants kicks in and eventually dom inates the physics, and the system ows into the Large Spin phase. Thus in a way the dopants are relevant perturbations in the RG sense.

The proliferation of large e ective spins can be understood from the following analysis. The nonmagnetic in purities introduced into the system can go into either sublattice A or B with equal probability, so in average the number of dopants in the two sublattices are equal. However, due to statistical uctuations, the number of dopants in the two sublattices are not equal in speci c realizations of the random distributions. In particular, in any nite segments of the system, the uctuations leave some of the half spins uncompensated for and destroy the perfect cancellation discussed in Sec. II, and the number of such spins grows as the square root of the size of the segment. The large e ective spins that get generated under RG have the same spin size as the ground state spin quantum number of the nite segments that they are made of, thus the proliferation of large spin at low energies is simply re ecting the growing uctuation of the spin size of longer and longer segments.

The therm odynamic properties of the doped ladders are dram atically in uenced by the presence of large e ective spins in the system . Fig. 2 shows the magnetic susceptibility for ladders with = 0 and = 0.6 with varying dopant concentrations, all with = 1. We associate the temperature with the cuto $_0$ where we stop the RG procedure and calculate the contribution from the active spins to the susceptibility. These active spins consist of undecimated half spins and e ective spins larger than 1/2 generated during the decimation process. All the spins that have been decimated down to the cuto $_0$ do not contribute to the susceptibility. All the active spins are treated as free spins, so the contribution can be calculated using :

where N_s is the number of spins left at energy scale $_0 = k_B T$ for a given spin size s and the summation runs over all possible spin sizes.

In all cases we nd that at low temperature the susceptibility can be t very well to a Curie-like behavior T⁻¹, which is insensitive to speci c details of the systems, like the strength of bond random ness and the dopant concentrations. Such behavior agrees with the predictions of Sigrist and Furusak²⁰ but it is very di erent from what we found earlier on the undoped ladders with bond random ness only, where the low-T susceptibility follows non-universal power laws with an exponent that depends on the bond disorder strength as well as the strength of the interchain interactions. We note that while our results agree with the Curie behavior predicted by Sigrist and Furusaki, due to the limited temperature range, they may also be t to the Random -Singlet like behavior $1=(T \log^2 T)$ that G ogolin et al.^{27,28} suggested, which di ers from the Curie behavior with a factor that only has a logarithm ic dependence on T. In order to further clarify the situation, we study the dependence of the Curie coel cient on the parameters of the system and compare it with predictions made by Sigrist and Furusaki.

The 1=T Curie behavior is usually associated with free spins. In our case how ever, the 1=T dependence has a very di erent origin; it comes from the strongly correlated e ective spins form ed during the RG procedure, due to the existence of ferrom agnetic couplings, which form clusters whose average size grow in a random walk fashion at low tem perature. Signist and Furusak²⁰, in their e ective model have show n, using the random walk argument similar to that used in Ref. 5, that the Curie constant for nite dopant concentrations is given by :

0 n the other hand, if the e ective spins induced by the dopants behave like free spins, and the C urie constant is given by

We plot the Curie constants for = 0 and 0.6, each with two di erent dopant concentrations, 2% and 4%, as a function of tem perature in Fig. 3. The gure shows that at low tem perature, the Curie constants deviate signic cantly from the free spin Curie constant, Eq. 5, and approach the asymptotic limit, Eq. 4. This strongly suggests that the e ective spins are strongly correlated and the susceptibilities follow 1=T behavior at low tem perature due to large m om ent form ation. If the susceptibilities were to follow 1=(T log²T), as G ogolin et al.²⁸ suggested, the Curie constants would go to zero at low tem perature. W hile we do see that the Curie constants decrease with decreasing T, they are approaching constants given by Eq. 4 in the low -T limit, instead of going to zero. We thus conclude that our data strongly support the results of Sigrist and Furusaki.²⁰ W e note that M iyazaki et al.²³ used quantum M onte C arlo m ethod to calculate the Curie coe cients of the doped ladder with di erent dopant concentrations. They were unable to obtain conclusive results for the coe cients due to the fact that the system size studied was not large enough to probe deep into the low tem perature regim e.

The tem perature dependence of susceptibility also gives us some inform ation how the system crosses over from one behavior (at high T) to another (at low T). In Fig. 2 we plot the susceptibility with di erent dopant concentrations for = 0 and = 0.6 as a function of tem perature. The inset of each gure shows the part of susceptibilities where the crossover into a new behavior occurs. This crossover is particularly clear for = 0. A swe vary the dopant concentrations, from 0% to 2%, there is a clear turnover in the susceptibilities. In the undoped lim it, the susceptibility goes to zero as T ! 0. For very sm all z, follows this behavior at higher T, as the e ect of the dopants have not yet dom inated the contribution to . How ever at low enough tem perature the e ects of the dopants start to dom inate; this is characterized as the susceptibility begins to increase and nally becomes divergent as the tem perature is decreased below a certain crossover scale. The same behavior can also be seen for = 0.6 although it is not as pronounced as for = 0, because in the undoped lim it, is already divergent as a power-law of T, and the power law exponent is given by $0.4.^{15}$ Introducing a sm all am ount of dopants into the system alters the physics at su ciently low tem perature where the susceptibilities have di erent power law exponent.




FIG.1: The results from numerical calculations for nonm agnetic in purities. The left column is for = 0 and the right column for = 0.6, both with = 1. The number of spins on a single chain is N = 100000. (a) and (b) The fraction of spins larger than 1/2, and (c) the spin size average as a function of cuto $_0$ with di erent dopant concentrations. Allare sample averaged. A more detailed view of the high temperature part from (a) is shown in (b). The error bars, not shown in the gures, are comparable to the size of the data points.




FIG. 2: The sample averaged susceptibilities per spin as a function of tem perature with di erent nonmagnetic dopant concentrations for = 0 and 0.6. The symbols have the same meaning as those in Fig. 1. The inset shows the part in susceptibility that crosses from one behavior to another. In both cases the 1=T line is drawn on the data as a guide to the eye. We do not include the error bars in the gures which are comparable to the size of the data points.

One important observation from the numerical results is that in the presence of a nite dopant concentration, the physics of the systems in the low temperature limit is not sensitive to the choice of the distribution of the bond random ness. The low energy physics for two quite di erent bond random ness strength = 0 and 0:6, as shown in Fig. 1, 2, and 3, are essentially the same. In both cases the system s are controlled by large e ective spins at low energy and the susceptibilities follow 1=T behavior at low tem perature, and the Curie constants are approaching the same e asymptotic limit, given by Eq. 4, which depends on dopant concentration only. Thus the insensitivity of the results on the speci c form of the bond distribution justi es our choice of the bond distribution based on convenience. We note that it tends to ow to a power-law form even if it does not have such form initially; thus by choosing such a form it puts one closer to the asymptotic form and reduces nite size e ects.

We now turn our discussion to the e ects of magnetic dopants with spin-1 on the spin ladders, which turn out to be very similar to those of non-magnetic dopants. In Fig. 4 we plot the fraction of spin larger than 1/2, the average

spin size as a function of cuto 0, and the susceptibility as a function of temperature with di erent magnetic dopant concentrations. As we can see from these gures, the qualitative behavior of the system doped with magnetic in purities at low energy are the same as that doped with nonmagnetic in purities. Large spin formations are seen at low energies which grow continuously as the energy is decreased. The similarity in the elects of these two di erent types of dopants lies in the fact that they both induce spin-1/2 local moments, and uncompensated spins in nite segments, due to the uctuation in the number of dopants going into the two di erent sublattices. This is the origin of the proliferation of large elective spins at low energies, and the 1=T C urie dependence of the susceptibility.

IV. SUMMARY AND DISCUSSIONS

We have studied antiferrom agnetic two-leg spin-1/2 ladders with bond random ness and site dilution/m agnetic impurity by means of a real-space renorm alization-group scheme. We found that there is proliferation of large e ective spins at low energy for non zero dopant concentrations. These large e ective spins show the tendency of growing without bound as the energy scale is lowered. The susceptibility of the doped spin ladder follows C urie-like 1=T behavior at low temperature. This behavior remains universal regardless of the dopant concentrations and the strength of bond random ness. We also nd the Curie coe cient is controled by the dopant concentration only, and agrees with that predicted by Sigrist and Furusaki.²⁰ We conclude that non zero dopant concentrations always drive the system into a phase dom inated by the large e ective spins. The large e ective spins control the low tem perature physics of the system which makes the the doped ladder behaves in many respects like the random spin chain with random ferrom agnetic and antiferrom agnetic interactions. This is very di erent from what we found in our earlier work for ladders with bond random ness only, ¹⁵ where no large spin proliferation was found, and the susceptibility at low tem perature follows non-universal pwoer law: T with an exponent that depends on the strength of bond random ness and the strength of bond random ness and the strength of bond random ness only.

Unfortunately at present we cannot make a direct comparison between our results and experiments, because in the system s studied so far the doped ladders all form long-range antiferrom agnetic order at low temperature, due to the presence of 3D inter-ladder couplings not included in our study.

W hile reaching the same conclusions, we used a di erent approach in our study of the doped ladders as compared with the work of Sigrist and Furusaki.²⁰ They focused exclusively on the elective spins that are induced by the dopants, and neglected all the original spins, justiled by the fact that without the dopants and the elective spins they induce, the system is gapped. Thus the model they used is an elective model appropriate for describing the low-T properties of the system. In our study on the other hand we include all the original degrees of freedom (the original spins), and system atically lower the energy scale by deciminating strong bonds one by one. Our approach thus treats high- and low-energy degrees of freedom on equal footing, and allow sus to address both the high-T and low-T properties of the system s, and the crossover between them. Thus our study is complementary to that of Sigrist and Furusaki.




FIG. 3: The sample averaged Curie constants for (a) = 0 and (b) = 0.6. For each we plot two di erent dopant concentrations. The dashed line in the inset is the Curie constant for free uncorrelated spin given by $z_B^2 = 4k_B$ and the dotted line is the constant for strongly correlated spins given by $z_B^2 = 12k_B$. In all cases, the Curie constants are always approaching the asymptotic limit given by Eq. (4) in the low temperature regime.




FIG. 4: The results from numerical calculations for magnetic in purities. The left column is for = 0 and the right column for = 0.6, both with = 1. The number of spins on a single chain is N = 100000. (a) The fraction of spins larger than 1/2, (b) the average spin size as a function of cuto $_0$ with dimensional concentrations, and (c) the sample averaged susceptibilities per spin as a function of temperature with dimensional concentrations. The dashed line in (c) is the 1=T line drawn as a guide to the eye.
