## An adjustable Brownian heat engine

A m icroscopic heat engine is modeled as a B rownian particle in a saw tooh potential (with load) moving through a highly viscous medium driven by the therm alkick it gets from alternately placed hot and cold heat reservoirs. We found closed form expression for the current as a function of the parameters characterizing the model. Depending on the values these model parameters take, the engine is also found to function as a refrigerator. Expressions for the e ciency as well as for the refrigerator perform ance are also reported. Study of how these quantities depend on the model parameters enabled us in identifying the points in the parameter space where the engine performs either with maximum power or with optimized e ciency. The corresponding e ciencies of the engine are then compared with those of the endoreversible and C arnot engines.

W e are in an era where devices including engines are being miniaturized to micron or even nano sizes. The physics of such m icroscopic engines is quite di erent from that of the macroscopic physics we daily experience. Due to their length scale, they are subjected to overdam ped Brownian motion. Any task such an engine perform s, such as translocating chem icals with nite velocity, costs energy. In order to nd out how e cient such an engine is, one has to generalize the de nition of e ciency. This is what Derenviet al. did in their crucial paper on generalized e ciency [1]. Another issue of how an engine operates is whether a fastest transporting velocity exists under a given condition. Such fast transport is at the expense of losing signi cant energy and implying less e ciency. A comprom ise between fast transport and energy cost m ay lead to an optim ized e ciency. Hernandez et al. recently cam e up with a uni ed optim ization m ethod for doing exactly this [2].

The aim of this paper is to model an adjustable microscopic (or Brownian) heat engine that could perform tasks in di erent modes of operation as mentioned above.

The idea of a Brownian heat engine working due to nonuniform temperature rst came up with the works of Buttiker, van K am pen, and Landauer [3] while they were involved in exposing the signi cance of the now in uentialpapers of Landauer on blow torch e ect [4]. Follow ing Buttiker's work, M atsuo and Sasa [5] considered such an engine as an example to show that it acts as a C amot engine at quasistatic limit. D erenyi and A stum ian [6], after analyzing the details of heat ow in a Brownian heat engine, found that its e ciency can, in principle, approach that of a C amot engine. The sam e group later used a model Brownian heat engine as an example to apply their new ly introduced de nition of generalized efciency and nd its in plications [1].

All these recent works addressed how a Brownian heat engine behaves in the quasistatic lim it. Instead of taking the engine as an example to address an issue of purely theoretical interest like quasistatic lim it, we would like to take an exactly solvable model where information of practical interest can also be extracted from the model parameters them selves. Not only will we be dealing with the quasistatic lim it but with general characteristics of real engines performing tasks either at maximum rate or at optimized e ciency or otherwise. Moreover, some of the wrong conclusions that were given due to either overbooking or lack of exact solution will be corrected.

The model consists of a B row nian particle moving in a saw tooth potential with an external bad where the viscous medium is alternately in contact with hot and cold heat reservoirs along the space (or reaction) coordinate. The shape of a single saw tooth potential,  $U_s(x)$ , located around x = 0 is described by




FIG.1. Plot of the saw tooth potential in the presence of constant external bad. The temperature prole is shown above the potential prole.

The potential corresponding to the external load is linear, fx, where f is the load. The temperature pro le, T (x), within the same interval  $L_1 = x < L_2$  is describe by

B oth  $U_s(x)$  and T (x) are taken to have the sam e period such that  $U_s(x + L) = U_s(x)$  and T (x + L) = T (x) where  $L = L_1 + L_2$ . Note that the left side of each saw tooth from its barrier top overlaps with the hot region of the m edium while the right side overlaps with the cold region. The saw tooth potential with the bad,  $U(x) = U_s(x) + fx$ , and the tem perature pro le, T (x), are shown in Fig. 1.

From practical point of view, the size of such m icroscopic heat engine is limited by how small in size tem – perature gradients can be. Since tem perature gradients of m icron size can be produced [7], the size of such an engine could be as small as few m icrons.

D ue to the presence of the hot and cold regions within each saw tooth potential and the external load, the B row – nian particle will generally be driven unidirectionally and attain a steady state current, J, whose magnitude and direction depends upon the quantities characterizing the m odel. The dynam ic equation governing the m otion of the B row nian particle in such highly viscous and inhom ogeneous m edium is the corresponding Sm oluchow ski equation rst derived by van K am pen and later by Jayannavar and M ahato [8]:

where P (x;t) is the probability density of nding the particle at position x at time t, U<sup>0</sup>(x) = dU (x)=dx, and (x) is the coe cient of friction at position x. Boltzm ann's constant,  $k_B$ , is taken to be unity. The constant current at steady state is given by

where  $P_{ss}(x)$  is the steady state probability density at position x. U sing periodic boundary condition,  $P_{ss}(x + L) = P_{ss}(x)$ , and taking coe cient of friction the same throughout the medium, we get a closed form expression for J for our potential and tem perature pro les [9]:

On the other hand, H can be put as a sum of three term s: A + B + C, where

Note that  $a = (U_0 + fL_1)=T_h$  and  $b = (U_0 - fL_2)=T_c)$ in Eqns. (6) and (7). For the case when there is no load (f = 0) and  $L_2 = L_1$ , the current takes a simple expression given by

Note that this current is a resultant of currents to the right and to the left; i.e.  $J = J_+ - J_-$ .

O ne can clearly see that the model acts as a heat engine when the current is to the right. The particle undergoes cyclic motion wherein during each cycle it is rst in contact with the hot region of width  $L_1$  and then with the cold region of width  $L_2$ . We take account of energy ow s between the two regions neglecting energy transfer via kinetic energy due to the particle's recrossing of the boundary between the regions [6,1,10]. As the particle m oves through the hot region it absorbs a total am ount of heat,  $Q_h$ , which will enable it not only to clim b up the potential ( $U_0 + fL_1$ ) but also acquire additional energy vL<sub>1</sub> (v being the particle's drift velocity and equal to J ( $L_1 + L_2$ )) to overcom e the region's viscous drag force so that

On the other hand, the cold region will absorb energy as the particle m oves down the potential hill while at the same time lose some energy due to the drag force in the region. Therefore, the net heat,  $Q_c$ , absorbed by the cold region will be

The net work, W , done by the engine in one cycle will then be the di erence between Q  $_{\rm h}$  and Q  $_{\rm c}$  so that

$$W = (v + f)(L_1 + L_2):$$

Note that the term (v+f) appearing in the above three expressions (Eqs. (9-11)) is the sum of the drag force due to the particle'sm otion through them edium and the load being lifted. One can take this term as generalized load so that the generalized e ciency, , as suggested by D erenyi et al. [1] will be given by

If, on the other hand, the load is large enough along with appropriately chosen other quantities then the current will be in the reverse direction in which case the load does work of am ount  $W_L = f(L_1 + L_2)$  in one cycle forcing heat to be extracted from the cold region of am ount  $Q_c = U_0$  (v + f)L<sub>2</sub>. Under this condition the engine acts as a refrigerator. This will then lead us to a generalized de nition of coe cient of perform ance (COP) of the refrigerator, P<sub>ref</sub>, which is given by

The condition at which the current changes its direction is the boundary dem arcating the dom ain of operation of the engine as a refrigerator from that as a heat engine. In general, this condition is satis ed when

$$f = \frac{U_0 (T_h - T_c)}{L_1 T_c + L_2 T_h} :$$

It is worth noting that the magnitude of the load at this point of zero current is exactly equal to what is usually called the stall force form olecular engines [11]. When we evaluate the expressions for both  $P_{ref}$  as we approach this boundary, we analytically nd that they are exactly equal to the values for e ciency of the Carnot engine and for COP of the Carnot refrigerator, respectively:  $\frac{T_h \quad T_c}{T_c}$  and  $\lim_{J \neq 0} P_{ref} =$ T<sub>c</sub> lim Hence, Th T<sub>C</sub> J! 0' this boundary at which current is zero corresponds to the quasistatic lim it be it from the heat engine side or from the refrigerator side. We would like to emphasize that the e ciency of the heat engine at the stall force takes the maximum value contrary to the claim (of zero value) m ade by Derenyi, et al. [1]. We would also like to point out that the e ciency goes to zero as the barrier height, U<sub>0</sub>, goes to in nity contrary to the claim (of maximum value) made by Derenvi and Astum ian [6]. This can be clearly seen from Eq. (12) above. We also claim that the expression for power of a reversible heat engine given in Eq. (10) of D erenyi et al. [1] does not m ake sense since one cannot have a therm all engine delivering nite power while, at the sam e time, operating reversibly.





FIG.2. (a) Plot of j versus for = 1, = 2 and u = 4. (b) Plot of j versus u for = 1, = 2 and = 0.4.

W e next explore how current, e ciency and COP of the model depend on some of the quantities characterizing it. In general, the quantities characterizing the model are U<sub>0</sub>, L<sub>1</sub>, L<sub>2</sub>, f, T<sub>c</sub> and T<sub>h</sub>. W e scale U<sub>0</sub>, L<sub>2</sub>, T<sub>h</sub> and f such that  $u = U_0=T_c$ , '= L<sub>2</sub>=L<sub>1</sub>, = (T<sub>h</sub>=T<sub>c</sub>) 1, and = fL<sub>1</sub>=T<sub>c</sub>. Hence, we have four parameters u, ', and

characterizing the model for a given  $T_c$  and  $L_1$ . We also scale current such that j =  $J{=}J_0$ , where  $J_0$  =  $T_c{=}(L_1^2)$ . Figure 2(a) is a plot of the scaled current, j, versus scaled load, . It shows that the engine works as a heat engine when the load value is less than the stall force (=0.8 in this case) and works as a refrigerator when the load is larger than this value. One can also see the domains of operations of the model by plotting j as a function of u as has been shown in Fig. 2(b). Note that when the model works as a heat engine there is a nite u at which the current is maximum. This corresponds to the point in the parameter space at which the engine operates with maximum power. When we plot the e ciency, , versus

within the domain where the model works as a heat engine, we nd that it increases linearly with increase in attaining its maximum value (Cannot e ciency) at the stall force (See Fig. 3(a)). On the other hand, Fig. 3(b) shows plot of  $P_{ref}$  versus which starts from its maximum value (COP of Cannot refrigerator) at the stall force and decreases fast as we increase the load.




FIG.4. Plots of  $_{CA}$ ,  $_{MP}$ ,  $_{OPT}$  and  $_{CAR}$  versus , where the model engine is put to function at f = 0 and '= 2 while u is xed depending on whether it is working at either maximum power or optim ized e ciency.

Let us now com pare the e ciency of ourm odel heat engine with that of the so-called endoreversible engine when both operate with maxim um power. Curzon and Ahlborn [12] took an endoreversible engine that exchanges heat linearly at nite rate with the two heat reservoirs and found its e ciency at maximum power, CA, to be equal to 1 ( $T_c=T_h$ ). Figure 4 gives plots comparing  $_{CA}$ with that of the e ciency of ourm odel heat engine when it also operates with maximum power, MP, for dierent values of . The plots show that the two results are reasonably close to each other for small with CA being slightly smaller than  $_{\rm M\ P}$  . The two values coincide at a particular value of and CA progressively gets larger and larger than that of  $_{M P}$  for higher values of . This shows that the assumption Curzon and Ahlborn took to get the expression for their e ciency holds reasonably well for our model heat engine as long as is small. It is worth noting that our model did not take any extra assumption in the way it operates either with maximum power or otherwise. We, therefore, believe that the reason for their deviation has got to do with the nonlinear nature of the way heat is exchanged.

We would further like to compare Carnot e ciency, CAR, with what is called optimized e ciency, OPT, by Hemandez et al. [2]. This optim ized e ciency is the e ciency at the point of operation of an engine where com petition between energy cost and fast transport is com prom ised. W e brie y sum m arize the m ethod H ernandez, et al. [2] used to get OPT. When the model operates with nite time the amount of work, W, it delivers is such that it lies between the maximum,  $W_{max}$ , and minin um , W  $_{\rm m}$  in , am ount of work that can be extracted from the m odelW m in W W  $_{m ax}$ . They de ned two quantities: e ective work,  $W_e = W$ W<sub>m in</sub> and none ective work W  $_{\rm ne}$  = W  $_{\rm m\,ax}$   $\,$  W  $\,$  and introduced a function, , to be optim ized to be equal to the di erence between these quantities. For our model heat engine (since  $W_{m in} = 0$ ) this function is given by




Figure 5 show splot of versus u in which the function has indeed an optimum at a nite value of u. The e ciency of the model heat engine when it operates at this particular point in the parameter space is what we call as optimized e ciency,  $_{OPT}$ . For the sake of comparison, we plot  $_{OPT}$  along with the corresponding C arnot e ciency,  $_{CAR}$ , in the same gure (Fig. 4) as we did for the other e ciencies. The plots clearly show that  $_{OPT}$  always lies between the  $_{CAR}$  and  $_{MP}$ . One can therefore say that the operation of the model at optimized e ciency is indeed a comprom ise between fast transport and energy cost.

In conclusion, we believe that our work has, for the rst time, quantitatively explored the basic properties such as current, e ciency and COP of a model B rownian heat engine. The recently introduced de nition of generalized e ciency [1] has been used in getting the expressions for these quantities. We have found operating conditions of the model under which either maximum power is delivered or optimized e ciency is attained and have been able to explicitly compare their e ciencies. These theoretical results propose the extents and limits to be considered in the design of actual B rownian heat engines which, of course, take nite time to accomplish any task.
