\Spin-D isentangled" Exact D iagonalization of R epulsive H ubbard System s: Superconducting Pair P ropagation

By a novel exact diagonalization technique we show that bound pairs propagate between repulsive Hubbard clusters in a superconducting fashion. The size of the matrices that must be handled depends on the number of ferm ion con gurations per spin, which is of the order of the square root of the overall size of the Hilbert space. We use CuO₄ units connected by weak 0-0 links to model interplanar coupling and c-axis superconductivity in Cuprates. The num erical evidence on Cu₂O₈ and Cu₃O₁₂ prompts a new analytic scheme describing the propagation of bound pairs and also the superconducting ux quantization in a 3-d geom etry.

Evidence for pairing in the repulsive H ubbard and related m odels has been reported by several authors. A nalytic approaches [1] [2], even at strong coupling [3], generalized conserving approximation theories like FLEX [4], as well as Q uantum M onte C arb Studies on supercells [5] lead to this conclusion. However, we want m one evidence about the real nature of the pairing interactions. Su and cow orkers [6] have reported that in narrow bands one- and two-dimensional H ubbard m odels no kind of superconducting bng-range order holds at any non-zero temperature. Here we wish to explore the possibility that the H ubbard m odel can show superconductivity in the ground state when interplanar coupling is allowed. Since one cannot m aster the problem with an in nite stack of in nite planes, som e econom y is needed. How ever in high-T c superconductors the coherent length is a few lattice constants, and Cu-O planes can be approximately represented by clusters that are large enough to host a bound pair. The interplanar hopping does not dissolve pairs and superconducting ux quantization is their clear signature. The m agnetic properties of attractive H ubbard m odels have been studied by C anright and G irvin [7]; here we propose a gedankenexperiment very m uch in the spirit of Little and Parks [8], in the repulsive case.

The repulsive H ubbard H am iltonian of fully sym m etric clusters C has two-body singlet eigenstates without double occupation [9] [10] [11] [12] called W = 0 pairs. The presence of such solutions at the highest occupied level of the non-interacting (Hubbard U ! 0) system is necessary to allow $_{\rm C}$ (N) < 0 where $_{\rm C}$ (N) = ${\rm E}_{\rm c}^{(0)}$ (N) + ${\rm E}_{\rm c}^{(0)}$ (N 2) $2{\rm E}_{\rm c}^{(0)}$ (N 1), and ${\rm E}_{\rm c}^{(0)}$ (N) is the interacting ground state energy of the cluster C with N fermions. By m eans of a non-perturbative canonical transform ation [2] [13], it can also be shown that $_{\rm C}$ (N) < 0 is due to an attractive pairing e ective interaction and at weak coupling j $_{\rm C}$ (N) j is just the binding energy of the pair.

 $C uO_4$ is the smallest cluster which fully preserves the point-sym m etry of the C opper-O xide planes of high-T_c m aterials. We have already described W = 0 pairing in great detail as a function of the one-body and interaction parameters on all sites; the study was extended to larger clusters too [1] [11]. W = 0 bound pairs in the C uO₄ cluster are found to exist in the physical region of the parameter space. However, since it is the sym m etry that produces the pairing force we use the sim plest working m odel to study bound pair propagation. Here, in order to sim plify the analytical form ulas, we neglect the O-O hopping term and also any distinction between C u and O sites (except geometry, of course). The only nonvanishing hopping m atrix elements are those between an O xygen site and the central C opper site; they are all equal to t. For the sake of sim plicity, we parametrize the H ubbard m odel in such a way that actually everything depends only on the ratio U =t; the im portant thing is that in this way we still have access to the part of the parameter space where pairing occours [9]. Thus, we consider the H ubbard H am iltonian

where p_i^y and p_i are the creation and annihilation operators onto the O xygen i = 1; ::; 4 with spin $= "; #, d^y$ and d are the creation and annihilation operators onto the C opper site, while $f_i^{(p)} = p_i^y p_i$ and $f_i^{(d)} = d^y d$ are the corresponding number operators. H_{CuO4} is invariant under the permutation G roup S [4], which has the irreducible representations (irreps) A₁ (total-symmetric), B₂ (total-antisymmetric), E (self-dual), T₁ and its dual T₂, of dimensions 1, 1, 2, 3 and 3, respectively. The ground state of CuO₄ [2] (i.e. CuO₄ with 2 fermions) belongs to ${}^{1}A_{1}$ and that of CuO₄ [4] is in ${}^{1}E$; both are singlets, as the notation in plies. The ground state of CuO₄ [3] is a ${}^{2}T_{1}$ doublet. _{CuO₄} (4) < 0 for this model when 0 < U < 34:77 t, as shown in Fig.(1).

Thus, we introduce a graph with CuO 4 units as nodes. The total Ham iltonian is

where $p^{y}_{,i}$ is the creation operator onto the O xygen i = 1; ::; 4 of the -th cell and so on. Hence, the point sym metry G roup of H₀ is S [4]^j, with j j the number of nodes. There are many dimensional ways to model an inter-planar hopping. Nevertheless, to preserve the sym metry that produces the $_{CuO_{4}}(4) < 0$ property, H must be invariant under the S [4] diagonal subgroup of S [4]^j. In the following we shall consider a hopping term allowing to a particle in the i-th O xygen site of the -th unit to move tow ards the i-th O xygen site of the -th unit with hopping integral :

For N = 2j j and 0, the unique ground state consists of 2 ferm ions in each CuO₄ unit. This paper is devoted to the inter-planar hopping produced by small $j_{CuO_4}(4)$ jwith a total num ber of particles N = 2j j+ 2p; p represents the num ber of added pairs. When U=t is such that $CuO_4(4) < 0$, each pair prefers to lie on a single CuO₄ and for N = 2j j+ 2p the unperturbed ground state is $2^p \qquad p \\ p \\ p \\ times degenerate (since ¹E has dimension 2).$

By this sort of models one can study the interaction of several ferm ion pairs in the same system. The simplest topologically non-trivial graph is the ring, with a set = f1;2;:::;jj and

where is the magnetic ux concatenated by the ring and $_0 = \frac{hc}{e}$. In the absence of magnetic eld, will be taken to be real.

N ote that for p=0 the concentration (number of holes per atom) is 2=5=0.4; this is som ewhat m ore than half-lling (1=3 0.33) but still reasonable. We are using CuO₄ as the unit just for the sake of sim plicity, but the W = 0 m echanism produces bound pairs at dierent llings for larger clusters [12] and the full plane [1] [2] too. By replacing CuO₄ by larger units one can model other ranges of the hole concentration.

We exactly diagonalize the j j = 2 and j j = 3 ring H am iltonian; to this end we introduce the Spin-D isentangled technique. We let $M_* + M_{\#} = N$ where M is the number of particles of spin ; fj ig is a real orthonorm albasis, that is, each vector is a hom ogeneous polynom ial in the p^y and d^y of degree M acting on the vacuum. We write the ground state wave function in the form

which show show the " and # con gurations are entangled. The electrons of one spin are treated as the \bath" for those of the opposite spin: this form also enters the proof of a fam ous theorem by Lieb [14]. In Eq.(6) L

is a m * m * rectangular matrix with m = $\frac{5j}{M}^{j}$. We let K denote the kinetic energy m m square matrix of H tot in the basis fj ig, and N $_{s}^{()}$ the spin- occupation number matrix at site s in the same basis (N $_{s}^{()}$ is a sym metric matrix since the j i's are real). Then, L is acted upon by the H am illonian H tot according to the rule

In particular for $M_* = M_{\#}$ ($S_z = 0$ sector) it holds $K_* = K_{\#}$ and $N_s^{(")} = N_s^{(\#)}$. Thus, the action of H is obtained in a spin-disentangled way. In the $S_z = 0$ sector for $j \neq 3$ the size of the problem is 1863225 and the storage of the H am illionian matrix requires much space; by this device, we can work with matrices whose dimensions is the square root of those of the H ilbert space: 1365 1365 matrices solve the 1863225 1863225 problem, and are not even required to be sparse. We believe that this approach will be generally useful for the many-ferm ion problem. Since we are mainly interested in getting the low-lying part of the spectrum as fast as possible we opted for the Lanczos method, taking advantage from our knowledge of the S [4] irrep of the = 0 ground state; the scalar product is given by $h_1 j_2 i = Tr(L_1^{Y}L_2)$. In this way, the H am iltonian matrix takes the tri-diagonal form; how ever a num erical instability sets in well before convergence is achieved if one uses chains longer than a few tens of sites. Therefore we use repeated two-site chains alternated with moderate-size ones.

The two-CuO₄ ring (14,400 con gurations in the S_z = 0 sector) is readily solved by a M athem atica code on the personal computer; how ever, this cluster is not adequate for studying the quantization (superconducting or otherwise) of a magnetic ux by the bound pair. The reason is that the two units are each at the left and at the right of each other; any vector potential perpendicular to the CuO₄'s can always be gauged away. How ever, we have veri ed that the ground state energy with 6 holes is $E_{CuO_4}^{(0)}$ (6) = $E_{CuO_4}^{(0)}$ (4) + $E_{CuO_4}^{(0)}$ (2) for

= 0 and it receives a negative correction / 2 =j $_{Cu0_{4}}$ (4) j for sm all , which is consistent with the presence of a bound pair.




FIG. 2.: Num erical results for Cu_3O_{12} with = 0:001. Lowest-energy eigenvalues labeled by their interplanar quasimom entum are shown versus ux. The pattern is periodic (a ux quantum can be gauged away). (a) U = 0. A paramagnetic current is excited by the eld and the system is utterly normal. (b) U = 5. The ground state shows a clear superconducting pattern, with a minimum at $= \frac{0}{2}$. All energies are in tunits.

The three $C \cup 0_4$ ring behaves similarly, but can also concatenate a $\cup x$. In Figure (2.a) and (2.b) we show the low est eigenvalues versus for U = 0 and U = 5 t, respectively; k denotes the interplanar quasi-m om entum quantum label. At = 0 the ground state energy is $E_{C u_3 O_{12}}^{(0)}(8) = E_{C u_0 O_4}^{(0)}(4) + 2E_{C u_0 O_4}^{(0)}(2)$ and the low energy sector derives mainly from the tensor product of the ground states of three independent CuO4's with 4,2 and 2 holes (which is the foundam entalm ultiplet) and 3, 3 and 2 holes (which is the lowest lying excited multiplet separated by a gap $C_{UO_4}(4)$). For U = 0, see Fig.(2.a), there is no pairing in C_{UO_4} and indeed the ground state energy is linear in the eld at small elds (norm al Zeem an e ect). The lowest state is k = 2 throughout. Interestingly, Cu_3O_{12} concatenated with half a ux quantum would be diamagnetic, but the absence of a second minimum shows that it would be Larm or diam agnetism. By contrast, at U = 5 t, when pairing in CuO₄ is about optimum, see Fig.(1), the k = 2 state is lowest in the central sector, k = 0 is the ground state at ! 0 while k = 1 is lowest as ! 0, see Fig.(2 b); this produces level crossings and the superconducting ux quantization; there is a central m in in um when the system swallows a half quantum of ux while, as we veried, $c_{u_3,0_{1,2}} < 0$. Rem arkably, one also observes superconducting quantization of a magnetic ux orthogonal to the plane [12]. W ith increasing U=t, the binding energy of the pair starts decreasing and eventually vanishes forU 34:77 t; we have found that at this point the ux quantization returns norm al and the system behaves like a param agnet. Even at optim all, the side barriers are depressed by increasing ; at 0:1 tonly sm all rem nants rem ain; for still larger interplanar hoppings the superconductivity is rem oved and a pattern sim ilar to Fig.(2.a) prevails. For larger j j a sm aller supercurrent would be necessary to screen the half ux quantum and the critical which kills the superconductivity should be expected to grow larger.

In order to better analyze the results physically and extend them qualitatively to arbitrary graphs, we obtained an e ective H am iltonian by the cell-perturbation m ethod with H₀, Eq.(3), the \cellH am iltonian" and H , Eq.(4), the \inter-cell perturbation" and by taking into account only the low-energy singlet sector. We note that the cell-perturbation m ethod w as already used in Ref. [15] to support the original Anderson's conjecture [16] on the \low-energy equivalence" between the d p m odel (proposed by Em ery [17]) and the single-band H ubbard m odel. Despite the analogies with Ref. [15] (like the same cellH am iltonian and weak 0-0 links between di errent cells) our inter-cell perturbation is di errent and, m ore in portant, it is the low-energy sector which di ers (one needs to consider CuO₄ units with 2, 3 and 4 holes to get bound pairs, in contrast with 0, 1 and 2 holes of Ref. [15]).

For a general graph , with $2j \neq 2p$ holes, we treat H by a simplified second-order degenerate perturbation theory, since H is a one-body operator. Each degenerate unperturbed ground state j_0^S im ay be labelled by a set S of units occupied by four holes; j = p. The secular problem yields the eigenvalue equation

where the sum has been truncated to the low-energy excited eigenstates involving CuO_4 units with 2 n 4 holes, all taken in their ground states $j_0^{(n)}()i; = 1:::jj$. The amplitude $a_s = a(_1;:::;_p)$ is totally symmetric with respect to permutations of the distinct indices $_1;:::;_p$. Letting $C() = f_2 : 6 Og$, after some a lgebra Eq.(8) m ay be written in the form :




FIG. 3.: (a) $(j^e \neq j)^2$ versus U=t. (b) Results of Eq.(9) for Cu_3O_{12} with = 0.001 t, U = 5 t. Lowest-energy eigenvalues labeled by their interplanar quasi-m om entum are shown versus ux . All energies are in tunits.

In Fig.(3.a) we show the trend of $(j^e \neq j)^2$ versus U = t; we note that the ratio decreases m onotonically. In Eq.(9), the rst term in the rh.s. describes hole pair propagation, e.g. from unit j to an unoccupied unit ; in the second sum, the system gets back to the initial state after virtually exploring unit ; the term $_{i \in j}(1)$ takes into account that if is one of the occupied units, the particle cannot m ove toward it. D ue to the m inus sign, the term in $jT_{i,j}^{Bose}$ prepresents pair-pair repulsion.

In Fig.(3 b) the superconducting ux-quantization for the j j = 3 ring is reported as reproduced by solving Eq.(9); it agrees well both qualitatively and quantizatively with the num erical results of Fig.(2 b), thus conming the above approximation. More data and a fuller account of the low-energy theory will be presented elsewhere.

In conclusion, we used a set of CuO_4 units connected by weak O-O links to model interplanar coupling and c-axis superconductivity in Cuprates. The results show that the system with two holes in each unit is a background such that inserting 2p holes one gets p pairs, bound by the repulsive interaction. The bound pairs propagation is well described by Eq.(9). We found analytically the superconducting ux quantization in the ring-shaped systems and con rm ed this noting num erically for the 3-unit ring (1,863,225 con gurations). To this end, we introduced a novel exact-diagonalization technique, which reduces the size of the m atrices that m ust be handled to the square root of the overall size of the H ilbert space. A ctually, real system s contain also vertical links via the orbitals of the apical oxygens. We expect that the inclusion of these hoppings does not change qualitatively the results since they do not contribute to the propagation of the bound pair in the lowest-order approxim ation.
