# Low Tem perature $P$ roperties of the $R$ andom $F$ ield $P$ otts $C$ hain

#### Abstract

The random eld $q$-States $P$ otts $m$ odel is investigated using exact groundstates and nitetem perature transfer $m$ atrix calculations. It is found that the dom ain structure and the $Z$ eem an energy of the dom ains resem bles for general $q$ the random eld Ising case ( $q=2$ ). $T$ his is also the expected outcom e based on a random $-w$ alk picture of the groundstate. T he dom ain size distribution is exponential, and the scaling of the average dom ain size w ith the disorder strength is sim ilar for q anbitrary. T he zero-tem perature properties are com pared to the equilibrium spin states at sm all tem peratures, to investigate the ect of localrandom eld uctuations that im ply locally degenerate regions. The response to eld perturbations ('chaos') and the susceptibility are investigated. In particular for the chaos exponent it is found to be 1 for $q=2 ;::: ; 5 . \mathrm{F}$ inally for $q=2$ (Ising case) the dom ain length distribution is studied for correlated random elds.

## I. INTRODUCTION

Adding disorder to random $m$ agnets creates new effects one the prim e exam ples being the random eld Ising
 rectly to the order param eter one has interesting physics
 $W$ ith a nite tem perature the disordering e ects of entropy and local elds com pete.

The purpose of this article is to explore the generalization or extension of the one-dim ensional RFIM to the one-dim ensional random - eld Potts model. The 1d RFPM is de ned on a chain of $L$ spins (w th periodic boundary conditions being used here) where each spin site can be in one of $q$ states. The H am iltonian is given by

where hi; ji are nearest-neighbour pairs and ; 0 the K ronecker-delta, i.e., ; $0=1$ for $=0$ and ; $0=0$ otherw ise. The vector $\sim_{i}$ is a unit vector pointing random ly in one of the $q$ spin directions and $h_{i}$ is the local eld strength which is chosen either constant or random ly distributed. In the num ericalcom putation spresented below we have used a G aussian distribution for the random elds w th $\mathrm{hh}_{\mathrm{i}} \mathrm{i}=0$ and $\mathrm{hh}_{\mathrm{i}}{ }^{2} \mathrm{i}=\mathrm{h}_{\mathrm{r}}{ }^{2}$; such that $\mathrm{h}_{\mathrm{r}}=\mathrm{J}$ is a $m$ easure for the strength of the disorder, except at nite $T$ where elds are uniform ly distributed between
[ ;+ ]. In the follow ing we denote the one-dim ensional versions of the RFIM and the RFPM w ith RFIC (random eld Ising chain) and RFPC (random eld Potts chain). O ur approach is to explore the RFP C by three di erent techniques. $W$ e com pute the exact $G S$ by using a short-
 idea that allow sto nd the GS of the RFIC, and can be understood as the zero-tem perature lim it of the transfer $m$ atrix com putation of the equilibrium spin state. This
is also em ployed here, to com pare that state w ith the G S. Finally we resort to a qualitative description in term $s$ of a random walk (RW) picture of the groundstate. T his is also_an extension of the RFIC case, where an earlier paper [T] $\overline{1}]$ presented a RW description of the exact groundstates.

There is rather little work on the RFPC w ith the exception oftrivial eld distributions $\left[\begin{array}{c}\overline{8}, 1,1,1 \\ \hline 1\end{array}\right]$. Thus it is w orth to recapitulate som e of the features of the RFIC or the reasons why it still receives som e attention. D ue to the fact that the $m$ odel is one-dim ensional one could expect that the basic $m$ agnetization properties are $m$ ore or less trivial. It tums out to be so, how ever, that in particular for binary random eld distributions ( $h_{i}=h_{f}$ ) these
 the localm agnetization can be considered as a 1d dynam ical system $w$ th, for suitable param eters, a m ultifractal probability distribution [12 1 ]. For the RFPC this is perhaps also the case, generalized to higher dim ensions if $q>2$. In this article we om it such considerations for the sake of the equilibrium and groundstate properties.

O ne of the points of an exact solution for the GS is that it can be investigated how exactly the introduction of a sm all, nite tem perature breaks up the GS. For the RFPC it is m ore or less trivial that the overlap betw een the G S and the T > 0 state stays close to one, contrary to e.g. spin glassesw here this question $m$ ay stillube open to a debate. H ow ever, it is of interest to study how exactly the GS is m odi ed by the \easy" excitations. These are, as discussed below, related to the alm ost degenerate regions of the GS. The equilibrium state is also of interest as the asym ptotic one for out-ofequilibrium processes. In such one-dim ensional system $s$ the dom ain $w$ alls undergo activated dynam ics, in particular the R F IC ones perform Sinaiwalks [131, '14 $\left.\mathbf{1}_{1}^{\prime}\right]$.

The structure of the rest of the paper is as follows. F irst we overview, in section II, the theoretical expectations for the groundstate properties and outline qualitatively the consequences for perturbations from a given GS, whether by tem perature or by changing the local
elds (by random shifts or by an uniform applied eld). Section III is devoted to exact num erical studies of the RFPC. In Section IV the tem perature is switched on, and the e ect ofentropy on the dom ain structure is analyzed. Section V contains a brief num erical study of the e ect of correlated elds. Finally, Section V I nishes the paper w ith conclusions. The num erical techniques are discussed in the A ppendioes.

## II. RANDOM WALKS:DECOMPOSITIONOF THE GROUNDSTATE

W e have earlier presented a w ay to divide the sequence ofrandom eldsh $h_{i}$ for the RFIC in such away so that one can understand the ensuing dom ain structure [ $\left.\overline{1}_{1}\right]$. The idea is to look at trial random walks: start from a test site, and follow the sum ofthe random elds left/right (an arbitrary choice). E ach of such trials constitutes either an absorbing or non-absorbing one. The term s describe the fact that trials are random walks w ith absorbing boundaries. O ne boundary results in an excursion of the RW which is such that enough Zeem an energy (2J) is accu$m$ ulated to form a dom ain, but if the other one is $m$ et
rst the try is nished and a new one is started. Since the RW 's are independent, the GS factorizes. M athem atically such excursions are given by the follow ing rules. A $n$ absorbing excursion (ae) is a sequence $S$ of spins starting at som e lattice site $i$ and ending at $j \quad i, w$ th the
eld sum $j{ }_{i 2} \mathrm{~s}_{\mathrm{i}} j$ for the rst tim e becom ing greater or equalto 2 J . On the other hand a sequence $S^{0}$ of spins from $i_{P}$ to $j \quad i$ is a non-absorbing excursion (nae) if $0<\sum_{\mathrm{l}=\mathrm{i}}^{\mathrm{j}} \mathrm{h}_{\mathrm{l}}<2 \mathrm{~J} 8 \mathrm{i}<\mathrm{k}<\mathrm{j}$; where $=1$ is the orientation of the spins $w$ thin the preceding absorbing excursion.

A s shown in $F$ igure ${ }_{1}^{111}$ for each dom ain one has at least one such absorbing $R \bar{W}$ (it can contain $m$ ore than one such large uctuation) and it will be bounded by the next opposite absorbing RW 's on each side. The rules to be follow ed are: (1) D eterm ine an absorbing excursion $S_{0}$ for a given eld con guration. If it starts at site $i_{0}$ and ends at $j_{0}$, and is the sign of its eld sum , then $k=$ $8 \mathrm{k} 2 \mathrm{~S}_{0}$. (2) Starting from $\mathrm{j}_{0}+1$ nd allnon-absorbing excursions until the next absorbing excursion $S_{1}$ (from $i_{1}$ to $j_{1}$ ) is found, whose eld sum is by de nition opposite in sign to the preceding one. The sites $k$ belonging to the non-absorbing excursions have the sam e orientation
$k=\quad$ as those $w$ ithin $S_{0}$. $T$ he orientation of the spins at sites $l \mathrm{w}$ th in $\mathrm{S}_{1}$ is opposite to the later one, ${ }_{1}=$. (3) Starting at $j_{1}+1$ the search (2) for the next absorbing excursion then leads to the overallg $S$.

This picture explains also, for binary random elds $h_{i}=h$, the degeneracy of the RFIC. For our punposes it is $m$ ore im portant to note that for any kind of perturbations it im plies that there are three processes, dom ain wall-shifts, destruction and creation ofdom ains, that follow naturally from the sequence of RW 's. If one changes the local random elds som e of the absorbing excursions

becom e non-absorbing, and thus dom ains are destructed while new ones $m$ ay ensue if som e non-absorbing ones becom e absorbing. These are in principle easy and in practioe cumbersom e (since one needs to be concemed w ith the exact rst passage properties of the perturbed eld distributions or random walk step length distributions) to com pute for each process. M oreover, the nom al outcom e is that the dom ain-walls are shifted. The $m$ ajor results that follow for the RFIC from the RW picture concem the dom ain structure and optim ization. T he do$m$ ain $m$ agnetic (Zeem an) energy scales linearly with dom ain size in contrast to the $\mathrm{Im} \mathrm{ry}-\mathrm{M}$ a argum ent [1] dom ain size distribution is exponential, and for $\bar{h}_{r} \quad 1$ the Im ry M a result $h h_{d} i \quad 1=h_{r}^{2}$ is recovered since both the contributions from the non-absorbing walks and the absorbing ones that contribute to the dom ain length scale w ith $1=\mathrm{h}_{\mathrm{r}}^{2}$. Thus for the RFPC it w ill be interesting to com pare both the dom ain structure and the Zeem an energy,

For the Potts model one can use the same thought experim ent: assume the spin $i=q^{00}$, and look for \absorbing excursions". N ow, in contrast to the $q=2-$ case the general RFPC is m ore com plicated. For each of the other $q^{0} q^{\infty}$ one can follow, analogously to the RFIC, the random walk that results from three steps: 1) null step (local eld aligned to other direction than $q^{0}$ and $\left.\left.q^{0}\right), 2\right)$ positive and 3) negative steps. O ne has q 1 such trial walks, w th the elem entary step direc-
tions being correlated or shared. These follow \partial" sum soflocalrandom elds, according to the rules 1) -3). T hus an analogy of the RF IC results in studying the rst passage properties of a $q 1$ dim ensional space. E ither one of the coordinates is increased, or all of them are decreased ( $q^{0}$-step) at the sam e tim e. O ne is interested in the rst-passage through one of the sides of a hyper-cube in $q 1$-dim ensions, ie. across the plane where $q=2 \mathrm{~J}$. The walk starts in the im $m$ ediate vicinity of the comer ( $0 ;::: ; 0$ ) of the hyper-cube. The sim plest com plication that arises over the $q=2, R F I C$ case is that for each trial walk that com pares any of the spin orientations and the original one there are \em pty" steps consisting of local
elds aligned w th the other $q \quad 2$ possibilities. This im plies that the typical dom ain length $m$ ight sim ply scale w th q , as bome out later by the num erics.

There are two further com plications com pared to the RFIC, both resulting from the fact that the optim ization can not be done as straightforw ardly as in the RF IC due to the factorization of the landscape to absorbing and non-absorbing excursions. Nam ely, for $q>2$ the process is slightly non-local. C onsider the $q=3$ case, and assume that spin i has $q^{0}=1$. If a large uctuation is found by follow ing the appropriate partial sum of the $q^{0}=2$-orientation, and the next one is of $q^{0}=3-k$ ind, one has to consider whether it is energetically more favorable to create a 2 -dom ain, a 3 -dom ain, or both, since the num ber of dom ain walls created can be low ered by om 壮ing in this exam ple the 2 -dom ain. O ne can also use the argum ent the other way: if a large 3-uctuation exists, it is possible to create a 2 -dom ain since one of the dom ain walls is free. The follow ing structure 11113 33 of total energy $E_{i}$, is changed into 1112333 of energy $\mathrm{E}_{\mathrm{f}}$ by ipping a single spin 1 ! 3 (the local random eld $\mathrm{h}_{\mathrm{i}}=\mathrm{h}$ directed along $\sim=3$ at the ipped site). $T$ he latter con guration would be $m$ ore favourable than the form er one if, $\mathrm{E}_{\mathrm{f}}<\mathrm{E}_{\mathrm{i}}$, yielding $\mathrm{h}>\mathrm{J}$. T his show s that the $m$ inim um Zeem an energy of a dom ain of length 1 should at least be $J\left(\begin{array}{l}q\end{array}\right)$.

## III. GROUND STATE PROPERTIES

A. C orrelations am ong the successive dom ains and the evolution w ith increasing disorder

A s noted above the sequence ofdom ains is com plicated due to the joint optim ization. The easiest quantity is to com pare the probability that the third dom ain from the original one is of the sam e orientation as the rst one. W e calculate the probability $P$ (q) of nding the every third dom ain ( $\mathbb{D}_{i+2}$ ) to be the sam e or di erent as the rst ( $\mathrm{D}_{\mathrm{i}}$ ) one. In absence of any correlations am ong the successive dom ains one should expect the probability $P^{n c}(q)$ of obtaining $D i+2$ sam $e$ or di erent $w$ ith respect to $D_{i}$ to be,

W e carried out com putations w ith the Shortest P ath A lgorithm (see A ppendix A ) for $q=2,3,4,5$ states, w ith the eld strength $h_{r}=0: 05$. It is easy to see that $P$ (q) deviates some from the $\mathrm{P}^{\mathrm{nc}}$ (q). Evidently, the system prefers to have the third dom ain di erent from the rst one. O ne can put this in two ways: creating a 121 conguration costs $m$ ore energy, on one hand, and on the other hand as noted before one can add a dom ain at the expense of a single dom ain w allbetw een tw o others (131 becom ing 1231).

T he evolution of the dom ain structure w ith increasing eld amplitude $h_{r}$ di ers fundam entally from the same phenom ena in the RFIC. New dom ains can be created in-betw een tw o earlier ones at a sm aller cost ( 2 J instead of $4 J$ ) . Figure depicts the evolution of the $G S$ dom ains for a $q=5$ states sample $w$ ith identical con guration of the random direction of the local elds but increasing disorder $\mathrm{h}_{\mathrm{r}}=0.05,0.07,0.15$. T he large dom ains are split into sm aller fragm ents, $m$ ostly at their boundaries.

> B. D istribution of dom ain length and Zeem an energy

To com pare w th the $q=2$ or RFIC case we now used a larger system size of $=100000$, w th $\mathrm{n}=10^{5}$ sam ples. $F$ igure' ${ }^{4}$ I' show s the num erical results for the accum ulated Zeem an energy $H_{z}$ as a function ofdom ain length $l_{d}$ for di erent eld am plitudes $h_{r}$. It easy to see that allh $\mathrm{H}_{\mathrm{z}}$ i

$F$ igure show $s$ the $m$ ean dom ain length $h l_{d} i$ for di erent values ofq asa function of the eld am plitude $h_{r}$. T he data along the $x$-axis for $q=3,4,5$ are shifted by factors 2,4 and 8 respectively. In the lim it $h_{r} \quad J$ the data
 $T$ he prefactor of the dom ain length is (see the inset of $F$ igure ' $\bar{S}_{1}^{\prime}$ '), exœpt for $q=3$, linearly dependent on $q$. $F$ igure 'G nally shows the scaling plots of the probability distribution $P\left(l_{d}\right)$ of the dom ain lengths. A part from the

in itial part, the distribution decays exponentially. W e $m$ ay therefore conclude that in spite of the slight correlations in the dom ain structure, the RFPC obeys the sam e scalings in the G S as the RFIC.
C. R esponse to constant external eld

In the presence of an extemal eld favoring one of the spin orientations via an additionalterm $\left.h \quad i(q) \sim_{i} ; \sim_{i} \quad 1\right)$ in the H am iltonian ( $\sim_{\mathrm{i}}$ arbitrary but xed and the same for all sites), the $m$ agnetization becom es of course non-

w th $\mathrm{m}(\mathrm{x})=$ const. for $\mathrm{x} \quad 1$ and $\mathrm{m}(\mathrm{x})=1=\mathrm{x}$ for $\mathrm{x} \quad 1$. The system is sub jected to a constant extemal eld $h$ in a xed direction $a=1$ to evaluate $m_{a}(S ; h)$ for $a$ sam ple $S$ with som e given realization of random elds. To start, $\mathrm{h}=0: 0001$, and the GS magnetization is com puted. Then the eld is increased after averaging 1000 samples, until saturation. $H$ ere $h_{r}=0: 1$, L $2 \mathrm{f} 5000 ; 10000 ; 20000 ; 40000 ; 80000 \mathrm{~g}$ while h is in the interval [0.0001, 0.03]. For sm aller system s one has to use higher values of $h_{r}$, since otherw ise a single dom ain m ay percolate.

## D. Chaos Exponent

A slight variation of the random elds in each sam ple gives rise to \chaos". In the case of the RFIC or RFIM in general this has already been studied $\left.\overline{[1} \overline{1}, \overline{1}, \overline{1} \overline{9}_{1}\right]$. $T$ here the generalbehavior is such that for sm all am plitudes of the localpertunbation the overlap betw een the new and the old GS rem ains considerable, and the difference is a sm ooth function of . This is easy to see if one considers the RW factorization of the G S : a variation of the local elds gives rise to a new RW, in supenposition w ith the original one. In the lim it ! 0 this has only $m$ inute e ects except forbarely absorbing $w$ alks and barely non-absorbing ones that can be a ected if is large enough.T hus the average overlap $q$ is linear for the RF IC in . N ext we look at the chaos properties in the RFPC.

To m odify the initial random elds $\mathrm{h}_{\mathrm{i}}$ at each site i they are replaced by $\mathrm{h}_{\mathrm{i}}{ }^{0}=\mathrm{h}_{\mathrm{i}}+\check{\mathrm{h}}$. As before, $\mathrm{h}_{\mathrm{i}}$ and also $\check{K}$ follow $G$ aussian distributions and the param eter $m$ easures the strength of the perturbation. Denoting $\sim_{i}^{0}$

In Figure, we show the results of our calculation of the G S overlap correlation function C (r). r is varied from 4 up to 160 for each perturbation strength. The obtained data collapse agrees quite wellw ith the argum ent above.
IV. DOMA $\operatorname{IN} S A T \mathrm{~F}$ IN ITE TEMPERATURE
A. Changes w ith the introduction of a $n$ ite tem perature

For $\mathrm{T}>0$ we calculated the expectation values $h_{i} i$ using the transfer $m$ atrix technique $[10, \overline{12}, \underline{1}]$ as described

in A ppendix B. The dom ains start $\backslash m$ elting", i.e. the overlap with the GS, h i i;G $i$ i, decreases, as the tem perature is $s w$ itched on from $T=0$. The e ect of tem perature is sim ilar to a random eld perturbation in the sense that both should play a role in particularw here the uctuations in the random landscape (absorbing/alm ost absorbing walks) $m$ ake it the easiest. On the other hand the e ect of tem perature is not lim ited to those regions, only. Next we com pare the nite tem perature and G S con gurations to ilhum inate the $T>0$ physics.

In $F$ igure ${ }_{1}^{19}$ we represent the destruction of a dom ain for a system of size of $L=400$ and $h_{r}=0.7$, as the tem perature is raised to 02 from $\mathrm{T}=0$. The random eld distribution is uniform in the interval [ $1 ; 1]$. The zero tem perature dom ain from $i=2$ to $i=5$ is due to a single absorbing excursion, depicted by the large shaded region in the upper part of the $F$ igure 'g.'. The inset in the m iddle part show $s$ the sensitive region at $i=5$, where the eld sum just crosses the absorbing boundary. As the tem perature is increased from zero, the entropy gives weight to states where the whole region or much of it is ipped, to the $=1$ state instead of +1 .
$F$ igure ${ }^{1} 10_{1}^{1}$, show $s$ the $m$ elting of $G S$ dom ain at $T=0: 1$ for a system of $L=400$ and strength ofdisorder $h_{r}=1.0$

(the distribution of local elds is again uniform in $[-1,1]$ ). N ow the sum -of-elds random walk in the GS from i $=1$ to 10 is actually part of a non-absorbing excursion inside the em bedding dom ain with $=1$. It is how ever susceptible to the introduction of tem perature (note the spins $i=4$ and 10 where the RW is closest to creating a dom ain, in the inset).

At a nite tem perature the sites 2, 3, 4 form a \new dom ain" w ith $=1$. This new dom ain contains only one part of the RF uctuation, from 1 to 4 .

To further investigate the $m$ elting of a G $S$ dom ains at nite tem peratures, an overview of the GS and equilibrium con gurations at nite tem peratures is shown in $F$ igure $\overline{1} \overline{1} \overline{1}$. T he calculations for each tem perature including the GS are carried out for the same local eld con guration. The thick dotted line corresponds to the GS whereas the continuous lines represents the $m$ elted con gurationsw ith the gradualincrease in tem perature.

In general, for very low tem peratures there are only a few segm ents of spins, which di er from their respective G S orientations [1] , grow ing w ith increasing tem perature in height and width. At high tem peratures ( $T \mathrm{~J}$ and $\mathrm{T} \quad \mathrm{h}_{\mathrm{r}}$ ) the expectation value $\mathrm{h} i$ of each spin nally uctuates around the $m$ ean value $1=q$.
B. D om ains at $T>0$

To construct a dom ain structure at any nite tem perature we focus to the $m$ elting of individual $q$ states. It is

easy to calculate the contribution for each of $q$ states to the resultant $m$ elting by taking a single state in the diagonalm atrix, in the transferm atrix calculation, and keeping the others zero. Them axim um of these contributions w ill give_rise to a de nite local spin state ( $i=1$; ::::q) . $F$ igure 121 (a) represents the G $S$ (straight bold line) and $m$ elted $h_{i} i$ at nite tem peratures for $q=3$. Figures 121 (b), (c), (d) show s the com ponents (for each q) of probability P ( $i=1 ; 2 ; 3$ ) at $T \quad 0$ of individual spins $h_{i} i$ at sites i. C onsider the 1st segm ent of dom ain in (a). It is evident that the $m$ elted dom ain approaches the state $q=3 \mathrm{as}$ con m ed by the behavior of the sam e segm ent in $F$ igures (b), (c) and (d). To analyze the $m$ elting process quantitatively we investigate the probability distributions of length s of the $m$ elted segm ents and the $m$ elting rates $\frac{\mathrm{m}_{\mathrm{i}}}{\mathrm{T}}$, where $\mathrm{m}_{\mathrm{i}}=\mathrm{h}_{\mathrm{i}} \mathrm{i}$ for each of $\mathrm{q}=2,3,4,5$.
W e also com pute the nite tem perature distribution of dom ain lengths. The sim ulations are for di erent tem peratures $w$ th a system of xed $L=300$ and disorder strength $h_{r}=0: 7$. The distribution of local random elds is uniform in $[-1,1]$. The disorder, tem perature, and system size are restricted by the fact that one has to com pute products of $L(q \quad q)$ transfer $m$ atrices. O ne also prefers to avoid Gaussian disorder instead of one w ith a bounded support. It is clear from $F$ igure 1 except for the initial part, the probability distribution $P\left(l_{F}\right)$ varies exponentially $w$ ith $l_{F}$, sim ilarly to $G S$ do$m$ ains. $W$ ith an increasing tem perature the decay in the tailbecom es faster, indicating that correlations dim in ish as expected.

W e de ne the probability distribution ofm elting rates $\frac{\mathrm{m}_{\mathrm{i}}}{\mathrm{T}} \mathrm{as}$,

where $n$ is the number of sam ples. $W$ e $m$ easure the change in $m$ agnetisation $m_{i}$ for each spin $i$ when the tem perature changes by $T$. For counting we use the resolution $=0: 001$, for which $N\left(\frac{\mathrm{~m}}{\mathrm{~T}}\right)$ is actually the num ber of spins i w th $\frac{m_{i}}{T} 2\left[\frac{\mathrm{~m}}{\mathrm{~T}} \quad \overline{2} ; \frac{\mathrm{m}}{\mathrm{T}}+\frac{\mathrm{L}}{2}\right]$.

Figure 14 show $s$ the distribution $P\left(\frac{m}{T}\right)$ at di erent tem peratures for $q=2,3,4,5 ; T=0: 05$ is the same for all tem peratures and $10^{5}$ con gurations. The data points for $\frac{m}{T}$ are not show $n$ as in this regim e we observe a strong $m$ axim um at $\frac{m}{T}!\quad 0$. Forq $=2$ there is a sm all but distinct peak in the curve for $T=0.2 \mathrm{w}$ hich gradually dim inishes for higher values of $q$.

## C. Fin ite tem perature lengthscales

Finally we investigate how the localregions of the m agnetization evolve at nite $T[\underline{1} 1] . W$ e calculate the average length $l_{n}\left(l_{n}=h l_{T} i\right)$ from the nite tem perature congurations. Figure ${ }_{1} \overline{5}_{1}^{\prime \prime}$ represents how this lengthscale changes $w$ ith temperature, if one rst scales aw ay the $T=0$ dependence on the eld. N ote that the tem perature is restricted so that T 0:09. A further collapse $w$ ith the right com bination of $h$ and $T$ m akes it possible to observe an universalscaling function for $l_{n}$ so that

does not change w ith $q$, and thus one has the sam e scaling for $q>2$ as for the RFIC. The implication is basically the sam e: one has per each dom ain a num ber of \easy" excitations that allow the $m$ agnetization to change a lot from the GS. The presence of such alm ost degenerate regions is not a ect by the exact value of $q$.

## V. RFIC W ITH CORRELATED RANDOM FIELDS

W e have already seen that for an uncorrelated random eld distribution the average dom ain length asym ptotically follow s the $\operatorname{Im} r y-M$ a argum ent, i.e. $h l_{d} i=h_{r}{ }^{2}$. $T h$ is should change for spatially correlated random elds. N ow we obtain an exponent with hai $1=h_{r} \quad$ where

approaches 2 as the spatial correlations decrease. C onsider a pow er-law correlation function of the form

for < 1. For > 1 this Im ry M a type argum entpredicts the irrelevance of the correlations in the disorder, i.e. $=2$.
W e com puted the probability distribution $P\left(l_{d}\right)$ on a large system ofsize $L=65536$, w th the local, correlated, G aussian random elds generated by the $N$ oise C onstruction A lgorithm [2] [2]. Statistical averaging w as perform ed
over $10^{5}$ sam ples. A $s$ in the case of uncorrelated elds $P\left(I_{d}\right)$ is again exponential for all values of we studied. $T$ he disorder $h_{r} w$ as varied for each value of , to calculate the exponent from the data collapse of $P\left(l_{d}\right)$ versus $l_{d}$. deviates signi cantly from the predicted value as approaches unity, but nally approach the value 2 for ! 1 . The deviation $m$ ight be due to logarithm ic corrections to the Im ry M a prediction (251) close to the critical value $=2$. The sam e properties can also be ver$i$ ed for the RFPC, if the random eld $m$ agnitudes and their directions obey the sam e correlations.
VI. CONCLUSIONS

It is a fortunate fact that one can solve num erically, but exactly, for the groundstates of the RFPC.For the RFIM one has access to pow erfill graph optim ization $m$ ethods that work in d arbitrary, but for $q>2$ it can actually be shown that the problem is NP -com plete for $\mathrm{d}>1$ [ $\left.{ }_{2}^{11} 1\right]$. H ere we have used this to study the P otts chains, augm ented w th random walk considerations and with transfer $m$ atrix calculations.

As it is already known that the RFIC groundstate is, essentially, separable to independent regions and what the consequences are it is $m$ ost natural to com pare the $q>2$ behavior to the RFIC physics. It tums out that essentially all m ore general scaling behaviors, whether pertaining to the GS or to the nite tem perature states, follow sim ilar law s. This is true, in groundstates, for the Zeem an energy, for the form of the dom ain distribution, and for the average dom ain length. At $T>0$ we have dem onstrated that the change from the G S con gurations follow s a sim ilar course for $q$ arbitrary. $F$ inally also for G S chaos the value of $q$ has no essential im portance.

T here are of course slight di erences since the localdo$m$ ain structure has correlations due to the \decorations" of large dom ains w ith sm aller ones that utilize the fact that only one dom ain wall needs to be created if e.g. induced by increasing the disorder strength. These are of secondary im portance for the scaling properties.
$T$ he greatest deviations from the expected behavior we observed in the case of the RFIC w ith correlated elds, where the scaling exponent of the dom ain length with disorder strength does not seem to take the expected value $=2$ (but is slightly less) for weakly correlated
elds. This $m$ ay be due to corrections to scaling, or to the detailed properties of a RW picture, sim ilarly to the uncorrelated case, when the walks are fractional B row nian $m$ otions.

In the case of the RFPC it is possible to propose a num ber of topics to study. Eg. the generalizations of the $m$ ultifractalm agnetization distributions of the R F IC seem m athem atically interesting. A lso the detailed properties of the $\backslash \mathrm{m}$ elting" of the GS m ight merit further study.

## APPENDIX A

T he ground state of q-State RFPC can be calculated exactly by m apping onto a shortest path problem on an acyclic graph. The graph $G(L ; q)$ corresponding to a $q$ State RF P otts chain of length $L$ consists of $(L+1) ~ q$ nodes which we consider to be arranged like presented in gure 1 and denoted by ( $x ; k$ ) w ith $x=1 ;::: ;$ L and $k=$ 1;::::;q. Each node $(x ; k)$ is connected to all of its right neighbours, i.e. to all nodes $\left(x+1 ; k^{0}\right)$ w ith $k^{0}=1 ;::: ; q$ by a directed onew ay edge $w$ ith cost

Fixing the spin at $x=0$ to be in state $k$ the groundstate ofRFPC then corresponds to a shortest path from $(1 ; k)$ to ( $L ; k$ ) in $G(L ; k)$. To apply periodic boundary conditions it is necessary to solve $q$ shortest path problem $s$, one for each of the $q$ ( $w$ ith ( $q ; q$ ) spins at sites $x=1$ and $x=L+1$ ) possible states. O ne of these shortest paths w ith m inim um energy gives rise to the optim al groundstate.

Since the underlying graph ( $F$ ig. $\cdot]_{1}^{2} \bar{T}_{1}$ ) is acyclic no cycle, in particular none w th negative weight, can occur and D ijkstra's algorithm for nding the shortest path in a weighted graph can be applied although not all edge weights are positive. T he running tim e of this algorithm is linear both in num ber $n$ of the nodes and in the num ber $m$ of the edges, thus the overall com plexity to nd the groundstate of the RFPC w ith periodic boundary condition is $O\left(q^{2} L\right)$.

## APPEND IX B

For tem perature $\mathrm{T}>0$ we generalize the T ransfer M atrix M ethod [22'] for the q-States RFP C. T he calculation of the partition function $Z_{N}$ can be reduced to the problem of nding the product of $N$ random $m$ atrioes:

The only computational e ort consists in calculating the product of $N$ q $q$ transfer $m$ atrices. Since the ele$m$ ents ofL ${ }^{(i)}$ becom e very sm all for low tem peratures, arbitrarily sm alltem peratures can not be considered. H ow ever, the adm issible tem perature interval is su cient for our investigations.
