## Spatial Structure of the Internet Tra c

The Internet infrastructure is not virtual: its distribution is dictated by social, geographical, econom ical, or political constraints. However, the infrastructure's design does not determ ine entirely the information trace and different sources of complexity such as the intrinsic heterogeneity of the network or human practices have to be taken into account. In order to manage the Internet expansion, plan new connections or optimize the existing ones, it is thus critical to understand correlations between emergent global statistical patterns of Internet activity and human factors. We analyze data from the French national Renater' network which has about 2 millions users and which consists in about 30 interconnected routers located in different regions of France and we report the following results. The Internet ow is strongly localized: most of the trace takes place on a spanning' network connecting a small number of routers which can be classified either as active centers' looking for information or databases' providing information. We also show that the Internet activity of a region increases with the number of published papers by laboratories of that region, demonstrating the positive impact of the Web on scientic activity and illustrating quantitatively the adage the more you read, the more you write'.

## I. IN TRODUCTION

Internet connects di erent routers and servers using di erent operating system s and transport protocols. This intrinsic heterogeneity of the network added to the unpredictability of hum an practices [1] make the Internet inherently unreliable and its traccomplex [2{6].

There has been recently major advances in our understanding of the generic aspects of the Internet [7{10] and web [11{16] structure and development. Concerning data transport, most of the studies focus on properties at short time scales or at the level of individual connections [2,17,18], while studies on statistical ow properties at a large scale [3,4,6,19] concentrate essentially on the phase transition to a congested regime. Despite of these results, large scale studies of tractoriations in time and space are still needed before understanding the new social practices of Internet users.

In this paper, we study the spatial structure of the large scale ow. We present in part II the data studied and in parts III and IV the results of our analysis, showing the existence of a spanning network concentrating the major part of the trac. Finally, in part V we relate the ow properties and its spatial distribution to scientic

## II.DATA STUD ED

An important diculty is to obtain real data measurements of the Internet tracon a global scale. The availability of data of the French network Renater' allows us to consider the cartography of Internet's tracand its relation with regional socio-economical factors.

The French network Renater' has about 2 m illion users and is constituted of a nation-wide infrastructure and of international links [20]. M ost of the research, technological, educational or cultural institutions are connected to Renater (Fig. 1). This network enables them to communicate between each other, to get access to public or private world-wide research institutes and to be connected to the global Internet.

We rst restrict our analysis to the national trac and exclude the inform ation exchange with external hosts and routers such as US and Europe Internet or peering with other ISPs. This restriction to a small part of the Renater trac ( 5% of roughly 2000 G igabytes a day) has two methodological advantages: First, it ensures that the trac studied is strictly professional (mail to non-

academ ics, like fam ily, friends, consultation of new spapers, e-com m erce, etc. goes through outer ISP and is not taken into account); Second, it helps to understand the regional tractors. We believe that the global patterns emerging for the Renater network will be relevant for larger structures such as the global Internet.

The data consist of the real exchange ow (sum of Ftp, Telnet, M ail, W eb browsing, etc.) between all routers, even if there is not a direct (physical) link between all of them . For a connection (i; j) between routers i and j (i for j),  $F_{ij}$  (t) (in bytes per 5 m inutes) is the e ective information ow at time t going out from i to j. For technical reasons, data for a few routers were not reliable and we analyzed data for 26 routers which amounts in 26 25 m atrices  $F_{ij}$  (t) given for every t=5 m inutes for a two weeks period (the quantities  $F_{ii}$  are excluded from the present study).

As an example of the measured time-series, we show (Fig. 2) the information ow versus time between two routers located in G renoble and M arseille for a nine days period. One can see the dierent days and within days, bursts of intense activity. In this study, we focus on the ow and not on the growth rate (and its correlations) used in a previous study [21].

## III. DATABASES VERSUS ACTIVE CENTERS

We now present our empirical results. The time averaged incoming ow

at a given router i is a measure of the Internet activity of the corresponding region (the over-bar denotes the average over time). On the other hand, the average outgoing ow

can be interpreted as the total request em anating from other routers. It is thus a m easure of the degree of interest produced by this region.

W e plotted both quantities  $F_{\rm in}$ ,  $F_{\rm out}$  versus their rank (Fig. 3a,b). In contrast with many cases observed since the work of Zipf [22], the observed distributions are not power law sbut exponentials. Thism ight be the signature of a transient regime and would mean that the Internet didn't reach his stationary state, but it is more probably the sign that the Internet trach has a unique, non hierarchical-type structure [23]. This exponential behavior also means that (at least in the Renater network (there are essentially two categories of regions. Considering Internet activity (Fig. 3a), one can distinguish active from

(alm ost) inactive regions. Roughly, there are about eight cities which receives 80% of the total trac, the rest being (exponentially) negligible. Concerning the outgoing ow (Fig. 3b), there are about ve most visited regions, the rest being comparatively unattractive. We checked that for dierent time windows the order of these cities can slightly change, but the exponential behavior is independent of these seasonale ects.

It is interesting to note that the most active and visited regions are not the same showing that each region has its specic activity. Regions with a large incoming ow can be classied as active research centers with a great need of information, and regions with a large outgoing ow correspond to important information resources such as e.g., databases or libraries.

At this stage, we have shown that in the Renater trafc there is a small number of receivers (located in active regions) and emitters (visited databases). However, a further question concerns the secondary routers and the ne structure of ows. Indeed, F  $_{\rm in}$  (and similarly for F  $_{\rm out}$ ) could be a sum of many small contributions coming from many regions, or in contrast there could be only few regions which exchange a signicant ow. Simple quantities which can characterize the ne structure of the incoming ow at router i are the  $Y_{\rm k}$  's introduced in another context [24]

where W  $_{ji}$  = F  $_{ji}$ =F  $_{in}$  is the weight associated with the incoming ow Fii (and similar expressions for the structure of outgoing ow). It is easy to see that  $Y_0 = N$ ,  $Y_1 = 1$  and the rst non trivial quantity is  $Y_2$ . We can illustrate the physical meaning of Y2 with simple exam ples. If all weights are of the same order W i 1=N is very small. In contrast, if one all  $i_i$ ; then  $Y_2$ weight is important for example of the order the others negligible 1=2 (N 1) then  $Y_2$ order unity. Thus  $1=Y_2$  is a measure of the number of important weights. We plot  $Y_2$  for both the incoming and outgoing ows (the statistics is over two weeks). The result (Fig. 4) shows clearly that them ost probable value is 1=4 and that  $Y_2$  is larger than 1=N ' 1=30' 0:03 (except for few cases which appear in the histogram). This conmm s the fact that a few routers are exchanging most of the inform ation, the rest of the network being negligible.

## IV.SPANNING NETW ORK

In order to illustrate the above results, we construct the network  $S_k$  connecting a number k of routers and carrying the maximal ow denoted by  $F(S_k)$ . We increase k from 2 to 26 and we obtain the result plotted in

Fig. (5a). It appears clearly that a small fraction of links carry most of the ow. This behavior is encoded in the fact that  $F_{\text{tot}}$  is a power law for p! 0

with an exponent sm aller than one ( ' 0:6), so that a sm all variation of the number of connections leads to a large variation of the transported ow.

This analysis completes the Renater tracm ap: there is a small number of receivers and em itters exchanging signicant information between them, the rest of the network being exponentially negligible. This demonstrates the existence of a spanning network carrying most of the trac and connecting the main em itters to the main receivers.

In order to visualize this spanning network on the French map, we liter the ow with the following procedure. We rst select ows above a certain threshold  $F_{\rm c}$ , and then we select a connection (ij) only if the corresponding ow  $F_{\rm ij}$  represents a large percentage of (i) the outgoing ow from i and (ii) the incoming ow in j. The result is shown on Fig. 5b. We checked that the instantaneous (or averaged over a dierent time window) spanning network is eventually dierent, but always with the same characteristics (small number of interconnected em itters and receivers). The procedure described above could thus be used as a simple liter in order to visualize in real-time a complex ow matrices.

# V.DIGRESSION TO SCIENTOMETRICS: INTERNET TRAFFIC VERSUS SCIENTIFIC ACTIVITY

So far, we have studied statistical properties of the tra c, but an important point is to relate them to econom icalor social factors. The Internet activity should in principle be related to social pointers such as the num ber of inhabitants, the number of students, and so on. From our data, the indicator which shows the best correlation with Internet activity is scientic activity measured by the number of published papers [25]. One can expect that the more a scientist consults books or data, the more he/she will publish. This principle, the more you read, the more you write', although commonly accepted in a number of historical cases [26], is dicult to evaluate quantitatively. The main diculty being the m easure of the amount of information gathered by scientists in libraries. In the case of Internet, the inform ation gathered by scientists working in a given region can be estimated by the average incoming ow in the corresponding router. Since the information needed for a scientist is usually scattered world-wide, it is important here to take into account the total incoming ow, including exchanges with international hosts. We thus compare

the total average incoming ow (per scientist) with the average number of papers published (per scientist) per year by the region's universities (obtained from the SCI database). As a representative panel, we choose to use data about papers published only by scientists in the national research institution (CNRS [27]). We represent these data on Fig. 6. This plot shows that the average incoming ow per scientist  $\overline{f}$  in a region is increasing with the number of published scientic papers per scientist p by this region's laboratories roughly as a power law

with exponent '11 0:1. This result con mms quantitatively the intuitive principle stated above and is particularly interesting from the point of view of the Web's social in pact. Indeed, it implies that the number of publications is growing with the incoming ow as a power law with exponent 1= '1: the more one uses Internet, the more one publishes! This result indicates that on average the use of Internet has a positive in pact on research productivity.

### VI.CONCLUSION

In sum mary, we have shown that the major part of the tractakes place only between a few routers while the rest of the network is almost negligible. We have proposed a simple procedure to extract this (bipartite) spanning network, which could have some implications in visualization and monitoring of real-time trac. In addition, resources allocation and capacity planning tasks could bene t from the knowledge of such a spanning network. These results point towards new ways of understanding and describing real-world trac. In particular, any microscopic model should recover these statistical properties and our results provide a quantitative basis for modeling the dynamics of information ow.

We also have shown that the scientic activity of a region is increasing with its Internet activity. This indicates that it is dicult for a scientist to avoid the use of Internet without a ecting his/her productivity measured in terms of publications. This result also demonstrates that in addition to increase people's social capital [28] the Internet has a measurable positive impact on research production. More generally, it underlines the importance of Internet as knowledge sharing vector. This study also suggests that the Internet activity could be used as an interesting new socio-economical pointer well adapted to the information society.

Finally, these results exhibit some global statistical patterns shedding light on the relations between the Internet and economical factors. It shows that in addition to the structural complexity of the web and the Internet, the trachasits own complexity with its own cartography.






FIG.2. Lin-Log plot of the information ow versus time from G renoble to M arseille over a 9 days period. We represent the raw data: the number of bytes (per 5 m inutes) exchanged between these two cities. One can see the dierent days and within days, bursts of intense activity.








FIG.3. Exponential disparities between regions. Lin-Log Zipf (rank) plot of the Internet activity (in bytes=5m inutes) a Incom ing ow F  $_{\rm in}$  and b outgoing ow , averaged over two weeks. The relation is an exponential (indicated by solid lines) F  $_{\rm in\;(out)}$  = exp( r=r\_{\rm in\;(out)}) with r\_{\rm in} '8 in the case (a) and r\_{\rm out} '5 for case (b). This result allows one to separate regions in two distinct groups: 'active' (r < r\_{\rm in\;(out)}) and 'inactive' ones (r > r\_{\rm in\;(out)}). We indicate in each case, the four rst cities. This order can change according to di erent period, but the exponential behavior will still holds.






FIG. 4. Fine structure of ows. We represent the probability distribution of  $Y_2$  for both incoming and outgoing ows. A small value of  $Y_2$  corresponds to a very 'fragmented' ow, while a large value means that there are only one or two important contributions, the rest being negligible. The arrow indicates the value  $1\!=\!N$ ′ 0.03 which corresponds to ows for which each router contributes. The distributions are peaked for  $Y_2$ ′ 0.2 and are concentrated in the range 0.2 1. This indicates that essentially a few routers contribute to each ow.

In insert, we show the same p but in Log-Log showing that for p' 0, the ow is growing as a power law p with p' 0.6. b We apply the litering procedure explained in the text and we obtain the spanning network. In this example, it is constituted by 14 connections between 11 routers (which is p' of the total number possible connections) and carries 30% of the total ow. On this map, the width of the connection is a slowly increasing function of the volume ow passing in it.




FIG. 6. Intermet activity versus scientic research. Intermet activity versus scientic research. Log-Log plot of the incom ing ow per scientist in a region versus the average ratio of scientic papers per scientist published (per year) by scientists working in that region. The solid line is a least square estimate with a slope of order 1:1 0:1. The correlation coe cient C = 0:80 while F = 41 for one degree of freedom. This plot shows that scientic productivity is increasing with Intermet activity.
