Statistical properties of the Jakarta and K uala Lum pur stock exchange indices before and after crash

U sing the tools developed for statistical physics, we simultaneously analyze statistical properties of the Jakarta and K uala Lum pur Stock E xchange indices. In spite of the sm all num ber of data used in the analysis, the result shows the universal behavior of com plex systems previously found in the leading stock indices. We also analyze their features before and after the nancial crisis. We found that after the crisis both stocks do not show a same statistical behavior. The impact of currency controls is observed in the distribution of index returns.

I. IN TRODUCTION

Recently, there have been considerable e orts to analyze nancial data by means of methods developed for statistical physics [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14]. M otivated by the scienti c challenge to understand the nature of complex systems, physicists have started to direct their attentions to a huge, and also growing am ount of econom ics data recorded m inutes by m inutes for decades. Am ong these interesting data, the uctuation of stock exchange indices is of special interest, since it might indirectly re ect the economic situation in a certain region and som e people happily speculate their money on it. Furthermore, the advancement in computing capabilities has enabled them to handle a large am ount of data, unlike alm ost 40 years ago when M andelbrot investigated approximately 2000 data points of cotton prices [15].

It is then expected that such studies could explain the nature of interacting elem ents in the complex system and, therefore, could help to forecast econom ic uctuations in the future. In other words, these studies were intended to produce new results in econom ics, which m ight help us to avoid econom ic \earthquakes" such as what happened in Indonesia a few years ago [16].

P revious studies in this subject so far have focused only on the long-term behavior of the leading stock indices. This is understandable, since to statistically investigate the universal features in econom ic activities one has to have a large am ount of data. Very little attentions are given to investigate what happen to the stock markets in developing countries (e.g., Indonesia) as well as what happen to the stock indices before, during, and after a nancial (orm onetary) crash, although in the latter the m ost in portant ingredients of the nancialm arket or econom ic uctuation could exist [10, 11, 12].

It is the objective of this paper to study the general statistical properties of the uctuation in stock indices in two developing countries, as well as their properties before and after a nancial crashes. This study is in portant in order to investigate the extent of the universality of com plex behavior found previously in the leading stock indices, such as S& P 500 and NY SE. Such investigation will naturally shed important information on the variation of the universal constants in the scaling behavior of the stock index. W ith this information at hand it is then possible to identify the statistical properties that quantify di erent behaviors in stock markets and those which indicate a crash or stable condition. For this purpose we take two di erent indices, the Jakarta Stock Exchange Index (abbreviated with IHSG, an acronym of Indeks Harga Saham Gabungan or composite stock exchange price index) and the K uala Lumpur Stock Exchange index (KLSE), which belong to di erent countries. Comparing the two indices would be very interesting since both Indonesia and M alaysia underwent the




FIG.1: The Indonesian and M alaysian G ross D om estic P roducts along with their populations. The vertical line indicates the year when the monetary and nancial crisis started to occur in the A sia region. In both countries the nancial crisis was started on July 1997, the impact was naturally recorded as the 1998 GDP.D ata are taken from [17].

same monetary crisis in 1997, which are then followed by nancial crashes in almost all econom ic sectors, but with quite di erent econom ic situations. A s has been often discussed, the behavior of two stock indices could be very di erent although the two stock markets are situated in the same region.

Before proceeding to the analysis, it is worth to glance at the Indonesian and M alaysian G ross D om estic P roducts (GDP) shown in Fig.1. Before the crisis the growth rate of the Indonesian GDP seems to be faster than that of Malaysian GDP. The monetary crisis in 1997 has a clear impact on both GDPs. Nevertheless, the impact on Indonesian GDP is more obvious. After the crisis, M alaysia was rather successful to stabilize its econom ic situation and did not accept the International M onetary Fund (IMF) prescription. Three years after that Malaysia was able to put its GDP slightly above the previous value in 1997. On the other hand, Indonesia was unable to stop the declination of Rupiah against US Dollar and decided to ask the IMF to help stabilizing its monetary condition. O ther crises, which followed the m onetary crisis, are blam ed as the reasons of this.

II. GENERAL PROPERTIES

A. Tim e Series and Index Returns

In our analysis we investigate the daily index returns, which are de ned as

with Y (t) indicates the closing index of the stock at day t. Som e previous studies [6, 7] are perform ed with the return de ned as the di erence in the index, instead of the di erence in the logarithm of index as given by Eq.(1). However, in our analysis we found that the results of calculations by using both m ethods do not di er signi cantly.

The available data for the IH SG index are the daily closing index data recorded from January 1988 to A pril 2002 which consist of 3526 data points. The K LSE data contain also the daily closing index starting from December 1993 and ending with June 2002, which com prise totally 2104 data points. The number of data in both indices seem s to be the rst obstacle in this analysis, since com pared with the previous analysis on the S& P 500 index, e.g. Ref. [9], which used approximately 5 10^6 data points, the num ber turns out to be extrem ely sm all. How ever, as shown by M andelbrot in his analysis on the cotton prices, even with about 2000 data points it is still possible to extract a quantitative conclusion from the data.




FIG. 2: The ratio between 1000 Indonesian Rupiah and 1 US Dollar (top), the Jakarta Stock Exchange Index (IH SG) Y (t) (m iddle) and the logarithm ic return Z (t) calculated from Eq.(1) as a function of time t sampled with t = 1 day (bottom). The arrow in the m iddle panel indicates the lowest value position of Y (t) in 1998. Two vertical dashed lines in the gure de ne the crash period during which the Rupiah exchange rates dropped signi cantly relative to US Dollar. D ata are taken from [19] (ID R/USD exchange rate) and [20] (IH SG stock index).

Figure 2 shows the time series of the IH SG index along with the logarithm ic returns calculated by using Eq.(1). It is naturally di cult to de ne when exactly the crisis

(or crash) started and when it nished. To get around this di culty, in Fig.2 we also display the historical time series of the exchange rate between 1000 Indonesian Rupiah and 1 US D ollar, since the econom ic crash started with the decline of this rate. The available data do not 11 the entire range, nevertheless they are su cient to locate the period of the crisis. It should be noted that before the monetary crisis the government intervention on this exchange rate was very strong and as a consequence, although the Rupiah was not pegged to US D ollar with a xed rate, the uctuation in the exchange rate was relatively tiny.

In Fig.2 we indicate the period when Rupiah started to continuously drop (10th July 1997) until it reached the minimum point (23rd January 1998). The IHSG index also dropped signi cantly during this period. However, the index continued to strongly uctuate and reached another minimum about one year later due to the unfortunate political situation. The same phenom enon also happened in the foreign exchange rate, though with a di erent scale. In view of this, according to the IHSG index, the duration of nancial crisis could be longer than one year.

Figure 3 displays the historical time series of the KLSE index along with their logarithm ic returns and the ratio between 1 M alaysian R inggit and 1 US Dollar. Coincidentally, our de nition of the crash period ts nicely with the latter. As in the case of IHSG, the KLSE index also signi cantly dropped during this period. The di erence between Indonesian and M alaysian foreign exchange rate is, nevertheless, apparent here, since on 1st Septem ber 1998 M alaysia in posed currency controls, the Ringgit was pegged with US Dollar with a xed rate of 3.80 R inggit per D ollar, while Indonesia was unable to do that due to the multi-crisis that simultaneously occurred in this country. From Fig.3 it is not clear whether or not such policy helped to elevate the K LSE index, since com paring with the IHSG uctuation in Fig.2 the two indices seem to be strongly correlated, thus other external factors could be more relevant to explain the improvement in the KLSE index. In fact, Ref. [18] claim s that the policy has led to a misposition of the Ringgit relative to its realistic exchange rate. During 1999 the Ringgit was overvalued since the regional currencies such as Japan Yen and Singapore Dollar have all depreciated against US Dollar. As a consequence, M alaysian export became less competitive and eventually this policy led to an econom ic slow dow n in M alaysia.

A quick glance to the index uctuation Y (t) in both gures reveals that the uctuation is more dram atic than that of S& P 500, indicating that in this case the situation is more complex. A fler the crash the magnitude of returns Z (t) is obviously larger in both indices, or, in the econom ics language, the probability to gain or to loose becomes larger than before. In the next section, it will be shown that both indices are clearly more volatile after the crash.

B. Scaling the Index Returns

Following previous studies [6, 7] we investigate the probability density function (PDF or P(Z)) of the return to the origin P(O) in order to investigate the scaling behavior of the IHSG and KLSE index returns. The advantage of such analysis is obvious, since the number of data included is relatively small, while the probability is largest at Z = 0, thus reducing the statistical inaccuracies.

Starting with the characteristic function [7]


From Eq.(3) the probability of return to the origin P (0) reads

where indicates the G amm a function.




FIG. 4: Left panels: Log-log plots of the IHSG (top) and KLSE (bottom) probability of return to the origin as a function of the sampling time t. Solid curves show linear regressions to this probability. The dashed curve in the case of KLSE shows another possibility if one uses only the rst three points in the linear regression, whereas the dotted curve is a linear regression by excluding the rst point (t = 1). The slopes of these lines, which are equal to negative inverse of the Levy stable distribution indices, are shown in the left panels. Right panels: Comparison between norm alized distribution functions for t = 1 and norm alized Levy stable distribution the left gures. The standard deviation and the number of data are shown in the right panels.

The log-log plots of P (0) as a function of the sam pling time t for both IHSG and KLSE indices are shown in the left panels of Fig.4. Since the num ber of data points is relatively small we limit our analysis only up to t =19 days for the IHSG index and t = 13 days for KLSE. In the form er (latter) case the num ber of data points in each set decreases from 3526 (2104) for t = 1 day to the value of 181 for t = 19 days (160 for t = 13 days). These values are already much smaller compared with previous analyses, e.g., for the H ang Seng index [14] one ends up with the value of 1481 for t = 128 m inutes.

The slopes of linear regressions to these plots equal the negative inverse of the Levy stable distribution indices .

U sing this index we calculate the parameter by means of Eq.(4) and plot the \theoretical" PDF as a function of normalized returns Z =, using Eq.(3), where the standard deviation of the distribution, and compare it with the empirical PDF obtained from data in the right panels of Fig.4. All relevant parameters obtained in this calculation are displayed in Table I.

In the IH SG case we obtain m = 0.7374 (corresponds to = 1:3561) which is slightly smaller than that of the S&P 500 index obtained from the same analysis [7] (= 1:40), or using di erent approach [9] (= 1:60 { 3.45). The value is also smaller than the result obtained for H ang Seng index (= 1:619) [14]. The value indicates that the central part of the IH SG distribution can be described by a Levy stable process.

In the KLSE case the situation is rather di erent as depicted by the bottom panel of Fig.4. The PDF at zero return shows a cross-over at t between 1 and 2 and, as a consequence, as shown by the solid line the linear regression to the points does not lead to a satisfactory result. To clarify this, we use the three rst points in the second regression and excluding the P (Z = 0; t = 1)

data point in the third one. The results are compared with the linear regression to all points in the bottom -left panel of Fig.4. In the rst case we obtain = 1:7433, already close to a Gaussian distribution although still within the Levy stable index. In the second case the index is smaller, indicating that the distribution for small t is far from Gaussian. How ever, in the third case the distribution is already a Gaussian unstable process. From this result, clearly we can conclude that by slightly increasing t the KLSE index does not retain its power law and quickly converges to a Gaussian distribution, in contrast to the IHSG index. The PDF behavior for the three cases is clearly seen in the bottom -right panel of Fig.4.

The standard deviation is known as the historical volatility in nancial literatures and quanti es the risk associated with the corresponding stock [23]. As shown in the rst line of Table I, the KLSE stock is slightly riskier than the IHSG one. The kurtosis measures the relative peakedness of the distribution to a G aussian one. The PDF of the less capitalized stocks is more leptokurtic than the PDF of the more capitalized ones [23]. From Table I we can clearly see that the IHSG stock is less capitalized than KLSE.Finally, the skewness characterizes the degree of asym metry of the distribution from its mean. A positive value of skewness indicates that the stock delivered more pro ts along its history, whereas a negative value displays m ore losses hit the investor. Table I reveals that the IHSG stock in general gives more pro ts than the KLSE one.

A lthough num erical values given in Table I could be interesting, the values become much more in portant when we discuss the behavior of the stock indices before and after the nancial crash in the next section.

To further explore statistical properties of the PDF of index returns we follow Refs. [6, 7], i.e. we investigate the stability of the distribution for t > 1 day. A ssum ing the central part of the distribution can be described by a Levy stable distribution, then using the scaling variables

the empirical PDFs for di erent time sampling twill collapse onto the t=1 distribution.




FIG.5: Top panels: P robability density functions of the IH SG and KLSE index returns for t < 20 days. Bottom panels: The same probability density functions, but plotted in scaled units, using Eqs.(5) and (6). Inverse of the Levy stable distribution index is shown in bottom panels.

The results for both indices are displayed in Fig.5, where we perform the analysis for t < 20 days. In general the data collapse is evident, especially in the case of IH SG. In the KLSE case we use = 1:7433 (result from regression to allem pirical P (0) in Fig.4), since the value leads to an average behavior. A s R ef. [14] has reported, we also nd that the extent of data collapse is stronger in the center of the distribution. The existence of a crossover in the KLSE case is also observed here, the scaled P⁰(Z) are more scattered than that of the IHSG.

C. M om ents

Reference [9] has pointed out that the use of the retum probability to the origin PDF (0) to estimate the Levy stable distribution index is statistically not optimal, due to discreteness of the distribution. Instead of exploiting such method, Ref. [9] used a di erent strategy, i.e. calculating by m eans of the slope of the cum ulative distribution tails in a log-log plot. To further test their results on the scaling behavior, Refs. [B, 9] analyzed the m om ents of the distribution of norm alized returns

where the norm alized returns g(t) is de ned by

with hZ (t)i the time average of Z (t) over the entire of time series. In the case of the S&P 500 index the result is found to be consistent with the analysis of the tails of cumulative distributions. They pointed out that the change in them on ents behavior originates from the gradual disappearance of the Levy slope in the distribution tails. In our case it is also in portant to cross-check the results shown in Fig.4, especially the KLSE slope, which is found to be non-linear in the range of t = 1 10.




FIG. 6: M om ents of the distribution of norm alized returns given in Eq.(7) for t = 1;2;3;4;6;9;13, and 19 days com – pared with those obtained from the G aussian distribution (solid thick lines). In the IH SG case, except for t = 13 and 19, all curves do not signi cantly deviate from the t = 1 m om ent.

It has been shown in Ref. [9] that Eq. (7) will diverge for k 3. In this study we also constrain k within 0 k 3. The result for both indices compared with the moment obtained from a G aussian distribution are shown in Fig.6. Obviously the results are consistent with our previous analysis, the IH SG moment retains its scaling up to t = 9 days, only after t = 13 the moment starts to deviate toward the G aussian distribution. In the KLSE case the moment quickly converges to the G aussian distribution as t increases from 1 day and does not show any scaling behavior as in the form er case.

D. Correlation in the stock index

A nother interesting behavior of the stock index uctuation is its short and long time memories which are usually expressed in terms of the autocorrelation. Understanding the power law in the correlation is very helpful in selecting the appropriate model or mechanism to explain the uctuation process. In Ref. [9] it has been

shown that the autocorrelation function of the S&P 500 returns exhibits an exponential decay with a characteristic decay time of approximately 4 m inutes, whereas the absolute value of index returns shows a scaling behavior with a power-law exponent of 0.3. In our case it is of course di cult to study such behavior since both indices are recorded daily. However, a qualitative com parison between the two indices m ight help us to probe the differences in the two stocks.

Following Ref. [9] the autocorrelation function is dened as




FIG. 7: Short range autocorrelation functions of the \mathbb{H} SG and KLSE index returns sampled with t = 1 day.

where indicates the time lag. The result for shortrange autocorrelation is depicted in Fig.7, where we can observe that the IHSG stock is slightly more correlated than the KLSE one. This result is certainly consistent with the analysis of the scaling and moments behavior. The uctuation in the KLSE index seems to be more random than that of IHSG, as can be seen also in Fig.6.




FIG. 8: Log-log plots of the long-range autocorrelation function of the absolute index returns [see Eq.(9)]. Solid lines represent a linear regression over the entire range. Regression to the power law in the form of a=(1 + b) leads to a similar result.

The long-range autocorrelation function obtained by calculating the absolute value of the return in Eq.(9) is shown in Fig.8. The absolute value of index returns from both stocks show a long-range power law behavior with a time scale up to almost one year. The only di erence is observed in the power exponent of the scaling, the IH SG correlation falls o faster than the KLSE one. This is, however, in contrast to their short-range correlation. Note that Refs.[4, 9] tted the long-range autocorrelation to the function in the form of a=(1 + b). In our analysis we found no signi cant di erence if we used such function.

E. How volatile are the two stocks?

F inally it is also interesting to see the volatility of the two stocks. The volatility of the stock index is a measure of how much the index is likely to uctuate. Inform ation on the stock volatility is very in portant for investors since it quanti es the risk factor and it is also an im portant input of the B lack-Scholes option-pricing m odel. There are m any di erent de nitions of the volatility in nancial literatures [24]. Here we de ne the volatility as an average of the absolute return over a tim e w indow




FIG.9: The volatility of the IHSG (top) and KLSE (bottom) stock indices obtained by calculating Eq.(10) with n = 1 m onth and sampling time t = 1 day.

with length n sampled with t = 1 day,

with Z() is given by Eq.(1).

The results are shown in Fig. 9. As can be estimated from Figs. 2 and 3 volatility in both stock indices increases after the nancial crash. It is obvious that after the drop of the foreign exchange rate nished in 23rd January 1998 volatilities of both indices are still large until the indices reached their minimum values in September 1998. From that on, the volatility decreases gradually although until 2002 the values are still larger than the values before the crash.

It is also obvious from F ig.9 that before 1997 the IH SG stock had a rather stable volatility variation, while on the other hand the variation in the K LSE case was already dram atic. In general, the two stocks maintain these behaviors after the crash, although in this period the averaged volatilities are larger than before. This might explain why the IH SG stock index is found to be more correlated than the K LSE one.

III. STAT IST ICAL PROPERTIES BEFORE AND AFTER CRASH

In section II we have shown that between July 1997 and Septem ber 1998 the index returns of both stocks uctuate strongly. As shown in Fig.9, compared with the situations before and after this period, both indices become m ore volatile. A more quantitative description can be




FIG. 10: Same as in Fig.4 but for the HSG case before, during, and after the nancial crash.

obtained from Table II, where in the rst line we average the index volatility over all times before 10th July 1997, 16 m onth after that (during which the volatility of both indices is signi cantly large), and over the rest of data, respectively. The result con rm s the nding of Ref. [23], namely the volatility of a stock index tends to be large right after the crash and in a relatively long period after that. This also happens to both stock indices, i.e. alm ost ve years after the nancial crisis both stocks are stillm ore volatile than before.

In the nancial literature the volatility is offen calculated from the standard deviation of the returns distribution [24]. In Table II we also present the standard deviations of the IHSG and KLSE index returns distributions in all three cases. Table II indicates that both de nitions are consistent in our analysis.

From the kurtosis of stock indices we can see that the IH SG stock is more capitalized after the crash, whereas the K LSE stock displays a very dierent behavior. Nevertheless, the skew ness of their distributions show s a similar tendency, both stocks deliver less prots after the crash, although more prots could be obtained from the K LSE




FIG.11: As in Fig.10, but for the KLSE stock index.

stock during the crash.

It is clearly tem pting to investigate whether or not the universal properties found in section II still exist in all periods and to ask what kind of di erences m ight quantify these conditions. The answer can be found in F igs.10 and 11. O bviously in all cases the statistical accuracies are not as good as in the previous section, when we used all data in our analyses. Nevertheless, in spite of the very limited data points used in our analysis, the mes-




FIG.12: M om ents of the distribution of IHSG normalized returns before, during, and after crash.




FIG.13: Same as in Fig.12, but for the KLSE index.

sage from F igs.10 and 11 is clear, the universal properties of the returns distribution retain their existences in all cases. Linear regression to the IHSG probability of the return to the origin reveals the fact that the distribution turns from Levy to G aussian after the crash. Surprisingly, the KLSE stock index shows a contrary result, the distribution alters from a G aussian to a Levy one after the crash.

A cross-check to the result shown in Figs.10 and 11 is inevitable, since the number of data could signi cantly lim it statistical accuracies in this case. For this purpose in Figs.12 and 13 we display the moments of both stock




FIG.14: Short range autocorrelation functions of the IHSG and KLSE index returns before, during, and after crash.

indices in the case of before, during, and after the nancial crash. A consistent result is obtained from these gures, in the case of IH SG the distribution becom es closer to G aussian during and after crash, whereas the K LSE m om entsm ove away from the G aussian distribution after the crash.

A nother important nding obtained from Fig.12 is that the scaling behavior up to t = 9 shown by the IHSG case in the previous section originates from the period before crash. A fler the crash, the IHSG moments quickly converge to a G aussian distribution. In fact, this phenomenon has already been seen in the left panels of Fig.10, where the empirical probability of return to the origin is more scattered in the crash periods and after that.

As in the previous section, investigation of the autocorrelation function from both stocks might also be of interest. The corresponding autocorrelation is shown in Fig.14. Although it is di cult to see how long the KLSE stock maintains its correlation, the IHSG stock index obviously becomes less correlated during and after the crash. This result can be understood by looking back to Fig.12, i.e. after the crash the returns distribution becomes more random and therefore the index losses its memory.

It m ight be more interesting if we compare results in this section with currency controls shown in the top panels of Figs.2 and 3. The government interventions on the exchange rate seem to create non natural econom ics activities which have a direct in uence on the uctuation of stock indices. Once the currency is under-controlled, the uctuations tend to signi cantly deviate from the G aussian distribution, which can be clearly seen in the IH SG moment before crash (Fig.12) and the K LSE one after crash (Fig.13). From the investors point of view this is obvious, a less uctuating exchange rate reduces the num ber of variables considered in estimating the future stock price.

IV. CONCLUSIONS

W e have analyzed the IH SG and K LSE stock index retums using the m ethods developed for statistical physics. In spite of the limited number of data used in our analysis, we still found that both stock indices show the universal properties previously observed in the leading stocks such as S& P 500 and NYSE, i.e. the scaling properties. The di erence is, nevertheless, found in the time scale, the IH SG stock retains its scaling property longer than the K LSE one. As a consequence, the form er is m ore correlated than the latter.

By investigating their statistical properties before, during, and after the nancial crash it is found that the scaling behavior of the IHSG index originates from its uctuation before the crash period. During and after the crash periods the index distributions are closer to G aussian and do not show a stable process. In the KLSE case, the return distributions in all periods show an unstable process and depart from G aussian after the crash. O ne possible explanation to these di erent behaviors could be the currency control. Besides these di erences, both stock indices show som e sin ilarities, nam ely both stocks becom em ore volatile during and after the crash and their return m om ents becom e closer to G aussian during the crash.
