In R ef [1], we presented a modi ed Popov theory that is capable of calculating the quasicondensate density n_0 in arbitrary dimensions and at all temperatures. When a condensate exists, i.e., in three dimensions at su ciently low temperatures and in two dimensions at zero temperature, the condensate density n_c is defined by the of-diagonal long-range order of the one-particle density matrix. In particular, in the modi ed Popov theory we have that

and the phase uctuations are determined by

Here n is the total density of the gas, T 2B (2) is the two-body m atrix at energy 2 , and is the chem ical potential. $_{k}$ = $_{k}^{2}$ + $_{k}^{2}$ = 2m and h! $_{k}$ = $_{k}^{2}$ + $_{k}^{2}$ = 2m and thus found that at zero tem perature the depletion of the condensate in two dimensions equals

whereas in three dimensions it equals

where a is the scattering length and we have used T^{2B} (2) = 4 $ah^2=m$. A careful analysis shows, however, that for a consistent calculation of the quantum depletion the above assumption is incorrect and we have to take the contribution from the phase uctuations into account. In the $\lim it \times i$ 1, we obtain in two and three dimensions

respectively. Since we consider a weakly-interacting Bose gas, the right-hand sides of Eqs. (7)-(8) are small and we can expand the exponents in Eq. (1) to rst order. Combining this with Eqs. (5)-(6), we nally obtain

in three dim ensions. These results are in perfect agreem ent with the results obtained from Popov theory.

We would like to point out that none of the other results presented in Ref. [1] are a ected by the above, since the theory is always applied in a regime where the gas parameter is small and the subtlety discussed here can be safely ignored.
