Exact reform ulation of the bosonic many-body problem in terms of stochastic wave functions: convergence issues

There exist methods to reform ulate in an exact way the many-body problem of interacting bosons in terms of the stochastic evolution of single particle wave functions. For one such reform ulation, the so-called simple Fock scheme, we present an elementary derivation, much simpler than the original one. Furthermore, we show that two other schemes, based on coherent states of the matter eld rather than on Fock states, lead to an in nite statistical uncertainty in the continuous time limit. The simple Fock scheme is therefore, up to now, the only one that was proved to lead to a convergent Monte Carlo simulation scheme at all times.

#### INTRODUCTION

Consider a gas of N indistinguishable bosonic spinless particles with binary interactions, a situation typically encountered in Bose condensed atom ic gases [1]. The time evolution of the many-body state vector j i of the gas is described by the Schrodinger equation

$$\frac{\mathrm{d}}{\mathrm{d}t} \mathbf{j} \ \mathbf{i} = \frac{1}{\mathrm{i}_{\sim}} \mathbf{H} \ \mathbf{j} \ \mathbf{i} \tag{1}$$

where H is the H am iltonian of the system, including kinetic energy, trapping potential energy and interaction terms. In the general case of a large number of particles and a large number of modes of the atom ic matter eld, the H ilbert space of the system is far too large for a direct integration of (1) to be feasible on a computer. A possible way out, intensively explored in particular in the quantum optics community, is to reform ulate the evolution equation in terms of the stochastic evolution of classical elds, which are much smaller objects. H istorically, the rst suggestion for such a reform ulation is based on the Positive-P distribution [2, 3]. O ther schemes have been proposed more recently, based on dierent representations of the many-body density operator [4, 5, 6]. Generalizations to ferm ionic systems are also possible [7, 8].

As these methods are stochastic in nature, their prediction for a nite number of realizations deviates from the exact result by a uctuating, zero-mean quantity, called the statistical error. One of the challenges of such reform ulations is to prove that the average of the absolute value of the statistical error remains nite at all times, so that an actual M onte C arlo simulation converges to the exact result in the limit of an in nite number of realizations <sup>1</sup>. To our know ledge, a proof of such a convergence property for the multi-mode H amiltonian problem dened above was given only for the so-called simple Fock scheme in [4] and for its fermionic counterpart [8].

The goal of the present paper is two fold. First, it presents a much simpler derivation of the simple Fock scheme than the original one in [4]: the main idea here is to work directly with state vectors j i rather than with the many-body density operator. Second, it addresses the issue of the convergence of two other schemes based on coherent states of the bosonic eld: the simple coherent scheme of [4] and a new scheme that we call the Bargmann scheme. It is found that these two schemes based on coherent states lead to an in nite mean of the absolute value of the statistical error for any nite evolution time.

Let us call the absolute value of the statistical error (to be de ned more precisely later on). Let us assume that the probability distribution for has a long tail scaling as  $1={}^{1+}$  for large . The most favorable case is > 2, in which case has a nite variance and the statistical error for a sample of N  $_{\rm r}$  M onte C arlo realizations scales as  $1={}^{1+}$  N  $_{\rm r}$ . In the intermediate 1<<2 case, the convergence is slower, scaling as  $1=N_{\rm r}^{1-1=}$ . In the worst < 1 case, the mean value of is in nite and the statistical error of the M onte C arlo simulation grows to in nity with the number of realizations as N  $_{\rm r}^{1+1=}$ . For more details, see [9].

## THE MODEL HAM ILTONIAN

A model for an ultracold trapped interacting Bose gas in D dimensions with short range interactions can be obtained in a second-quantization form alism by using the Hamiltonian

the spatial coordinate r runs on a discrete orthogonal lattice of M points with periodic boundary conditions; V is the total volume of the quantization box and V = V = M is the volume of the unit cell of the lattice.  $h_0 = \frac{p^2}{2m} + U_{ext}$  is the one-body H am iltonian in the external trapping potential  $U_{ext}$  (r), m is the atom icm assand interactions are modeled by a two-body discrete delta potential with a coupling constant  $g_0$ . ### THE SIMPLE FOCK SCHEME

Consider the N particle bosonic Hartree-Fock state de ned as

where the operator  $\hat{a}^{y}$  creates a particle in the non-necessarily normalized single-particle wave function (r):

The challenge is here to nd an equation of motion for (r) in order for the Hartree-Fock ansatz to give an exact solution to the full many-body dynamics, i.e. we aim to obtain a dynamics for (r) such that

in a sense to be de ned. In the following we proceed to evaluate both sides of (5).

The action of the Ham iltonian (2) on N: i can be worked out by splitting the eld operator in its longitudinal and orthogonal components with respect to :

On the other hand, the variation of a Hartree-Fock state following a variation of (r) can be calculated by replacing (r) by (r) + d (r) in (3) and expanding with the binomial formula. Up to second order in the variation d (r), this leads to

In the usual Hartree-Fock mean-eld approximation, has a determ in istic evolution with d / dt, so that the last term on the right-hand side of (13) is negligible in the limit dt! 0 and therefore the last term on the right-hand side of (11) cannot be accounted for. The best that one can do in the mean-eld approximation is to set

thus recovering a nonlinear Schrodinger equation for of the same form as the usual G ross-P  $\frac{1}{P}$   $\frac{1}{Q}$   $\frac{1}{Q}$   $\frac{1}{Q}$ . The main idea to recover the exact evolution is to include in d a term dB proportional to  $\frac{1}{Q}$ .

so that the quadratic term  $pin_d$  in (13) is no longer negligible. The price to pay for this is the apparition of an extra term proportional to dt in (13) which has no counterpart in (11). The trick is to make dB stochastic with a vanishing mean value. Then the average variation of the Hartree-Fock ansatz exactly matches the one required by the many-body Schrodinger equation:




FIG. 1: Schem atic view of the M onte C arbo sam pling of the exact m any-body state vector j i at time t (cross) by a collection of random H artree-Fock states  $N:_k i$  (stars). In the limit of an in nite number of realizations, the center of m ass of the distribution of the stars exactly coincides with the cross. In the N-body Hilbert space, u is an arbitrary unit vector and  $c_u$  is the component along u of j i and of the  $N:_k i$ .

where the projector  $Q_{\hat{p}} = 1$  j in j = k  $k^2$  projects orthogonally to . The zero mean property of the noise makes the term sproportional to  $k^2$  dt vanish in the averaging over noise. The term so forder three or more in  $k^2$  in the expansion (13) are negligible as compared to dt in the limit dt! 0. In mathematical terms, this procedure corresponds to assuming that the evolution of is governed by an Ito stochastic dierential equation [10]. Fig.1 gives a geometrical interpretation of the Monte Carlo sampling of the many-body state vector  $k^2$  is by Hartree-Fock states. provided that this is the case at the initial time t = 0.

In practice, a noise with the correlation function (17) can be obtained as

this expression was already discussed in [4] and is easily generalized to nite range interaction potentials. The index k is restricted to a half space and to the rst Brillouin zone. The (k)'s are random angles uniformly distributed in [0;2]. An alternative choice can be

We can then calculate the evolution of the squared norm  $k k^2$  and check that it remains nite at all times:

so that remains nite at all times. The present stochastic wave function reformulation of the bosonic many-body problem is exactly the same as the so-called simple scheme with Fock states introduced in [4] from a dierent and more general point of view. Among the schemes based on a Hartree-Fock ansatz for the many-body density matrix of the form

with  $_{1;2}$  evolving according to stochastic di erential equations, the simple Fock scheme was shown to be the one which minimizes the growth rate of the statistical variance of around the exact many-body density matrix (t):

where ::: represents the average over all stochastic realizations. The last term in the above equation, the so-called purity of , is constant for H am iltonian evolutions. If the stochastic wave functions  $_1$  and  $_2$  are statistically independent at the initial time t=0, they remain so at any later time since their evolutions are independent. The mean squared norm of is then

For the present Fock scheme, it follows from (23) that

this upper bound was already discussed in [4]. In the model of this paper, the number of modes of the bosonic eld is nite, so that the inequality (29) guarantees that the simulation can predict the expectation value of any observable with a nite statistical dispersion. The Monte Carlo statistical variance  $0^2$  on the quantum expectation value Tr[0] of any observable 0 is indeed trule trul

where the traces are taken in the N-particle subspace and the trace  $Tr[0^2]$  is a nite quantity for a nite number of modes.

This form alism can be extended to the imaginary-time evolution [11], which allows one to sample in an exact way the thermal equilibrium state at a given temperature T:

This requires solving the imaginary-time evolution equation

for a \time" going from 0 to  $= 1 = k_B T$ . The use of the projector onto the N particle subspace  $P_N$  as the initial condition allows one to calculate the physical quantities in the canonical ensemble, i.e. for a xed number N of particles. As we shall prove in full detail in the next section, the projector operator  $P_N$  has a simple expression in terms of H artree-Fock states.

The correct imaginary-time evolution of the Hartree-Fock state N: i is recovered if the stochastic wave function (r) evolves according to

We have recently applied this method to study the probability distribution of the number of condensate particles in a 1D trapped Bose gas for temperatures both above and below the transition temperature [12].

In the previous section we have shown how the N -boson time-dependent problem can be exactly reformulated in term s of the stochastic evolution of single particle wave functions; in particular, the therm all equilibrium state in the canonical ensemble can be obtained by means of an imaginary-time evolution with the projector  $P_N$  as the initial state. Here, we shall prove that the projector P  $_{
m N}$  has a simple expression in terms of Hartree-Fock states and that any state vector can be expanded onto a set of Hartree-Fock states. This ensures that the identity (18) can be satis ed at time t = 0 for any initial many-body state vector j (0)i.

It is a well-known fact of quantum optics [13] that the G lauber coherent states form an overcomplete basis of the Hilbert space of an harm onic oscillator. In the general multim ode case, this property can be expressed as

As discussed in [11], the expression (39) is the starting point for an exact num erical calculation of the therm odynam ical equilibrium properties of the interacting Bose gas.

Completeness of the set of Hartree-Fock states is an immediate consequence of the result (39): any state vector ji belonging to the N particle subspace can in fact be expanded over Hartree-Fock states according to

The Bargm ann scheme

The derivation of the Fock scheme can be reproduced for the case of unnormalized coherent states, the so-called B argm ann states:

where is a stochastic dynam ical variable and  $_0$  is a time-independent amplitude. Thanks to (35), one can show that any initial state vector j (0)i can be obtained as a statistical average of B argm ann states of the form (46); the initial value of both and  $_0$  can then vary random by from one M onte C arbo realization to the other.

The exact time e-evolution given by the many-body Hamiltonian (2) can be shown to be exactly recovered if the eld amplitude (r) evolves according to

In practice, we take the following implementation of the noise which minimizes the squared norm of dB [4]:

where k is restricted to a half-space and to the rstBrillouin zone. W ithin the fram ework of [4], this Bargm ann scheme recovers one of the possible solutions of the consistency equations in the case of a coherent state ansatz, namely the one with a constant amplitude (t) at all times.

Here we shall prove that, contrary to the scheme with Fock states, the scheme (47-48) has an in nite statistical uncertainty for any time t > 0, in a sense to be precised below. As in the section with Fock states we introduce

As initial state at t = 0 we take for simplicity a pure Bargmann state  $\beta$  arg: (0) i with in average k (0)  $k^2 = N$  particles. 0 is taken as exp( N = 2), so that the initial state is normalized to unity. We now show that the mean value of (t) is in nite for any t > 0.

From (47) and (48), it follows that the evolution of X (t) = k (t) $k^2$  is described by

Inserting in this expression the noise correlation function (48), the rst two terms on the right-hand side of (53) cancel. For the remaining term, a lower bound can be obtained by using the explicit expression (49) for the noise and applying the Schwartz inequality  $^2$ :

As the ratio of two successive elements of the series tends to in nity in the  $\lim it n ! 1$  for any t > 0, this results in an in nite value of h i(t) and therefore of the variance of the statistical error on the many-body density operator.

The same result could have been obtained by explicitly calculating the probability distribution for X at a given timet: as the evolution of the random variable  $Y = \ln(X)$  is a simple distribution in presence of a constant drift term, its probability distribution P(Y;t) has a Gaussian shape at all times t. By going back to the original variable X by means of  $P(X;t) = \frac{dY}{dX}P(Y;t)$ , the distribution of X is found to be equal to

It follows that the average of the exponential  $\exp(X)$  does not converge at X = +1 and therefore that the average of (50) is indeed in nite.

One m ight wonder if the same conclusion holds for other indicators of the magnitude of the statistical error. For example, one could consider the mean value of the distance between the Monte Carlo ansatz Barg: i and the exact many-body state vector j i:

By a straightforward generalization of (58), we not that the mean value of  $^{1=2}$  is in nite for any t> 0, so that the mean value of is in nite. From the explicit form of the probability distribution (59) one can also check that the same result holds for any moment h i of the distance, with an arbitrary real exponent > 0.

These results nicely demonstrate the dierence between the convergence of the stochastic process for the eld amplitude and for the many-body ansatz. Since the deterministic term (47) is norm-conserving and the noise term (48) does not grow faster than k k, one can apply a regularity theorem which guarantees that no nite time divergences can occur in the random dynamics of the eld amplitude and that all the moments of the stochastic wave function are nite (cf. [10, chap. 43] and [14, chap.6-7]). However, the statistical uncertainty is still divergent because the Bargmann ansatz involves an exponential function of the eld amplitude (r) and not only a polynomial one as was the case with Fock states [4].

# The sim ple schem e w ith coherent states

In the previous subsection we showed that the statistical uncertainty for a simulation performed according to the Bargmann scheme is in nite. In [4] we have identied among all the schemes based on coherent states the one (the so-called simple scheme) which minimizes the growth rate of the variance of the statistical error on the many-body density operator. Here we shall show that for any nite time the statistical uncertainty is in nite also for the simple scheme, similarly to the case of the Bargmann scheme.

The scheme denoted in [4] as the simple scheme with coherent states corresponds to a slightly more general ansatz than (46):

where the amplitude (t) is now a stochastically evolving dynamical variable. The eld amplitude now solves the Ito di erential stochastic equation

with exactly the same noise term dB as in the Bargmann scheme, see (49). The evolution of the amplitude is given by

The determ inistic term in d includes the usual mean eld contribution. As it remains norm conserving, the results previously proved for the distribution and the moments of X (t) = jj for the Bargmann scheme still hold for the present scheme. In particular, the stochastic dierential equation (64) has a well de ned solution according to the regularity theorem of [10, 14]. Setting =  $\exp S$ , equation (65) can be turned into

U sing the explicit expression for the correlation function of dB, this expression simplies to

This equation for S can be integrated by quadrature proving the existence of a regular solution to (65).

As in the previous section we quantify the statistical spread in the simulation with

As the initial state at t = 0, we take for simplicity a pure coherent state jobh: ((0); (0)) i with on average k (0) $k^2 = N$  particles and an amplitude (0) = exp(N=2), so that the state vector is normalized to unity. The time evolution of (t) is given by [4]:

Because of the nonlinear term proportional to X (t) in (69), the coupled system of (69) and (51) does not full all the hypothesis of the regularity theorem [10, chap. 4.3] and therefore we can expect singular behaviors.

In term s of the rescaled time  $= q_0 t = V \sim$ , the stochastic equation of motion for X ( ) and ( ) can be rewritten as

the in nite sum of the E  $_{\rm n}$  is in nite as well as the sum of the D  $_{\rm n}$  which appears in (74). This proves that the variance of the statistical error on the m any-body density m atrix is indeed in nite also in the case of the simple scheme with coherent states.

As for the Bargm ann scheme, this result can be generalized to other indicators of the statistical error, e.g. the distance between the Monte Carlo ansatz and the exact state vector

## CONCLUSION

We have shown that the simple Fock scheme can be rederived in a very elementary way using the Schrodinger equation for the state vector rather than the Liouville equation for the many-body density operator. Such a derivation is inspired from the derivation for fermions used in [8]. We have also given a proof of completeness of the Hartree-Fock state ansatz more detailed than in [4].

For the two schemes with coherent states considered in this paper, we have shown that the absolute value of the statistical error on the many-body state vector has an in nite mean for any nite evolution time. This negative result has been obtained by analytical means for a continuous time evolution. Of course, any actual numerical calculation is performed with a nite time step dt so that any given time t is reached with a nite number of steps. As the noise (49) is bounded from above, this imposes an upper limit to the maximum value of the statistical error which can be achieved by any realization and therefore its mean value remains nite in the numerics. This is why this problem of the simple coherent scheme was not discovered in the numerical simulations of [4].
