## Quantum theory of bilayer quantum H all sm ectics

Mean-eld theory predicts that bilayer quantum Hall systems at odd integer total lling factors can have stripe ground states in which the top Landau level is occupied alternately by electrons in one of the two layers. We report on an analysis of the properties of these states based on a coupled Luttinger liquid description that is able to account for quantum uctuations of chargedensity and position along each stripe edge. The soft m odes associated with the broken symmetries of the stripe state lead to an unusual coupled Luttinger liquid system with strongly enhanced lowtem perature heat capacity and strongly suppressed low -energy tunneling density of states. We assess the importance of the intralayer and interlayer back-scattering terms in the microscopic Hamiltonian, which are absent in the Luttinger liquid description, by employing a perturbative renorm alization group approach which re-scales time and length along but not transverse to the stripes. With interlayer back-scattering interactions present the Luttinger liquid states are unstable either to an incom pressible striped state that has spontaneous interlayer phase coherence and a sizable charge gap even at relatively large layer separations, or to W igner crystal states. Our quantitative estim ates of the gaps produced by back-scattering interactions are sum marized in Fig. 11 by a schematic phase diagram intended to represent predicted experimental ndings in very high mobility bilayer systems at dilution refrigerator tem peratures as a function of layer separation and bilayer density balance. W e predict that the bilayer will form incom pressible isotropic interlayer phase coherent states for sm all layer separations, say d 1:5'. At larger interlayer spacings, how ever, the bilayer will tend to form one of several di erent anisotropic states depending on the layer charge balance, which we param eterize by the fractional lling factor contributed by one of the two layers. For large charge im balances ( far from 1=2), we predict states in which an isotropic W igner crystals form in each of the layers. For closer to 1=2, we predict stripe states that have spontaneous inter-layer phase coherence and a gap for charged excitations. These states should exhibit the quantum Halle ect for current owing within the layers and also the giant interlayer tunneling conductance anom alies at low bias voltages that have been observed in bilayers when the N = 0 Landau level is partially led. W hen the gaps produced by backscattering interactions are su ciently small, the phenom enology observed at typical dilution fridge tem peratures will be that of a sm ectic m etal, an isotropic transport without a quantum Halle ect. For stripe states in the N = 2 Landau level, this behavior is expected over a range of bilayer charge in balances on both sides of = 1=2.

#### I. IN TRODUCTION

The recent discovery of strongly anisotropic transport in single layer quantum Hall systems near half-odd integer lling factors<sup>1{3</sup></sup> has attracted m uch experim ental<sup>4</sup> and theoretical<sup>5</sup> interest. Transport an isotropies have been observed in single two-dimensional (2D) electron gas layers at half lling of Landau levels with index N 2, i.e. at lling factors = 9=2;11=2;:::. This e ect is commonly ascribed to the formation of striped chargedensity-wave phases, predicted on the basis of Hartree-Fock calculations by K oulakov et al.<sup>6</sup> and by M oessner and Chalker<sup>7</sup> with additional theoretical support from subsequent exact-diagonalization<sup>8</sup> and DMRG<sup>9</sup> num erical studies. The stripe state is a consequence of the form factors that arise in describing interactions between electrons in higher kinetic energy Landau level orbitals and allow density waves to form in cyclotronorbit-center coordinates that have a very sm all electrondensity-wave am plitude and therefore little electrostatic energy penalty.

The physics of quantum Hall systems is enriched by the additional degrees of freedom that appear in bilayer system s<sup>10</sup> in which two 2D electron layers have a separation d sm all enough that their interactions have consequences. For total lling factor T = 1 and other odd integer total lling factors, interlayer interactions can lead to a state with spontaneous phase coherence<sup>11</sup> between the layers and a charge gap that is revealed experimentally<sup>12</sup> by the quantum Halle ect. Further spectacular experim ental m an ifestations of spontaneous phase coherence were revealed very recently in 2D to 2D tunneling and Hall drag experiments by Eisenstein and collaborators.<sup>13</sup>. In tunneling studies spontaneous coherence is signaled by a sharp zero bias peak in the di erential conductance between the layers. As the ratio of d to the magnetic length ' is reduced experim entally, the conductance peak appears to develop continuously starting at a critical value of d=` that is consistent with earlier experim ental anom alies<sup>12</sup> attributed to spontaneous coherence and with m ean- eld-theory estimates of the critical layer separation<sup>12</sup> at which coherence is expected to develop. These experiments are still not understood quantitatively and raise a number of interesting issues in non-equilibrium collective transport theory that have stim ulated a growing body of theoretical<sup>14</sup> work.

Since balanced bilayer system s at large odd integer total lling factor ( $_{\rm T}$ 9) are com posed of 2D layers that, if isolated, would show stripe-state behavior, it is natural to consider the possible interplay and competition between the form ation of striped phases in each 2D layer and the developm ent of spontaneous interlayer phasecoherence. These issues have been investigated in several recent theoretical papers<sup>15 {17</sup> and  $\ddagger$  has been argued<sup>17</sup> that they may be relevant for understanding a recent observation of resistance an isotropy at integer lling factor by Pan et al.<sup>18</sup>. In the present paper we extend earlier work by two of the present authors<sup>19</sup> on sm ectic states in single layers to the case of bilayer system s. The approach we take is one that is intended to be valid when quantum uctuation corrections to the stripe states predicted by Hartree-Fock theory are weak on m icroscopic length scales, although as we discuss at length they inevitably alter the ultim ate physics at very low energies and tem peratures and the behavior of correlation functions at long distances. Since stripe states occur as extrem a of the Hartree-Fock energy functional for any orbital Landau level index, not only for N 2 where the states are seen experimentally, and are in fact always unstable to the form ation of W igner crystal states in meaneld-theory, it is evident that we must appeal in part to experiment to judge when our starting assumption is valid.5;6;20

In describing stripe states it is convenient to use a Landau gauge basis with single-particle states extended in the direction along the stripes, which we choose to be the x direction, and labeled by a one-dimensional wavevector k that is proportional to the guiding center along which the wavefunction's y-coordinate is localized,  $Y = k^{2}$ . For balanced bilayers, the stripe states that occur in Hartree-Fock theory are occupation num ber eigenstates in this representation, with the valence Landaulevel Landau gauge states occupied by top and bottom layer electrons in alternating stripes. In the Hartree-Fock approximation, the low-energy excitations of the stripe states consist of coupled particle-hole excitations along each edge of top and bottom layer stripes. These degrees of freedom are conveniently described using the bosonization techniques fam iliar from the theory of onedimensional electron system s.<sup>21</sup>0 ur approach is partly in the spirit of Ferm i liquid theory in that we assume that the Hilbert space of low -energy excitations can be placed in one-to-one correspondence with those that occur in the Hartree-Fock theory. W hen quantum uctuations are too strong our approach will not be useful; for exam ple, it cannot predict either the fact that low est Landau

level isolated layers have com posite-ferm ion liquid rather than stripe ground states, or the likelihood of bubble<sup>6</sup> rather than stripe states far away from half-lling. Our approach to stripe state physics is sim ilar to that taken rst by Fradkin and K ivelson<sup>22</sup>. For the case of monolayers, the m icroscopic basis of the coupled Luttinger liquid model for quantum Hall stripe states was carefully examined by Lopatnikova et al.<sup>23</sup> and other properties of quantum Hall stripe states have been addressed by Barci et al.<sup>24</sup> and W exler and D orsey.<sup>25</sup>

Our paper is organized as follows. In Section II we review the coupled Luttinger liquid model for quantum Hall stripe states and discuss its application to the bilayer case. The model rests fundam entally on the assumption that the excitation spectrum of bilayer stripe states may be placed in one-to-one correspondence with that of the Hartree-Fock picture; for bilayers this assumption im plies that the degrees of freedom at each stripe edge are those of a one-dimensional electron gas. Our analysis of the low -energy long-wavelength physics exam ines this subspace of the m icroscopic m any-particle H ilbert space and includes forward scattering terms in the Ham iltonian that create and destroy particle-hole excitations at the stripe edges, and back scattering terms that scatter electrons between chiral one-dimensional electrongas branches. Since the microscopic amplitude of backscattering processes is weak, they can often be neglected at experim entally accessible tem peratures. W hen only forward scattering terms are included, the Ham iltonian can be solved exactly using bosonization and is form ally equivalent to that of a system of coupled one-dimensional electron gases. The quantum sm ectic broken symmetry character of the electronic state is re ected, how ever, in the coupled Luttinger liquid interaction parameters and results in enhanced uctuations. The properties of this bilayer sm ectic state are discussed in Section III. The behavior of the one-particle G reen's functions at the sm ectic

xed point, carefully addressed by Lopatnikova et al.<sup>23</sup> for the single layer case, is discussed for the bilayer. W e nd that, as in the single-layer case, the one-particle G reen's function does not exhibit the power law behavior that is generic for weakly coupled Luttinger liquids and instead vanishes faster than any power law at large distances, in plying strongly suppressed tunneling at low energies. The enhanced im portance of quantum uctuations is a consequence of the invariance of the model's Luttinger liquid H am iltonian under a sim ultaneous translation of all stripes. Back-scattering interactions are addressed in Section IV, using a perturbative RG approach. As in the single-layer case we nd that back-scattering interactions are always relevant. The gapless Hartree-Fock sm ectic state cannot be the true ground state in either single-layer or bilayer quantum Hall systems. Instead we conclude that except at relatively large layer separations, interlayer interactions induce a ground state that has spontaneous interlayer phase coherence. This state would be signaled experimentally by the simultaneous occurrence of an integer quantum Halle ect and

anisotropic nite-tem perature transport, som ething that has not been seen in single-layer systems. Where intralayer interactions are more important, they drive the system to a state with an anisotropic W igner crystal in each layer. W e argue that both types of interactions lead to charge gaps and to integer quantum Halle ects and estim ate the size of the resulting energy gaps. A coording to our estimates, the gap created by inter-layer backscattering will be large enough to be observable out to surprisingly large layer separations. The e ect of nite tunneling between the layers is also addressed in Section IV. Finally in Section V we discuss several interesting theoretical issues that arise from this work. We com ment explicitly on inconsistencies between the conclusions that have been reached by di erent researchers on the question of sm ectic state stability in the single-layer case. We also address the suggestion  $^{24}$  that the enhanced quantum uctuations that follow from the broken translational sym m etry of the starting H artree Fock state m ay invalidate our perturbative renorm alization group analysis for back-scattering interactions.

### II. THE MODEL

# A.Coupled Luttinger Liquid M odel Energy Functional




FIG.1. Schem atic illustration of the Hartree-Fock bilayer smectic state. The shaded areas are electron stripes whose edges are chiral Luttinger liquids as denoted by the solid arrows. Each electron (hole) stripe in one layer faces a hole (electron) stripe in the other. The average lling factor of the highest occupied Landau level is while that in the top layer is 1 , giving a total lling factor  $_{\rm T}$  = 1. In the convention used here, a rung pair consists of the edges of an electron stripe in the top layer and an hole stripe in the bottom layer. The right-m oving and left-m oving chiral quasiparticle branches of each element of a rung pair are localized in opposite layers and denoted by = 1;2. The momentum -conserving back-scattering interactions not present in the Luttinger liquid model, discussed in this section, include both interlayer and intralayer processes which have di erent behavior. The gure illustrates interlayer and intralayer back-scattering processes with the sm allest possible m om entum transfer.

In Hartree-Fock theory the smectic bilayer state at total lling factor  $_{T} = 1$  is a single Slater determinant where the occupation of guiding-center modes in a Landau level of index N 2 f0;1;2;:::g alternates between the layers with period a, as depicted schematically in Fig. 1. Lower index Landau levels are assumed to be frozen in lled states and higher index in empty states, allowing them to be neglected in the following. Each stripe has chiral left-m oving and right-m oving branches of quasiparticle edge states, localized in opposite layers, allowing the low-energy degrees of freedom of each electron stripe to be mapped to those of a one-dimensional electron gas. We consider the general case of a biased double layer system where the width of the stripes in one layer is a while that in the other layer is a (1 ).

2 [0;1]. As indicated in the gure, for 6 0.5 the system has two types of stripe edges, distinguished by the direction of their closest neighbor. In the following we refer to a pair of chiral stripe edges one above the other in each layer as a rung, and the two closest such rungs as a rung pair.

Sm all uctuations in the positions and shapes of the stripes can be described in terms of particle-hole excitations near the stripe edges. The residual interactions, ignored in Hartree-Fock theory, which act on energy states fall into two classes: forward scattering interactions which conserve the number of electrons on each edge of every stripe, and backward scattering processes which do not. The quantum sm ectic m odel includes

forward scattering processes only. Backscattering processes involve large momentum transfer and their bare matrix elements will be smaller in magnitude (see below). We treat their e ects perturbatively, using a renormalization group approach to account for the infrared divergences ubiquitous in quasi one-dimensional electron systems. The smectic state is stable only if the backscattering interactions are irrelevant.

The classical quadratic H am iltonian which describes the energetics of sm all stripe edge uctuations has the following general form  $^{19}$ :

where the indices j and k label rung pairs, and the two di erent rungs within a rung pair, and the right or left m oving chiral edges within a single rung, and x,  $x^0$  positions along the stripes. In this equation,  $u_{\rm j}$  is the transverse displacement of the edge (j; ; ) from its classical ground state location.

In Eq. (1), the linear charge density associated with

an edge displacement is  $_{j}(x) = nu_{j}(x)$ , where n is the two-dimensional electron density inside the stripes n = 1=2 l<sup>2</sup> and = ;+; or L;R; for the left, right, moving fermions respectively. It follows from symmetry considerations that the elastic kernel satis es the follow - ing equalities,

which allow the Ham iltonian to be rewritten into sums and di erences of the positions of left and right-going branch edges:

We regard the rst term in this H am iltonian as the contribution from uctuations in the position of the rungs while the second term is the contribution from uctuations of their charge densities. (The total lling factor varies locally when left and right going branch edges do not m ove together.) These two terms are analogous respectively to current and charge terms in the elective H am iltonian of a conventional one-dimensional electron gas. The calculations we perform here will require only the long-wavelength limits of the x  $x^2$  dependence of elastic kernel in this H am iltonian, which we estimate using a weak-coupling approximation that we discuss below.

#### B.Bosonization

This Ham iltonian is quantized by recognizing that charge and position uctuations result from particle-hole excitations at the edges of chiral quasiparticle branches, just as in an ordinary one-dimensional electron system. The real spin is frozen due to the presence of strong perpendicular magnetic eld and as a result we bosonize according to spinless bosonization schem  $e^{21}$ . It follows from standard arguments that

The low energy H am iltonian is more conveniently described in terms of boson elds. The right and left moving ferm ionic elds on the left stripe edge of rung pair j are given by

The above equations hold similarly for the left movers with the only change R  $\,!\,$  L. Here  $b=~a=l^2$  is the width in k space of a rung and  $k_F=~a=21^2$  is the Ferm i wavevector for the bottom layer stripes. The right and left slow elds can be expressed in terms of boson elds as in conventional one-dimensional electron system s:

Introducing the dual eld  $_{j}(x) = _{j;R}(x) _{j;L}(x) = 2$ , the position and charge variables  $U_{j}$ ,  $U_{j}^{0}$ , of the two edge system can be expressed as  $U_{j} = \hat{f}e_{x j}$  and  $U_{j}^{0} = \hat{f}e_{x j}$ . This shows that the eld is related to the position uctuations of the two edge system whereas is related with their charge density uctuations.

## C.M icroscopic Theory of Long-W avelength Interaction Param eters

The objective of this coupled Luttinger liquid model for stripe states in quantum Hall bilayers is to address

the consequences of weak quantum uctuations when the ground state is similar to the mean-eld-theory stripe state. In this spirit, we use weak-coupling expressions for the interaction parameters of the model, replacing scattering am plitudes by the bare values for scattering of the Hartree-Fock theory quasiparticles. If the true ground state were a sm ectic, the values of these param eters would be renorm alized som ewhat by higher order scattering processes. W e expect that it w ill prove di cult to system atically in prove on the estim ates given here for the quantum Hallbilayer case because of the absence of a one-body kinetic energy term in the relevant m icroscopic H am iltonian that would enable a system atic perturbative expansion. W e em phasize that a quantitative theory of the forward scattering am plitudes that has a sound microscopic foundation is necessary in order to decide on the relevance of the back-scattering interactions we have neglected so far and the character of the true ground state. As emphasized by the work of Fradkin, Kivelson and co-workers<sup>27</sup> any conclusion is possible if the forward scattering interactions are allowed to vary arbitrarily. The perturbative renorm alization group scaling dimensions that we evaluate below are dependent only on the elastic constants at  $q_x = 0$ , i.e. for strait stripe edges. The weak- uctuation H am iltonian m ay be evaluated in this lim it by calculating the expectation value of the m icroscopic H am iltonian in the H artree-Fock theory ground state, which in this lim it is a single Slater determ inant with straight stripe edges displaced from those in the Hartree-Fock theory stripe ground state. By evaluating the expectation value of the M icroscopic H am iltonian in a state with arbitrary stripe edge locations we nd that forj€ 0:

Note that the intralayer interaction contributions have competing direct and exchange contributions that cancel for Y = 0 whereas the interlayer interaction has only a direct contribution. In the following we shall assume in nitely narrow quantum wells in both layers so that the interaction potentials occurring in the above equations read

where  $L_N$  (x) is the Laguerre polynomial form factor for electrons in the N -th excited Landau level, and  $V_{S=D}^{0}$  is the Fourier transform of the Coulomb interaction within and between the layers,  $V_S^0(q) = e^2 2 = jq j$ ,  $V_D^0(q) =$  $e^2$  (2 = jq) exp ( jqd) with d being the layer separation. The long-ranged nature of the C oulom b interaction leads to logarithm ic divergences in V and W which we regularize by adding a term  $(e^2 2 = jqj) exp(2jqjd_{ate})$  to  $V_{S=D}^0$  with  $d_{gate}$  d. This regularization can be roughly thought of as introducing a metallic screening plane at distance d<sub>gate</sub> leading to image charges that screen interactions between electrons in the bilayer system . A though V and W diverge for  $d_{gate}$  ! 1 , it is possible to show<sup>28</sup> that K and K remain nite. In the following we choose a large but nite value for  $d_{\text{gate}}$  for num erical convenience.

The above form of the smectric energy kernel K = (j) applies for  $j \in 0$ . ### D. The Balanced Bilayer Limit

The special case of half lling in each layer has additional symmetry that is most conveniently exploited by taking a slightly di erent approach. In this case the electron stripes in both layers have the same width and the system therefore has e ective periodicity of a=2. To be more precise, the problem can be formulated as a onedimensional lattice of equidistant double edges placed a distance a=2 apart, noting carefully that right and left goers interchange their layer labels on alternate edges. To describe this system instead of using coupling matrices K (x; j) and K (x; j), as in the unbiased case, one can simply use the coupling constants K (x; j) and K (x; j)

#### III. SM ECTIC STATE PROPERTIES

A peculiar property of quantum H all stripe states is that the m icroscopic scale of back-scattering interactions is weak. For this reason observable properties m ay be those of sm ectic states over a wide interval of tem perature, even when back-scattering interactions are relevant at the sm ectic xed point. In this section we discuss som e characteristic properties of quantum H all bilayer stripe states.

## A . Collective m odes and Therm odynam ic P roperties

The coupled Luttinger liquid model for bilayer quantum Hall stripe states gives rise to two collective modes with dispersions that can be determined by evaluating zeros of the determinant of the 2 2 m atrix that de nes




FIG.2. Collective modes of the bilayer QH smectic phase. These results shown here were evaluated using K = (x; j) values from Eqs. (23-25) with N = 2, 1=2 and a = 5.81. Notice that  $!_+$  ( $q_x; q_y$ ) always disperses linearly for sm all  $q_x$ , whereas ! ( $q_x; q_y$ ) disperses sub-linearly (as  $q_x^3$ ) when  $q_y = 0$ . The  $q_y = 0$  behavior of the lower collective mode is sensitive to the  $q_x$  dependence of the interaction coe cients which we do not evaluate m icroscopically. This illustration was constructed by adding a sm all  $q_x^4$  contribution to the interaction coe cients.

Both modes have energies that are proportional to  $q_x$ . The velocity of the ! (q) mode vanishes for  $q_y$  ! 0. In fact, when the  $q_x$  dependence of K and K is dropped, as in most of our calculations !  $(q_x;q_y = 0)$ vanishes identically; when the  $q_x$  dependences are restored !<sup>2</sup> (q)  $q_x^2(q_y^2 + q_x^4)$  at small wavectors and !  $(q_x;q_y = 0) / q_x^3$ . For gate-screened C oulom b interactions, the x-direction ! mode velocity is proportional to  $j_{xy}$  jin the small  $q_x$  and  $q_y$  lim it. In the independent layer lim it, the two modes become degenerate and we recover the isolated layer results obtained previously<sup>19</sup>.

In the case of balanced bilayers the alternate form ulation m entioned above is m ore convenient. The collective m odes for this  $\lim i m$  ay be expressed as

The collective modes of the bilayer QH smectic phase are shown in Fig. 2. The right panel shows  $!_+ (q_x;q_y)$ which disperses linearly in small  $q_x$  for arbitrary  $q_y$ . In contrast,  $! (q_x;q_y)$  disperses linearly at small  $q_x$  for  $q_y \in$ 0, but for  $q_y = 0$  it is sub-linear:  $! (q_x;q_y = 0) \quad q_x^2$ .

The Therm odynam ic properties of the smectic phase of the bilayer system are those of a non-interacting boson system and are readily evaluated given the collective m ode energies. For example, for = 1=2 in each layer, using the simpler alternative formulation, we have one collective m ode at each wavevector. The internal energy density is

The specic heat of this system varies as  $T \ln (T_0 = T)$  at small T, vanishing less quickly than that of a non-interacting Ferm ion system because of the soft collective modes that result from the translational invariance of the stripe state. This low tem perature behavior relects the form of the dispersion relation at small q, ! (q)  $q_{q_y}$ ; only the prefactor of this enhanced speci c heat changes in the unbalanced bilayer case. These results for the speci c heat are sim ilar to the ones obtained in previous works by Barci et al.<sup>24</sup>, and Lopatnikova et al.<sup>23</sup> for the case of a single layer. There is no qualitative di erence between the therm odynam ic properties of single layer and bilayer stripe states. For unbalanced bilayers the speci c heat at low tem peratures is dom inated by the softer of the two collective modes, whose long wavelength dispersion is given by

for large x, where K = v (q)= . In the limit of balanced lling fraction for which K and K are scalars the integrand which is averaged over  $q_v$  above reduces to K = K, the familiar result for - eld correlation functions in a standard one-dimensional electron system.

This result is generalized here by the average over  $q_v$ and by the particular way in which the matrix nature of the K and K expressions enter the matrix elements above. The result for the eld correlation functions diers only by the interchange of the K and K matrices. At rst sight it appears that the position uctuation factor in the right m over correlation function decays algebraically along the stripes. However, the power which characterizes this decay, d  $_{\mbox{\tiny ;x}}$  , is given by the integral over q, of Eq (46), which diverges logarithm ically because K / v vanishes as  $jq_v j$  as  $jq_v j!$  0; the same soft position uctuations that led above to an enhanced speci c heat, lead here to ferm ion correlation functions that decay faster than any power low but slower than an exponential. This observation generalizes to bilayers, a property of single layer stripe states noted by Lopatnikova et a $1^{23}$  and Barci et a $1^{24}$ .

This shows that the density of states vanishes at the ferm i energy stronger than any power of E and that in this sense the stripe edge physics in bilayer quantum Hall system s is not that of a usual system of weakly coupled Luttinger liquids. The above result generalizes to the case of bilayer system s, points that have been m ade about single-layer quantum Hall stripe states by Lopatnikova et al<sup>23</sup> and Barci et al<sup>24</sup>.

# IV.STABILITY OF THE QUANTUM HALL SM ECTIC PHASE

We now consider \backward" (interchannel) scattering interactions that do not conserve the num ber of electrons in each stripe edge. The most important conclusion of the follow ing analysis is that back-scattering interactions are much more important for bilayer stripe states than for single-layer stripe states. We can classify the backscattering interactions as either intralayer interactions that involve electrons only in one layer or interlayer interactions that involve electrons in both layers. Non-zero back-scattering two-particle matrix elements conserve totalm om entum along the stripes, which means that the two Landau gauge guiding center jumps must sum to zero. In the case of quantum Hall stripe states, the m icrocopic m atrix elements associated with these backscattering processes tend to be small and these interactions will be important only if they produce strong infrared divergences in perturbation theory. The strength of these divergences is characterized here by evaluating low est order perturbative renorm alization group scaling dim ensions for these operators. As in Ref. 19 our renormalization group (RG) scheme involves only x and di– mensions and and treats the rung label as an internal index of the elds i, i. The philosophy underlying this procedure is discussed in the next section.

### A . Interlayer Tunneling

We rst address the tunneling of an electron from one stripe edge to the other in the same rung. The action contribution from this process has the following bosonized form:

Stability of the sm ectic xed point in the presence of back-scattering

with t = lnb. As can be seen from this equation the tunneling operator will become relevant when its scaling dimension is less than two. When this term in the H am iltonian is strong, the system is described at low energies by a set of quantum sine-G ordon models coupled by gradient terms (22). In the domain  $0 < _{Tunn} < 2$  the continuous symmetry, present in (22), and broken by tunneling, is lost in the low energy xed point action. This model has a discrete symmetry  $_{j}$ !  $_{j}$  + n for any integer n and the QFT becomes massive<sup>30</sup>. The gap due to tunneling will lead to an integer quantum H all e ect at total lling factor  $_{T} = 1$ . Using Eqs. (22), and (59), we not the following expression for the scaling dimension

The integrand in the integral over  $q_v$  is similar to that involved in the boson correlation eld and, ignoring them atrix character of the coe cients that appear in the smectic xed point H am iltonian, is K = K. Since K vanishes for  $q_v ! 0$ , we can expect this quantity to be small. Indeed we nd by evaluating this integral num erically that interlayer tunneling is always relevant.

#### B.Coulom b Backscattering Interactions

The tunneling am plitude in bilayer quantum Hall systems can be made extremely small by making the barrier between quantum wells higher or wider and is often com pletely negligible in practice. Coulom b interactions, on the other hand, are always present and must always be considered. We consider interlayer and intralayer Coulomb back-scattering processes separately. In the strongest interlayer back-scattering process an electron is transferred from , say, a left-m oving top layer stripe edge to a right-moving edge in the same rung pair of the same layer, while in the same rung pair of the bottom layer an electron is transferred in the opposite direction, as depicted in Fig. 1. The interlayer back-scattering operators for processes involving neighboring rungs have large scaling dimensions and tend to be irrelevant. In addition, the bare matrix elements for such a process will fallo rapidly in magnitude with increasing distance between the rungs involved. The action for interlayer backscattering interactions for electrons within the same rung pair reads

[I he other kind of process involving two neighboring rung pairs is related to the above one by a particle-hole transformation 71 ].

This expression is similar to that which would be obtained for inter-wire back-scattering interactions in a systems of two coupled quantum wires. This integral is sim ilar to the one that appears in the tunneling operator scaling dimension calculation, although it is easy to verify that forward scattering interactions between different stripes play an essential role. A swe discuss below, this operator is usually strongly relevant (  $_{\rm inter}$  ! 0), so that at low temperatures the phases  $\frac{1}{1}$  and  $\frac{2}{1}$  of neighboring two edge system are strongly anti correlated. The low energy nontopological (chargeless) excitations in this lim it can be understood by approxim ating  $\cos[(\frac{1}{1} + \frac{2}{1})] = 1 (\frac{1}{1} + \frac{2}{1})^2 = 2.$  W hen a term of this form is added to the quadratic Hamiltonian, the lowenergy collective mode dispersion at long-wavelengths takes the form of a spatially an isotropic two-dimensional XY ferrom agnet,  $!^2$  K  $q_1^2 + uq_2^2$ . W e discuss the significance of this result at greater length below .

Finally, in an intra-layer back-scattering process two electrons move in opposite directions between pairs of stripe edges in the same layer with the same separation (cf. Fig 1). Here we also concentrate on processes involving neighboring rungs only. Processes involving two rung pairs are again related to those involving three pairs by a particle-hole transform ation. For the rst case the action reads

Note that the imaginary part of the integrand in Eqs. (63), (65-66) does not contribute to the integrals. Backscattering processes other than the ones discussed above have larger scaling dimensions and also involve larger momentum transfer and have therefore exponentially smaller bare matrix elements. We therefore shall concentrate on the processes discussed above.




FIG.3. Scaling dimensions for tunneling and back scattering interactions as a function of layer separation d=l in a balanced bilayer system at bilayer total lling factor  $_{\rm T}$  = 9, i.e. with a N = 2 valence Landau level.

We now discuss our num erical results for scaling dim ensions of the operators that are not described by the quadratic boson theory. Fig. 3 shows the scaling dim ensions of the back-scattering interactions in a balanced system ( = 1=2) in the second excited Landau level (N = 2) as a function of the layer separation d='. The stripe period chosen for these calculations, a = 5.8', corresponds to the period at which the Hartree-Fock energy of the stripe state in a isolated layer is minim ized.31. Interestingly, single-electron tunneling is irrelevant ( Tunn > 2) for d=' > 1.5, but is strongly relevant at sm aller layer separations. Interlayer backscattering is relevant (  $_{inter}$  < 2) at all layer separations, m ore strongly so at sm aller layer separations, while the scaling dimension of the intra layer back-scattering is sm aller than 2 only for d= > 2 and approaches a value 1:84 for d=' 1. This value for the lim it of of intra weak interactions between the layers recovers the singlelayer result obtained earlier.<sup>19</sup>. The contributions to intra, not shown in the gure, become equal and in this case.




FIG.4. The left panel shows the N = 2, d=' = 5.8, intralayer back-scattering interaction scaling dimension. The right panel shows the scaling dimension of the Tunneling operator.




FIG.5. The left panel show the scaling dimensions for interlayer back-scattering across narrow and the right panel for interlayer back-scattering across wide rungs in unbalanced bilayers. Note the di erence in scale between left and right panels. The most relevant interlayer back-scattering interactions are those of narrow rungs.

The dependence of scaling dimensions on the bilayer balance is illustrated in Fig. 4 and Fig. 5. We see that intralayer interactions become more relevant when their individual lling factors move away from = 0.5, as in the single-layer case, while the tunneling operator becomes less relevant. Interestingly the interlayer back-scattering interactions show di erent results depending on the distance between the edges involved in the transition. For

€ 0:5 we have to distinguish between nearest neighbor interlayer and intralayer back-scattering processes that involve, according to the de nition given in Fig. 1, only the sm allest num ber of neighboring rung pairs (one and two, respectively) and those processes that involve formally two and three rung pairs, respectively. These two kinds of processes are related by particle-hole transform ation and therefore shown in di erent panels. Generally the scaling dim ension increases with the distance between the edges. The data shows that one of these two backscattering processes, related by a particle-hole transformation, is always relevant and that the minimum scaling dimension decreasing with increasing bias between the layers. In sum m ary, the m ost relevant residual interactions is interlayer back-scattering and they are increasingly in portant as the bilayer is unbalanced.

We note that the scaling dimensions Tunn of the single-electron tunneling and inter of the interlayer back-scattering approach zero for d=`! 0, i.e. these processes become strongly relevant. This is a natural result since in this lim it we recover the monolayer electron spin quantum H all ferrom agnet. This system is perfectly




FIG.6. The scaling dimension of the back-scattering interactions in the various Landau level (N = 0;1;2;3) in a balanced system as a function of the layer separation d='. The stripe periods a are obtained from Hartree-Fock monolayer results given in Ref.<sup>31</sup>.

isotropic in pseudospin space, and therefore processes like tunneling which acts essentially like a (pseudo-)magnetic eld are obviously very relevant. This increased relevance arises formally in our calculations through the property that the matrices K  $(q_v)$  vanish in the limit d ! 0, so that the integrands in Eq. (61) and (63) are identically zero. K vanishes because it is a measure of energy changes associated with charge transfer between layers at a particular stripe edge; when d! 0 only the total charge near each stripe edge in uences the energy functional. In Fig. 6 we show the dependence of these scaling dim ensions on Landau level index N = 0;1;2;3 with the stripe periods taken from Ref.<sup>31</sup> in each case. As this gure shows, our results for the scaling dimensions of back-scattering processes around the assumed stripe state depend only weakly on the Landau level index. We note that in the lowest and rst excited Landau level (N = 0;1) no conductance an isotropies are found experim entally in single layers, even though there is a stripe state in each of these Landau levels which is a localm in im um of the Hartree-Fock energy functional. The true ground state in these instances is far from the stripe state, di erencing in character even at m icroscopic length scales. The fact that our calculation does not obtain anom alous results in cases where we do not believe stripe states occur, em phasizes again that our approach can only address the properties of systems in which uctuations around Hartree-Fock stripe states are weak. It cannot predict when stripe states occur. Future experimental activity will be necessary to identify with con dence when stripe states occur in bilayers.

# C .Sm ectic interlayer phase coherent and W igner C rystal states

# 1. Sm ectic interlayer phase coherent state

In this section we exam ine the e ect of the interlayer back scattering interactions (when they are strongly relevant) on the low energy physics of the system and show that the phase coherence is marked by a nonvanishing value of an interlayer phase order parameter. In this phase electrons at each stripe edge are coherent superpositions of the upper and low er layer states.

The most relevant interlayer back-scattering operators are related by particle-hole sym metry and describe backscattering across an electron stripe in the top layer and the corresponding hole stripe in the bottom layer or across a hole stripe in the top layer and the corresponding electron stripe in the bottom layer. In terms of the Luttinger liquid elds we have de ned, the sum of these two interactions takes the form :

Expressions for the bare values of these coupling constants are given below. As shown on Figs. 5(a), 5(b), (left, right panel respectively), at small layer separations these operators are strongly relevant. At low temperatures the phases  $\frac{1}{j}$  and  $\frac{2}{j}$ ,  $\frac{2}{j}$  and  $\frac{1}{j+1}$  of neighboring two edges tend to be strongly anticcorrelated. The low energy excitations in this limit can be understood by approximating  $\cos[(\frac{1}{j} + \frac{2}{j})] = 1$   $(\frac{1}{j} + \frac{2}{j})^2 = 2$ . When terms of this form are added to the action, it takes the following form:

where M is the matrix of the system at the smectic xed point and is given by Eq. (22) or by Eq. (45) (interchanging K , K ) and  $u_{i1}$ ,  $u_{i2}$ , is the short notation for  $u_{inter;}$ ,  $u_{inter;(1)}$ , respectively. The e ects of the interlayer back-scattering interactions, included on the new matrix of Eq. (69) (which we denote by N ), shift the poles of the boson propagators. The low energy collective modes now are given by




FIG. 7. The collective modes of the bilayer QH smectic interlayer coherent phase, for the case of K = (x; j) of Eqs. (23-25) and N = 2, 1=2 and a = 5.81, are shown. !+ (q<sub>x</sub>;q<sub>y</sub>), the right panel, is of the form of a spatially anisotropic two-dimensional ferrom agnet, !<sup>2</sup><sub>+</sub> (q) K  $q_x^2 + uq_y^2$ . The ! (q<sub>x</sub>;q<sub>y</sub>) collective mode vanishes only for q<sub>y</sub> ! 0 and q<sub>x</sub> ! 0 when non-local contributions to the interaction coefficients are accounted for.

These low energy collective modes are shown in Fig. 7.

As before, the case of balanced lling fraction can be described in a more transparent way using the scalar couplings K $^{\sim}$ , K $^{\sim}$  of Eq. (32), (33). For this case the low – energy collective modes have the form

In this formulation one of the gapless modes is located at the edge of the Brillouin zone, which is now doubled, at  $q_y = 2$  =a. In the extended Brillouin zone we use for balanced bilayers the ! (q) softm ode appears for  $q_y$  ! 0, whereas the !<sub>+</sub> (q) softm ode appears as  $q_y$  ! 2 =a. The two modes have the following behaviors:

Similar results can be obtained using the matrix form ulation for general and become equivalent for = 1=2. There is no qualitative change in the collective mode structure when  $\neq 1=2$ .

The interlayer phase coherent smectic state is characterized by a nite value of the following order parameter,

In (77) we have introduced an upper short distance cuto 1=' for the  $q_x$  integration. Interlayer back scattering interactions have cut-o the infrared divergence of the  $q_x$ integration, making the integral nite and establishing particle-hole pair condensation. In this state the U (1) symmetry associated with conservation of total charge di erence N<sub>T</sub> N<sub>B</sub> between top and bottom layers is broken.

W e conclude on the basis of this analysis that interlayer back-scattering will drive the Hartree-Fock bilayer sm ectic state to a state which has both broken translational and orientational symmetry and spontaneous interlayer phase coherence along the edges. We expect this state to exhibit giant interlayer tunneling conductance anom alies at low-bias voltages, sim ilar to those that have been seen in the N = 0 Landau level in bilayers. A lthough these states have a charge gap that we discuss below and should exhibit the quantum Halle ect, we expect that they will exhibit strongly an isotropic dissipative transport at nite tem peratures. Their two gapless collective modes arise because they have broken translational and orientational symmetry and spontaneous interlayer phase coherence. W e also note that the quantum character of these bilayer smectic states is quite distinct from the quantum smectics discussed previously for the single-layer case. For instance the long-wavelength behavior of the quantized collective mode !  $(q_x;q_y)$  changes from being proportional to  $jq_k q_j$  to being proportional to  $jq_j$  only when spontaneous inter-layer phase coherence is present; locking the phase di erence between di erent layers qualitatively increases the cost of independent position uctuations. The long-wavelength behavior of the  $!_+$  ( $q_x; q_y$ ) collective mode is that of an anisotropic super uid. As in the case of uniform states, spontaneous interlayer phase coherence is equivalent to electron-hole pair super uidity, but the broken orientational sym m etry of the sm ectic state causes this super uid to have orientation dependent sti ness.

It seems quite possible that the order parameter that characterizes the broken orientational and translational sym m etry of these states will be driven to zero when interlayer interactions are su ciently strong. Indeed this is suggested<sup>15;16</sup> by m ean-eld calculations. We are unable to estimate where this transition takes place using the m ethods of this paper.

### 2. Coherent sm ectic state speci c heat

The internal energy of the bilayer smectic phase coherent (SPC) state will be dom inated at low energies by the contribution from the ! (q) mode. The leading contribution to the integral for the internal energy comes from the region of small q. The  $q_{f}$  integral now has a natural infrared cut-o how ever at  $u_{i1}=K'$  (0). It follows that the internal energy is given for small u by

and the speci c heat will now be linearly dependent on T. The speci c heat anom aly noted previously for the bilayer sm ectic is suppressed when inter-layer coherence is established, even though broken translational and orientational symmetry are still present.

#### 3. W igner crystal state

Intralayer back-scattering interactions take the form

where the oscillatory dependence on coordinate along the edge which we have exhibited explicitly follows from our earlier eld operator de nitions. This interaction dom inates only at quite large layer separations. When it does it drives the system to a state which has periodicity along the stripe edges as well as across the stripes. Since, the wavelength along the stripe is 4  $1^2$ =a, and since the periodicity along the direction perpendicular to the stripes is a, this state will contain one electron per layer per two dimensional unit cell. We therefore identify this state as a bilayer W igner crystal (W C) state.

### D.G ap Estim ates for Bilayer Stripe States

The most important conclusion from the above calculations is that interlayer C oulom b back-scattering interactions are always relevant in bilayer stripe states. The gapless bilayer stripe state can never be the true ground state. Since the bare matrix elements associated with these interactions are offen quite small, however, they will offen be important only at low temperatures. As we explain below, we believe that C oulom b interactions will most offen drive the system either to an isotropic coherent state or to a smectic coherent state. B oth states will have a charge gap and an integer quantum H alle ect. In this section we estim ate the size of this gap and hence the temperature above which we expect the phenom enology of these states to cross over from quantum Hallbehavior to stripe state behavior.

O ur estim ates are built on bare matrix elements whose evaluation we discuss below and on the scaling dimension calculations discussed above. G iven dimensionless inter- and intralayer back-scattering interactions  $u_{inter}$  and  $u_{intra}$ , we can estimate the gap by integrating the RG ow equations to obtain

where the super- and subscripts e=a are used for interand intralayer interactions respectively. When the interactions become of order 1 on the renormalized energy scale ( $b^2$  u = 1), the energy gap should be roughly equal to the renormalized characteristic C oulom b energy E<sub>c</sub>, giving




FIG. 8. Estimated charge gap due to interlayer back-scattering interactions. These interactions are always relevant and lead, in the absence of interlayer tunneling, to states with spontaneous interlayer phase coherence. The energy scale in this gure is  $e^2 = `which is k_B 50K$  for a typical higher Landau level experiment. The energies should be reduced to account for screening from inter-Landau level transitions that we have not included in our calculations.

where  $U = uE_{c}$  is the microscopic high-energy-scale back-scattering interaction strength. The dependence of the gap enters through U, and through the scaling dimensions. Both e ects conspire to strongly reduce the gap magnitude near half lling. Taking  $E_c = 0.3e^2 = 1$ , approximately the maximum correlation energy per electron in a partially led Landau level, the resulting gaps for N = 2 and  $d_{qate}$  = 501, are shown as a function of lling fraction and distance between layers in Fig. 8 and Fig. 10. We notice that the gap resulting from the intralayer back-scattering interaction is very small near half lling, dropping below the range accessible to dilution fridges over most of the lling factor shown in this gure. On the other hand the gap resulting from the interlayer back-scattering interactions is not as small and remains reasonably large out to large values of the interlayer separation d. Recalling that this interaction is proportional to  $R_1^{y}L_1L_2^{y}R_2$ , we see that when this interaction is strong it favors interlayer phase coherence along each stripe edge and that when it is very strong it leads to condensation of the eld  $\frac{1}{1} + \frac{2}{1}$  to a value independent of j. Since i is by de nition the phase di erence between left and right-going ferm ion elds at the (j; ) stripe edge, and since the layers indices of right and left going ferm ions is opposite at = 1 and = 2 stripe edges, what is condensing when this interaction is strong is the phase di erence between ferm ions in opposite layers. In other words, the state that occurs in the strong interedge back-scattering lim it has spontaneous interlayer phase coherence. States with interlayer phase coherence and stripe order can occur as local and even globalm inin a of Hartree-Fock energy functionals. Coupled with the irrelevance of intralayer back scattering interactions at sm all layer separations in the bilayer case, our analysis suggests that they can be the ground states of bilayer quantum Hall systems in high Landau levels.




FIG. 9. Estimated charge gap due to interlayer back-scattering interactions, for balanced bilayers (= 1=2 in each layer), as a function of layer separation. This dependence is extracted from Fig. 8 and shown here for clarity.

For intralayer back scattering, the bare backscattering interaction m atrix elem ent has both direct and exchange contributions, while interlayer back-scattering has only a direct contribution. An elem entary calculation using Landau gauge basis states leads to the following explicit expressions that were used to obtain gap estim ates: Sam e-Layer D irect




FIG.10. Estimated charge gap that would result from intralayerback scattering interactions in the bilayer case. When the scaling dimension is larger than two, the gap vanishes. Intralayer interactions are more important than interlayer interactions only at very large layer separations. The energy scale in this qure is  $e^2 = 1$ .

where the subscripts S and D refer to two-dimensional Fourier transforms of the C oulom b interactions between electrons in same and di erent layers. We see in Fig. 8 and Fig.10 that the importance of interlayer interactions diminishes rather slowly with layer separation, leading to sizable integer quantum Hall gaps out to large layer separations.




FIG.11. Apparent phase diagram predicted for experin ental studies of high m obility bilayer systems at dilution fridge tem peratures. The various phases in this illustration have qualitatively di erent transport properties. These calculations are for stripe states in the N = 2 orbital Landau level (a = 5:8), with weak remote-gate screening  $(d_{gate} = 50)$ . It is possible to explore the phase diagram experimentally in a single sample, since both the top layer lling factor and the normalized interlayer separation d=', are altered when the charge in balance and total electron density are changed by using front and back gates in combination. For interlayer spacing d less than approxim ately 1:5' and any charge in balance, we expect the bilayer to be in an isotropic interlayer phase coherent (IIPC) state which has a large gap, integer quantum Hall e ect and isotropic transport properties. An isotropic states are expected only for more widely spaced layers, d > 1:5'. For strongly unbalanced layers ( far from 1/2) we expect an isotropic W igner crystal (W C) states to appear because of intralayer backscattering interactions, just as they do in the single layer case. These states will exhibit a quantum Halle ect with an odd integer quantized Hall conductivity. Stripe (sm ectic m etal) states (SS) tend to occur when each layer has a lling factor close to = 1=2, but as in the single layer case these states are never the true ground states. Sm ectic m etal states show an isotropic transport but do not show an integer quantum Halle ect. Interlayer backscattering interactions always induce charge gaps but these are som etim es too sm all to be observable at a typical dilution fridge tem peratures which we take to be  $0.001e^2 = 1$ . Regions with an estim ated charge gap larger than this value are labeled as sm ectic phase coherent (SPC) state regions in the phase diagram . Sm ectic phase coherent states have an odd integer quantum Halle ect, and are expected to have transport properties which are much more anisotropic than those of the anisotropic W igner crystal states. This state should also exhibit giant interlayer tunneling conductance anom alies at low bias voltages.

Our results for the energy gaps are summarized in Fig.11 by a schematic phase diagram intended to represent predicted experimental notings in very high mobility bilayer systems at dilution refrigerator temperatures. This phase diagram was constructed from a recipe spec-

ied below. Dierent regions of the phase diagram as a function of layer separation d=l and im balance, characterized by , are identied as exhibiting the behavior of one of the following phases. The bilayer smectic state is a state with no integer quantum Halle ect and anisotropic transport. The coherent bilayer sm ectic state willhave an integer quantum Halle ect but will still have anisotropic transport at nite tem perature. The bilayer W igner crystal state will have an integer quantum Hall e ect with an odd integer quantized Hall conductivity. W e predict bilayer sm ectic state behavior when neither interlayer nor intra layer back-scattering interactions produce a gap larger than  $0.001e^2 =$  W e judge that a gap smaller than this size would not produce observable effects in a typical dilution fridge experiments. Interlayer backscattering interactions are much more e ective than intralayer interactions in producing gaps because they are strongly relevant. We predict bilayer W igner crystal behavior when the intralayer back-scattering yields the largest gap and a gap that exceeds our minimum value. These states are expected only when the charge in balance is large or the layer separation is quite large. W e predict bilayer coherent sm ectic states when interlayer back-scattering produces the largest gap, provided again that it exceeds our minimum value. Because the intralayer interactions are strongly relevant observable gaps are expected out to very large layer separations, an unexpected result of our analysis. The interval of charge in balance where stripe (sm ectic m etal) states are expected expands only modestly with layer separation, but is sensitive to the orbital index N of the Landau levels, since nodes in the orbital wavefunctions can cause the bare backscattering matrix element to vanish at particular N -dependent values of . The details of boundaries separating stripe state and stripe-phase-coherent regions of this phase diagram will be quite di erent for di erent values of N . As we have emphasized, our approach is reliable only when quantum uctuations around the mean-eld stripe state of Hartree Fock theory are weak. For small layer separations the charge gaps start to becom e com parable to the underlying m icroscopic energy scales. In this regime we expect that the ground state is actually an isotropic coherent bilayer state, but are unable to provide a reliable quantitative estim ate of the layer separation at which this transition occurs.

## V.DISCUSSION AND CONCLUSIONS

In this paper, we have studied double layer quantum H all systems at odd integer total lling fractions. M ean eld theory predicts that these systems can form striped ground states. This observation serves as the starting point for our work. The H ilbert space in which the low energy excited states of m ean-eld bilayer stripe states reside m ay be m apped to those of an in nite set of coupled Luttinger liquids, one for each stripe, allowing us

to borrow bosonization techniques from the literature on one-dimensional electron systems. Quantum uctuations around the mean-eld stripe state are conveniently described in terms of Bose quantum elds that can be interpreted as representing charge density and the position uctuations along each stripe edge. The interactions that controlquantum uctuations in the electron ground state include both forward scattering terms which contribute to quadratic interactions in the Boson Ham iltonian and weak, but m ore com plicated back-scattering term s. The coupled Luttinger liquid model obtained when the backscattering interactions are neglected is not of the standard form because both charge and position terms in the e ective Ham iltonian have a matrix character and because the energy cost of uctuations in which stripes m ove collectively is small when the stripes are not pinned. We nd that the latter property leads to Ferm ion spatial correlations whose decay is faster than any power law, to a specic heat that vanishes less quickly than T for T ! 0, and to a tunneling density of states that vanishes faster than any power law for E ! 0. These properties of bilayer stripe states are sim ilar to properties established previously for single layers by Lopatnikova et al. and Barciet al.. There is no lim it in which bilayer stripe quantum Hallstates can be treated as a system of weakly coupled Luttinger liquids.

W e address the role played by intralayer and interlayerback-scattering interactions by evaluating their perturbative renorm alization group scaling dim ensions, following an approach two of us have taken previously for the case of single-layer stripe states.<sup>19</sup> In the single-layer case we reached the conclusion that these interactions are always relevant, and that they likely drive the system to a W igner crystal state with an energy gap. Estim ates of the size of this gap based on bare back-scattering m atrix elements and scaling dimensions gave extremely sm all values, how ever, consistent with the observation of stripe state phenom enology at tem perature scales that could be reached experim entally. Since other researchers have reached di erent conclusion about the relevance of back-scattering interactions in single layer system s, it is worthwhile in stating the conclusions we have reached in the present work to emphasize once again the philosophy that underpins our calculations and explain why we have considerable con dence in the conclusions we reached previously.

Our identication of a low-energy Hilbert space in which it is possible to derive a simpli ed many-electron H am iltonian is based on the experimental discovery of stripe states and on evidence from experiment that the true ground state is energetically very close to the meaneld theory ground state. In our view the most convincing evidence in this regard is the ability<sup>32</sup> of H artree-Fock theory to accurately predict the dependence of the stripe state orientation on in-plane eld strength, quantum well width, and other microscopic parameters. In single-layer systems, quantum uctuations are important only at low-energies and long length scales. W hen

mean-eld theory accurately describes the microscopic length scale physics, we can use the elementary excitations of the Hartree-Fock stripe state to identify the Hilbert space of low -energy excitations, and con dently use bare interaction m atrix elem ents to estim ate forward and back-scattering interaction param eters. The issue of quantum stability of smectic states in single-layer systems has received interest partly because it is closely related to the possible existence<sup>33;27;34</sup> of freely sliding analogs of the K osterlitz-T houless phase in stacked twodim ensional X Y m odels. A lthough it is certainly clear<sup>27</sup> that interacting Luttinger liquid xed-point actions exist for which back-scattering interactions are irrelevant, that is not su cient to decide on their relevance in the case of quantum Hall stripe states. Crudely speaking, irrelevance in the case of repulsive interactions requires<sup>19;28</sup> that the forward scattering interaction strength decay in a strongly non-monotonic way with edge separation. For single-layer system s Fertig and collaborators<sup>35</sup> have estim ated forward scattering am plitudes using an approach that goes beyond the weak coupling approxim ations we employ, doing so however in a partially ad hoc manner by tting their model to collective modes evaluated in a tim e-dependent Hartree-Fock approximation. Their conclusion on the relevance of back-scattering interactions is opposite to ours. The source of the discrepancy may be traced to broken particle-hole symmetry in the half-lled Landau level Hartree-Fock approxim ation W igner crystal state that they use to extract strongcoupling interaction param eters. For a single layer stripe state, back-scattering interactions can be irrelevant only if the true ground state at = 1=2 breaks particle-hole symmetry. This raises an interesting question. Could there be another class of as yet undetected phase transitions that occur in the quantum Hall regime either in the high N stripe state regime or for lower N? Broken particle-hole symmetry at = 2 would imply a nitetem perature phase transition in the 2D Ising universality class, for which the deviation of the Hall conductivity = 1=2 from  $e^2$ =2h could be taken as the order paat ram eter. There is certainly no evidence for such a phase transition in experiment, although it might be washed out by disorder<sup>36</sup> even if it occurred. In any event, broken particle-hole symmetry in the ground state would require that a phase transition occur between the hightem perature stripe state of Hartree-Fock theory that does not have broken particle-hole sym m etry and a low tem perature stripe state in which particle-hole symmetry is broken and back-scattering is irrelevant. In light of the evidence that uctuation corrections to the Hartree-Fock ground state are weak, we still believe that the sim pler conclusion of our earlier work is more likely to be correct, namely that particle-hole symmetry is not broken and that the sm ectic state is not stable.

A swe have emphasized several times the approach we have taken does not lead to standard coupled Luttinger liquid behavior. In particular, the decays of ferm ion correlation functions at large distances, and of the tunneling

density of states at sm all energies, are faster than power laws. This property occurs in our analysis because of broken translational symmetry in the stripe state which makes its energy functional invariant under a simultaneous translation of all stripes. Barci et al.24, have argued that this unusual property m ight signal a failure of the perturbative renorm alization group transform ation we have used, which rescales spatial coordinates along the stripe edges but not across them . A lthough we agree that our conclusions concerning the nature of the true ground state could in principle be altered if it were possible to extend the perturbative RG analysis to higher order. Indeed this must happen when our analysis is applied to low index Landau levels in which stripe states do not occur. W e do not believe, how ever, that the unusual correlation functions signal a greater likelihood of this eventuality than normally applies to lowest order perturbative RG calculations. In practice, the microscopic back-scattering am plitudes treated perturbatively are su ciently weak in high Landau levels that our low est order calculations seem likely to describe what happens down to the lowest tem peratures available experim entally. In our view the approach we have taken should be trusted when experim ental evidence suggests that the physics at low-energies is described by the stripe states of Hartree-Fock theory.

We nd here that the role of back-scattering interactions is quite di erent in the bilayer case com pared to the single layer case. At very large layer separations, the single-layer case in which stripe state physics occurs down to very low tem peratures for 1=2 is recovered. However, already for layer separations 10', we nd that interlayer back-scattering interactions which drive the system toward a state with spontaneous interlayer phase coherence along the edges becom e in portant and lead to a state with a substantial charge gap. O ur prediction of odd integer quantum H alle ects with anisotropic

nite-temperature transport coe cients in surprisingly widely separated bilayer systems is an important result of this paper. This conclusion about the properties of spontaneously coherent stripe states in the absence of interlayer tunneling di ers from that reached by Fertig and collaborators who, incorrectly in our view, ignore interedge coupling in considering the properties of coherent stripes. Interestingly, intra-layer back-scattering interactions that drive the system toward a W igner crystal state are irrelevant in this regime. We conclude that stripe states are indeed stable in bilayer quantum Hall system s, unlike the single layer case, but not sm ectic m etal states. It seems likely that for very small layer separations, backscattering interactions will drive the system toward a uniform charge density state with interlayer coherence, although our perturbative approach is not able to o er any substantial guidance in deciding this question.

The study of stripe state physics in single-layer quantum Hall systems requires samples of exceptional quality, beyond that required for studies of fractional quantum Hall physics with lower index partially led Landau levels which can be studied at higher magnetic elds. It is still not possible to create bilayer quantum H all system s with disorder that is as weak as that in single layer quantum H all system s. N evertheless recent sam ples appear to be of a quality that opens the physics of stripe states in bilayer system s up to experim ental study. W e expect on the basis of this work, and of previous theoretical work, that the physics will be rich, with much potential for suprises beyond the properties anticipated here.
