I. IN TRODUCTION

Reaction-di usion systems in low dimensions provide an excellent testing ground for developing our understanding of the uctuation e ects in complex systems far from equilibrium. A great deal of inform ation, both num erical and analytical, has been gathered over the past twenty years to show that the evolution of statistical properties in simple reaction di usion systems in low dimensions is anom alous, in the sense that it does not follow the corresponding mean eld equations (see [1] for a short review). In low enough dimensions, in the instances where an exact solution is lacking, there are no form alm ethods by which the exponents characterizing the di erent physical quantities may be calculated. The renorm alization group m ethod (see [2] for a review) provides the only system atic way to calculate these exponents and thus understand uctuation-dom inated kinetics in reaction-di usion systems. In this paper, we consider the model of irreversible aggregation of diusing, massive particles  $A_i + A_j ! A_{i+j}$ , in dimensions 2, and use the renorm alization group m ethod to d 1  $t^{d=2}$ ) behavior of P (m ;t), calculate the sm allm ass (m the mean density of particles of massm at timet. As we explain later in this section, this problem of determ ining P (m;t) requires using the full power of the renorm alization group m ethod. This is unlike m any other problem s where just considering the rate equations with a renom alised reaction rate is enough to obtain the right answer.

W e now give a more precise de nition of the clustercluster aggregation (CCA) model  $A_i + A_j ! A_{i+j}$  and review earlier relevant results. Consider a d-dim ensional lattice and particles that possess a positive m ass. G iven

a con guration of particles on this lattice, the system evolves in time via the following microscopic moves: (i) W ith rate D, each particle hops to a nearest neighbor and (ii) with rate , two particles on the same lattice site aggregate together to form a new particle whose mass is the sum of masses of the two constituent particles. As tim e increases, the num ber of particles decreases due to collisions and ultim ately when t! 1, all particles coagulate together to form one massive aggregate. How ever, at nite times there is a well de ned average mass distribution P (m;t) which is of interest to determ ine. It will be shown later (see the text following Eq. (16)) that the large time limit of this model is the same as the large limit. The ! 1 limit was studied numerically by K ang and Redner in one and two dimensions [3]. It was shown that P (m ;t) has the scaling form  $P(m;t) = t^{d}f(mt^{d=2})$ , where d 2 is the dimension. The two exponents are easily determined from the two gonditions m P (m ) dm t (mass conservation) and t d=2 (recurrence of random walks). The P (m) dm sm allm assbehavior of P (m;t) can be obtained by knowing the small x behavior of the scaling function f (x). On the basis of num erical simulations it was conjectured in  $x^{(2 d)=d}$ . In one dimension, the model [3] that f (x) can be solved exactly [4, 5]; it was shown that f(x)х mt<sup>3=2</sup> form or equivalently P (m;t) t. The one dimensional solution uses the property of ordering of particles on a line and is not generalizable to higher dimensions. In two dimensions, f(x) was seen numerically to increase with x for small x [3]. Also, in two dimensions, the scaling function could be determined in the limit of xed x for t! 1, where  $x = m \ln(t)=t$ . In this case it was shown [6] that P (m;t) = t<sup>2</sup>  $\ln^2$  (t)e<sup>x</sup>  $\ln^{1=2}$  (t) and jln (x) j jln (t) j. This result how – for x ever, becomes incorrect in the limit when m is xed as t! 1.

In this paper, we compute P (m;t) in 1 d 2 in the lim it t ! 1;  $m = m_0 = xed$ , where  $m_0$  is the mass of the lightest particle at t = 0. We show that P (m;t)

These results provide a theoretical basis to the results obtained by num ericalm ethods in [3]. } \end{array}$ 

The CCA m odelm ay also be considered to be a special case of the m ore generalm odel in which the aggregation kernel is m ass dependent. For a review of results on the rate equation approach to this problem see [7, 8]. The dependence of P (m;t) on m in one dimension in this m ore generalm odel has also been studied [9]. In this paper, we will restrict ourselves to the aggregation kernelwhich is m ass independent; i.e., the rates and D are independent of m ass. W hen the m ass is ignored and ! 1, the CCA m odel reduces to the well studied A + A ! A m odel [10]. The CCA m odel and its variants also nd application in a large num ber of physical system s including colloidal suspensions [11], irreversible polymerisation [12], aerosols and cloud form ation [12], river networks [13] and coarsening phenom ena [14].

Field theoretic m ethods have been previously used to study com plex systems far from equilibrium (see [15] for a review). We brie y review results relevant to reactiondi usion systems. In some earlier works [16, 17], the effective reaction rate and the decay exponent of the average particle density were computed for the A + A ! A (;)model. The renormalization group study of the same model with sources was done in [18]. In [19] the system atic renorm alization group procedure for the com putation of average density and density-density correlation function in kA ! ; reaction was developed. In [20] renormalization group analysis of A + B ; reaction in d > 2was used to study the e ects of initial uctuations on the late time decay of particle densities. The renorm alization group technology developed by Peliti, Lee and Cardy [17, 19, 20] was used to compute the average mass distribution of clusters in the CCA model in the intermediatemass range in [6].

It turns out, how ever, that as far as the study of scaling properties of one-point correlation functions in most reaction-di usion system s is concerned, renorm alization group is not a vital tool. Consider, for example, a single species annihilation model A + A ! ;. Once the renorm alization of e ective reaction rate is understood, the correct density decay exponent can be obtained from simple dimensional arguments [15]. Alternatively, one can use simple random walk argum ents or use the Sm oluchowski approximation (we refer to the case in which the reaction rate is replaced by a time dependent reaction rate as the Sm oluchow ski approximation) [3, 21], to obtain the correct values of decay exponents. A renormalized mean eld theory or, alternatively, a version of Sm oluchowski theory can also be used to compute the average m ass distribution in cluster-cluster aggregation for interm ediate m asses [22].

In the CCA model considered in this paper, it turns out that the stochastic eld P (m;x;t), describing the

continuous lim it of the local mass distribution, has a non-zero anom alous dimension in d < 2. The scaling exponent governing the dependence of the average m ass distribution P (m;t) on m ass is proportional to the anom alous dimension of the operator corresponding to the local mass distribution. As explained in Section  $\square$ any approximation schemewhich disregards this anomaly (such as the Sm oluchow ski approxim ation) predicts that m<sup>0</sup> when m  $t^{d=2}$ , for any dimension. This is P (m ;t) in contradiction with both num erical results [3] as well as the exact result in one dimension [4, 5]. The full power of renorm alization group analysis has thus to be brought to bear in order to compute the anom alous dimension of P(m;x;t) in the form of the = 2 d expansion. Since the peculiarity in the sm all m ass distribution of clustercluster aggregation is rst discussed in [3] we refer to this as the K ang-Redner anom aly.

In addition to the calculation of P (m;t), we found m any similarities between the problem of cluster-cluster aggregation and the problem of weak turbulence (see [23] for a review on weak turbulence). We elaborate on this connection in Sec.VI, where the K ang-Redner anom aly is interpreted as a violation of the K olm ogorov (constant ux) spectrum of particles in m ass space due to strong ux uctuations.

The rest of the paper is organized as follows. Section II contains a discussion of the stochastic integro di erential equation satis ed by P (m;x;t). The mean eld results, as well as the reasons for their failure in low dimensions are also included. In Sec. III, we analyze the large time a sym ptotic behavior of P (m;t) in d < 2 using the renormalization group method. We do the same for d = 2 in Sec. IV. In Sec.V, we rederive the results of Sec. III and IV using explicit re-sum mation of all diagram sgiving the leading contribution to the average mass density in the lim it of large time. Reasons for the failure of the Sm oluchow skitheory then become more transparent. In Sec.VI we elaborate on the connections with weak turbulence. Finally, we conclude with a sum mary and discussion of open problem s in Sec.VII.

# II. CONSTANT KERNEL CLUSTER-CLUSTER AGGREGATION AND MEAN FIELD ANALYSIS.

The problem of computing density correlation functions in d-dimensional stochastic processes can be reformulated as an elective equilibrium problem in (d + 1)dimensions with the help of Doi-Zeldovich-Ovchinnikov trick [24]. One can then attempt to solve the problem using the powerfulm ethods of statistical eld theory, in particular those based on renormalization group ideas. Starting from the lattice version of the CCA model, we would like to derive the corresponding eld theory and the Langevin equation obeyed by P (m;x;t), where P (m;x;t)dm dV is the num ber of particles with masses in the interval [m; m + dm] in the volum e dV. It was shown in [6], that the problem of noding all correlation functions of the local mass distribution is equivalent to nding all moments of the following stochastic integro-di erential equation (stochastic Sm oluchow skiequation):

where P  $P = \frac{R_m}{0} dm^0 P (m m^0; x; t) P (m^0; x; t)$  is a convolution  $R_{term}$ , (x; t) is Gaussian white noise and N  $(x; t) = \frac{1}{0} dm P (m; x; t)$ , is the local particle density. We are interested in P (m; t) = hP (m; x; t), where h:::i denotes averaging with respect to the noise . If the initial number of particles of di erent m asses at di erent lattice sites are independent Poisson random variables parameterized by initial average m ass distribution  $P_0(m)$ , then the initial condition to be supplied with Eq. (1) is P  $(x; m; 0) = P_0(m)$ . It is easy to check that Eq. (1) conserves the average m ass density = m P(m) dm.

As particles aggregate the typical mass grows in time as  $t^{d=2}$ . If we are interested in small masses, we need to consider masses smaller than the typical mass, m

 $(D t)^{d=2}$ . This can be achieved by considering  $m = m_0$  to be xed as t ! 1, where  $m_0$  is the smallest mass at t = 0. In this case, the rst term on the right hand side of Eq. (1) is almost surely small compared to the other term s. Consequently, the small mass behavior of the local mass distribution is described by the following system of non-linear stochastic partial di erential equations (SPDE):

Equations (2) and (3) demonstrate an interesting connection between this model and A + A ! A model. Stochastic eld P can be identied with  $\frac{@N}{@N_0}$ , where N<sub>0</sub> is the initial density. D i erentiating Eq. (3) with respect to N<sub>0</sub>, and setting P =  $\frac{@N}{@N_0}$ , we obtain Eq. (2).

We are interested in the behavior of P (m;t) in the limit of xed m and t! 1. We can then identify the particles with this xed mass as B kind of particles and the remaining particles as A kind of particles. Then, clearly, the study of Eqs. (2) and (3) is equivalent to the study of a two species reaction

in the limit when concentration of B particles is much smaller than that of A particles. This two species problem has been studied in d = 1 for arbitrary di usion rates [25]. Specializing results of this paper to our case, we nd that P (m;t) t  $^{3=2}$  fort ! 1 . A sum ing that the large time a symptotics of P (m;t) is universal, we can restore the m-dependence using dimensional analysis, to obtain

where C is a constant, and is the average m ass density. Equation (5) m atches with the exact results obtained for the CCA m odel in one dimension [4, 5].

However, no exact solutions are available for dim ensions d > 1. In the rest of the paper we will be analyzing Eqs. (2) and (3) in d > 1 using the dynam ical renormalization group method. We will show that for small masses and 1 d < 2,

Here,  $t_0 = 2$  , where is the lattice spacing.

Before doing the renorm alization group analysis, let us analyze Eqs. (2) and (3) in them ean eld (weak coupling) lim it. Neglecting stochastic terms in the right hand side of Eqs. (2) and (3) and solving the resulting system of ordinary di erential equations, we obtain

Thus, at large times, P (t)  $t^2$ , given that mean eld theory is applicable. Relative corrections to the m ean eld result are of the order  $g_0$  (t) =  $\frac{t}{(D t)^{d-2}}$ . Therefore mean eld theory is asymptotically exact in d > 2[26] and diverges with t if d < 2. Re-sum m ation of the most divergent terms in the weak coupling expansion of P around the classical solution is required and can be performed in the case at hand using the formalism of renorm alization group. The details of the computation are given in the next Sec. III. Here, we would like to dem onstrate that accounting for renorm alization of the coupling constant alone doesn't yield the correct decay exponent as m entioned earlier. To the leading order in d, renorm alization of the e ective reaction rate = 2 reduces to replacing in Eqs. (2) and (3) with renorm alized value  $_{\rm R}$  = f ( )t  $^{=2}$  and om itting stochastic term s (renorm alized m ean eld approxim ation). E lim inating N (t) from the resulting system of ordinary di erential equations one nds the following equation for P (m;t):




FIG.1: Propagators and vertices of the elective theory, Eq. (12)

This implies, that  $P(m;t) = m^0 t^{-d}$ . In other words, P(m;t) scales with time according to its physical dimension. As a result it does not depend on mass. As we will show in Sec. III, arguments leading to this conclusion are incorrect, as they disregard the possibility of anom alous dimension of the stochastic eld P.

#### III. RENORMALIZATION GROUP ANALYSIS OF STOCHASTIC AGGREGATION.

The average m ass distribution P (t) and average particle density N (t) adm it functional integral representations which can be obtained by applying the M artin-Siggia-Rose procedure [27] to Eqs. (2) and (3) (equivalently see Eqs. (2)-(4) of [6]). We then obtain

where O(t) = N(x;t) or P(x;t) and

is the elective action functional. Perturbative expansions of N(t), P(m;t) in powers of can now be obtained in the standard way, see for example [28]. Feynm an rules for constructing terms of these expansions are sum marized in Fig. 1. Due to the non-renorm alization of the di usion rate as well as the average m ass density in the eld theory Eq. (12), in all that follows, we use units in which = D = 1.

The averagem ass distribution P (m;t) is form ally given by the sum of all diagram shuilt out of blocks presented in Fig.1 with one outgoing punctuated line (P-line). The contribution from each diagram is a function of N<sub>0</sub>t and 'bare' dimensionless reaction rate  $g_0$  (t) =  $\frac{t}{t^{d-2}}$ . Unless we are interested in the small time expansion of P (m;t), N<sub>0</sub>t cannot be treated as a small parameter. Therefore,




FIG.2: Diagrammatic form of mean eld equations for: (A) A verage particle density; (B) A verage mass distribution; (C) N N -response function; (D) P P -response function.

the contributions of all diagram s proportional to a given power of  $g_0$  (t) and various powers of N  $_0$ t have to be sum m ed up. A sim ple com binatorial argum ent (see [19] for details) shows that the contribution of a diagram with n loops is proportional to  $g_0(t)^n$  . In the weak coupling regime the main contribution to P (m;t) and N (t) is, therefore, given by the sum of all tree diagram s, the rst correction com es from sum ming all one-loop diagram s and so on. It turns out [19, 29] that the sum of all tree diagram s gives the mean eld answers E gs. (8) and (9). The expansion in powers of  $q_0$  (t) is therefore the standard loop expansion around solutions of mean eld equations. It is obvious that in d < 2 the loop expansion is not very useful at large times as  $\lim_{t \ge 1} g_0(t) = 1$ . Fortunately, the value of dimensionless reaction rate properly renorm alized to account for the build-up of inter particle correlations turns out to be of order = 2 d for large times. This allows one to convert the loop expansion into an -expansion using perturbative renorm alization group method. Such an expansion works well for large tim es and will therefore yield all the inform ation we need about the behavior of the average mass distribution in the strongly uctuating regime.

In computing loop corrections to any order, there are generally an in nite number of diagrams to sum. However these diagrams can be resum med in part if one introduces classical response functions  $G_{cl}^{NN}$  and  $G_{cl}^{PP}$ . Response function  $G_{cl}^{NN}$  ( $G_{cl}^{PP}$ ) is equal to the sum of all tree diagrams with one outgoing and one ingoing line of types N (P). As was already mentioned, mean eld densities Eqs. (8) and (9) are also equal to the sum s of tree diagram s with one outgoing N or P line correspondingly. One then simply has to associate incoming lines with mean eld densities and propagator lines with mean eld response functions. Integral equations satis ed by classical densities and response functions are presented




FIG. 3: O ne-loop corrections to the mean eld answer for average m ass distribution.

in diagrammatic form on Fig.2.

Solutions of Eqs. Fig. 2 (A) and Fig. 2 (B) coincide with Eqs. (8) and (9), as they should. Equations Fig. 2 (C) and Fig. 2 (D) can also be solved with the result

where  $G_{\,0}\,$  is the G reen's function of the linear di usion equation.

U sing the notion of mean eld response functions and densities one can easily classify all one-loop diagrams s contributing to average mass distribution. The result is presented in Fig. 3. A quick check shows that analytical expressions corresponding to diagram s Fig. 3 (i) and Fig. 3 (iii) containing primitive loops diverge in d 2, which is consistent with that fact that upper critical dimension of the elective theory Eq. (12) is two. C om puting the relevant integrals in d = 2 dimensions we nd the following one-loop expression for the average mass distribution:

Equation (14) can be used to determ ine the large time asymptotics of P (t) in the following way. The exact averagem ass distribution satis as the Callan-Sym anzik equation which we will derive below. Coe cients of this equation depend on the law of renorm alization of all relevant couplings of the theory Eq. (12). One relevant coupling is the elective reaction rate. Its renorm alization is known [17]. Below we will show that the only other relevant coupling is the initial mass distribution  $P_0$ . We will determ ine it's renorm alization law with one-loop precision dem anding that, the expression Eq. (14) be non-singular in the lim it ! 0 when expressed in terms of renormalized coupling constant and renormalized initial mass distribution. This will determ ine coe cients of Callan-Sym anzik equation up to terms of order  $g_R$ , where  $g_R$  is the renormalized dimensionless reaction rate. Solving this equation we will be able to compute the decay exponent of P (t) up to term s of order  $% P_{R}$ .

D in ensional analysis of e ective vertex parts of the theory Eq. (12) shows that the only relevant bulk coupling is the e ective reaction rate. Its relevance is due to the recurrence of random walks in d 2. Reaction rate renorm alization accounts for all uctuation e ects in the A + A! A m odel.

However, the CCA model is more complicated and interesting due to the presence of boundary-relevant couplings. To identify them, we use the following version of dimensional analysis. Boundary coupling constants correspond to vertices with no incoming lines. As PPinteractions can be neglected in the problem at hand, we are interested in boundary vertices with at most one P-line. A ssume for simplicity that d = 2 (critical dim ension). A ssume also that the initial density  $N_0 = 1$ . This assumption is justilled if one is interested in the large tim e behavior of correlation functions in aggregation, as N<sub>0</sub> ow sto in nity under renorm alization group transform ation to increasingly largertim e scales, see [15] form ore details. Let ; (t), where = 0;1; = 0;1;2;... be the simultaneous G reen's function of the theory Eq. (12) with P-lines and N-lines with all external momenta equal to 0. Using Eq. (13), one can express G ; (t) in term s of corresponding vertex part V ; (t) as follow s:

As physical dimension of G ; (t) is (Length)  $^{2}$  <sup>4</sup>, V ; (t) t  $^{2}$  <sup>1</sup>. As a result, Eq. (15) converges at small times for any if > 0. If = 0 and = 1, Eq. (15) diverges logarithm ically. This divergence can be regularised using a small-time cut-o  $\frac{1}{N_{0}}$  and leads to the renormalization of the initial mass distribution P<sub>0</sub>. The latter plays a role of the coupling associated with V<sub>1;0</sub>.

As a result of the discussed divergence, diagram s involving  $V_{1;0}\,$  grow with time faster compared with diagram s with the same number of loops but with no sub-diagram s contributing to renorm alization of  $P_0$ . Consequently, diagram s belonging to the form er class have to be re-sum m ed exactly in order to obtain the correct large time behavior of the average m ass distribution.

We conclude that uctuations in stochastic aggregation lead to two e ects: renorm alization of the e ective reaction rate and renorm alization of the initial mass distribution. It follows that renorm alization of these two couplings regularizes the perturbative expansion of P (m;t) to all orders.

As it turns out, the renorm alization of  $P_0$  is solely responsible for K ang-Redner anom aly. In Sec.V we will

analyze initial density renorm alization by explicitly resum ming small time divergences in the perturbative expansion for P (m;t). Now, we will show how it appears form ally within the framework of perturbative renorm alization group method. We follow dynamical renorm alization group procedure described in [15], part I. For a review of results concerning coupling constant renorm alization, see ibid, part II.

Let us x a reference time  $t_0 > 0$ . Expression (14) evaluated at  $t_0$  is to be made nite by absorbing the divergences appearing as ! 0 into the renormalization of the reaction rate and the initial density.

Let  $g_0 = t_0^{=2}$  be the dimensionless 'bare' reaction rate. As has been shown in [17], renormalized reaction rate  $g_R$  is related to  $g_0$  via the following exact form ula:

Here g = 2 (1 + 0 ()) is the non-trivial xed point of the renorm alization group ow in the space of eective couplings of Eq. (12). Recall that  $g_0$  . Hence  $\lim_{! \ 1} g_R = g$ . It follows from the Callan-Symanzik equation that large time behavior of the P (m;t) is also determ ined by the xed point value of the elective reaction rate g. We therefore conclude that the limits  $t > 0; \ ! \ 1$  and  $> 0;t ! \ 1$  of K ang-Redner m odel belong to the same universality class as claimed in the introduction.

Solving Eq. (16) with respect to  $g_0$ , expanding the result in powers of  $g_R$  and substituting the expansion into Eq. (14) we obtain the average mass distribution at time  $t_0$  as a power series in  $g_R$ :

A sexpected, the order- $g_R$  term in Eq. (17) is still singular at = 0. To cancel the remaining divergences we have to introduce renorm alized initial mass distribution  $P_R$ :

where Z is a power series in  $g_R$  with coe cients chosen in such a way, that the average mass density

when expressed in terms of  $P_R$ ;  $g_R$ , is non-singular at = 0. Substituting Eq. (17) into Eq. (19) we nd that

in order for P (t) to be non-singular at 1-loop level.

Now we can derive the Callan-Sym anzik equation. The fact that P (t;  $_0$ ; P $_0$ ; ) does not depend on the reference time to leads to the following equation for P (P<sub>R</sub>):

Noticing that P (t) =  $t_0 \frac{d P_R}{N_0^2}$  (t=t\_0; g\_R), where is a dimensionless function, one can convert the above condition into C allan-Sym anzik equation for P (t):

It is wellknown, that at large times and in  $d < d_c = 2$ , solutions to Eq. (21) are governed by non-trivial xed points (zeroes) of beta-function. D i erentiating Eq. (16) with respect to  $t_0$ , one nds that  $(g_R) = g_R (g_R g)$ . Hence,  $(g_R)$  has a unique non-trivial xed point  $g_R = g$ . It follows from C allan-Sym anzik equation (Eq. (21)) that P (t) t<sup>d</sup>; t! 1; where

W e see that scaling dimension of P (m;t) diers from it's physical dimension by a term proportional to the value of -function at the xed point. This term is called the anom alous dimension of the eld P. The physical reason for the presence of anom alous dimension is the renormalization of the initial mass distribution by small time uctuations.

As g , the substitution of g expansion of into Eq. (23) yields the -expansion for d . Using Eq. (22) we nd that

F inally, one can restore the m -dependence of P (m;t) using dimensional argument. The result is

where  $e_{KR} = + 0$  (<sup>2</sup>) is equal to twice the anom alous dimension of the stochastic eld P.

Note that in d = 1,  $e_{K,R} = 1$  and P (m;t)  $m^1$ , which coincides with the exact answer, [4]. However, at the moment we do not have reasons to believe, that higher order -corrections to our answer for  $e_{K,R}$  vanish identically for any 0 < 1. Equation (24) in plies that anom alous dimension of P vanishes at  $d_c = 2$ . Yet, it follows from general theory of perturbative renormalization group that traces of anom alous dependence of P (m;t) on m ass in d < 2 must be present at the critical dimension as well. We analyze K ang-R edner anom aly in d = 2 in Sec. IV and com pare renormalization group predictions with conclusions of direct numerical simulations of the system of di using-aggregating point particles on the two-dimensional lattice.




FIG.4: The variation of P (m;t) $t^2$  with t is shown form = 1;2 and 4 on a sem i-log scale. The variation is linear in plying that P (m;t) = c(m) ln(t)= $t^2$ , where c(m) is some m ass dependent function.

#### IV. KANG-REDNER ANOMALY IN TWO DIMENSIONS.

It is wellknown that anom alies in  $d_c$  dimensions lead to logarithm ic corrections to mean eld theory answers in  $d = d_c$ . K ang-R edner anom aly is not an exception. Sm all m ass behavior of the average mass distribution in two dimensions can be easily obtained by solving the C allan-Sym anzik equation (see Eq. (21)). Note that

produced by the mean eld theory, we nd that

Such a behavior of P (m;t)  $j_n = f_{ixed}$  in two dimensions was originally seen by K ang and Redner in numerical simulations [3]. We have now shown that Eq. (28) can be obtained as a result of system atic renorm alization group computation.

A nalyzing their m odel in two dimensions, K ang and R edner noticed that P (m;t) is a slow ly varying (increasing, as suggested by Fig. 2 of [3]) function of m ass. We can now quantify this observation by computing the m ass dependence of the average m ass distribution. In  $d = d_c$  direct dimensional arguments cannot be used to restore the m ass dependence of Eq. (28) due to the explicit dependence of P (m;t) on the lattice cut-o. Instead let us analyze Eq. (25) for P (m;t) in the limit ! + 0. Near




FIG.5: The small m behavior of P (m;t)=P (1;t) is shown on a sem i-log plot. The variation is linear in plying that c(m) ln (m) with c(m) as de ned in caption of Fig.4.

= 0, the amplitude A ()  $^2$ . Expanding the right hand side of Eq. (25) in powers of and using the fact that P (m;t; ) is non-singular at = 0 as a function of renorm alized parameters, we nd that

We are interested in P (m;t) in the limit t ! 1; m = xed. Time dependence of P (m;t) is given by Eq. (28). Therefore,  $\infty$ e cient C <sub>1</sub> in Eq. (29) is 0. Hence

Note that Eq. (30) is valid for m M (t), where M (t) t= ln(t=t\_) is the typical mass. If m M (t), then P (m;t) (ln(t=t\_)=t)<sup>2</sup>, which coincides with the answer for P (m;t)  $j_{n-M-(t)}$  in the intermediate mass range [6].

To check our analytical results Eq. (28) and Eq. (30) we did a numerical simulation of the system on a twodimensional lattice. For the sake of computational ecciency, we chose to work in the limit ! 1 so that a lattice site can hold utmost one particle. The lattice was chosen to be a square lattice of size 3000 3000 with periodic boundary conditions. In Fig. 4, we show the variation of P (m;t) with t for xed smallm. It is seen that P (m;t) = c(m) ln(t)=t<sup>2</sup>, where c(m) is some function of the mass m. This is in excellent agreement with Eq. (28). To determ ine c(m), we studied the variation of P (m;t)=P (1;t) with the mass m (see Fig. 5). We see that c(m) ln(m), thus con rming Eq. (30).

# V. KANG-REDNER ANOMALY VIA EXPLICIT RESUMMATION OF BOUNDARY DIVERGENCES

In this section we will derive Eq. (25) without using the form alism of renorm alization group. Instead, we will identify the principal set of diagram s contributing to the the largetime limit of P (m;t) and derive a simple integral equation satis ed by the sum of these diagram s.

A dditional divergences in the term s of the perturbative expansion of the average m ass distribution discussed in the previous Sec. IV are actually due to the quadratic singularity of the mean eld expression Eq. (9) for the average m ass distribution at N<sub>0</sub> = 1 ; t = 0. Let us illustrate this statem ent on the example of diagram (i) of F ig. 3. A ssum ing for sim plicity that d = 2 and denoting ultraviolet cut-o by t, we nd that the most divergent contribution com ing from this diagram is

Setting N<sub>0</sub> = 1 under the sign of integration is clearly impossible, as the resulting integral would diverge. D irect computation of Eq. (31) shows that

We see that  $I_{(i)}$  is proportional to  $\ln(t)^2$ , not  $\ln(t)$  as one would have deduced from the simple loop counting. The additional singularity is due to the fact that  $P_{M \ F} \ j_{l_0=1} t^2$ . (Recall that  $N_{M \ F} \ j_{l_0=1} t^1$ . As a result divergences at t=0 are absent in the eld theory of  $A + A \ ! \ 0$  reaction.) The additional boundary singular terms are generally present in all Feynm an integrals contributing to P (m;t) and have to be re-sum m ed to all orders of perturbation theory to get the correct large time asymptotics of the average m ass distribution.

Let  $(t_2;t_1)$  be the exact zero m om entum vertex function of type PP - the sum of all one-particle irreducible diagram s contributing to PP response function divided by the propagators corresponding to external lines. The Schwinger-D yson equation for the exact average m ass distribution reads:




FIG.6: (I) Schwinger-Dyson Equation for (t). (II) Perturbative expansion of the polarization operator: (IIA) - in the num ber of loops; (IIB) - in the order of exact vertex parts.

Equation (33) is most easily derived using the form alism of Feynm an diagram s. Its diagram matic representation is given in Fig. 6 (I).

We know that in two dimensions P (t)  $t^2$ . Therefore, near d = 2, the function (t) = P (t)  $t^2$  is slow ly varying. The following simplied version of Eq. (33) is therefore valid to the leading order in :

D i erentiating Eq. (34) with respect to time, we nd that (t) satis es the following di erential equation:

Solving Eq. (36) with (t) given by Eq. (37), we nd that P (t) (t)= $t^2$   $t^{(2+ =2+0(^2))}$ . Thus, we have been able to rederive Eq. (24) without any reference to renorm alization group.

Before we turn to the derivation of Eq. (37), we would like to demonstrate, that solving integral equation Eq. (34) is indeed equivalent to sum m ing leading boundary singular terms in the perturbative expansion of P (t) to all orders. All divergences at t = 0; N\_0 = 1 can be regularised by setting the low er limit of integration in the integral in the right hand side of Eq. (34) equal to  $\frac{1}{N_0}$ . Resulting equation,

Note that  $_{1}$  (t) is equal to 1-bop boundary singular term,  $_{2}$  (t) -2-bop boundary singular term and so on. Sum – ming the resulting series for one con m s our main result that (t) t<sup>=2</sup>. One bop-boundary singularity leads to mass-dependent logarithm ic corrections to the average mass distribution. This is most easily seen by expanding Eq. (25) in powers of . These corrections, which were originally observed in [6], motivated to a certain extent the present investigation.

The know ledge of the rst term in the -expansion of decay exponent of (t) leads to a good approximation of the average mass distribution, given that  $\ln (N_0 t)$  1, but  $^2 \ln (N_0 t)$  1. If the latter condition breaks down, we need to know the expansion of the polarization operator (t) to second order in and modify Eq. (34) by including corrections proportional to the derivative (t) (which account for the fact that (t) is not constant).

W e will now derive Eq. (37) by computing (t) to the rst order in using 1-loop diagram s and verifying that higher-loop diagram s lead to term soforder <sup>2</sup> and higher. If mean eld theory for the average mass distribution was exact, operator would have been identically equal to zero. Consequently only loop diagram s contribute to  $(t_2;t_1)$ . The one-loop diagram s are shown in Fig. 6 (IIA). The computation of corresponding Feynman integrals is straightforward. A fler integration with respect to  $t_1$  we nd their respective contributions to (t):

Note that individual contribution from diagrams (i) and (ii) are 1= -tim es bigger than the contribution from diagram (iii), which does not contain primitive loops. Yet, term s of order 1 cancel upon adding (i) (t) and  $_{(ii)}$  (t) leaving term s of order up to  $^{0}$  -sam e as the leading order of terms of (iii) (t). This cancellation explains why we had to account for an apparently subleading contribution of diagram (iii) to the perturbative expansion of (t). Such a cancellation is not accidental and happens at all orders of loop expansion: diagram s (i) and (ii) can be interpreted as rst two terms in -expansion of the rst term in the cumulant expansion of  $(t_2;t_1)$ , see Fig. 6 (IIB). This term corresponds to an exact total particle density N (t) connected to the P'P-propagator via an exact P'N P -vertex. The vertex is of the order of the xed point coupling q , while exact density is of the order <sup>1</sup>, [19]. Therefore the contribution of the term in question to  $(t_2;t_1)$  is of order 1, which is reected in cancellation of the term s of the lowest order in

in every term of its loop expansion.

Adding together Eqs. (40), (41) and (42), we nd that

Large-tbehavior of (t) can be obtained from Eq. (43) by replacing the 'bare' reaction rate with renormalized reaction rate  $_{\rm R}$  (t) 2 t  $^{=2}$ ;t! 1. The result does indeed coincide with Eq. (37).

It rem ains to verify that two-and higher loop diagram s contribute only to higher order terms in the -expansion of (t). Order-<sup>2</sup> contributions from diagrams containing only primitive loops cancel as explained above. Order-<sup>1</sup> contributions from diagram swith two prim itive loops and two-loop diagram swith one primitive loop are accounted for by one-loop renormalization of coupling constant in one-loop diagram s. Hence non-trivial corrections to polarization operator com e only from twoloops diagram s containing no prim it ive loops and nonsingular parts of all other two-loop diagram s. Simple counting shows that contribution from such diagrams to (t) is proportional to  $\frac{(R(t)t)^{2}}{(R(t)t)}$  $\frac{2}{t}$ . Sim ilar argument shows that n-loop diagram s contribute to (t) at the order n only.

Now it is very easy to characterize the class of diagram s giving the leading contribution to the -expansion of (t). The statistics of N (t) is strongly non-G aussian. Yet, the main contribution to the polarization operator

(t) com es from the diagram s proportional to the rst and the second cum ulants of the stochastic eld N (x;t) only. N on-G aussian e ects are due to the fact that these cum ulants are connected to P P -propagator via exact vertices.

It is also possible to derive formula Eq. (28) without using the formalism of renormalization group. Instead, one can solve equation Eq. (36) directly using one-loop expression for polarization operator (t) in two dimensions. The latter can be obtained by setting in Eq. (43) d = 2 and replacing the bare reaction rate

with renormalized reaction rate in two dimensions:  $_{R}$  (t) =  $\frac{4}{\ln(t=t_{0})}$  (1 + O (1= ln (t=t\_{0}))). The presented expression for  $_{R}$  (t) is easy to compute by explicit resummation of all diagrams contributing to renormalization of the bare reaction rate, see [19] for details. The resulting equation for (t)  $t^{2}P$  (t) is

The solution is (t)  $\ln(t=t_0)$ . Correspondingly, P (t)  $\frac{\ln(t=t_0)}{t^2}$ , which coincides with Eq. (28).

# VI. KANG-REDNER ANOMALY AND CORRECTIONS TO KOLMOGOROV PARTICLE SPECTRUM .

Now we will show that the mean eld result P (m;t) m<sup>0</sup> can be interpreted as a constant ux (K olm ogorov)

solution of the Sm oluchow skiequation.We will then interpret K ang-Redner anom aly as a breakdown of K olm ogorov scaling due to strong ux uctuations developing at large times.

A veraging Eqs. (2) and (3) with respect to noise one gets the following relation between one- and two point m ass distribution functions:

Let us look for solutions of Eq. (46) having the form

where =  $\frac{m}{M(t)}$ . Recall that M (t) = N<sup>-1</sup> is the typical mass. The new dependent variable J has a simple physical meaning: 0 d<sup>-0</sup>J (<sup>-0</sup>;t) is the average number of particles with masses less than M (t) contained in the volum e N<sup>-1</sup> (t).

At times much less than  $t_c = ()^{2=}$  relative uctuations of local density are small. As a result, mean eld theory is applicable and hJN i hJihN i. As a result, equation Eq. (45) simpli es to

Therefore,  $\frac{J}{J}$  is a locally conserved quantity with ux equal to (J). Note that J > 0. Therefore the cascade of  $\frac{J}{J}$  is inverse in the term inology of turbulence: its ux is directed towards the small masses. We see that selfsim ilar solutions of Eq. (46) correspond to constant ux solutions of Eq. (48). The latter is just J = C onst. C onstant ux solutions of kinetic equations are called K olm ogorov solutions in the theory of weak turbulence, see [23] for details. We therefore conclude that in the mean eld approximation

where  $e_{k\,o\,lm}~=~0$  is the exponent, which determ ines the K olm ogorov scaling of the average mass distribution. Note, that the  $~ux\,J$  also has a meaning of dimensionless particle density (the number of particles in the volume N $^{-1}$ , which is an obvious integral of motion.

The fact that J = const, means that particles are equipartitioned between system's degrees of freedom and particles' ux is identically equal to zero. The characteristic feature of the state Eq. (49) of our system is therefore the presence of non-zero constant ux of one integral of motion and equipartition of the other. Sim ilar kind of behavior has been observed in models of turbulent advection, [30]

We know however, that mean eld approximation is invalid in the limit of large times if dimension is two or lessbecause of strong uctuations of local particle density
. U sing results of the previous sections one can interpret
K ang-R edner anom aly as the anom aly in the constant
ux condition:

where  $e_{K R}$  is K ang-R edner's exponent.

Solving Eq. (50), we not that P (m;t) <sup>e</sup>, where  $e = e_{k \circ lm} + \frac{e_{K \cdot R}}{d}$ . Therefore, K ang-R edner anom aly can be also interpreted as a correction to K olm opprov scaling of the average m ass distribution due to strong uctuations.

## VII. CONCLUSION.

In the present paper we have shown that the problem of cluster-cluster aggregation in d 2 can be e ectively analysed using renorm alization group m ethod. W e have dem onstrated that the dependence of average m ass distribution on mass is determined by the anomalous dimension of the stochastic eld P (local mass distribution). This anom aly is due to the relevance of 'boundary' (t = 0) uctuations for the large times asymptotics of P (m;t). In that respect the phenom enon of K ang-Redner anom aly resembles the phenom enon of boundary phase transition in equilibrium statistical mechanics, see [2] for a review. Form ally, the anom alous dimension of the local mass distribution is a consequence of the nontriviality of the -function of the eld theory Eq. (12). The fact that (g)  $\neq$  0 is ultimately responsible for the breakdown of the Smoluchow skitheory (or equivalently, the renorm alized m ean eld theory) applied to the model at hand. At present, renorm alization group analysis seem s to be the only theoreticalm ethod of studying the problem of cluster-cluster aggregation in d > 1. This is not quite satisfactory, as the analysis is essentially perturbative in nature. However, our theoretical predictions concerning the behavior of the average mass distributions at sm all m asses in two dimensions have been unambiguously con med num erically.

In section VI we have shown that there is a relation between cluster-cluster aggregation and the theory of weak turbulence. In particular, we demonstrated that K ang-Redner anom aly can be interpreted as a correction to the K olm ogorov spectrum of particles in the mass space. However, we must stress that the analogy between our model and the phenom enon of turbulence must be taken with a pinch of salt: while the cascade of the conserved quantity in ourm odel happens along the mass axis only, conserved quantities (such as energy or enstrophy) in more traditional turbulent system s ow through the scales of the physical space.

The method of dynamical renorm alization group developed in the context of the model at hand can be applied to other non-equilibrium particle systems as well. In particular the problem of cluster-cluster aggregation with annihilation of particles, can be solved using techniques similar to those outlined in this paper [31]. This latter problem is related to the computation of the domain wall persistence exponent for the 1d q-state Potts m odel [31].

As a result, density-density correlation function is not equal to the product of one-point function, but rather is proportional to it. Yet, as the renorm alized reaction rate in d > 2 is a constant depending on lattice spacing, decay exponents are predicted by the mean eld correctly.
