


FIG. 3: Scaling of the model with a = m = 1size N, for (a) k =least-squares fits to the  $P_N(k)^{-1} \sim \ln N$  in (b)




FIG. 4: Clustering cofor different values of merical simulations or network size  $N = 10^5$ the analytical solution





FIG. 5: Average near degree k for different from numerical simulup to a network size tions. The continuou dependency  $\bar{k}_{nn}(k)$  –




