NEURAL NETW ORK ANALYSIS OF THE MAGNET IZAT ION REVERSAL IN MAGNETIC DOT ARRAYS

SUM M ARY

We simulated the remagnetization dynamics of the ultra-dense and ultra-thin magnetic dot array system with dipole-dipole and exchange coupling interactions. Within the proposed 2D XY superlattice model, the square dots are modeled by the spatially modulated exchange-couplings. The dipole-dipole interactions were approximated by the hierarchical sums and dynamics was reduced to damping term of the Landau-Lifshitz-Gibert equation. The simulation of 40000 spin system leads to nonequilibrium nonuniform con gurations with soliton-antisoliton pairs detected at intra-dot and inter-dot scales. The classic cation of intra-dot magnetic con gurations was performed using the self-adaptive neural networks with varying num ber of neurons.

1. IN TRODUCTION

M any interesting applications of the periodic m agnetic dot arrays are expected in the eld of the m agnetic recording [1] and m agnetic sensors. The typical properties brought by the array geometry is the limited length of the spin chains coupled by the exchange coupling and the uniqueness of the m agnetostatic interactions at the scales com parable or larger than dot size.

The powerful tools to study the static and dynam ic properties of magnetic nanostructures including the thin $\ln s$ and isolated small particles represent m icromagnetic [2], and M onte Carlo [3, 4, 5, 6] simulations. They are focussed to the analysis of the nonuniform magnetization states. On a purely qualitative level the intra-dot nonuniform ities can be characterized as a mixtures of vortices, owers, domain walls, etc.. Our recent activity is related to the search for the tools allow ing the system atic classi cation of the simulated magnetic structures.

The methodology presented in this paper is inspired by the progress in the theory of arti – cial neural networks, that are nonlinear models suitable to reduce, classify or interpolate the inform ation involved in the system s of the com plex patterns [7]. In the previous paper [8] we suggested the im plem entation of radial basis function networks to model the magnetic dot array m agnetization processes. The lack of this proposition was the absence of the network learning which needs the data support from physically acceptable m icrom odel sim ulations.

The above reasons led us to make some progress towards the opposite direction by using the neural network analysis of the con gurations generated by the rem agnetization processes described by the XY superlattice model of the ultra-dense array of the square dots limited to inplane spin polarization. The motivation for the study of ultra-dense spin structures is the special interest for the interfacial inter-dot e ects. The experim ental studies of the magnetization reversal are generally not in agreement with the fam iliar m odel of coherent rotation. Instead, com plex processes such as curling and buckling are observed. The model structures were obtained by simulations based on the numerical solving of Landau-Lifshitz-Gilbert equation. The simulations bring the usual problem of e ective data post-processing [9]. In the present paper the data were treated by means of so called adaptive resonance neural network ART, which is introduced in section 3. This tool was used to classify the intra-dot magnetic con gurations, which are the transients of the magnetization reversal process. The ART choice is connected with its ability to vary the number of neurons (network topology) according to complexity of treated inputs, which are in our case activated by the intra-dot m agnetic con qurations. In the section 4 we concentrate to the analysis of data provided by the sim ulated m agnetization reversal.

2.XY MODEL OF ULTRA-DENSE ARRAY

The details of the rem agnetization dynamics are studied by means of the model of nite magnetic superlattice system described by the XY spin Hamiltonian




Figure 1: The schem atic plot of the exchange coupling (bonds represents = 1) m odulation. The system contains 16 dots, each of them consists of 25 spins.

The rst sum of Eq.(1) represents the dipolar contribution controlled by the constant K, where (5 j = 1) is the planar spin variable and S is the dem agnetization tensor of superlattice; ; are site indices. The second sum represents the exchange energy contribution with periodically modulated nearest-neighbor exchange coupling interaction J , where 2 f0;1q (see Fig. 1). The third sum represents standard Zeem an term where e_x is the Cartesian unit vector oriented along the main axis of superlattice. Presented m odel belongs to the idealized structure, where the patterning attains the maximum geometric lling independent of dot size (L₀ linear size of dot).

The model dynamics was described by the Landau-Lifshitz-Gilbert equation, that in 2D case reduces to relaxation term. The numerical integration scheme was derived from the recursive propagator form

where ! (t) = (S (t) g)(h (t) g) (S (t) e_y)(h (t) g) is the instant angular frequency of the spin rotation, h (t) = H = S is the local e ective eld; t is the time, t is the integration step. The unitarity of the spin rotation m atrix

in plies that num erical integration scheme conserves the spin vector size independently of additional approximation of integral in Eq.(2). The computationally demanding task of the integration is the calculation of the dipolar elds, where essential reduction brings the hierarchical sum m ation [10]. In the case of array, the m ost natural hierarchy level choice is the block association with the single intra-dot m om ent.

3. THE ART CLASSIFICATION OF INTRA-DOT CONFIGURATIONS

The articial neural network models are inspired by the physiology, and m im ic the neurons and synaptic connections of a brain. They can be considered as mappings [7] constructed from given activation functions. The unknown param eters of these functions called synaptic weights are adjusted by training. The fascinating feature of the neural systems is the associative recognition of complex structures. In this paper we deal with the ART networks developed by Carpenter and G rossberg [11], originally as a model to explain the adaptive phenom ena in visual systems. The family of ART algorithms belongs to group of unsupervised learning algorithm s based on the theory of adaptive resonance motivated by the need to construct network su ciently exible to novel inputs and preserving previously learned patterns. ART model represents simple clustering algorithm, which has been complemented with the ability to generate new neurons if necessary. This is done by using a so called vigilance parameter. For the summary of the key results and examples of ART network applications see e.g.[12]

These properties led us to the opinion that ART network should be powerful to classify and compress the magnetic intra-dot con gurations generated during the reversal. First, we must encode the magnetic structure into network input form at. We used encoding, where each dot magnetization eld is replaced by N_c e ective magneticm om ents located at interaction centers. The mom ents income into 2N_c dimensional vectors [8] named as m_i, where i is the dot label. The vectors m_i represent inputs of ART which com – presses this information into N_w output neurons named w_i. Their structure is




Figure 2: The example of the averaging from Eq.(4) showing the sixth square segment 2_{16} of ith dot including N_S = 49 spins.

index n enumerates the spin blocks; m in represents locally averaged dot m icrostate over the N_S spins (see Fig.2) belonging to the square element 2_{in} of ith dot. The match between ART input m_i and output w_i is measured by the "m agnetic"

(T is superscript denotes the transposition).

The learning algorithm is described in the follow - ing points

- 1. Initialization setting $N_w = 1$, $w_1 = m_i$ for random selection i2 f1;2;:::N dg.
- Loop through the set of the intra-dot m agnetic patterns. For each random ly selected dot i follow s:
- 2.1 Presentation m_i to the network. The learning is repeated for iteration steps k = 1;2;:::
- 2.2 Computing of the actual index j (k;i) of the winning neuron $w_{j (k;i)}(k)$ trained by m_i according to the competitive rule

- 2.3 C om paring kw_j (k_{ji}) (k) m_ik to the vigilance parameter .
- 2.3.1 Update of the weights via the Hebbian learning rule [7]

The product of annihilation $[z_1; z_2] ! z_1$, $N_w N_w 1$ is the neuron w_{z_1} determined by the midpoint rule $w_{z_1} \frac{1}{2}(w_{z_1} + w_{z_2})$. After w_{z_1} update $w_{j>z_2}$ neurons undergo to collapse: $w_{j1} w_{j}$.

 Stop criterion is represented by the inequality

where " is small parameter. If the above inequality is not fulled the algorithm follows from the step 2 with k incremented by 1.

The full lm ent of the last criterion m eans that network attains a xed point. By this way xed neurons w_j ; $j = 1;2;:::;N_w$ represent the collection of the basic types of the extracted intra-dot con gurations. In the case of m agnetization reversal, the ART network has been applied independently to arrays at di erent time steps. The typical intra-dot and inter-dot rem agnetization transient states are presented in the next section.

4. RESULTS OF SIM ULATION

The computations were performed for system of 100 dots which each dot consists of 400 spins in external eld H = J = 1 and K = J = 0:1 with initial saturated state M (t = 0) g = 1, where M is the magnetization of array.

In the array simulations we observed the hom ogeneously magnetized dots as well as dots showing the nonuniform remagnetization. At the beginning of reversal the opposite external magnetic eld form s dom ain nucleation centers at the dot corners. The dom ains inclined by the external eld then grow and pass towards the dot centers by diminishing the area of the opposite domains. If the same polarity dom ains originating at di erent parts (corners or edges) of the dot are separated by the dom ain of opposite polarity, the dom ain grow th causes the form ation of two-fold dom ain wall - so called soliton-antisoliton pairs [3].




Figure 3: Two schemes of the principal transient states of the nucleation, soliton-antisoliton pair form ation, dom ain motion and double-wall annihilation. The axial-symmetric scenario with openwall soliton-antisoliton pair (case a) is typical for the earlier transients of remagnetization and noncentric dots, whereas the center-symmetric solitonantisoliton closed-wallm ode (case b) is typical at the later transient states and dots located near to the center of array.

The hom ogenization of intrinsic dot region is attained by the driving e ect of external magnetic eld which leads to wall otion annihilating the soliton-antisoliton pairs (see model Fig. 3). The coherent rotation occurs only at the early stages of the remagnetization for the su ciently small dots when the exchange length is su ciently greater than size of dot. This coherence locates nearly the comers of array. The form ation of the soliton-antisoliton dom ain walls is typical for the central parts of the array and later stages of the remagnetization.




Figure 4: The pruning of ART network with the increasing vigilance parameter for K = J = 0:1 and $L_0 = 20$. The intra-dot con guration is locally averaged over N_s = 4 spins [see Eq.(4)]. a) the con guration near to the switching time (t' 850 t); b) for the time when internal energy attains its maximum (t' 1100 t).




Figure 5: The ART network representation of the magnetization reversal for K = J = 0.1, $L_0 = 20$. The con guration belongs to N_s = 4 spin average (see Eq.(4)). The arrows connect the closest dots (in the sense of "m agnetic" Euclidean distance from Eq.(5)). The columns of intra-dot structures correspond to integer multiplies of t = 0.01 units.

Them ain point of analysis of intra-dotm agnetization con gurations deals with the implementation of ART network treating the subsequent stages of the rem agnetization. The ART training was realized for the con gurations at times separated by the time step t for training parameters $_{0} = 0:1$, $_{learn} = 20$ and " = 10⁶, = 1:15. The optim ized choice of vigilance (= 1:15) stem s from the prelim inary quasistatic calibration sim ulations (see Fig. 4), where vigilance was slow ly decreased from the initial large value = 1:5 (stabilizing one neuron) to the sm all values pushing the network to the incorporation of many neurons. The view point mediated by ART leads to the intra-dot taxonom y depicted by Fig. 5, where the nearest neurons [in the sense of distance Eq.(5)] belonging to di erent tim es are connected by arrows. The ART model clearly distinguishes between coherently rotating m onodom ain dots and




Figure 6: The detailed view on reversal in the ART representation for su ciently small = 0.8 showing the process of form ation and annihilation of intra-dot solitons (for the same parameters used in previous picture).

dots including com plex dom ains structures. The increasing diversity of con gurations occurring immediately after the switching time is selfadaptively rejected by the extended population of neurons. The ART compression for later reversal transient states is clearly caused by the small intra-dot diversity within the array. The details can be studied by means of the parameter , which represents the virtual "magnifying glass" capable to focus to the most interesting nal intra-dot transients (see Fig. 6 for = 0.8).

5. CONCLUSIONS

The magnetization reversal has been sinulated for superlattice model of ultra-dense magnetic dot array. Results of ART classication demonstrated that details of reversal are determined by the interplay of exchange and magnetostatic couplings, inter-dot domain wall couplings and nite-size e ects. The consequence of periodic exchange-coupling cuts is the form ation of intra-dot soliton-antisoliton pairs.

The neural network is a new type of model which allow studying of systems with many interacting pieces. We have shown that ART diagram matic view point is helpful in thinking how a dot switches from one state to another within the large time intervals, and how to extract the typicalchannels of intra-dot evolution. The computational experience creates also believe that advantages of ART paradigm should be valued namely in 3D case, where visual classi cation meets human recognition bounds.
