In uence of the Potential Energy Landscape on the Equilibration and Speci c H eat of G lass Form ing Liquids

We show that a glass transition, signaled by a peak in the speci c heat vs. tem perature, can occur because a glassy system that shows no signs of aging progresses so slow ly through the energy landscape that the time needed to obtain an accurate estimate of the therm odynam ic averages exceeds the observation time. We nd that below the glass transition tem perature of a three dimensional binary mixture of soft spheres, the speci c heat increases with measurement time spans orders of magnitude longer than previously recognized equilibration times.

As a glass form ing liquid is cooled or compressed, a glass transition occurs when the system falls out of equilibrium, i.e., when the time scale for reaching equilibrium exceeds the observation time [1]. Like m any com plex system s, such as proteins and neural networks, the dynam ics of such a system is strongly in uenced by the potential energy landscape where each point corresponds to a particular con guration and energy of the system [2, 3]. The energy landscape can be used to describe the three ways in which a system can fallout of equilibrium. First a system can become trapped in a metastable minimum where it stays for the duration of the observation time. Second a system can be in an energetically unlikely part of phase space and proceed slow ly to a region of the energy landscape where its con gurations obey a Boltzm ann distribution. As such a nonequilibrium system evolves toward m ore probable regions of phase space, it exhibits aging which means its properties system atically change with time and do not obey stationarity [4]. The aging time, after which aging stops, is equal to the relaxation time which is the charactistic time for the system to forget its initial con guration.

The third way is not widely appreciated and is the subject of this paper. Namely, even after a glassy system no longer ages and has reached basins with appropriate energies, the system proceeds so slow ly through the energy landscape that it takes a long time to accumulate the large num ber of statistically independent m easurem ents needed to accurately determ ine a therm odynam ic average. We nd from molecular dynamics simulations that a glass form ing liquid can undergo a glass transition, as signaled by a peak in the specic heat C_V versus tem perature, that is due to insu cient averaging by a system that shows no signs of aging. The distribution of energies that a system samples in a basin of the energy landscape is a subset of the full distribution of energies available to the system . Since this subset has a sm aller variance than the full distribution, the resulting speci c heat, which is proportional to the variance of the energy, will be sm aller when calculated from short time spans than from long time spans. These smaller values account for the values below the peak in C_V on the low tem perature side. Going

to longer time spans elim inates the peak, though at tem – peratures below the peak tem perature T_p , these longer time spans can be orders of magnitude longer than previously recognized equilibration times such as the relaxation time, the energy correlation time, and the aging time.

W e have perform ed a m olecular dynam ics simulation on a three dimensional glass forming liquid [5, 6] consisting of a 50:50 m ixture of two types of soft spheres, labelled A and B, which dier only in their sizes. The interaction between two particles a distance r apart is given by V (r) = $[(=r)^{12} + X]$ (r)] where the in-= (+)=2, and the ratio of the teraction length ratio of the diameters $_{B} = _{A} = 1.4$ (, = A, B). The equations of motion were integrated using the leap frog m ethod [7] with a time step of 0.005. During each run the density $_{\circ} = N = L^3$ was kept constant. $N = N_A + N_B$ is the total number of particles. The system occupies a cube with volum e L³ and periodic boundary conditions. A coording to the ideal m ode coupling theory, the relaxation time diverges at a tem perature T_c [8]. For our system $T_c = 0.303$ [9].

We cool the system from a high temperature (T = 1.5) by low ering the temperature in steps of T = 0.05. At each temperature we equilibrate for 10^4 time steps and then measure the quantities of interest for 10^7 additional steps. The results are then averaged over di erent runs. At the glass transition the system falls out of equilibrium and becomes trapped in a basin of the energy landscape. In order to avoid this, we have used parallel tempering together with molecular dynamics. We implement parallel tempering (PT) [9, 10] by running molecular dynam ics simulations in parallel at chosen temperatures using a temperature constraint algorithm [7] to keep the tem perature of each simulation constant. At 100 time step intervals we attempt to switch the con gurations of two neighboring temperatures using a Metropolis test which ensures that the energies of the con gurations sampled at any given tem perature have a Boltzm ann distribution. Let $_1$ and $_2$ be two neighboring inverse tem peratures, and let U_1 and U_2 be the corresponding potential energies of the con gurations at these temperatures. If = (1 2)(U2 U_1), then the switch is accepted with probability unity if 0 and with probability exp() if > 0. The acceptance ratio is between 30% and 75%. Near T_p , the acceptance ratio was above 60%. A fter a swap is accepted, the velocities of the particles in each con guration are rescaled to suit their new tem perature. Switching con gurations allows a given simulation to do a random walk in tem perature space in which it visits both low tem peratures and high tem peratures. This helps to prevent it from becoming trapped in a valley of the energy landscape at low tem peratures. Typically we equilibrate for 2 m illion time steps and then do measurem ents for an additional 4 to 10 m illion m olecular dynam ics (md) steps. We average over dierent runs which have di erent initial positions and velocities of the particles at each tem perature.




FIG. 1: Speci c heat versus tem perature. Shown is the speci c heat calculated from uctuations for systems with 216 particles (, averaged over 6 runs) and with 512 particles for m easurem ents covering 4 10^t tim e steps (5, averaged over 9 runs) and 10^7 time steps (, averaged over 3 runs) done with parallel tem pering. The solid line is the speci c heat calculated from the derivative of the energy from the 4 m illion tim e step parallel tem pering runs with 512 particles. A lso shown is the specic heat calculated from the energy uctuations for a system with 512 particles (, averaged over 6 runs) that was cooled conventionally with 10^7 time steps per tem perature. The J correspond to concatenating between 13 and 40 single tem perature runs; each run had 10⁸ tim e steps with 512 particles that were initiated from parallel tem pering con gurations and equilibrated for up to 5 10° time steps. Inset: A verage inherent structure energy per particle versus tem perature for 512 particles obtained from parallel tem pering, cooling, and single tem perature runs. The sym bols denote the sam e cases as in the main gure. The arrow points to the in ection point which coincides with Tp.

W e calculate the speci c heat C_V per particle at constant volume in two ways. The rst uses the uctuations in the potential energy U per particle: C_V = $(3k_B = 2) + N k_B^2 h U^2 i h U i^2$ where the rst term is the kinetic energy. The second way uses C $_{\rm V}~=~d<$ U > $(\langle U (T_{i+1}) \rangle \langle U (T_i) \rangle) = (T_{i+1} T_i)$. The re-=dTsults are shown in Figure 1. Notice that there is a sharp asym m etric peak centered at $T_p = 0.305 \quad 0.003$. The low tem perature side of the peak drops steeply. The curves for 216 and 512 particles coincide, indicating that there is no size dependence. The discrete points are calculated from the energy uctuations. The solid line is calculated from the derivative of the energy. The fact that the two coincide indicates that the system was equilibrated in all the basins of the energy landscape that were visited. For comparison we also show the result of cooling through the transition (). The peak in G_V found by cooling coincides with the peak found in parallel tem pering.

W e do not believe that the parallel tem pering peak in the speci c heat is due to the system becoming trapped in a metastable minimum in the energy landscape for the following reason. The con gurations corresponding to the bottom of the basins of the energy landscape are called inherent structures [11]. W e sam pled the con gurations that were visited during the parallel tem pering runs and found the corresponding inherent structure energy e_{LS} per particle by m in imizing the potential energy locally using the method of conjugate gradients [12]. In the inset of Figure 1 we plot the average inherent structure energies versus the tem perature of the con guration that was originally saved. As the tem perature decreases below 0.5, he_{IS} i decreases rather steeply [3]. The tem perature of the in ection point of this decrease coincides with the tem perature T_p of the peak in the speci c heat. We also show he_{IS} i for a system of 512 particles that 2

was cooled from T = 1.5. At low temperatures $h_{\rm IS}$ is rather independent of temperature for the cooled system, indicating that the system is trapped in an energy basin. Such a attening o at low temperatures is not observed when parallel tempering is used, indicating that the system is able to visit deeper energy basins as the temperature decreases.

However, this does not mean that the peak in the specie c heat is an equilibrium feature. We will now show that the peak is the result of not sampling enough of phase space below T_p . None of the runs we have done at $T < T_p$ have reached the time which is necessary in order to achieve an accurate therm odynam ic average. To show this, we took a con guration of 512 particles generated by parallel tempering at T = 0.289855, equilibrated for $5 \ 10^7$ time steps, and then ran for an additional 10^8 time steps during which we recorded the energy at every time step. Then we did block averaging in which we divided




FIG. 2: B lock averaged speci c heat versus time span t $_{\rm b}$ for 512 particles at T = 0.289855, 0.308642, and 0.3424658. Solid lines are the result of block averaging each run and then averaging over the num ber of runs show n. Open sym bols are the result of stringing runs together and then block averaging. Inset B lock averaged speci c heat versus time for 512 particles at T = 0.289855. The lower curve corresponds to t $_{\rm b} = 10^6$ m d steps, and the upper to t $_{\rm b} = 4$ 10⁶ m d steps. The time is the time (in m d steps) in the m iddle of each block. The data at T = 0.289855 is averaged over 23 runs. Param eters for both gures are the same as in Figure 1.

our 100 m illion time steps into equal segments, each of length t_b , and calculated the specic cheat from energy uctuations for each segment [13]. The block averaged specic cheat versus time for 2 di erent time spans t_b is shown in the inset of F igure 2. Notice that for any given time span, there is no sign of system atic aging. How ever, the specic cheat averaged over time increases with t_b .

The specic heat, averaged over time spans of a given size and over di erent runs, versus tim e span size t_b at several tem peratures is shown in Figure 2 by the solid lines. To obtain time spans that are longer than any given run, we concatenated the energies from the runs done at a given tem perature to m ake one huge run, and then did block averaging on the huge run. The results are shown as open symbols in Figure 2. There is good agreem ent between the solid lines and symbols. Notice that the specic heat initially increases with time span but then levels o when the time span is long enough to exceed the time needed to achieve the therm odynam ic value of the specic heat. This time increases with decreasing tem perature. Thus at $T = 0.289855 < T_p$, the speci c heat continues to increase with time span up to $t_{b} = 10^{8}$ time steps which is 100 times longer than the

relaxation time . Equilibrated values of C $_V$ near T $_p$ are plotted in Figure 1 and lie above the peak in C $_V$ found with parallel tempering. Thus the speci c heat

peak found with parallel tem pering is the result of not sam pling enough of phase space at $T < T_p$ to obtain the true therm odynam ic value of the speci c heat $C_V^{\rm true}$. The exploration of the energy distribution below T_p is slow even with parallel tem pering because the probability of sam pling large increases in U are exponentially sm all.

Note that C_V^{true} is proportional to the variance $\frac{2}{U}$ of the distribution P (U), i.e., $C_V^{\text{true}} = N \frac{2}{11} = (k_B T^2)$. If $\frac{2}{11}$ is nite and if n sam ple values of U are statistically independent and identically distributed, then basic statistics dictates that the m easured C_V , which is proportional to the sample variance S_n^2 of U , has an expectation value of $hC_V i = C_V^{true} (1 \quad 1=n)$ [13]. Since the potential energies in a time series can be correlated, the number n of statistically independent energies is given by $n = t_{b} = u$ where u is the energy correlation time. Fitting the data that is within 5 to 10% of C_v^{true} in Figure 2 to $hC_V i = C_V^{true} (1 1=n) yields U$ $3 10^6, 1$ 10⁵, and 5 10^3 time steps at T = 0.2898551, 0.308642, and 0.342466, respectively. These values are comparable to the relaxation times of 10^6 , $6 10^4$, and $2 10^4$ time steps, respectively (see below). They imply that the energies are correlated and that n is substantially sm aller than the total num ber of energies.




FIG. 3: Number of con gurations versus the average energy per particle acquired during one run of 10^8 m d steps of a system of 512 particles at T = 0.289855. The large curve centered at 1.62 is the histogram for the entire run. The sm all curve on the left centered at 1.60 represents the counts acquired between 4 $1\vec{0}$ and 5 $1\vec{0}$ time steps; the sm all curve on the right centered at 1.63 represents the counts acquired between 7 $1\vec{0}$ and 8 $1\vec{0}$ time steps. Inset: D ata from the same run. C incles represent the potential energy per particle averaged over 10^6 time steps versus time. The solid line is $e_{IS} + 3k_B T=2$ versus time.

Note that at shorter time spans and lower tem peratures Figure 2 shows that C_v ln(t_b). This occurs because the system does not uniform ly sample P (U) during these shorter time spans. As the system travels through the energy landscape, it samples the energies of each basin that it visits. As shown in Figure 3, we nd that the distribution of energies sampled from the basins visited during a shorter time span has a smaller variance than the total distribution P (U). Furtherm ore, the centers of the smaller distributions do not necessarily coincide with the center of the total distribution. Rather the smaller distributions are centered at the inherent structure energy plus the energy of vibrations around e_{LS} [14]. In support of this, we show in the inset of Figure 3 that the block averaged energy versus time approximately coincides with $(e_{IS} (t) + 3k_{B} T = 2)$ vs. time. As more basins are visited, the sample average hU i moves towards the average of the full distribution and the variance grows. This corresponds to C_V increasing with time span.

We now cite evidence that systems at temperatures just below $T_{\rm p}$ have equilibrated in the sense of showing no signs of aging. First the inset of Fig. 2 shows the lack of aging in the speci c heat versus time for a given value of $t_{\rm b}$. Second is the absence of aging in the relaxation time . We have calculated using the full intermediate scattering function $F_{\rm BB}$ (k;t) = $(1=N_{\rm B})h_{\rm g}$ (t) $_{\rm g}$ (0)i for the B particles where $N_{\rm B}$ is the number of B particles and $_{\rm g}$ (t) = $_{\rm i=1}^{\rm N_{\rm B}}$ (k;t). We choose k = $k_{\rm max}$, the wavevector of the maximum in the partial static structure factor $S_{\rm BB}$ (k) for the B particles, because $F_{\rm BB}$ (k;t) relaxes slow est at $k_{\rm max}$ [15]. The relaxation time is dened by F (k;)=F (k;t = 0) = 1=e. We have averaged

F (k;t)=F (k;t = 0) over 40 runs after waiting times t_W of 5 10^7 , 10^8 , and 1:5 10^8 time steps for a system with 512 particles at T = $0.289855 < T_p$ [9]. We nd that the relaxation time = $(1:0 \ 0:1) \ 10^6 \text{ md time}$ steps. This value of shows no signs of aging [4] in the sense that there is no system atic variation with waiting time. The lack of aging is to be expected since the aging time is equal to which is much less than t_W . We have con med that the aging time is the same as the equilibrium value of by starting from 11 di erent equilibrium con gurations at T = 1.5, quenching to T = 0.289855, and measuring after waiting times of $t_W = 0, 5 10^4$, 5 10^5 , 10^6 , 5 10^6 , and 2:5 10^7 m d steps. Fort_w < 10^6 m d steps, increases with t_w which indicates aging [4]. 10^6 m d steps, there is no aging and How ever, for t_W equals its equilibrium value of 106 md steps.

Third we have looked for signs of aging in the inherent structure energy versus time in our single temperature molecular dynamics runs of 10^8 time steps at $T = 0.289855 < T_p$. During the run, con gurations were recorded every so often. A veraging over 40 runs, we nd no evidence that the inherent structure energy decreases system atically with time, though the noise in the data prevents us from seeing changes smaller than 1%.

W e have also exam ined the root m ean square displacem ent h r² (t)i¹⁼² where h r² (t)i = (1=N) h $\sum_{i=1}^{N} (r_i (t) r_i (0))^2$ i. W e found that h r² (t)i¹⁼² > 10 A in each run exam ined after 10^8 time steps at T = 0.289855. This is comparable to the box size L = 9.48 $_{\rm A}$ for a system of 512 particles. So the system does not appear to be getting stuck in a metastable minimum of the energy landscape.

O ur work is a cautionary tale for those who perform num erical simulations on slow ly relaxing systems. It indicates that to obtain accurate therm odynam ic averages, one must not only check that the system shows no signs of aging, but one must also check that the quantity to be m easured has sampled enough of phase space to obtain a large num ber of statistically independent values. This sam pling time can be orders of m agnitude longer than previously recognized time scales such as the aging time and the relaxation time.
