# Integrability and exact solution of an electronic model with long range interactions

#### Abstract

We present an electronic model with long range interactions. Through the quantum inverse scattering method, integrability of the model is established using a one-parameter family of typical irreducible representations of $g l(2 \mathrm{j})$. The eigenvalues of the conserved operators are derived in terms of the Bethe ansatz, from which the energy eigenvalues of the Hamiltonian are obtained.


## 1 Introduction

The Quantum Inverse Scattering Method (QISM) [in tools in the exact study of quantum systems. It can be applied in a number of contexts, including both one-dimensional systems with nearest neighbour interactions such as the Heisenberg [ $[1] 1]$ and Hubbard [ $[2]$ ] models, and also for the analysis of models with long range interactions such as the Gaudin Hamiltonians [3/3] and extensions $\left[\mathcal{H}_{-1}\right]$. These latter constructions in particular have received renewed attention as it has been realised that the reduced BCS model, which was recently

[^0]proposed to describe superconducting correlations in metallic grains of nanoscale dimensions ['5ind can be shown to be integrable through the use of Gaudin Hamiltonians in non-uniform external fields [6] 6 ]. Formulating the reduced BCS model in the framework of the QISM reproduces the exact solution originally obtained by Richardson and Sherman [7]i], and opens the way for the calculation of form factors and correlation functions [880

Motivated by this result, one can investigate to what extent the construction can be generalised to yield new classes of models, with some examples already given in [鸟]. Here, we will consider a case where an underlying superalgebraic structure (i.e., one with both bosonic and fermionic degrees of freedom) is employed to yield an electronic model. The supersymmetric formulation of integrable systems can be traced back to the work of Kulish [110 symmetric Gaudin Hamiltonians have been analysed in detail in [ili

In this article we present a Hamiltonian derived through the QISM from a solution of the Yang-Baxter equation (YBE) associated with a typical irreducible representation of the Lie superalgebra $g l(2 \mathfrak{j})$, which has the explicit form

Above, the energy levels ${ }_{j}$ are two-fold degenerate, $g$ is an arbitrary coupling parameter and $D$ is the total number of distinct energy levels. Also, $n_{j}$ is the fermion number operator for energy level ${ }_{j}$ and for the parameters $j ; j=1:: D$ we define

with $X_{j}=\frac{q}{{ }_{j}=\left({ }_{j}+1\right)}$ : The $c ; c^{y}$; , are two-fold degenerate Fermi annihilation and creation operators.

The Hamiltonian has a similar form to the reduced BCS model ['5i]. There, Cooper pairs are scattered into vacant energy levels while the one particle states are blocked from scattering. In the Hamiltonian above, there is correlated scattering depending on the occupation numbers. One of the features of this model is that the scattering couplings can be varied through the choice of the parameters i. Via the algebraic Bethe ansatz method and using the minimal typical representation of gl(2 j1), from which these free parameters arise, we establish the exact solvability of the model. Here we outline the necessary definitions and constructions, while full details will be presented elsewhere.

The Lie superalgebra $g l(2 \mathfrak{j})$ has generators $E \stackrel{i}{j}, i ; j=1 ; 2 ; 3$ with supercommutator relations

Above, the BBF grading [1] = 2$]=0 ;[3]=1$ is chosen and the elements are realised in terms of the Fermi operators through (cf. [12 12

The Casimir invariant of the algebra, $C={ }^{P} \underset{i ; j=1}{3} E_{j}^{i} \quad E_{i}^{j}(1)^{[j]}$, which commutes with all the elements of $g l(2 \mathfrak{l})$, will also be needed, and has the eigenvalue $c=2(+1)$ in the above representation. Below we let $V()$ denote the four-dimensional model on which the representation acts, with the basis j+ i; j+i;ji; j0i

## 2 The Yang-Baxter equation and integrability

To construct the model, we use the supersymmetric formulation of the QISM [īO We take the following solution of the YBE which acts on $W \quad W \quad V()$, where $W$ denotes the three-dimensional vector module of $g l(2 \mathfrak{l})$,

The representations taken for the operators $E_{m}^{n}$ are as stated above, the variable $u$ represents the rapidity is arbitrary and $I$ is the identity operator.

By the usual procedure of the QISM, we define a transfer matrix acting on the

The term involving ${ }_{j k}$ may be simplified using the Casimir invariant and the commutation relations of the algebra $\mathrm{gl}(2$ 기 $)$

For $\mathrm{g}=1=$ we obtain the Hamiltonian ( 1 d ), which establishes integrability since $\left.\mathbb{H} ;{ }_{j}\right]=0 ; 8 j$.
