R enorm alization of the electron {phonon interaction: a reform ulation of the BCS {gap equation

A recently developed renorm alization approach is used to study the electron-phonon coupling in many-electron systems. By starting from an Ham iltonian which includes a small gauge symmetry breaking eld, we directly derive a BCS-like equation for the energy gap from the renorm alization approach. The electron-electron interaction for C ooper pairs does not contain any singularities. Furtherm ore, it is found that phonon-induced particle-hole excitations only contribute to the attractive electron-electron interaction if their energy di erence is smaller than the phonon energy.

I. IN TRODUCTION

The fam ous BCS-theory [1] of superconductivity is essentially based on the analysis of attractive interactions between electrons of many-particle systems [2]. As was pointed out by Frohlich [3] such an interaction can result from an electron coupling between electrons mediated via phonons. The recent discovery of superconductivity in magnesium diboride M gB₂ [4] below a rather high T_c of about 39 K has attracted again a lot of interest on this classical scenario of a phonon-mediated superconductivity. However, the electron-electron interaction derived by Frohlich [3] contains some problem s. There are certain regions in momentum space where the attractive interaction becomes singular and changes its sign due to a vanishing energy denominator.

Recently, e ective phonon-induced electron-electron interactions were also derived [5,6] by use of W egner's ow equation method [7] and by a similarity renormalization proposed by G latzek and W ilson [8,9]. The main idea of these approaches is to perform a continuous unitary transformation which leads to an expression for an electronelectron-electron interaction which is less singular than Frohlich's result [3].

Recently, we have developed a renorm alization approach which is based on perturbation theory [10]. This approach resembles Wegner's ow equation method [7] and the similarity renorm alization [8,9] in some aspects. Therefore, the investigation of an electric phonon-induced electron-electron interaction is very useful to compare the three methods in more details. Therefore, in this paper we directly diagonalize the classical problem of interacting electrons and phonons by use of the new renorm alization technique [10]. the Ham iltonian is given by

which will be used to describe superconducting properties. In (1) c_{k}^{y} , and c_{k} ; are the usual creation and annihilation operators for electrons with wave vector k and spin b_{q}^{y} and b_{q} denote phonon operators with phonon energies $!_{q}$. The electron excitation energies $"_{k}$ are measured from the chemical potential .

The paper is organized as follows. In the next section we brie y repeat our recently developed renorm alization approach [10]. In Sec. III this approach will be applied to the electron-phonon system (1) in order to derive a BCS-like gap equation. Furthermore, electron-electron interaction derived in this fram ework will be compared with the results from form er approaches [3,5,6]. Finally, our conclusions are presented in Sec. IV.

II. PROJECTOR -BASED RENORMALIZATION METHOD (PRM)

The PRM [10] starts from the decomposition of a given many-particle H am iltonian H into an unperturbed part H $_0$ and into a perturbation H $_1$

We assume that the eigenvalue problem H_0 is $E_n^{(0)}$ is of the unperturbed part H_0 is known. The parameter " accounts for the order of perturbation processes discussed below. Let us de ne projection operators P and Q by

P and Q are super-operators acting on usual operators A of the unitary space. Here, P projects on that part of A which is form ed by all transition operators juilm jwith energy di erences $f_n^{(0)} = E_m^{(0)}$ jless or equal to a given cuto . The cuto is smaller than the cuto of the original Hamiltonian H.Q is orthogonal to P and projects on high energy transitions larger than .

The aim is to transform the initial H am iltonian H into an elective H am iltonian H which has no matrix elements between eigenstates of H $_0$ with energy dilerences larger than . H will be constructed by use of an unitary transform ation

Due to construction the elective H am iltonian H will therefore have the same eigenspectrum as the original H am iltonian H. The generator X of the transformation is anti-H erm itian, $X^{Y} = X$. To nd an appropriate generator X we use the condition that H has no matrix elements with transition energies larger than , i.e.,

has to be fullled. By assuming that X can be written as a power series in the perturbation parameter "

Now, the high-energy parts parts Q X $^{(n)}$ of X $^{(n)}$ can successively be determ ined from Eq. (6) whereas the low energy parts P X $^{(n)}$ can still be chosen arbitrarily. In the following we use for convenience P X $^{(1)} = P X ^{(2)} = 0$ so that for the elective H am iltonian H up to second order in H₁ follows

Here " was set equal to 1. The quantity L_0 in (9) denotes the Liouville operator of the unperturbed H am iltonian. It is de ned by $L_0 = [H_0; A]$ for any operator A. Note that the perturbation expansion (9) can easily be extended to higher orders in ". One should also note that the correct size dependence of the H am iltonian is automatically guaranteed due to the commutators appearing in (9).

Next, let us use this perturbation theory to establish a renorm alization approach by successively reducing the cuto energy . In particular, instead of eliminating high-energy excitations in one step a sequence of stepwise transformations is used. Thereby, we obtain an elective model which becomes diagonal in the limit ! 0. In an in nitesimal formulation, the method yields renormalization equations as function of the cuto . To not these equations we start from the renormalized H am iltonian

after all excitations with energy di erences larger than have been eliminated. Now we perform an additional renormalization of H by eliminating all excitations inside an energy shell between and a smaller energy cuto () where > 0. The new Ham iltonian is found by use of (9)

Here, L_0 ; denotes the Liouville operator with respect to the unperturbed part H₀; of the dependent H am iltonian H . Note that the ow equations derived from Eq. (11) will lead to an approximative renormalization of H because only contributions up to second order in H₁; are included in Eq. (11). For a concrete evaluation of Eq. (11) it is useful to divide the second order term on the rhs into two parts: The rst one connects eigenstates of H₀; with the same energy. This part commutes with H₀; and can therefore be considered as renormalization of the unperturbed H am iltonian

In contrast the second part connects eigenstates of H $_0$; with di erent energies and represents a renorm alization of the interaction part of the H am iltonian

Note that for small only the mixed term, i.e., the rst part on the rh.s. of Eq. (13), contributes to the renorm alization of H₁;

In the limit ! 0, i.e. for vanishing shell width, equations (12) and (14) lead to di erential equations for the H am iltonian as function of the cuto energy . The resulting equations for the parameters of the H am iltonian are called ow equations. Their solution depend on the initial values of the parameters of the H am iltonian. Note that for ! 0 the resulting H am iltonian only consists of the unperturbed part H $_{(! 0)}$ so that an electively diagonal H am iltonian is obtained.

III. APPLICATION TO THE ELECTRON PHONON SYSTEM

In this section we apply the renorm alization approach discussed above to the system (1) of interacting electrons and phonons. The aim is to decouple the electron and the phonon subsystem s. The H am iltonian (1) is gauge invariant. In contrast, a BCS-like H am iltonian breaks this sym m etry. Thus, in order to describe the superconducting state of the system, the renorm alized H am iltonian should contain a sym m etry breaking eld. Therefore, our starting H am iltonian H reads

The 'elds' k; and k; in H₀; couple to the operators $c_{k,"}^{y} c_{k,\#}^{y}$ and $c_{k,\#} q_{k,"}$ and break the gauge invariance. They will take over the role of the superconducting gap function but still depend on . The initial values for k; and the energy shift C are those of the originalm odel

Note that renorm alization contributions to the electron energies " $_k$, the phonon energies ! $_q$, and the electron-phonon interactions g_q have been neglected in (15). A lso, additional interactions which would appear due to renorm alization processes have been om itted. Let us rst solve the eigenvalue problem of H $_0$; . For this purpose, we perform a B ogoliubov transform ation [11] and introduce new dependent ferm ionic quasi-particles

Next let us elim inate all excitations within the energy shell between and () by applying the renorm alization scheme of section II.We are primarily interested in the renorm alization of the gap function $_{k}$; . Note that for this case we have to consider the renorm alization contribution given by (14)

The reason is that the renorm alization (12) of H₀; only gives contributions which connects eigenstates of H₀; with the same energy. Thus, this part only changes the quasiparticle energies from E_k ; to $E_{k;()}$. In contrast, the renorm alization (22) changes the relative weight of the operator terms in (16) and is exactly the renorm alization needed to describe the ow of k; which will be discussed in the following.

There is no principle problem to evaluate the renorm alization contributions (14). First, one expresses the creation and annihilation operators by the quasiparticle operators (19) and uses the relation L_0 ; ${}^y_{k;} = E_k$; ${}^y_{k;}$ and an equivalent relation for ${}^y_{k;}$ to evaluate the denom inator in Eq. (14). Then the quasi-particle operators (18) have to be transformed back to the original electron operators. The main reason for this procedure is the fact that the Bogoliubov transform ation (19),(20) depends on the cuto \cdot . Thereby, a lot of term s arise which contribute to the renormalization (14). For convenience, we evaluate the denom inator in Eq. (14) by use of the assumption w_k j k; \hat{j} . As it turns out, the resulting ow equations still contain sum s over k. Note that the approximation used is valid for most of the k dependent term s (except for those k values close to the Ferm in omentum). Thus, it does not strongly a ected the renormalization contributions. The two operator expressions contributing to the commutator in (14) are given in this approximation by

describes the restriction to excitations on the energy shell . We are not interested in the renorm alization of the phonon modes. Therefore all contributions including phonon operators are neglected. By using (23) and (24) we then nd from (14)

In the following we restrict ourselves to renorm alization contributions which lead to the form ation of C ooper pairs. Consequently, the conditions $k^0 = (k + q)$ and $^0 = have to be fulled so that$

results from (26). Here, 2 " $_{k}$ " $_{(k+q)}$ is due to the projector operator P () in (26). Note that the di erential expression on the lh.s. of (27) is di erent from the di erential dH $_{1i}$ =d. This follows from the de nition of H₁(;) = H_{1;(}) P₍₎H₁; which di ers from H₁(;) = H_{1;(}) H₁; due to the second term. Next we can simplify the -functions in Eq. (27) by discussing " $_{k}$ " $_{(k+q)}$ and " $_{(k+q)}$ > " $_{k}$ separately. There are no contributions from the latter case. For " $_{k}$ " $_{(k+q)}$ the contribution from the result can be rewritten as

Here, we have assumed $g_q = g_q$. Eq. (28) describes the renorm alization of the dependent H am iltonian H with respect to the cuto . Next we use (28) to derive ow equations for the parameters $_k$; and C . For this purpose, a factorization with respect to the full H am iltonian H is carried out. The nal ow equations read

Note that in contrast to (28), Eqs. (29) and (30) are di erential equations with normal derivatives of $_{k}$; and C. This fact can be explained as follows: As discussed above, the di erence between the expressions $H_1(;) = H_{1;()} P_{()} H_{1}$; and $H_1(;) = H_{1;()} H_1$; is given by the quantity $Q_{()} H_1$; which consists of all matrix elements of H_1 ; between eigenstates of H_0 ; with energy di erences between () and . We are interested in the new H am iltonian $H_{()} = P_{()} H_{()} H_{()}$, which only contains transition operators between states with energy di erences an aller than (). Therefore, all renormalization contributions which lead to matrix elements with energy di erences larger than () are not relevant. Thus, we obtain di erential equations for the parameters of $H_{()}$.

Note that the factor 2 in front of (29) is due to the sum over in (28). The expectation values h:::i in (29) and (30) are form ed with the full H am iltonian H and are independent of . The ow equations can be easily integrated between the lower cuto (! 0) and the cuto of the original model. The result is

where a short hand notation for the desired values of $_k$; and C_k ; at = 0 was introduced: $\tilde{}_k = _{k;(! 0)}$; $C = C_{(! 0)}$. Note that $\tilde{}_k$ and C only depend on the parameters of the original system (1) and on $_k$; and C. The initial conditions (18) for $_k$; and C will be used later. For ! 0 the renorm alized H am iltonian $H = H_{(! 0)}$ reads

H can easily be diagonalized by a Bogoliubov transform ation according to (19) and (20)

F inally, we have to determ ine the expectation values in (31) and (32). Since H[°] emerged from the originalm odel H by an unitary transform ation, the free energy can be calculated either from H or from H[°]

Here, $f(\mathbf{E}_k)$ denotes the Ferm i function with respect to the energy \mathbf{E}_k . If we neglect higher order corrections, Eqs. (31) and (32) can be rewritten as

where the initial conditions (18) were used. Note that Eq. (37) has the form of the usual BCS-gap equation. Thus, the term inside the brackets f:::g can be interpreted as the absolute value of the electron-induced electron-electron interaction

for the form ation of C ooper pairs. In contrast to the usual BCS-theory, in the present form alism both the attractive electron-electron interaction (39) and the gap equation (37) were derived in one step by applying the renorm alization procedure to the electron-phonon system (1).

Let us now compare the induced electron-elctron interaction (39) with Frohlich's result [3]

Note that (40) contains a divergency at \mathbf{j}_{k}^{r} $\mathbf{j}_{k+q}^{r} = \mathbf{j}_{q}^{r}$. Furtherm one, this interaction becomes repulsive for \mathbf{j}_{k}^{r} $\mathbf{j}_{k+q}^{r} > \mathbf{j}_{q}^{r}$. Thus, a cuto function \mathbf{j}_{q}^{r} \mathbf{j}_{k+q}^{r} for the electron-electron interaction (40) is introduced by hand in the usual BCS-theory to suppress repulsive contributions to this interaction. In contrast our result (39) has no divergency and is always attractive. Furtherm one, the cuto function in Eq. (39) shows that the attractive interaction results from particle-hole excitations with energies \mathbf{j}_{k}^{r} \mathbf{j}_{k+q}^{r} . This result directly follows from the renorm alization process.

Recently, Mielke [6] obtained a -dependent phonon-induced electron-electron interaction

where in (41) for convenience the -dependence of the electron and the phonon energies is suppressed. A part from the -dependent -function, the main di erence to our result (39) is that the cuto function $!_q$ "_k "_(k+q) is not present in (41). This di erence may result from M ielke's way of performing the similarity transformation [8,9] of the electron-phonon system (1). The similarity transformation is based on the introduction of continuous unitary transformations and is formulated in terms of di erential equations for the parameters of the H am iltonian. Like in our approach (see Sec. II) also the similarity transformation leads to a band-diagonal structure of the normalized H am iltonian with respect to the eigen representation of the unperturbed H am iltonian. Due to the renormalization processes also new couplings occur. M ielke has rst evaluated the phonon-induced electron-electron interaction (41) by eliminating excitations with energies larger than . In particular, for an Einstein m odel with dispersion-less phonons of frequency !₀ the interaction becomes independent of if is chosen less than !₀. O f course, for this case and assuming J'_{k+q} "kj<!_q M ielke's result (41) and the result (39) become the same. K exping this interaction and neglecting at the same time the remaining part of the electron-phonon interaction with energies smaller than

a BCS-like gap equation was derived by M ielke [6]. The main di erence to our result (39) is the absence of the cuto -function $!_q$ "_k "_(k+q), which demonstrates that only particle-hole excitations with energies less than $!_q$ participate in the attractive interactions. However, note that by setting = 0 a nite value of the interaction remains in (41). This interaction is non-diagonal in the unperturbed H am iltonian as used by M ielke, H^{M ielke} = P k; "k, c_k^Y ; c_k ; $+ q!_q b_q^y b_q$. This seem s to be a contradiction to the allowed properties for operators at = 0 which should commute with the unperturbed H am iltonian.

Finally, by use of W egner's ow equation m ethod [7], Lenz and W egner obtained the following phonon-induced electron-electron interaction

$$V_{k;q}^{\text{Lenz/W egner}} = \frac{2 j g_q j^2 !_q}{{}^{\prime\prime}_{k} {}^{\prime\prime}_{(k+q)} {}^2 + !_q^2}$$

which is attractive for all k and q [5]. The result (42) is similar to (40) if $!_q$ "_k "_(k+q) is fullled. In contrast to our result (39), the interaction (42) remains nite even for "_k "_(k+q) > $!_q$. We gener's ow equation method [7] as well as the similarity transform ation [8,9] are based on the introduction of continuous unitary transform ations. Both methods are form ulated in terms of di erential equations for the parameters of the H am iltonian. How ever, they di er in the generator of the continuous unitary transform ation. This leads to the di erent results (41) and (42). A detailed comparison of the ow equation method and the similarity transform ation can be found in Ref. [6].

IV . C O N C LU S IO N

In this paper we have applied a recently developed renorm alization approach [10] to the 'classical' problem of interacting electrons and phonons. By adding a small eld to the H am iltonian, which break the gauge symmetry, we directly derive a BCS-like gap equation for the coupled electron-phonon system. In particular, it is shown that the derived gap function results directly from the renorm alization process. The electron phonon-induced electron-electron interaction is deduced from the gap equation. In contrast to the Frohlich interaction [3] no singularities appear in the electric interaction. Furtherm ore, the cuto function which is included in Frohlich's result by hand to avoid

repulsive contributions to the electron-electron interaction follows directly from the renormalization procedure. This means that phonon-induced particle-hole excitations only contribute to the attractive electron-electron interaction if their energies are smaller than the energy of the exchanged phonon.
