Energy Spectrum for N eutral Collective Excitations in Striped H all States

A bstract. Neutral collective excitations in the striped H all state are studied by using the single m ode approxim ation and H artree-Fock approxim ation at the half-led third and fourth Landau level. We nd that the spectrum includes an isotropic NG m odes and periodic line nodes.

1. Introduction

In recent experiments, highly anisotropic states, which have anisotropic longitudinal resistances, were observed around the half-led third and higher Landau levels [1, 2]. It is believed that the anisotropic state is the striped H all state which is a unidirectional charge density wave in the mean eld theory [3, 4]. The anisotropy of the resistance is naturally explained by the anisotropic Ferm i surface in the magnetic Brillouin zone [5, 6, 7].

In the absence of disorder and edges, the quantum Hall system has the magnetic translation and rotation symmetry. In the striped state, a magnetic translation in one direction is spontaneously broken to the discrete translation and the rotation is also spontaneously broken to the -rotation. Using the conserved current, the property of the neutral collective excitations is studied. The spectrum of the neutral collective excitations is studied. The spectrum of the neutral collective excitation is useful for the fractional quantum Hall state (FQHS). We show that the spectrum fot the striped Hall state has a multiple line node structure and cusps. Furtherm ore, the spectrum has anisotropic feature, that is, in one direction the spectrum resembles the liquid Helium spectrum with the phonon and roton minimum, and in another direction it resembles the FQHS spectrum.

2. Sym m etries

Let us consider the two-dimensional electron system in a uniform magnetic eld $B = Q_x A_y$ $Q_y A_x$. We ignore the spin degree of freedom and use the natural unit (h = c = 1) in this paper. We introduce two sets of coordinates, relative coordinates and guiding center coordinates. The relative coordinates are dened by

These coordinates satisfy the following commutation relations,

The operators X and Y are the generators of the magnetic translations of the oneparticle state in y direction and x direction respectively. The angular momentum J is written as

J is the generator of the rotation of the one-particle state.

The total H am iltonian H for the interacting charged particles is the sum of the free H am iltonian H $_0$ and the C oulom b interaction H am iltonian H $_{\rm int}$ as follows,

where is the electron eld operator, $!_c = eB = m$ and $V(r) = q^2 = r(q^2 = e^2 = 4)$, is the dielectric constant) for the Coulom b potential.

C onserved charges are obtained as the spatial integral of the zeroth component of the N oether currents for the sym m etries. We de ne the conserved charges, Q, Q_X , Q_Y , and Q_J for U (1), m agnetic translations, and rotation sym m etry respectively, as follows,

where v = (1;v), $v = !_c (;)$, Remeans realpart, and L is the Lagrangian density for the total H am iltonian H. These charges commute with the total H am iltonian H and obey the following commutation relations,

The U (1) charge Q commutes with all conserved charges. We assume that Q is not broken and the ground state is the eigenstate of Q as Q $\mathcal{D}i = N_e \mathcal{D}i$ where N_e is a number of electrons.

The commutation relations between the conserved charges and the current density operators read,

The U (1) charge Q com m utes with all N oether currents. If the expectation value of the right hand side of these equation is not zero, corresponding sym m etry is spontaneously broken.

W e use the von N eum ann lattice (vN L) base for the one-particle states [9]. A discrete set of coherent states of guiding center coordinates,

is a complete set of the (X;Y) space. These coherent states are localized at the position $a (m r_s; n=r_s)_{q} w$ here a positive real number r_s is the asymmetric parameter of the unit celland a = 2 =eB. By Fourier transforming these states, we obtain the orthonormal basis in the momentum representation

where $\#_1$ is a Jacobi's theta function and $= ir_s^2$. The two-dimensional lattice momentum p is de ned in the Brillouin zone (BZ) $\dot{p}_i j < \ldots$ Next we introduce a complete set in (;) space, that is the eigenstate of the one-particle free Ham iltonian,

The Hilbert space is spanned by the direct product of these eigenstates

where l is the Landau level index and l = 0, 1, 2, . We set a = 1 (eB = 2) in the following calculation for simplicity.

Electron eld operator is expanded by the vNL base as

As seen in Eq. (16), the magnetic translation in the real space is equivalent to the magnetic translation in the momentum space. The free kinetic energy is quenched in a magnetic eld and the one-particle spectrum becomes at. Therefore the free system in a magnetic eld is translationally invariant in the momentum space. We show that there exists the Ferm i surface in the mean eld solution for the striped Hall state. The existence of the Ferm i surface indicates the violation of the translational symmetry in the momentum space or in the real space.

3. M ean eld solution

The mean eld state is constructed as

where FS.means Ferm is a, N₁ is a normalization constant, and juaci is the vacuum state in which the l 1 th and lower Landau levels are fully occupied. The mean eld of the two-point function for the electron eld is given by

where is a chemical potential and one-particle energy $_{\rm HF}$ (p) is determined selfconsistently in the Hartree-Fock approximation [5, 6]. We assume that the magnetic eld B is so strong that Landau levelmixing e ects can be neglected. Then we use the

Ham iltonian projected to the 1 th Landau level

where P_1 is the projection operator to the 1 th Landau level and N_e is a number of electrons occupying the 1 th Landau level. The free kinetic term is quenched and the total H am iltonian is reduced to the C oulom b interaction term projected to the 1 th Landau level, H⁽¹⁾.




Figure 1. (a) Ferm i sea for the striped Hall state at the half-lling. (b) Charge density and electric current for the striped Hall state at the half-lling.

It was shown that the mean eld state with Ferm i sea $p_y j < satisfies the self-consistency equation at the lling factor = 1+ (0 < < 1) in the Hartree-Fock approximation [5, 6] and corresponds to the striped Hall state whose density is uniform in y direction and periodic with a period <math>r_s$ in x direction [6]. The one-particle energy $_{\rm HF}$ (p) depends only on p_y in this self-consistent solution. The Ferm i sea and corresponding charge density distribution in x-y space are sketched in Fig.1. The period of stripe is r_s . The electric current ows along each stripes. Note that the true charge density and current density distribution in the mean eld theory are not sharp as shown in the gure but fuzzy [6].

Hartree-Fock energy per area for the striped Hall state is calculated as

where L^2 is an area of the system . $E_{\rm HF}$ depends on the period of the stripe $r_{\rm s}$ and the optim al value of $r_{\rm s}$ is determined by minimizing $E_{\rm HF}$. For = 2 + 1 = 2 and 3 + 1 = 2, optim al values are $r_{\rm s} = 2.47$ and 2.88, respectively.

The striped Hall state obtained above breaks the magnetic translation symmetry in x direction which corresponds to $Q_{\rm Y}$. Using the commutation relation (9), we can prove the Goldstone theorem for the striped Hall state[8]. The theorem states that the NG mode appears at low energies and couples with the charge density operator. In the next section, we investigate the spectrum of the NG mode using the single mode approximation.

4. Single mode approximation

We calculate the spectrum for a neutral collective excitation at the half-led third and fourth Landau level using the single mode approximation. The single mode approximation is successful in the FQHS because the back ow problem is absent for Energy Spectrum for Neutral Collective Excitations in Striped Hall States

the electron states projected to the Landau level[10]. Projected density operator (k) is written as e $^{k^{2}=8}$ L_1(k^{2}=4) (k), where

where $v_1(k) = e^{k^2=4} (L_1(k^2=4))^2 q^2 = k$ for the Coulomb potential. It is well-known that the density operators projected to the Landau level are non-commutative, that is,

where E_0 is a ground state energy, N_e is a electron number in the 1th Landau level, and s(k) is the so-called static structure factor. To derive these expressions, we use the relation f(k) = f(k) and s(k) = s(k) due to rotation symmetry. Using the commutation relation (23), f(k) is written as

The rst term in s(k) behaves as $k_y \neq r_s$ at small k_y and periodic in k_y direction with a period 2 r_s . The analytic form for f(k) are given by using Fourier series expansion as




Figure 2. Energy spectrum at $0 < r_s k_y < 4$ for $k_x = 0$ and 1 (linear dispersion at $k_y = 0$), = 2 + 1 = 2 in the single mode approximation. The unit of k is a ¹ and the unit of spectrum is $q^2 = a$. The same unit is used in Fig. 3.




Figure 3. Energy spectrum $at 0 < r_s k_y < 4$ for $k_x = 0$ and 1 (linear dispersion $at k_y = 0$), = 3 + 1=2 in the single mode approximation.

The numerical results for the energy spectrum for = 1+1=2, 1=2 and 3 are shown in Figs. 2 and 3, respectively.

As seen in these gures, the spectrum in k_y direction resembles the liquid Helium spectrum with the phonon and roton minimum. The spectrum has a multiple line node

at $k_y = 2 r_s n$ (n is integer). The comparison to particle-hole excitation energy [8] shows that the single mode approximation is good around $k_y = 2 r_s n$. In a usual Fermi system, the single mode approximation seems not to work well because of the particle-hole excitation near the Fermi surface at low energies. In the present case, however, the low energy excitation near the Fermi surface is suppressed by the divergence of Fermi velocity at Fermi surface[8]. Cusps also appear at $k_y = r_s (2n + 1)$.

5. sum m ary

We have studied neutral collective excitations in the striped Hall state. We have obtained the neutral excitation spectrum in the striped Hall state using the single mode approximation. The spectrum has a new rich structure. The neutral collective mode includes the NG mode due to spontaneous breaking of magnetic translation symmetry. The spectrum is highly anisotropic, that is, the dispersion in $k_{\rm x}$ direction is sim ilar to that of FQHS and the dispersion in $k_{\rm y}$ is sim ilar to that of Liquid Helium . We hope these excitations will be observed in experiments for the evidence of the striped Hall state.
