D ynam ics of Freely Cooling G ranular G ases

We study dynamics of freely cooling granular gases in two-dimensions using large-scale molecular dynamics simulations. We not that for dilute systems the typical kinetic energy decays algebraically with time, E (t) t¹, in the long time limit. A symptotically, velocity statistics are characterized by a universal G aussian distribution, in contrast with the exponential high-energy tails characterizing the early hom ogeneous regime. We show that in the late clustering regime particles move coherently as typical local velocity uctuations, v, are small compared with the typical velocity, v=v t¹⁻⁴. Furtherm ore, locally averaged shearm odes dom inate over acoustic modes. The small therm alvelocity uctuations suggest that the system can be heuristically described by B urgers-like equations.

Freely evolving granularm edia, i.e., ensem bles of hard sphere particles undergoing dissipative inelastic collisions, exhibit interesting collective phenom ena including clustering, vortices, shocks, and multiple dynam ical regimes. This dissipative nonequilibrium gas system can be described by kinetic theory in the early hom ogeneous phase where density uctuations and velocity correlations are relatively sm all. How ever, quantitative characteristics of the late clustering regime such as the typical length and velocity scales, particle velocity distributions, as well the corresponding continuum theory remain open questions [1{19].

Recent molecular dynamics simulations in onedimension have shown that the asymptotic energy decay is universal and that clustering corresponds to the formation of shocks in the inviscid Burgers equation [12]. In this paper we study long time asymptotic dynamics of freely evolving granular gases in two dimensions using M olecular D ynamics (M D) simulations. Treating the particles as identical, totally undeformable hard disks, we developed an elecient event-driven algorithm [20{22] that allow sus to probe the system well into the clustering regime. O urmain result is that the asymptotic dynamics of dilute granular gases is universal as it is independent of the degree of dissipation.

In the simulations, $N = 10^6$ identical disks of radius R = 0.15 and mass m = 1 are placed in a twodimensional system of linear dimension $L = 10^3$ with periodic boundary conditions. The particle concentration, c = 1, so the mass density (or volume fraction) is $= c R^2 = 0.0707$. Initially, particles are distributed random ly in space and their velocities are drawn from a G aussian distribution with zero m ean and unit variance. To ensure random initial conditions, the system is rst evolved under elastic collisions on ly, with each particle undergoing 10^2 collisions on average. Then, time is reset to zero and each particle experiences up to an average of $4 10^6$ inelastic collisions. In such a collision the particle velocity, v, changes according to

with $g = v = v^{0}$ the relative velocity of the colliding particles and n a unit vector connecting the centers of the two particles. In each collision, the normal component of the relative velocity is reduced by the restitution coe cient, 0 r 1, and the energy dissipation equals $\frac{1}{2}(1 - r^{2})(g - r^{2})$. In the following, time is quoted in units of $t_{0} = \frac{3}{20cR} - r^{2}$ which is proportional to the initial m ean free time, where E_{0} is the average particle energy initially.

Inelastic collapse, the form ation of a cluster via an innite series of collisions occurring in a nite time, poses a di culty for num erical simulations [4]. To properly resolve such nite time singularities, we take collisions to be perfectly elastic (r = 1) when the relative velocity falls below a pre-speci ed threshold g n < . This scheme, which m in ics actual granular particles where r ! 1 for su ciently sm all relative velocities, can be applied as long as the cuto velocity is much smaller than the root m ean square (rm s) velocity, $v_{rm s} = hv^2 i^{1-2}$ [12,23]. In our simulations, $v_{rm s} > 10^3$, and $= 10^5$.

Given the initial conditions, the collision sequence is determ inistic, and the system evolves freely (velocities are not controlled). In the absence of energy input, the system \ccols" in nitely. The average particle energy, E (t) = $\frac{1}{2}hv^2i$, as a function of time is shown in Fig.1. First, we con rm ed that for su ciently smalltimes, when the spatial distribution of particles remains roughly uniform, the energy decay follows Ha 's cooling law [1]

Here, $(t_0=t)^1 = 3^{p-1}(1 r^2)g(2R)=20$, where g(r) is the pair correlation function [10,11].

However, this cooling law eventually breaks down due to the form ation of dense clusters $[3,7,9,11\{13,15\}]$. The deviation from this law occurs at a time scale that ultim ately diverges when collisions become elastic. Interestingly, our simulations show that a universal decay law

holds beyond this time scale. This implies that the typical velocity decays with time according to $t^{1=2}$. The typical length scale explored by a parv ^τ dt⁰v (t⁰) t^{2} , remains small compared ticle, L (t) with the system size, L L, and thus, nite size e ects were negligible throughout the simulations. The inset to Fig. 1 shows that the energy decay law is independent of the cuto velocity as long as 10⁴ (we also veri ed that num erical errors were irrelevant).

O verall, this behavior is consistent with the rindependent energy decay law, E $t^{2=3}$, found in onedimension [12], although the exponent di ers from the 1D value of 2/3. This asymptotic law (3) has not been observed in previous numerical studies primarily due to insu cient temporal range [3,7,9,11,13,15]. For exam – ple, power-law behavior was previously suggested by deform able sphere m olecular dynam ics simulations in twoand three-dimensions [13]. How ever, the value of the scaling exponent depended on parameters such as the system size and the restitution coe cient.

The simulations show that as the volume fraction was reduced, the dependence of the prefactor A (r) on the restitution coe cient r became weaker and weaker, suggesting completely universal behavior in the dilute limit,

! 0. Further numerical studies with smaller volume fractions are needed to fully resolve this issue. If indeed the prefactor A is independent of the restitution coe – cient r, this implies a certain behavior of t_c , the time scale marking the transition from the hom ogeneous to the clustering regime. Matching the two asymptotic behaviors E (t) $[(1 \ r)t]^2$ for t t_c with E (t) t^1

for t t_c shows that this crossover time scale diverges according to t_c $(1 r)^2$ in the quasi-elastic limit, r! 1.

Next, we exam ined whether the entire velocity distribution, not merely the typical velocity scale is independent of the restitution coe cient. We studied P (v;t), the probability distribution function of the velocity magnitude v jv j at time t. Figure 2 clearly shows that a universal scaling function underlies the velocity distribution when t $t_c(r)$

This provides evidence that the asymptotic dynamics are universal.

The simulations suggest that the corresponding scaling function is Gaussian, $(z) = {}^{1} \exp(z^{2}), (see$ Fig. 2). We therefore studied the kurtosis, particularly, = hv⁴ i=hv² i² the quantity 2. Initially, = 0, the expected value for a Gaussian distribution in twodimensions. In the intermediate regime, is distinctly nonzero and strongly depends on the value of the restitution coe cient. However, in the asymptotic regime does not depend on restitution coe cient t_c), (t and is very close to zero (j j < 0:1), a manifestation of the universal velocity statistics. G iven this universality, we present data for a representative value of r = 0:1 in the rest of this paper.

For completeness, we mention that in the intermediate hom ogeneous regime, the distribution has an exponential high-energy tail, in agreem ent with kinetic theory studies $[3,8,16\{19\}]$. The measured slope of 3:3 is consistent with Direct Simulation M onte Carlo (DSMC) [17] and MD simulations [19] (see the inset in Fig.2).

Both the Gaussian and the exponential extrem al velocity statistics are consistent with the following heuristic argument. The large-velocity tails are dominated 1) initially present in the by the fastest particles (v system, still moving with their initial velocity at time t. These particles managed to avoid any collisions with other particles. The \survival" probability, S (v;t), for such particles decays exponentially with the volum e they sweep till time t, S(v = 1;t) / exp(const: t). Assum ing a stretched exponential large-velocity tail for the scaling function (z) exp(const: jz)jasz!1 and the typical velocity decay v t ast! 1, and then m atching the dom inant behavior of the fastest particles P(1;t) = P(1;0)S(1;t) / exp(const:t) with the expected scaling behavior P (1;t) / t exp const: t yields the exponent relation = 1. In the hom ogeneous regime, = 1 and thus = 1, while in the clustering regime, = 1=2 and thus, = 2.

To quantify collectives motions and the corresponding velocity uctuations in the clustering regime, we also m easured the local kinetic energy, E_k , and the local therm al energy, E $_{\rm th}$. The local kinetic energy is de ned by $E_k = \frac{1}{2}h u^2 i w$ ith the density and the velocity $(u_x; u_y)$ obtained by averaging the corresponding u quantities over a sm all region of space. The local thermalenergy $E_{th} = \frac{1}{2}h(v_x - u_x)^2 + (v_y - u_y)^2$ u,)² i is obtained by subtracting the average local velocity u from the particle velocity v . Space was divided into 128 128 sm all boxes. As shown in Fig. 4, initially, the therm alenergy is large com pared with the kinetic energy, indicating that particles essentially m ove independently and there are no collective m otions. In contrast, in the asym ptotic regim e, 1° the therm all energy becomes much $t_{c}(r = 0:1)$ t sm aller than the kinetic energy, indicating that coherent motion of particles becom es dom inant. The appearance of the collective m otions was suggested by linear stability analysis of the hydrodynam ic equations [2,7] and observed in MD simulations [2,3,5,7,9{13].

Interestingly, we nd that the ratio of thermal to kinetic energy decays algebraically, $E_{th} = E_k t^{0.5}$, in the long time limit. The thermal energy, $E_{th} = \frac{1}{2}h(v)^2 i$ quantiles local velocity uctuations, v, and using Eq. (3),

In other words, local velocity uctuations, v $t^{3=4}$ are small compared with the typical velocity, v $t^{1=2}$, as v=v $t^{1=4}$. Thus, at least two distinct velocity scales are needed to characterize particle velocities in the clustering regime. Moreover, the relatively small velocity uctuations im ply strong velocity correlations and a well-de ned average local velocity. Thus, a hydrodynam ic description is plausible in the clustering regime.

To distinguish between acoustic and shear modes, we transformed the averaged velocity eld into Fourier space and decomposed the velocity as $u(k) = u_1(k) + u_t(k)$. Here $u_t(k)$ is the transverse velocity satisfying k u = 0, and $u_1(k)$ is the longitudinal velocity with k $u_1 = 0$. The corresponding representation in physical space is $u(x;y) = u_1(x;y) + u_t(x;y)$, with r u = 0, and

 $u_1 = 0$. The averaged longitudinal energy, i.e., the r energy of acoustic modes, is de ned as the spatial average $E_1 = \frac{1}{2}h u_1^2 i$, and the transverse energy, i.e., the energy of shear modes, is de ned as the space average of $E_t = \frac{1}{2}h u_t^2 i$. Initially, the system is isotropic and consequently, the longitudinal and the transverse energies are equal (see Figure 5). Since collective motions are negligible initially, statistical uctuations are isotropic as well. The ratio of longitudinal to transverse energies decreases steadily and eventually, it saturates at a value of roughly $E_1 = E_t$! 0:4 for t > t_c. Therefore, shear modes dom inate over acoustic modes in the clustering regime. This behavior is consistent with the form ation of dense, thin, elongated clusters, where particles move coherently, parallel to the cluster orientation [2]. Interestingly, we did not observe obvious correlations between the cluster size and its velocity.

C ollective motion of granular media can be described by mass, momentum and energy balance equations [2,7,24,25]. We have seen that the thermal energy, i.e., the temperature T, is negligible compared with the kinetic energy, and therefore, we may expand the system around zero temperature. In particular, we can ignore the pressure term in the momentum equation due to the fact that p T while keeping the viscosity term since $T^{1=2}$ [7]. The resulting governing equations are

taken in the lim it of vanishing viscosity, ! 0. The above equations are sim ilar to the two-dimensionalBurgers equation supplemented by the continuity equation, used to model large-scale formation of matter in the universe [26,27]. Here, the formation of shocks corresponds to dense, thin, string-like clusters where particles move parallel to the cluster orientation. At least qualitatively, this is consistent with the above indings that shear modes dominate over acoustic modes.

In conclusion, our simulations show that in the low density and large system limits, the kinetic energy of freely evolving granular media decays with time as t¹ in the long time limit. We have also observed that the particle velocity distribution is G aussian in this asym ptotic time regime. The above behavior is independent of the degree of dissipation. We have studied the origin of this universality and found that the asym ptotic dynam ics are dom inated by collective motions of particles or alternatively, shear modes. In the clustering regime, strong spatial velocity correlations develop, as local velocity uctuations are much smaller com pared with the typical velocity. We have also argued that the governing continuum equations are similar to the two-dimensional Burgers equation with in nitely small viscosity.
