# Three body problem in a dilute Bose E instein condensate

#### Abstract

We derive the explicit three body contact potential for a dillute condensed Bose gas from microscopic theory. The three body coupling constant exhibits the general form predicted by T.T.W u $\mathbb{P}$ hys.Rev.113, 1390 (1959)] and is detem ined in tem s of the am plitudes of two and three body collisions in vacuum. In the present form the coupling constant becom es accessible to quantitative studies which should provide the crucial link between few body collisions and the stability of condensates $w$ ith attractive two body forces.

D espite their diluteness atom ic Bose E instein condensates (BEC s) are signi cantly in uenced by inter-atom ic forces. The binary potential enters their properties m ainly through two body low energy scattering observables described by the $s w$ ave scattering length a. R ecent experim ents [1] [1] have provided the opportunity to tune the scattering length from the repulsive $(a>0)$ through the ideal gas ( $a \quad 0$ ) to the attractive ( $a<0$ ) regim e where the gas nally becom es unstable w th respect to collapse $\overline{\underline{L}}, \overline{1}, \overline{2} \overline{1} 1]$. W ith this new technique one can thus access a w ide range of dilute gas param eters and study phenom ena related to few body collisions in the gas.
$V$ irtually all properties of BECs at zero tem perature are described by a nonlinear Schrodinger equation (NLSE) [ $\left.\underline{4}_{1}^{-1}\right]$

which, in this extended form, depends on the H am iltonian of a single trapped atom as well as the two and three body coupling constants $g_{2}$ and $g_{3}$, respectively. Three body scattering obviously becom es signi cant at large scattering lengths, through the increase of the dilute gas param eter $=\overline{j \dot{j}^{2} \dot{\operatorname{jaj}}{ }^{3}}$, but also in the ideal gas regim e. Sm all scattering lengths ofonly a few A, e.g., are needed to produce stable condensates w ith attractive interactions and several thousands of atom $s$ in present day atom traps. T w o body scattering alone, how ever, seem s not su cient to explain the experim ental criterion for stability against collapse of ${ }^{85} \mathrm{Rb}$ [-1] and a tofEq. (1, $\overline{1}$ ) to the data gives an attractive three body interaction w ith very reasonable coupling constants $\mathrm{Reg}_{3} \dot{=} \sim$ of the order of $10^{27} \mathrm{~cm}^{6} / \mathrm{s}$ [G] $]$. In this way the corresponding three body $m$ ean eld shift of the energy density, $R \operatorname{eg}_{3} j j^{6}=3$, should becom e directly accessible to experim ents.
$T$ he determ ination of the three body coupling constant in a dilute BEC, and its associated mean eld energy, have a long history of theoretical research in $m$ any body physics [-6]. A lready in $1959 \mathrm{~W}_{\mathrm{p}} \mathrm{u}$ [ $\left.\overline{1}\right]$ discovered the general form $g_{3}=16 \sim^{2} a^{4}\left(\begin{array}{ll}4 & 3^{\rho}\end{array}\right)$ In $\left(C^{2}\right)=m$ for a B ose gas of hard spheres. $T$ he constant $C$ in the argum ent of the logarithm, how ever, rem ained undeterm ined and only
recently was signi cant progress made. In 1999 B raaten and $N$ ieto [i] used e ective eld theory to determ ine W u's general result by taking into account low energy three body scattering. They estim ated the argum ent of the logarithm on the basis of general assum ptions on the length scales set by the inter-atom ic potential. B raaten et al. [id $\left[\frac{1}{1}\right]$ also studied the role of param eters of the potential apart from the scattering length, through ts to m any body M onte C arlo sim ulations [1] $\left.1_{1}^{\prime}\right]$, as well as the properties of the e ective three body coupling constant when the scattering length is large in com parison to the range of the potential [1]

To the best of our know ledge, the three body coupling constant has not been derived from a m icroscopic description of the gas and expressed in term s of the binary potential. In this letter we provide a m icroscopic theory of three body collisions in a BEC and determ ine $g_{2}$ and $g_{3}$ to second order in the dihute gas param eter. T he derivation is based on the exact quantum evolution of correlation functions, i.e. quantum expectation values of products of single $m$ ode annihilation and creation operators of the form hap $i$, $h a_{p_{2}} a_{p_{1}} i$, ha $\mathrm{q}_{\mathrm{q}}^{\mathrm{Y}} \mathrm{a}_{\mathrm{p}}$ i etc.. R eferences [12, 1 act in nite hierarchy ofdynam ic equations for correlation functions into a m ore favorable form that allow sfor a system atic truncation in accordance with W ick's theorem. The resulting set of dynam ic equations for non com mu tative cum ulants []_] lends itself to iteration. W e shall apply this cum ulant approach here to express the exact dynam ic equation for the condensate $w$ ave function of a uniform gas through nonlinear term $s$ in and and determ ine $g_{2}$ and $g_{3}$ in equilibrium.

A ccording to $R$ ef. $\left[\begin{array}{c}{[13} \\ \hline 1\end{array}\right]$ the exact quantum evolution of the condensate wave function $p=h a_{p} i$ depends on the pairfunction $p_{1} p_{2}=h \mathrm{p}_{2} \mathrm{a}_{\mathrm{p}_{1}}$ i ha $\mathrm{p}_{2}$ iha $\mathrm{p}_{1}$ i and the third order cum ulant which is associated w ith the correlation function ha ${ }_{\mathrm{q}}^{\mathrm{Y}} \mathrm{a}_{\mathrm{p}_{2}} a_{\mathrm{p}_{1}} i$. T he explicit dependence of E q．$\overline{\mathbf{G}}$ ）on higher order cu－ $m$ ulants can be elim inated successively by solving their dynam ic equations form ally and inserting the solutions into Eq．$\overline{2}$ ）$\left[\begin{array}{ll}{[1]} \\ \hline\end{array}\right] . W$ ith this iterative procedure Eq．$\overline{2}$ ） can be expressed exactly through nonlinear term $s$ in ${ }^{-}$， and up to a given order and a rem ainder which contains only higher order cum ulants．To obtain the cou－ $p l i n g$ constants $g_{2}$ and $g_{3}$ we shalldeterm ine all the non－ linear term $s$ in and up to the fth order．

tim e dependent transition $m$ atrix is sharply peaked at $t=0 \mathrm{w}$ ith a width determ ined by the two body collisional duration. The $f$ th order nonlinear term $s$ in and (three body contributions), indicated by the dots on the right hand side ofE q. $\left(\overline{\underline{T}}_{1}\right)$, involve up to four tim e integrals which have a sim ilar form to the leading term.

To determ ine the equilibrium properties of the gas we shall assume rst that the scattering length is positive and the potentialdoes not support any bound clusters of atom s . In the zero tem perature equilibrium the ansatz

The logarithm ic behavior of the realparts of the integrals in Eqs. A trapped dihute BEC can usually be divided into regions w th an extent much larger than the range of the inter-atom ic forces but still m uch sm aller than the scale of the spatial variation of the condensate $w$ ave function
( x ). In these regions the gas can be considered as $10-$ cally hom ogeneous and the coupling constants in Eq. (14) rem ain valid when 0 is replaced by the local chem ical potential $0(x)=4 \sim^{2} a j(x) j^{2}=m$.

A realistic $m$ olecular potential $V(r)$ usually supports two body bound states. The coupling constant $g_{3}$ then acquires an im aginary part through $\mathrm{T}_{3 \mathrm{~B}}^{(5)}$. A ccording to
three body collision theory this im aginary part corresponds to the threshold-less form ation ofdim erm olecules and was determ ined here via an optical theorem with the $m$ ethods of $R$ ef. [2]. W . W thus obtained $2 \mathrm{Im} g_{3}=\sim=$
$\mathrm{K}_{3}=6 \mathrm{w}$ here $\mathrm{K}_{3}$ is the three body recom bination rate constant for an ultra-cold non condensed B ose gas. This w as determ ined in $R$ ef. [ $[2]=1]$ using classicalprobability argum ents, by assum ing that three atom $s$ are lost in each event. The factor of $1=6$ expresses the fact that all three condensed atom $s$ share the sam e quantum state $\left[2^{-2} 4_{1}^{\prime}\right]$ and w as veri ed in subsequent experim ents [2] ${ }_{2}^{2}$ ]. In the presence of bound states the condensate can only assum e a $m$ etastable state. T he change of its density, how ever, is negligible on tim e scales com parable to collisional durations so that the present results rem ain valid.

If $a$ is negative but the trapped gas is still stable w ith respect to collapse the above analysis slightly modi es: $0(x)$ then becom es negative and instead of Eq. (1 $\left.\overline{1}_{1}^{1}\right)$, respectively. The contribution of Eq. (1112), w th $\bar{j} j$ replaced by $j o j$ revises the two body coupling constant to $g_{2}=(2 \sim)^{3} \mathrm{~T}(20 ; 0 ; 0)$ $4 \sim a^{2} \mathrm{P} \frac{\mathrm{j}}{2 \mathrm{j} 0 \mathrm{~m}}$. This leads to $\mathrm{g}_{2}=\frac{4 \sim^{2}}{\mathrm{~m}} \mathrm{a}\left[1+\mathrm{O}\left({ }^{2}\right)\right]$ by Eq. ( $\underline{q}_{1}^{\prime}$ ). If the gas collapses [1] sum ption as well as the subsequent concept of tw o and three body coupling constants break dow $n$.

W hen a three body bound state em erges close to the zero energy threshold $g_{3}$ is dom inated by the residue of the corresponding pole through $\mathrm{T}_{3 B}^{(5)}$ [20 $\left.0_{1}^{\prime}\right]$. The real part of $g_{3}$ can then assume all positive and negative values in com plete analogy to the two body case. This phenom enon was discussed in Ref. ["I'] in connection with the m ove ect in the three body energy spectrum [2].1.

T he three body coupling constant in Eq. (14') has the form predicted by $W$ u $[\bar{T}]$ and $B$ raaten et al. $[\underline{[10},[1]$ can be determ ined quantitatively by solving the tw $\circ$ and three body scattering problem in vacuum [27]. The explicit representation in Eq. ( $\left.1-144_{1}^{\prime}\right)$ also allow s to directly relate all our current know ledge about two and three body transition am plitudes to properties of the gas. T he present theory is valid for all (non singular) molecular potentials and avoids divergences. C onvergence at high energies has been achieved by taking into account the exact binary potentialwhich enters the coupling constants through two and three body T m atrices. At low energies the argum ents of the infrared divergent contributions to $g_{3}$ have been determ ined to m ultiples of 0 which is the energy scale that corresponds to the healing length [E] $]$.

In sum $m$ ary, we have derived the explicit three body contact potential for a dilute condensed B ose gas from a m icroscopic m any body theory. T he respective coupling constant, $g_{3}$, that re ects general equilibrium properties ofan interacting BEC has been expressed in term sof the binary potential through two and three body transition
$m$ atrices. Its explicit form allow sfor a determ ination of the $m$ agnitude of $g_{3}$ from few body physics. W e have derived the heuristic three body recom bination rate constant ofR ef. [2]-3] asw ellas phenom ena related to resonant three body bound states.
