## Three body problem in a dilute Bose-Einstein condensate

We derive the explicit three body contact potential for a dilute condensed Bose gas from microscopic theory. The three body coupling constant exhibits the general form predicted by T.T.Wu [Phys.Rev.113, 1390 (1959)] and is determined in terms of the amplitudes of two and three body collisions in vacuum. In the present form the coupling constant becomes accessible to quantitative studies which should provide the crucial link between few body collisions and the stability of condensates with attractive two body forces.

D espite their diluteness atom ic B ose E instein condensates (BECs) are signi cantly in uenced by inter-atom ic forces. The binary potential enters their properties m ainly through two body low energy scattering observables described by the swave scattering length a. Recent experiments [1] have provided the opportunity to tune the scattering length from the repulsive (a > 0) through the ideal gas (a = 0) to the attractive (a < 0) regime where the gas nally becomes unstable with respect to collapse [2, 3]. With this new technique one can thus access a wide range of dilute gas parameters and study phenomena related to few body collisions in the gas.

Virtually all properties of BECs at zero temperature are described by a nonlinear Schrodinger equation (NLSE) [4]

which, in this extended form, depends on the Ham iltonian of a single trapped atom as well as the two and three body coupling constants  $q_2$  and  $q_3$ , respectively. Three body scattering obviously becom es signi cant at large scattering lengths, through the increase of the dilute gas param eter = j j<sup>2</sup> ja j<sup>3</sup>, but also in the ideal gas regime. Small scattering lengths of only a few A, e.g., are needed to produce stable condensates with attractive interactions and several thousands of atom s in present day atom traps. Two body scattering alone, however, seem s not su cient to explain the experimental criterion for stability against collapse of  $^{85}$  Rb [2] and a tofEq. (1) to the data gives an attractive three body interaction with very reasonable coupling constants  $\Re eg_3 \neq \sim$  of the order of 10  $^{27}$  cm  $^{6}$ /s [5]. In this way the corresponding three body mean eld shift of the energy density,  $\operatorname{Reg}_3$  j j<sup>6</sup>=3, should become directly accessible to experiments.

The determ ination of the three body coupling constant in a dilute BEC, and its associated mean eld energy, have a long history of theoretical research in m any body physics [6]. A lready in 1959 W<sub>p</sub>u [7] discovered the general form  $g_3 = 16 \ ^2a^4$  (4  $3\ \overline{3}$ ) ln (C  $^2$ )=m for a Bose gas of hard spheres. The constant C in the argum ent of the logarithm , how ever, rem ained undeterm ined and only recently was signi cant progress m ade. In 1999 B raaten and N ieto [8] used e ective eld theory to determ ine W u's general result by taking into account low energy three body scattering. They estim ated the argum ent of the logarithm on the basis of general assum ptions on the length scales set by the inter-atom ic potential. B raaten et al. [9] also studied the role of param eters of the potential apart from the scattering length, through ts to m any body M onte C arlo sim ulations [10], as well as the properties of the e ective three body coupling constant when the scattering length is large in com parison to the range of the potential [11].

To the best of our know ledge, the three body coupling constant has not been derived from a microscopic description of the gas and expressed in terms of the binary potential. In this letter we provide a m icroscopic theory of three body collisions in a BEC and determ ine  $g_2$  and  $g_3$  to second order in the dilute gas parameter . The derivation is based on the exact quantum evolution of correlation functions, i.e. quantum expectation values of products of single m ode annihilation and creation operators of the form  $ha_p i$ ,  $ha_p a_p i$ , i,  $ha_q^y a_p i$  etc.. R efferences [12, 13] provide a general approach to transform the exact in nite hierarchy of dynam ic equations for correlation functions into a more favorable form that allows for a system atic truncation in accordance with W ick's theorem . The resulting set of dynam ic equations for non commutative cum ulants [13] lends itself to iteration. We shall apply this cum ulant approach here to express the exact dynam ic equation for the condensate wave function of a uniform gas through nonlinear terms in and and determ ine  $q_2$  and  $q_3$  in equilibrium.

A coording to Ref. [13] the exact quantum evolution of the condensate wave function  $_{p} = ha_{p}i$  depends on the pair function  $_{p_{1}p_{2}} = ha_{p_{2}}a_{p_{1}}i$   $ha_{p_{2}}iha_{p_{1}}i$  and the third order cum ulant which is associated with the correlation function  $ha_{q}^{y}a_{p_{2}}a_{p_{1}}i$ . We shall rst consider the uniform




FIG .1: Jacobicoordinates of three atom s. The spatial coordinates are chosen as the vector from atom 1 to atom 2  $(r_{12})$  and the vector from the center of m ass of atom s 1 and 2 to atom 3 (). The conjugate Jacobim om enta are  $p = (p_2 \quad p_1)=2$  and  $q = (2p_3 \quad p_1 \quad p_2)=3$ , respectively, where  $p_1; p_2; p_3$  denote the m om enta of the single atom s.

gas lim it. The dynam ic equation for then reads [14]

where the integration variables are chosen as center of m ass and relative atom ic m om enta  $q \ge p_1 + p_2$  and  $p = (p_2 \ p_1)=2$ , respectively, and V (p) = drV (r) exp ( ip r=~)= $(2 \ 2 \ -)^3$  is the Fourier transform of the potential into m om entum space. Additional terms [13] that are proportional to the density m atrix of the non condensed fraction,  $p_q = ha_q^y a_p i$   $ha_q^y i ha_p i$ , neither contribute to  $g_2$  nor to  $g_3$  and have been om itted in Eq. (2).

The explicit dependence of Eq. (2) on higher order cumulants can be eliminated successively by solving their dynamic equations formally and inserting the solutions into Eq. (2) [13]. With this iterative procedure Eq. (2) can be expressed exactly through nonlinear terms in ,

and up to a given order and a remainder which contains only higher order cum ulants. To obtain the coupling constants  $g_2$  and  $g_3$  we shall determ ine all the non-linear terms in and up to the fith order.

The form al solutions of the dynam ic equations of and [13] involve the triple function , i.e. the third order cumulant associated with the correlation function ha<sub>p3</sub> a<sub>p2</sub> a<sub>p1</sub> i, and the G reen's function corresponding to two atoms described by the two body Ham iltonian H<sub>2B</sub> =  $\frac{x^2}{m}$  r + V (r) in their center of m ass frame. The relevant retarded G reen's function is given by [15] G (t) =  $\frac{1}{i^{\sim}}$  (t) exp( iH<sub>2B</sub> t=~). We shall use G (t;p;p<sup>0</sup>) = hpjG (t)S j<sup>0</sup>i in momentum space, where S projects onto the symm etrized relative momenta that correspond to two identical Bose atom s. At the initial tim e t<sub>0</sub> the gas is assumed to be prepared in a (ideal gas) coherent state of the lowest energy mode [16]. The form alsolutions then read:

where  $p_1^0 = q^0=2$   $p^0$  and  $p_2^0 = q^0=2 + p^0$ . The form of Eqs. (3) and (4) is exact, save that terms that neither contribute to  $g_2$  nor to  $g_3$  are not given. The arguments of the triple function for a uniform gas are chosen here as the three body Jacobim omenta in Fig. 1.

The dynam ic equation for involves the H am iltonian of three atom s interacting pairw ise,

where  $V_{3B} = V(r_{23}) + V(r_{13}) + V(r_{12})$  (see Fig.1). The corresponding symmetrized retarded G reen's function in the three body center of mass frame is denoted here as  $G_{3B}(t;q;p;q^0;p^0)$  in the representation through the Jacobim omenta in Fig.1. The only relevant contribution of the triple function reads

where  $p_2^0 = q^0 = 2 + p^0$ .

All nonlinear contributions in and up to the ffh order are obtained by inserting Eqs. (3) and (4) into the right hand side of Eq. (2) and then replacing by Eq. (6) and by its leading rst contribution on the right hand side of Eq. (3). Equation (2) then becomes a non-M arkovian NLSE [13] with the leading (two body) contribution

where T(t) = V(t) + VG(t)V is the Fourier transform of the energy dependent two body T matrix [15]. This time dependent transition matrix is sharply peaked at t = 0 with a width determ ined by the two body collisional duration. The fifth order nonlinear terms in and (three body contributions), indicated by the dots on the right hand side of Eq. (7), involve up to four time integrals which have a similar form to the leading term.

To determ ine the equilibrium properties of the gas we shall assume rst that the scattering length is positive and the potential does not support any bound clusters of atom s. In the zero tem perature equilibrium the ansatz

(t) = exp( i t=~) then transform s the NLS Eq. (7), including the three body contributions, into its stationary form in the limit t  $t_0$  ! 1 [17]:

The two body contribution to Eq. (8) is directly obtained from Eq. (7) through the Fourier transform of T (t ;0;0) at the energy 2 which yields the two body T m atrix T (2 ;0;0) [18]. The low energy expansion [19, 20]

shows that the leading contribution to is the mean eld chem ical potential  $_0 = 4 \ ^2 a j \ j^2 = m$ . The three body contributions to the right hand side of Eq. (7) (not shown n explicitly) can also be arranged in such a way that all bare two body potentials are connected to two and three body T matrices. The general form of the real part of Eq. (8) is then obtained as ( =  $\int j \ j^2 a^3$ ):

where corrections smaller than  $_0$ <sup>2</sup> have been neglected. The rst term on the right hand side of Eq. (10) is the two body part. All three body contributions to Eq. (8) are at least of third order in the two body T m atrix. The real parts of the third and fourth order terms exhibit a logarithm ic divergence at low energies ! 0 as indicated in the second term on the right hand side of Eq. (10). The respective explicit expressions read

The logarithm ic behavior of the real parts of the integrals in Eqs. (11) and (12) was determ ined with the methods in Ref. [20]. Them omentum units  $p^{(3)}$  and  $p^{(4)}$  are found using the regular parts of the integrals in the limit ! 0.

The last contribution to the right hand side of Eq. (10) involves the T m atrix for three asymptotically free incom – ing and outgoing atom s,  $T_{3B}$  (E) =  $V_{3B} + V_{3B}$  G<sub>3B</sub> (E) $V_{3B}$ . The regular part of  $T_{3B}$ , denoted here by  $T_{3B}^{(5)}$ , consists of allmultiple scattering contributions to  $T_{3B}$  from the ffh order upward [21].  $T_{3B}^{(5)}$  (E) can be evaluated at E = 0 [20] and is the only contribution to  $g_3$  that depends on the complete zero energy three body scattering state.

Equation (8) also exhibits an imaginary part

whose rst leading term stems from Eq. (9). The second term is the leading contribution to the imaginary part of describes the exchange of atoms between the condensed and therm al fraction [13] and is thus required to vanish exactly in equilibrium as soon as all few body scattering contributions are taken into account. The right hand sides of Eqs. (10) and (13) change by an amount sm aller than  $_0^{-2}$  if is replaced by its leading contribution  $_0$ . The square root terms in Eq. (13) then, indeed, cancel each other and Eqs. (10) and (8) yield

A trapped dilute BEC can usually be divided into regions with an extent much larger than the range of the inter-atom ic forces but still much sm aller than the scale of the spatial variation of the condensate wave function

(x). In these regions the gas can be considered as locally hom ogeneous and the coupling constants in Eq. (14) rem ain valid when  $_0$  is replaced by the local chem ical potential  $_0(x) = 4 -^2 aj(x)j^2 = m$ .

A realistic molecular potential V (r) usually supports two body bound states. The coupling constant  $g_3$  then acquires an in aginary part through  $T_{3B}^{(5)}$ . A coording to

three body collision theory this imaginary part corresponds to the threshold-less form ation of dimermolecules and was determined here via an optical theorem with the methods of Ref. [22]. We thus obtained  $2 \text{Im} g_3 = ~ =$ 

K  $_3=6$  where K  $_3$  is the three body recombination rate constant for an ultra-cold non condensed Bose gas. This was determ ined in R ef. [23] using classical probability arguments, by assuming that three atoms are lost in each event. The factor of 1=6 expresses the fact that all three condensed atoms share the same quantum state [24] and was veried in subsequent experiments [25]. In the presence of bound states the condensate can only assume a m etastable state. The change of its density, how ever, is negligible on time scales comparable to collisional durations so that the present results remain valid.

If a is negative but the trapped gas is still stable with respect to collapse the above analysis slightly modiles:  $_{0}(x)$  then becomes negative and instead of Eq. (13) one obtains real contributions,  $_{0}$  m 2j ja=~ and  $_{0}8 \sim j j^{2}a^{2} = 2 m 2j$  j through Eq. (9) and the integral in Eq. (11), respectively. The contribution of Eq. (11), with j j replaced by  $j_{0}j$ , revises the two body coupling constant to  $g_{2} = (2 \sim)^{3}T (2 \circ)(0)$  $4 \sim a^{2} 2j_{0}jm$ . This leads to  $g_{2} = \frac{4 \sim^{2}}{m}a[1 + 0 (2)]$  by Eq. (9). If the gas collapses [3] the equilibrium assumption as well as the subsequent concept of two and three body coupling constants break down.

W hen a three body bound state emerges close to the zero energy threshold  $g_3$  is dominated by the residue of the corresponding pole through  $T_{3B}^{(5)}$  [20]. The real part of  $g_3$  can then assume all positive and negative values in complete analogy to the two body case. This phenom enon was discussed in Ref. [11] in connection with the E move ect in the three body energy spectrum [26].

The three body coupling constant in Eq. (14) has the form predicted by W u [7] and B raaten et al. [8, 11] and can be determ ined quantitatively by solving the two and three body scattering problem in vacuum [27]. The explicit representation in Eq. (14) also allows to directly relate all our current knowledge about two and three body transition am plitudes to properties of the gas. The present theory is valid for all (non singular) molecular potentials and avoids divergences. Convergence at high energies has been achieved by taking into account the exact binary potential which enters the coupling constants through two and three body T matrices. At low energies the arguments of the infrared divergent contributions to  $g_3$  have been determ ined to multiples of  $_0$  which is the energy scale that corresponds to the healing length [4].

In sum m ary, we have derived the explicit three body contact potential for a dilute condensed Bose gas from a m icroscopic m any body theory. The respective coupling constant,  $g_3$ , that re ects general equilibrium properties of an interacting BEC has been expressed in term s of the binary potential through two and three body transition m atrices. Its explicit form allows for a determ ination of the magnitude of  $g_3$  from few body physics. We have derived the heuristic three body recombination rate constant of R ef. [23] as well as phenom ena related to resonant three body bound states.
