Non-universality in Ising models with four spin interaction.

A bstract. We consider two bidimensional classical Ising models, coupled by a weak interaction bilinear in the energy densities of the two systems; the model contains, as limiting cases, the Ashkin-Teller and the Eight-vertex models for certain values of their parameters. We write the energy-energy correlations and the specience heat as Grassman integrals formally describing Dirac 1+1 dimensional interacting massive fermions on a lattice, and an expansion based on Renormalization Group is written for them, convergent up to temperatures very close to the critical temperature for small coupling. The asymptotic behaviour is determined by critical indices which are continuous functions of the coupling.

Key words Coupled Ising models, non-universality, Renormalization Group, ferm ions, critical indices.

1. Introduction and main results

1.1 M otivations. It is well known that the partition function and many correlations of the d = 2 classical Ising model can be written as G rassman integrals formally describing a system of d = 1+1 free ferm ions, see [H], [SML], [K], [MW], [S], [D]. This mapping of the Ising model in terms of a ferm ionic theory is quite useful; as the corresponding action is quadratic in the Grassman variables, it can be diagonalized by a Bogoliubov transform ation so that the partition function and many observables can be exactly computed. However, even a slight perturbation of the Ising model makes the corresponding ferm ionic action non-quadratic. The relationship between spin Ising-like models and interacting ferm ionic models is deeply investigated in the literature; it is for instance claim ed that models of coupled Ising models with an interaction quartic in the spins, like the Eight-vertex model, are in the same class of universality of models of interacting d = 1 + 1 ferm ions in the continuum, like the massive Thirring model or the massive Luttinger model, see for instance N], [LP], PB]. This relationship is however found under many approximations. In this paper we consider two Ising models coupled by a general interaction bilinear in the spin densities; the model contains as particular cases the Ashkin-Teller and Eight-vertex model for certain values of their parameters. We clarify the relation between this general spin model and systems of interacting ferm ions by writing the partition function and some correlations as G rassm an integrals with a formal action resembling but not coinciding with the action of the m assive Thirring or Luttinger model; the main dierence (in addition to the fact that the form all action describes ferm ions in a lattice, not in the continuum) is that it does not verify som e special sym m etries (like invariance under local G auge transform ations) which are generally veried in models of interacting ferm ions and which play an important role in their analysis. The main interest in this representation in terms of Grassman integrals is that we can apply the Renormalization G roup techniques developed for interacting ferm ions (see for instance [BG] or [GM]) for writing a convergent perturbative expansion for the partition function and some correlations of the spin model we are considering. A naive power series expansion in the coupling is not expected to be convergent close to the critical tem perature (the free and interacting model are not analytically close) and one needs a resum m ed or renorm alized expansion which is provided by R enorm alization Group.

1.2 Spin systems with quartic interactions. We consider two Ising models coupled via a four spin interaction bilinear in the energy densities of the two sublattices. Given M2 Z2² a square lattice with side M and periodic boundary condition, we call $x=(x;x_0)$ a site of M. If $_x^{(1)}=1$ and $_x^{(2)}=1$, we write the following H am iltonian

The above H am iltonian can be a model for a number of physical problem s; for instance two magnetic spin planes coupled by an interplanar interaction quartic in the spins (in this interpretation $^{(1)}$ and $^{(2)}$ are the spin of the rst or second plane). Moreover it contains, as \lim iting cases, two wellknown models, the Ashkin-Teller and the Eight-vertex model.

1.3 The Ashkin-Teller model. Ashkin and Teller introduced their model as a generalization of the Ising model to a four state system. Each site x is occupied by one of the four kinds of atom, said A,B,C,D, and two neighboring atoms interact with an energy "o for AA,BB,CC,DD;" for AB;CD, "o for AC;BD, "o for AD;BC. It is quite easy to express this model in terms of Ising spins, see [F]. One associates to each site of the lattice two spins $_{\rm x}^{(1)}$ and $_{\rm x}^{(2)}$, see Fig.1; then $_{\rm x}^{(1)}$; $_{\rm x}^{(2)}$ = (+;+) if there is an A atom at site x, (+;) if there is an atom B, (;+) if there is an atom C and (;) if there is an atom D. Then the ham iltonian is given by

The model is not soluble, except in some particular case, and we refer to [Ba] chapt 12 and references therein for a review of the main results about it; it is of the form (1.1) with b=c=0.

1.4 The Eight-vertex model. In such model one associates to each site of a square lattice a vertex with four arrows with dierent orientations, see [Ba] chapt. 10.

Am ong the sixteen possibilities, only eight kind of vertices are allowed, and an energy $"_i$, i = 1; :::; 8, is associated to each of them. It was solved in [Ba] if $"_1 = "_2$, $"_3 = "_4$, $"_5 = "_6$, $"_7 = "_8$ and for suitable values of the $"_i$ it reduces to the icemodel, solved in [Li]. Such models are called vertex models and were introduced to describe crystal with hydrogen bonding. As explained in [Ba] or [V] they can be written in terms of the following Ham iltonian, see Fig. 2

If $J^{00}=0$ the above ham iltonian decouples in the ham iltonian of two Ising models, involving spins located in two sublattices, one with $x+x_0$ equal to an even number and the other to an odd number. Each site of the sublattices is in the center of the unit square of the other one. Calling (1) and (2) the spin located in the 1st or the second sublattice, relabeling the spins and performing a rotation of $\frac{1}{4}$ the ham iltonian can be written as, see Fig.3

1.5 Main results. We will consider in this paper the case

If = 0 the problem reduces to the Ising model whose critical tem perature is given by tanh $_cJ_0=\frac{p}{2}$ 1 t_c where J J_0 and 1 is the tem perature. The interaction changes in general the value of the critical tem perature by term s O (), and it is instead technically convenient to x its value still in correspondence of $t_c=\frac{p}{2}$ 1, by choosing properly the molecular energy parameter J as a function of ; in this way the critical tem perature of the system with = 0 and \bullet 0 is the

same. We consider then the model (1.1) with J_r replacing J, and we will choose $J_r = J + O$ () so that the critical temperature is in correspondence $t_c = \frac{D}{2} - \frac{1}{2}$. We de ne

Remarks. The above theorem describes the behaviour of the energy-energy correlation and the speci c heat near the critical tem perature of Ising m odels in two dimensions weakly coupled by a four spin interaction. One can distinguish two di erent regim es in the asym ptotic behaviour of the energy-energy correlation function, discrim inated by an intrinsic correlation length of order to tej 1 2 with z = 0 (). If $1 << \dot{x}$ y $\dot{y} <<$, the bounds for the correlation function is power-like (with a dependent exponent) while if << ; i, there is a faster than any power decay with rate of order 1 . In the 1st region we can obtain the exact large distance asymptotic behaviour of the energy-energy correlation function, see (1.15), while in the second region only an upper bound is obtained. The logarithm ic behaviour of the speci c heat in the Ising model getting closer and closer to the critical tem perature is changed by the four spin interaction in a power law, at least up to tem peratures very close to to for small four spin coupling. A bound like $C_1 \log (t_c j^1) = \frac{1}{\log_1 t^2} f(J) j = C_2 \log (t_c j^1)$, for some positive -independent constants C_1 and C_2 , which would be true if the model would be in the same universality class as the Ising model, cannot be true by (1.16) at least for t t_cj e $\frac{1}{a_3}$.

In the particular case a=c=0 our model reduces to the Eight-vertex model, which is exactly soluble [Ba]; our results agree with the informations obtained by the exact solution, in which non universal critical behaviour is found and it is believed that the speci cheat diverges with a power law [W]. In the case a=b=0 our model reduces to a model of two non interacting Ising models with nearest neighbor and four spin interaction within each copy, which was studied in [PS] (which is indeed the rst paper in which fermionic RG methods were applied to classical Ising-like models, and it is a major source of inspiration for the present work). In this case $C_1 \log (t_c t_c t_c) = t_c \log (t_c t_c t_c)$ (up to $t_c t_c$) so that universality indeed holds

1.7 Sketch of the proof. The proof of the theorem is based on G rassmann variables combined with renormalization group techniques. In x2 we brie y recall the well-known representation of the bidimensional Ising model in terms of G rassmann variables, mainly due to [K], [H], [M], [M], [S] and recently rederived in a more cohesive way in [PS]. The partition function and the correlation can be written in terms of G rassmann integrals with a quadratic action which can be explicitly computed in terms of P fa ans. The exact solvability of the Ising model is hence related to

the fact that it can be expressed in terms of free ferm ions, as it was sixt noted in [SM L]. In the Grassmann representation there are four independent Grassmann variables associated to each point of the lattice, two with a large 0 (1) m ass and the other two with a continuously vanishing mass at the critical temperature. In x2 we show that two Ising models weakly coupled by four spin interactions, with ham iltonian (1.1), can be also written in term s of G rassm annn integrals, with the di erence that there are now eight independent Grassmannn variables (four for each Ising model) and that the formal action contains now term swhich are quartic in the elds, corresponding to a short range interaction among ferm ions. By perform ing a suitable linear transform ation in the G rassmann variables one obtains that in the new variables the quadratic part of the action strongly resembles the action of two massive D irac ferm ions in d = 1 + 1 dimensions (it would coincide with that if the continuum lim it would be taken); again one Dirac ferm ion has a large 0 (1) mass and the other is vanishing at t_c , and we call them heavy and light ferm ions. We are essentially exploiting in this transform ation the relation $Pf^2A = detA$.

In x3 we integrate out the heavy elds in the G rassm ann integral for the partition function, so obtaining a G rassm ann integral whose form alaction contains m onom ials of every degree in the light D irac ferm ions. In order to do this we use the representation in [Le] of ferm ionic truncated expectations and G ram -H adam and inequality.

In x4 we apply renormalization group methods to integrate the light ferm ions, which in a sense are the critical modes. We will use a suitable modi cation of the multiscale expansion used in [BM] (see also [BG] or [GM] for a general introduction to the form alism) to study the correlation functions of the Heisem berg-Ising X Y Z chain; the close relationship between Ising models with quartic coupling and the X Y Z times has been pointed out many times in the literature, see for instance [Ba]. A power counting analysis says that the terms bilinear in the Grassmann variables are relevant in a RG sense, while the quartic term s, or the bilinear with an extra derivative are marginal. One can understand here why universality is still present if one considers decoupled Ising models with nearest neighbor and four spin interaction within each copy, and why on the contrary it is lost if the Ising models are coupled. In the rst case (which is the one treated in [SP]) one can easily check that the local part of the quartic term s is vanishing, so the e ective interaction is indeed irrelevant in the RG sense. On the other hand in the second case the quartic interactions is truly marginal and this produces a line of xed points for the RG transform ation (instead of the gaussian xed point as in the previous case) continuously depending on the coupling . We decompose the G rassm ann integration P (d) as a product of independent G rassm ann integrations P (d (h)), with covariance with non vanishing support only for momenta with modulus between h = 1 and h + 1, with > 1 and h = 0; 1; 2; 3; W e integrate each P (d (h)) iteratively starting from P (d (1)) obtaining a sequence

of e ective potentials V (h) describing the theory at m om entum scale h; at each step new contributions to the mass and the wave function renormalization are obtained which are included in the ferm ionic integration; hence P (d (h)) has a covariance with m ass m $_{\rm h}$ and wave function renormalization Z $_{\rm h}$ with a non trivial dependence on h, i.e. m_h ' t t_c j 2h and Z_h ' 4h , with $_4$ = 0 (2). The iteration stops as soon as the mass m, becomes of order b; we will call h the last scale to be integrated (of course h ! 1 at the critical temperature $t = t_c$). The iterative procedure allows to write the e ective potential V (h) as sum of m onomials in the Grassmann variables, with one cients which are (convergent) perturbative expansions in term sofa few running coupling constant, h, the e ective coupling of the interaction between ferm ions, h, which takes into account the renormalization of the value of the critical tem perature, h related to the renormalization of the ferm ionic velocity and other couplings in the coe cients of quadratic terms in the Grassmann elds with a derivated eld. Despite there are many similarities between our Grassmann integrals and the one describing relativistic ferm ions, there is a crucial di erence; the interaction term in the action is not invariant under gauge transform ation, hence term swhich were absent in the free action can be generated in the RG iterations. One can check that indeed peculiar sym m etries of the m odel (1.2) ensure that there is only one relevant term quadratic in the ferm ions (if there were more one gets in troubles, as there is only one free param eter in the ham iltonian). On the other hand we cannot exclude the generation of marginal quadratic terms which were absent in the free action; they are the term $s_{i;!;h}$; $\tilde{s}_{i;!;h}$. At the end the result of this iterative integration is an expansion for the partition function in terms of the running coupling constants which is proved in x4 to be convergent provided that the running coupling constants are small for any h.

In x5 we prove indeed that it is possible to choose the counterterm—as a function of—so that the running coupling constants are indeed small; the condition on the tem perature \dot{t} — \dot{t}_c \dot{j} —e $^{\frac{1}{a_3}\frac{1}{2}}$ is used to control the—ow of the running coupling constants, and some cancellations at the lower order in our expansion are also used to be as close as possible to the critical tem perature.

Finally in x6 we de ne an expansion for the correlation functions and the specic heat; it is similar to the one for the partition function, with the main dierence that one has to introduce new elds associated to the external elds. There are additional marginal terms in RG expansion to which other renormalization constants, with a non-trivial behaviour in h, are associated, i.e. $Z_h^{(1)}$ ' 1h and $Z_h^{(2)}$ '. By such expansion the statements in the theorem are derived.

Am ong interesting open problems there is the reaching of the critical temperature; surely one has to exploit suitable cancellations at every order of the expansion for $_{\rm h}$; $_{\rm h}$, as in the theory of d = 1 interacting Ferm i systems, see for instance [BGPS] and [BM], but at the moment the main diculty is in the ow of the couplings $_{\rm i;l}$; $_{\rm h}$ and $_{\rm i;l}$; $_{\rm h}$. A nother interesting problem would be the analysis of the

spin-spin correlation function whose expression in terms of G rassmann variables is unfortunately quite complicated and not easy to manage. A similar problem appears in considering two Ising models coupled by a weak interaction bilinear in the spins; in such a case the interaction in terms of G rassmann variables has a quite complex expression and it seems dicult to study. On the other hand, for large coupling, such bilinear interaction should be irrelevant and universality should hold. Finally it should be interesting to study the case of two coupled Ising models at dierent temperatures or the case of four coupled Ising models; in this last case interacting spinning d=1 ferm ions appear in the ferm ionic description, which are known to have a behaviour quite dierent from the spinless one (like in the d=1 Hubbard model).

2. Ferm ionic representation






Fig.4: Closed polygon in the high temperature expansion of the Ising model partition function.




Fig.3. The Eight-vertex model in the rotated frame, with spins relabelled; the solid lines represent the quartic interaction.




Fig.2. The spin representation of the Eight-vertex model; the solid points have x0+x even and the void points, odd; the solid lines represent the quartic interaction.




Fig.1: The spin representation of the Ashkin Teller model; the dotted lines represent the Ising interactions, the solid lines the quartic interaction.




Fig.5. The second lattice and its polygon configurations.




Fig.6. Local identification of Ising configurations and configurations over the second lattice.
