Expansion algorithm for the density matrix

A puri cation algorithm for expanding the single-particle density matrix in terms of the Ham iltonian operator is proposed. The scheme works with a prede ned occupation and requires less than half the number of matrix-matrix multiplications compared to existing methods at low (< 10%) and high (> 90%) occupancy. The expansion can be used with a xed chemical potential in which case it is an asymmetric generalization of and a substantial improvement over grand canonical McW eeny purication. It is shown that the computational complexity, measured as number of matrix multiplications, essentially is independent of system size even for metallic materials with a vanishing band gap.

I. IN TRODUCTION

Theoretical predictions of material properties of complex systems consisting of millions of atoms are often lim ited not by theory but by the calculational techniques. Recently there has been a large e ort to develop ab-initio m ethods that computationally scale linearly with system size [1]. The techniques may play an important role in a broad spectrum of science such as molecular biology, materials science, chem istry and nanotechnology. Several of the linear scaling schem es are based on the single-particle density matrix that can be used in order to calculate the energies and densities that occur in self-consistent eld theories. The construction of the density matrix is used as an alternative to solving an eigenvalue problem. For large com plex system swithin a sparsem atrix representation this approach can be performed more e ciently and instead of a cubic scaling the computational cost scales linearly with the system size [1]. The matrix sparsity is essential for the success of density matrix schemes. For m aterials with a gap the real space representation of the density matrix is sparse [24] due to a nite interaction length, which is usually referred to as near sightedness [5]. However, within other representations, such as a multiresolution wavelet basis or a group-renormalization representation, the density matrix is sparse also for metallic system s $[6{9}]$.

M ost techniques for constructing the density matrix can be seen as a polynomial expansion of the density matrix $_{0}$ in terms of the Hamiltonian operator H . In an iterative approach this expansion can be formulated as

The projection polynomials P_n (H; X_n) are chosen to achieve a rapid convergence under the conditions of commutation, $[H;_0]=0$, idempotency, $[h]_0^2=0$, and particle conservation, $[h]_0^2=0$. They may either be chosen from a constrained conjugate gradient minimization of the energy functional $[h]_0^2=0$, or as a fast expansion of the step function $[h]_0^2=0$, or as a fast expansion of the step function $[h]_0^2=0$, or as a fast expansion of the step function $[h]_0^2=0$, or as a fast expansion of the step function $[h]_0^2=0$, and $[h]_0^2=0$, the Fermi $[h]_0^2=0$ for a trick matrix additions, subtractions and multiplications. The problem is to not a rapidly convergent expansion that minimizes the number of matrix-matrix multiplications, since these operations are the most time consuming $[h]_0^2=0$.

The e ciency of the di erent density-matrix schemes varies depending on particular characteristics of the problem such as the existence of a band gap, a prede ned chem ical potential, lling factor, self-consistency cycles, thresholding, basis set and system size. In this letter we propose a puri cation algorithm for the construction of the density matrix that is simple, general and rapidly convergent also for very large metallic systems. The method works with a prede ned occupation and does not need the input or adjustment of the chemical potential. Only one previous purication strategy, recently developed by Palser and Manolopoulos (PM) [24], exists for this important problem. By using a starting guess X_0 with the trace equal to the occupation number and thereafter performing trace-conserving spectral projections, X n converges to the correct density matrix without prior know ledge of the chem ical potential. The PM scheme has an excellent performance compared to other m ethods [24,20]. However, due to the constraint of trace conservation the method is ine cient at low and high partial occupancy. This is of great concern, for example, when using a multi-resolution wavelet representation for m etallic problems, since the fractional lling in this case is low. The same problem occurs with a minimal basis set at both high and low occupancies. A simple general algorithm that avoids this particular problem, and still converges as or more rapidly, especially for very large problem s, would therefore be of great interest.

II.TRACE CORRECTING PURIFICATION

The method we propose is based on the continuously increasing puri cation polynomials with stationary end points in [0;1]

Two examples of $P_m^{(a)}(x)$ and $P_m^{(b)}(x)$, for m=1 and 3, are displayed in Fig. 1. It can be shown that any combination of these polynomials in an iterative expansion converges to a step function for $x \ge [0;1]$, i.e.

with the step 2 [$_m$; 1 $_m$]. Here $_m$ is the in ection point of $P_m^{(a)}$ (x), i.e. where $P_m^{(a)}$ ($_m$) = $_m$, $0 < _m < 1$, and (1 $_m$) is the in ection point of $P_m^{(b)}$ (x). The convergence towards a step function can be understood from the fact that for each new iteration the new function will still be continuously increasing, but with an in creasing number of vanishing derivatives at the end points. The asymmetry in the number of vanishing derivatives determines the position of the step. The choice m=2 corresponds to the McW eeny polynomial [21]. In this symmetric case $_2$ = 1=2, and a step can only be formed at = 0.5. The occupation of an operator X can be modied such that

where "(X) are the eigenvalues of X. For m = 1 the reverse situation holds, with switched inequalities. With m \in 2 we can apply the polynomials of Eq. (2) in the expansion of the density matrix, Eq. (1), such that each step adjusts for the occupation of X_n . In this way an expansion is created that converges to the density matrix with the correct occupation, i.e. $_0$ = (I H) with $Tr[_0] = N_e$, but without a priori knowledge of . The algorithm (for m > 2) is given by this pseudocode:

Form = 1 the trace condition has to be reversed to " > ". The scheme can be described as follows: First the Ham iltonian is normalized to an initial matrix X_0 with all its eigenvalues "(X_0) 2 [$_{\rm m}$;1 $_{\rm m}$]. The constants " $_0$ and " $_{\rm N}$ are the lowest and highest eigenvalues of H ,

respectively. These can be approximated by, for example, Gersgorin estimates or the Lanczos method, with only a small extra computational cost [20,24]. A necessary criterion for convergence is that the unknown chem ical potential of the normalized initial matrix (X_0) 2 m]. For intermediate occupancy, provided $(X_0) 2 [_m; 1]$ $_{\rm m}$], $_{\rm m}$ can be set to zero in the starting guess. This usually reduces the number of iterations by one or two steps. The improvement has not been used in the present study. A fter initializing X_0 the projections $P_m^{(a)}$ (X $_n$) or $P_m^{(b)}$ (X $_n$) are perform ed, adjusting the occupancy and expanding a step function at the same time. The iteration stops when some appropriate error estimate is less than a prede ned error lim it. Note, that a high order expansion m ay lead to too fast convergence, m aking the adjustment of the occupation impossible. We may also use combinations with dierent values of mas well as other asym metric purication polynomials. Any set of asym m etric continuously increasing polynom ials in [0;1] with stationary points at 0 and 1 can be used equivalently. The presented algorithm cannot handle problem s with degenerate eigenstates at . The algorithm would still converge, but to the wrong density matrix, since the degenerate states would split due to num erical noise. This diers the presented trace correcting purication scheme from the PM scheme, which correctly can treat the case of degeneracy.

III. GRAND CANONICAL PURIFICATION

Since any combination of the expansion polynomials in Eq. (2) converges to a step function we can use a predened xed expansion combination of (I H). In this case must be known, but the e ciency might be slightly improved compared to the schemes working with a predened occupancy. For example, we may use the repetitions of the combination $P_{\rm ex}^{\rm GC}(x) = P_2^{\rm (b)}(P_1^{\rm (b)}(P_3^{\rm (a)}(x)))$ or (for m > 1) only $P_{\rm m}^{\rm (a)}(x)$, or only $P_{\rm m}^{\rm (b)}(x)$, in the combination

where is the normalized chemical potential, = ($"_0$)($"_N$ $"_0$) 1 . We can now, as in Eq. (1), perform the expansion using the xed repeated combination of $P_m^{(a)}$ (x) and $P_m^{(b)}$ (x) with the starting guess

The constant is here determined by the in ection point of the repeated xed polynomial combination, e.g. $_{\rm m}$ or (1 $_{\rm m}$) for P $_{\rm m}^{\rm G\,C}$ (x;). The approach can be seen as an asymmetric generalization of the grand canonical M cW eeny purication scheme [21,24,25]. W ith

 P_2^{GC} (x;) they are equivalent. The method is directly related to matrix sign function expansions [23]. The matrix sign function expansion is equivalent to the purication scheme via a trivial linear transform where the step function expansion is performed between 1 and +1 in the interval [1;1].

If the chemical potential is unknown the density matrix m ay have to be recalculated with dierent values of until the occupation is correct. However, since the density matrix can be described as a superposition of outer products of the occupied eigenstates we can adjust the occupation by adding or subtracting Hamiltonian eigenstates close to the chemical potential. A few of these states can be calculated e ciently, for example, using inverse power iterations [28]. In this way the occupation can be adjusted without a complete recalculation of the density matrix with a new shifted chemical potential. Moreover, in the case of a material with a gap we do not need to have a very precise prior know ledge of as long as the estim ate is som ew here in the gap. The grand canonical approach, with a prede ned xed, may thus be an e cient alternative to trace correcting puri cation in som e special cases.

IV . EXAMPLES

To illustrate the e ciency of the expansion techniques we have constructed an N $\,$ N $\,$ H am illustrate the atrix H (i; j) with random ized o -diagonal elements decaying as ji $\,$ jj 2 , and with a uniform distribution of eigenvalues in [0;1]. Only the eigenvalue distribution of the H am iltonian is of importance for the convergence. With H we have that the occupation factor $\,$ = $\,$ N $_{\rm e}$ =N $\,$ = $\,$ and it is easy to compare grand canonical schemes with the trace correcting or trace conserving methods.

Figure 2 shows the number of matrix multiplications necessary to achieve an error jiX n οĦ 10 ⁹ as a function of the lling factor or chemical potential. The PM trace conserving puri cation scheme is slow at low and high occupancy (since the slope at the in ection point tends to 1 as the in ection point approaches 0 or 1), whereas the new trace correcting expansion algorithm, with m = 1 (P_1), m = 3 (P_3), and m = 5 (P_5), has an overall fast convergence. For example, at 10% occupancy the new scheme with m = 3 is about twice as fast compared to the PM scheme. There are essentially three reasons for the improved convergence: i) a more optim ized ratio between the number of matrix multiplications and the polynomial order, ii) a faster increase of the number of vanishing derivatives at the stationary end points, and iii), as will be shown below, a steeper slope at the in ection points, partly due to the asymmetry of the puri cation polynom ials. The generalized grand canonical expansion with m = 3 (P_3^{GC}) converges several steps

faster com pared to the grand canonical M $\,$ cW $\,$ eeny $\,$ (M $\,$ cW $\,$) m $\,$ ethod for the sam e reasons.

V.SCALING

By varying N, i.e. the size of the H am iltonian test matrix, we may see how the number of matrix multiplications necessary for convergence scales with system size, or equivalently with the inverse gap at the chemical potential " = 1=N. The behavior is crucial for very large systems, especially if we wish to construct an expansion scheme that computationally scales linearly with the system size for metallic materials with a vanishing band gap. Figure 3 displays the number of necessary matrix multiplications as a function of ln (N). In the upper graph the results of M cW eeny purication (M cW) and the trace conserving canonical puri cation (PM) are on top of each other. For this particular symmetrical case the two schemes are identical [24]. The graph indicates a stepwise linear relationship between the number of matrix multiplications M necessary for convergence and the logarithm of the system size. The relation can be approxim ated by the linear form ula

The least square ts of M (;N) are shown together with the values of . The expansions P_1 , P_5 and P_3^{GC} perform equally well or slightly worse compared to P_3 , and are not shown. The slopes determ ine the e ciency for very large systems and we not the best scaling for P_3 .

The convergence is determined by the slowest converging eigenvalue (X_0) , closest above or below the chem ical potential of the normalized initial matrix (X_0) . This particular eigenvalue should either converge to 1 or 0. Since the puri cation polynomials are continuously increasing, preserving the order of the eigenvalues, all other eigenvalues converge faster. In the case of grand canonicalpuri cation, with a uniform distribution of N eigen-1=(2N). By means of a linearizavalues, $(N; X_0)$ tion of the puri cation polynomial around it can be shown that $(N; X_0)$ $(kN; X_1)$, where k is the derivative of the purication polynomial at the in ection point, e.g. $k = P_m^{GCO}(m;)$. Thus, increasing the number of states by N = N (k 1) and performing one extra iteration leads to the same error in . If M is the number of multiplications necessary to achieve a xed error of and p is the number of matrix multiplication in one iteration, we have that

for som e constant . This approximate formula explains the linear relation in Eq. (8) and is a useful measure in optimizations of grand canonical expansions. Puri cation polynomials should be optimized on the criterion of matrix multiplications v.s. vanishing derivatives at the stationary xed points, and the slope $_{\rm est} = p (k - 1)^{-1}$ as estimated in Eq. (11). For example, the purication $P_3^{\rm GC}$ (X) requires two matrix multiplications in each iteration, it has three vanishing xed point derivatives, and $_{\rm est} = 3:1$. This should be compared to McW eeny purication that also requires two matrix multiplications in each iteration, but with only two vanishing xed point derivatives, and with a $_{\rm est} = 4:0$.

For m aterials with a band gap, the value 1=N should be replaced by the gap at the chem ical potential ". In this case the scaling with the logarithm of the system size vanishes and the number of necessary matrix multiplication for a prede ned convergence accuracy is constant.

Notice that one may use dierent criteria for convergence such as the error per state, per atom, or the total error. However, this has only a minor e ect on the number of necessary matrix multiplications because of the very rapid rate of convergence close to idem potency, which, for example, is quadratic in the Wow eeny case.

VI.FIRST PRINCIPLES PERFORM ANCE

To further illustrate the perform ance of the expansion scheme we show the result of an implementation in the MondoSCF suite of linear scaling self-consistent eld program s [17,29{31]. Figure 4 displays the number of necessary matrix multiplications for clusters and strings of Liatoms and for dierent molecules. In the case of Li clusters and strings of Liatom s the system s are m etallic in the sense that the gap vanishes in the lim it of in nite number of atoms. This is thus a good test to check the linear relationship between the number of matrix multiplications and the logarithm of the inverse band gap, i.e. the logarithm of the system size for metallic materials. The P_1 scheme is e cient compared to the PM scheme, especially in the case of SiF₄ where the occupancy high. This particular example illustrates the ine ciency of the PM scheme at high and low occupancy which is avoided with the trace correcting algorithm. The weak logarithm ic dependence between computational cost and system size form etallic system s, illustrated by the dashed lines in the gure, is also con med. Notice that an actual linear scaling is reached only if the number of non zero elem ents of the density matrix grows linearly with system size. This can generally not be achieved within a

real-space representation for metallic systems. Instead, as mentioned above, a multi-resolution wavelet basis or a group-renorm alization approach has to be applied. However, the number of matrix multiplication necessary for convergence should not be a ected by a change of representation since the vanishing gap around the chemical potential will remain the same regardless of the representation, given, in the case of a wavelets, via a biorthogonal transform ation of the Hamiltonian [8,9].

The P_1 scheme implemented in the MondoSCF programs has two major advantages compared to other schemes: i) It requires less memory compared to higher order schemes since only second order polynomials are used and intermediate matrix products does not have to be stored. ii) It is less complex and only matrix squares has to be calculated. A specially designed algorithm for matrix squares can possibly be made more e cient than a general matrix product algorithm.

V II. D ISC U SSIO N

The expansion scheme and the convergence analysis illustrated and argued for here provide a basis for the understanding of puri cation algorithms and their eciency, and it shows that the computational complexity, as measured in number of matrix multiplications, essentially is independent of system size even for metallic system s. This is in contrast to, for example, som e conjugate gradient schemes, where in the worst case, the maximal number of iterations was shown to scale as N°, with c varying between 1=3 for insulators and 1 for metals [32]. However, if the additional problem of thresholding is included, which can be performed either via a nite cut-o radius truncation, or via a num erical threshold, the com putational complexity as a function of system size, within som e required num erical accuracy, becom es far m ore difcult to analyze and practical experience m ay be the only way to understand the e ciency.

In the alternative construction of the density matrix using a constrained functional minimization, as devised by Lietal. [11], the M cW eeny purication is used to impose idempotency. The asymmetric polynomial expansions proposed here may serve as a possible alternative.

VIII.SUM M ARY

In sum mary we have proposed an algorithm for expanding the single-particle density matrix in terms of the Ham iltonian that is simple, general, and with a computational complexity essentially independent of system size even for very large metallic systems with a vanishing band gap. If the expansion is used together with a xed them ical potential it was shown to be an asymmetric generalization of the grand canonical Medween y purication.

The algorithm is a substantial in provement of previous schemes and provides together with the presented convergence analysis a framework for the understanding and optimization of purication.




