The O slo rice pile m odel is a quenched Edwards-W ilkinson equation

The O slo rice pile model is a sandpile-like paradigm atic model of \Self-O rganized Criticality" (SOC). In this paper it is shown that the O slo model is in fact exactly a discrete realization of the much studied quenched Edwards-W ilkinson equation (qEW) N atterm ann et al., J. Phys. II France 2, 1483 (1992)]. This is possible by choosing the correct dynam ical variable and identifying its equation of motion. It establishes for the rst time an exact link between SOC models and the eld of interface growth with quenched disorder. This connection is obviously very encouraging as it suggests that established theoretical techniques can be brought to bear with full strength on some of the hitherto elusive problem s of SOC.

The O slo rice pile m odel (O slo m odel hereafter) was originally intended to m odel the relaxation processes in real rice piles [1]. M eanwhile, it has been subject to m any investigations and publications in its own right. The m odel as de ned below supposedly develops into a scale free state w ithout the explicit tuning of external parameters, and is therefore regarded as an example of Self-O rganized C riticality (SOC) [2]. In fact, contrary to m any other \standard" m odels of SOC [3, 4, 5, 6], it shows a reliable and consistent (simple) scaling behavior and is robust against certain changes in the details of the dynam ics [7, 8, 9]. The m ost prom inent observable in the m odel, the avalanche size s, is governed by a probability distribution P (s) which obeys simple scaling,

$$P(s) = s \quad G(s=s_0) \text{ and } s_0 = L^D$$
, (1)

where L denotes the system size and and D are critical exponents, consistently reported to be = 1:55(10) and D = 2:25(10) [7, 8, 9, 10, 11, 12]. These two exponents are related by D (2) = 1 [10, 11], which can be proven easily given that the rst moment of P (s), hsi, scales like L.

In the following the model is dened, the relevant dynamical variable extracted and its equation of motion derived, which turns out to be a discretized quenched E dwards-W ilkinson (qEW) equation. By analyzing the essential characteristics of the model on the lattice, such as uniqueness of the solution and symmetries, it is then possible to construct the continuum theory, which can subsequently be examined using standard methods.

The model [10] is defined on a one dimensional grid of size L, where each site i = 1 L has slopenzed critical slope $z_i^c 2$ f1;2g. Starting from an initial conguration with $z_i = 0$ and z_i^c random everywhere, the model evolves according to the following update rules: 1) (Driving) Increase z_1 by one. 2) (Toppling) If there is an i with $z_i > z_i^c$ decrease z_i by 2 and increase its nearest neighbors by one, $z_{i-1} + 1$, provided that 1 i 1 L. A new z_i^c is chosen at random, 1 with probability p and 2 with probability q 1 p. 3) Repeat the second step until $z_i = \frac{1}{2}$ everywhere. Then proceed with the first step. The order of updates is irrelevant in this model and the original definition does not x it explicitly. Therefore the microscopic (fast) timescale is a priori unde ned.

The avalanche size s is de ned as the number of charges, i.e. apart from boundary e ects, twice the number of times the second rule is applied between two consecutive application of the rst rule. For convenience the model is dissipative on both boundaries, where one of the two \units" lost by the boundary site during toppling leaves the system.

A few years ago Paczuski and Boettcher translated the O slom odel into the language of interfaces in random media [11]. However, the evolution of the dynam ical variable H (x;t), which is the total number of topplings of site x, was given by $@_tH = (@_x^2H (x;H))$, where @ is de ned in discrete time, i.e. $@_tH H (x;t+1) H (x;t)$ and @ is the lattice Laplacian, so that x is actually an index. The last term (x;H) represents a quenched noise. The Heaviside

-function makes this equation of motion highly nonlinear and analytically almost intractable [13]. Paczuski and Boettcher have already conjectured that the O sho model is in the same universality class as qEW [14]. More recently, A lava has suggested that certain other sandpile models are described by qEW [15]. It is, how ever, im portant to realize that no rigorous and exact link has so far been established between SOC models and the qEW equation.




FIG.1: Each site can be in one of three states and changes stepwise between them, whenever it receives a charge. The labels indicate the probability of the move and whether it entails a toppling.

The crucial step to make this correspondence exact is to identify the proper dynam ical variable. It is found in the form of the number of times a site has been charged (i.e. received a unit from a neighbor during a toppling or by external drive, see below) h (x;t), where x and t are discrete for the time being. There is a simple functional relation between h (x;t) and H (x;t), which can be obtained as follows: Each site can be in one of three stable con gurations, $z_1 \ge 0;1;2$. When a site receives a unit from a neighbor, it changes state as shown in Fig.1. Charging a site in state 0

necessarily leads to state 1 without toppling and the speci c value of z_i^c is completely irrelevant at this stage. Sim ilar for state 2: If a site receives a charge in this state, its z_i^c must be 2 and it must topple. The only point where the value of z_i^c actually matters, is in state 1, therefore it can be e ectively chosen at random when necessary, so that the site topples with probability p (according to the probability of having $z_i^c = 1$) or increases to 2 with probability q (see Fig.1). It is immediately clear that any even number of charges, say m = 2n, starting from $z_i = 1$ leads to state 1 again with n topplings. An odd number of charges, say m = 2n + 1, leads either to n topplings and state 2 or n + 1topplings and state 0. This is illustrated in Fig.1: The m charges lead to m steps along the arrow s. W henever one m oves left, the site topples.

In order to write a functional relation between h(x;t) and H(x;t), the random ness in the decision of moving to the left or to the right from state 1 m ust be quenched in h(x;t), i.e. it is not allowed to change unless h(x;t) changes. This can be sum marized as

$$H(x;t+1) = \frac{1}{2}(h(x;t) + (x;h(x;t))), \qquad (2)$$

where is 0 whenever h(x;t) is even, corresponding to state 1. If h(x;t) is odd, is either 1 (with probability p, state $z_i = 0$) or 1 ($z_i = 2$). Every sequence of (x;h) values maps uniquely to a sequence of z_i^c and vice versa. The equation above can easily be transformed to comply to any initial con guration, especially to $z_i(t = 0) = 0$. Essentially, it is (2), which makes the exact identication of the 0 slom odel and gEW possible.

The nalequation is derived by noting that obviously h(x;t) = H(x - 1;t) + H(x + 1;t) with appropriately chosen boundary conditions (BC's) (see below), so that using the short hand notation h = h(x - 1;t) and = (x - 1;h) the equation of motion is

which is the exact representation of the 0 sb m odel as de ned above, captured in a single equation. Its di erential form is accordingly

$$\theta_{t}h(x;t) = \frac{1}{2}\theta_{x}^{2}h(x;t) + 1 + \frac{1}{2}\frac{d^{2}}{dx^{2}} \quad (x;h(x;t)) .$$

The right hand BC is h(x = L + 1;t) = 0 (and h(x = L;t) = 0 in the continuum), while the left hand BC provides the driving via h(x = 0;t) = 2E(t), E(t) being the total number of initial seeds (step 1 above) at time t. These seeds arrive at site x = 1 via the Laplacian. In the continuum, the simplest drive is E(t) = vtw ith v a driving velocity and t the m icroscopic time. Together with the BC's, Eq. (4) or the generalized form

where the correlator of is now normalized, i.e. R = R around R = 1, describes the movement of an elastic band over a rough surface [16] pulled by a transverse force acting at one end point only. Below it is shown that the -term disappears in the continuum, establishing the rst rigorous identication of the O slo model and the qEW equation. The same equation with di erent properties of the noise term and/or di erent BC's applies to other models, such as the BTW model [17], Fixed Energy Sandpiles (for example [18]) or the tilted sandpile [19]. Having identi ed the relevant dynam ical variable h, the e ect of modi cations of the dynam ical rules of the O slo model, such as [7, 8, 9], can be understood.

The equation above exemplies a general trick [29] to get rid of -functions in equations of motion | they often appear in descriptions of sandpile-like systems (for example [13]): One simply replaces (h b) by h + (h) with

an appropriately chosen saw tooth-like . This does not necessarily simplify the problem, unless there is already a quenched noise present in the system. In this case the turns into a correlation in . This is highly remarkable from the point of view of SOC, because the presence of \thresholds" is usually expected to be a crucial ingredient of SOC [2, 17, 20]. Moreover, the correlations in , which are of fundam ental signi cance in interface models [14, 21] and have been neglected in form erm appings, now arise naturally from the dynam ical description of the model.

In order to construct the proper continuum theory, it is worthwhile to consider the form all solution of Eq. (5). It will turn out later that E (t) = vt is su ciently general, so that it makes sense to de nev(x) $v \frac{L}{L}$ and

in order to hom ogenize the BC's. $P_3(x)$ is a third order polynom ial only present to cancel the rst term in the di erential equation, i.e. $(\ell_x^2 P_3 = 2v(x))$, with roots at x = 0 and x = L. Therefore $(\ell_t z = \ell_x^2 z + g(x;h(x;t)))$ with hom ogenous BC's. The term (x;h(x;t)) $(1 + \frac{d^2}{dx^2})(x;h(x;t))$ is actually a functional of h. The initial condition of z(x;t) is not z(x;t=0) 0 as for h, because of the data shift above. But due to the hom ogenous BC's any initial condition decays, so that the initial sources, accounting for $z(x;t=0) = P_3(x)$, can be ignored. Then the form al solution is $z(x;t) = \prod_{n=1}^{1} z_n(t) \sin(k_n x)$ with

and $k_n = \frac{n}{T_1}$.

A coording to Eq. (6), the tilt of h(x;t) in x increases in time. Assuming stationarity of the relevant statistical properties (especially avalanches as de ned below), this requires the solution to be invariant under tilt, which is also known as Galilean invariance [22]: $h^0 = h + x$ must produce the same statistics as h, which entails (x;a + x) to be equally likely as (x;a), so that h (x;a + x) ($x;a^0 + x^0i = h$ (x;a) ($x;a^0$)i. But assuming the standard form [14] h (x;a) ($x;a^0$)i = $_k(x x^0)$; (a d), the correlator obeys for any x x⁰ where $_k(x x^0)$ is nite, $_2(a d) = _2(a d + (x x^0))$. This holds for any , so if $_k(x x^0)$ was nite for any x $x^0 \in 0$, $_2$ would be bound to be a constant. This is impossible, because $_2$ must be non-vanishing som ewhere and norm alizable, so that $_k(x x^0)$ must vanish for any nite x x^0 , i.e. it must be a -function.

Next it can be shown that the 0 sb model obeys M iddleton's no-passing [23]. For \notin 0 this will lead to a constraint on the noise which is incompatible with the correlation of $_{k}$ in the continuum, so that must vanish in the continuum. Defining a partial ordering for two consumptions h_{1} (t_{1} ;x) and h_{2} (t_{2} ;x) of the interfaces as h_{1} (t_{1} ;x) h_{2} (t_{2} ;x), 8_{x2} ($_{0;L}$, h_{1} (t_{1} ;x) h_{2} (t_{2} ;x), one has to show that this order is preserved under the dynamics [24]. With the vector and edd being the BC's E₁ (t) and E₂ (t), one shows that if h_{1} (t_{0} ;x) h_{2} (t_{0} ;x) for a given t_{0} (which entails E₁ (t_{0}) E_{2} (t_{0})) the interfaces can never vertake each other at t t_{0} . By assuming the opposite, one only needs to prove that where the two interfaces \touch" for the rist time, x_{0} , the velocity of h_{1} is higher or equal to the velocity of h_{2} . For the model on the lattice (3), this is equivalent to

 $h_1^+ + \frac{1}{1} + h_1 + \frac{1}{1} + h_2^+ + \frac{1}{2} + h_2 + \frac{1}{2}$ (8)

using the same notation as in (3). In the original discrete model, condition (8) follows immediately from (x;h) + h being a monotonically increasing function in h for any x. For the continuum equation (5) the corresponding calculation gives

assuming that $\frac{d^2}{dx^2} = \varrho_x^2 + \varrho_x h \varrho_x \varrho_h + \varrho_x h \varrho_h \varrho_x + \varrho_x^2 h \varrho_h + (\varrho_x h)^2 \varrho_h^2$ and that the interface is smooth in x_0 such that $\varrho_x h_1(x_0;t) = \varrho_x h_2(x_0;t)$ and $\varrho_x^2 h_1(x_0;t) > \varrho_x^2 h_2(x_0;t)$. For a noise with divergent width, $_k(x) = (x), Eq.$ (9) cannot hold for any \notin 0, i.e. a non-vanishing destroys no-passing. However, no-passing must be regarded as a crucial feature, as it ensures the asymptotic uniqueness of the conguration and is reminiscent of the irrelevance of the order of updates in the original model, so that = 0 is a necessary condition for the equivalence of the continuum and discrete model.

This is physically justified: A ssum ing a smooth , in the continuum approximation of Eq. (3) becomes proportional to the square of the lattice spacing and therefore vanishes in the continuum limit.

K exping the term nevertheless, a nave scaling analysis shows that it is irrelavant. Moreover, its Fourier transform in Eq. (7) produces only a term $g k_h^2$, because of the total derivative in . This can be absorbed into the bare

propagator of a perturbative expansion in the style of [14, 21] in the form $\frac{2g(1-k_n^2)}{L(k_n^2+i!)}$, leading possibly to an ultraviolet divergence. A part from that, the term s obtained for an renormalization group treatment are structurally the same as in [21] as calculations show (details to be published later). The only di erences are due to the peculiar way of driving the interface (i.e. the term 2v(x), which is a mean velocity in (6), but also drives the model by moving the quenched noise in (7)) and the non-conservative nature of the interface (which makes sense only for a nite system) leading to the hom ogenous BC's and therefore to the sin ($k_n x$) rather than exp (2i $k_n x$) term s. In turn, the standard qEW problem [14] corresponds to an 0 slo m odel with periodic BC's and continuous, uniform drive.

Expanding in powers of z_n , the rst two terms of z_n (!) (the Fourier transform of (7) in t) are:

where (x;q) is the Fourier transform of (x;h) in h.

The denition of the avalanche sizes in the continuum is the area between the interface congurations at two times t_1 and t_2 , $s = \begin{bmatrix} R_L \\ 0 \end{bmatrix} dx (h(x;t_2) = h(x;t_1))$, so that hsi = v tL with t t_2 t_1 , because hz(x;t) is expected to be asymptotically independent of t, as a non-vanishing $\lim_{t \ge 1} e^{t_1} e^{t_1}$ (k;t) is with hom ogenous BC's would require support for a divergent curvature of the interface. Choosing h tv constant for dierent system sizes L then preserves the property hsi / L.

Due to the asymptotic uniqueness of the solution the system can either be driven in jumps of h separated by su ciently long times, or driven very slow ly taking \snapshots" of the con guration in order to calculate s.

The model possesses two characteristic timescales: One is the di usive timescale t_0 L^2 , the other one is the non-trivial scale due to noise and drive, t_g $g^2 = (v^3L)$. One has to maintain a su ciently large t to prevent distinct avalanches from merging, otherwise the central limit theorem would turn P (s) into a Gaussian. The SOC limit is usually identieed with v ! 0, which makes sense only in the presence of an intrinsic scale for v. The only combination of parameters (, g and L, but = 0) which provides a \natural velocity" is v_g (g^2)¹⁼³=L. The SOC condition v ! 0 is therefore already met by v v_g / L ¹, which is how ever, not su cient. A coording to Ref. [11] t L ^z with z 1:42, so that h = const. entails v L ^z, which therefore seem s to be the correct condition for SOC, even though the microscopic timestep in [11] is de ned as a parallel update, which is not exactly (3).




FIG. 2: C om parison of a data collapse according to (1) for system sizes between L = 128 and L = 512 and the continuous and the discrete realization of the model. The same value of = 1.55 collapses all curves within each model onto its scaling function. D ue to the om ission of the non-universal constants in Eq. (1) the two resulting curves are shifted relative to each other.

P relim inary num erical studies indeed suggest that (5) with = 0 is a valid continuous description of the O sho m odel: Fig. 2 compares a scaling collapse for di erent system sizes of the continuous m odel (with = 0) and the original, discrete one. The best collapse is obtained by = 1:55 for both m odels. The scaling law D = 1 + [11] remains applicable as long as the two con gurations at t_1 and t_2 are correlated. It is in perfect agreement with num erical results [25, 26] for the qEW m odel [30].

In conclusion, the O slo m odel has been reduced to a quenched E dwards W ilkinson equation. In the continuum lim it the qEW becomes the exact equation of m otion for the O slo m odel. This not only makes it possible to approach the exponents of an SOC-m odel analytically, but also gives insight into the nature of avalanche like behavior and the relation between SOC and other theories of critical phenomena. It provides the perfect test bed for analytical m ethods proposed for SOC.

The established relationship is presently being pursued in order to develop a direct approach to the critical exponent

, clear up the rôle of the noise and clarify the relation between noise and drive. The fram ework used here is also prom ising for other models, such as the BTW model [17], various other sandpile models [18, 19] and the Zhang model [27].
