T im e scales in shear banding of worm like m icelles

A bstract. { We show the existence of three well de ned time scales in the dynamics of worm like micelles after a step between two shear rates on the stress plateau. These time scales are compatible with the presence of a structured interface between bands of di erent viscosities and correspond to the isotropic band destabilization during the stress overshoot, reconstruction of the interface after the overshoot and travel of a fully form ed interface. The last stage can be used to estim ate a stress di usion coe cient.

Introduction. { Depending on the type and concentration of surfactant molecules and added salt, solutions of surfactant worm like m icelles have shear thinning or thickening behavior under shear ow . Unlike m ost uids, worm like m icelles offen have non-analytic ow curves with sharply-selected plateaus along which strain rate or stress may change discontinuously. In the well docum ented case of shear thinning solutions the usual explanation of the constant stress plateau is shear banding $[1{3}]$, i.e. a separation of the material into bands of di erent viscosities, triggered by a constitutive instability (such as an isotropic-to-nem atic transition [2]). As shown recently $[8\{12]$, the stress selection and history independence of shear banding can be explained using the inhom ogeneities of the relevant m esoscopic order param – eter (polym er stress), i.e. by incorporating \di usive" term s in the constitutive equations. Order parameter di usion was introduced long time ago by van der W aals in the so-called \gradient theory" of the gas-liquid interface [7], and is obligatory in phase eld models for pattern form ation. Notwithstanding a few attempts to deal with inhom ogeneous stresses [6] the same concept has not obtained full acceptance in the rheological community. While one m ight argue that di usion terms are negligibly small, these non-perturbative terms resolve stress selection even for in nitesim al values [11]. How ever, a sm all di usion coe cient should also in ply a slow approach to steady state; the main purpose of this letter is to dem onstrate these long time scales experimentally and relate them to simple model di usive behavior.

Shear banding involves spatial inhom ogeneity and several tem poral stages. Light polarization probes the localm icellar orientation, while rheology detects the molecular stress. In this

work we shall calculate the stress transients using a theoretical model. This will be compared to birefringence measurements that are assumed to probe the state of molecular orientation and hence stress (but see Ref. [13]) Rather than the typical start-up transient experiment, we consider the simpler experiment of a step between two xed values of the shear rate in the banded regime. Small steps should induce less drastic changes in the uid while still remaining in the non-linear regime, and hopefully yield more controllable results. The transient features will be shown to be intimately related to the dynamics of the interface between the bands.




Fig.1 { Stages and characteristic times (in units): a) total stress during the step $_= 10 ! 20 s^{1}$ for CTAB/KBr; b) simulated total stress during the step $_= 1:4= ! 2:8=$ using the d-JS model; c) Extinction angle during the step $10 ! 20 s^{1}$ for CTAB/KBr.

Experiments. { The surfactant solutions used are summarized in Table I. The stress response was measured using an RFS R heom etrics Scienti c controlled strain rate rheom eter in Couette (radii 245;25mm) and cone-plate geometries. Linear response is of the M axwell type with alm ost identical relaxation times and moduli G_0 for the three solutions. In the non-linear regime the coexistence plateau width __ for solution 3 is larger than for solutions 1 and 2, while solutions 1 and 2 have a sloped stress plateau that roughly follows a power ไลพ _, with . 0:1; a slope could indicate concentration di erences between coexisting states [14]. Upon a step increase of the shear rate between banded states the stress increases to a maximum, and then decreases monotonically (or sometimes by a small undershoot and a monotonic increase). Three relaxation times (1 10⁻s, 2 10 1 s and 310s) follow successively after the overshoot until steady ow is reached (Fig. 1a). The 100 three time scales are well separated and the result is reproducible for all solutions and both cone-plate and Couette geometries. We In ed the step shear rate experiment for the third

solution in a Couette geom etry with a slightly larger gap (radii 24;25mm) between crossed polarizers to extract the average extinction angle . The kinetics of resemble that of the shear stress, displaying time scales sim ilar to the second and the third time scales found in the rheology (Fig.1c). The rst, unresolvable, time scale is shorter than the interval between successive video frames. The second time scale is well resolved, although shorter by a factor of two than the equivalent time in the stress rheology measurements. The third time scale is buried in noise and regression does not provide signi cant results.

Theory. { The momentum balance is $(\theta_t + v + r)v = r + T$; where is the uid density and v is the velocity eld. The stress tensor T is given by T = pI + 2D + r, where the pressure p is determined by incompressibility (r + v = 0), is the \solvent" viscosity, is the \polymer" stress, and D is the symmetric part of the velocity gradient tensor (r + v) = 0v. The non-New tonian \polymer" viscoelastic stress is assumed to obey the di usive Johnson-Segalman (d-JS) model [9],

where is the anti-sym metric part of r v, $= G_{\circ}$ is the \polymer" viscosity, is a relaxation time, and D is the di usion coecient. The \slip parameter" a (describing the non-a nity of the deformation) is necessary to reproduce a non-monotonic constitutive curve, and the added di usion term was shown to resolve stress selection [9].

The initial dynamics is governed by inertia; within a very short time $_{\rm M}$ = L^2 = ($_{\rm M}$ = 10⁴ s for = = 0.01m²s¹ and a gap L = 1mm) m on entum di uses across the gap and the m on entum balance becomes T = const. The subsequent slower dynamics is controlled by the viscoelastic response of the uid. In a planar geometry with v = v(y)\$, our constitutive m odel leads to a system of reaction-di usion equations(¹):

where _ is the shear rate, $S = _{xy}$, and W is a combination of the polymer norm al stresses, $_{xx}$ and $_{yy}$. S;W are the order parameters of the transition (S is small in the nem atic (N) band, and large in the isotropic (I) band). They can di use across stream lines with di usion coe cient D, and relax in the linear regime within the linear (M axwell) time . The non-linear reaction term s C_S = _(G_o W) and C_W = _S can be straightforwardly derived from Eq. (1) [8,10].

where = . The dynam ics of Eq. 2 can be understood with the aid of two (local) dynam ical system s:

where S- @S=@t. System (4a) describes the dynam ics along a stream line at prescribed shear rate; in this case changes proportionately to S according to Eq. (3). System (4b) describes the dynam ics along a stream line at constant total stress .

 $^(^{1})$ Any non-monotonic di erential constitutive model (e.g. Cates [17], Doi-Edwards [15,16]) with di usion term s leads to a similar equation set.




Fig. 2 { a) R elaxation times to I and N attractors at constant stress, I; N. b) Thick line: theoretical ow curve (the negative slope, unstable branch should be replaced by the constant stress plateau). Thin lines: trajectories of the coexisting bands near the walls. fs_ig; i = 1;3 are the starting points of the three stages discussed in the paper.

The two dynam ical systems have the same xed points (since, for hom ogeneous steady ow, _ and are related by Eq. 3): stable xed points (attractors) representing the bands I and N, and an interm ediate unstable saddle xed point. Coexistence of bands at common total stress is possible only for 2 [1();2()]. Linearizing systems (4a) and (4b) about the xed points yields the dominant relaxation times of the attractors, I and N. These are di erent for the two dynam ical systems, denoted at constant shear rate by I,N. For the JS model I = N = for all_. N is close to , while I is larger than N and diverges as ! 2() (Fig. 2a). This divergence is consistent with R ef. [5]: controlled stress experiments have much longer relaxation times on the m etastable extension of the high viscosity branch above the constant stress plateau.




Fig.3 { Simulation of the order parameter proles for the three stages (s: start, e: end): a) destabilization ($0 < t < t_1$); b) reconstruction ($t_1 < t < t_2$); c) travel ($t_2 < t < 1$).

Consider an initial banded steady state, with average shear rate h_i. Suddenly increasing the average shear rate to $_2 > h_i$ produces a stress overshoot because the amount of high viscosity I band is too large; both I and N bands then become unstable, and the stress can decrease by producing more of the low viscosity N m aterial. Num erical simulation (Figs.1, 3) shows that this occurs in three stages:




Fig. 4 { $CTAB/KBR: _= 10$! 30s¹ jump: birefringence in ages and proles (averaged between the two vertical lines on the lm) corresponding to the second time scale, showing the interface reconstruction. The moving (inner) cylinder is at r = 1.0 and the xed (outer) cylinder is at r = 0.0.

2. Interface reconstruction | At the end of stage 1 the interface separates an unsteady I band close to the unstable saddle point from a nearly stable N band. The part of the pro le closer to the I attractor will evolve toward this one, while the other part approaches the N attractor. This reconstructs the interface in a more advanced position, stabilizes the bands, and increases the contrast between them . Interestingly, there is a spatial position at which S and W practically remain xed at their saddle xed point values. During this stage h_i is constant (because it is in posed) and hS i is alm ost constant (because of the compensating evolutions of the two bands), so according to Eq. (3) the total stress variation is sm all, and the characteristic time (controlled by the I band) is $_2$. This time exceeds the linear (see Fig. 2), and depends on how close the stress at the end of stage viscoelastic tim e 1 is to the spinodal limit $_2$ (), and on the quantitative details of the curve in Fig. 2, all of which are sensitive to the constitutive model. The analysis suggested by the num erical experiment is con med by the birefringence measurements. The sequence of images in Fig. 4 show the gap of the Couette cell In ed between crossed polarizers during stage 2. Although we can not quantitatively compare Figs. 3b) and 4 (the relation between the transmitted intensity and the order parameter is unknown and sure to be non-linear), the sharpening of the contrast corresponding to the interface reconstruction is visible. The di erence between the characteristic times for the extinction angle and rheology (Fig.1) could be due to the di erent Couette cell gap widths.

3. Interface travel | The instability and reconstruction of the interface in the rst two stages is ensured by the reaction term s of the Eq. (2), ending when a sharp interface between stable bands is fully form ed. This interface could have a non-zero velocity if it forms in at a position corresponding to a stress value above or below the plateau stress . \Front propagation" over the small distance toward the nal equilibrium position is then controlled by D (this distance is too small to observe by birefringence). Because of the undershoot in the num erical simulation the sign of the displacement during stage 3 is opposite to the one in the rst stages (Fig.3c). The characteristic time $_3$ for this stage follows from the velocity c of the sharp interface close to steady state which is independent of the presence or absence of the undershoot [10] (see below).

Let us consider a single sharp interface, at a position r inside the gap. At in posed shear rate, the lever rule $h_i = \frac{r}{L} \frac{N}{r}$ () + $(1 \frac{r}{L})^{-1}$ () relates and r and leads to

and obeyed well by the JS m odel).

We showed previously that the velocity c of the interface is a function of the total shear stress only, and that c = 0 when = [8,10] which via the lever rule corresponds to a unique stable interface position r. Thus, close to this position r the equation of motion of the interface is:

Using Eqs. (5,6), and the derivative $\frac{d}{dc} = K G_0^p \frac{p}{D}$, we not the solution $r = (r(0) - r)e^{t=3}$, with characteristic time

where the dimensionless constant K depends on the particular constitutive m odel.

Eq. (7) in plies that a fully form ed interface equilibrates faster in systems with larger plateaus _, such as CTAB/KBr. In such cases, Eq. (5) in plies larger stress variations and thus larger interface accelerations for the sam e position variation. This is compatible with the shorter $_3$ in Table I. For simplicity, Eq. (5) was for a planar geom etry; in cylindrical C ouette ow a slight correction (negligible for the thin gaps we consider) leads to a sm aller $_3$.

Using the experimental value of $_3$ and Eq.7, we can estimate D. In order to do this we need the value of K. In the JS model, while G₀ and are measurable, the two free parameters and a determine the function K. Nevertheless, G₀ _= = f₁(), _T= _= f₂() and K = ($_{q}$ _) = $_{f}$ () are functions of only, given to a good approximation (> 80%) by $f_1() = \frac{4}{3} \quad \frac{1=8}{1=2}$, $f_2() = \frac{p}{(1 \ 8)(1 \ 2)+1 \ 8}$, $f_3() = \frac{3}{8} \, ^2f_1()$. From either f_1 , or f_2 and experimental data, one can estimate (the average of the two values is given in Table II) and then f_3 gives K (Table II). Thus we do not need the value of a. M icroscopically, we expect D = 2 = where is the stress correlation length. In dilute solutions this should be the micelle gyration radius [6], while in concentrated solutions a reasonable candidate is the mesh size , which can be estimated from G₀ $kT = ^3$. The results are presented in Table II.

The stress correlation length is of order the mesh size, which is reasonable; how ever there is still no theory for such a di usive term in concentrated solutions.

To conclude, a general dynam ical system s analysis of the d-JS m odel provides plausible explanations for the observed time scales, and consistent estimates of the stress di usion coe cient D. N evertheless, neither the d-JS m odel, nor reptation-retraction-reaction m odels [16,17] can provide perfect ts of transient stress curves in the nonlinear regime. A lso, it it conceivable that concentration di erences between the bands could in uence the observed time scales. The di erence of the values of D between sam ples 1,2 and 3 (Table II) could be a concentration e ect, consistent with the di erent slopes of the ow curves plateaus (tilted for 1,2, alm ost horizontal for 3).
