Resonant X -ray Study on the Bi-Layered Perovskite M n O xide LaSr₂M n₂O₇

C harge and orbital ordering behaviors in the half doped bi-layered compound LaSr₂M n₂O₇ have been studied by resonant and non-resonant X-ray scattering. Three di erent order param eters, which correspond to the A-type antiferrom agnetic, a charge and an orbital ordered states, were observed by m easuring the m agnetostriction and the superlattice peaks characterized by wavevectors $(\frac{1}{2}, \frac{1}{2}, 0)$ and $(\frac{1}{4}, \frac{1}{4}, 0)$, respectively. The superlattice relations indicating the charge and orbital ordered states were observed below 210 K. Both the intensities reach a maximum at 160 K on cooling and become very weak below 100 K. The peak width of the charge ordered state agrees with that of the orbital ordered state at all tem peratures studied. These results indicate that both the states originate from a single phase and that the charge/orbital ordered islands with de nite interfaces disperse in the A-type antiferrom agnetic phase. The dim ensionality of the charge/orbital ordered phase is discussed using this model.

KEYW ORDS: charge order, orbital order, X-ray scattering, layered structure

1. Introduction

Am ong various properties which transition m etal oxides exhibit, especially drastic phenom ena are the high T_c superconductivity and the colossal magneto-resistance (CMR).CMR has been found in som e doped m anganese oxides:¹⁾ An extremely large drop of the resistivity is induced by a magnetic eld which is very small in terms of the energy scale. Through recent intensive studies of CMR, it has become recognized that uctuations tow ard a orbital-and charge-ordering state and their collapse by a magnetic eld play important roles in $CMR_{I}^{(2)}$ which idea is based on a hom ogeneous system . On the contrary, one of the recent theoretical studies³⁾ proposes that inhom ogeneities have colossale ects in transition m etaloxides and that CMR can be explained by coexistence of m etaland insulator phases. In either case, CMR and charge-ordering phenom ena are considered as results from complex interactions among charge, spin and orbital degrees of freedom of electrons.³⁽⁵⁾ However, the m icroscopic mechanism of CMR, orbital ordering and charge ordering are not yet fully understood.

W e have been studying the stability of charge ordering as a function of the structural dimensionality.^{6,7)} C learly, various properties of m anganese oxide system s depend upon their structural dimensionality. For instance, let us compare La_{1 x} Sr_xM nO₃ (LSM 0 113), La_{2 2x} Sr_{1+2x}M n₂O₇ (LSM 0 327) and La_{1 x} Sr_{1+x}M nO₄

(LSM 0 214). Structurally, LSM 0 113 is an in nite layer system thus three dimensional, and LSM 0214 is a single layer system thus two dimensional. LSM 0 327 is a bi-layer system, which is in between two and three dimensional structures. A round half doped (x = 0.5), LSM 0214 undergoes orbital ordering and charge ordering at low temperature,^{8,9)} while LSM 0113 remains metallic¹⁰⁾ LSM 0 327, on the other hand, exhibits a phase coexistence of a charge ordered state, an orbital ordered state and the A-type antiferrom agnetic (A-type AF) state.¹¹⁾ M oreover, LSM 0 327 shows extremely large CMR phenom ena when the doping rate is reduced from x = 0.5,¹²⁾ though LSM 0.214 rem ains insulating.⁷⁾ In the present paper, we focus on the charge and orbital ordering behaviors in the half doped bi-layered com pound $LaSr_2M n_2O_7$, and report our com prehensive studies using resonant and non-resonant X -ray scattering techniques.

The resonant X -ray scattering (RXS) technique is so far the only way to detect a long-range ordered state of a local sym m etry around a speci c elem ent. This elem entspeci c sensitivity provides an evidence for a charge and an orbital orders. In addition, this technique costs relatively short tim e (about several hours per one condition) without requiring special conditions such as a low sam ple tem perature, thus allow s us to measure under various conditions. A lthough X -ray structural analysis can also clarify the local sym m etry of arbitrary atom in a crystal, the data collection costs several days or m ore.

The known properties of the half-doped compound $LaSr_2Mn_2O_7$ are summarized as follows: The crystal space group is I4=mmm with the tetragonal lattice constants a = 3.874 A and c = 19.97 A at room temper-

ature. The resistivity¹³⁾ becomes large between 100 K and 210 K and below 50 K, and exhibits a large therm alhysteresis around 120 K. The origin of the tem perature dependence between 100 K and 210 K is considered as a charge order. In this tem perature region, a transverse distortion wave with the modulation vector $(\frac{1}{4}\frac{1}{4}0)$ was observed by electron di raction.^{13,14)} The distortion wave was attributed to an orbital order and is consistent with the CE-type bond con guration proposed by Goodenough¹⁵⁾ for charge ordered cubic perovskites. Neutron scattering experiments¹¹ show that the (003) magnetic scattering, which corresponds to the A-type AF order, coexists with $(\frac{3}{2},\frac{3}{2},1)$ nuclear scattering, which is interpreted as the scattering from lattice distortion due to a CE-type charge order, below the N celtem perature T_N^A = 210 K. It is also reported that a CE-type AF order em erges at T_N^{CE} = 150 K and that this m agnetic order and the charge order alm ost vanish below Τт. 75 K but clear CE -type m agnetic scattering peaks were observed even at 15 K .RXS m easurem ents by W akabayashiet al.6) show that the correlation length for the CE-type charge order in this compound is identical with that for the orbital order, while, in LSM 0214, the correlation length for the orbital order is longer than that for the charge order.⁷⁾ A rgyriou et al.¹⁶⁾ reported the phase coexistence at 125 K from a high-resolution X -ray di raction measurement. They also observed a lattice distortion characterized by the wavevector $(\frac{1}{4}\frac{1}{4}0)$ and obtained the corresponding crystal structure at 160 K by structure analysis using only superlattice re ections. The superlattice re ections do not disappear com pletely even at 10 K. They attributed the remaining intensity at low temperature to extrinsic e ects. On the other hand, Chatterjiet al.¹⁷⁾ reported the tem perature dependence of the rem aining scattered X -ray intensity, which is sm aller than 1 $\%\,$ at 10 K com pared w ith that at 170 K but 6 tim es larger than that at 50 K. They thus proposed a reentrance of the charge order.

There still remain two problems despite the intensive studies mentioned above. One is that the vanishing of the orbital and charge ordered phase at low tem perature is not understood. The other is that the interpretation of the observed sm all intensity below 50 K is controversial. The main results of the present paper are sum marized as follows: (i) the charge order and the orbital order in this compound are two di erent characters of the same phase, (ii) the structure determ ination of the orbital/charge ordered phase corresponding to the modulation vector $(\frac{1}{4}\frac{1}{4}0)$ and $(\frac{1}{2}\frac{1}{2}0)$ is dem onstrated, (iii) the tem perature dependence of the observed peak widths for the orbital/charge order can be understood in term of a phase segregation, and (iv) our experim ental result does not show the reentrant charge order though the statistic error of our measurements is as small as that of Chatterji et al¹⁷⁾ and our result is consistent with high-resolution X -ray scattering study by A rgyriou et al.¹⁶⁾

2. Experim ent

2.1 Resonant X -ray scattering m ethod

The detection of a charge order and an orbital order is made possible by the following mechanism. RXS is a method to detect the change in the anom alous dispersion of an ionic form factor.^{6(8,18(22)} The essence of observing an orbital state by this technique is that the local sym – metry of an anisotropic form factor can be regarded as that of the corresponding valence electron orbital. The form factor f is closely related to the 1s-4p transition probability, where is fx;y;zg. The transition probability from 1s to 4p depends on the angle between the

-axis and the polarization vector of the incident X -rays as well as the di erence between the energy of incident X-ray and the 1s-4p transition energy, E E_a: For exam ple, X -rays with the polarization vector parallel to the x-axis produce only the 1s-4p_x transition and E_{q}^{y} and E_{α}^{z} do not a left the form factor for this case. This dependence makes the form factor anisotropic when E_{a} is anisotropic. An isotropic change in E $_{\rm g}$ is caused by a change in the valence of a M n ion, and an anisotropic change in E_{α} is caused by a change in the orbital state of a M n ion or the surrounding crystal eld. Since f is related to the 1s-4p transition, f has a sharp bend at E_{q} , and it can be expressed as f (E Eq) approximately. Destructive interference among scattering waves from ions having di erent E_{α} 's, E_1 and E_1 + , produces the am $plitude f[f(E E_1) f(E E_1)] = g$ ′ @f=@E because is expected to be small. Therefore, the bend of f at E_q in plies that the scattering intensity from the di erence in E_g has a sharp enhancement at E_g . The intensity from the anisotropy of a form factor depends on the rotation angle around the scattering vector called azim uthalangle , because the e $\operatorname{ect} \operatorname{ofE}_{g}$'s on f varies with the angle between the polarization vector and the -axis. Therefore the azim uthal angle dependence of the

intensity re ects the orbital state or the sym m etry of the crystal eld.

2.2 X-ray scattering of LaSr₂M n₂O₇

X-ray di raction measurements were performed at beam lines BL1B and BL16A2 of the Photon Factory, KEK, Tsukuba. BL1B, which is dedicated to powder di raction measurements, was used for measurements of the lattice constants. This beam line is equipped with a bending magnet, an X-ray beam from which is monochromatized at the wavelength of 0.7081 A by a at double-crystal Si (111) monochromator and focused

on the sample position by a Rh coated bent cylindrical m irror. The spot size at the sample position is 0.5mm (vertical) 0.7mm (horizontal). X -rays scattered from a pow der sample, which is typically encapsulated in a glass capillary of 300 m in diam eter, are detected by a curved im aging plate. BL16A 2 has a multi-pole w iggler as the light source, producing a linearly polarized X -ray beam. A standard four-circle di ractom eter is installed there for single crystalm easurem ents such as RXS studies. The incident X -rays are collim ated by the rst m irror then m onochrom atized by a sagittal focusing doublecrystals Si (111) m onochrom ator which resolution is 1 eV for the incident energy near the M n K -edge, 6.555 keV. The beam is focused vertically on the sample position by the second m irror, which elim inates the higher harm onics component. The spot size is 0.7 mm (v) 1.5 mm (h). An ion chamber and a scintillation counter were used as a beam m onitor and a signal detector, respectively. C losed-cycle H e refrigerators were used for tem perature control at both these beam lines.

The absorption correction wasm ade for all the E -scan because the absorption coellicient drastically changes at E_g 6:555 keV. The correction wasm ade using the absorption factors of La, Sr, O²³⁾ and the average of measured f⁰ for M n³⁺ and M n⁴⁺ ions. The value of f⁰ for M n³⁺ and M n⁴⁺ are obtained by measuring the absorption spectra of LaSrM nO₄ and Sr₂M nO₄, respectively. The signal intensity depends on the azim uthal angle when the form factor is anisotropic. We denot the scattering plane. All the measurements except for the azim uthal angle scans were made at = 90 giving a maximum intensity of RXS.

A polarization analyzerw as used to measure the polarization of the scattered X-ray. From now on, we de ne polarization as a polarization which vector is or а perpendicular or parallel to the scattering plane. The absence of the component in the Thom son scattering with the analyzer scattering angle 2 $_{\rm A}$ = 90 is used for the polarization analysis. A Cu 220 single crystal was used for the polarization analysis because it gives a scattering angle of 2 $_{\rm A}$ = 95:6 when the incident photon energy E is set at the Mn K -edge. We de ne a polarim eter angle $\prime_{\rm A}$ as an angle between the scattering plane for the sample and that for the analyzer crystal. The $\prime_{A} = 0$ and the $\prime_{A} = 90$ con gurations extract polarization and the polarization components, the respectively.

A single crystal of $LaSr_2M n_2O_7$ was grown by the oating-zone method. The (110) and (100) surfaces were prepared for this study. The sam ple surface was polished using emery paper before each nun. Thus the sam ple conditions for di erent nuns were not identical. The typical half-width at half-maximum (HW HM) of the rocking curve was 0.1. The pow der sam ple was prepared by grinding a portion of the single crystal.

3. Results

3.1 Lattice Constants




Fig. 1. Lattice constants a and c as functions of the tem perature. Solid line shows the calculated value from the the A-type AF order parameter.

The lattice constants a and c obtained from powder X-ray di raction measurements are shown in Fig.1 as functions of temperature. They have no signi cant hystereses with changing temperature. The temperature dependence of the lattice constant c is dom inated by a sim – ple therm alexpansion. In contrast, the lattice constant a has a characteristic N " shape temperature dependence. Note that the lattice constant c increases 0.45% with increasing temperature from 10 K to 300 K while the lattice constant a increases only 0.09%. The characteristic tem – perature dependence of the lattice constant a is brought into prom inence by the sm all therm al expansion. This N " shape is caused by magnetoelastic coupling, which

we will discuss later in detail. The temperature dependence of the lattice constants is extremely dierent from that of the superlattice intensity.

3.2 Temperature Dependence of Superlattice Re ections




Fig. 2. Peak pro les of (110), $(\frac{3}{2}\frac{3}{2}0)$ and $(\frac{5}{4}\frac{5}{4}0)$ re ections at 170 K with E = 6.555 keV along (a) the [110] direction and (b) the [001] direction. The pro le for the [001]-direction consists of three peaks, re ecting that the sam ple is com posed of three dom ains.

As described in Sec.1, there appear two types of superlattice re ections at low tem peratures, namely the $\frac{1}{4}\frac{1}{4}0$) and $(\frac{1}{2}\frac{1}{2}0)$ type re ections, which correspond to the orbital ordering (00) and charge ordering (C0) in the CE type model, respectively. Both types of superlattice reections were observed by RXS at E = 6.555 keV in the tem perature region between 100 K and 210 K. Typical results of longitudinal and transverse scans at 170 K are shown in Fig. 2. The widths for the [110] and the [001] directions of the superlattice re ections are nearly equal. to those of the Bragg re ections, which are limited by the instrum ental resolution and the mosaicity of the crystal: the resolution lim it of this experim ent was about 2500A. The pro le along the [001] direction consists of a main peak and two sm all peaks, which indicates that the sam ple has three dom ains in the beam spot area. Pro les along [001], i.e., !-scan pro les, varied slightly in di erent spots and di erent runs. W e thus mainly focused on ! -2 scans, which are free from dom ain distributions, for m easuring the peak widths in the present study.




Fig. 3. (a) Tem perature dependence of the intensities of the $(\frac{3}{2},\frac{3}{2},0)$ and $(\frac{5}{4},\frac{5}{4},0)$ superlattice re ections with E = 6.555 keV. The $(\frac{5}{4},\frac{5}{4},0)$ intensity is multiplied by 3.2 so as to be directly compared with the $(\frac{3}{2},\frac{3}{2},0)$ intensity. The superlattice re ections are enhanced between T_L and T_N . (b) Tem perature dependence of the inverse peak widths, i.e., the correlation lengths or dom ain sizes l, for the charge order(circles) and the orbital order(triangles) calculated from the peak widths of the $(\frac{3}{2},\frac{3}{2},0)$ and $(\frac{5}{4},\frac{5}{4},0)$ superlattice re ections. (c) Tem perature dependence of the peak width of the (110) B ragg re ection. The width is broad between T_L and T_N . R. L.U. stands for reciprocal lattice unit.

We have focused upon $(\frac{5}{4}\frac{5}{4}0)$ and $(\frac{3}{2}\frac{3}{2}0)$ for the $(\frac{1}{4}\frac{1}{4}0)$ type 00 peak and the $(\frac{1}{2}\frac{1}{2}0)$ type CO peak. Temperature dependence of the two peaks is shown in Fig. 3(a). Note that the $(\frac{5}{4}\frac{5}{4}0)$ intensity is multiplied by 32 so as to be directly compared with the $(\frac{3}{2}\frac{3}{2}0)$ intensity. Both

the intensities have a similar temperature dependence and a large hysteresis around 120 K. Both the superlattice re ections appear at 210 K on cooling and reach a maximum at 150 K, then decrease with further cooling. The maximum was observed at 170 K on heating. At 10 K , both the intensities decrease to approxim ately 1% of the maximum values though the peak widths are as narrow as that of the Bragg re ection. These rem anent peaks correspond to the 00 and C0 phase because they com pletely disappear above 250 K. As for $(\frac{5}{4}, \frac{5}{4}, 0)$, the intensity and width show no tem perature dependence below 90 K for heating and 50 K for cooling. This result is consistent with ref.16, which reported no tem perature dependence of the $(\frac{7}{4}\frac{9}{4}0)$ intensity in this tem perature range. However, ref. 17 reported that the $(\frac{5}{4},\frac{3}{4},0)$ intensity is tem perature dependent in this region. We thus studied $(\frac{5}{4}\frac{3}{4}0)$ and con med that the temperature dependence is similar to that of $\left(\frac{5}{4}\frac{5}{4}0\right)$. The origin of this re ection will be discussed later.

To extract the correlation lengths of the 00 and CO peaks, we subtracted the remanent intensities at 10 K from the data below 150 K. The peak proles were tted with a G aussian function convoluted with the instrum ental resolution. Thus obtained peak widths are shown in Fig. 3 (b) in the form of the inverse width, which corresponds to the domain size 1 or the correlation length

along the [110] direction. As shown in Figs. 3(a) and (b), both the $(\frac{5}{4}\frac{5}{4}0)$ and $(\frac{3}{2}\frac{3}{2}0)$ peaks have sim ilar tem – perature dependence of the intensities and widths. The width of the (110) B ragg re ection is shown in Fig. 3(c)

as a function of temperature. The width was found to become broad in the temperature region in which the superlattice rejections are enhanced.

3.3 Energy Dependence of Superlattice Re ections




Fig. 5. Schem atic view of the reciprocal space at 150 K with E = 6.555 keV for (a) hk0-plane and (b) hk1-plane. C losed diamonds and closed circles denote the observed B ragg and superlattice re ection, respectively, and the open circles denote the position where the no intensity was observed. These peaks form $2 \ \overline{2} \ \overline{2} \ 1 \ (a_1 * b_1 *)$ and its tw in, $\overline{2} \ 2 \ \overline{2} \ 1 \ (a_2 * -b_2 *)$, reciprocal lattice with system atic extinction h + 1 = 2n, which indicates a B-base centered lattice. The reciprocal lattice points for both tw ins are denoted by the symbols and +.

To determ ine the unit cell of the CO/OO phase, we searched for superlattice re ections in the (hhl), (hk0) and (hk1) planes at 170 K. The results are sum m arized in Figs. 4 and 5. The results indicate the unit cell of this phase is a b, 2a + 2b, and c, where a, b and c are the basis vectors of the structure at room tem perature. Since the crystal system at room temperature is tetragonal_bthis^{*} 2 2 2 1 structure is twinned with the 2^{1} 2 2 1 structure. The reciprocal lattice points for the intrinsic two dom ains are illustrated in Fig. 5 as crosses and plus signs. The peak position shows the system atic extinction h + 1 = 2n, which indicates a B-base centered lattice. Figure 6 shows the E-dependence of the intensities of selected superlattice re ections. A sexpected for the CO and OO phase, the peak intensities of the superlattice re ections at $\frac{b}{4}\frac{5}{4}0$, $(\frac{1}{2}\frac{1}{2}0)$ and $(\frac{3}{2}\frac{3}{2}0)$




Fig. 4. Schem atic view of the reciprocal space at 170 K with E = 6.555 keV.C losed rectangles and closed circles represent the observed B ragg and superlattice re ections, respectively, and the open circles represent the position where the superlattice re ections are expected to be observed. The measured region is shown by the gray line.

are enhanced near the M n K -edge. How ever, the $(\frac{5}{4}\frac{3}{4}0)$ re ection, which was ascribed to a reentrant charge ordering in ref. 17, show s no enhancem ent. This lack of the enhancem ent and sim ilarity to the (110) energy dependence denote that this peak is mainly caused by displacem ents of M n ions. We have carried out som e m odel cal-




Fig. 6. Energy dependence of the integrated intensity of (a) $(\frac{5}{4}\frac{5}{4}0)$, (b) $(\frac{3}{2}\frac{3}{2}0)$, (c) $(\frac{1}{2}\frac{1}{2}0)$, (d) (110), (e) $(\frac{5}{4}\frac{3}{4}0)$ and (f) $(\frac{3}{2}\frac{1}{2}0)$ re ections at 170 K with = 90 . The absorption correction wasmade using the average of measured f⁰⁰ for M n³⁺ and M n⁴⁺ ions and absorption factor of La, Sr, O²³⁾. Calculated intensity is also shown by solid lines in the panels (a)–(c).

culations of the energy dependence using the values of $f^{(0)}$ experimentally determined from LaSrM nO₄ and $f^{(0)}$ obtained by the K ramers-K ronig transformation of $f^{(0)}$. We found that the energy dependence of the $(\frac{5}{4}\frac{5}{4}0)$ intensity is proportional to $j \ell f = \ell E j$ as shown in Fig. 6(a). On the other hand, as shown in Figs. 6(b) and (c), the $(\frac{1}{2}\frac{1}{2}0)$ and $(\frac{3}{2}\frac{3}{2}0)$ intensities are described as $j \ell f = \ell E + C j$ where C is an amplitude of a real number. The nite C is ascribed to the displacement of oxygen induced by the valence and orbital states of the M n ions. M ore detailed analyses on these results are described in x 4.1.

3.4 Polarization and Azim uthal Dependence of Superlattice Re ections




Fig. 7. Polarim eter angle dependence of the B ragg and the superlattice intensity at 170 K with = 90 . Solid line and dotted line show the calculated values for - and polarization, respectively. The maximum value of each data set is normalized to unity.

W e m easured the polarization dependence of selected (hh0) re ections. Figure 7 shows the results as a function of the polarim eter angle '_A. The solid and dotted lines in the gure denote calculated intensities for the - and the polarizations, which indicate that the $(\frac{1}{4}\frac{1}{4}0)$ -type re ection (00) has the polarization while




Fig. 8. A zim uthal angle dependence of the intensity of several superlattice re ections. The solid lines for $(\frac{3}{2}\frac{3}{2}0)$ and $(\frac{1}{2}\frac{1}{2}0)$ show the results of the tting to $A + B \sin j^2$ and that for $(\frac{5}{4}\frac{5}{4}0)$ the tting to $A \sin j^2$.

the $(\frac{1}{2}\frac{1}{2}0)$ -type rejection (CO) has the polarization as Bragg rejections. The rotation of the polarization shown in this gure is caused by the anisotropy of a scattering factor. The anisotropic scattering factor also makes the azim uthal angle dependence of the scattering intensity. The azim uthal angle dependence of the (hhO) superlattice rejections is shown in Fig. 8. The intensity of the $(\frac{1}{2}\frac{1}{2}0)$ -type rejections is normalized by the intensity at an o -resonant energy (E = 6.45 keV) to make an accurate correction for the sample shape. The $(\frac{5}{4}\frac{5}{4}0)$ intensity is normalized by the (110) Bragg intensity because the $(\frac{5}{4}\frac{5}{4}0)$ rejection has no intensity at o -resonant energies. The azim uthal dependence of the $(\frac{5}{4}\frac{5}{4}0)$ and $(\frac{1}{2}\frac{1}{2}0)$ -type




Fig. 9. The intensity at $(\frac{3}{2}\frac{3}{2}0)$ superlattice re ection for several E's. The solid curves for each plots show the results of the tting to $jA + B \sin j^2$.

intensities can be tted to \sin^2 and $jA + B \sin^2 f$ (A and B are real numbers), respectively. A zim uthal angle dependence of the $(\frac{3}{2}\frac{3}{2}0)$ at selected energies (four different energies) is shown in Fig. 9. These results have

the intensity m axim a at = 90. This result indicates that changing the incident energy causes little change in this dependence.


4. D iscussion

4.1 Structure of the O rbital O rder

In this section, we demonstrate the structure determ ination of the orbital order, referring to the extinction rule and the azim uthal angle dependence of the intensity. The peak widths of the superlattice re ections in the c*direction at 170 K are nearly equal to the widths of the Bragg re ections, which are limited by the instrum ental resolution and the mosaicity of the crystal, as shown in Fig. 2. This result indicates that the charge and orbital orders have long range correlations in the c-direction. It gives contrast to the result for the single layer com pound $La_{0:5}Sr_{1:5}M nO_4$,⁷⁾ which shows a short range correlation along the c-direction. This suggests that the magnitude of the inter-layer interaction of the bi-layered com pound is di erent from that of the single-layered compound. The inter-layer interaction is closely related to the structure of the orbital order in the c-direction.

A sm entioned above, the unit cell of the orbital ordered phase has the dimensions $2a \ 2 \ 2a \ c$. A sthe origin of the anisotropy of the scattering factor, two mechanism s have been proposed; the C oulom b mechanism $^{21,22)}$ and the JT mechanism $^{24(26)}$ In the former, the anisotropy of the form factor is attributable to the C oulom b interaction between 3d and 4p electrons. The latter, on the other hand, the anisotropy is regarded as the band effect due to the lattice distortion, which is caused by the anisotropy of the eg-electron density through the Jahn-Teller e ect. In either case the anisotropy of the scattering factor is considered to re ect the anisotropy of the eg-electron density due to the orbital ordering.

W e assume that each layer in a double $M nO_2$ sheet has the same orbital structure and the whole structure is formed by stacking of such layers with certain intraand inter-bilayer stacking vectors. This assumption is reasonable because the $M nO_2$ planes are crystallographically equivalent at room temperature and there is no superstructure in the c-direction. B ased on this assum ption, we will consider the orbital structure, that is, the spatial arrangement of M n⁴⁺ and two kinds of M n³⁺ (M n_A³⁺ and M n_B³⁺). Possible structures in a M nO₂ plane having an area of 2a 2 2a are shown in Figs. 10 (a)-(c). The polarization property of the superlattice re ection shows that the M n³⁺ site is on a re ection plane perpendicular to the c-axis; The details of this assignment will be shown in the next section. This symmetry

requires that the form factors for M n_A^{3+} and M n_B^{3+} are equal at = 0. The structure factor of the $(\frac{1}{4}\frac{1}{4}0)$ -type re ection is proportional to $f_1 + if_2$ f_3 if_4 , where f_1 denotes the form factor of M n ion num bered i in F ig.10 (a). For the structure (a), the structure factor is poportional to the di erence between the form factor of M n_A^{3+} and that of M n_B^{3+} . The intensity of $(\frac{5}{4}\frac{5}{4}0)$ at = 0 is zero as shown in F ig.8. This result indicates the structure factor of the $(\frac{1}{4}\frac{1}{4}0)$ -type re ection is zero at = 0, therefore the structure in the plane is (a). Unlike this, for the structures (b) and (c), the structure factor of $(\frac{1}{4}\frac{1}{4}0)$ -type re ection contains the di erence between the form factor of $(\frac{1}{4}\frac{1}{4}0)$ -type re is no condition in which the form factor of M n^{3+} equals that of M n^{4+} .

Next, let us consider the stacking structure, which consists of an intra-bilayer stacking and an inter-bilayer stacking. The possible intra-bilayer stacking vectors are (A) (0,0,0,18), (B) (1,0,0,18) and (C) (1,1,0,18), which are shown in Fig. 10(d), and those for the inter-bilayer stacking are (D) $(\frac{1}{2}, \frac{1}{2}, \frac{1}{2})$, (E) $(\frac{1}{2}, \frac{1}{2}, \frac{1}{2})$ and (F) $(\frac{3}{2}, \frac{1}{2}, \frac{1}{2})$, which are shown in Fig. 10(e). We have concluded that the intra-bilayer stacking vector is (A), because the (B)-and the (C)-stacking cause the absence of $(\frac{2n+1}{2}, \frac{2n+1}{2}, 0)$ and $(\frac{2n+1}{4}, \frac{2n+1}{4}, 0)$ re ections, respectively. The interbilayer stacking vector is (E), because, as mentioned in x 3.3, the B ravais lattice of this com pound is B -centered orthorhom bic. M ore specify, (D)-stacking makes the

 $(\frac{5}{4},\frac{5}{4},1)$ re ection, which were not observed, and (F)stacking results in the absence of $(\frac{1}{4},\frac{1}{4},0)$. Consequently, it was found that the orbital structure of this compound is Fig. 10 (a)-type structure with the stacking vectors (A) and (E). The intra-bilayer stacking is same as the stacking of cubic perovskite compounds with the CE-type order, such as Nd₁₌₂Sr₁₌₂M nO₃ and Pr₁₌₂Ca₁₌₂M nO₃. This implies the cubic- and bi-layered perovskite com – pounds have a common interaction which induces the orbital order.

The E -dependence of the intensity shown in Fig.6 can be explained from the stacking vectors (A) and (E). The structure factors for this $2 \ 2 \ 2 \ 1$ structure at $(\frac{1}{2}\frac{1}{2}0)$ and $(\frac{3}{2}\frac{3}{2}0)$ with = 90 are

where f^{n+} and f_0 are the form factor of the M n^{n+} and the oxygen, respectively, and is the breathing mode displacement of the oxygen atoms. The solid lines in Figs.6(a) and (b) are the results of the tting to these equations. The experimental results are well reproduced.

4.2 Anisotropic Scattering Factor Tensor at 170 K

The element of the scattering factor tensor f , where are x; y; or z, is brought about by the process and that an electron excites from 1s to 4p and relaxes from 4p to 1s. In the ATS scattering, we have to deal with an ellipsoid of scattering function, which has three principle axes in the reciprocal space. Thus, when the Mn site has an inversion symmetry, one can chose a certain coordinate to make the scattering factor tensor a diagonal tensor. In bi-layered com pounds, M nO 6 is alm ost a regular octahedron so that the form factor tensor is approxim ately diagonal. A regular octahedron has three fourfold rotation axes, six twofold rotation axes and four threefold rotation axes. A principal axis of the form factor is expected to coincide with one of them . If we choose a threefold axis as a principal axis of the tensor, the scattering with polarization is not expected on the [110]*axis for any orbital structure. This is the reason for the existence of the re ection plane on the M n^{3+} site which was used in the previous section. Thus, the principalaxes are (i) the three fourfold rotation axes x, y and z, or (ii) a fourfold rotation axis x^0 and the two twofold rotation axes y^0 and z^0 , which are perpendicular to the x^0 axis. We denote the principal value of the scattering factor tensor for the principal axis as f. The incident, scattered element of the structure factor tensor at $(\frac{5}{4}\frac{5}{4}0)$ for the set (i) is ($f_y = f_x$) sin \cos and for the set (ii) is $\frac{1}{2}(f_{y^0} + f_{z^0} 2f_{x^0}) \sin \cos + \frac{p_1}{2}(f_{y^0} f_{z^0}) \cos(2) \sin$. The experim ental result shows that the intensity is proportional to \sin^2 , which agrees with the expectation from the set (i). Therefore, we choose the set (i) as the principal axes of the scattering factor tensor for this com pound.

scattering factor tensor. As shown in Figs.8 and 9, the $(\frac{n}{2}\frac{n}{2}0)$ intensity has maxima at $m_{ax} = 90$, which are independent of n and E. The structure factors for the polarization are

and those for the polarization are sm all.²²⁾ T hese structure factors are same as eq.(1) and eq.(2) when we substitute $(f_x + f_y)=2$ for f^{3+} and for 90 . Let us recall that the f can be written in the form f (E Е_а) approxim ately. It suggests that the azim uthal angle dependence should be explained by the anisotropy of the absorption-edge energy. To reproduce the experim ental results, the value of E_{α}^{z} has to be larger than the average of E_{α}^{x} and E_{α}^{y} . A possible origin of the anisotropy of E is not only the e ect of the e electron, such as Coulomb interaction or Jahn-Teller distortion, but also the layered structure.²⁷⁾ In fact, it is known that the EXAFS spectra for some layered compounds are highly anisotropic.28) Although the origin could not be determ ined from this experim ent, a theoretical analysis show s the e ect of the layered structure is dom inant 27 .

4.3 Tem perature dependence of the lattice constants

The unusual tem perature dependence of the a-lattice constant can be understood in term softhe m agnetoelastic coupling corresponding to the A-type AF order. The t_{2g} spins, which have a greater part of the m om ent are localized. The magnetoelastic e ect of localized moments causes m agnetostriction proportional to the square of the ordered m om ent size, $^{29,30)}$ which is proportional to the intensity of the neutron magnetic scattering. Thus, the change of the lattice constant at T_N is expected to be proportional to the magnetic scattering intensity corresponding to the A-type AF order. For this compound, the result of the magnetic scattering measurement was reported in ref.11 and we use it for our analysis. The calculated a-lattice constant is shown in Fig. 1 as a solid line. The non-magnetic lattice constant a₀ at temperature T is assumed to be $a_0(T) = T + a_0(0)$, where

and $a_0(0)$ are obtained from the therm al expansion above T_N . The magnitude of the magnetoelastic e ect was treated as a tring parameter. The calculated value shows a good agreement with the experimental results. As a consequence, the temperature dependence of the lattice constant is understood by taking into account only the e ect of the A-type AF order. Neglecting the CE-AF for above discussion is valid because the result of the neutron magnetic scattering indicates that the fraction of the A-type AF order is vertimes as large as that of the CE-type AF order.¹¹⁾ The temperature dependence of the lattice constant is very di erent from that of the intensity of the superlattice re ection. This difference means the existence of more than two di erent order parameters and suggests a phase coexistence. The broadening of the (110) Bragg relection around 150 K shown in the inset of Fig. 3 (b) also supports the occurrence of the phase coexistence.

4.4 Tem perature Variation of the Charge Order and the Orbital Order

The intensity of the superlattice re ection is proportional to the volum e fraction of corresponding phase and the inverse of the peak width gives the dom ain size lor correlation length . Here, the order param eters of the charge and orbital orders are expected to be constant because other half-doped cubic perovskitem anganites show sharp rst order charge/orbital ordering transition.^{19,20} The order in the cubic perovskites are similar to that in LSM 0 327 in terms of its stacking structure or correlation length. The correlation length of the charge ordered phase in Pro:6Ca0:4M nO3 diverges toward the ordered tem perature:²⁰⁾ this behavior is very sim ilar to that of the LSM 0 327 around 210 K. The charge order transition of the half-doped LSM 0 214 is not a sharp one, but the order in this compound is dierent from that in LSM 0 327 in term of correlation length. In LSM 0 214, the correlation is always short ranged.

The temperature region with enhanced superlattice re ections coincides with that for a large resistivity I^{13} hence the excess resistivity is ascribed to the charge order. The peak width in the charge ordered phase agrees with that in the orbital ordered phase at all tem peratures studied, though these two widths are not necessarily equal: Di erent peak widths for these orders were observed in $Pr_{1 x} Ca_{x} M nO_{3}^{20}$ and LSM $O214_{7}^{6}$ whose charge order and the orbital order structures are same as that of LSM 0 327. The present result can be explained by two di erent models; That is, (A) of the charge ordered phase coincides with that of the orbital ordered phase, or, (B) the peak width re ects the size of the ordered dom ain which consists of the charge and orbital ordered phase. The model (A) implies that such accidental coincidence is realized at all the tem peratures measured, which is implausible. The model (B) does not have such an unreasonable assumption. This model implies that a domain which is orbitally ordered is also chargely ordered, i.e., the charge order and the orbital order in this compound originate from a single phase; we thus call this phase the charge/orbital ordered phase. Therefore, in this compound, there are only two phases though it seems that there are three phases (charge ordered phase, orbital ordered phase and the A-type phase) at rst sight. This model also im plies that islands of the charge/orbitalordered phase with de nite interfaces disperse in the A-type phase. This phase coexistence is consistent with the above results showing two di erent order parameters, which correspond to the A-type and CE-type, de ned by the magnetostriction and superlattice peaks respectively.

Next, we consider how the charge/orbital ordered islands grow or melt in the A-AF phase below 150 K. As mentioned above, l corresponds to the domain size in this system. Thus, it is expected that the inten-

sity of the superlattice re ection, which is the volume of the charge/orbital ordered state, is proportional to N $\mathbb{I}^{\mathbb{P}}$ where N is the number of the ordered islands and D denotes the dimensionality of the growing or melting. If we assume that N is conserved as tem perature varies, the volum e fraction of the ordered phase is proportional to \mathbb{P} . Results of thing the tem perature dependence of the superlattice intensity with $(A_h l_h)^3$ or $(A_c l_c)^3$, where A_h and A_{c} are the scaling parameters, are shown in Fig. 3 with the solid and dashed lines, respectively, The tting results are very good. We tried thing with $D_{h(c)} = 2$ and 4, but they produce worse agreem ent. Thus the experim ental result indicates that the value of D is three in the melting and growing processes of the ordered phase between 100 K and 150 K; The result D = 3 coincides with the expectation from the Landau free energy with a surface tension term . A_h can be norm alized to unity because the intensity is represented in arbitrarily units, and the norm alized A_c is 0:89. The sm all deviation of A_c from unity indicates that alm ost all the dom ains are not divided by cooling. This deviation is ascribable to the correlated sm all charge/orbital ordered dom ains which were made by dividing a large dom ain on cooling.

5. Sum m ary

Resonant X-ray scattering measurements have been performed on $LaSr_2M n_2O_7$ to elucidate the charge and the orbital ordering. We have observed anisotropic form factor of Mn ion near the K-absorption edge. The structure determ ination of the charge/orbital order was dem onstrated using the extinction rule and the anisotropy of the form factor. The anisotropy of the form factor indicates that the energy level of 4pz is higher than that of in-plane $4p_x$ and $4p_y$. This electronic structure is attributable to the orbital ordering of equectrons and the layered structure of the compound. The temperature dependence of the lattice constant is ascribed to the magnetoelastic e ect in the A-type AF phase while the superlattice re ections com e from a long-range order of charge and orbital in the CE-type AF phase. The correlation length for the charge order is same as that for the orbital order, while the two lengths are, in general, not related. The results indicate the coexistence of the A-type AF phase and CE-type AF phase. M oreover, the grow th and melting of the charge/orbitalorder were observed, showing the dimensionality of the order is three dim ensional.
