Twist of cholesteric liquid crystal cellwith substrates of di erent anchoring strengths

Abstract

We consider director con gurations of cholesteric liquid crystal (CLC) cells with two plane con ning substrates. Exact solutions of the Euler-Lagrange equations for out-of-plane orientations of the easy axes that correspond to inhom ogeneous conical structures of CLC director are derived. We study dependence of the CLC twist wavenum ber on the free twisting num ber assuming that anchoring energies at the substrates are either equal or dierent. In both cases this dependence is found to be generally discontinuous with hysteresis loops and bistability elects involved. For CLC cells with identical substrates and planar anchoring conditions the jump-like behaviour only disappears in the weak anchoring limit. Contrastingly, when the anchoring strengths are dierent, there is the nite value of anchoring below which the dependence becomes continuous. A nother elect is the appearance of the gap between the adjacent twist wavenum ber intervals representing locally stable director con gurations. We calculate the critical value of anchoring asymmetry and present the results of numerical calculations.

1 Introduction

In equilibrium cholesteric phase molecules of a liquid crystal (LC) align on average along a local unit director \hat{n} (r) that rotates in a helical fashion about a uniform twist axis [1, 2]. This tendency of cholesteric liquid crystals (CLC) to form the helical twisting pattern is caused by the presence of an isotropic molecules with nominor plane | the so-called chiral molecules (see [3] for a recent review).

The phenom enology of CLCs can be explained in terms of the Frank free energy

where K₁, K₂ and K₃ are the splay, twist and bend Frank elastic constants. As an immediate consequence of the broken mirror symmetry, the expression for the bulk free energy (1) contains the chiral term proportional to the chiral strength parameter h. This parameter gives the equilibrium value of CLC twist wavenumber, $q_0 = h=K_2$, which corresponds to the pitch $P_0 = 2 = q_0$. In what follows the parameter q_0 will be referred to as the free twist wavenumber or the free twisting num – ber. So, if the twist axis coincides with the z-direction, the director eld $\hat{n} = (\cos qz; \sin q_0 z; 0)$ denes the equilibrium con guration. Since \hat{n} and \hat{n} are equivalent in liquid crystals, periodicity of the spiral is given by the half-pitch, $P_0=2$.

Typically, the pitch P_0 can vary from hundreds of nanom eters to m any m icrons or m ore, depending on the system. The m acroscopic chiral parameter h (and thus the pitch) is determined by m icroscopic interm olecular torques [4, 5] and depends on the m olecular chirality of CLC consistuent m esogenes. In experiments it can be in uenced either by variations in therm odynamic parameters such as temperature or by introducing impurities.

So far we have seen that the twisting number of the ideal helical director con guration in unbounded CLCs equals the free twisting number q₀. This is no more the case in the presence of boundary surfaces or external elds that generally break the translational symmetry along the twisting axis. The case of planar CLC cell bounded by two parallel substrates exemplies the simplest con ning geometry and is of our primary concern in this paper.

D irector con gurations in the CLC cellare strongly a ected by the anchoring conditions at the substrates, so that, in general, the helical form of the director eld will be distorted. Nevertheless, when the anchoring conditions are planar and out-of-plane deviations of the director can be neglected, the con gurations still have the form of the helical structure which twist wavenum ber, q, di ers from q. D ependence of the twist wavenum ber q on the free twisting number q_0 has been previously studied in Refs. [6, 7, 8] and was found to be discontinuous. In Refs. [9, 10] this jump-like behaviour was shown to manifest itself in abrupt changes of selective transm ission spectra with temperature. D i erent mechanisms behind temperature variations of the pitch in CLC cells have been discussed in recent papers [11, 12].

Theoretical results of Refs. [6, 7, 8, 9, 10, 11, 12] are related to the CLC cells placed between two identical substrates and the corresponding anchoring strengths were taken to be equal. In this paper we consider CLC cells with di erent anchoring energies at the con ning surfaces. In particular, we nd that su ciently large asymmetry in anchoring strengths will render the dependence of the twist wavenum ber on q_0 continuous.

The paper is organized as follows.

D irector con gurations within CLC cells are analyzed in Sec.2. Using the one-constant approxim ation we derive exact solutions of the Euler-Lagrange equations. These solutions are expressed in terms of the Jacobian elliptic functions and correspond to inhom ogeneous conical orietational structures. The case of the planar anchoring conditions is considered in Sec. 3 where we present both analytical and num erical results about the dependence of the twist wavenum ber on the free twisting num ber. Concluding remarks are given in Sec. 4.

2 Orientational structures in CLC cell

We consider director congurations in a CLC cell of thickness 21 sandwiched between two parallel plane substrates located at z = 1 and z = 1, so that the z-axis is normal to the conning surfaces. We shall also assume that the symmetry with respect to in-plane translations is unbroken and the director eld describing orientational structures does not depend on the coordinates x and y. Its parameterization in terms of the angles and is taken in the form:

Substituting the parameterization (2) into Eq. (1) and using the one-constant approximation, $K_i = K$, we have the following expression for the bulk free energy per unit area:

where the prime stands for derivative with respect to z.

In order to specify the anchoring conditions at the boundary surfaces z = 1 in terms of the anchoring strengths W and the vectors of easy orientation \hat{e} we shall write the surface contribution to the free energy as an anchoring energy taken in the form of Rapini-Papoular potential:

The phenom enological anchoring parameters W characterize the strength of interaction between CLC molecules and the surfaces, while the preferred orientation of the molecules at the substrates is de ned by the easy axes \hat{e} .

2.1 Solutions of the Euler-Lagrange equations

The free energy functional (3) only depends on the derivative 0 , so that the corresponding Euler-Lagrange equation can be integrated to yield the following equation:

where c is the integration constant. Variation of the functional (3) with respect to will give the second Euler-Lagrange equation that can be simplied by using Eq. (5). The result is as follows




Figure 1: Real-valued solutions of Eq. (9) exist only if the integration constants c and d de ne a point in the c-d plane that is above the curves: $d = c^2 + 1$ at jcj > 1 (solid line) and d = 2jcjat jcj = 1 (dashed line).

The rst integral of Eq. (6) is not di cult to nd and is given by

where d is the integration constant. From Eqs. (5) and (6) we have the bulk free energy in the form Z

We can now proceed with solving Eq. (7) that can be conveniently rewritten in the form :

where $2c = d = \frac{p}{d^2} + \frac{1}{4c^2}$. This equation will have solutions only if the values of c are nonnegative and do not exceed the unity, 0 c 1. This immediately places the restriction on the parameter d: d max(2jcjc² + 1). Fig. 1 shows this region in the c-d parameter plane.




Figure 2: Dependencies of (= 2ql) on $_0 (= 2q_0l)$ at $W = W_+ W$ for various values of the dimensionless and oring energy parameter w (= W = K): (a) strong and oring limit, w ! 1 ; (b) w = ; (c) w = =2; (d) w = 0.25.

In the upper part of the region, $d > c^2 + 1$, we have $c_+ > 1$ and solutions of Eq. (9) can be expressed in terms of the Jacobian elliptic functions [13] as follows

where $a^2 = 1$ c, $b^2 = c_+$ c, $m = b^2 = a^2$ and $_0$ is the integration constant. Below the parabola $d = c^2 + 1$, where $2jcj < d < c^2 + 1$ and $c_+ < 1$, these solutions are given by

In addition, there are how ogeneous solutions that are independent of z: $\sin = \frac{P}{1 c}$ and $\sin = \frac{P}{1 c_{+}}$ (at $c_{+} < 1$). These solutions correspond to a conical helix in which the director makes an oblique angle with respect to the helix axis. There are no spatially varying solutions at




Figure 3: The curves representing the plot of the function $_+$ () and () are shown as thick solid and dashed lines, respectively. The points located at the intersection of the curves and the horizontal straight line $=_0$ give the roots of Eq. (23). The value of $_0$ is (10+1=2) (thin solid line) and is (10+1=2) w (thin dotted lines). Two cases are illustrated: (a) w₊ = w = w = =2; (b) w = 10:0, w₊ = 2:19, w = =2 (see Eq. (30)).

the boundary of the region depicted in Fig.1. In this case the pretilt angle does not depend on z and we have (

G iven the pretilt angle as a function of z, integrating of Eq. (5) will give the azim uth angle :

where $_0$ is the twisting angle in the middle of CLC cell.

In order to compute the integration constants $c, d, _0$ and $_0$ we need to know the boundary




Figure 4: The free energy f_+ (solid line) and f (dashed line) of stable con gurations with the half-turn numbers between 10 and 14 as a function of $_0$ computed from Eq. (24) by using Eq. (23) for various values of the anchoring energy parameters (a) w = =2; (b) w = .

conditions. The standard variational procedure will yield the following result:

where $\hat{n} = (\sin ; \cos ; 0)$ and $\hat{n} = (\sin \cos ; \sin \sin ; \cos)$.

3 Pitch wavenum ber versus free twisting num ber

In this section we consider the simplest case of an ordinary spiral director conguration in which the pretilt angle equals zero, $\sin = 0$ and $d = c^2 + 1$. This case occurs when the anchoring conditions are planar and both of the easy axes are parallel to the con ning surfaces. We direct




Figure 5: Dependencies of on $_{0}$ calculated at w = 10.0 for various values of the parameters (= 2w w_{+} = (w w_{+})) and w (see Eq. (30)): (a) w = (= 11.8 and w_{+} = 3.705); (b) w = = 2 (= 5.6 and w_{+} = 2.19); (c) = 1.0 (w_{+} = w_{c} = 0.476); (d) = 0.5 (w_{+} = 0.25).

the x-axis along the vector \hat{e} , while the easy axis at the upper substrate is rotated through the angle $\hat{e}_{+} = (\cos ; \sin ; 0)$.

From Eq. (13) we have

where $q = q_0 (1 + c)$ is the twisting wavenum ber. The boundary conditions (14) can be conveniently rewritten in the form :




Figure 6: The free energy f_+ (solid line) and f (dashed line) of the con gurations with the half-turn numbers between 10 and 14 as a function of computed from Eq. (24). This lines represent the energy of unstable con gurations. Two cases are shown: (a) $w = w_+ = w = =2$; (b) w = 10.0, $w_+ = 2.19$ (= 5.6 and w = =2).

There are two additional conditions for a stationary point to be a local minimum of the free energy surface (19). These conditions ensure local stability of the corresponding director con gurations and can be written in the following form:

From Eq. (17) we can now relate the angles and through the following equation

where the number k is integer, k 2 Z, that is the number of half-turns of the spiral. Substituting




Figure 7: Dependencies of w_+ for various values of the anchoring energy parameter w_- .

The right hand side of Eq. (23) is $_{+}$ () (()) when the number k is even (odd). Solving Eqs. (23) will provide, in general, various values of . The values that meet the stability conditions (20) and (21) correspond to metastable con gurations of CLC. The equilibrium director structure is determined by the solutions of Eq. (23) that give the least value of the free energy. From Eqs. (19) and (23) the free energy can be expressed in terms of the angle and is given by




Figure 8: Dependencies of w on w_+ for various values of the anchoring energy parameter w . It is shown that w = w at $w_+ = w$ and w = 0 at $w_+ = w_c$ (see Eq. (32)).

It is now our task to study the dependence of the pitch wavenumber q on the free twist wavenumber q_0 , which is proportional the chiral parameter, $q_0 = h=K$, at dimensional conditions. Equivalently, we concentrate on the dependence of n_0 (see Eqs. (18) and (23)). This dependence can be thought of as a sort of dispersion relation.

3.1 Strong anchoring lim it

First we consider the case of the strong anchoring limit, W = W ! 1, that can be readily treated without recourse to num erical analysis. In this case the boundary conditions require the director at the substrates to be parallel to the corresponding easy axes, \hat{n} (1) k \hat{e} . This im poses the restriction on the values of q, so that q takes the values from a discrete set. This set represents locally stable director con gurations labelled by the half-turn number m as follow s

Substituting the values of from the relation (28) into the rst term on the right hand side of Eq. (24) will de ne the equilibrium value of m as the integer that m in in izes the distance between m and $2q_1l$. The resulting step-like dependence is depicted in Fig. 2a.

3.2 Equal anchoring energies

W hen the anchoring strengths at both substrates are equal, $W = W_+ W$, the right hand side of Eq. (23) is w sin (w = W = K) and $_+ = -$. So, as is illustrated in Fig. 3(a), we need to nd the intersection points of the horizontal line $=_0$ and the curves = () in the

plane. The stability conditions $A_+ > 0$ and $H_+ > 0$ (A > 0 and H > 0) require the values of to be ranged between (m 1=2) and (m + 1=2), where m is even (odd) integer equal to the half-turn number. The function + () monotonically increases on these intervals, so that the value of $_0$ runs from (m 1=2) w to (m + 1=2) + w on the interval with the half-turn numberm : [(m 1=2); (m + 1=2)]. For each number of m we have the monotonically increasing branch of the vs $_0$ dependence. The branches with m ranged from 10 to 14 for di erent values of the dimensionless anchoring energy parameter w are depicted in Fig. 2. It is illustrated that the $_0$ -dependence of will be discontinuous provided the anchoring energy is not equal to zero. Fig. 2 shows that the jumps tend to disappear in the limit of weak anchoring, where the anchoring energy approaches zero, w ! 0.

Similar to the case of strong anchoring, at $_0 = -2 + m$ we have two dimensions of Eq. (23) with k = m and k = m + 1 that are equally distant from $_0$ and are of equal energy. According to Refs. It means that there are hysteresis boys in the response of CLC to the change in the free twisting number.

W hen the anchoring energy is small and w < =2, there are only two con gurations at the critical point $_{0} = _{+}^{(k)}$: the marginally stable con guration with m = k and the equilibrium one with m = k + 1. In this case Eq. (23) has at most two roots and the jumps will occur as transitions between the states which half-turn numbers di er by the unity, j m j = 1.

Fig. 4a illustrates that for w = -2 we have two marginally stable structures of equal energy with m = k and m = k + 2. Being metastable at -2 < w < -4 this newly formed structure and the con-guration with m = k + 1 will be degenerate in energy at w = -3. So, as is shown in Figs. 2b and 4b, both transitions k + 1 and k + 1 and k + 2 are equiprobable, so that we have the bistability elect at the critical point under w = -3. For -4 < w < -2 the con-guration with m = k + 2 gives the equilibrium director structure at $_0 = -\frac{(k)}{+}$.

It is not different to see that further increase of the anchoring energy involves the conguration with m = k linto the transition when the parameter w is passing through the value $(1 \quad 3=2)$. The jump to the equilibrium state will require the half-turn number changed from k to k + m,

where j m j = lat (l 1) < w < l. There are a number of transient m etastable con gurations involved in transitions with j m j < l.

3.3 Dierent anchoring energies

W hen the anchoring energies at the surfaces are di erent, $W \in W_+$, sin $_+$ on the right hand side of Eq. (23) equals zero at = =2 + k and, as is seen from Fig. 3b, we have additional intersection points of the curves $_+$ () and (). The stationary points, where the derivative of with respect to equals zero, represent the local maxim a and minim a of and are located

at = =2 + k. The value of can be calculated by solving the following equation

From the stability conditions $H_+ > 0$ (H > 0) the values of for stable con gurations fall between the stationary points (m 1=2) + and (m + 1=2) , where the half-turn number m is even (odd) integer. The function $_+$ () monotonically increases and $_0$ varies from (m 1=2) w to (m + 1=2) + w on these intervals. The dimensionless parameter w, as opposed to the case of equal anchoring energies, is now given by

C learly, we can now follow the line of reasoning presented in the previous section to nd out the results concerning hysteresis loops and bistability e ects that are similar to the case of equal anchoring strengths. There are, how ever, two important di erences related to Eqs. (29) and (30).

If \bigcirc 0, the intervals of representing stable director congurations are separated by the gap of the length 2. The presence of this gap is illustrated in Figs. 5a and 5b. Fig. 6b shows the gap between stable branches of the dependence of the free energy on . The values of that are within the gap represent unstable congurations (\forbidden" states of CLC). The graph of the vs w₊ dependence is presented in Fig. 7 and indicates that the gap disappears in the limit of equal energies, w₊ = w. In addition, referring to Fig. 7, there is a critical value of w₊ below which equals zero.

It can be shown that Eq. (23) has the only root, $= _0$ at $_0 = =2+$ k, under the anchoring energies m eet the following condition:

In this case the gap disappears and the dependence of on_0 becomes continuous in the manner indicated in Figs. 5c and 5d. G iven the value of w the relation (31) yields the threshold value

for the anchoring strength at the upper substrate. The critical anchoring energy parameter $w_{\,\rm c}$ is given by

As illustrated in Fig. 8, the dependence of w on w_+ is approximately linear for large values of w and w goes to zero at the critical point $w_+ = w_c$.

4 Conclusion

In this paper we have studied how the pitch wavenum ber of CLC cell depends on the free twisting num ber for the cases in which the anchoring strengths at the substrates are either equal or di erent. It is found that in both cases this dependence is generally discontinuous and is characterized by the presence of hysteresis and bistability. But the di erence in the anchoring energies introduces the following two e ects:

- (a) the jum p-like behaviour of the twist wavenum ber is suppressed under the anchoring strength at one of the substrates is below its critical value;
- (b) the twist wavenum ber intervals of locally stable con gurations with adjacent num bers of the helix half-turns are separated by the gap where the structures are unstable.

The part of our analysis, presented in Sec. 3.2, relies on the assumption that the transition between congurations with different half-turn numbers occurs when the initial structure loses its stability, so that its pitch wavenumber no more corresponds to a local minimum of the free energy surface. The result is that the stronger the anchoring, the larger the change of the halfturn number (and of the twist wavenumber) needed to reach the equilibrium state. So, whichever mechanism of relaxation is assumed, the metastable states certainly play an important part in the problem. D ynamics of the transitions is well beyond the scope of this paper and it still remains a challenge to develop a tractable theory that accounts for director uctuations, hydrodynam ic modes and defect form ation.

A nalytical results of Sec. 2 can be used to study the e ect of pretilt angles at the con ning surfaces. This problem requires a more complicated analysis that will be published elsewhere.
