# T w ist of cholesteric liquid crystal cell w ith substrates of di erent anchoring strengths

#### Abstract

We consider director con gurations of cholesteric liquid crystal (C LC) cells with two plane con ning substrates. Exact solutions of the Euler-Lagrange equations for out-ofplane orientations of the easy axes that correspond to inhom ogeneous conical structures of C LC director are derived. W e study dependence of the C LC tw ist w avenum ber on the free tw isting num ber assum ing that anchoring energies at the substrates are either equal or di erent. In both cases this dependence is found to be generally discontinuous w ith hysteresis loops and bistability e ects involved. For C LC cells w ith identical substrates and planar anchoring conditions the jum p-like behaviour only disappears in the weak anchoring lim it. C ontrastingly, when the anchoring strengths are di erent, there is the nite value of anchoring below which the dependence becom es continuous. A nother e ect is the appearance of the gap between the adjacent tw ist wavenum ber intervals representing locally stable director con gurations. W e calculate the critical value of anchoring asym $m$ etry and present the results of num erical calculations.

## 1 Introduction

In equilibrium cholesteric phase molecules of a liquid crystal (LC) align on average along a local unit director $\mathrm{f}(\mathrm{r})$ that rotates in a helical fashion about a uniform tw ist axis [1, 2]. This tendency of cholesteric liquid crystals (C LC) to form the helical tw isting pattem is caused by the presence of anisotropic $m$ olecules $w$ th no $m$ irror plane | the so-called chiralm olecules (see 目] for a recent review ).

The phenom enology of C LC s can be explained in term s of the Frank free energy

where $K_{1}, K_{2}$ and $K_{3}$ are the splay, tw ist and bend $F$ rank elastic constants. A s an im $m$ ediate consequence of the broken $m$ irror sym $m$ etry, the expression for the bulk free energy (1) contains the chiral term proportional to the chiral strength param eter $h$. This param eter gives the equilibrium value of C LC tw ist wavenum ber, $q_{0}=h=K_{2}$, which corresponds to the pitch $P_{0} \quad 2=q$. In what follow $s$ the param eter $q_{0} w$ ill be referred to as the free tw ist w avenum ber or the free tw isting num ber. So, if the tw ist axis coincides $w$ th the $z$-direction, the director eld $A=\left(\operatorname{cosqz} ; \sin q_{p} z ; 0\right)$ de nes the equilibrium con guration. Since f and A are equivalent in liquid crystals, periodicity of the spiral is given by the half-pitch, $\mathrm{P}_{0}=2$.

Typically, the pitch $P_{0}$ can vary from hundreds of nanom eters to $m$ any $m$ icrons or $m$ ore, depending on the system. The macroscopic chiral param eter $h$ (and thus the pitch) is determ ined by $m$ icroscopic interm olecular torques [4, [5] and depends on the $m$ olecular chirality of C LC consistuent $m$ esogenes. In experim ents it can be in uenced either by variations in therm odynam ic param eters such as tem perature or by introducing im purities.

So far we have seen that the tw isting number of the ideal helical director con guration in unbounded CLCs equals the free tw isting num ber $q_{b}$. This is no $m$ ore the case in the presence ofboundary surfaces or extemal elds that generally break the translational sym $m$ etry along the tw isting axis. The case of planar C LC cell bounded by two parallel substrates exem pli es the sim plest con ning geom etry and is of our prim ary concem in this paper.

D irector con gurations in the C LC cellare strongly a ected by the anchoring conditions at the substrates, so that, in general, the helical form of the director eld w illibe distorted. N evertheless, when the anchoring conditions are planar and out-of-plane deviations of the director can be neglected, the con gurations still have the form of the helical structure which tw ist wavenum ber, $q$ di ers from $q$. Dependence of the tw ist wavenum ber $q$ on the free tw isting number $q$ has been previously studied in Refs. [6, 7, 8] and was found to be disoontinuous. In Refs. [9, 10] this jum $p$-like behaviour was shown to $m$ anifest itself in abrupt changes of selective transm ission spectra w ith tem perature. D i erent $m$ echanism $s$ behind tem perature variations of the pitch in C LC œells have been discussed in recent papers 11, 12].

Theoretical results of Refs. [6, 7, $8,[9,19,11,12]$ are related to the C LC cells placed between two identical substrates and the corresponding anchoring strengths were taken to be equal. In this paper we consider CLC cells with di erent anchoring energies at the con ning surfaces. In particular, we nd that su ciently large asym $m$ etry in anchoring strengths will render the dependence of the tw ist w avenum ber on $q_{0}$ continuous.

The paper is organized as follow s.
D irector con gurationsw th in C LC clls are analyzed in Sec 2 . U sing the one-constant approxim ation we derive exact solutions of the Euler-Lagrange equations. These solutions are expressed
in term s of the Jacobian elliptic functions and correspond to inhom ogeneous conical orietational structures. The case of the planar anchoring conditions is considered in Sec. 3 where we present both analytical and num erical results about the dependence of the tw ist wavenum ber on the free tw isting num ber. C oncluding rem arks are given in Sec. 4 .

## 2 Orientational structures in C LC cell

W e consider director con gurations in a C LC cell of thickness 21 sandw iched betw een tw o parallel plane substrates located at $\mathrm{z}=\quad$ land $\mathrm{z}=1$, so that the z -axis is norm alto the con ning surfaces. $W$ e shall also assum e that the sym $m$ etry w ith respect to in-plane translations is unbroken and the director eld describing orientational structures does not depend on the coordinates $x$ and $y$. Its param eterization in term s of the angles and is taken in the form :

Substituting the param eterization (2) into Eq. (1) and using the one-constant approxim ation, $K_{i}=K$, we have the follow ing expression for the bulk free energy per unit area:

where the prim e stands for derivative $w$ ith respect to $z$.
In order to specify the anchoring conditions at the boundary surfaces $z=l$ in term $s$ of the anchoring strengths $W$ and the vectors of easy orientation $A$ we shall write the surface contribution to the free energy as an anchoring energy taken in the form of RapiniP apoular potential:

The phenom enological anchoring param eters $W$ characterize the strength of interaction betw een C LC m olecules and the surfaces, while the preferred orientation of the $m$ olecules at the substrates is de ned by the easy axes $A$.

### 2.1 Solutions of the Euler-Lagrange equations

The free energy functional (3) only depends on the derivative ${ }^{0}$, so that the corresponding EulerLagrange equation can be integrated to yield the follow ing equation:

where $c$ is the integration constant. Variation of the functional (3) with respect to $w$ ill give the second Euler-Lagrange equation that can be sim pli ed by using Eq. ( $(\mathbf{\beta})$. The result is as follow s

W e can now proceed w ith solving Eq. (7) that can be conveniently rew rilten in the form :

where $2 c=d \quad \mathrm{p} \overline{d^{2} 4 c^{2}}$. This equation $w$ ill have solutions only if the values of $c$ are nonnegative and do not exceed the unity, 0 c 1 . This im $m$ ediately places the restriction on the param eter $d$ : $d \quad m a x\left(2 j \dot{j} ; c^{2}+1\right)$. $F$ ig. $]_{1}$ show $s$ this region in the $c-d$ param eter plane.

In the upper part of the region, $d>c^{2}+1$, we have $c_{+}>1$ and solutions of Eq. (9) can be expressed in term s of the Jacobian elliptic functions 13] as follow s

In addition, there are hom ogeneous solutions that are independent of $z: \sin =\frac{p}{1-c}$ and $\left.\sin =P \frac{c_{+}}{1 \quad(a t} c_{+}<1\right)$. These solutions correspond to a conicalhelix in which the director $m$ akes an oblique angle $w$ ith respect to the helix axis. There are no spatially varying solutions at

the boundary of the region depicted in $F$ ig. 1 . In this case the pretilt angle does not depend on $z$ and we have

In order to com pute the integration constants $\mathrm{c}, \mathrm{d}$, o and owe need to know the boundary

## $3 P$ itch $w$ avenum ber versus free tw isting num ber

In this section we consider the sim plest case of an ordinary spiral director con guration in which the pretilt angle equals zero, $\sin =0$ and $d=d^{2}+1$. This case occurs when the anchoring conditions are planar and both of the easy axes are parallel to the con ning surfaces. $W$ e direct

the x -axis along the vector $\hat{e}$, while the easy axis at the upper substrate is rotated through the angle $: e_{+}=(\cos ; \sin ; 0)$.

There are tw o additionalconditions for a stationary point to be a localm in im um of the free energy surface 19). These conditions ensure local stability of the corresponding director con gurations and can be written in the follow ing form :

The right hand side ofE q. 23) is +()()$^{(1)}$ when the num berk is even (odd). Solving Eqs. (23) w ill provide, in general, various values of. The values that $m$ eet the stability conditions (2G) and (21) correspond to $m$ etastable con gurations of CLC. The equilibrium director structure is determ ined by the solutions of Eq. (23) that give the least value of the free energy. From Eqs. (19) and (23) the free energy can be expressed in term s of the angle and is given by

It is now our task to study the dependence of the pitch wavenumber $q$ on the free $t w$ ist wavenumber $q_{D}$, which is proportional the chiral param eter, $q_{D}=h=K$, at di erent anchoring conditions. Equivalently, we concentrate on the dependence of on (see Eqs. (18) and (23)). This dependence can be thought of as a sort of dispersion relation.

### 3.1 Strong anchoring lim it

F irst we consider the case of the strong anchoring $\lim$ 五, $\mathrm{W}=\mathrm{W}$ ! 1 , that can be readily treated w thout recourse to num erical analysis. In this case the boundary conditions require the director at the substrates to be parallel to the corresponding easy axes, A ( l) k e. This im poses the restriction on the values ofq, so that $q$ takes the values from a discrete set. This set represents locally stable director con gurations labelled by the half-tum num ber m as follow s

Substituting the values of from the relation (2q) into the rst term on the right hand side of Eq. (24) w ill de ne the equilibrium value ofm as the integer that $m$ in im izes the distance betw een m and 2 gl . The resulting step-like dependence is depicted in Fig. Zᄌara.

### 3.2 Equal anchoring energies

W hen the anchoring strengths at both substrates are equal, $\mathrm{W}=\mathrm{W}+\mathrm{W}$, the right hand side of Eq. (23) is $\mathrm{w} \sin (\mathrm{w}=\mathrm{W} \mathrm{l}=\mathrm{K})$ and $+=\quad=$. So, as is ilhustrated in Fig. $\mathrm{B}^{3}$ (a), we need to nd the intersection points of the horizontal line $=0$ and the curves $=()$ in the plane. The stability conditions $\mathrm{A}_{+}>0$ and $\mathrm{H}_{+}>0$ ( $\mathrm{A}>0$ and $\mathrm{H}>0$ ) require the values of to be ranged between ( $m$ 1=2) and ( $m+1=2$ ), where $m$ is even (odd) integer equal to the halftum num ber. The function +() m onotonically increases on these intervals, so that the value of 0 runs from ( $m \quad 1=2$ ) $\quad w$ to $(m+1=2)+w$ on the interval $w$ ith the halftum num berm : [ $\left.\begin{array}{ll}m & 1=2) \\ \text {; } & (m+1=2)\end{array}\right]$. For each num ber ofm we have the $m$ onotonically increasing branch of the vs o dependence. The branches $w$ th $m$ ranged from 10 to 14 for di erent values of the dim ensionless anchoring energy param eter w are depicted in $F$ ig. 2 . It is illustrated that the o-dependence of will be discontinuous provided the anchoring energy is not equal to zero. Fig. 2 show s that the jum ps tend to disappear in the lim it ofweak anchoring, where the anchoring energy approaches zero, w! 0 .

Sim ilar to the case of strong anchoring, at $0=2+m$ we have two di erent roots of Eq. (23) w th $k=m$ and $k=m+1$ that are equally distant from 0 and are of equal energy. A coording to Refs. [9, 10, 11, 12] it can be assum ed that the jum ps actually occur at the end points $0=2+k \quad w$, where the con guration $w$ ith $m=k+1=2 \quad 1=2$ becom es $m$ arginally stable ( $\mathrm{A}=\mathrm{H}=0$ ) and loses its stability. In other words, the system needs to penetrate the barrier separating the states w ith di erent halftum numbers. As it is seen from F ig. [k, in this case the upward and backw ard transitions with $m=1: k!k+1$ and $k+1!k$ occur at di erent values of $0:_{+}^{(k)}==2+k+w^{(k)}=2+k w^{(k)}$, correspondingly. It $m$ eans that there are hysteresis loops in the response of C LC to the change in the free tw isting num ber.

W hen the anchoring energy is m all and $\mathrm{w}<=2$, there are only two con gurations at the critical point $0={ }_{+}^{(k)}$ : the marginally stable con guration $w$ th $m=k$ and the equilibrium one $w$ ith $m=k+1$. In this case Eq. (23) has atm ost tw o roots and the jum pswilloccur as transitions between the states which half-tum num bers di er by the unity, $j \mathrm{~m} j=1$.

F ig. Ha illustrates that for $\mathrm{w}==2$ we have two m arginally stable structures of equal energy w ith $\mathrm{m}=\mathrm{k}$ and $\mathrm{m}=\mathrm{k}+2$. Being m etastable at $=2<\mathrm{w}<$ this new ly form ed structure and the con guration w th $\mathrm{m}=\mathrm{k}+1 \mathrm{w}$ ill be degenerate in energy at $\mathrm{w}=$. So, as is show n in F igs. 2 b and 4 b , both transitions $\mathrm{k}!\mathrm{k}+1$ and $\mathrm{k}!\mathrm{k}+2$ are equiprobable, so that we have the bistability e ect at the critical point under $w=$. For $<w<2$ the con guration $w i t h$ $\mathrm{m}=\mathrm{k}+2$ gives the equilibrium director structure at $0={ }_{+}^{(\mathrm{k})}$.

It is not di cult to see that further increase of the anchoring energy involves the con guration w ith $\mathrm{m}=\mathrm{k} \quad \mathrm{l}$ into the transition when the param eter w is passing through the value ( $1 \quad 3=2$ ). $T$ he jum $p$ to the equilibrium state $w$ ill require the half-tum number changed from $k$ to $k+m$,
where j m j= lat (l 1) < w < l. There are a num ber of transient m etastable con gurations involved in transitionswith $j \mathrm{~m} j<1$.

### 3.3 D i erent anchoring energies

$W$ hen the anchoring energies at the surfaces are di erent, $W \in W+$, $\sin +$ on the right hand side of Eq. 23) equals zero at $==2+\mathrm{k}$ and, as is seen from Fig . F b , we have additional intersection points of the curves +() and ( ). The stationary points, where the derivative of
$w$ th respect to equals zero, represent the localm axim a and minim of and are located at $==2+\mathrm{k}$. The value of can be calculated by solving the follow ing equation

From the stability conditions $H_{+}>0(H>0)$ the values of for stable con gurations fall between the stationary points $(m \quad 1=2)+$ and $(m+1=2)$, where the half-tum num berm is even (odd) integer. The function +() m onotonically increases and $o$ varies from ( $m \quad 1=2$ ) $\quad w$ to $(m+1=2)+w$ on these intervals. The dim ension less param eter $w$, as opposed to the case of equal anchoring energies, is now given by

C learly, we can now follow the line of reasoning presented in the previous section to nd out the results conœming hysteresis loops and bistability e ects that are sim ilar to the case of equal anchoring strengths. There are, how ever, two im portant di erences related to Eqs. (2 2 ) and (3p).

If 0 , the intervals of representing stable director con gurations are separated by the gap of the length 2 . The presence of this gap is illustrated in Figs. Fa and Fhb. F ig. [fo show s the gap betw een stable branches of the dependence of the free energy on. The values of that are within the gap represent unstable con gurations ( $\backslash$ forbidden" states of C LC). T he graph of the $\quad$ vs $\mathrm{w}_{+}$dependence is presented in F ig. 7 and indicates that the gap disappears in the lm it of equal energies, $\mathrm{w}_{+}=\mathrm{w}$. In addition, referring to F ig. $\mathrm{O}^{7}$, there is a critical value of $\mathrm{w}_{+}$below which equals zero.

It can be shown that Eq. (23) has the only root, $=0$ at $0=2+k$, under the anchoring energies $m$ eet the follow ing condition:

In this case the gap disappears and the dependence of on obecom es continuous in the $m$ anner indicated in Figs. 5c and Ford. G iven the value of w the relation 31) yields the threshold value
for the anchoring strength at the upper substrate. The critical anchoring energy param eter $\mathrm{w}_{\mathrm{c}}$ is given by

A s illustrated in F ig. $\mathrm{C}_{6}$, the dependence of w on $\mathrm{w}_{+}$is approxim ately linear for large values of w and w goes to zero at the critical point $\mathrm{w}_{+}=\mathrm{w}_{\mathrm{c}}$.

## 4 C onclusion

In this paper we have studied how the pitch wavenum ber of C LC œell depends on the free tw isting num ber for the cases in which the anchoring strengths at the substrates are either equalordi erent. It is found that in both cases this dependence is generally discontinuous and is characterized by the presence of hysteresis and bistability. But the di erence in the anchoring energies introduces the follow ing two e ects:
(a) the jum p-like behaviour of the tw ist w avenum ber is suppressed under the anchoring strength at one of the substrates is below its critical value;
(b) the tw ist w avenum ber intervals of locally stable con gurations $w$ th adjacent num bers of the helix half-tums are separated by the gap where the structures are unstable.

The part of our analysis, presented in Sec.3.2, relies on the assum ption that the transition between con gurations with di erent half-tum numbers occurs when the initial structure loses its stability, so that its pitch wavenumber no m ore corresponds to a localm in im um of the free energy surface. The result is that the stronger the anchoring, the larger the change of the halftum num ber (and of the tw ist wavenum ber) needed to reach the equilibrium state. So, whichever $m$ echanism of relaxation is assum ed, the $m$ etastable states certainly play an im portant part in the problem. D ynam ics of the transitions is well beyond the soope of this paper and it still rem ains a challenge to develop a tractable theory that accounts for director uctuations, hydrodynam ic $m$ odes and defect form ation.

A nalytical results of $S e c$. $Z_{6}$ can be used to study the e ect of pretilt angles at the con ning surfaces. This problem requires a m ore com plicated analysis that will be published elsew here.
