## Capillary-gravity waves: $a \setminus xed$ -depth" analysis.

A bstract. { We study the onset of the wave-resistance due to the generation of capillarygravity waves by a partially immersed moving object in the case where the object is hold at a xed immersion depth. We show that, in this case, the wave resistance varies continuously with the velocity, in qualitative accordance with recent experiments by Burghelea et al. (Phys. Rev. Lett. 86, 2557 (2001)).

Introduction. { The dispersive properties of capillary-gravity waves are responsible for the complicated wave pattern generated at the free surface of a still liquid by a disturbance m oving with a velocity V greater than the minimum phase speed  $V_c = (4g = )^{1-4}$ , where g is the gravity, is the surface tension and the density of the uid [1]. The disturbance m ay be produced by a small object partially immersed in the liquid or by the application of an external surface pressure distribution [2]. The waves generated by the moving perturbation propagate momentum to in nity and, consequently, the disturbance experiences a drag R called the wave resistance [3]. For  $V < V_c$  the wave resistance is equal to zero since, in this case, no propagating long-range waves are generated by the disturbance [4].

A few years ago, it was predicted that the wave resistance corresponding to a surface pressure distribution symmetrical about a point should be discontinuous at  $V = V_c$  [5]. More precisely, if  $F_0$  is the the total vertical force exerted on the uid surface, the wave resistance is expected to reach a  $p_n$  rite value  $R_c > 0$  for  $V ! V_c^+$ . For an object much smaller than the capillary length 1 = -g, the discontinuity  $R_c$  is given by:

Experim entally, the onset of the wave-resistance due to the generation of capillary-gravity waves by a partially im m ersed m oving object was studied recently by two independent groups [6,7]. W hile B row aeys et al. [6] indeed nd a discontinuous behaviour of the wave-resistance at  $V = V_c$  in agreem ent with the theoretical predictions, B urghelea et al. [7] observe a sm ooth transition.

The discrepancy between the theoretical analysis of [5] and the experim ental results of [7] m ight be due to the fact that the experim ental setup of Burghelea et al. uses a feedback loop to keep the object at a constant depth while the analysis of [5] assumes that the vertical




Fig.1 { W e study the behavior of a hydrophobic m oving object of characteristic size b in m ensed at a depth h. The velocity of the object is V. W e decompose the force exerted by the uid on the object in a component orthogonal to the free surface ( $F_0$ ) and a component parallel to it (R).

component  $F_0$  of the force exerted by the disturbance on the uid does not depend on the velocity V (we might call such an analysis a \ xed force" analysis). In order to check this proposition, we perform in this letter a \ xed-depth" calculation of the wave-drag close to the onset threshold. A somewhat similar analysis was performed in the large velocity limit by Sun and K eller [8]. We will show that such a calculation indeed yields a cancellation of the vertical force at  $V = V_c$ , that is to say, according to equation (1), a smoothing of the discontinuity.

Model. { We take the x; y plane as the equilibrium surface of the uid. The immersed object exerts a stress at the uid surface that can be considered equivalent to a pressure eld p [9] that travels over the surface with a velocity V in the x direction. We assume  $\hat{p}$  (the Fourier transform of p) to be of the form :

 $q = \frac{q}{k_x^2 + k_y^2}$  and (0) = 1. In this case, p is isotropic [10] and  $F_0$  is the total vertical force exerted on the uid.

W ithin the fram ework of Rayleigh's linearized theory of capillary-gravity waves, the Fourier transform  $\hat{k}$  of the free surface displacement (r) is related to the pressure eld through [11]:

where  $!_0^2(k) = gk + k^3 = is$  the free dispersion relation,  $q^2 = k^2$  ik V = and = is the kinematic viscosity of the uid.

Let us suppose the object is located at the origin of the moving frame. If h is its depth, the free surface displacement must be h under the pinpoint (here we suppose the object su ciently hydrophobic and h not to large so that the pinpoint does not pierce the surface). This leads to the following norm alization condition:

The value of h as a function of  $F_0$  can be readily calculated using equations (3) and (4):

F inally, the drag-force R  $\,$  is calculated by simply integrating the pressure force over the free surface [12].

This yields, using the explicit expression (3) for  $\hat{}$ ,

A coording to equation (8), the integral describes the xed-force behaviour of the waveresistance. Due to the sym metry of  $\hat{}$ , is parallel to V and we shall henceforth set = u, where u = V =V is the unit vector parallel to the velocity of the object. The authors of [5] studied the properties of in the case of a non-viscous uid for which they showed that:

In the case of a -xed depth analysis,  $F_0$  becomes a function of V . Using equations (5), we can rewrite the wave-resistance as




Fig.2 { (a) Numerical calculation of the dimensionless integral = (V) = (0). (b) C om parison of (V) = (V) =  $_{\rm c}$  (dashed line) and R =  $^2$  (full line) describing respectively the xed-force and xed-depth behaviour of the wave-resistance. We clearly see that contrary to the xed-force analysis, the xed-depth calculation does not yield any discontinuity at the threshold. Here = 10  $^6$  m<sup>2</sup> s<sup>1</sup>, = 72 m N m<sup>-1</sup>, = 1000 kg m<sup>-3</sup> and b = 0.1 m m.

In general we have to rely on num erics to calculate the integrals and . Typical results are presented on Figure 2 for an objet of size 0.1 mm immersed in water, and for a step-like function  $^{\circ}$  equal to 1 for k < 1=b and 0 otherwise.

We rst observe on Fig. (2-a) that increases sharply near the threshold. This leads to two rather di erent behaviours for and R as shown on Fig. (2-b): while exhibits a discontinuity close to  $V = V_c$  [13], the xed-depth wave-drag  $R = = {}^2$  cancels sm oothly at the critical velocity.

Inviscid ow. { The characteristic features displayed by the plots of Fig. 2 can be captured by a zero-viscosity analysis. Setting = 0, equation (6) can be simplified as:

where P denotes the C auchy principal value of the integral. The integral is calculated in polar coordinates (k; ), where is the angle of k with respect to V. Introducing the function G de ned by:

where  $m_k^2 = k = + = k$  and  $M = V = V_c$  is the \M ach" number, equation (13) can then be rewritten as:

Using the residue theorem [14], we get:




Fig. 3 { Variations of  $m_k^2$  (see text) with k. Since  $m_k^2$  reaches a minimum for k = w ith  $m^2 = 2$ , equation  $m_k^2 = 2M^2$  presents solutions for M > 1. In this case, there are two possible values  $k_1$  and  $k_2$  with  $k_1 < < k_2$ .

where the is the H eaviside step-function. The variations of  $m_k^2$  with k are plotted on Fig. 3:  $m_k^2$  reaches its minimum value  $(m_k^2)_{min} = 2$  for k = . It shows that equation  $2M^2 = m_k^2 = 0$ has two solutions  $k_1$  and  $k_2$ , with  $k_1 < < k_2$ , if V is larger than the critical velocity  $V_c$ , and none if  $V < V_c$ .

For  $V > V_c$ , evaluates to

The above integrals can be calculated in the two limiting cases M  $\,$  1 (i.e. V  $\,$  V) and M  $\,$  1 (i.e. V  $\,$  V\_c).

For large M , the integrals are restricted to either large or small values of k. If  $^{\circ}$  vanishes faster than 1=k for large k, we can show that the small k contribution dom inates. In this region, the dispersion relation is dom inated by gravity waves, so that we can approximate m<sup>2</sup><sub>k</sub> by k= . A straightforward calculation then yields the following asymptotic expansion for :

Let's now focus on the case V close to  $V_c$ . W e set:

When V !  $V_c$ , the  $(k \ k_1)(k \ k_2)$  term cancels in k = . Since all other terms are regular, we can write at the leading order:

This latter integral is readily calculated and gets a very simple form in the lim it V ! V<sub>c</sub>:

Since  $m_k^2$  is invariant by the transform ation k= ! =k, we see that 1 and 2 have the same asymptotic behaviour for V ! V<sub>c</sub>. In this lim it we have =  $e_1 + e_2 = 2e_1 = 1$ , hence:

In the case of an object of size b, the width of  $\hat{}$  is about 1=b. If we choose b m uch sm aller than the capillary length  $^{1}$ , we can approximate  $\hat{}$  () by  $\hat{}$  (0) = 1. In this limit, equation (19) takes the following form :

If we combine equations (10) and (20), we see that slightly above the threshold, the wave-resistance behaves like:

Equation (21) constitutes the main result of this paper. First, we notice that for small objects this relation is, as expected, independent of the actual shape of the pressure eld. Second, and more important, it shows the wave resistance R cancels out at  $V = V_c$ . This sm earing is due to the cancellation of the vertical force  $F_0$  near the threshold that we get from the behaviour of  $\cdot$ .

Conclusion. { In this paper we have shown that in a xed-depth situation the discontinuity of the drag-force calculated in [5] vanishes and is replaced by a smooth variation, in accordance with the experimental results found in [7]. A quantitative comparison between the present analysis and the data of R ef. [7] is however more involved since experiments from [7] were performed in narrow channel geometry [15] with objects of size comparable with the capillary length. To recover the scaling relation observed experimentally, it would also be necessary to take into account both the variations of the shape of  $^{\circ}$  with V and the rections of the waves on the walls of the channel. The present study suggests nevertheless that to fully test relation (1), experiments need to be devised that would measure both R and F<sub>0</sub>. - [9] Not that this assumption is not entirely correct in the presence of viscosity since it leads to a slip of the object with respect to the uid surface. In this case, a force eld parallel to the free surface should be added to take into account the viscous drag. However, this new term leads to the well known Stokes drag, that can substracted from experimental results, and so can be om itted in our analysis.
