# D ynam ics of ballistic annihilation

#### Abstract

The problem of ballistically controlled annihilation is revisited for general in itial velocity distributions and arbitrary dim ension. A n analytical derivation of the hierarchy equations obeyed by the reduced distributions is given, and a scaling analysis of the corresponding spatially hom ogeneous system is perform ed. This approach points to the relevance of the non-linear Boltzm ann equation for dim ensions larger than one and provides expressions for the exponents describing the decay of the particle density $n(t) / t$ and the root $m$ ean-square velocity $\bar{v} / t \quad$ in term of a param eter related to the dissipation of kinetic energy. T he B oltzm ann equation is then solved perturbatively within a system atic expansion in Sonine polynom ials. A nalytical expressions for the exponents and are obtained in arbitrary dim ension as a function of the param eter characterizing the sm all velocity behavior of the in itial velocity distribution. M oreover, the leading non-G aussian corrections to the scaled velocity distribution are com puted. These expressions for the scaling exponents are in good agreem ent w ith the values reported in the literature for continuous velocity distributions in $d=1$. For the tw o dim ensional case, we im plem ent M onte-C arlo and molecular dynam ics sim ulations that tum out to be in excellent agreem ent w ith the analytical predictions.


## I. IN TRODUCTION

B allistically controlled reactions provide sim ple exam ples of non-equilibrium system $s w$ ith com plex kinetics. T hey consist ofan assem bly ofparticlesw ith a given velocity distribution, $m$ oving freely betw een collisions in a d-dim ensional space. In the sim plest version of these $m$ odels we consider here, when two particles $m$ eet, they instantaneously annihilate each other and disappear from the system. D espite its apparent simplicity, this problem is highly non trivial and has attracted substantial interest during the past years case where the particles can only have tw o velocities chas been studied in a pioneering work by E lskens and Frisch [1] I. In particular, they proved that for a sym $m$ etric initial velocity distribution, the particle density is decreasing, in the long time lim it, as $n(t) / t / t^{1=2}$. The case of general distributions in dim ension $d=1$ was discussed by P iasecki $\overline{[ }] \mathbf{l}$, w ho reduced exactly the annihilation dynam ics to a single closed equation for the tw o-particle conditional probability. M oreover, 止 was show $n$ in the particular bim odal situation of a discrete velocity distribution ( $c$ ) that in one dim ension, im portant dynam ical correlations are developing during the tim e evolution, invalidating $m$ ean- eld or B oltzm ann-like approaches. This exact approach was applied to the case of a three velocity distribution by D roz et al $\left[\frac{3}{3}\right]$, w th the result that the dynam ical exponents w ere strongly depending upon the details of the in itial velocity distribution.
 have show $n$ that the exponent could depend on the behavior near the origin of the initial velocity distribution. This problem has been revisited by $R$ ey et al [G][]. B ased on the exact theoretical approach [ w as derived and its validity supported by num erical sim ulations for several velocity distributions. This leads to the con jecture that all continuous velocity distributions $f(v)$ that are sym $m$ etric, regular, and such that $f(0) \& 0$ are attracted, in the long-tim e regim $e$, tow ards the sam e distribution and thus belong to the sam e universality class. This con jecture w as reinforced by num erical sim ulations in two dim ensions [10

The case of continuous velocity distribution has also been approached recently by K rapivsky and Sire $[\overline{9}]$. Starting from a Boltzm ann equation, they investigated the decay of the particle density $n$ ( $t$ ) $t$ and the root mean-square velocity $\bar{v} / t$. They derived upper and low er bounds for the exponents as well as their leading expansion in $1=d$, valid in high dim ension. Them ain question $w$ ith such an approach concems the validity of a Boltzm ann equation. This is not justi ed in 1D and rem ains an open problem in higher dim ensions.

The purpose of this paper is to give a rst principle answer to this type of question. The article is organized as follow s. In section II, an originalanalyticalderivation of the equations goveming the dynam ics ofballistic annihilation is given. The hierarchy equations obeyed by the reduced distributions are obtained. It is show $n$ that in the $G$ rad lim it, the hierarchy form ally reduces to a B oltzm ann-like form for $d>1$. If the in itial reduced distributions factorize, the whole hierarchy reduces to one non-linear equation. In the second part of section II, a scaling analysis of the
exact spatially hom ogeneous hierarchy is perform ed. The exponents and are showed to depend only on one param eter related to the dissipation of energy. This scaling analysis tums out to be invalid for the case $d=1$ w ith discrete velocity distributions, but correct in the continuous case. Strong argum ents are given in favor of the validity of the Boltzm ann approach for the case $d>1$ in the long tim elim it. The Boltzm ann equation is then solved
 corrections to the scaled velocity distribution are com puted and predictions for the exponents and are explicitly worked out as a function of the dim ension $d$ and the param eter characterizing the sm all velocity behaviour of the initial velocity distribution: $[f(v ; t=0) / j v j$ for $j v j!0]$. These predictions for and are asym ptotically exact for large dim ensions, and reproduce the $1=\mathrm{d}$ correction to the $m$ ean-eld values. In 1 D , they are in very good agreem ent w ith the exponents reported in the literature [19] at the Boltzm ann level. In 2D, we im plem ent extensive $D$ irect Sim ulation M onte C arlo m ethods (D SM C ) where the non-linear Boltzm ann equation is solved, and M olecular
 the M D and D SM C routes con ms the validity of the Boltzm ann approach, and the decay exponentsm easured are in exceptionally good agreem ent with the Sonine prediction. C onclusions are draw $n$ in section $N$. A prelim inary account of part of the results presented here has been published elsew here $\left[\begin{array}{ll}{[101}\end{array}\right]$.

## II. EXACT RESULTS

## A. D erivation of the $h$ ierarchy

H ere $b$ is the unit vector along the line passing through the centers of the spheres at contact. The integration $w$ ith respect to the $m$ easure $d b$ is thus the angular integration over the solid angle in $d$-dim ensionalspace. The function in ( ${ }^{\prime}(\bar{\prime})$ restricts this angular integral to the hem isphere corresponding to pre-collisional con gurations.

Equation (2-5) is the Boltzm ann kinetic equation corresponding to the annihilation dynam ics. In the follow ing section, we shall see that the form alG rad lim it taken here, where $n!1$, is relevant for the description of the annihilation dynam ics at late tim es, even if the density $n(t)$ decreases $w$ ith tim $e$.

## B. Scaling analysis of the $h$ ierarchy

The evolution of the annihilation kinetics shares a com $m$ on feature $w$ ith the $G$ rad lim it: The ratio of particle diam eter to $m$ ean-free-path $=1=\left(n^{d}{ }^{1}\right)$, which is related to the packing fraction, vanishes in both cases. To be $m$ ore speci c, we perform a scaling analysis of the exact hom ogeneous hierarchy equations and look for self-sim ilar reduced distributions where the tim e dependence has been absorbed into the density $n(t)$, $w$ ith the velocities $v$ and positions r renom alized by the typical (root $m$ ean squared) velocity $\bar{v}(t)$ and $m$ ean-free-path respectively: W e de ne the reduced variables

section ${ }_{1} \bar{I} \overline{-} \overline{1} \cdot \mathrm{M}$ oreover, if the initial velocity distribution is of nite support (i.e. vanishes outside a sphere of given velocity $\overline{v^{?}}$ ), $\bar{v}$ ful lls the bound $\bar{v} \quad v^{3}$ so that is necessarily positive (or 1). In the fram ew ork of Boltzm ann's equation, it will be shown in appendix 'Al that the quantity is necessarily larger than 1. For the speci c in itial condition where all particles have the sam e kinetic energy at $t=0, \bar{v}^{2}=h v^{2} i$ is tim e-independent, and (31) im plies that $=1$. From Eq. W e therefore recover the conclusions obtained by considering the form alG rad lim it, w ith distribution functions expected to obey a Boltzm ann-like equation. T his analysis points to the relevance of $B$ oltzm ann equation for $d>1$, a point which is further corroborated by the num erical results given in section ${ }^{1} \bar{I} \overline{1}$.

It is interesting to note that both Eq. (30) and the relation $+\quad=1$ do not hold in 1D for discrete in itialvelocity distributions. In the sym $m$ etric situation of a bim odaldistribution, the average kinetic energy per particle is conserved
 incorrect in the speci c situation ofdiscrete distributions in 1D, but valid for continuous distributions [G] . To be m ore speci $c$, the scaling form ( $2 \bar{z}_{1}^{\prime}$ ) im plies that the collision frequency scales $w$ ith tim e like ! / $n \bar{v}$. O n the other hand, from the analytical solution of the bim odal c situation $\left.{ }_{[1]}^{[ }\right]$, we obtain ! / $n^{2} \bar{v} w$ ith $\bar{v}=c$. This discrepancy is the signature of dynam ical correlations in the latter discrete case. These correlations are responsible for the breakdown of (2d), and in addition violate $m$ olecular chaos. For continuous velocity distributions, again in 1D, m olecular chaos also breaks dow $n$ while the scaling (2 $\overline{2}$ ) is correct. A s a consequence, the exponents obtained at the B oltzm ann level
 holds.

## III. BOLTZMANNKINETICEQUATION

This section is devoted to the analysis of the decay dynam ics within the molecular chaos fram ew ork [[]3] of the hom ogeneous non-linear Boltzm ann equation. No exact solution could be obtained, and our goal is to derive accurate approxim ate predictions for the scaling exponents and of the density and root $m$ ean squared velocity.

Before considering the kinetic equation obeyed by the rescaled distribution function, it is instructive to rew rite the original hom ogeneous B oltzm ann equation (25) in the form

H ow ever, it $w$ ill be shown in section (1V) that the di erence betw een the truncated expansion (48 (1) and the num erical velocity distribution becom es $m$ anifest far_in the tail, where the distribution has reached very low probabilities. C onsequently, when the $m$ om ent involved in (4-1) and (4) are evaluated from the truncation of (4) , the accuracy of the result is expected to be better for low orders p in (46). H ence the privileged role played by (471), which is of low er order than any of the identities (4). In practioe, upon truncating (4), at order $n$, the $n$ unknowns, $a_{2}, \ldots, a_{n}$ are

The second order expansion considered here $m$ ay be im proved by consideration of higher order Sonine term $s$ and inclusion of non-linear term $s$ in $a_{2}$. In the related context of inelastic hard spheres, the lim itation of w ork ing at linear order in $a_{2} w$ ith neglect of Sonine term sof order $n \quad 3 \mathrm{~m}$ ay be found in [1] ]. A ltematively, keeping non linear term $s$ in $a_{2}$ and neglecting again Sonine term s oforder n _ 3 leads to m ultiple solutions. A stability analysis is then required to determ ine which one is stable, as discussed in [1] [].

Here, the value obtained for $a_{2}$ is quite sm all (see below). O ur approxim ate expressions are accurate when com pared to the full num erical solution of $B$ oltzm ann's equation, so that we did not calculate any higher order coe cients, nor consider non linear term $s$ in $a_{2}$. The existing body of literature reports, within Boltzm ann fram ew ork, num erical exponents in 1D that are in excellent agreem ent with our predictions, already at zeroth order. For the case $=0$,
 These exponents are close to their counterparts extracted num erically from the exact dynam ics (0.785 0:005 in [[\$] [ 0 , and $m$ ore recently 0.804 [19 ${ }^{-1]}$ ). The di erence betw een the exact exponents and those obtained assum ing $m$ olecular chaos is consistent w ith the conclusion of section II: In 1 dim ension, the factorization of the tw o-body distribution $f_{2}$ underlying Boltzm ann ansatz is not an exact property of the distributions obeying hierarchy (1) $\mathbf{H}_{1}^{\prime \prime}$ ). On the other hand, ford 1, the m olecular chaos exponents are expected to becom e exact. T his property is illustrated in the next section.

IV . SIM ULATION RESULTS
$T$ he num erical results presented in this section correspond to the situation $=0$, unless stated. W e refer to [1d] for the case of diverging $(<0)$ or depleted $(>0)$ velocity distributions near $v=0$.

## A. The num ericalm ethods

We follow two com plem entary num erical routes. First, we solve the tim e-dependent hom ogeneous Boltzm ann equation by $m$ eans of the $D$ irect Sim ulation $M$ onte $C$ arlo $m$ ethod (D SM C ), originally developed to study ordinary gases [2d]. This schem e, where a suitable $M$ ankov chain is constructed, has been extended to deal with inelastic collisions [21 $\left.1^{1}, 22_{1}^{\prime}\right]$ and is easily m odi ed to describe the situation under study here, which does not conserve the total num ber of particles. Restricting to a spatially hom ogeneous system, the algorithm is especially easy to im plem ent, and $m$ ay be sum $m$ arized as follow $s$ : am ong $N_{0}$ in itial particles having a given velocity distribution, a pair ( $i ; j$ ) is chosen at random, and rem oved from the system $w$ th a probability proportionalto $j j_{i j} j$. $T$ he (suitably renorm alized) tim e variable is then increm ented by the am ount $\left(N^{2} \dot{j}_{i j}\right)^{1}$, where $N$ is the number of particles rem aining in the system, before another pair is drawn etc...This schem e provides the num erical exact solution of Eq. (3d), and allow s to test the validity of the approxim ations put forw ard in section "III [essentially: T runcation at second order in expansion (48') supplem ented w ith calculations perform ed at linear order in the fourth cum ulant $a_{2}$, see A ppendix ', '1]. A precise analysis of the late tim e dynam ics (and especially the com putation of velocity distributions) su ers from the concom titant low num ber of particles left, and the statistical accuracy is im proved by averaging over independent realizations.
$T$ he second num ericalm ethod (M olecular D ynam ics [2]-1]) consists of integrating the exact equations ofm otion for an assem bly of spheres con ned in a (hyper)-cubic box $w$ ith periodic boundary conditions. This route assesses the validity of the approach relying on the hom ogeneous Boltzm ann equation, but does not o er the sam e accuracy as D SM C, nor the possibility to follow the evolution over com parable tim es. In particular, once the m ean-free-path , which grow s rapidly as $t$, becom es of the order of the box size $L$, the subsequent evolution su ers from nite size e ects and should be discarded: W hen $>L$, the algorithm used is unable to nd collision events for those particles which $m$ ake $m$ ore than one free ight round on the torus topologically equivalent to the sim ulation box, which causes a spurious slow ing dow $n$ of the dynam ics. It is then tem pting to reduce by increasing particles diam eter, but then nite (and necessarily transient) density e ects \{incom patible with the scaling assum ption (28) \{ $m$ ay also arise if the packing fraction, proportional to $n$ d, is not low enough. Sim ulating explicitly the lim it of point particles, the D SM C schem e considered here is free of this defect. T he initial num ber of particles considered in M D needs to be large to allow the system to enter the scaling regim e before nite-size e ects becom e dom inant: we considered system sw ith $\mathrm{N}=5: 10^{4}$ to $\mathrm{N}=5: 10^{5}$ spheres intially (com pared to $\mathrm{N}=10^{6}$ to $10^{8}$ in D SM C).
B. D ynam ic scaling behaviour

The results of tw O-dim ensional DSM C and M D sim ulations are shown in Figure 1 axis is expected to scale like real tim e from the scaling relation $+\quad=1$. This log-log plot is a direct probe of the exponent, from the slope m easured. B oth M D and D SM C m ethods give com patible results, w ith the possibility to follow the dynam ics over a longer tim e interval in D SM C. The departure observed for $n_{0}=n^{\prime} 200$ corresponds to the slow ing down of M D dynam ics resulting from nite-size e ects (see Figure そ! below). T he theoretical predictions at zeroth and second order are very close ( $0=0: 872$ and $2=0: 870$ ), and in excellent agreem ent w ith the sim ulation results over severaldecades. On a sim ilar graph as Fig. 1 (not shown) w ith an exponent 2 in good agreem ent with the theoretical prediction ( $0: 13$ in 2D). M oreover, the exponents obtained analytically and num erically are com patible to those reported in the literature ( $\quad$, 0:89 in [4] ${ }^{-1}$ ] and $\quad 0: 87$ (5) using a m ulti-particle lattice gas $m$ ethod '[24]).
$T$ he tim e evolution of inverse density and inverse typical velocity square is show in $F$ igure $n_{0}=n \quad 1$ and $\bar{V}_{j}^{2}=\bar{v}^{2} \quad 1$ instead of $n_{0}=n$ and $\bar{v}_{0}^{2}=\bar{v}^{2}$ allow $s$ to probe the short tim e behaviour. U nless stated, the

'ī. M $\overline{\mathrm{D}}$ - and D SM C result super-m pose, except at late tim es where M D dynam ics su ers from the slow ing down discussed previously. For both num ericalm ethods, the scaling relation $\quad+\quad=1$ is well obeyed, in principle at late tim es only, in the scaling regim e. Special com binations of $n$ and $\bar{v}$ can how ever be constructed with the requirem ent to $m$ atch the short tim e evolution $w$ ith the scaling behaviour. O ne of these quantities is displayed in
 validity of the theoretical scaling exponents, but also the full tim e dependence as predicted by Eqs. (3G) and ( $3 \bar{Z}_{1}$ ). In order to im prove the agreem ent betw een theory and sim ulation (which holds overm ore than 6 orders ofm agnitude in tim e), the system has been left tim e to enter the scaling regim e: The tim e origin $t=0$ has been chosen when $80 \%$ of the particles originally present have disappeared. T he corresponding reference con guration (w ith subscripts 0 ) thus di ens from the ones considered previously.

## C. Velocity distribution in the scaling regim e

In order to understand the reasons for the good agreem ent betw een our theoreticalpredictions and the sim ulations, we now consider the velocity distribution, restricting to $M$ onte $C$ arlo results (leading to sim ilar conclusions, M D is much more dem anding on CPU time and does not allow to investigate detailed features of fin with the sam e accuracy). A fter a transient where the probability distribution function $\mathrm{E}_{1}$ evolves with tim e, a well de ned scaling regim $e$ is reached w ith a tim e independent fin (c) shown in $F$ ig. Together w ith the Sonine prediction pushed at second order. The agreem ent is rem arkable, and it is also observed that the G aussian approxim ation is already close to the asym ptotic rescaled velocity distribution, which is quite surprising in a kinetic process extrem ely far from equilibrium, w ith furtherm ore no conservation laws. G iven that our perturbative analyticalw ork relies on the calculation on low order $m$ om ents of $e_{1}$, this explains the accuracy of the zeroth order predictions 0 and 0 . From Eq. (43), we expect the di erences betw een the Sonine expansion and the num ericaldistribution to becom e visible in the high energy tail, which is con $m$ ed by $F$ ig. $\frac{1, \bar{G} .}{}$. A s predicted, e $\frac{1}{1}$ is ovenpopulated $w$ ith respect to the $G$ aussian, and displays a high velocity tail of the form (4) (see the inset).

## D. Evolution tow ard the asym ptotic solutions

Before the scaling regim $e$ is attained, $\mathrm{f}_{1}$ is tim e-dependent, as show $n$ in F ig. ${ }^{1} \overline{1} 1$, where the distributions at di erent tim es have been renorm alized by $M$ to em phasize the building-up of non-G aussianities. The evolution tow ards the scaling solution $1+\mathrm{a}_{2} \mathrm{~S}_{2}$ can be observed. W ith respect to the G aussian, $\mathrm{f}_{1}$ is at all tim es overpopulated both at large and $s m$ all velocities (which $m$ ay be related to the positive sign of $a_{2}$ for the latter case); norm alization is ensured by
 non $-G$ aussian character of $\mathrm{f}_{1}=\mathrm{M}$ agrees w ith the theoretical prediction, but it is also possible to com pute directly $\mathrm{a}_{2}$ in the sim ulations through its de nition as a fourth cum ulant $\mathbb{E q}$. (504í) ]. It tums that both $m$ ethods are num erically fully com patible. M oreover, the Sonine expansion (48) truncated at $n=2$ holds at any tim e, even in the transient regim e, w ith the tim e dependent fourth cum ulant $a_{2}$ m easured from ( 5 expected and points to the relevance of the expansion (48). W e did not try to solve analytically the hom ogeneous tim e-dependent Boltzm ann equation within the sam e fram ew ork as in the scaling regin e, so that we do not have any
prediction for the (transient) tim e-dependence of $a_{2}$ and. H ow ever, as shown in the inset of $F$ ig. ig, the relation (B10) (which reads in 2D $=5=4+7 a_{2}=16$ ) rem arkably holds for all tim e. H ere, the energy dissipation param eter hàs been com puted through the ratio $h c_{12} c_{1}^{2} i=\left(h c_{12} i h_{1}^{2} i\right)=h c_{1}^{2} i_{\text {coll }}=h c_{1}^{2} i$, where h $c_{1}^{2} i_{c o l l}$, the $m$ ean energy dissipated in a collision is com puted in the sim ulations and norm alized by the tim e-dependent $m$ ean kinetic energy per particle $h c_{1}^{2} i$.

## E. A nal rem ark: Identi cation of $\backslash$ isobestic" points

For $=0$, Figure $\overline{1}_{1}$ indicates that during the transient evolution tow ard scaling, the distributions of reduced velocities have xed points (for a given initial velocity distribution, the curves corresponding to $\hat{\mathrm{A}}_{1}$ at di erent tim es all pass through com $m$ on points, that we called isobestic points). This feature has been observed for all initial distributions investigated and appears to be a system atic property of the dynam ics, which stillholds for non vanishing values of (see Fig. $\left.{ }_{\underline{1}}^{\mathbf{1}} \mathbf{- 1}\right)$. W e have no analytical explanation for this observation.

## V. CONCLUSION

An analytical derivation of the equations goveming the dynam ics of an in nite system of spherical particles in a d-dim ensional space, $m$ oving freely betw een collisions and annihilating in pairs when meeting, has been obtained. $T$ he hierarchy equations obeyed by the reduced distributions $f_{k}(1 ; 2 ;::: ; k ; t)$ have been derived. In the $G$ rad $\lim$ it, this hierarchy form ally reduces to a Boltzm ann-like hierarchy for dim ensions $d>1$. If these reduced distributions $f_{k}^{B}$ factorize at the initial tim $e$, this factorization rem ains valid for all tim es and the whole hierarchy reduces to one non-linear equation.

In the long time lim it, the ratio of the particle radius to the $m$ ean-free path vanishes. A scaling analysis of the exact hom ogeneous hierarchy equations has been perform ed. Self-sim ilar reduced distributions in which the tim e dependence has been absorbed into the density $n(t)$ and the root $m$ ean-square velocity $\bar{v}(t)$ were introduced. As a result, the exponents and describing the decay with tim efn ( $t$ ) and $\bar{v}(t)$ depend only upon one single param eter , related to the dissipation of energy. M oreover, it tums out that in dim ension higher than 1 , the term s responsible for the violation ofm olecular chaos are asym ptotically irrelevant. T herefore, we recover the conclusions reached in the form alG rad lim it and thus, the Boltzm ann equation becom es exact in the long tim e lim it in dim ensions higher than 1. The above argum ents give a rst principle justi cation for the use of the Boltzm ann equation approach for $d>1$, as well as its lim tations, in ballistic annihilation problem $s$, an issue that has been overlooked so far. H ow ever, as discussed above, this scaling analysis is incorrect for a 1 dim ensional system $w$ ith discrete in itial velocity distribution, a situation for which the scaling assum ption underlying our approach fails.
$T$ he Boltzm ann equation hasbeen solved w ith in an expansion in Sonine polynom ials $S_{n}$. Truncation to order $n=2$, provides the rst non-G aussian corrections to the scaled velocity distribution, and leads to analyticalpredictions for the exponents and as a function of $d$. For large dim ension $d$, these predictions coincide $w$ th the exact $1=d$ correction to the naive $m$ ean eld values ( $=1$ and $=0$ ), calculated in '[ $[\uparrow]$. The above analytical predictions are in rem arkable agreem ent with the results of extensive num erical sim ulations we have perform ed for two dim ensional system s (im plem enting the com plem entary M onte Carlo and M olecular D ynam ics techniques). In 1D for regular continuous velocity distributions, it is notew orthy that they are in excellent agreem ent $w$ th the num erical solution of the Boltzm ann equation, and quite close to the exact values obtained with M olecular D ynam ics ( $4 \%$ di erence). This last point was unexpected since m olecular chaos breaks in 1D. F inally, the tim e dependence of the reduced velocity distribution function show s an unexplained and rem arkable feature, w ith the existence of xed ( $\backslash$ isobestic") points, irrespective of in itial conditions.
