# Vortex-Line Phase Diagram for Anisotropic Superconductors

# Abstract

The zero tem perature vortex phase diagram for uniaxial anisotropic superconductors placed in an external magnetic eld tilted with respect to the axis of anisotropy is studied for parameters typical of BSCCO and YBCO. The exact G lobs free energy in the London approximation, using a self-energy expression with an anisotropic core cuto , is minimized numerically, assum ing only that the equilibrium vortex state is a vortex-line-lattice with a single vortex line per primitive unit cell. The numerical method is based on sim ulated annealing and uses a fast convergent series to calculate the energy of interaction between vortex lines. A phase diagram with three distinct phases is reported and the phases are characterized in detail. New results for values of the applied eld close to the lower critical eld are reported.

### I. IN TRODUCTION

One in portant theoretical problem in the study of type-II superconductors is the zero temperature equilibrium vortex phase diagram for clean, uniaxially anisotropic, bulk materials subjected to an external magnetic eld, H tilted with respect to the axis of anisotropy (c-axis). In the case of isotropic materials the vortex phase is the well known triangular vortex-line lattice with the vortex lines oriented parallel to H. In anisotropic materials the vortex phase is still a vortex-line lattice but, in general, the lattice is not triangular nor are the vortex lines oriented along H [1,2].

P revious work indicate the vortex phases for the anisotropic superconductor are related to those for the isotropic one when H is oriented along the c-axis, in which case they are identical, when H is along the a-b plane or for H large compared with the lower critical eld [3]. In the latter two cases, the vortex-line-lattices are related to the triangular lattice by scaling and the vortex lines are essentially parallel to H. For general orientations of H this is not the case. The vortex phases were instructed by Buzdin and Sim onov [4] by numerically m inimizing the G ibbs free-energy in the London limit with m aterial parameters appropriate for YBCO.Our calculation, like their's, m inimizes the London G ibbs free-energy numerically. However, we go beyond the work of these authors by incorporating into our calculations recent results for the vortex state at the lower critical eld, not taken into account by them [5,6]. We show that this leads to new vortex phases close to the lower critical eld.

It was found rst by Grishin, Martynovich and Yam pol'skii [7] and later by others [8{10], that a pair of straight vortex lines parallel to each other and coplanar with respect to the c-axis attract at large distances. A consequence of this is that a chain of such lines has lower energy than the same vortex lines placed far apart. On the basis of this result Buzdin and co-workers [8,10] suggested that at the lower critical eld the mixed state consists of a vanishing sm all density of vortex line chains instead of vortex lines. However this argum ent does not apply in general. As pointed out in Ref. [6], in order to determ ine whether vortex lines or vortex-line chains constitute the vortex phase at the lower critical eld it is necessary to minimize the G ibbs free-energy for each one of them and obtain their respective lower critical elds. The one with the lower critical eld is the true equilibrium phase. One in portant aspect of the calculation of Ref. [6] is the use of an expression for the tilted vortex-line self energy with an appropriate an isotropic core cuto function. This expression was derived by Subdo and Brandt [11] and later used in Ref. [5] to show, by minimizing the London G ibbs free-energy for a vanishing sm all density of vortex lines, that for an isotropy param eters typical of BSCCO there is coexistence two such states, with di erent vortex lines tilt angles, for one particular orientation of H . These authors also showed that if a selfenergy expression based on an isotropic core cuto, such as the one adopted by Buzdin and Sim onov [8], is used instead, the coexistence disappears. It is found in Ref. [6] that at the lower critical eld and for an isotropy parameters typical of BSCCO the equilibrium vortex state for H tilted by  $< c = 7.9^{\circ}$  with respect to the c-axis is a dilute vortex-line chain state whereas for  $>_{c} = 7.9^{\circ}$  it is a dilute vortex-line one. For an isotropy parameters typical of YBCO Ref. [6] nds that the lower critical elds for vortex lines and vortex-line chains di er so little from each other that it is not possible do decide which one corresponds to true equilibrium .

In this paper, we minim ize the exact G ibbs free-energy in the London limit using Sudbo and B randt [11] expression the vortex line self energy. We assume that the equilibrium state the vortex lines are straight and parallel to each other and the VLL has only one vortex line per unit cell, and obtain the vortex lines orientation and VLL shape as functions of H, by minimizing the G ibbs free-energy in the London limit.

The free parameters in our calculation for given H, specified here by its magnitude, H, and its tilt angle with respect to the c-axis, , are the vortex lines tilt angle, , and the VLL primitive unit cell vectors  $L_1$  and  $L_2$ , defined in the plane perpendicular to the vortex lines. Since the vortex lines are straight and parallel to each other, the magnetic induction B is also tilted by with respect to the c-axis and, as explained in detail in Sec. IIA, it is coplanar with H and the c-axis. The orientations of H, B, and the c-axis, and the VLL primitive unit cell are shown in Fig.1. Hereafter we specify the VLL unit cell by the magnitudes of  $L_1$  and  $L_2$ , denoted by  $L_1$  and  $L_2$ , by the angle between  $L_1$  and  $L_2$ , ', and by and the angle of rotation of the VLL unit cell with respect to B, , as shown in Fig.1.

A sdiscussed in Sec. IIA, am inim um of the G ibbs free-energy occurs for = 0, where is de ned in Fig.1. We assume that this is the absolutem inim um and carry out the calculations with = 0. This means that  $L_1$  is also coplanar with H and the c-axis, oriented along the x-direction de ned in Fig.1. To simplify the calculations we set  $' = 90^{\circ}$ . This means that the VLL unit cell is a rectangle, with  $L_2$  perpendicular to the plane de ned by H, B and the c-axis (Fig.1). We nd that this simplications does not change our main results. Under these conditions we have only three free parameters, to be determined by minimizing the G ibbs free-energy: ,  $L_1$  and  $L_2$ . This minimization is carried out numerically, using a fast convergent series to calculate lattice sums entering the expression for the VLL interaction energy [13]. This series, together with the small number of free parameters, allow us to create an e cient and accurate numerical algorithm.

We study in detail the phase diagram for anisotropy parameters typical of YBCO and BSCCO.For YBCCO our results are essentially the same as those obtained by Buzdin and Sim onov, except very close to the lower critical eld. For BSCCO our results are new.

The main results of this paper are summarized in the generic phase diagram show in Fig. 2. We not three distinct phases, hereafter called phase-I, phase-II, and phase-III. We not that phase-I is new and closely related to the vortex-line equilibrium state at the lower critical eld. We also not that phase-II is essentially identical to that found by Buzdin and Sim onov and that phase-III is that expected for elds much larger than the lower critical eld. In this limit the VLL unit cell is related to that appropriate for the isotropic superconductor by scaling, and B ' H ( ' ) [3].

The lower critical eld in isotropic superconductors is independent of the orientation (), and has magnitude H<sub>cl</sub>. For H just above H<sub>cl</sub>, the vortex state corresponds to vortex lines parallel to H very far apart. In our notation this state is described by = and L<sub>1</sub>, L<sub>2</sub> = 1 . In a superconductor with uniaxial anisotropy, the magnitude of the lower critical eld depends on , hereafter denoted by H<sub>cl</sub>() [5]. The vortex state for H just above H<sub>cl</sub>() consists of vortex lines not parallel to H ( $\stackrel{6}{\leftarrow}$ ) in one of two possible con gurations, named dilute vortex line state (DVL) and dilute vortex-line chain state (DVLC) [6]. The DVL is sim ilar to the traditional vortex state for the isotropic superconductor, in the sense that L<sub>1</sub>, L<sub>2</sub> = 1, whereas the DVLC corresponds to vortex-line chains along the x-direction with period L<sub>1</sub>, very far apart, that is L<sub>1</sub> nite and L<sub>2</sub> = 1. The latter possibility results from

attractive interactions between vortex lines that only exist in anisotropic superconductors [7{10]. To decide if the DVL or the DVLC is the equilibrium vortex state it is necessary to calculate  $H_{cl}$  () for each one. The equilibrium con guration is that with the smallest  $H_{cl}$  (). This calculation is reported in Ref. [6]. The results for anisotropy parameters typical of BSCCO and YBCO, referred to as strong an moderate anisotropies, respectively, are shown in Fig. 3. It is found that for both an isotropies there is a value of the external eld tilt angle, c, around which the equilibrium vortex states undergoes a signi cant change. For > c and both for strong and moderate an isotropies the equilibrium state is a DVL with vortex lines tilted at ' 90°, that is parallel to the ab-plane. For strong anisotropy the vortex state for  $< _{\rm c} = 7.9^{\circ}$  is a DVLC with vortex lines tilted at < 60°. At = <sub>c</sub>, there is coexistence of a DVL and DVLC. A discontinuous change in takes place at =  $_{c}$ . For a moderate anisotropy, is found to change smoothly with and  $_{c}$ 20. The calculation on Ref. [6] nds that for moderate anisotropy the DVL and DVLC values of H  $_{\rm cl}$  ( ) are so close that their di erence is within the num erical errors of the calculation. We nd that phases I and II evolve, respectively, from the < c and > c vortex

states at  $H = H_{c1}$  (), represented by the horizontal line in Fig.2.

P hase-II is essentially an extension into the H > H <sub>cl</sub> () region of the phase diagram of the vortex state found for > <sub>c</sub> at H = H <sub>cl</sub> (). Its predom inant characteristic is that

90 and, consequently, the VLL within phase-II is essentially identical to that for vortex lines parallel to the ab-plane. In this case the unit cell is, approximately, related to that for the isotropic superconductor by scaling relations that depend only on the anisotropy. For strong and moderate anisotropies the unit cell is a rectangle elongated in the y-direction, that is  $L_1 = L_2$ . Phase-II is limited from above by the line H = H (), which gives the eld value around which changes from 90° to a lower value, accompanied by signi cant changes in the VLL unit cell. At = -c, H = -c, H = -c.

Phase-I is the region of the phase diagram where the VLL properties are strongly inuenced by the attractive interactions between pairs of vortex lines aligned along the xdirections. For both strong and moderate anisotropies we nd that phase-I is not limited to < , but it also exists in a small part of the region > , and H > H (). For strong anisotropy we nd that phase-I consists of vortex-line chains along the x-direction, with a period L1 that is nearly identical to that of an isolated chain with the sam e tilt angle (which di ers from that of an isolated vortex), separated from each other by  $L_2$  $L_1$ . This means that the attractive interactions between vortex lines prevail in determ ining the VLL periodicity along the x-direction. We also nd that as H ! H  $_{cl}$  ( ) from above, the equilibrium VLL approaches the sam eDVLC found in Ref. [6] for  $H = H_{cl}$  (). Form oderate an isotropy we obtain a new result for the vortex state at  $H = H_{cl}$  (). By extrapolating our data as H ! H () from above, we conclude that the vortex state at H =  $H_{cl}$  () is a DVLC. However, within phase-I for moderate anisotropy, the attractive interactions between vortex lines are so weak that vortex-line chains along the x-direction with periods close to those of isolated chains only exist within phase-I near  $H = H_{cl}$  (). However, distinctive behavior, due to attractive vortex-line interactions, can still be identi ed within phase-I.

This paper is organized as follows. In Sec. IIA we review London theory for the energy of the vortex-line system under consideration and the known results for the phase diagram at  $H = H_{cl}$  () and for particular cases at  $H > H_{cl}$  (). In Sec. IIB we discuss the numerical method used to minimize the G ibbs free energy. In Sec. III we report the results

of this m in imization, the detailed properties of each phase, and discuss how the phases are identified. Our conclusions are stated in Sec. IV. In the Appendix the relevant formulas for the fast convergent series used in our in our calculation are sum marized.

### II.M ETHOD OF CALCULATION

Here, we review London theory for this problem, its known results for the phase diagram, and describe some details of our num erical method.

# A.London Theory

To obtain the zero-tem perature phase diagram for a superconductor in an applied eld it is necessary to determ ine the vortex arrangem ent that m in in izes the G ibbs free-energy density

with H and the volum e kept constant. In Eq. (1) F is the vortex energy density and B is the magnetic induction. We assume that the zero-tem perature equilibrium vortex con guration consist of straight vortex lines, parallel to each other, arranged on a periodic VLL, with a single vortex line perprimitive unit cell. In this case B is parallel to the vortex lines direction and has magnitude  $B = _0=A_c$ , where  $A_c$  is the VLL primitive unit cellarea. M inimization of G gives then the vortex lines orientation and unit cell shape that corresponds to equilibrium. Because F is unchanged, if the vortex lines are rotated around the c-axis, the equilibrium B lies in the same plane as H and the c-axis. Thus, for H with magnitude H and tilted with respect to the c-axis, and on the parameters de ning the VLL primitive unit cell. In the system of axis de ned in Fig.1a, the generic VLL primitive unit cell lies in the x y plane, and is de ned by the primitive unit vectors  $L_1$  and  $L_2$ , as shown in Fig.1b. In this case  $A_c = L_1L_2 \sin'$ .

In the London lim it the superconductor is characterized by the penetration depths  $_{ab}$  and  $_{c}$ , for currents parallel to the ab-plane and to the c-direction, respectively. The free energy density of a generic arrangement of these vortex lines can be written as the sum of pairwise interactions [2]

where  $r_i$  is the i-th vortex-line position vector in x y plane, A is the sample area in this plane, and f (r) is the Fourier transform of

and g(k) is the vortex core cuto function [2,3]. It is costum ery to write G as

where  $"_{sf}()$  is the vortex line self-energy and  $"_{in}(;L_1;L_2)$  is the interaction energy per vortex line. In term s of f (r), de ned in Eq. (2), these quantities are given by

where  $R_i$  denotes the VLL positions ( $R_i = n_1L_1 + n_2L_2$ ,  $n_1$ ,  $n_2 = integer$ ).

The minim a of G, Eq. (5), are known in the following cases.

i) Lower critical eld:  $H = H_{cl}$  (). The equilibrium vortex phase at the lower critical eld is studied by Sudb , Brandt and Huse [5], assuming that it consists of a dilute arrangement of straight vortex lines (DVL). A coordingly, these authors minimize G, Eq. (5), neglecting "in, and using for "sf the expression derived by Sudb , and Brandt [11], based on an elliptic core cuto function,

In a recent publication by some of us [6], the Sudb , Brandt and Huse [5] calculation was generalized to account for two possible vortex phases at the lower critical eld: a dilute vortex-line state (DVL) considered by them and a dilute vortex-line chains arrangement (DVLC). The DVLC consists of vortex lines tilted with respect to the c-axis, parallel to one another, and aligned along the x-direction, form ing a periodic chain. This is possible because the interaction between a pair of such vortices is attractive at large distances [7{10}]. In Ref: [6], G, Eq. (5), is minimized in the limit of vanishing vortex density, for each one of these possibilities. For the DVL, "int is neglected in Eq. (5), whereas for the DVLC "int in Eq. (5) is identied with the interaction energy per vortex line of an isolated chain. The lower critical eld as a function of the tilt angle  $, H_{\rm cl}($ ) is then obtained for each possibility, and the equilibrium vortex phase at H = H\_{\rm cl}() is identied as that with the smallest H  $_{\rm cl}($ ).

In Ref: [6], two sets of an isotropy parameters are considered:

Strong an isotropy: = 10, = 1 = 200M oderate an isotropy: = 50, = 1 = 5

These values for an etypical of YBCO (moderate anisotropy) and BSCCO (strong anisotropy). The parameter for moderate anisotropy is typical of YBCO but for strong anisotropy is about ve times smaller than those typical of BSCCO [1]. However, this difference does not alter signicantly the phase diagram because only the self-energy depends on  $\cdot$ 

The main results of Ref. [6], sum marized in Fig. 3 are as follows. For both moderate and strong anisotropy and for  $>_{c}$  the vortex lines are nearly parallel to the a-b plane (90). For strong anisotropy  $_{c} = 7.9^{\circ}$  and form oderate anisotropy 20°. For strong anisotropy and  $<_{c}$  the vortex phase at H = H  $_{cl}$  () is a DVLC. For  $>_{c}$ , on the other hand, no signi cant di erence is found between the DVLC and DVL phases, because the vortex lines are tilted at 90, and at such tilt angles the equilibrium chain period is very large. Phase coexistence is also found for strong anisotropy at  $=_{c} = 7.9^{\circ}$ , but the coexisting phases are a DVLC and DVL, instead of the two DVL found in Ref. [5]. A discontinuous jump in takes place as crosses  $_{c} = 7.9^{\circ}$ . For moderate anisotropy the DVL and DVLC phases give nearly identical values for H  $_{cl}$  (), so that no conclusion on which is the equilibrium state is reached.

ii) =  $0^{\circ}$  and =  $90^{\circ}$ . In both cases = and the lower critical ed is related to the self energy by the usual form ula  $H_{c1}$  ( =  $0^{\circ};90^{\circ}$ ) = 4 "<sub>sf</sub> ( =  $0^{\circ};90^{\circ}$ )= 0. For = 0 the equilibrium VLL is the familiar isotropic superconductor triangular lattice, with  $L_1 = L_2 = L$  (  $_0=B \sin 60^{\circ}$ )<sup>1=2</sup>, ' = 60^{\circ} and undetermined. For = 90^{\circ} the x-direction coincides with the negative c-axis. The equilibrium VLL is related to that for = 0 (assuming  $L_1$  along the x-direction or = 0°) by the following scaling relations [1]

where  $L_0 = (_0=B \sin')^{1=2}$ , with  $' = 60^{\circ}$  for the triangular lattice. These results also apply if the  $= 0^{\circ}$  VLL is a square lattice, which will be considered in Sec. III, in which case  $' = 90^{\circ}$  in Eq. (9). The unit cell de ned by Eqs. (9) results from compressing the  $= 0^{\circ}$  VLL unit cell (with  $L_1$  along the negative c-direction) by  $^{1=2}$  along the cdirection and stretching it by  $^{1=2}$  in the ab plane. This transform ation conserves the unit cell area  $A_c = L_0^2 \sin'$ . The B vs. H curves for  $= 0^{\circ}$  and  $= 90^{\circ}$  are also related by scaling as follows [1,2]

iii) High elds (H  $H_{c1}$  ()). To a good degree of approximation the equilibrium VLL is related to the =  $0^{\circ}$  VLL by the scaling relations Ref. [3]

In this case B ' H, with B =  $_0=L^2 \sin'$ , with ' = 60° for the triangular VLL and ' = 90° for the square VLL.

A part from these cases, little else is known about the vortex phase diagram. Results for  $H = H_{cl}()$ , such as the occurrence of a DVLC as the equilibrium state, phase coexistence, and large di erences between and , suggest a low eld ( $H > H_{cl}()$ ) phase diagram that is non-trivial and that di ers considerably from the high-eld one. It is of interest then to obtain a full picture of the phase diagram. This is our main motivation here.

A coording to the discussion above, for a given H, G depends on ve independent variables,  $;L_1;L_2$ , or, equivalently, on  $;L_1;L_2;';$  (Fig. 1.b). It can be shown that the dependence of G on the angle of rotation of the VLL with respect to B, , is such that G has a minimum for = 0. We assume that this is the absolute minimum and, from here on, take = 0 in our calculations. In order to simplify the calculations, we x the value of the angle ' at ' = 90°. Thus, in the results reported here,  $L_1$  is along the x-axis and coplanar with B, H and the c-axis,  $L_2$  is along the y-axis, and the VLL unit cell is rectangular. We not that setting ' = 90° does not change the general picture for the phase diagram. W ith these restrictions G depends only on three variables:  $;L_1;L_2$ . In the rem ainder of the paper we use instead  $;L_1;B = _0 = (L_1L_2)$  as independent variables.

O ne novel aspect of our calculation is to account for the e ects of interactions between vortex lines in the zero-tem perature phase diagram . We nd that the simplem odel described above has a non-trivial low – eld phase diagram because attractive interactions between vortex lines give an important contribution to "int at low elds. The reason is that, as discussed above, the equilibrium VLL unit cell has  $L_1$  along the x-direction ( = 0). This means that the equilibrium phase consists of periodic vortex-line chains aligned along x, with period  $L_1$ , separated from each other by  $L_2$ . According to [7{10}, the interaction between a pair of vortex lines in the same chain is attractive if their separation x is greater than  $x_m$  ( ), and repulsive if  $x < x_m$  ( ). Thus, as long as  $L_1$  is not too small compared to  $x_m$  ( ), the vortex-line chains contribution to "int is predom inantly attractive and essentially negative. Interactions between interchain vortex lines are always repulsive, thus giving a positive contribution to "int.

In the DVLC state at  $H = H_{cl}()$ , these chains are in nitely far apart ( $L_2 = 1$ ) and  $L_1$  m inim izes "int for the equilibrium . In this paper, we obtain the vortex phases at  $H = H_{cl}()$  by extrapolating our results for  $H > H_{cl}()$ . For strong anisotropy, our results are in agreement with those of Ref. [6]. For moderate anisotropy, we not that the vortex phase at  $H = H_{cl}()$  is also a DVLC for < c, a result not obtained in Ref. [6].

Our results for the zero-tem perature phase diagram can be summarized in the generic phase diagram show in Fig.2, consisting of three distinct phases, whose main characteristics are discussed in Sec. I.

### B.Num erics

The main di culty to carry out the minimization of G, Eq. (5), is to evaluate the lattice sum in the expression for "in, Eq. (7). This can only be done numerically. However, the direct evaluation of this sum is impractical for our purposes, because it converges very slow ly. To circum vent this di culty we use the results obtained by D oria [13], who showed that the lattice sum in Eq. (7) can be transformed into a series that converges much faster than the direct sum .

Our numerical method uses a simulated annealing algorithm to locate the minim a of G. For a given H, specied by H and , the minimization of G is carried out in the space spanned by ;L<sub>1</sub>, and B. Our algorithm starts from a convenient choice for these variables and attempts to change them to new values that decrease G. Once a set of such values is found, another one is searched by repeating the procedure, and so on. This converges to a set corresponding to a minimum of G after several steps. For each new set of ;L<sub>1</sub>;B we calculate "in, using D oria's fast convergent series. This allows us to run the simulated annealing for a very large number of steps, and to obtain them inim a of G with high accuracy, except when H is very close to H<sub>c1</sub>(). In this case our method converges slow ly, because the VLL unit cell becomes very large and "in very small. A similar numerical method is described in Ref. [14]

#### III.RESULTS

Here we report in detail the results obtained by the numerical method described in Sec. IIB for strong and moderate anisotropies. To explore the (H; ) phase diagram we x and obtain the minim a of G for several values of  $H > H_{cl}$  (). By repeating this procedure for several we obtain the phase diagram. We check that these minim a are absolute ones by running the above described simulated annealing algorithm starting from distinct initial states, and selecting the minim a with the smallest G.

### A. Strong anisotropy

The main results are summarized in Figs. 4 and 5.

First, we argue that our results are consistent with the prediction, discussed in Sec. I, that at  $H = H_{cl}$  () the vortex con guration for  $< c = 7.9^{\circ}$  is a DVLC.

The existence of a DVLC at  $H = H_{cl}()$  for  $< _{c}$  m eans that as  $H = H_{cl}() ! 1$  the primitive unit cellsides behave as  $L_{1} ! L_{ch}$  (= chain period),  $L_{2} ! 1$ , and that "in, Eq. (5), approaches a negative value, equal to the interaction energy per vortex line in an isolated chain. Our results for  $= 7^{\circ}$  show exactly this behavior. The  $L_{1}=L_{2}$  curve in Fig. 4.c decreases continuously as  $H = H_{cl}() ! 1$ , indicating that  $L_{1}=L_{2}$  extrapolates to  $L_{1}=L_{2} = 0$  at  $H = H_{cl}()$ . On the other hand, the  $L_{1}$  curve in (Fig. 5.b) approaches a nite value. We not that the extrapolated values of  $L_{1}$ , and "in at  $H = H_{cl}()$  are  $L_{1} = ab = 2.8$ ,  $= 50^{\circ}$  and "in = 0 = 0.04. These values agree, within numerical errors, with the chain period, tilt angle and interaction energy per vortex line of the isolated vortex-line chain obtained in Ref. [6].

Next we consider the behavior for  $< _{\rm c}$  and H > H  $_{\rm cl}$  ( ).

For = 7° our results for the L<sub>1</sub> vs. H curve (Fig. 5b) show that there are two distinct behaviors. One for  $1 < H = H_{c1} (7^{\circ}) < 1.03$ , where L<sub>1</sub> increases with H, and another for  $H = H_{c1} (7^{\circ}) > 1.03$  where L<sub>1</sub> decreases with H. The "<sub>in</sub> vs. H curve changes slope at  $H = H_{c1} (7^{\circ}) = 1.03$ , and shows that "<sub>in</sub> increases continuously with H, being negative for  $H = H_{c1} (7^{\circ}) < 1.02$ . A decrease of L<sub>1</sub> with H is what is expected if interactions between

vortex lines are purely repulsive. This behavior is identified with phase-III (Fig. 2) and corresponds to the region where  $L_1=L_2 > 0.6$ ,  $< 23^\circ$  and  $"_{in} > 0$ . The increase of  $L_1$  with H, on the other hand, arises from attractive interactions between vortex lines. This can be seen by plotting  $L_1$  vs. for = 7, as shown in Fig. 5.c. This gure shows that in this range of H values,  $L_1$  is nearly equal to the period of an isolated vortex-line chain with the same = and has essentially the same H dependence. This is only possible if the attractive intrachain vortex-line interactions are strong compared to interchain repulsions. Further evidence for this is found in the negative values for "in . We identify the region  $1 < H = H_{c1} (7^\circ) < 1.03$  as phase-I and that for  $H = H_{c1} (7^\circ) > 1.03$  as phase-III. For  $= 7^\circ$  we also nd that  $L_2 > L_1$ , and that  $L_2$  decreases with H in such a way that  $L_1 = L_2$  increases with H as shown in Fig. 4.c.

A similar behavior is expected for other values of  $< _{\rm c}$ . For  $= 5^{\circ}$  we nd that the  $L_1=L_2$  curve shows a downtum as  $H=H_{\rm cl}$  ( $= 5^{\circ}$ ) decreases (Fig. 4.c), similar to that for  $= 7^{\circ}$ , suggesting that the limit value as  $H=H_{\rm cl}$  ()! 1 is small. We also nd that the limit value of as  $H=H_{\rm cl}$  ()! 1 (Fig. 4.a) agrees well with that obtained in Ref. [6]. A lthough, for  $5^{\circ}$ , we are unable to observe a region where  $L_1$  increases with H and "in < 0, we believe that the phase diagram for  $= 5^{\circ}$  and  $= 7^{\circ}$  are similar. One diculty with values of close to  $0^{\circ}$  is that the region where phase-I exists is so close to  $H=H_{\rm cl}$  () = 1 that the accuracy of our num erical method is insulcient to observe it.

Next we discuss the behavior for  $> _{\rm c}$  and H > H  $_{\rm cl}$  ( ).

Our results show that remains close to 90° in the range  $H_{cl}() < H < H()$  (Fig. 4.a). We not that for the results in this range the scaling relations discussed in Sec. I. For strong anisotropy = 1= 200, so that tan > 1= for > 86. A coordingly, the eld H() is obtained from the vs. H curve as the largest H for which > 86, as indicated in Fig. 4.a. For 10° and  $H_{cl}() < H < H()$  the  $L_1=L_2$  and B vs. H curves in Fig. 4 essentially coincide. The common curves are  $L_1=L_2 = 0.07$  and the B vs. H curve for = 90°, obtained from that for = 0° by the scaling relations Eq. (10). The behavior of  $L_1$ ,  $L_2$  and  $"_{in}$  in this region is that expected for repulsive interactions: as H increases,  $L_1$  and  $L_2$  decrease, and  $"_{in}$  increase (Fig. 4). From these results we identify the region  $H_{cl}() < H < H()$  as phase-II.

For H > H () and for = 10°, 15° and 20° the tilt angle decreases smoothly with increasing H (Fig. 4.a). The behaviors of L<sub>1</sub> and "<sub>in</sub> with H are not smooth. As shown in Fig. 5 there are regions where L<sub>1</sub> increases with H and the "<sub>in</sub> curve shows a dip, reaching negative values for = 10°. This behavior of L<sub>1</sub> is similar to that for = 7° <  $_{\rm c}$  in phase-I region. We also not that for 20° the VLL period along x, L<sub>1</sub>, is close that for an isolated vortex-line chain with the same , and has a similar H dependence (Fig. 5.c). In view of these similarities we identify the region where L<sub>1</sub> increase with H as phase-I. Thus the portion of the phase diagram occupied by phase-I extends into the region >  $_{\rm c}$  for H > H (), as shown in Fig. 2.

O ur results indicate that for strong an isotropy within phase-I the vortex-line chains along x have essentially the same period as an isolated chain tilted at the equilibrium  $\cdot$ .

We nd that as increases above  $= 20^{\circ}$  the region where  $L_1$  increases with H becomes smaller and the dip in "in decreases. Eventually these features disappear altogether at some , so that the phase-I region in the phase diagram is bounded as shown in Fig. 2.

Our results indicate that the transition from phase-II to phase-I is a sm ooth crossover,

with an intermediate region starting just above H () and ending when 70. In this region the  $L_1=L_2$  and B curves for  $= 10^\circ$ ,  $15^\circ$  and  $20^\circ$  show only small deviations from the scaling behavior of phase-II, with  $L_1=L_2$  smaller than the scaling value and the B curve slightly above the scaling one (Fig. 4). Behavior characteristic of phase-I, as described above, show s up only for  $< 70^\circ$ . The reason is is that for  $> 70^\circ$  interactions between intrachain vortex lines are predominantly repulsive because  $L_1 = x_m$  ().

For  $= 10^{\circ}, 15^{\circ}$  and  $20^{\circ}$  phase-I behavior ends at the H value where  $L_1$  stops increasing with H. For larger H, we nd that  $L_1$  decreases smoothly with H, with  $L_1=L_2$  1, and that "in increases with H (Fig. 4). We identify these regions as phase-III (Fig. 2).

## B.M oderate an isotropy

The results are similar to those for strong anisotropy and are sum marized in Figs. 6 and 7.

First we argue that as  $H = H_{c1}()$ ! 1 the equilibrium state approaches a DVLC for  $< 20^{\circ}$ . As seen in Fig. 6 c, for  $= 10^{\circ}$ ,  $15^{\circ}$  and  $20^{\circ}$ ,  $L_1=L_2$  approaches a small value as  $H = H_{c1}()$ ! 1, which we interpret as indicating that  $L_2$ ! 1. The  $L_1$  vs H and  $L_1$  vs. curves, shown in Figs. 7 b and 7 c, suggest that, as  $H = H_{c1}()$ ! 1,  $L_1$  approaches a nite value that is close to the period of an isolated vortex-line chain with the same [6]. The  $I_{in}$  vs. H curve shown in Fig. 7 a becomes negative as  $H = H_{c1}()$ ! 1 for  $= 10^{\circ}$  and  $13^{\circ}$  and extrapolates to a negative value at  $H = H_{c1}()$  for  $= 15^{\circ}$  and  $20^{\circ}$ . This behavior is only possible for a DVLC state at  $H = H_{c1}()$ .

Next we consider the behavior for  $< _{\rm c}$  and H > H  $_{\rm cl}$  ( ).

For  $= 10^{\circ}$ ,  $13^{\circ}$  and  $15^{\circ}$  the L<sub>1</sub> vs. H curves in Fig. 7 b show non-m onotonic behavior. A s H increases L<sub>1</sub> rst decreases, then increases and, nally, decreases m onotonically. This behavior suggests that attractive interactions between intrachain vortex lines are competing with repulsive interchain ones. This is further supported by the negative "<sub>in</sub>, for the same

values, shown in Fig.7b. We interpret as phase-I the H range starting from  $H = H_{cl}()$  and ending at the H value in Fig.7b where  $L_1$  stops increasing. However, the behavior in phase-I form oderate anisotropy di ers from that for strong anisotropy. The  $L_1$  vs. curve in Fig.7c shows that  $L_1$  di ers considerably from the equilibrium period of an isolated chain with the same and has a di erent H dependence.

We nd that for  $>_{\rm c}$  our results agree with phase-II behavior for H<sub>cl</sub>() < H < H (). For moderate anisotropy = 1=5, and tan > 1= for > 80. The eld H () is obtained from the vs. H curve as the largest H for which > 80, as indicated in Fig. 6 a. We nd that for H<sub>cl</sub>() < H < H () the L<sub>1</sub>=L<sub>2</sub> and B vs. H curves shown in Fig. 6 agree well with the scaling predictions Sec. I.

Thus we conclude that form oderate an isotropy the phase diagram is also like that shown in Fig. 2.

## IV . C O N C LU S IO N S

In conclusion, we obtain the zero-tem perature phase diagram for superconductors with anisotropy parameters typical of BSCCO and YBCO. Three distict phases are found and

In phase-II, we recover the results of Buzdin and Sim onov that reveal a large region of the phase diagram over which the vortex lines remain nearly parallel to the ab-plane. Moreover we nd the curve, H = H (), around which the vortex lines tilt away from the ab-plane. We also nd that this line starts at  $_{c}$  and  $H = H_{cl}(_{c})$  and that, as this line is being crossed, the VLL undergoes a structural change that becomes more and more abrupt as  $!_{c}$ .

Our results are obtained with the simplifying assumption that  $' = 90^{\circ}$ . We have also carried out the minimization of G, Eq. (5), with ' as independent variable. The results are identical to those reported above, except for the VLL unit cell shape which, in general, is not rectangular.

O ur present results seem to indicate that the equilibrium VLL changes smoothly with H and . In this case the phase boundaries in Fig. 2 are crossover lines. However, our data for strong anisotropy shows abrupt changes in the slope of the curves for , B and L<sub>1</sub> vs. H for H close to H<sub>cl</sub>(). These could result from a rapid crossover or from true discontinuities. It is found in Ref. [6] that, for strong anisotropy, if is changed and H is kept along the  $H = H_{cl}() = 1$  curve, there is a discontinuous change in  $at = c = 7.9^{\circ}$ , associated with coexistence of a DVLC state with a DVL one. This coexistence m ight remain for  $H = H_{cl}() > 1$  in the vicinity of c. In the present study we do not attempt to verify if there are true discontinuities. However, our num erical m ethod is capable of doing so. W ork on this topic is under way and will be reported elsewhere.

D oria showed that the lattice sum in Eq. (7) (with  $L_1$  along x) can be transformed in a fast convergent series [13]. The results are:

In the expression for "in, Eq. (A1),  $V_0$  (0) stands for  $V_0$  (u), Eq. (A2), for u = 0, or, in other words with the functions  $c_1, c_2$ , and  $_0$  in this equation evaluated at u = 0.

In our numerical calculations of " $_{in}$  we evaluate V<sub>0</sub>(0) by using the following generic approximation for the summations in eqs.(A2) and (A3)

where g(x) is an analytic function. By using M = 200 we obtain excellent num erical precision with m odest computer run times.

The integral in eq.(A1) is calculated using standard integration algorithms found in the literature, up to a precision of one part in  $10^8$ . We run typical calculations of 10-20,000 M etropolis steps for each run. The results obtained are easily reproducible.




FIG.1. De nition of coordinate system and VLL primitive unit cell. a) Relative orientations in the plane containing H, the c-axis and the equilibrium induction B. The x-axis is perpendicular to B and the y-axis is perpendicular to the plane H-B, pointing inside. b) G eneric VLL primitive unit cell in the x y plane.




FIG.2. Generic phase diagram in the (H; ) plane for both strong and m oderate anisotropy.




FIG.3. Results of Ref.[5] for H  $_{\rm cl}$  ( ) and  $\,$  vs. for: a) strong anisotropy, b) m oderate anisotropy




FIG.4. Numerical results for strong an isotropy. a) Vortex lines tilt angle. The full line =  $86^{\circ}$  corresponds to tan = 1=. The arrow indicates H (=  $10^{\circ}$ ). b) M agnetic induction. c) Ratio between VLL unit cell sides. The full line  $L_1=L_2$  = corresponds to the value predicted by scaling for =  $90^{\circ}$ 




FIG.5. Numerical results for strong an isotropy. a) Interaction energy per vortex line. A rrow indicate the value of H for  $= 10^{\circ}$ . b) VLL period along x. c) VLL period along x vs. tilt angle compared with the period of an isolated vortex-line chain tilted at the same angle (full curve)




FIG.6. Numerical results for moderate anisotropy. a) Vortex lines tilt angle. The full line =  $80^{\circ}$  corresponds to tan = 1= . b) M agnetic induction. c) Ratio between VLL unit cell sides. The full line  $L_1=L_2$  = corresponds to the value predicted by scaling for =  $90^{\circ}$ 




FIG.7. Numerical results for moderate anisotropy. a) Interaction energy per vortex line. b) VLL period along x. c) VLL period along x vs. tilt angle compared with the period of an isolated vortex-line chain tilted at the same angle (full curve)
