# System s of particles w ith interaction and the cluster form ation in condensed m atter

#### Abstract

W e investigate the behaviour of a system of particles with the di erent character of interaction. The approach $m$ akes it possible to describe system $s$ of interacting particles by statistical $m$ ethods taking into account a spatial nonhom ogeneous distribution of particles, i.e. cluster form ation. For these clusters are evaluated: their size, the num ber of particles in a cluster, and the tem perature of phase transition to the cluster state. Three system s are under consideration: electrons on the liquid helium surface, particles interacting by the shielding Coulomb potential, which are found under the in uence of an elastic eld (e.g. nucleons in a nucleus), and gravitating $m$ asses $w$ th the Hubble expansion.

## 1 Introduction

B asically, statisticaldescription ofm any-particle system s concems hom ogeneous states. In $m$ onograph [1], a generalm ethod based on quantum eld theory was successfully applied to hom ogeneous states of condensed $m$ edia. A $n$ approach that took

[^0]into account spatial nonhom ogeneous states of a system of particles was rst proposed in paper [2]; the approach was resting on the em ploym ent of the m ethodology of quantum eld theory as well. Them ost general approach to the description of a system ofparticles, which included the intenparticle interaction was o ered in paper [3] in which the procedure of discount of the num ber of states providing for the nonhom ogeneous particle distribution was proposed. H ow ever, a correct solution of nonlinear equations in the saddle-point is an im possible task for the $m$ ost part: the general approach does not perm it one obtains analytical solutions for a system of particles when the inverse operator of the interaction energy does not exist. In the inter'm we need to know a series of param eters which characterize possible clusters. The major param eters are the cluster size and the critical tem perature of cluster stability. Because of that, one can arise the question about a m ore sim pli ed approach, which, how ever, would allow the study of cluster form ation in an initially hom ogeneous system of particles.

In the present work we study a system of interacting particles having regard to the concept proposed in papers [2,4]. Such an approach reduces the number of variables, which determ ine the free energy and introduces a peculiar "com bined variable" [5] playing a role of a typical variable that describes the them odynam ics of the system with a spatial nonhom ogeneous particle order.

For instance, as an analog of a certain com bined variable one can consider the interaction of two waves on the water surface, which interfere in a lim ited range. H ow ever, after the interference the w aves depart and hence in this case the com bined variable does not bring into existence any instability of the system studied. On the other hand, the interaction of an incident electrom agnetic wave with a polar crystal results into the polariton, a stable form ation, which is indeed described by a com bined (canonical) variable \{ a m ixture of the electrom agnetic eld and optical phonon.

C an the combined variable give rise to the change in the hom ogeneous distribution of interacting particles? W e analyze such an option considering concrete exam ples. Below we take a look at the speci c system s w ith long-range repulsion/attraction and short-range attraction/repulsion. In particular, the approach provides a way of estim ating of the cluster size, the num ber of particles in a cluster and the tem perature ofphase transition to the cluster state. The approach is exam ined in three exam ples: i) electrons on the liquid helium surface, ii) particles w ith the shielding C oulom b interaction, which are found in an applied elastic potential, and iii) gravitating $m$ asses $w$ ith the $H$ ubble expansion.

## 2 Statistical m echanics for m odel system $s$ w ith interaction. T he princíple of states selection

Let us consider a m odel system of particles with arbitrary kinds of interactions. N evertheless, the de B roglie them alw avelength of a particle is taken to be greater than the $m$ ean distant lbetw een particles. H ow ever on the other hand, the value of
$m$ ust be sm aller than the $m$ ean am plitude of scattering. T he type of the statistics introduces signi cant peculiarities to the interparticle interaction, which, how ever, can be rendered by the classical $m$ ethods allow ing one does aw ay with dynam ic quantum correlations. In this case the $m$ acroscopic state of the system in question $m$ ay be speci ed by lling numbers $n_{s}$, where the symbol $s$ describes the state of the system. In other words, particles can occupy only knots are still non-occupied. $T$ his $m$ eans that the lling num bers $n_{s}$ can run only two $m$ eanings: 1 (the sth knot is occupied) or 0 (the sth knot is not occupied). B esides, the allocation of particles in the lattice invites the type of statistics, which set lim its on the behaviour of particles, i.e. the statistics refers particles to either bosons or ferm ions, see below .
$T$ he $H$ am iltonian of the system of interacting particles can be w ritten in the form

$w$ here $E_{s}$ is the additive part of the particle energy in the sth state; $\mathrm{v}_{\mathrm{ss}}{ }^{0}$ and $\mathrm{u}_{\mathrm{ss}}{ }^{0}$ are, respectively, the paired energy of attraction and repulsion between particles in the states $s$ and $s^{0}$. Signs before the potentials in expression (1) re ect the proper signs of the attractive and repulsive paired energies and therefore both of the functions $\mathrm{v}_{\mathrm{ss}}{ }^{0}$ and $\mathrm{u}_{\text {ss }}{ }^{0}$ are positive.

Such w riting of the $H$ am iltonian corresponds to the $m$ odel in which particles are found in sites of the three-dim ensional lattioe. A s w ill be evident from the further consideration, a speci c form of the lattice will be unneeded. H ow ever the m edium w ill be supposed isotropic at the transition to the continual approxim ation.
$N$ ote that the H am iltonian of the m odel of replacem ent of solid solutions [6] am ounts to the $H$ am iltonian (1) as well. This m eans that the approach proposing can describe the behaviour ofdefects in solids, allow s , liquids, etc. (in these cases one particle will characterize an un lled place and another particle that of a lled one). The reduced solution H am iltonian can be am ounted to a general Ising $m$ odel, which takes into account an arbitrary interaction allow ing the spatialnonhom ogeneous distribution of particles.

is full lled. In particular, condition (4) in principle could allow one to determ ine the inverse operator $\mathrm{w}_{\text {ss }}{ }^{1}$ (in the case when it is exist) which in its tum would perm it the construction of the $G$ reen function for interacting particles.

W e do not include the dependence on $m$ om entum of particles to the functional integrals in the partition function (5); the sum takes into consideration only the spatial distribution of particles and their energy.
$N$ ow we can settle the quantity of particles in the system, ${ }^{P}{ }_{s} n_{s}=N$. The procedure is an equivalent to the consideration of the canonical ensemble. For this purpose one can use the form ula known in the theory of com plex variable

Here, the function is equal to 1 (Ferm ior B ose statistics), see e.g. Refs. [79]. This provides the $m$ eans determ ining the necessary procedure of the states
selection that introduces the $m$ ost essential contribution to the partition function and de nes the free energy of the system. Let us set $z=+i$ and consider the action $S$ on the transit path passing through the saddle-point $w$ ith a xed in aginable variable Im $\mathrm{z}=0$. In this case, it stands to reason that the action $S$, sim ilarly to quantum eld theory, is the variational fiunctional that depends on three variables: the elds $s$ and $s$, and the fiugacity (here $=e^{=k_{B} T}$ where is the chem ical potential). The extrem um of the functional must be realized at solutions of the equations $S={ }_{s}=0, S={ }_{s}=0$, and $S==0$. These equations appear as the follow ing

Equations from (10) to (12) com pletely solve the problem of the statistical description of system swith any type of interaction. O ne or another of states of the system is realized in accordance w ith the solution of the nonlinear equations. Am ong the solutions there are solutions which correspond to the spatial nonhom ogeneous distribution of particles. So the B ose condensation is realized in the real space because we can say that an aggregation of particles is the B ose condensation of a sort. O ne of the possibilities of cluster form ation was dem onstrated in Ref. [2]; the nonhom ogeneous distribution of particles which were characterized by the shielded C oulom b interaction for both the attraction and the repulsion just yielded stable clusters. Such type of the interaction was chosen ow ing to the existence of the inverse operator of the interaction energy in an explicit form. N evertheless, it is a very di cult problem to nd the inverse operator am ong the most widespread types of interactions. This is why, there is the necessity to develop $m$ ethods which are capable to describe the particle distribution at any interaction. In $R$ efs. [ 4,5$]$ the approach based on the selection of states in the form of a "com bined variable" has been proposed. The com bined variable has given us the chance to nd connections betw een di erent elds (such as $s$ and $s$ in the present paper) along the extrem al path that passes through the saddle-point.

## 3 C om bined variable and the selection of states

This means that $s$ directly speci es the quantity of particles in the sth state. H ence the value s m ight be considered as a characteristic of the num ber ofparticles contained in the sth cluster. So it is quite possible to consider $s$ as the variable of particle num ber and, on the other hand, itm ay be called the com bined variable ow ing to the fact that it combines the variables s , s, and. Probably the introduction of the com bined variable is a rough approxim ation, but it adm its to determ ine the clusterization conditions in cases when the inverse operator of the interaction potential can not be found.

U tilizing the variable (13) we can represent the action (9) as a function of only tw o variables, s and , and it m akes possible to do aw ay with the inverse operators $\psi_{s s^{0}}{ }^{1}$ and $\mathrm{was}^{1}{ }^{1}$ in the nal expression.

It hasbeen show $n$ in $R$ ef. [5] that them inim um of the free energy based on expression (22) is lower than that obtained in the fram ew ork of the $m$ ean eld approxim ation. Indeed, let us assum e follow ing $R$ ef. [7] that $\mathrm{N}_{\mathrm{u}}$ and $\mathrm{N}_{\mathrm{v}}$ are num bers of particles getting into the in uence of the repulsive and attractive force respectively. The num ber of particles $s$ in a cluster can be put constant equals. Let interaction energies in the range of in uence of these foroes be change to their average values. In this case expression (22) becom es

where $U$ and $V$ are average values of the repulsive and attractive potential respectively. H ere, in the $m$ ean eld approxim ation the expression in the curly brackets coincides w th the free energy. The next term, i.e. the expression in the square bradkets decreases the free energy at < 1. This inequality, < 1, corresponds to the coherent state of a system of interacting particles. T hus the approach that is developing can be considered as a generalm ethodology of the $m$ ean eld theory applying to the nonhom ogeneous particle distribution.

Expression (22) is a function of only one variable and the fugaciy and it is applicable to any kind of the interaction, even though the inverse operator is unknow $n$. The m ost advantage of expression (22) lies in the fact that it provides a way of nding of such characteristics of the system as its size, the num ber ofparticles in a cluster and the tem perature of phase transition.

Now let us pass to continual variables into the action (22). Inasmuch as we are interested in the nonhom ogeneous distribution of particles in an indeterm inate
volum $e$, let a radius $R$ be the tting param eter of the system studied. A ssum e that the density of particles is distinguished from zero only in the cluster volum e. T hen Eq. (14) can be written as

Ifwem inim ize the action (34) by the variable, wew illbe able to de ne the num ber of particles in a cluster, the cluster size, and the tem perature ofphase transition that triggers the nonhom ogeneous distribution of particles. It m ust be em phasized that the de nition of the param eters ofnonhom ogeneous form ations requires only explicit
form s ofpotentials of interparticle interactions. T hen the system itselfw ill select the realization which $w i l l$ provide for the $m$ inim um of the free energy. N onetheless, we assum e by rst the availability of clusters and then the conditions and param eters of their existence are de ned.

Studying the phase transition of chusters to the spatialhom ogeneous distribution of particles, we should take into account the behaviour of the fugacity $=e^{=k_{B} T}$. Indeed, in the classical system the chem ical potential

Thereby when we investigate the action (34) searching for chusters at the tem perature $T<T_{c}$, we m ay neglect the last term as jln jis rather sm all in com parison with term $s w h i c h$ include highest orders of . H ow ever, if we consider the action (34) scanning for the critical tem perature $T=T_{c}$, we should retain the last term because in this case trends to a very sm all m agnitude such that jin $j \gg 1$ and yet other term $s$ decrease ow ing to the dim inution of the value of .

## 4 C lusters in condensed m edia

In this section we apply them ethodology developed above to system s ofparticles w ith long-range repulsion (attraction) and short range attraction (repulsion).

### 4.1 Electrons on liquid helium surface

The energy of electrostatic repulsion betw een electrons can be w ritten as $u_{s s^{0}}=$ $1=4 \quad 0 \quad Q=\left(\begin{array}{ll}r_{s} & r_{5}\end{array}\right)$ where $Q$ is the e ective charge of the electron in the helium Im. The attraction betw een electrons caused by the deform ation of the helium
Im can be taken as $V_{S s^{0}}=\frac{1}{2} \quad \mathrm{~m}\left(r_{s} \quad r_{5}\right)^{2}$ where the coe cient $\quad \mathrm{m}$ characterizes the elasticity of the helium m in respect to the deform ation caused by im bedded electrons (see, e.g. review [10]).

Then setting these values into expression (45) we get the num ber of electrons in a cluster: $\quad 10^{8}$. For the radius of the chuster we have $R=\left(\begin{array}{ll}3=4 & n\end{array}\right)^{1=3} \quad 10^{4}$ m . The critical tem perature $\mathrm{T}_{\mathrm{c}}$ estim ated from expression (47) is of the order of 100 $K$ that is far beyond the critical tem perature ( 4 K ) of the liquid helium m . Thus the them odynam ic condition of the liquid helium stability sets lim its on the real tem perature $T_{c}$ of the cluster existence.

The behaviour of electrons in the liquid helium m has been studied by m any researchers [10]. An experim ental appraisal of the $m$ ean num ber of electrons in a near-surface bubblon was approxim ately equal to $10^{8}$. The radius of the bubblon was estim ated as $10^{2} \mathrm{~cm}$. In such a m anner our qualitative evaluation of the values and $R$ is in agreem ent $w$ th the experim ental data.

### 4.2 Shielding C oulom b potential

Let particles be repulsed by the shielding Coulom b potential $u_{s s^{0}}=1=4 \quad 0$ $Q^{2} e^{j_{s}} r_{s} 0 j$ ( $\left.r_{s} \quad r_{5}\right)^{1}$, where is the e ective radius of screening of nucleons in a nucleus, and attracted by the potential $v_{\mathrm{ss}^{0}}=\frac{1}{2} \quad\left(\begin{array}{ll}r_{s} & \left.r_{5}\right)^{2}\end{array}\right.$ that can be created by $^{2}$ an outside reason (so is the force constant of an 0 -site elastic eld). In this case the param eters a and b (33) of the action (34) becom e

H ow ever, having found the fugacity , we now cannot follow the procedure described in the previous subsection. In a nucleus, the tem perature and the therm al de B roglie w avelength are others. In other w ords, we should exploit the law s of high energy physics, i.e. that the totalenergy of a nucleon is linked w th the $m$ om entum of the nucleon by the relation $\mathrm{E}=\overline{\mathrm{p}^{2} \mathrm{c}^{2}+\mathrm{m}^{2} \mathrm{c}^{4}}$. H ence in this case

The results obtained in this section $m$ ay account for the reasons of the atom ic nucleus stability from the $m$ icroscopic view point. The shielding $C$ oulom b potential $u=1=4 \quad 0 \quad Q^{2} e^{r}=r$ is the typical nuclear (Yukaw a) potential that provides for repulsion between protons. The potential $v=\frac{1}{2} r^{2}$, which is applied to nucleons, is ensured their mutual attraction. For example, setting $=4 \quad 10^{7} \mathrm{~N} / \mathrm{m}$ we obtain from expression (55) 30, which corresponds to the num ber of nucleons in a nucleus of zinc. The critical tem perature of ssion of a proton-neutron pair calculated from expression (60) results in $\mathrm{T}_{\mathrm{c}} \quad 10^{11} \mathrm{~K} . \mathrm{N}$ ote that this value is several tim es ofm agnitude greater than the typical tem perature of a weight nucleus (the nucleus tem perature is of the order of the C oulom b repulsion betw een protons in the nucleus).

### 4.3 G ravitating $m$ asses w ith $H$ ubble expansion

$G$ ravitational physics $m$ ay also be assigned to the condensed $m$ atter [11]. The gravitationalattraction between particles, i.e. big m asses, is beyond question. H ow ever the uniform character of the $H$ ubble expansion is in doubt. W e will use only the fact that an additional kinetic energy of particles $E_{s s^{0}}=\frac{1}{2} m\left(w_{s} \quad w_{s}\right)^{2}$ is associated $w$ th such an expansion. The relative velocity $w_{s} \quad w_{s} 0$ of particles which are found in points $s$ and $s^{0}$, respectively, pertains to the relative distance betw een the particles, since

In this connection, we will consider a m odel system of identical gravitating $m$ asses, i.e. stars, w th the attraction $V_{s s^{0}}=G m^{2}=\left(r_{s} \quad r_{0}\right)$ and the e ective repulsion $u_{s s^{0}}=\frac{1}{2} H^{2} \mathrm{~m}\left(r_{s} \quad r_{5}\right)^{2}$. For such kinds of interactions one has for the param eters $a$ and $b$ (33):

At the transition from the B ose statistics to the classical one, the chem ical potential gradually decreases w ith tem perature starting from a value 0 (but still < 0) to $\ll 0$. So, the fiunction ln in Eq. (68) is strongly negative: $\ln =j j \mathrm{kT}$. This signi es that the critical tem perature in the system of gravitating $m$ asses is absent. In other words, in the universe, $m$ asses trends to the aggregation at any conditions.

Thus the results obtained dem onstrate that the availability of the $H$ ubble expansion is the deciding factor in the form ation of galaxies in the universe (note that w ithout $H \mathrm{~m}$ asses in the universe w ill trend m erely to the totalm ergence and any spatialdistribution $w$ illnot be observed). A ctually, expression (67) show s that H ubble's constant, $\mathrm{H} \quad 50 \mathrm{~km} /\left(\mathrm{s} \mathrm{M} \mathrm{psc}\right.$ ) $=1: 6$ 1fo $\mathrm{s}^{1}$, is one of them ain param eters that determ ines the steady state ofm asses in a cluster, i.e., galaxy. So the greater the $m$ ean $m$ ass $m$, the greater the num ber of stars in a galaxy.

## 5 C onclusion

In the present paper the statistical description of a system of interacting particles, which allow s the study of their spatial nonhom ogeneous distribution, has been proposed. O ne of the $m$ ost im portant properties of our $m$ odel is the presentation of the totalpotential of interacting particles in the form of the paired energy of attraction and repulsion. W e have started from the H am iltonian that describes interacting particles located in knots of the three-dim ensional lattioe and applied the quantum eld theory $m$ ethodology based on the functional integrals for the description of the partition function of system s studied.

W e have show $n$ that the solutions ofequations characterizing the behaviour of the eld variables yield the full resolving the initial statistical task. T he solutions $m$ ay
correspond to both the hom ogeneous and nonhom ogeneous distributions of particles and only the character of interparticle interaction and the tem perature de ne the kind of the solution.

The free energy represented through eld variables in the saddle-point has allow ed us to investigate specialconditions, which provide for the form ation ofchusters in a system with the initially hom ogeneous particle distribution. T he conditions are answ erable also for the size of clusters and the tem perature of phase transition to the cluster state.

The approach proposed does not need tting param eters: the cluster size and the tem perature of phase transition to the cluster state are com pletely determ ined by the value and character of paired potentials in the system s of interacting particles. Besides, the introduction of a peculiar type of the com bined variable has sm pli ed the investigation procedure. Speci cally, the procedure has provided a way for the obtaining the necessity criterion of the transition of a system of separate particles into the spatial nonhom ogeneous state.
