# REVISITING THE DERIVATION OF THE FRACTIONAL DIFFUSION EQUATION

# A bstract

The fractional di usion equation is derived from the master equation of continuous time random walks (CTRW s) via a straightforward application of the Gnedenko-Kolmogorov limit theorem. The Cauchy problem for the fractional di usion equation is solved in various important and general cases. The meaning of the proper di usion limit for CTRW s is discussed.

## 1. INTRODUCTION

This paper provides a short, but self-contained, introduction to fractional di usion. The readers will not the basic ideas behind the derivation of the fractional di usion equation starting from continuous-time random walks. We have included formulae for the solution of the Cauchy problem which can be numerically implemented and used for applications. Special care has been used to avoid unessential mathematical technicalities. Even if far

from exhaustive, the bibliography should give a su cient number of entry points for further reading. The following sections are based on a series of papers about the application of fractional calculus to  $nance^{1/2/3}$ .

It is our hope that theoretical and experim ental condensed matter physicists will not this work useful.

The paper is divided as follows. In Section 2, we outline the theory leading to the time-fractional master equation. In Section 3, the transition to the space-time fractional discussed. Section 4 is devoted to the solutions of the Cauchy problem for the fractional discussed in Section 5. In Appendix A and Appendix B, we introduce the denitions of fractional derivatives in time and space, respectively, entering the fractional discussed usion equation.

# 2. STEP ONE: TRANSITION TO THE TIME-FRACTIONAL MASTER EQUATION

Let x be the position of a di using particle in one dimension. Let us assume that both jumps  $_{i} = x(t_{i})$   $x(t_{i-1})$  and waiting times between two consecutive jumps  $_{i} = t_{i}$   $t_{i-1}$  are i.i.d. random variables described by two probability density functions: w() and (). A coording to the model of continuous-time random -walk (CTRW), introduced by Montroll and Weiss<sup>5;6</sup>, the evolution equation forp (x;t), the probability of noting the random walker at position x at time instant t; can be written as follows, assuming the initial condition p(x;0) = (x) (i.e. the walker is initially at the origin  $x = 0)^{2}$ ,

The master equation of the CTRW can be also derived in the Fourier-Laplace domain.

The integral  $^{\circ}_{0}$  (t<sup>0</sup>) dt<sup>0</sup> represents the probability that at least one step is taken at som e instant in the interval [0; ). Thus, ( ) is the probability that the di using quantity x does not change value during the time interval of duration after a jump.

In a paper by M ainardi et al.<sup>2</sup>, an alternative form of Eq. (2.2) was presented in terms of a convolution between the rst time derivative of p(x;t) and a suitable kernel. The resulting equation can be interpreted as an evolution equation of generalized Fokker-P lanck-K olm ogorov kind. It reads:

where the \auxiliary" function (t) is such that (t) =  ${}^R_t$  (t t 0) (t 0) dt Eq. (2.3) can be obtained by Fourier-Laplace transform ing Eq. (2.1) and by suitable assumptions on the Laplace transform of the function (t).

In general, a CTRW is a non-M arkovian process. A CTRW becomes M arkovian if (and only if) the above memory function is proportional to a delta function so that (t) and (t) dier only by a multiplying positive constant. By an appropriate choice of the unit of

tim e, we can write (t) = (t); t 0: In this case, Eq. (2.3) becomes:

Up to a change of the unit of time, this is the most general master equation for a Markovian CTRW; Saichev & Zaslavsky call it the Kolm ogorov-Feller equation 7.

Eq. (2.3) allows a natural characterization of a peculiar class of non-M arkovian processes, where the mem ory function, (t) has power-law timedecay. Within this class, an interesting choice is the following:

In this case, (t) is a weakly singular function that, in the limit! 1; reduces to (t) = (t); according to the formal representation of the Dirac generalized function, (t) =  $t^{-1}$  = (0);  $t^{-1}$  = 08. As a consequence of the choice (2.5)2, Eq. (2.3) can be written as:

where @ =@t is the pseudo-di erential operator explicitly de ned in the Appendix A, that we usually call the Caputo fractional derivative of order : Eq. (2.6) is a time-fractional generalization of Eq. (2.4) and can be called time-fractional Kolmogorov-Feller equation.

Our choice for (t) in plies peculiar forms for the functions (t) and (t) generalizing the exponential behaviour of the waiting time density in the Markovian case. In fact, we have for t  $0^2$ :

denotes an entire transcendental function, known as the M ittag-Le er function of order; de ned in the complex plane by the power series

D etailed in form ation on the M ittag-Le er-type functions is available in the literature  $^{9;10;11}$ . From the properties of the Mittag-Le er function, it can be shown that the corresponding survival probability and waiting-time poff interpolate between a stretched exponential, for small waiting times, and a power-law decay, for large waiting times. Such a behaviour has been observed in M ainardiet  ${\rm al}^2$  and in R aberto et  ${\rm al}^3$ , where the function () has been estim ated from empirical nancial data.

As a nal remark, it is important to notice that dierent choices of the kernel (t) in eq. (2.3) are possible, leading to di erent properties of the waiting-time pdf and di erent generalized Kolmogorov-Feller evolution equations for p(x;t).

## 3. STEP TW O: THE DIFFUSION LIM IT

In the physical literature, m any authors have discussed the connection between continuous time random walks and di usion equations of fractional order, with dierent degrees of detail  $^{12}$   $^{23}$ . A sound proof of the equivalence between fractional di usion and CTRW has been given by Hilfer & Anton  $^{16}$ . However, in order to perform the transition to the di usion limit, we shall use a dierent approach. We shall start from Eqs. (2.4) and (2.6), and pass through their Fourier-Laplace counterparts. The stochastic process whose probability density evolves according to those equations is a random walk originating from a sequence of jumps, each jump being a sample of a real random variable Y. During the time interval  $t_n$   $t < t_{n+1}$ ; the particle position is  $Y_1 + Y_2 + \dots + Y_n : The Y_k$  are i.i.d: random variables all described, as Y, by the pdf w(x). Let us denote by w() the characteristic function corresponding to the probability density w(x).

Let us specify some conditions on the pdf w (x). The requirement is that, if = 2:

Let us now consider a sequence of random process pdf  $^0$ s  $p_h$  (x;t) describing scaled jumps of size  $h Y_k$  instead of  $Y_k$ ; with a speed increase of the process by a factor (the scaling factor)  $^{1=}h$ ; where must satisfy some conditions which will be specified later. The pdf of the jump size is  $w_h(x) = w(x=h)=h$ ; so that its characteristic function is  $w_h(x) = w(x)=h$ ; for 0 < 2 and 0 < 1, Eq. (2.6) (including (2.4) in the special case = 1) is replaced by the sequence of equations

By Fourier-Laplace transform ing and by recalling the Laplace transform of the Caputo time-fractional derivative, de ned by Eq. (A.2), we have

We shall now present arguments based on the classical central limit theorem or on the Gnedenko limit theorem, (see the book by Gnedenko & Kolmogorov $^{24}$ ) both expressed in terms of the characteristic functions. The Gnedenko limit theorem is a suitable generalization of the classical central limit theorem for space pdf $^{0}$ s with in nite variance, decaying according to condition (32).

The transition to the di usion  $\lim$  it is based on the following Lemma introduced by G oren  $o^{25}$ :

By inversion and using the Fourier transform of the Riesz space-fractional derivative, de ned in Eq. (B 2), we nally obtain the equation:

which is a space-time fractional diusion equation. In the limiting cases = 1 and = 2, Eq. (3.10) reduces to the standard di usion equation.

We have presented a formally correct transition to the diusion limit starting from the general master equation of the CTRW, namely Eq. (2.1) or Eq. (2.3). By invoking the continuity theorem of probability theory, see e.g. the book by Lukacs26, we can see that the random variable whose density is  $p_h(x;t)$  converges in distribution ("weakly" or "in law") to the random variable with density  $p_0(x;t)$ :

## 4. SOLUTIONS AND THEIR SCALING PROPERTIES

For the determ ination of the fundam ental solutions of Eq. (3.12) in the general case f0 < 2; 0 < 1g the reader can consult G oren o et al.  $^{27}$  and M ainardi et al.  $^{29}$ . W e also refer to the above references for the particular cases f0 < 2; = 1g and f = 2; 0 < 1g, already dealt with in the literature.

For param eters in the interval 0 < 2, and 0 < 1, the Cauchy problem in Eq. (3.12) can be solved by means of the Fourier-Laplace transform method.

The solution (G reen function) turns out to be:

Remarkably, a composition rule holds true, and it can be shown that the G reen function for the space-time fractional di usion equation of order and can be written in terms of the G reen function for the space-fractional di usion equation of order and the G reen function for the time-fractional di usion equation of order  $2^{29}$ :

### 5. SUM MARY AND DISCUSSION

Applications of fractional di usion equations have been recently reviewed by Uchaikin & Zolotarev<sup>30</sup> and by M etzler & K lafter<sup>22</sup>. A fter that, other contributions appeared on this issue, am ong which we quote the paper of Zaslavsky in the book edited by Hilfer 1, the papers by M eerschaert er al.  $^{32}$  and by P aradisi et al.  $^{33}$  and the letter by W est and N onnenm acher  $^{34}$ .

In this paper, a scaling method has been discussed to get the transition to the diusion lim it in a correct way, starting from the CTRW master equation describing the time evolution of a stochastic process. Moreover, the solutions of the Cauchy problem for the fractionaldi usion equation have been listed for the various relevant values of the fractional derivative orders and .

Various form ulae which can be useful for applications have been presented. In principle, given a di using quantity, the waiting (tim e density, the jum p density, and the probability of nding the random walker in position x at timet are all quantities which can be empirically determ ined. Therefore, many relationships presented above can be corroborated or falsi ed in speci c contexts.

As a further remark, it may be useful to add some comments on the meaning of the di usion lim it taken in section 3.

The factor h can be viewed as causing the jump process to run faster and faster (the waiting times becoming shorter and shorter) as his becomes smaller and smaller. Replacing the density w (x) by the density  $w_h(x) = w(x=h) = h$ ; and, accordingly, the jumps Y by hY; m eans that the jum p size becom es smaller and smaller as the scaling length h tends to zero.

An alternative interpretation is that we look at the same process with a discrete number of jumps occurring after nite times, from far away and after long time, so that spatial distances and time intervals of normal size appear very small, being x replaced by x=h; t replaced by  $t=(1^{-1} h^{-1})$ :

## APPENDIX A: THE CAPUTO TIME-FRACTIONAL DERIVATIVE

For readers' convenience, here, we present an introduction to the Caputo fractional derivative starting from its representation in the Laplace domain and pointing out its dierence from the standard Riemann-Liouville fractional derivative. In so doing we avoid the subtleties lying in the inversion of fractional integrals.

Eqs. (A 1-4) can be extended to any non integer > 1; (see e.g. the survey by G oren o & M ainardi<sup>10</sup>). We refer to the fractional derivative de ned by (A 2) as the C aputo fractional derivative, as it was used by C aputo form odelling dissipation e ects in linear viscoelasticity in the late sixties  $^{35;36;37}$ .

This de nition di ers from the usual one named after Riemann and Liouville, given by the rst term in the R H S. of (A A), and de ned e.g. in the treatise on Fractional Calculus by Sam ko, K ilbas & M arichev<sup>38</sup>.

Goren o & Mainardi<sup>10</sup> and Podlubny<sup>39</sup> have pointed out the usefulness of the Caputo fractional derivative in the treatment of dierential equations of fractional order for physical applications. In fact, in physical problems, the initial conditions are usually expressed in terms of a given number of boundary values assumed by the eld variable and its derivatives of integer order, despite the fact that the governing evolution equation may be a generic integro-dierential equation and therefore, in particular, a fractional dierential equation.

## APPENDIX B: THE RIESZ SPACE-FRACTIONAL DERIVATIVE

The fractional derivative de ned by (B 2) can be called Riesz fractional derivative, as it is obtained from the inversion of the fractional integral originally introduced by M arcel Riesz, known as the Riesz potential $^{38}$ . The representation (B 2) $^{25}$ , is more explicit and convenient than others found in the literature 7,38. It is based on a suitable regularization of a hyper-singular integral.

For = 2, the R iesz derivative reduces to the standard derivative of order 2, as  $jj^2 =$ 2:

For = 1, the R iesz derivative is related to the H ilbert transform, resulting in the form ula

The notation used above is due to Saichev & Zaslavsky7. A di erent notation which takes into account asymmetries was used by Goren o & Mainardi $^{40;41}$ .
