Seven energy/tem perature scales in hole-doped cuprates

A bstract The purpose of this paper is to discuss a phase diagram of hole-doped cuprates. Holedoped cuprates have a very rich phase diagram as a function of doping. This is due to a charge inhom ogeneity in CuO₂ planes: the charge distribution in CuO₂ planes is inhom ogeneous both on a nanoscale and macroscale. Depending on the doping level, the CuO₂ planes comprise at least four di erent types of clusters having a size of a few nanom eters. Each type of clusters has its own features. As a consequence, the common phase diagram consists of, at least, seven di erent energy/tem perature scales. As an example, we consider a phase diagram of Bi₂Sr₂CaCu₂O_{8+x}.

I. IN TRODUCTION

The phenom enon of high- T_c superconductivity was discovered in cuprates [1]. The understanding of a phase diagram of cuprates is in portant since it is directly related to the understanding of the physics of high- T_c superconductors.

In the literature, one can nd a few di erent phase diagram s for superconducting cuprates. A s an example,

qure 1 shows four di erent phase diagram sofhole-doped cuprates, taken from the literature. All four phase diagram s show the commensurate antiferrom agnetic phase at low doping levelp and the superconducting phase with a transition temperature T_c. These two phases are longranged. The commensurate antiferrom agnetic phase appears at a N eel tem perature T_N . If in La_{2 x} Sr_xCuO₄ (LSCO), these two phases are separated by some distance, in $YBa_2Cu_3O_{6+x}$ (YBCO) the distance between them is almost absent. In spite of this and some other small di erences, there is good agreem ent on the existence of these two phases in the phase diagram of superconducting cuprates. In gure 1, one can see that the disagreem ent am ong all these phase diagram sism ainly in the dispositions of the tem perature scales situated above the superconducting phase. In other words, there is no consensus on the physics of norm al state of cuprates.

Soon after the discovery of high- T_c superconductivity it becam e clear that the understanding of norm al-state properties of cuprates is crucial for the understanding of the mechanism of high- T_c superconductivity. Indeed, there is an interesting contrast between the developm ent of the physics of cuprates and that of the physics of conventional superconductors. Just before the creation of the BCS theory, the norm al-state properties of conventionalm etals were very well understood; how ever superconductivity was not. The situation with the cuprates was just the opposite: at the time high- T_c superconductivity was discovered, there already existed a good understanding of the phenom enon of superconductivity, but the norm al-state properties of the cuprates were practically unknown. W hat is interesting is that 16 years after the discovery [1] their norm al-state properties are still \unknown." The problem is not that there is no explanation of these unusual properties, the problem is that there are too m any of them.

There is good agreement on the existence of the socalled pseudogap which occur at T > T_c . There is even consensus on the doping dependence of pseudogap in hole-doped cuprates: the magnitude of pseudogap decreases as the doping level increases. How ever, here the common agreement ends. Further there is a polarization of opinions based either on di erent measurements or on di erent theories. First, there is no yet consensus on the presence of preformed C coper pairs above T_c in cuprates. Secondly, there is no agreement on the exact doping dependence of temperature (energy) scale T.

The question concerning the presence of preformed Cooper pairs above T_c in cuprates is not the main topic of this paper, therefore we are not going to discuss it here. There are enough evidence in the literature for the presence of preform ed C ooper pairs above T_c in cuprates (see references in [2] and [3]). The purpose of this paper is to discuss the second issue raised above, namely, the doping dependences of di erent tem perature/energy scales in hole-doped cuprates and their origins. Holedoped cuprates have a very rich phase diagram as a function of doping. This is due to a charge inhom ogeneity in CuO_2 planes: the charge distribution in CuO_2 planes is inhom ogeneous both on a nanoscale and m acroscale. D epending on the doping level, the CuO₂ planes com prise at least four di erent types of clusters having a size of a few nanom eters. Each type of clusters has its own features. As a consequence, the common phase diagram consists of, at least, seven di erent energy/tem perature scales. As an example, we consider a phase diagram of $B_{1_2}Sr_2CaCu_2O_{8+x}$ (Bi2212).

II.D IFFERENT PHASE DIAGRAM S

In gure 1, the rst two phase diagrams are based on experimental data: the phase diagram shown in gure 1 (a) is mainly inferred from nuclear magnetic resonance, speci cheat and resistivity measurements (see references in [3]). The phase diagram in gure 1 (b) is based on tunneling and angle-resolved photoemission (ARPES) measurements. In gure 1 (b), the pseudogap temperature scale T is inferred from bias positions of humps in tunneling and ARPES spectra, while the positions of main peaks in these spectra determine the pairing temperature/energy scale T_0 corresponding to the formation of incoherent C coper pairs. The phase diagrams in gures 1 (c) and 1 (d) are purely theoretical and based on the idea of the existence of two types of superconductivity: an unconventional type in underdoped cuprates and a BCS type in overdoped cuprates. They emerge near the optim ally doped region of superconducting phase.

Leaving the phase diagram s shown in gures 1 (c) and 1 (d) for further theoretical considerations, we focus our attention exclusively on experimental data presented in

gures 1 (a) and 1 (b). The question is why do di erent experim ental techniques give di erent energy/tem perature scales? This question is directly related to the understanding of norm al-state properties of cuprates.

III.PHASE DIAGRAM OF BI2212

Figure 2 shows an idealized phase diagram of Bi2212 taken from [3], in which the spin-glass tem perature scale T_{q} is added. This temperature/energy scale was recently observed in Bi2212 by muon spin relaxation measurem ents [4]. Figure 2 shows six di erent tem perature/energy scales in Bi2212. The seventh tem perature scale the com m ensurate antiferrom agnetic phase at low doping level is not shown because it was not yet observed in Bi2212: There is a technical problem to synthesize large-size good-quality undoped single crystals of Bi2212, which are necessary for neutron scattering measurem ents. In fact, the com m ensurate antiferrom agnetic phase is not the prim ary focus of this paper. It is worth noting that the phase diagram of Bi2212 in gure 2 is not universal but re ects main features of the physics involved in all cuprates. First, the tem perature scales in gure 2 will be given explicitly, and then we discuss their origins.

The superconducting phase appears at a critical tem – perature T_c shown in gure 2. In Bi2212, the doping dependence T_c (p) can be expressed [5] as

For Bi2212, T_{cm} ax = 95 K. The superconducting phase is approximately located between p = 0.05 and 0.27, having the maximum critical temperature T_{cm} ax in the middle, thus at p ' 0.16. The corresponding phasecoherence energy scale _c is proportional to T_c as 2 _c = $k_B T_c$, where k_B is the Boltzm ann constant. In di erent cuprates, the coe cient is slightly di erent: '5:4 in Bi2212; '5.1 in YBCO; and '5:9 in T $_{2}Ba_{2}CuO_{6}$ (T12201) [3].

In the literature, there are ample evidence for the existence of the so-called quantum critical point in cuprates (see references in [3]). In a quantum critical point located at/near absolute zero, the magnetic order is about to form or to disappear. In gure 2, the quantum critical point in B i2212 exists at p' 0.19. At low temperature, superconductivity in cuprates is most robust at this doping level p = 0.19, and not at p = 0.16 (see below why).

In gure 2, the temperature scale $T_{M T}$ starts/ends in the quantum critical point (M T = M agnetic Transition). Then, it is more or less obvious that this tem – perature/energy scale has a magnetic origin. The tem – perature scale $T_{M T}$ is analogous with a magnetic transition temperature of long-range antiferrom agnetic phase in heavy fermions [3]. The doping dependence $T_{M T}$ (p) can be expressed as

where $T_{M T,0} = 970\{990 \text{ K} \text{ (see references in } \beta]\text{)}$. As was mentioned above, this energy scale is inferred from resistivity, nuclear magnetic resonance and speci c heat measurements. Magnetic uctuations are strong along the transition temperature $T_{M T}$ (p).

In gure 2, the energy scale with a characteristic tem – perature $T_{C\,0}\,$ corresponds to a charge ordering (CO) in shape of quasi-one-dimensional stripes. A structural phase transition precedes the charge ordering. The doping dependence $T_{C\,0}\,$ (p) can approximately be expressed as follows [3]

The corresponding charge gap $_{cg}$ observed in tunneling and ARPES spectra depends on hole concentration as

In cuprates, m anganites and nickelates, the charge ordering always precedes a m agnetic ordering (M O) [3]. In

gure 2, the energy scale with a characteristic tem perature $T_{\rm M~O}$ corresponds to an antiferrom agnetic ordering occurring in insulating stripes which separate charge stripes. This magnetic ordering stabilizes the charge order which becomes long-ranged at $T_{\rm M~O}$. The doping dependence $T_{\rm M~O}$ (p) can be expressed as follow s

The dynam ical two-dimensional magnetic stripes can be considered as a local memory e ect of the commensurate antiferrom agnetic phase. In gure 2, the tem perature scale T_{pair} corresponds to the form ation of C ooper pairs, the doping dependence of which can be expressed as

The corresponding pairing energy scale $_{\rm p}$ depends on doping level as follows

The pairing gap m an ifests itself in tunneling and ARPES m easurements. The extensions of three dependences $T_{C\,O}$ (p), $T_{M\,O}$ (p) and T_{pair} (p) cut the horizontal axis approximately in one point, at p = 0.3.

In gure2, the spin-glass tem perature scale T_g is shown schem atically. For example, the tem perature scale T_g in LSCO linearly increases as the doping starts to increase from zero, reaches its maximum when it crosses a N eel tem perature scale $T_{\rm N}$, and then decreases to zero as the doping increases. In Bi2212, T_g '8 K at p=0.05, and $T_g=0$ som ewhere at p'0.15 [4].

It is worth noting that, in rst approximation in Bi2212, the two energy scales with characteristic tem – peratures $T_{C\,0}$ and $T_{M\,T}$ intersect the vertical axis in one point, at T 980 K. Som e discussion on this issue can be found elsewhere [3].

It is necessary to mention that the above form ula are approximate. To understand why, consider just one tem – perature/energy scale | the charge ordering scale $T_{C\,O}$. From acoustic measurements, it is well known that any structural phase transition has a hysteresis on low ering and on increasing the temperature. Since in cuprates, a structural phase transition precedes the charge ordering, its hysteresism ay a left the charge ordering temperature scale. As a consequence, the above expression for $T_{C\,O}$ (p) is most likely approximate. Secondly, the realdoping dependences of temperature scales $T_{M\,T}$, $T_{C\,O}$, $T_{M\,O}$ and T_{pair} , most likely, are not linear but quasi-linear.

IV.CHARGE IN HOM OGENEIT IES: PHASE SEPARATION

Let us go back to the question raised above: W hy do di erent experim ental techniques give di erent energy/tem perature scales? A s a m atter of fact, this question is related to another question, nam ely, how is it possible that there are severalm agnetic tem perature/energy scales in one phase diagram (see gure 2)?

Consider CuO_2 planes at di erent doping levels. In undoped region (p < 0.05), the doped holes gather into clusters having a size of a few nanom eters. These clusters are embedded in an antiferrom agnetic background where the long-range antiferrom agnetic order is preserved. In the clusters, the holes are not distributed hom ogeneously, but they form quasi-one-dimensional stripes along the diagonal direction relative to the Cu {O {Cu bonds [6]. In gure 3, this type of clusters is marked by B. The spin

glass appears in these clusters at T_q [6]. In underdoped region, thus above p = 0.05, the charge stripes in most clusters are rotated by 45 relative to those in undoped region. Thus, they now run along the Cu{O {Cu bonds, and the distance between stripes becom es sm aller than that between diagonal stripes. How ever, in a small fraction of clusters, the charge stripes remain diagonally oriented. This explains the existence of spin glass in the superconducting phase. The clusters with vertically (horizontally) oriented charge stripes are schematically shown in gure 3 by C. Thus, in deep underdoped region, the two types of clusters with vertical stripe order and with diagonal stripe order are em bedded in an antiferrom agnetic background. Therefore, the long-range antiferrom agnetic phase which is usually located at low doping level extends to higher dopings. The doped holes are sucked out by the clusters. As a consequence, the N eel tem perature scale T_N literally transform s into the tem perature scale $T_{M T}$ shown in gure 2. In a sense, the tem perature scale $T_{M\ T}\,$ is an echo of the T_N scale.

N ear optim ally doped region, the picture is di erent: now clusters with intact antiferrom agnetic order are em – bedded in a charge-stripe background. In gure 3, the antiferrom agnetic clusters are shown by A. At p = 0.19, this type of clusters com pletely vanishes, as schem atically shown in gure 4 (a). At the same time, the fraction of clusters with vertical charge stripes is maximal at p =0.19, as shown in gure 4 (b). Since superconductivity in cuprates occurs in these clusters, this is the reason why it is most robust at p = 0.19, and not at p = 0.16.

The three temperature scales, $T_{M T}$, T_g and $T_{M O}$ shown in gure 2, originate from a magnetic ordering in di erent clusters A, B and C in gure 3, respectively. Since di erent experimental techniques are sensitive to di erent types of correlations, and have di erent resolutions and di erent characteristic times, it is then obvious why there is a discrepancy among phase diagram s presented in the literature.

Finally, let us consider the deep overdoped region. In deep overdoped region, new doped holes gather between stripes, form ing clusters with Ferm isea, in which the hole distribution is more or less hom ogeneous. The Ferm isea clusters, shown schematically in gure 3 by D, are embedded in a charge-stripe background. Since, the superconducting phase vanishes at p = 0.27, it is commonly assumed that above this doping level, the hole distribution becomes hom ogeneous in CuO₂ planes. In fact, this assumption may be not true: The three tem perature scales T_{CO} , T_{MO} and T_{pair} in gure 2 originate from di erent types of ordering in clusters with vertical charge stripes.

Since these three temperature scales cut the horizontal axis approximately at p = 0.3, as shown in gure 2, it is possible that between p = 0.27 and 0.3, the hole distribution in CuO₂ planes is not completely hom ogeneous. The clusters with vertical charge stripes may exist between p = 0.27 and 0.3, being embedded in a Ferm i-sea background. In this case, the hole distribution in CuO₂ planes is hom ogeneous only above p = 0.3, as schem atically shown in gure 4(a). A fter all, this is not very important for understanding the mechanism of high-T_c superconductivity.

V.STRIPE PHASE

Since superconductivity in cuprates occurs in clusters with vertical charge stripes, it is most important to understand the physics of this phase. The size of clusters with vertical charge stripes depends on the doping level: In underdoped region, the size of these clusters is about 30 A [7]. Then, it is obvious that the length of charge stripes is of the same magnitude. In overdoped region, the length of charge stripes increases up to 100 A [8]. Therefore, the length of charge stripes also depends on the doping level.

Since charge stripes in cuprates are very dynam ical, one may wonder how it is possible to observe chargestripe domains by tunneling [7, 8]. First of all, there are two types of dynam ics involved: the uctuation of charge stripes inside clusters, and the clusters uctuate as whole. Superconductivity most likely requires the form er but not the latter. Secondly, the charge stripes can slow down in one separate cluster, this will not a ect superconductivity locally if the charge stripes in the neighboring clusters go on uctuating [3]. Generally speaking, the charge stripes can be pinned by an in purity, by a lattice defect, or by the surface.

It is commonly assumed that the charge-stripe orientation in adjacent $C uO_2$ layers is alternately rotated by 90. In fact, this assumption is not necessary: D epending on doping level, the clusters with vertical charge stripes m ay coexist in the same $C uO_2$ layer with clusters having horizontal charge stripes [3].

VI.SUMMARY

We discussed here a phase diagram of hole-doped cuprates and the origins of di erent tem perature/energy scales. Hole-doped cuprates have a very rich phase diagram as a function of doping. This is due to a charge inhom ogeneity in CuO_2 planes: the charge distribution in CuO_2 planes is inhom ogeneous both on a nanoscale and m acroscale. Depending on the doping level, the CuO_2 planes com prise at least four di erent types of clusters having a size of a few nanom eters. Each type of clusters has its own features. As a consequence, the common phase diagram consists of, at least, seven di erent energy/tem perature scales. As an example, we considered a phase diagram of B i_2 Sr₂C aC u₂O $_{8+x}$.




FIG. 1. Dierent phase diagrams of superconducting cuprates, which can be found in the literature. T_N is the N eel tem perature; T_c is the critical tem perature; T is the pseudogap tem perature; and T_0 is the pairing tem perature (AF = antiferrom agnetic; SC = superconducting).




FIG.2. Phase diagram of B i2212 [3]. $T_{\rm c}$ is the critical tem – perature; $T_{\rm pair}$ is the pairing temperature; $T_{\rm M~T}$ is the magnetic-ordering temperature; and $T_{\rm C~O}$ is the charge-ordering temperature (for more details see text). The commensurate antiferrom agnetic phase at low doping is not shown. The spin-glass temperature scale $T_{\rm g}$ is shown schematically (Q CP = quantum critical point).




FIG.3. Schem atic representation of four types of clusters existing in CuO₂ planes at di erent dopings. Cluster A includes a virgin antiferrom agnetic phase. Cluster B includes diagonal charge stripes and a magnetic ordering between the stripes. The stripes are schem atically shown by the lines. Cluster C includes vertical charge stripes and a magnetic ordering between the stripes. In cluster D, holes are distributed hom ogeneously (the Ferm i sea). The magnetic ordering in clusters A, B and C occurs at T_{M T}, T_g and T_{M O}, respectively.




FIG.4. (a) Fractions of clusters (phases) A, B and D in gure 3 in a CuO₂ plane as a function of doping. (b) Fraction of clusters (phase) C.Both plots are shown schematically.
