Super uid transition tem perature in a trapped gas of Ferm i atom s with a Feshbach resonance

Abstract

W e investigate strong coupling e ects on the super uid phase transition in a gas of Ferm i atom s with a Feshbach resonance. The Feshbach resonance describes a composite quasi-Boson, which can give rise to an additional pairing interaction between the Ferm i atom s. This attractive interaction becomes stronger as the threshold energy (2) of the Feshbach resonance two-particle bound state is low ered. In a recent paper, we show ed that in the uniform Ferm i gas, this tunable pairing interaction naturally leads to a BCS-BEC crossover of the Nozieres and Schmitt-Rink kind, in which the BCS-type super uid phase transition continuously changes into the BEC -type as the threshold energy is decreased. In this paper, we extend our previous work by including the e ect of a harm onic trap potential, treated within the local density approximation (LDA). We also give results for both weak and strong coupling to the Feshbach resonance. We show that the BCS-BEC crossover phenom enon strongly modi es the shape of the atom ic density pro le at the super uid phase transition tem perature T_c, re ecting the change of the dom inant particles going from Fermi atom s to composite Bosons. In the BEC regime, these com posite Bosons are shown to stappear well above T_c. We also discuss the ρ as a function of the tunable threshold energy $2 \cdot W$ e introduce a characteristic tem perature T (2) describing the elective

The search for the super uid phase transition in a trapped gas of Ferm i atom s is one of the most exciting problem s in current physics. [1] This involves the formation of BCS Cooper-pairs made up of degenerate Ferm ions of two di erent species (\spin up" and \spin down"). Degenerate Ferm igases have been realized in ⁴⁰K [2] and ⁶Li. [3[5] Very recently, a Feshbach resonance was observed in ⁴⁰K working with the two hyper ne states $\mathcal{P}=2$; 9=2i and $\mathcal{P}=2$; 7=2i. [6] In the Feshbach resonance, a quasi-m olecular Boson is form ed, which can produce an attractive pairing interaction between two Ferm i atom s of opposite spins. [7[11] A sa result, one expects a BCS-type super uidity with a high phase transition tem perature T_c due to this strong attractive interaction. [9] H owever, such strong interaction is also known to enhance uctuations, which can strongly suppress T_c predicted by the usual mean- eld BCS theory. Thus the inclusion of these Cooper-pair channel uctuations is crucial in considering the high-T_c super uidity induced by an atom is Feshbach resonance.

In a previous paper, [11] we have discussed how this uctuation contribution a ects the super uid phase transition temperature in a uniform Fermigas, extending the theory developed by Nozieres and Schmitt-Rink: [12{15] W e assume that $N_{*} = N_{*}$, where N is the number of Fermi atom s with spin-, and that both Fermion components have the same single-particle energy. As the threshold energy of the Feshbach resonance is lowered, the character of the phase transition is found to continuously change from the BCS-type to BEC-type. In the latter regime, T_{c} is strongly suppressed compared with the usual meaneld BCS theory and it approaches $T_{c} = 0.218T_{F}$ in the BEC limit. (Here T_{F} is the Fermi temperature of the non-interacting spin-up Fermigas.) We show that the stable Bosons which appear as we enter the BEC regime are a strongly hybridized mixture of Feshbach molecules and preform ed Cooper-pairs. The Feshbach component of these Bosons dom inates the excitation spectrum in the BEC limit.

In this paper, we extend our previous work [11] by including the e ect of a harmonic trap potential. This extension is clearly necessary since all experiments on Ferm i gases are

done in some sort of trap potential. So far, the trapping potential has been exam ined within the mean-eld BCS theory using the simple local density approximation (LDA). [10] In this paper, we also use the LDA but go past the mean-eld approximation to include the e ect of particle-particle uctuations. We show how the BCS-BEC crossover can be observed from characteristic changes in the static atom ic density prole, easily measured by standard techniques.

Besides the phase transition temperature T_c , it is also in portant to understand how strong-coupling uctuation e ects enter above T_c . In particular, it is an interesting problem to clarify at what temperature the stable Feshbach molecules and preform ed Cooper-pairs in the BEC regime rst appear in the norm al-uid phase above T_c . Our calculations show that above T_c , there exists a characteristic temperature T which describes the crossover from a free Ferm igas to a molecular Bose gas.

In this paper, our treatment of the particle-particle uctuations assumes that their coupling to the Feshbach resonance is weak and can be thus treated perturbatively. Most of our discussion is for this case, in which the BCS-BEC crossover is driven by decreasing the value of the Feshbach resonance threshold (2) relative to twice the bare Ferm i energy $(2^{"}_{F})$. When the Feshbach coupling strength is very large, as Kokkelm and and coworkers have found, [16] it is not clear that our simple treatment of the particle-particle uctuations is valid. However, in this lim it, one nds that the BCS-BEC crossover occurs for values 2 $2^{"}_{F}$ because of the broad Feshbach resonance (see also Ref. [17]). Electively, one is in the strong-coupling regime discussed by Nozieres and Schmitt-Rink, [12] where the BEC phase is associated with preform ed Cooper-pairs. When the threshold energy 2 becomes comparable to $2^{"}_{F}$, our calculations again show that the Feshbach resonance takes over as the dom inant component of the BEC phase.

This paper is organized as follows: In Section II, we review the coupled Ferm ion-Boson model used in earlier work and discuss the LDA extension of the results we presented in Ref. [11]. In Section III, we use this opportunity to expand on certain aspects which were not discussed in detail in Ref. [11] due to lack of space. The BCS-BEC crossover in a trapped

system is discussed in Section IV. In Section V, we consider the character of the composite Bosons. The crossover from a free Ferm i gas to a gas of long-lived molecular Bosons above T_c is discussed in Section VI. Section VII considers the case of a strong Feshbach coupling.

II.FORM ULATION

A.Coupled Ferm ion-Boson gas in a trap

The gas of interacting Ferm i atom s coupled to a Feshbach resonance can be described by the coupled Ferm ion-Boson model given by $[7\{11,18\{20\}\}]$

Here c_p^{\vee} is the creation operator of a Ferm i atom with the kinetic energy $"_p = p^2 = 2m$. We assume that the system involves two atom ic hyper- ne states which will lead to C ooper-pair B osons and hence super uitility. We describe these atom ic states for simplicity using the pseudo-spin language = ";#. The quasi-molecular B oson of momentum q associated with the Feshbach resonance is described by the operator b_q^{\vee} . E_q^0 $\hat{q}=2M$ is the kinetic energy of this B oson and 2 represents the bottom of this resonance B ose spectrum, to be referred to as the threshold energy of the Feshbach resonance. The coupling to this Feshbach resonance B osen is described by last term in eq. (2.1) with a strength g_r , in which two Ferm i atoms form one b-B oson and the b-B oson breaks into two free Ferm i atom s. The H am iltonian also includes a standard BCS pairing interaction with the coupling constant U < 0, originating from non-resonant interactions between two Ferm i atom s (= ";#). Even assuming that this direct attractive pairing interaction U is weak, the elective pairing interaction strength can be strong due to the elect of the coupling to the Feshbach resonance. In this paper, we do not discuss the question of how good the model H am iltonian in eq. (2.1) is in the context of ultracold Ferm i gases, but sin ply refer to the literature [7(10,16].

Since in this model, one Feshbach-induced b-molecule consists of two Ferm i atoms, we have M = 2m and also impose the conservation of the total number of particles as

A soliscussed in our previous paper, [11] this constraint is incorporated into the model H am iltonian in eq. (2.1) by replacing H ! H N, where is the chemical potential. The resulting H am iltonian has the same form as eq. (2.1), but the kinetic energies of the Ferm ions and Bosons are now given by "_p ! "_p and E_q^0 ! E_q^0 2, respectively.

Now we introduce the e ect of a harm onic trap. In this paper, we consider an optical trap in which the two hyper ne Ferm i atom states feel the same trap potential given by

where $r_j = (x_j; y_j; z_j)$ is the position of the j-th atom. In our model, we also assume that the Feshbach molecules also feel this potential with m being replaced by the Boson mass M = 2m. We could relax this last assumption to deal more realistically with the dipole moment of the composite molecule but we have this extension to future studies. Treating the resulting trapped Fermion-Boson gas within the LDA [21,22] amounts to replacing the chemical potential by

The constraint on the total number of Ferm i atom s is then replaced by $N = {}^{R} dr N_{F} (r) + 2N_{B} (r)$, where $N_{F} (r)$ and $N_{B} (r)$ are the number density of Ferm i atom s and B ose m olecules, respectively.

The atom ic hyper ne states may feel di erent trap potentials in a magnetic trap. This situation is similar to electron spins in superconducting metals under a magnetic eld. In the theory of superconductivity, it is known that a magnetic eld suppresses superconductivity and, under certain conditions, produces a non-uniform kind of superconducting state called

the Fulde-Ferrell state. [23{25] The e ect of uctuations on this kind of Zeem an splitting in atom ic Ferm i gases is considered in another paper. [26]

B . Equations for $T_{\rm c}\colon T$ houless criterion

The super uid phase transition temperature T_c can be conveniently determined using the Thouless criterion, [12] in which the phase transition is characterized by a singularity in the particle-particle scattering vertex function at ! = q = 0, associated with the formation of C ooper-pairs. [27,28] The four-point vertex function within the generalized t-matrix approximation in terms of U and g_r is given by the diagram s in Fig.1. In this gure, the rst line describes ladder processes associated with the attractive interaction U < 0, processes familiar in strong coupling superconductivity in electronic systems. [12] 0 n the other hand, the second line includes the elective Fermion-Fermion interaction mediated by the b-B oson propagator D₀ de ned in eq. (2.6), scattering processes which only arise in atom is Fermi i gases coupled to a Feshbach resonance, such as in eq. (2.1). The equation of the vertex function is given by

Since the modiled chemical potential (r) includes the trap potential, the LDA G reen functions and vertex function also depend on position r. Multiplying both the sides of eq. (2.5) by 1 G₀ (p₊;r)G₀ (p;r) and summing over !_m and p, we obtain

W e shall see that the e ective attractive pairing interaction is given by

A coording to the Thouless criterion, T_c is given as the tem perature at which the vertex function $(q; i_n; r)$ in eq. (2.9) develops a pole at q = n = 0. W ithin the LDA, since depends on position r, this condition is satis ed at di erent tem peratures $T_0(r)$ depending on r. In this approximation, we have to regard the highest $T_0(r)$ as the phase transition tem perature of the trapped gas. [31] Since the density of particles is maximum at the center of the trap, we have $T_c = T_0(r = 0)$. Then the equation for T_c within the LDA is given by

is the static part of the e ective pairing interaction in the long wave length lim it at r = 0. Equation (2.11) indicates that even if the direct pairing interaction U is weak, the e ective pairing interaction U_e in eq. (2.12) can be large if g_r is large or when the chem ical potential of the b-B oson ($_B$ 2) approaches the bottom of the the B ose band 2. M ore explicitly, we note that eq. (2.11) can be written in the well known BCS form

As shown in the literature, [27,28] the pole which develops at T_c at $q = _n = 0$ signals an instability of the norm al Ferm igas. At $T < T_c$, the amplitude of this two-particle bound state can be shown to grow exponentially with time. This instability is removed by the appearance of a new phase below T_c , described by the Cooper-pair order parameter.

C.Fluctuation contributions to the chem ical potential

The chem ical potential in eq. (2.13) is determ ined by the equation of the total number of Ferm i atom s where a b-B oson also counts as two Ferm i atom s. In the weak-coupling BCS theory in the absence of the b-B oson, this equation simply gives = "_F (where "_F is the Ferm ienergy in the absence of any b-B osons), assuming that the temperature dependence of can be neglected. Indeed, in most metallic (weak-coupling) superconductors, the deviation of (T_c) from "_F is negligibly small as $(T_c="_F)^2$ 1. [32] On the other hand, when g_r is large or the Feshbach resonance strongly enhances the elective pairing interaction U_e , in analogy with the \strong-coupling" superconductivity discussed by Nozieres and Schm itt-R ink, [12] the chemical potential is expected to deviate remarkably from "_F due to the elect of uctuations associated with the Cooper-pair channel. We now discuss these uctuations.

The equation giving the number of Ferm i atoms determ ines the chemical potential . This is obtained, as usual, [12] from rst calculating the therm odynamic potential R^{R} dr (r) and then using the identity N = Q = Q. The uctuation contribution to the local therm odynamic potential (r) is shown in terms of diagrams in Fig. 2. In Fig. 2(a), we show the usual diagram s associated with the direct pairing interaction U.W orking to

all orders in U, this gives [12,13]

This is the contribution discussed in Ref. [12]. In Fig. 2 (b), we show the new uctuation diagram s contributing to (r) associated with the Feshbach coupling interaction g_r . Summing up to all orders, this gives

where the elective pairing interaction U_e (q; i_n; r) is as defined in eq. (2.10). In other words, the only elect of the diagram s in Fig. 2(b) is to renormalize the pairing interaction as U_e (q; i_n; r) in eq. (2.14). We also note that the collective luctuations in eq. (2.17) (which are Bosons) are precisely those which are associated with the poles of the particle-particle vertex function in eq. (2.9). The therm odynam ic potential for the contribution of the free Fermions and b-Bosons is given by the sum of [33]

Here n_B (E) represents the Bose distribution function. Equations (2.11) and (2.19) provide us with a closed set of two coupled equations, from which we can obtain (T;N) and T_c(N). In solving the coupled equations numerically, we have to take into account carefully the convergence factor e^{i_n} in the last term in eq. (2.19). In the appendix, we explain how to sum up the M atsubara frequencies in this term. Above T_c, we need only solve eq. (2.19) for (T;N). Our numerical results will be discussed in Sections IV and V. In the next section, however, we institution. This will allow us to better understand the nature of the Bosons involved in the crossover to a BEC regime.

III.PHYSICS OF COUPLED B-BOSONS AND COOPER PAIRS

The contribution arising from the interaction in eq. (2.19) can be described in terms of Bose uctuations given by the solutions of

where we made the usual analytic continuation from the imaginary Bose M atsubara frequency to the real frequency axis as $i_n ! ! + i . W$ hile eq. (3.1) appears relatively simple, it describes a complex situation involving the formation of preformed C coper-pairs and their coupling to the bare b-Bosons in eq. (2.1) due to the Feshbach coupling interaction g_r . The preformed C coper-pairs and the b-molecules are coupled to each other, which leads to hybridization and only one kind of composite Bose molecule. It is useful to try to disentangle these e ect, although there seems no unique way of doing this in such a coupled excitation problem .

Denoting the number density of atom s given by the last term in eq. (2.19) as N $_{\rm FL}$ (r), we have

The self-energy in eq. (3.3) describes the e ect of the decay of a b-Boson into two Ferm i atom s and their recombination to a b-Boson, treating the non-resonant interaction U within the ladder approximation. This self-energy can be also obtained by summing up the diagram s shown in the third line in Fig. 1 (shaded bubble in the gure).

One may verify that the rst term in the square brackets in eq. (3.2) renormalizes the number of b-B osons, giving

All these versions emphasize that the renormalized Bosons given by $D^{-1} = 0$ are the hybridized version of the bare preform ed Cooper-pairs and the bare b-Bosons. One can still ask what is the relative \weighting" of these two components in the renormalized Bose spectrum given by the pole of D^{-} , as given by the values of N_B and N_C in eq. (3.10). In Ref. [11], we calculated both these contributions as a function of the threshold 2 in the case of a uniform Ferm i gas.

IV.TRANSITION TEMPERATURE IN THE BCS-BEC CROSSOVER W ITH A FESHBACH RESONANCE

A . R enorm alization for U and $g_{\rm r}$

In this section, we consider the case of an isotopic harm onic trap $(!_{0x} = !_{0y} = !_{0z} !_{0})$ for simplicity. It is convenient to take "_F as the unit of energy (for one Ferm ispecies). As for the unit of length, we take the radius R_F of a non-interacting Ferm igas at T = 0 de ned by "_F (R_F) "_F m $!_0^2 R_F^2 = 2 = 0$, or $R_F^2 = 2"_F = m !_0^2$. We also take, as the unit of the number of particles, the total number of Ferm i atom s given by

where $p_F(r) = \frac{q}{2m} \frac{1}{r_F(r)}$ is the Ferm in one ntum at r within the LDA.W ith this normalization, since N and R_F always appear with the coupling constants U and g_r as \tilde{U} UN = R_F^3 and g_r^2 $q_{N}^2 = R_F^3$, they can be absorbed into these coupling constants. (In the following, we simply write \tilde{U} and g_r as U and g_r .) In our numerical calculations, we simply introduce a Gaussian cuto $e^{\frac{q}{p}=\frac{1}{c}^2}$, with $\frac{1}{c}=2^{m}_F$, in the momentum summation involved in the particle particle response function $(q; i_n; r)$ de ned in eq. (2.8) and thus also in eq. (2.13).

The interactions U and q used in this paper should be regarded as renormalized quantities electively involving the elects of screening by (pseudo-spin and density) uctuations and renormalization in terms of high energy processes: G or kov et al. showed within the mean-eld BCS theory that in the dilute limit, T_c is suppressed by an elective interaction mediated by uctuations described by particle-hole (p-h) bubble diagrams. [34] This elect was also studied recently by C on bescot [35] in connection with the possibility of high T_c super uidity in ⁶Li. This reduction of T_c can be physically understood as a screening elect by (pseudo-) spin and density uctuations, which weakens the pairing interaction between Ferm i atom s. One should understand that U and q in our model in eq. (2.1) include this p-h screening.

As for the renorm alization of U and g by high energy processes, we note that our Ferm i atom ic gas has no physical cuto -energy, in contrast to superconductivity in m etals, where the lattice phonon D ebye frequency acts the elective cuto in the BCS gap equation. However, a prescription about the renorm alization of the high energy interactions is in plicit when we introduce a cuto $!_c$ in the momentum summations. To see this, it is convenient to introduce an energy cuto E_c . This cuto energy is assumed to be much higher than $!_c$ and T, and it may be arbitrarily large. We can then divide the summation in the equation for T_c in eq. (2.13) into a low energy part " $_p = [0;!_c]$ and high energy part " $_p = [!_c;E_c]$. In this decomposition, when E_c $!_c$ $jj > T_c$, we can take $tanh("_p) = 2T_c ! 1$ in the high energy part. Since this replacement corresponds to ignoring the in uence of the Ferm i distribution [recall that in eq. (2.13), tanh x=2T = 1 2f(x)], the high energy region can be described as two atom s interacting in a vacuum. The elect of the surrounding gas and Ferm i statistics is absent. Then the decomposition of eq. (2.13) is reduced to [36]

In this equation for T_c , high energy two-particle scattering processes in the region $[!_c; E_c]$ has been absorbed into the renorm alized coupling U_e^R $(!_c) = U^R$ $(!_c) + g_r^{R^2}$ $(!_c) = (2^R (!_c) 2)$ describing the low energy physics in the region $[0; !_c]$. The renorm alized interaction U^R $(!_c)$, Feshbach coupling g_r^R $(!_c)$ and threshold energy 2^R $(!_c)$ are thus given by

Physically, U^R (!_c) is the non-resonant Ferm ion-Ferm ion interaction enhanced by high energy scattering processes and is diagram matically described by Fig. 3 (a). The renormalized Feshbach coupling g_r^R (!_c) involves the three point vertex correction coming from the high-energy processes in Fig. 3 (b). Finally, the renormalized threshold energy 2^R (!_c) originates from the self-energy correction caused by the break of a Bose molecule into two Ferm iatom s with high momenta, which can be described by the diagram s in Fig. 3 (c).

We should determ ine the renorm alized quantities experimentally. In this regard, the renorm alized quantities for the low energy lim it (! $_{c} = 0$) can be introduced. [16,17] O ne can write the renorm alized parameters in eq. (4.4) in terms of their low energy values (! $_{c} = 0$) as follow s:

W ritten in terms of the renormalized variables given in eq. (4.5), the BCS gap equation in eq. (4.3) no longer involves E_c explicitly. A lthough we simply write the couplings as U, g

All these expressions for the equation for T_c give physically the same result, assuming that one takes the appropriate values for renormalized parameters.

W ith regard to the renorm alization of the coupling constants, recent work by K okkelm ans et al. [16] has discussed the coupled Ferm ion-B oson m odel given in eq. (2.1) and incorporated the full two-body scattering theory into an in proved fashion. M ilstein et al. [17] have m ore recently derived identical equations to eqs. (4) and (6) in Ref. [11] (these correspond to eqs. (2.13) and (2.19) for a trapped Ferm igas), which include the e ect of particle-particle uctuations and the appearance of C ooper-pairs. They have extended our analysis in Ref. [11] by renorm alizing these equations in a way which treats the two-body scattering and bound states correctly. Their work thus leads to explicit num erical values for the various param eters in the renorm alized m odel corresponding to eq. (2.1).

In the rest of this Section and Sections V and VI, we discuss our results for T_c and the region above, using U = 0.3"_F and $g_r = 0.6$ "_F. Our diagram matic approximation for the uctuations, as summarized in Figs. 1 and 2, assumes that the interactions are weak. In Section VII, we discuss the analogous results predicted by our equations (2.13) and (2.19) using a value g_r "_F, such as found in Refs. [9,17]. In this case, the Feshbach resonance is very broad and thus can have a huge e ect on T_c even if the threshold 2 2"_F.

B . C rossover behavior at $T_{\rm c}$ w ithin LDA

Our num erical solution for T_c and $(T_c; N)$ from eqs. (2.13) and (2.19) for a trapped Ferm igas gives results which are very similar to those for a uniform Ferm igas obtained in Ref. [11]. Figure 4 shows the BCS-BEC crossover in a trapped Ferm igas. As the threshold energy 2 is lowered, Fig. 4(a) shows that T_c deviates from the mean-eld BCS theory (BCS' in the gure) and approaches the BEC phase transition temperature of a gas of N =2 free Bosons of mass M = 2m (BEC' in the gure). The chemical potential also changes remarkably in this crossover as shown in Fig. 4(b). As expected from the mean-eld BCS theory, we obtain ' "_F for 2 > 2"_F (BCS regin e) while deviates from "_F and approaches

for < 0 (BEC regime). The latter result releases that the b-B osons become the dominant contribution in the BEC regime. As a result, the phase transition occurs when the chemical potential of the b-B oson $_{\rm B}$ (= 2) reaches the bottom of the B ose band (2) at the center of the trap (within our LDA). We note that we can rewrite the equation for T_c in eq. (2.11) in the form

Using the fact that $T_F = (6N_*)^{1=3}!_0$ is the Ferm i tem perature for a trapped free Ferm i gas (with N * = N =2), we can write this expression for T_c in terms of T_F to give

Figure 4 (a) shows that this T_c is obtained in the BEC regime as the limiting maximum value in the trapped Fermigas. We recall that Fig. 4 is for $U = 0.3"_F$ and $g_r = 0.6"_F$.

We note that this upper lim it for T_c is much higher than that of a uniform Ferm i gas in the absence of a trap. [11] In the uniform system, T_c in the BEC regime is given by [11,15]

This shows that the low energy region of the DOS has larger weight in the uniform gas $(DOS / \stackrel{p}{E})$ than in the trapped one (DOS / E^2) . As a result, the transition tem perature (relative to T_F for each case) must be higher in the trapped gas than in the uniform gas.

V.LONG-LIVED COM POSITE MOLECULAR BOSONS

In the BCS regime, where is always nite for ! > 0 (see the inset in Fig. 5(a)), the quasiparticle b-Bose spectral density shows a broad peak, as shown in Fig. 5(a). This b-Boson thus has a nite lifetime, which is given by the inverse of the peak width, due to decay into two Ferm i atoms by the coupling to the Feshbach resonance. As one approaches the BEC regime, $!_{th} > 0$ is realized (as shown in the insets in Figs. 5(b) and 5(c)). In this case, when the b-Boson pole given by eq. (3.11),

In Fig. 5(b), the excitation spectrum is still accompanied by a incoherent part in high energy region (! > $!_{th}$), in addition to the undam ped bound state pole below $!_{th}$. On the other hand, the incoherent part is seen to be alm ost absent in the BEC regime in Fig. 5(c), evidence that a stable bm olecule dom inates the two-particle excitation spectrum.

The condition for such a stable b-Boson is simply that [11]

where Z (q;r) has been de ned in eq. (5.10). There is also a contribution from scattering states and hence we have $N_c = N_c^{=0} + N_c^{\infty}$, where N_c^{∞} represents the scattering contribution associated with dam ped particle particle (or C coper channel) uctuations.

Figure 4 (c) shows the change of the character of the excitations in the BCS-BEC crossover in the trap. As is lowered and approaches "_F, the Feshbach resonance molecular state starts to play a role and the Feshbach damped molecules $(N_B^{>0})$ appear. These Bosons are replaced by the stable molecules $(N_B^{=0})$ around = 0.18"_F for the parameters used in Fig. 4 (c). At the same time, a contribution from preformed Cooper-pairs $(N_c^{=0})$ appear. In the BEC regime, stable Feshbach molecules become dominant and $N_B^{=0}$ approaches 0.5 (= N=2). The contribution from preformed Cooper-pairs are seen to again disappear in the BEC limit < 0. The increase in the total number of molecules is, however, slower than that found in the uniform system. [11] This is simply because the stable molecules initially only begin to appear at the center of the trap, rather than throughout the system as in the uniform gas case..

Figure 6 shows the number of composite Bosons $N_{\rm M}$ ^R drN_M (r) as a function of [where $N_{\rm M}$ (r) is defined in eq. (3.17)]. Although each component of Boson ($N_{\rm B}^{=0}$, $N_{\rm B}^{>0}$, $N_{\rm C}^{=0}$ and $N_{\rm C}^{\infty}$) shows a singular behavior around = 0.18"_F in Fig. 4 (c), $N_{\rm M}$ ($N_{\rm B}^{=0}$ + $N_{\rm C}^{>0}$ + $N_{\rm C}^{=0}$ + $N_{\rm C}^{\infty}$) is found to increase smoothly as the threshold energy 2 is low ered, as expected.

As we have discussed in detail in Section III, the strong hybridization induced by the Feshbach coupling interaction $g_r m$ eans that there is only a single two-particle Bose branch, whose energy is given by the solution of eq. (5.5). Thus $N_B^{=0}$ and $N_c^{=0}$ only represent the relative spectral weights of the two components (corresponding to long-lived b-Bosons and

stable preform ed Cooper-pairs) of this com posite Boson. This decom position is only meant as a way of understanding the physics of the BCS-BEC crossover which arises in the model given by eq. (2.1). This interpretation is, however, very useful to understand the di erence between the present BCS-BEC crossover and that in strong-coupling superconductivity with no Feshbach resonance: In the latter case, the preform ed Cooper-pairs are the dom inant excitations in the strong coupling BEC regime. [12,14,15] In the present case, for the values of the parameters U = 0.3"_F and $g_r = 0.6$ "_F used in F ig. 4, although preform ed Cooper-pairs m ake a contribution, the stable Feshbach m olecules dom inate the excitation spectrum in the BEC limit (< 0).

B. The binding energy of com posite Bosons

The binding energy of the long-lived composite B oson is the energy to break thism olecule into two Ferm i atom s. This dissociation energy can be evaluated from the energy di erence between the bound state energy $!_q$ in eq. (5.5) and the excitation spectrum of the free Ferm i gas measured from the chem ical potential . In particular, the binding energy of the zero-energy ($!_{q=0} = 0$) two-particle bound state with q = 0 which appears at T_c is given by

where we have used (r = 0) < 0 and eq. (5.6) to obtain expressions on the right hand side. This result means that $E_{binding}$ is equal to the absolute value of the energy of a renormalized b-m olecule at the bottom of the renormalized Bose spectrum.

The threshold energy $!_{th} (q = 0)$ of the two-particle spectrum is de ned as where Im (q = 0; !; r = 0) given in eq. (5.2) becomes nite (see Fig. 5). We recall that Im describes the excitation spectrum of the Cooper-pair channel uctuations. This frequency $!_{th} (q = 0)$ is the same as the threshold energy of the continuum spectrum of the renormalized b-Boson self-energy in eq. (3.3), since = Im = $g_r^2 \text{Im} \sim (i_n ! ! + i) / \text{Im} (! + i)$. W hen a stable b-Boson at $!_{q=0} = 0$ is excited to a state with energy E $!_{th}$, this excited b-Boson will decay into two Ferm iatoms lading to a nite lifetime for this excited state. We conclude that $!_{th} (q = 0) = E_{binding}$, i.e., the particle-particle threshold energy $!_{th} (q = 0)$ is equal to the binding energy of a stable two-particle bound state.

Since the chemical potential approaches in the BEC limit as shown in Fig. 4(b), we not from eq. (5.14) that E_{binding} ! 2j j in this regime. This energy 2j j is just equal to the energy needed to transfer a free b-Boson at the bottom of the Bose energy band ($E_{q=0}^{0} + 2 = 2j$) to two Ferm i atoms with zero energy ($2_{q=0}^{n} = 0$). This result is consistent with the fact that the preform ed Cooper-pair component in the bound state is absent in the BEC limit, leaving the b-m olecule component.

The binding energy of the preform ed Cooper-pair in the strong-coupling BEC regime has been also discussed in superconductivity, [12,14,15,39] and it is useful to understand how the present results are related to this previous work. To see this, let us recall the cuto -free equation for T_c given by eq. (4.9). Since 0 in the BEC limit, one can approximately take tanh ("_p)=2T = 1. Summing over p in eq. (4.9), we obtain

[14,15,39] In the present m odel, where the pairing interaction m ediated by the Feshbach resonance is dominant in the BEC regime, we can neglect the non-resonant part U in U_e . Then in the case of < 0, the solution of eq. (5.15) is [40]

The right hand side of this equation is reduced to unity in the BEC limit, ! 1, namely, the chem ical potential for the b-Boson (2) approaches the (renorm alized) threshold energy 2, as one expects. The relation between and the binding energy of a bound state in a two-particle system can be also obtained by extending the previous discussions given in the superconductivity case. [14,15,39] W hen we consider two Ferm i atom s in a vacuum and employ relative coordinates, the scattering t-m atrix for one Ferm i atom with reduced m ass m =2 and energy ! is given by

where $U_e^0 = U + g_r^2 = (2 + 1)$, in which the renorm alized variables are given in eq. (4.10). This equation is the same as eq. (5.17) in the BEC limit (0, where $\tanh("_p) = 2T + 1$) when we replace ! ! 2. Thus the energy of the bound state is related to the chemical potential by the relation ! = 2j j which is consistent with our earlier result in eq. (5.14).

VI.STRONG COUPLING EFFECT ABOVE T_C

A.BCS-BEC crossover e ect on the atom ic density pro le

As expected, the change of the character of the particles from the Fermion to Boson in the BCS-BEC crossover shown in Fig. 4(c) strongly a ects the density pro le of atom s in the trap. This is shown in Fig. 7(a). In the BCS regime, the density pro le is spread out, as shown by result for = "_F. In this regime, the density pro le is mainly composed of Ferm i atom s, and the Pauli exclusion principle between Ferm i atom s electively acts as a repulsive interaction. This pushes the atom s away from the center of the trap. As the system approaches the BEC regime (< 0), the number of stable Bosons gradually increases and thus the repulsive elect of the Pauli exclusion principle becomes less in portant. As expected for Bosons, the particles are now seen to cluster near the center of the trap as is lowered, as shown by Fig. 7(a) [see also the inset in Fig. 7(a) for = 0]. These results indicate that the easily measured atom ic density prolemay be a very useful signature in boking for the BCS-BEC crossover phenomenon experimentally, especially as one gets close to T_c .

We note that the atom ic density prole shows a steep decrease near the trap center at T_c (Fig. 7(a)), but this is absent at $T = 1.5T_c$ (Fig. 7(b)). The cusp-like behavior at T_c originates from the Boson component (N_B and N_C) in the density, as shown in the inset in Fig. 7(a). In the extrem e BEC limit, since the gas is described by N =2 free Bose gas in a trap, the density of atom s is proportional to $g_{3=2}$ (z (r)), [38] where $g_{\frac{3}{2}}$ (z) $P_{n=1}^{1} z^{n} = n^{3=2}$ and the fugacity is z (r) $e^{2-2-2V - trap} (r) = T$. At T_c , since the BEC is realized when the dom ical potential of Bosons (2) reaches the bottom of the Boson excitation spectrum (2), we nd z (r) ! 1 at the trap center. From the well known behavior of $g_{3=2}$ (z) at z = 1, the atom ic density pro le shows a nite slope at r = 0 at T_c . In contrast, this sharp cusp at the trap center is absent for tem peratures above T_c , where 2 < 2 and hence the fugacity z (r) is no longer close to unity. [38] W e also show in the inset in Fig. 7 (b) the density pro le above T_c when the tem perature is xed as $T = 0.75T_F$. In this case, the density pro le becomes m ore spatially di use as is increased. This is because of the increasing dom inance of the Ferm ions and the resulting enhancement of the e ect of the Pauli exclusion principle.

B.C rossover from a Ferm igas to a Bose gas above T_{c}

It is useful to clarify when and how the stable B osons (N $_{B}^{=0}$ and N $_{C}^{=0}$) at T $_{c}$ shown in Fig. 4 (c) disappear as the tem perature is increased above T $_{c}$. Figure 8 (a) shows the tem perature

dependence of the number of particles above T_c (for = 0). The number of stable Bosons $(N_B^{=0} \text{ and } N_c^{=0})$, as well as the nite lifetim eBosons $(N_B^{>0})$ and the scattering contribution (N_c^{sc}) , are found to all decrease at higher temperatures. This result is also obtained when < 0. Thus only the free Ferm i atom s contribute at higher temperatures well above T_c .

The reason that the Ferm i atom contribution dom inates at high temperatures has a very simple explanation in the di erence of the chem ical potentials between a Ferm i atom ($_{\rm F}$ =) and a b-B oson ($_{\rm B}$ = 2). As the temperature is increased, the chem ical potential must decrease so as to conserve the total number of atom s N = (Ferm i atom s)+2 (Bose molecules)], as shown in Fig. 8 (b). Thus for T T_c, the Boson excitation energy E $_{\rm q}^{0}$ +2 2 always increases faster than the excitation energy of the Ferm ions " $_{\rm p}$, simply due to the factor two in front of in the Bose excitation energy. As a result, the occupation of the Bose band always approaches zero for T T_c, even though the Bosons can be the dom inant excitation at T_c in the BEC regime.

However, Fig. 8 still shows that there is a signi cant region above T_c where the number of long-lived Bosons is substantial. It is thus useful to de nea \crossover tem perature" T which separates the Ferm i gas and the Bose gas regimes, even though the increase in the number of stable Bosons occurs continuously. We de ne T as the tem perature at which $N_B^{=0} = 0.05$, or when 10% of the Ferm i atom s combine to form stable b-m olecules (Fig. 9). Figure 9 shows that T rapidly increases when is small or negative, for which case stable Bosons appear at T_c (=" $_F$ < 0.18, for the parameters used). Even for ' 0, T " $_F$ is considerably larger than T_c . Since this \Bose gas regime" lying between T_c and T is fairly wide, one m ight expect to observe the form ation of the stable m olecules somewhat above T_c if we can decrease the threshold energy 2 enough, namely to values where the super uid transition at T_c would be of the BEC type (see Fig. 4).

Figure 10 com pares the tem perature dependence of the num ber of particles and the chem – ical potential (lines in the gure) for = "_F with the case of a free (U = $g_r = 0$) Ferm ion–Boson m ixture (led circles and squares). In the non-interacting Ferm ion-Boson m ixture, we only impose the constraint that the total num ber of atom s is conserved N =(Ferm i

atom s)+2 (Bose molecules)]. Figure 10 shows that deep in the BEC regime (= $\frac{1}{F}$), this constraint alone determ ines the tem perature dependence of the number of particles and the chem ical potential. As far as these quantities are concerned, the e ect of including the interaction g_r and U is clearly negligible.

VII.THE CASE OF STRONG FESHBACH COUPLING

In all of the num erical results presented so far, we have considered the case of a weak Feshbach coupling described by $g_r = 0.6"_F$. In this regard, recent calculations have argued that strong coupling $(g_r "_F)$ was a more realistic description of Feshbach resonances observed in ultracold gases. [9,16,17] In this section, we investigate what arises in this strong Feshbach coupling regime, although the present treatment of uctuations in plicitly assumes a weak Feshbach coupling. We present some numerical results for T_c in the limit of a large Feshbach coupling (broad resonance) for a uniform gas. In this regard, we note that our analysis in the present paper and in Ref. [11] has shown that the BCS-BEC crossover in a trap is very similar to that in a uniform gas, at least for the case of weak Feshbach coupling.

Figure 11 show the BCS-BEC crossover in the case of $g_r = 20"_F$ "_F. Figures 11 (a) and 11 (b) show that the crossover behavior already occurs around = $150"_F$, which is much higher than "_F. Results sim ilar to this are presented in Ref. [17]. Since the bottom of the Bose excitation spectrum 2 is then still much higher than the Ferm ion band, the Feshbach related b-Bosons described by $N_B = N_B^{=0} + N_B^{>0}$ are alm ost absent in this crossover regime, as shown in Fig. 11 (c). The high-energy b-Bosons only contribute to virtual scattering processes involving Ferm ions, which mediate the pairing interaction between Ferm i atom s. Thus, when the Feshbach coupling g_r is very strong, the character of the BCS-BEC crossover becomes identical to that in the case of strong-coupling superconductivity as discussed by Nozieres and Schm itt-R ink. [12] The fact that the crossover to the BEC region occurs at such large values of 2 is easy to understand. Since the chemical potential is always of order of "_F or less, at large values of 2 and g_r , we have $U_e = U + g_r^2 = (2 - 2)$ ' $g_r^2 = 2$. Since the strong-coupling e ect should be most pronounced when U_e becomes comparable to "_F, the BCS-BEC crossover will occur at U_e "_F, which gives 2 q^2 ="_F. For $g_r = 20$ "_F, this predicts that the crossover will occur at 200"_F, consistent with the num erical results in Fig. 11 (a).

That the case of a very broad Feshbach resonance $(g_r \, "_F)$ is equivalent to the case studied in Ref. [12,15] is also shown clearly by the fact that stable preform ed Cooper-pairs are the dominant excitation [see Fig. 11(c)] in the crossover region at 150"_F. The Feshbach b-m olecule component only becomes dominant when < 0. This result is in contrast to our results for a weak Feshbach coupling $g_r = 0$:6"_F as shown in Fig. 4. In that case, the b-m olecule becomes the dominant component at the BCS-BEC crossover.

Figure 12 shows the total number of composite Bosons N_M $N_B^{=0} + N_B^{>0} + N_C^{=0} + N_C^{sc}$ as a function of , for $g_r = 20"_F$. A lthough the individual Cooper-pair components $N_C^{=0}$ and N_C^{sc} show [see Fig. 11 (c)] singular behavior in the BCS-BEC crossover regime (at 150"_F), N_M itself increases sm oothly as the threshold energy is decreased.

Since the BCS-BEC crossover around = $150"_{\rm F}$ shown in Fig. 11 is intrinsically the same phenom enon as discussed by N ozieres and Schm itt-R ink, [12] the origin of the small peak in T_c shown in Fig. 11 (a) is the analogue of the one form ed also in the case of strong-coupling superconductivity. [12,14,15] However, Haussmann [41] showed that the slight peak in T_c obtained at the BCS-BEC crossover in strong-coupling superconductivity disappears when one includes higher order scattering processes beyond the simple t-m atrix approximation, such as used in the present paper. Thus, we regard the small peak T_c in Fig. 11 (a) as probably an artifact of our simple t-m atrix approximation. A s in the weak Feshbach coupling case shown in Fig. 4, we expect that the maximum transition temperature T_c will again be given by the BEC expressions in eqs. (4.12) and (4.13). To summarize, we have extended our recent work [11] and investigated the e ect of particle-particle uctuations in conjunction with an atom ic Feshbach resonance on the super uid phase transition in a gas of Ferm i atom s in a harmonic trap, using a simple LDA approach. The BCS-BEC crossover predicts a maximum transition temperature of $T_c = 0.518T_F$, som ewhat larger than $T_c = 0.218T_F$ in a uniform gas. [11] In the BEC regime, the excitation spectrum is dominated by the stable long-lived Feshbach-related m olecules in the case of a small Feshbach coupling parameter g_r . This is in contrast with results for the BCS-BEC crossover with no Feshbach resonance, [12,15] where the preform ed Cooperpairs are the dominant bound states. For a very broad Feshbach resonance ($g_r = T_F$) as studied in Refs. [9,16,17], we nd that the crossover region is also dominated by preform ed Cooperpairs.

The BCS-BEC crossover is shown to strongly a ect the atom ic density pro le in the trap, which can be measured. In the BCS regime, where Ferm i atoms are dominant excitations, the spatial distribution of the atoms is spread out from the trap center due to the Pauli exclusion principle. The atoms increasingly cluster at the center of the trap as the threshold energy of b-Bose excitation spectrum is lowered and the the number of stable composite Bosons increases.

In the BEC regime, we show that stable molecules can exist above T_c . As the temperature increases, however, the number of these Bosons decreases. We introduce a crossover temperature T dened as the temperature above T_c at which 10% of the Fermi atom s have formed long-lived bemolecules. Plotting T as a function of the threshold 2 gives a sort of \phase diagram " in the norm alphase which may be useful in experimental searches for the BCS-BEC crossover.

The experimental observation of Cooper-pairs in trapped Ferm i gases will be a very exciting m ilestone in physics. W hat makes this topic even more interesting is the possibility that we can observe the BCS-BEC crossover in such systems. As we have shown in this

paper, this crossover involves very interesting physics and, moreover, it leads to characteristic changes in the properties of the trapped gas. The changes in the atom ic density prolemay provide a crucial experimental signature for the existence of Cooperpairing and super uidity.

W e will discuss the BCS-BEC crossover in the super uid region below T_c in a future paper. In particular, we will discuss how the collective modes vary as we pass through the crossover region. [42]

APPENDIX A:CALCULATION OF FLUCTUATION CONTRIBUTION TO THE NUMBER OF FERMIATOMS

The density of atom s associated with uctuations given by N_{FL} (r) in eq. (2.19) can be split into two contributions [using eq. (2.17)], [43]

Since the second term involving $\frac{\theta}{\theta} \ln [1 + g_r^2 D_0]$ goes as n^2 in the large n limit, the convergence factor $e^{i n}$ has no e ect. However, this convergence factor cannot be dropped in the rst term in eq. (A1), because the quantity $\frac{U}{1 U} - \frac{\theta}{\theta}$ only goes as n^1 for large n. In numerical calculations, it is di cult to sum up the M atsubara frequencies directly taking into account the convergence factor involving a in nitesim ally small number . One method to avoid this di culty is to employ a spectral representation as carried out by N ozieres and Schmitt-R ink. [12] However, this method requires high numerical accuracy in executing the resulting energy integration. We used a dimentional calculation.

To calculate the st term in eq. (A1) $[N_{FL}^{(1)}(r)]$ without employing a spectral representation, we compare $N_{FL}^{(1)}(r)$ to the expression without the convergence factor,

This quantity is easy to calculate num erically. When we transform the summation over the discrete M atsubara frequencies into an integral in the complex plane in the usual way, we obtain

where the path C_0 is shown in Fig. 13. we are allowed to add the circular contours C_1 and C_2 for the integration in $N_{FL}^{(1)}(r)$ without changing the result, because the contributions from C_1 and C_2 vanish in the large radius limit (R ! 1) due to, respectively, the factors

 n_B (z) and e^z . The integration in $N_{FL}^{(1)}$ (r) is thus reduced to sum m ing up the poles inside the closed contours $C_0 + C_1$ and $C_0 + C_2$ shown in Fig. 13.

We next show how $N_{FL}^{(1)}(\mathbf{r})$ is related to $N_{FL}^{(2)}(\mathbf{r})$ de ned in eq. (A2). First, we note that when dealing with $N_{FL}^{(2)}(\mathbf{r})$, the integration along the path C_2 gives a nite contribution when we add the paths C_1 and C_2 due to the absence of the convergence factor. However, if we write the integration in $N_{FL}^{(2)}(\mathbf{r})$ as

we nd that the rst term can be calculated by sum m ing up the contribution from the poles inside the closed paths $C_0 + C_1$ and $C_0 + C_2$, and the result is identical to $N_{FL}^{(1)}(r)$. The last term in eq. (A4) [$N_{FL}^{corr}(r)$] can be evaluated to give, in the lim it R ! 1,

Here, $e^{\left|\frac{p}{p}\right|^{2}}$ is the Gaussian cuto introduced in Section IV, and we have used eq. (2.8) and changed the integration variable using $z = R e^{i}$. Thus we have shown that $N_{FL}^{(1)}(r)$ involving the convergence factor is related to $N_{FL}^{(2)}(r)$ without the convergence factor by

U sing this expression, we can calculate $N_{FL}^{(1)}(r)$ num erically by evaluating the simpler expression $N_{FL}^{(2)}(r)$.

The essence of this prescription m ay be easily understood from the following example: Consider the two quantities:

In this case, the frequency sum in N_B⁽¹⁾(q) can be easily done analytically and reduced to the Bose distribution function $n_B (E_q)$. The sum in N_B⁽²⁾ gives

The contribution from $C_{\,2}$ in the last term in eq. (A 4) is given by

Thus we can easily verify that $N_B^{(1)} = N_B^{(2)} - N_B^{(2)}$, as in eq. (A 6).

FIG.13. Path for the complex integration discussed in the Appendix. The dots show the imaginary discrete Bose M atsubara frequencies i_n .




Fig.1 Ohashi and Griffin





Fig.2 Ohashi and Griffin






Fig.3 Ohashi and Griffin




Fig.4 Ohashi and Griffin




Fig.5 Ohashi and Griffin




Fig.6 Ohashi and Griffin




Fig.7 Ohashi and Griffin




Fig.8 Ohashi and Griffin




Fig.9 Ohashi and Griffin




Fig.10 Ohashi and Griffin




Fig.11 Ohashi and Griffin




Fig.12 Ohashi and Griffin




Fig. 13 Ohashi and Griffin
