Current induced entanglem ent of nuclear spins in quantum dots

W e propose an entanglem ent m echanism of nuclear spins in quantum dots driven by the electric current. The current accompanied by the spin ip in quantum dots gradually increases components of larger total spin of nuclei. This entangled state drastically enhances the spin relaxation rate of electrons, which can be detected by m easuring a leakage current in the spin-blockade region. This m echanism is not relevant in optical experiments which exam ine the spin relaxation of single excitations.

The spin relaxation time of electrons in quantum dots is an important issue. The time needs to be su ciently long for the implementation of quantum computing devices utilizing electron spins in quantum dots [1]. The relaxation time has been found to be quite long by optical [2, 3] and transport experiments [4, 5]. In the form er experim ents, the transient m easurem ents indicate a quenching of the spin relaxation on the exciton lifetime scale in self-assembled quantum dots. In the latter experin ents, the tunneling current is measured through single or double quantum dots in \spin blockade" situations, where electrons cannot be transported unless the spins are ipped in the dot. The relaxation time is as long as 200 s from a spin-triplet excited state to spin-singlet ground state in single quantum dots [4]. In weakly coupled double quantum dots, the current suppression has been observed when two electrons occupy the lowest energy level in each dot with parallel spins: an electron tunneling from one dot to the other is forbidden by the Pauli exclusion principle [5].

In the present paper, we theoretically study a small leakage current in spin-blockade regions. The current is accompanied by the spin ip in the quantum dots. As a spin-ip mechanism, we investigate the hyper ne interaction between electrons and nuclear spins [6, 7]. Recent experim ental results have im plied its im portant roles in the leakage current [8]. We exam ine a form ation of entangled states of nuclear spins driven by the electron transport. This mechanism is analogous to the current induced dynam ic nuclear polarization (DNP) in quantum Hallsystem s [9, 10]. The DNP is created by the electron scattering between spin-polarized regions, which leads to a hysterisis in the longitudinal resistance [11, 12]. In our case, the entanglem ent of nuclear spins drastically enhances the spin relaxation rate of electrons in quantum dots, which could be observed experim entally. Thism echanism is not relevant in the optical experiments which exam ine the spin relaxation of single excitations. Hence the role of the hyper ne interaction in the spin relaxation could be quite di erent in transport and optical experim ents.

M odel: To consider the spin blockade in quantum dots, we adopt a following model. A quantum dot is weakly coupled to external leads L,R through tunnel barriers. The C oulom b blockade restricts the num ber of electrons in the dot to be N_{el} or N_{el} + 1. N_{el} electrons form a background of spin singlet. From lead L on the source side, an extra electron tunnels into the dot and occupies a single level with envelope wavefunction (r). The spin of the electron is either " (S_z = 1=2) or # (S_z = 1=2) with equal probability (we assume an easy-axis of electron spins in z direction for a while). The electron stays for a long time by the spin blockade [13] because the spin relaxation time is much longer than the tunneling time. A fler the spin ip in the dot, the electron is mediately tunnels out to lead R on the drain side, and then the next electron is injected from lead L.

An electron occupying orbital (r) interacts with N nuclear spins, I_k , by the hyper ne contact interaction. N 10^6 in GaAs quantum dots. We assume nuclear spins of 1=2 for simplicity. The Ham iltonian in the dot reads

where v_0 is the volume of the crystal celland $I = {P \atop k=1}^{N} I_k$ is the total spin of nuclei. We have assumed that (r) is independent of the nuclear site, r_k . This is a good approximation for a large part of nuclear spins in the quantum dot, except in the vicinity of nodes of (r), since the distance between nuclei is much smaller than the size of the dot, or an extension of (r).

Basic idea: The Ham iltonian (1) indicates that N nuclear spins interact with a common $\$ eld" of electron spin although there is no direct interaction between them (dipole-dipole interaction between nuclear spins is weak and neglected). This eld results in the entanglement among the nuclear spins. To illustrate this, let us consider the simplest case of N = 2 and begin with a polarized state of nuclear spins $j_z = 1=2i_1 j_z = 1=2i_2$. An electron with spin j#i tunnels into the dot and is spin-ipped by the hyper ne interaction. Then the state of nuclear spins becomes (j $1=2i_1j=2i_2 + j=2i_1j$ $1=2i_2 = jJ = 1;M = 0i$, where J and M are the total spin and its z component, respectively. This

is an entangled state. A fier the electron tunnels out of the dot, the next electron is injected with j #i (or j "i). The spin- ip probability of the second electron is proportional to j1; 1;" (#) H_{hf}];0;# (")i $f = 2^{-2}$. This value is twice the probability in the case of non-entangled states $jl=2i_1 j$ $1=2i_2$ or j $1=2i_1j=2i_2$. In general, the capability of state jJ;M i to ip an electron spin is / (J M)(J M + 1).

In presence of easy-axis: W e form ulate the entanglem ent of N nuclear spins. In the initial state, they are not entangled at all and oriented random ly

where the coe cients fC $_{J,M}^{(0)}$; g are random ly distributed $\stackrel{P}{(}_{J,M}$; $jC_{J,M}^{(0)}$; j= 1). Index distinguishes states with the same J and M. The number of such states is given by

A fler the injection of the rst electron, say, j#i, the time evolution of the dot state by H $_{\rm hf}$ is

The expansion to the lowest order in t= yields the spinip probability, P $^{(0)} = F {}^{(0)} (t=)^2$, with

(the lower sign indicates the electron spin ip from j "i to j #i). When N 1, $\mathcal{T}_{J,M}^{(0)}$, \mathcal{J} can be replaced by $1=2^{N}$ (law of large number). Then F ⁽⁰⁾ = $(1=2^{N})_{J,M}$ K (N;J)(J M)(J M + 1) = N=2. P ⁽⁰⁾ = (N=2)(t=~)^{2} is identical to the spin- ip probability which would be evaluated on the assumption that one of the nuclear spins is ipped with the electron spin.

The electron tunnels o the dot immediately after the spin is ipped. Then the wavefunction $^{(0)}$ shrinks to

⁽¹⁾ is partly entangled since it contains m ore com ponents of larger J and sm aller **M** j. The degree of the entanglem ent increases each time an electron is injected, spin-ipped, and ejected out of the dot. A fler n events, the state of nuclear spins becomes




FIG.1: The distribution of (a) the total spin J and (b) its z component, in the state of nuclear spins. An easy-axis of electron spins is assumed. (a) $p(J) = \prod_{M,j} (j \prod_{J,M}^{(n)}, j J, and (b)) p(M) = \int_{J,j} (j \prod_{J,M}^{(n)}, j J, where n is the num ber of transported electrons accompanied by the spin ip. The num berofnuclear spins is N = 100. In Eq. (9), we take the geometrical mean between upper and lower signs.$

Figure 1 shows the distribution of (a) the total spin J and (b) its z component M . The spin- ip processes increase the weight of larger J and smaller M j. A lthough M changes less faster than J, this m eans that the total nuclear spins tend to develop in the plane perpendicular to the easy-axis of electron spins.




FIG.2: (a) The spin- ip probability P $^{(n)}$ with xed t, as a function of n (number of transported electrons accompanied by the spin ip). (b) The spin- ip current I (t) as a function of time t. The cases in the presence and absence of easy-axis of electron spins are indicated by solid and broken lines, respectively. The number of nuclear spins is N = 100. In the presence of easy-axis, we take the geom etrical m ean between upper and lower signs in Eq. (11).

This entangled state enhances the spin- ip probability. For the (n + 1)th electron, the probability is given by P⁽ⁿ⁾ = F⁽ⁿ⁾ (t=~)². P⁽ⁿ⁾ with xed t is shown by solid line in Fig. 2(a). Using Eq. (11), we nd that F⁽ⁿ⁾ (N=2)n for 1 n N=2, and F⁽ⁿ⁾ (N=2)² for N=2 n. Therefore the probability increases with n linearly (P⁽ⁿ⁾ nP⁽⁰⁾) and nally saturates (P⁽ⁿ⁾ (N=2)P⁽⁰⁾).

In absence of easy-axis: Until now, we have assumed the presence of easy-axis of electron spins. In the absence of the axis, the spin of the nth electron is oriented in an arbitrary direction, $\cos^{(n)}j$ " $i + \sin^{(n)}e^{i'^{(n)}}j$ #i. In this case, the previous form ulation can be applied after the rotation of fC $_{J,M}^{(n)}$; g, $C_{J,M}^{(n)}$; $= {}^{P}{}_{M^{0}}{}_{=}{}_{J}U(J; {}^{(n)};'{}^{(n)})_{M \to M^{0}}C_{J,M^{0}}{}_{;}$, to align the z axis parallel to the spin direction. If the spin direction of incident electrons is completely random, we can average over the z-component of the total spin. Then the coe cients fC $_{J,M}^{(n)}$; g in Eq. (9) are replaced by the averaged values fC $_{J,i}^{(n)}$ g. They develop by

As in the previous case, components of larger J increase with n, which enlarge the spin- ip probability by the factor of 2J (J + 1)=3. The probability is given by P (n) = G ⁽ⁿ⁾ (t= \sim)², which is shown by broken line in Fig. 2 (a). This behaves as P ⁽ⁿ⁾ (2n=3)P ⁽⁰⁾ for 1 n N=2, and P ⁽ⁿ⁾ (N=3)P ⁽⁰⁾ for N=2 n, with xed t.

Leakage current: The enhancement of the spin-ip probability is relected by the leakage current. Instead of calculating the current in the previous situations, now we consider the case in the presence of magnetic eld:

Zeem an energy for electrons is much larger than the hyper ne interaction, whereas that for nuclear spins is negligible. Then H_{hf} can be treated as a perturbation. The magnetic eld makes an easy-axis of electron spins. We also take into account the electron-phonon interaction for the energy conservation at the spin ip [7]. The Ham iltonian in the dot reads $H = H_{el} + H_{php} + H_{hf} + H_{el} ph$, where $H_{elp} = \sum_{q} E_Z (a_{\pi}^y a_{\pi} - a_{\pi}^y a_{\#}), H_{ph} = \sum_{q} \sim !_q D_q^y b_q$, and $H_{el ph} = \sum_{q} a_q a^y a (b_q^y + b_q)$, with a^y , $a (b_q^y, b_q)$ being creation and annihilation operators for an electron in the dot (phonon). The spin- ip processes in the lowest order in $H_{hf} + H_{el} ph$ (rst orders in H_{hf} and in $H_{el ph}$) change the nuclear spin state in the same way as in Eq. (9) [14].

The spin- ip rate for the (n + 1)th electron is ${}^{(n)} / F^{(n)}$. The time interval between nth and (n + 1)th electron transports is t ${}^{(n)}$ $1 = p^{(n)}$. Thus the current is given by I(t) = e ${}^{(n)}$ at t = ${}^{n}_{j=0}$ t ${}^{(j)}$. This current is shown in Fig.2(b), as a function of t (solid line). The approximate form of F ${}^{(n)}$ yields an asymptotic form of the current

The current grows with time drastically and nally saturates. The saturation time is given by $t_{sat} = \ln (N = 2) = {}^{(0)}$, where ${}^{(0)}$ is the spin- ip rate of an electron with the non-entangled state of nuclear spins. The increase in the current continues until the entangled state is broken by dephasing e ects.

Even in the absence of magnetic eld, the electron energies for j "i and j #i could be split in H_{el} , eg. by

spin-singlet or -triplet form ation with an electron trapped in the other dot, in double dot system s. In this case, the easy-axis of electrons would be absent (if the crystal eld is weak enough). The perturbation with respect to $H_{\rm hf} + H_{\rm el}$ ph changes the nuclear spin state following Eq. (12). The spin- ip rate is ${}^{(n)}$ / G ${}^{(n)}$. The leakage current I (t) is represented by broken line in Fig. 2 (b). It is written approximately as

where $t_{sat} = 3 \ln (N = 2) = (2^{(0)})$. The enhancem ent of the current is less prom inent than in the presence of easy-axis.

D iscussion: W e have proposed the current induced entanglem ent of nuclear spins in quantum dots. The current accompanied by the spin ip in the dots gradually increases components of larger total spin of nuclei, which signi cantly enhances the spin relaxation of electrons. As a result, the leakage current in the spin-blockade region grows drastically with time and nally saturates. This mechanism is not relevant in the optical experiments which examine the spin relaxation of single excitations.

The saturation time of the leakage current is of the same order as $1 = {}^{(0)}$, spin relaxation time with nonentangled state of nuclear spins, which is 100 ns or much larger [4, 5]. The current is enhanced during the dephasing time T_2 . When the entangled state is broken, the current is suppressed. Possibly this would result in a current uctuation with time which has been observed recently [8]. The characteristic time of the uctuation is T_2 .

A possible origin of the dephasing is the dipole-dipole interaction between nuclear spins. Note that, among N nuclear spins participating in the formation of total spin, jJ; M i, this interaction conserves the total spin, and hence does not destroy the entangled state. The interaction between one of the N spins and a spin surrounding the dot results in the dephasing. Estimating T_2 in our case and analyzing evolution of nuclear spins after the dephasing are beyond the present paper.

W e discuss the validity of our simple models. W e have

disregarded the spatial variation of the envelope wavefunction of electrons in the quantum dot. A lthough the entanglement of nuclear spins is generally seen in the presence of the variation (see Eq. (4) in Ref. [15]), the enhancement of the spin relaxation is more electron with larger total spin J. Hence the capability to ip an electron spin is determined by the electron eld, if an electron spin is determined by the electron eld, if an electron nuclear spins which feel the same electron eld, if an electron spin is an interesting problem.

If the contribution from higher energy levels of electrons in quantum dots is not negligible, through electronphonon interaction [6, 7] or spin-orbit (SO) interaction [16], it should be taken into account carefully. Particularly, the coexistence of hyper ne and SO interactions would complicate the evolution of the nuclear spin state because the term s of j#i and j"i are m ixed on the right side of Eq. (5). We have also disregarded higher-order tunneling processes [17], which could play a role in the spin relaxation of electrons [4]. How ever, the processes do not in uence the entanglem ent of nuclear spins discussed here.

Finally, we comment an analogy between our mechanism and the Dicke e ect of superradiance [18, 19]. The spontaneous em ission of photons is enhanced from N atom s with two levels (pseudo-spin $S_z =$ 1=2) if all of them are excited initially. This is due to the form ation of pseudo-spin state jJ;M i with J = N = 2. (Starting from jJ; Ji, the state of N atom s changes like a cascade, , em itting photons.) A sim ilar e ect ΰ;Ji, ΰ;J 1i; has been proposed for the emission of phonons from N equivalent quantum dots [19, 20]. The atom s (quantum dots) correspond to the nuclear spins in ourm odel, while the emission of photons (phonons) to the spin ip of electrons. A main di erence is the initialization. N excited states have to be prepared by the pum ping in the Dicke e ect, whereas the initialization is not necessary in our mechanism.

- [13] In double quantum dots, it depends on the spin direction whether the spin blockade takes place [5]. If the spin of an incident electron in the rst dot is parallel to that of the electron trapped in the second dot, the form er electron cannot tunnel in the second dot due to the Pauliexclusion principle. If the spins are anti-parallel, the spin blockade does not happen; the electron tunnels in the second dot and nally out to lead R immediately. The total current

is the sum of the currents with and without spin ip.W e consider the form er current only.

- [14] We assume that $k_B T$ is larger than E_Z . O therwise, the spin ip of electrons only from j#i to j"i is available by $H_{\rm hf} + H_{\rm el}$ ph, which increases the components of larger J and M. The other ip could be caused by eg.higherorder tunnel processes between the dot and leads [17].
