Virial expansion for charged colloids and electrolytes

Abstract. U sing a eld-theoretic approach, we derive the rst few coe cients of the exact low-density (\virial") expansion of a binary m ixture of positively and negatively charged hard spheres (two-com ponent hard-core plasm a, TCPHC). Our calculations are nonperturbative with respect to the diam eters d_+ and d and charge valences q_+ and q of positive and negative ions. Consequently, our closed-form expressions for the coe cients of the free energy and activity can be used to treat dilute salt solutions, where typically d_+ d and q_+ q , as well as colloidal suspensions, where the di erence in size and valence between m acroions and counterions can be very large. W e show how to m ap the TCPHC on a one-com ponent hard-core plasm a (OCPHC) in the colloidal lim it of large size and valence ratio, in which case the counterions e ectively form a neutralizing background. A sizable discrepancy with the standard OCPHC with uniform, rigid background is detected, which can be traced back to the fact that the counterions cannot penetrate the colloids. For the case of electrolyte solutions, we show how to obtain the cationic and anionic radii as independent parameters from experimental data for the activity coe cient.

1 Introduction

The two-component hard-core plasm a (TCPHC) has been used for a long time as an idealized model for electrolyte solutions. In this model, also known as \primitive model," the ions are spherical particles that interact with each other via the C oulom b potential and a hard-core potential, which avoids the collapse of oppositely charged particles onto each other. In the general asymmetric case, the positive ions have a charge q_{t} e (where e is the elementary charge) and ionic diameter d_{t} , while the negative ions have a charge q e and diameter d. The particles are immersed in a structureless solvent whose presence is felt only through the value of the dielectric constant of the medium, and the system is (globally) electroneutral.

The TCPHC in this form ulation is a gross sim pli cation of real system s. When two ions are at distances of the order of the size of the solvent molecules, the assum ption of a continuum solvent breaks down, giving rise to so-called solvation forces[1]. Such e ects also lead to nonlocal contributions to the dielectric constant. Since the dielectric constant of ions or colloids typically di ers from the surrounding aqueousm edium, one also expects dispersion forces to act between these particles. A ll these e ects, which contribute to \ion-speci c" e ects[2], and are possibly more relevant than previously thought[3], are not accounted for in the TCPHC, which treats the solvent usually water as a structureless medium within which the charged particles are embedded, neglecting the molecular arrangem ent that occurs around the ions.

N evertheless, even with such simplications, the TCP-HC is far from being amenable to an exact treatment. A better understanding of this model is a necessary step if one wishes to develop more realistic approaches to charged systems. In this article, we turn our attention to the lowdensity, or virial, expansion of the TCPHC. Since we have exact results for the therm odynamic properties at low concentrations using eld-theoretic methods, we can obtain useful information on dilute systems with otherwise arbitrary hard-core radii and charge valences (like colloidal suspensions). In particular, we can test various approximations to treat the TCPHC, like the mapping of a colloidal solution on an elective one-component plasma.

Due to the long-range character of the Coulomb potential, it is not easy to obtain the therm odynam ic behavior of the TCPHC through the usual methods of statistical mechanics. For example, it can be shown [4,5,6] that the straightforward application of the cluster expansion to the TCPHC leads to divergent virial coe cients. Mayer[4] proposed a solution to this problem through an in nite resummation of the cluster diagrams, carried out such that the divergent contributions to the virial expansion are canceled.W ith this, he was able to obtain explic-

itly the rst term in the virial (or low-density) expansion that goes beyond the ideal gas, which turns out to be the well-known D ebye-Huckel lim iting law [7]. Haga [8] carried the expansion further and went up to order 5=2 in the ionic density. M ore or less at the same time, Edwards [9] also obtained the virial expansion of the TCPHC by m ixing cluster expansion and eld theory. In both cases only equally-sized ions were considered.

The aforem entioned m ethods typically depend on drawing, counting and recollecting the cluster diagram s which give nite contributions to the expansion up to the desired order in the density. This can be quite a form idable task, and unfortunately it is easy to \forget" diagram s that are relevant to the series (see for instance the comment on pp. 222{223 of Ref. [5]). A lso, the generalization to ions with di erent sizes is rather com plicated [5]. B esides, the nal results are typically not obtained in closed form, i.e., the nal expressions depend on in nite sum s that usually have to be evaluated num erically, which re ects the in nite diagram matic resum mation.

W egeneralize here a novel eld-theoretic technique [10], introduced for the sym metric TCPHC $(q_{+} = q_{-} and d_{+} =$ d). We obtain the exact low-density expansion of the asymmetric (both in size and charge) TCPHC. Thismethod does not use the cluster expansion (and resum m ation) and yields analytic, closed-form results. We go up to order 5=2 in the volume fraction of a system where the sizes and the charge valences of positive and negative ions are unconstrained, that is, the results we obtain can be applied, without modi cations, to both electrolyte solutions (where anions and cations have approximately the same size and valence) and to colloidal suspensions (where the m acro-and counterions have sizes and valences that can be di erent by orders of m agnitude). In the colloidal lim it, we dem onstrate how to m ap the TCPHC on an e ective onecomponent hard-core plasm a (OCPHC) and obtain the corrections due to the exclusion of the background (i.e. the counterions) from the colloidal particles. For electrolytes, we obtain e ective ionic sizes in solution, or therm odynam ic diam eters, from experim ental data for the mean activity. The method developed here allows, in principle, to m easure the diam eters of cations and an ions as independent variables, given that the range of experim ental data extends to low enough densities such that the expansion used here is valid. It should be noted that the diam eters obtained in this way are fundam entally di erent from the hydrodynam ic diam eters.

This article is organized as follows. In section 2 we describe in detail the steps that lead to the low-density expansion. Readers which are not interested in this derivation can go directly to section 3, where we apply the expressions obtained to two particular problems, viz., (i) colloids, where one of the charged species is much smaller and much less charged than the other one and (ii) the mean activity coe cient (which is related to the exponential of the charged to our results. Finally, section 4 contains som e concluding remarks.

2 The method

W e begin our calculation by assuming a system with N $_{\rm +}$ positively charged particles with charge valence $q_{\rm +}$ and diameter $d_{\rm +}$, and N negatively charged particles with charge valence q and diameter d. G bobalelectroneutrality of the system will be imposed at a later stage of the calculation. The canonical partition function Z is given by

Coulom b potential, for a short-ranged potential this can be more problem atic: for instance, a hard-core potential does not even have a well-de ned inverse function.We will anyway take this form al step for the short-ranged potential, and, as we will see later, the way we handle the resulting expressions leads to nite (and consistent) results, viz., the virial coe cients[11].

In order to make the calculations simpler we use the grand-canonical ensemble. This is achieved through the transform ation

condition before going to the grand-canonical ensemble makes the calculations much more di cult. Later, electroneutrality will be imposed order-by-order in the lowdensity expansion in a consistent way, any in nities arising from the non-neutrality of the system will then be autom atically canceled.

In the preceding steps we obtained the exact expression for the grand-canonical free energy density g, still without in posing electroneutrality. In order to obtain the low-density expansion of the free energy, we now (i) expand g in powers of + and (up to a order 5=2), (ii) calculate the concentrations of positive and negative particles and im pose electroneutrality consistently, order-byorder, and (iii) make a Legendre transform ation back to the canonical ensemble.

2.1 Expansion in powers of the fugacities

These terms are present in Eq. (32) because global charge neutrality has not been yet dem anded. By im posing this condition, these divergent term s cancel exactly, as is show n next.

2.2 Im posing electroneutrality

The electroneutrality condition ensures that the global charge of the system is zero, i.e., $q_{+} N_{+} = q N_{-}$. In the grand-canonicalensemble, N + and N are no longer xed numbers but average values. This means that the electroneutrality condition in the grand-canonical ensemble is given by

(36), the fugacities will depend on each other in a non-trivial way such that the system is, on average, neutral. If the system were totally symmetric (i.e., $q_{+} = q$ and $d_{+} = d$), this dependence would be given by the relation $e_+ = e_{[10]}$. However, this is not the case here: one needs to nd the relation between the fugacities order-by-order.

First, assume that e can be expanded in term s of e_+ such that.

This is inspired by the expanded form of the grand-canonical and the coupling parameter free energy $\mathbf{g}_{\mathbf{f}} \in \mathbf{q}_{\mathbf{i}}(32)$.

A fter calculating e_+ and e_- from g_+ Eq. (32), according to Eq.(38), and insertion into the electroneutrality condition Eq. (36), we substitute the fugacity ^e by its expanded form Eq. (39). This leads to the expanded form (up to order $e_{+}^{5=2} \ln e_{+}$) of the electroneutrality condition. Solving it consistently, order-by-order, yields the values of the coe cients in Eq.(39), which ensure electroneutrality

The ∞ e cients 0 and 1 are given by the divergent order by order. For instance, at linear order in e_+ , the expanded form of Eq. (36) reads

which naturally gives $a_0 = q_+ = q_-$. With the know ledge of a_0 , one can solve the next-order term (in this case $e_{\perp}^{3=2}$) and obtain the value of a1, and so on. The resulting coe cients a_0 up to a_5 are given in the appendix cf. Eqs. (93) 98).

As this order-by-order neutrality condition is in posed, one notices that the term s $_0$ and $_1$ in Eq. (32) are exactly canceled in a natural way, without any further assum ptions. The resulting expression for g, now expanded only in one of the fugacities (in this case e_+), is then a wellbehaved expansion (we om it this expression here since it is quite lengthy). With this, one can nally obtain the canonical free energy (as a density expansion) through a Legendre transform .

2.3 The canonical free energy

In order to obtain the free energy in the canonical ensem ble, we use the back-Legendre-transform ation




Fig.1.Coe cients (a) B₂ and (b) B₅₌₂ of the free energy expansion Eq. (43) as functions of $_+$ for dimension energy expansion Eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension energy expansion eq. (43) as functions of $_+$ for dimension eq. (43) as

The free energy Eq. (43) is the exact low density expansion of the asymmetric TCPHC and constitutes the main result of this paper. The only parameter that is demanded to be small is the ion density \mathbf{e}_{+} , that means, this result is non-perturbative in the coupling _+, charge ratio and size ratio _.

We chose the positive ions as the \reference species" (i.e., the expansion is done with respect to e_{+}) without any loss of generality, since the relation between e_{t} and e_{t} is xed through the electroneutrality condition. As consistency checks, we notice that our expression for ₱ is sym m etric, as expected, with respect to the simultaneous exchange of d+ with d and q+ with q . Also, in the limit $d_{+} = d$ and $q_{+} = q$, we recover the same expression as previously calculated in Ref. [10] for totally symmetric system s. Finally, as one turns o the charges in the system (or equivalently, as one takes the $\lim_{t \to 0} \frac{1}{t} + \frac{1}{2} = 0$), the pure hard-core uid is recovered, i.e., f becom es the usual virial expansion with B $_{\rm 3=2}$ and B $_{\rm 5=2}$ equal to zero and B $_{\rm 2}$ given by the second virial coe cient of a two-com ponent hard-core gas, $B_2^{HC} = B_2(+ ! 0)$, which in our units reads

This limit can be also understood as the high-tem perature regime: as the therm alenergy largely exceeds the C oulom b energy at contact, the hard core interaction becomes the only relevant interaction between the particles.

3 Results




Fig. 2. Coe cients (a) B₂ and (b) B₅₌₂ of the free energy Eq. (43) as functions of + for dimensional d =d₊ (with $q_{+} = q$). Notice that B₂ is normalized by the second virial component B $_{2}^{HC}$ of a pure two-component hard-core gas. The inset in (a) shows the behavior of B₂ close to + = 0 on a dimensional core scale.

3.1 The virial coe cients

The behavior of the coe cients B $_2$ and B $_{5=2}$ as functions of the coupling parameter $_+$ are depicted in Figs.1 and 2, the behavior of B $_{2\log}$ and B $_{5=2\log}$ is rather trivial and not shown graphically. In Fig.1 the ionic diameters of positive and negative ions are kept equal, $d_+ = d$, and the ratio between the charge valences, , is varied, while in Fig.2 the charge valences are equal and the ratio between the ionic diameters is varied. These gures highlight the fact that both coe cients diverge as $_+$ goes to in nity. In this lim it,



Note that $B_{5=2}$ diverges faster (and with opposite sign) than B_2 , rejecting that this low-density expansion is badly converging, as we will discuss further below. The exponentially divergent behavior of B_2 and $B_{5=2}$ when + ! 1 is due to the increasing in portance of the interaction between oppositely charged particles (ionic pairing) as the coupling parameter increases [14,15,16], corresponding for instance to lower temperatures. This is commed by noting that the argument in the exponential occurring in both asymptotic form s Eqs. (55) and (56), viz. $2_{-+} = [1 + -]$, can be re-expressed as $2q_{+}q_{--}^{n} = [d_{+} + d_{--}]$, which is the coupling between positive and negative ions (in this case, the ratio between the C oulom b contact energy between oppositely charged ions and the therm all energy $k_{\rm B}$ T).

To estim ate roughly the ionic density e_{+} up to which the expansion in Eq. (43) is expected to be valid, we use the following simple criterion: the terms proportional to B_{DH} and $B_{5=2}$ give the same contribution to the free energy when $\mathcal{B}_{DH} \dot{\mathbf{g}}_{+}^{3=2} = \mathcal{B}_{5=2} \dot{\mathbf{g}}_{+}^{5=2}$ or, in other words, at a critical density $e_{+} = \mathcal{B}_{DH} = B_{5=2} \mathbf{j}$. Note that we set up this criterion separately for the integer and fractional coe cients, since the scaling behavior for the two di erent classes is very di erent and no meaningful results can be obtained by mixing them . The analogous criterion for the integer term s leads to a critical density $e_{+} = (1+1=)=B_{2}j$ where for the ideal contribution in Eq. 47 we replace the logarithm ic term by a linear one (which is the ideal contribution to the osm otic pressure).We tacitly assume that the higher-order terms (which we have not calculated) show the same relative behavior, an assumption which seem s plausible to us but which we cannot check. In Fig. 3 we show the estimate for the critical densities obtained from a) the ratio of the integer term s and from b) the ratio of the fractional term s. In a) the critical density settles at a nite value for vanishing coupling parameter " $_{+}$! 0, and decreases to zero for increasing coupling parameter (the divergence in the curves at nite value of " $_+$ is not signi cant since it is caused by a change in sign of B_2 .). This means that for small coupling constants the integer coe cients are expected to show regular convergence behavior for not too large concentrations. For large values of e_+ on the other hand, the range of densities which can be described by the expansion quickly goes to zero. In b) the displayed behavior is more com plex. The expansion of the coe cient B $_{5=2}$ for sm all values of the coupling parameter "+ leads to

plus term s with scale as higher powers in ", . The important point is that except for the singular case = 1, that is for particles of identical radius, the leading term of B₅₌₂ scales as $I_{+}^{3=2}$ and thus identical to the lower leading term B_{DH}. In the case = 1 the leading term scales as $I_{+}^{5=2}$ and thus show s a di erent scaling behavior than B_{DH}. In Fig. 3b) this di erence is cleary seen: For = 1 the curves diverge as ", ! 0 and the convergence of the fractional density term s in the series is expected to be guaranteed. For = 0:1 the behavior is similar to the results in a),

showing a saturation at a nite value as " $_+$! 0 (and an unsigni cant divergence at nite " $_+$). All curves go to zero as the coupling param eter grows. In conclusion, the reliability of the low-density expansion becomes worse as the coupling param eter increases, but one can always nd a window of sm all densities within which the expansion should work.

F inally, we mention that in a di erent calculation scheme, based on an integral-equation-procedure within the socalled mean-spherical-model (MSM) approximation, sim – ilar results for the free energy and other thermodynamic functions have been obtained [17,18,19]. Those results also reproduce the limiting laws, namely the hard-core behavior as the coupling parameter goes to zero, and the leading D ebye-Huckel correction at low density, and give a quite satisfactory description even form uch larger values of the density. It is important to note, how ever, that the nextleading (beyond D ebye-Huckel) terms in the low-density expansion are not correctly reproduced by the MSM approximation.

3.2 The colloidal lim it

In colloidal suspensions, occulation or coagulation (driven by attractive van der W aals interaction between colloidal particles) can be prevented by the presence of repulsive electrostatic forces. These suspensions are typically quite dilute, with volum e fractions of colloidal particles usually not higher than a few percent. The macro-particles norm ally have dimensions [20,21,22] ranging from 10 to 1000 nm and charges of several thousands e (elementary charge), with much sm aller counterions that have a charge of a few e. In such systems the charge and size asymmetry between ions and counterions is immense; the TCPHC with unconstrained charge and size asymmetry is a suitable model for dilute colloidal suspensions, and the free energy Eq. (43) can be used to study the therm odynam ic behavior of such system s. W ith this in m ind, let us take the following lim it: assume the parameters describing the positive ions (representing the colloids) d_+ , q_+ and e_+ xed, and m ake both $q = q_+$ and $d = d_+$ vanishingly small (this has to

be done with some care, since the lim it = 0 is not wellde ned). One can then rewrite the free energy Eq. (43) up to second order in e_{+} as


is the hard core contribution due to the counterion {counterion and m acroion {counterion interactions only, without the m acroion {m acroion contributions, which explains the difference to the full hard-core virial coe cient in Eq.(54). It is necessary to treat this term separately, as it does not have a well-de ned behavior in the double lim it ! 0 and ! 0. It is to be noted that the contributions in \mathbf{f}_{id} and $\mathbf{B}_2^{\mathrm{HC};cl}$ contain terms that scale with 1= .For dilute colloidal systems therefore the ideal contribution of the counterions

dom inates the free energy and cannot be neglected. Effects due to the electrostatic interaction between the ions are corrections to the ideal behavior.

At this point we brie y introduce yet another model that is also widely used to describe charged system s. It is the one-component plasma (OCP), which in its sim plest form consists of a collection of N equally charged point-like particles in m ersed in a neutralizing background that ensures the global charge neutrality of the system (in the TCPHC electroneutrality is ensured by oppositely charged particles). The OCP, or its quantum mechanical counter-part (\jellium ") has been used in di erent contexts in physics, as for instance to describe degenerate stellar matter (the interior of white dwarfs or the outer layer of neutron stars) and the interior of massive planets like Jupiter. A nother exam ple com es from condensed matter physics, where jellium is often used as a reference state when calculating the electronic structure of solids. For reviews see Refs. [23,24,25].

W hen the particles have a hard core, the OCP is called one-component hard-core plasm a (OCPHC): what we will see next is that the electrostatic contribution to the free energy in dilute colloidal suspensions can be almost described through the OCPHC. If we compare the coe – cients Eqs. (60{51) with the ones previously obtained [10] for the low density expansion of the OCPHC

where the notation used in Ref. [10] is kept in Eq. (63) and on the rhs of Eqs. (64(66). The comparison between B_2^{cl} and d_2 is shown in Fig. 4, where we rescaled both coe – cients by their value at vanishing coupling, d_2 ($_+ = 0$) = $B_2^{cl}(_+ = 0) = 2$ =3. This shows that, including the order $e_+^2 \ln e_+$ (i.e., for very dilute colloidal suspension), the OCPHC is almost recovered, except an additional term in Eq.(65). This additional term can be quite in portant at interm ediate values of $_+$ since it changes the sign of the virial coe cient, as seen in Fig. 3.

This is in fact what one would intuitively expect: each m acroion has around it a very large number of sm all neutralizing counterions which act like a background. Our results show that the background formed by counterions, which is a deformable background since the counterion distribution is not uniform, acts alm ost like a rigid hom ogeneous background, as it is assumed in OCP calculations. How ever, there is a sm all di erence between the TCPHC in this lim it and the OCPHC: in the latter, the background penetrates the particles, while in the TCPHC it cannot (for a thorough discussion of this di erence see [26]). In our calculation, this is rejected in the e_1^2 term, where

 $_+$ =2 is the positive extra cost in the free energy that the OCPHC hasto pay (at this order) to expel the background from the hard-core particles. The rst consequence of the non-penetrating background is that the e ective charge of the colloids increases by exactly the am ount of background charge that is expelled from the colloidal interior. A sim – ple calculation shows that the increased e ective charge $q_{\rm f}^{\rm e}$ of colloids for the non-penetrating background turns out to be




Fig. 5. A colloidal particle (with diam eter d+ and charge valence q_t) in the OCPHC model (a) with and (b) without the penetrating background.

In the low -density expansion of the OCPHC, Eq.(63), one would have to reexpand all coe cients with respect to the density, using Eq.(67). However, since the leading term which depends on the charge $q_{\scriptscriptstyle \! +}$ goes like $e_{\scriptscriptstyle \! +}^{3=2}$, the effect would come in at order $e_{\perp}^{5=2}$ and therefore is not responsible for the additional term in Eq.(65). The reason for the extra term in Eq.(65) has to do with an increase of the self-free-energy of a colloidal particle, which can be understood in the following way: A ssume that the OCPHC is very dilute, such that each colloidal particle and its neutralizing background form a neutral entity (in the spirit of the cellm odel, see for instance Ref. [27]) that can be regarded independent from the other particles. The free energy di erence per colloidal particle between a system without penetrating background and with penetrating background (Fig. 5) is then given by two contributions: one com ing from the entropy lost by the background (form ed by N counterions) since it cannot penetrate the m acroions, given by

This is one of the contributions to the second virial coe cient due to the hard-core interaction, and already in-

cluded in Eq. (59). This term does not depend on the coupling $_+$, and therefore has nothing to do with the extra term in Eq.(65). The second contribution to the selfenergy is electrostatic in origin. De ning the charge distributions for the situations in Fig. 4 as $_{a}(r) = q_{t}$ (r) when the background can enter the colloids and $_{\rm b}(r) =$ q₊ (r) ₀ 1 $(d_{+}=2 r)]$ when the background cannot enter the colloids (where $_0 = c_+ q_+$ is the background charge density and (x) = 1 if x > 0 and 0 otherw ise), the electrostatic self-energy di erence between the two cases reads

Note that this is a positive contribution to the e^2 term with the same coe cient as the extra term in Eq. (65). Therefore, we conclude that this extra term is due to the electrostatic energy associated with expelling the background from the colloidal volume. This is in accord with m ore general results on the di erence between OCPHC more general results on the difference between OCPHC typically measured at constant pressure, while the the-models with penetrating and excluded neutralising backgrounds[26]. The sults are obtained for constant volume. Note In sum m ary, whenever using the OCPHC to describe highly asymmetric charged systems such as colloids, one has to to take into account the exclusion of the background from the macroions. As we demonstrated, if this is taken into account, then the TCPHC maps exactly (at least up to order \mathbf{e}_{\perp}^2) onto the OCPHC.

3.3 Ionic activity and diam eters

In electrochem istry, it is usual to de ne the mean activity of an electrolyte as


for a two-component system where the positively charged particles are used as reference species in the sam e way as in Eq. (43). f_{ex} , the excess free energy, is the di erence between the free energy of the interacting systems and the free energy of an ideal gas, i.e., $f_{ex} = f f_{id}$.

There are di erent ways of measuring f , as for instance, through the change of the freezing point of the solvent (usually water) with the addition of salt[28], by m easuring the change of the potential di erence between the electrodes of a concentration cell as salt is added [29, 28] (potention etry), or by direct m easurem ent of the solvent activity through vapor exchange between a solution with known activity and the sam ple [30,28] (isopiestic) . A lthough dating from the early nineteen hundreds, these are still the most common techniques used today, especially the potention etry, which is regarded as the most precise technique of all. The values of f are tabled as function of the salt concentration for many di erent electrolytes $\beta 1$, 32,28].

From the free energy Eq. (43) and the de nition Eq. (72)we can obtain the low density expansion for the m ean activity coe cient of a q+ :q salt. To compare with experim ental results, it is useful to note that $e_{+} = 6.022$ 10 4 q d³₊ %, where d₊ is in Angstrom s and % is the salt concentration in m oles/liter. A fter the appropriate expansion, f reads

(the order 3=2 in the mean activity coe cient is the one consistent with a free energy given up to 5=2). The coefcients DH, 1, etc. are given in the appendix, Eqs. (99{ 103). Experim entally determ ined activity coe cients are that in the lim it of vanishing density, the distinction between the activities calculated in the Lew is-Randall or in the M dM illan-M ayer descriptions (constant pressure versus constant volum e ensem ble) becom es negligible [33] in comparison to the st corrections to ideal behavior. The experim ental data at low density can be directly com pared with the theory without the need to convert between the two ensembles.

At in nite dilution, them can activity $\cos \operatorname{cient} \operatorname{Eq.}(73)$ goes to 1, which is the prediction for an ideal gas. The rst correction to the ideal behavior is the term $_{\rm D\,H}$ $^{\circ}_{\rm H}^{1=2}$, which is the prediction one obtains from the Debye-Huckel lim iting law (DHLL), and is independent of the ionic diam eters, see Eq. (99). This means that there is always a range of concentrations where di erent salts (but with the sam e q_{t} and q) will deviate from ideality, but have the same activity. At higher concentrations, other term s have to be taken into account, and the ionic sizes begin to play an important role. In fact, as one xes $'_{\rm B}$ (' 7:1 A in water at 25 $^{\circ}$ C) and the valences q_{+} and q_{-} , the only free param eters in the rhs of Eq. (73) are the ionic diam eters d_{+} and d, which can be used in the theoretical predictions to t the experim ental values. This leads to e ective equilibrium values of the ionic diameters (when in solution), which we call the \therm odynam ic diam eter", in contrast to the bare diam eter[1] (obtained through crystallographic m ethods) and the hydrodynam ic diam eter (obtained from m obility m easurem ents[34]). By construction, it is this diam eter which should be used in equilibrium situations if one wants to describe an electrolyte solution as a TCPHC, as for exam ple com puter sim ulations of electrolytes.

3.3.1 Fitting assuming one mean diameter

We now show the tting procedure assuming that $d_+ = d = d$, where d is the mean diameter. We also restrict here this procedure to 1:1 salts, where more experimental data is available at reasonably low densities (below 0:05 mole/liter). For asymmetric salts, this method dem ands precise data at the range below 0:01 mole/liter, where

Debye-Huckel is often assumed to account for all e ects and few experimental points are available.

The assumption of equal ionic sizes has been offen used in the past to tactivities to modiled Debye-Huckel theories[28] to account for the ionic sizes (as previously mentioned, the Debye-Huckel limiting law is insensitive to it). Since we force the two diameters to be equal, we only need the expansion for f up to linear order since this will determ ine uniquely the single unknown parameter. From the experimental data f^{exp} [35,31] we subtract the diameter-independent term and obtain the dilerence

The tto this function leads to the coe cient of the linear term $_{1}^{exp}$, and that can be used to determ ine the diam eter by solving the equation $_{1}$ (d) = $_{1}^{exp}$ (with d as unknown). In Fig. 6 we show the experim ental[35,31] f for HCl, N aC land KC land the theoretical results (up to linear order in %) using, respectively, the diam eters 4:0 A, 3:7 A and 3:6 A. These values come from the tting described above applied to the experimental data in the range % = 0:01 to 0:05 m ole/liter. The diam eters obtained are very close to the ones obtained in R ef. [35] with a sim ilar tting, but using the D H theory with an approximate way to incorporate the ionic sizes.

The fact that $d_{\rm H\,C\,l} > d_{N\,\,aC\,l} > d_{K\,C\,l}$, which is the opposite to the sequence of bare diam eters, is a consequence of the existence of hydration shells around the ions which tend to be larger for sm aller bare ion size[1]. Notice how – ever that the values obtained here lie between the bare diam eters and the hydrated values available in the literature. This is not surprising since the e ective hard-core size simultaneously re ects both the presence of the hydration shells and the \softness" of the outer water layer as two oppositely charged ions approach each other.

3.3.2 Fitting assuming two diam eters

If we now assume that both d_+ and d_- are unconstrained, we have to use one more term in the expansion of the activity coe cient and solve the coupled equations




Note that we subtracted the term proportional to \ln , since like the DH term it is independent of the ionic diam - eters. W hat is interesting about this tting procedure is

that the two ionic diam eters are independent param eters, that is, the e ective sizes obtained through this tting do not depend on the size of a \reference" ion, contrary to what happens when using crystallographic m ethods[36]. The m ethod we show here can in principle lead to useful results, as long as the experim ental data is accurate enough at very low densities, as we now dem onstrate.

Fig. 7 shows the mapping between the parameter space of ionic diam eters and the two coe cients $_1$ and $_{3=2}$ (for a 1 : 1 salt in water at room temperature). The mapping is restricted to the range 3 A < d_{+} < 27 A and 3 A < d < 27 A. This allows the \inverse m apping" between the $(_1;_{3=2})$ (space and the (d ;d,) (space: any system with ionic diameters within the values above should have the coe cients $_1$ and $_{3=2}$ inside the region in the $(_1;_{3=2})$ {space, as shown in Fig. 7.0 ne problem becomes obvious: the coe cient $_{3=2}$ is larger than the coe cient of the linear term, 1, meaning that experimental data at very low concentrations are needed. As an example, Fig. 8 shows f = for NaC 1[31] as a function of $\text{S}^{1=2}$, which should be asymptotically linear in the lim it %! 0 and therefore give the coe cients $_1$ and $_{3=2}$ by a simple linear t according to Eq.(77). The lines shown are two possible asymptotic linear ts to the experimental points (line a is given by f = 8 = 2.59 9:94 $8^{1=2}$, and line b by 2:47 $6:00\%^{1=2}$). The inset to Fig. 8 gives the corresponding positions in the $(_1; _{3=2})$ {space (cf. Fig.7) for the two lines. C learly, only one of the ts (line b) leads to reasonable values for the diam eters (between 3 and 9 A as seen from the position of point b in the inset, $d_{+} = 3.8 \text{ A}$ and d = 5:4 A as obtained by solving Eq. (75)), while the other t (line a) leads to unreasonable values for the

diam eters (outside the range 3 to 27 A). In other words, the asym ptotic extrapolation of the experim ental data is very sensitive to sm all errors, and in order to obtain the diam eters with this m ethod one needs m ore accurate data at very low densities (which to the best of our know ledge is not available in the literature). A lthough N aC lw as used as exam ple, the situation is identical for other salts.

4 Conclusions

U sing eld theoretic m ethods we obtained the exact low density (\virial") expansion of the TCPHC up to order 5=2 in density. In its general form, the model can be applied to both electrolyte solutions and dilute colloidal suspensions (when the van der W aals forces are unim portant); the free energy derived here provides a uni ed way for handling both systems in the lim it of low concentration. A sthe calculations show, the generalization to shortranged potentials other than hard core is possible.

The behavior of the coe cients B $_2$ and B $_{5=2}$ suggests that the series is badly convergent, meaning that the inclusion of higher order terms does not necessarily extend the validity of the free energy to larger densities. We saw that the divergent behavior of these coe cients is related to the ionic pairing [14,15,16] which is favored as the coupling increases (this is not present e.g. in the OCPHC [10]). This also means that such a low density expansion is not very useful to study the phase behavior[37] of ionic systems: in the situation of phase-separation between a very

dilute phase and a dense phase, typically the average density in the dense phase already falls outside the range of validity of the low density expansion.

In applying our results to colloidal systems we concluded that at low density the counterion entropic contribution dom inates over the electrostatic contribution due to the macroions; the latter contribution can be described, in this lim it and up to this order, by an OCPHC corrected by e ects due to the exclusion of counterions from the colbidal particles.

Finally, we used the theoretical results for the mean activity coe cient to t experimental data and extract e ective ionic sizes. In the simplest thing, where we assum ed the two ionic diam eters to be equal, we obtained sizes that are reasonable and close to what one would expect from the results obtained by other methods. For the m ore interesting case where the two ionic sizes are taken as free param eters and determ ined independently, we show ed that one would need m ore experim ental data for the m ean activity coe cient at very low densities (which, to the best of our know ledge, is not available in the literature) to obtain the correct values for the diam eters. W ith the proper experim ental data it would then be a simple matter to obtain the e ective therm odynam ic ionic sizes, which could serve as useful input for computer simulations of twocom ponent-plasm as with hard-cores to m odel electrolyte solutions.
