The m icroscopic theory of super uid ${}^{4}\text{H}e$

W e present a m icroscopic theory of super uid ⁴He, form ulated using the overall experim ental observations as input inform ation. W ith the theory of a consistent basis, we answer all of the essential questions regarding He II. To conform to the overall key experimental observations, we show that in their coexistence at a higher T the super uid and norm al uid atom s necessarily aggregate in separate large regions, which with falling T reduces to predom inantly super uid aggregates. In a super uid aggregate, term ed a m om enton, the helium atom ic wave-packets primarily perform localized (harm on ic) oscillations about sites xed on the momenton, facilitating excitation states of discrete energy levels. The predom inant therm al excitation in the super uid equilibrium is hence between these discrete levels, i.e. in the form of single phonons. Superposed to the coherent oscillations of the single atom s above, the m om enton waves, com prising the in phase, sim ultaneous oscillations of all of the atom s in each m om enton, give rise to the so-called second sound wave, which contribution to the total excitation and energy is however negligible. The super uid atom s are strongly correlated, due to a many-quantum -atom correlation, having a binding energy 7.2 K /atom as from experim ents; from this we suitably de nea super uid bond, $_{\rm b}$ ' 7.2 K/atom. $_{\rm b}$ is substantial, on the scale of total excitation energy (15 K) or of the binding energy of He I (3 K / atom), and inevitably dom in a tes the phase stability of He II. A coordingly in the super uid in quasi equilibrium between 0.6-2.17 K, therm al excitation is predom inantly due to the break-up of b, at an activation energy b + v ' 8:6 K. This yields the experimentally observed specic heat, and in turn the inelastic dam ped-B ragg scattering of neutrons at 1:93 A⁻¹. By embodying these concepts pertaining to static structure of the uid, atom ic bobnding and atom ic dynam ics, we establish equations of motion for the super uid atom s, both sem i-classical and quantum m echanical, in a coordinate decomposition scheme. Based on their solutions, and the results from a corresponding statistical therm odynam ic treatment, we have been able to quantitatively predict all the essential properties of H e II, including the full excitation spectrum (dividing in q < 1:93 = 2, 1:93 = 2 < 1:93 and q = 1:93A 1), the two uid fractions, the speci c heat (dividing in the T $^3-$ and the -C $_{\rm V}$ regions), the super uid phase transition temperature T , and in a separate paper II the critical velocity v_c , the total number of excitation states and the super uid viscosity; all of which are in good overall good agreem ents with experim ents. We have also evaluated the zero point energy, the potential energy, the st order therm odynam ic functions including U (T), A (T), S (T) and J (T) of which S (T) can be satisfactorily compared with experim ental data; we also form ally present the continuity and stability conditions of the super uid, and the dynam ics structure factor due to the b excitation. The microscopic scheme also facilitates a novel, consistent QCE super uidity m echanism , presented in paper II. A lso on the basis of the scheme, we show that the circulation qunataization is due to a circular atom ic wave self-interference. As a whole, in terms of the theory proposed in this work not only are all the explanations regarding the essential properties of H e Π of a consistent theoretical grounding, but also are consistent with the concep-

tions that apply to common condensed matter systems and with the common laws of physics. The series of novel concepts evolving from this work can give signi cant impact also to the understanding of other super uids.

I. IN TRODUCTION

Liquid ⁴He exhibits properties which are altogether anom alous at tem peratures below 2.17 K, i.e. in the super uid phase, H e II. The two most striking ones are its restraint from solidi cation down to zero K under am bient pressure¹ and its super uidity.^{2 {4;6;5;7;8} Som e of the anom alies, such as the large zero point energy⁹ and the volum e expansion with falling T $_{\rm r}^{10}$ can be traced in mediately to the extrem e chemical character of the $^{4}{\rm He}$ atom, which being light, sm all and inert. M any others, on the other hand, cannot be understood in this sim ple m anner; the far-m ost of these are the super uidity, the circulation quantization, 11 {13 the specic heat about the phase transition, 14 the anom abus excitation spectrum 15 and the anom abus therm alconductance¹⁶ and melting curve.¹⁷ These properties can be seen to be largely dictated by the collective and correlation behaviour of the atom s in the condensed form and, their interpretations inevitably require stly an adequate m icroscopic depiction of this condensed system . Since the discovery of the super uidity of H e II during 1911, 10 $-1938^{3;4;8}$ extensive investigations have been made on this system both experimentally and theoretically; although, experimentally direct probe of the excitations using neutron scattering technique, which inform s a great deal about the m icroscopic dynam ics, did not begin until the end of 1950's.¹⁵ M any com prehensive reviews on this subject haven been given.^{18 {33}

Theoretically, the current understanding of $H \in \Pi$ is essentially based on the compilation of a few distinct models proposed by London,³⁴ Landau,³⁵ and Feynman³⁶ during 1938–1950's; a num ber of other studies 37 {42 have also historically contributed to the now accepted "single" model. With one thing in common, all these models assume that He II consists of two coexisting uids, the norm al uid and the super uid, and the two uids interpenetrate on an atom is scale. The otherwise main concerns in each of the models have been the excitation scheme of the super uid and a (corresponding) super uidity mechanism. London^{34,18} suggested that of the tow uids, the super uid undergoes Bose Einstein condensation (BEC), i.e. it consists of atom s that condense in the momentum space into a single degenerate state and in real space are motionless and non-interacting. A coordingly, the BEC in plies a non-viscous and zero-entropy super uid, and hence yields the super uidity. This is despite the fact that, in his early view, London also foresaw the possibility that the quantum states of liquid He II would partly have the feature of the vibration states (phonons) of Debye in the theory of $m \text{ etals}^{43}$. As opposed to London, Landau³⁵ described He II as having two elementary excitations, phonons created mainly at a low T, and rotons at a higher T. Super uidity will result if the velocity of a ow motion is lower than that of the particles from the elementary excitations. A landmark success of Landau's model is the excitation spectrum he phenom enologically designated in order to achieve a desirable (lambda) speci c heat; the key feature of the spectrum has been remarkably corroborated, rstly by the neutron scattering experiment of Larsson et al. in 1958.¹⁵ However, Landau did not provide a microscopic scheme as to how the two elementary excitations occur, and in particular, what actually a "roton" is. Furtherm ore, for the super uidity Landau predicted a critical velocity which is at least two orders of magnitude too large than the experimental values, and contains no mechanism for channel width dependence. The two distinct models above were linked together by Bogoliubov³⁸ who suggested that the majority of super uid is in BEC state in which, in contrast to London's BEC, the atoms interact weakly, and that the transition of the atoms from the BEC state to the quasi particle state produces the two types of elementary excitations of Landau. These two or three models are essentially phenom enological. Feynm an³⁶ in the 1950's, in a sem i-m icroscopic description, suggsted the excitations (of both types) result from the super uid, being the ground state, to the norm al

uid. Quantitatively based on variational principle for som e trial wavefunction, where the m icroscopic picture for atom ic m otion and excitation is how ever essentially lost, he gave an im proved prediction of the excitation spectrum (1954; Feynm an and Cohen, 1956). At a microscopic scale, Feynm an brie y, qualitatively described the atom s as being con ned in the cages built by neighboring atom s ({ a picture held also in the present work), but prim arily showed the "rotons" of Landau, representing the higher energy excitations, to be possible from a symmetry point of view. Taking Landau's critical velocity as a valid start, but to rescue it from the clearly large quantitative discrepancy, Feynman (1955) assumed there present even lower excitations, vortices; the creation of maximum vortices yields critical velocities giving the right m agnitudes. Until 1990's, the widely adopted (excitation) m odel of $H \in \Pi$ is the up-dated compilation of the models by the four individuals, referred to below as the LLBF theory, is as follows:⁴⁴ the super uid corresponds to a BE condensate, which becomes hundred percent at zero K; the two elementary excitations result from the shuttling of atom s between the super uid - the BE condensate { and the norm al uid. W hilst the LLBF m odel assumes that, at zero K, the BEC, being identied with the super uid, is hundred percent, recent experiments have shown the BEC is only 9 10 percent. This con ict was circum vented by G lyde and G ri n in the 90's, 42 in proposing that the BEC fraction as well as the helium atom mass is modied due to an interaction of the super uid with the norm al uid atom s. This apparent in provem ent does not how ever rem ove the basic di culties pertaining to the foundation of the LLBF model. Theoretical studies of liquid ⁴He in the past two decades have otherwise largely involved quantum simulations including variational ${}^{\bar{}}$ C 47 {50 and path integral M C , 51,52 which essentially pertain to a m ore accurate representation of Feynman's (or, the LLBF) excitation m odel. M ore broadly, these studies are not yet apt to yield the m icroscopic inform ation of the super uid atom s, regarding conquration, motion and dynamics, and are even far remote from touching the microscopic scheme of super uidity, and circulation quantization. The Green's function technique for treating many-body problems is not feasible today for treating such complex system as He II, in respect of its above ground propety in parcticular.^{33;54}

As a whole, the LLBF theory encounters various di culties which give rise to a variety of self-contradictions, and therefore does not represent an ultim ately satisfactory theorization for the super uid H e II. Its m ost signi cant di culties m ay be outlined as follows (further discussions are pointed to each relevant sections). 1). The LLBF them alexcitation picture (when faithfully formally represented) inevitably predicts a broad peak in the dynamics structure factor, in direct contradiction to experim ental observations (Sec. IIA). 2). The non-viscous, non-interacting super uid atoms, which although is sensibly not held in the dynam ic model of the LLBF theory but is nevertheless a base for the LLBF explanation of super uidity { see item 4) below, directly contradicts with the fact that super uid atom s are strongly correlated and the actually substantial atom ic binding energy (Sec. IIB). 3). A mixture of two uids interpenetrating on an atom ic scale lacks the mechanism for the maintenance of the atom ic bonding characters of the respective uids (Sec. IIB).4). The critical velocity criteria for super uidity of Landau³⁵ and Feynm an³⁶ (1955) have both incorrectly ignored the prim ary low energy excitations due to phonons (which in fact sensibly presents in the LLBF super uid dynam ic picture), and the com parison of velocities of di erent m asses they made does not conserve energy (Ref. 55).⁴⁵. 5). The "roton" picture does not predict the experim entally observed overall features in the excitation at q_0 (Sec. IIB). 6). The "Bose-E instein condensation" picture is itself not capable of explaining super uidity.⁵⁶ These di culties inherent in the foundation (s) of the LLBF theory, cannot to us just be removed by a few minor improvements. Therefore, as the motivation for beginning this work, we felt it necessary to develop a theory that starts from an alternative { an essentially consistent { theoretical grounding.

To provide an overall satisfactory interpretation of the complex behavior of He II, we rst, in Secs. II-III, carry out a system atic derivation of a (m icroscopic) theory by using, to the broadest possible extent, the key experimental properties of liquid ⁴He as input inform ation. Three key questions are to be addressed: 1) do the super uid atom sprim arily perform localized oscillations, or, di usion, or do they stand still (see Sec. IIA)? 2) whether and how the atom s are interacting (see Secs. IIB, III)? 3) when the two uids coexist in He II in the higher T end, do the super uid atom s aggregate in large regions such that they possess

a characteristic bonding energy, or, do they intermingle with the normal uid on an atom ic scale (Sec. IIC)? The answers to these questions have been achieved in this work after making iterative contrasts between what is predicted by an assumed "theoretical model" and what is observed by experiment, and between the prediction of one property and its in plications for others. The key components of the theory are therefore already characterized in Secs. II-III. In Secs. IV $-V \square$ we establish the corresponding form altheoretical and quantitative description of H e II, including the composition structure of H e II (Sec. IV), the set-up of equations of m otion of the super uid atom s (Sec. V) and solving (V B-V C), and the prediction from the solution of the physical properties, including excitation spectrum (V B,V C), the stability condition of the super uid (Sec. V I), the quantization of circulation (Sec. VII), and the scattering function near the super uid bond excitation (Sec. VIII). The super uidity (its mechanism and the critical velocity) is treated in a separate paper, II.⁵⁵ These above contents constitute the microscopic part of the theory of super uid ⁴He. Sections IX -X present a corresponding statistical therm odynam ics description of H e II. B rief description of the theory has previously been presented in unpublished internal reports⁵⁷ except for Ref. 57 (2000) which mainly discusses the experimental probe of the QCE e ect as fully presented in paper Π .

II. THE FORM ULATION OF THE M ICROSCOPIC THEORY BASED ON OVERALL EXPERIMENTAL OBSERVATIONS




FIG.1. (a). The experimental static structure factor S (q) 60 is plotted to assist discussions in the text. (b). Total thermal excitation energy "(q) versus the neutron momentum transfer q (equal to phonon wave number K) for the super uid of He II. C incless indicate data points from inelastic neutron scattering measurement at 1.12 °K 67. The solid and dashed curves show the theoretical dispersion (Sec. V); see further FIG.7. The dotted curve illustrates a regular (i.e. with no super uid bond excitation and with no nearest-neighbour repulsion) longitudinal single phonon energy dispersion, given by Eq. (26a) for all K values, obtained with a = 3:3 A (2 = a = 1:93 A 1). (c). Lower graph: ratio of neutron scattering intensities, I_1 (T_1) and I_2 (T_2), at two tem peratures T_1 (< T) and T_2 (> T) as indicated in the upper graph.

The static structure factor, S (q), of the (pure) super uid, as has been probed both by neutrons^{58;59} and by X-ray,^{60 {63} exhibits a heavily damped rst peak at about q_b 1:93 A ¹ and alm ost vanishing higher rank peaks (FIG .1b). Immediately, this signatures that the super uid retains only a short range ordering, with a mean atom ic separation $a = 2 = q_b = 3:3 \text{ A}$. The detail of this ordering is not our concern; for a large part of our purpose here it su ces to conveniently, fully represent the atom ic con guration with three orthogonal arrays of atom ic chains in X;Y;Z directions, we thus have a simple cubic pseudo lattice with a lattice constant a and a pseudo lattice reciprocal lattice vector $b = 2 = a = q_b$; see further Sec. V B.

Experim ents, including speci cheat (Secs. I,II), frequency dispersion (Sec. I), and second sound, $^{64\,\{66\}}$ have commonly shown that H e II is an coexistent of the super uid between about 2.17 to 0.6 (1) K, reduces to predom inately a (pure) super uid below 0.6 K, and at zero K is hundred percent a super uid. Below in Secs. IIA-IIC we infer from experiments the excitation and dynamic schemes in the two respective temperature regions, and the m icroscopic composition structure of the two-uid coexistent and the related dynamics.

A. Therm alexcitation via single phonons and atom ic dynam ics scheme of the super uid equilibrium

(i) The dynamic structure factor The most revealing indication as to the underlying dynamic scheme in the super uid equilibrium, which predominates below < 0.6 K, is from the dynamic structure factor S (q;!). The measurements from inelastic neutron scattering^{15;67{73}</sup> have shown that the S (q;!) of He II is characteristically dierent at T below and above T, at a given momentum transfer q, with q raging from 0 up to at least 2.4 A ^{1.74} The strongest distinction presents at an intermediate q ($1:1 A^{-1}$).^{68{70} Here, the S (q;!) exhibits a superposition of a sharp and a broad peak on the ! axis, ! being the neutron energy transfer.⁶⁸ The broad peak, which has a non-vanishing intensity at ! = 0, at T above T identies with the broad di use peak of the norm all uid He I and reduces smoothly in intensity as T is reduced to below T. The sharp peak appears abruptly as T falls just below T ; its intensity increases as T falls and then basically stabilizes from about 1 K dow nwards.




FIG.2. Excitation scheme for the super uid equilibrium as proposed: (a) by the present theory. The excitation is via the creation of a single phonon, corresponding to a transition between the discrete energy levels $_n$ (q) and $_{n+1}$ (q) of the oscillation mode q of the localized (relative to) super uid atom s. (b) by the LLBF theory. The excitation of the helium atom ic motion is produced by a transition from the single degenerate state of the "Bose-E instein condensate" (the super uid) of energy E_{BEC}, to the continuous norm al-uid energy E (p) at a given momentum p.

It is natural to correlate this T dependence of the scattering intensity with the two-uid fraction variation just m entioned. W oods and Svensson⁶⁸ based on quantitative evaluation, have shown that indeed the sharp and the broad peaks are attributable to the super uid and the normal uid respectively. Now, for the super uid of concern, we can thus concentrate oursevels below only on the sharp peak. The compelling feature with the sharp peak is that, with the observed nite width being in principle only due to the nite instrumental resolution, $r^{25;68;69;75}$ it has the three characteristics of the phonon excitations in a crystalline solid: it is qualitatively narrower, it has a high frequency cut-o and, it peaks at a nite ! and has a vanishing intensity at zero !. Such a sharp peak in S(q; !) which represents the probability that an energy transfer of ! occurs inevitably in plies that, the excitation must have occurred between two discrete energy levels. Experiments using pulse transmission techniques⁷⁶ have on the other hand shown that, at long wavelengths, the excitations are via sound waves. The combined information above hence characterizes the excitation to be via the creation and annihilation of phonons, each having an energy quantum, E (q). We refer to these as "single phonons" to separate from the "collective phonons" of Sec. IIB. It should be remarked that, phonon excitation, with a well de ned atom ic dynam ic scheme

in Debye's theory of solids (1912),⁴³ is term inological also held in the LLBF theory for He II but, as will be illustrated in FIG. 2 below, it clearly is unable to be produced by the dynam ics scheme of the LLBF theory.

To infer from the above feature of excitation the underlying atom ic dynam ic scheme, we shall rst be guided by a general principle of quantum mechanics, which states that the state of a quantum particle will be discretized when under spatial connement. In a bulk super uid { a condensed atom ic assembly, if and only if assuming the atom s are localized { in both ends of its excitation, then each atom is wholly conned by its surrounding atoms, as is in a solid. And only then, the atom will then acquire fully discretized states; the transition between these states will result in the sharp peak of the S (q;!), as is how such a sharp S (q;!) peak in a crystalline solid (at low T) regularly results. (A lthough, the two present a few important distinctions which we discuss in Sec. V B.) Based on the above arguments and furtherm ore on the variety of other uniform indications to be described below, we propose:

In the super uid equilibrium, the therm alexcitation is predom inartly via the creation and annihilation of (longitudinal) single phonons, which predom inate at tem peratures below 0.6 (1) K. This excitation can only have occurred within the (pure) super uid and resulted from localized (harm onic) atom ic oscillations (of an amplitude u (R)), referred to as the LAO dynam ics scheme. Each oscillator roughly corresponds to a single helium atom, separated by the interatom ic spacing of H e II, a '33 A, and oscillates in a potential well V (of a depth of 72 K/atom as will be detailed in Sec. IIC).

Based on the LAO dynam ics scheme, the solution of equations of motion of the super uid atom s in Sec. V actually reproduces the experimentally observed excitation feature, i.e. the excitation is between discretized energy levels $_n$, n = 0;1;::: (FIG. 2a), each di ering by an energy quantum of a phonon, E(K). In e ect, LAO is the only dynam ic scheme able to give rise to a sharp di raction peak for the super uid. In contrast, the LLBF picture of phonon excitation (FIG. 2b), namely the excitation results from the knocking out of atoms from the Bose-Einstein condensate into the norm al uid, will incorrectly predict a broad peak of the dynam ic structure factor. Evidently, this is because the energy of an atom in the norm al uid end, E (p) at a given momentum p, and consequently the excitation energy E (p) E_{BEC} , are continuous, despite the single valued BEC energy E_{BEC} .

The inference of localization and the LAO from the sharp S (q;!) peak is further supported by the observation of a one-to-one link between a sharp S (q;!) (or broad) peak and atom ic localization (or di usion) which being general and system -independent, as has been identied, for the rst instance, by Skold and Larsson⁷⁷ in their comparison of the scattering features from the solid and the classical liquid phase of argon, and sim ilarly from the two di erent phases of other system s. W here, the broad scattering intensity at lower energies

was assigned to be due to di usion, the so called "quasielastic scattering". In another example, a sharp S (q;!) peak centered at a nite! for a xed (interm ediate) q has also been observed in various m etallic liquids, such as lead by E gelsta ⁷⁸ and rubidium by C opley et al.⁷⁹ C opley and Lovesey⁸⁰ correlated that feature to the stronger m etallic bonding of R b com pared to that of a classical liquid. W e can readily infer that the strong bonding functions to con ne { to localize { the atom ic m otion.

The LAO scheme also in mediately explains as to why mainly the intermediate q scattering rather than the low q is speci c with the super uid; at a q < 0.4 A⁻¹, for T below and above T, the position, intensity and width of the S (q; !) peak of liquid helium exhibit no distinct changes except that the rate of increase of the width is slowed dow n.⁷⁰ Since K (q) 1.1 A⁻¹ corresponds to a wavelength (= 2 =q) 10 A crossing over only a few atom ic spacings (with a '3:3 A). Hence a coherent oscillation, if to occur at such a short wavelength, would require all of the atom s m ove cooperatively and the atom s m ust therefore be localized. By contrast, at long wavelength crossing overm any atom s, the oscillation occurring by m eans of density uctuation is insensitive to di usion of som e individual atom s. Indeed, in addition to the observation for liquid helium above, neutron scattering experiments have shown that the S (q; !) functions from norm al liquids all present a certain sharp peak at q < 0.4 A^{-1.80}

(ii). The excitation spectrum The LAO scheme is further pointed to by the excitation spectrum (FIG.1b), ! (q) due to the sharp peak of S (q; !)⁶⁷ in two respects. First, except for the peculiar non-zero value, $_{\rm s}$ ' 8.6 K at q_b ' 1.93 A 1 , ! (q) has a sinusoidal dispersion which is the solution of the equation of motion of (relatively) localized helium atom s, Eq. 26 in Sec. VB, for the longitudinal mode. Second, the solution informs the linear sector to be due to propagating elastic sound waves, here phonon waves, of a velocity 238.9 m /sec which is in near exact agreement with the rst sound velocity $c_1 = 239 \text{ m/sec}$ from pulse transm ission experiments.⁷⁶ M oreover, the experiment by W oods showed that the slope here is independent on T 81 and disproves the postulation⁸² that the slope m ight be instead due to the two-uid density variation with T ($c_1 (s=)^{1=2}$). Furtherm ore, the dispersion "period", $q_b = 2 = a' 1:93A^{-1}$, giving a' 3:3 informs the oscillator size a 3:6 A,⁸³ which is just a helium atom. This can be similarly seen from the upper limit, q' 0.6 A ¹, of the propagating phonon wave which development would require at least be a few oscillators within a wavelength. In contrast, the part of the "in-phase" oscillation of a large (N $_{\rm M}$) num ber of super uid atom s (to be discussed in the next section), which alone is sim ilar to the weekly interacting BEC wave or the zero sound wave⁴⁰ in the LLBF term inology, has a maximum dispersion period K_M / 2 \exists N_M a << q_b and an excitation energy negligibly low com pared to the one of the single phonon here.




FIG.3. Speci c heat of He II, C_V (T). C incles represent experimental values (Refs. ??); solid lines are statistic thermodynamic results of Sec. IX as based on the present microscopic theory of Secs. II-V. (a) for T below 0.6 K, the theoretical C_V (T) / T³, Eq. (74)⁰, is given by the derivative of the internal energy obtained from a canonical ensemble average over the states, with a D ebye type of density of states, of the independent, indistinguishable single phonons, which are produced due to in real space the harm onic oscillations in the norm al coordinates of the (N) independent, localized super uid atoms relative to . (b) from 0.6 to just below 2.17 K, the theoretical $-C_V$ (T) (Eq. (74)⁰) results principally from the conversion of the super uid to the norm al uid, via the excitations of super uid bonds. The lower and upper limits of T_o, 2.17 and 3.0° K, yield the uncertainty boundaries of the theoretical C_V (T) shown by the solid lines 1 and 2; T_o = 2.6 K gives the optimum C_V (T), solid line 3.

(iii). The T³ speci c heat The LAO scheme is indicated by the D ebye T³ behavior of the speci c heat C_V of He II between 0 0.6 K (FIG. 3a).⁸⁴ Insofar as a non-conducting condensed atom ic system is in question, a D ebye T³-C_V is broadly known to be necessarily given rise to by an atom ic assembly where the atom s are localized and perform harmonic oscillations; the super uid is not an exception as Sec. IX D explicitly treats based on statistical therm odynamics. By contrast, a classical uid consisting of di usive atom s generally shows a Petit-D ulong heat capacity. It follows that, the LLBF excitation scheme w ill inevitably yield a speci c heat strongly bearing the feature of the norm al uid, which cannot be of a T³ behavior. Furtherm ore, the theoretical D ebye C_V (T) obtained in Sec. IX D, when tted to the experimental C_V data, produces a longitudinal phonon velocity of 241 m /sec. This value agrees (within experimental error) with the c₁ value (239 m /sec) from pulse transm ission⁷⁶ as well as phonon velocity (238.9 m /sec) from the excitation spectrum discussed in (ii).

(iv). The inferred di usion rate The LAO scheme is directly supported by the solid-like low di usion rate in He II, being 10 $\,^8$ cm²/sec as Eq. 26 in Sec. V C shows. The associated di usion barrier in plies a negative potential well in which the atom executes oscillation.

(v). The capability of predicting super uidity The preceding observations inform that the super uid atom s are not standing-still (in either the absolute or relative coordinates), and rather, the super uid is fully them ally excited, with the excitation states, as Sec. IX shows, exhibiting a P lanck distribution. The LAO scheme e and the implied property above are furtherm ore supported by the fact that, as paper II shows, on the basis of the LAO scheme e the QCE super uidity mechanism can consistently, quantitatively predict super uidity and critical velocity both in satisfactory agreements with experimental data.

The one-to-one connection between an excitation spectrum as FIG.1b for He II and a fully excited He II is an inevitable truth, if one compares it with the analogous excitation phenomena of the vast body of crystalline solids, in terms of the phonon feature in general and the K $c_{\rm l}$ behaviour in the linear sector in particular. Had Landau's criterion of critical velocity for He II, namely that if $v_{\rm s} < c_{\rm l}$ there is no phonon excitation, rejected the truth, then one will be led to the inevitably untrue conclusion, that any piece of crystalline solid moving, say against the surface of the ground, with a speed less than its sound velocity would be in super uidity motion.

B.The super uid bond excitation and atom ic dynam ics scheme; the gradual phase transition of the super uid

The atom ic localization in the LAO dynam ics scheme derived in Sec II immediately suggests that, in the super uid the atom ic bonding has undergone a qualitative enhancement compared to the van der W aals (vdW) "bonding" energy of the normal uid HeI.We represent the former by super uid bond, b, which is dened to be the negative of the binding energy per super uid atom that is given rise to by the attraction from many super uid atom s within their correlation regime, C learly, b is directly associated with the stability of the super uid phase. We propose:

A quasi equilibrium process is predom inated by excitations of super uid bond $(_{\rm b})$ in two closely related $_{\rm b}$ dynam ics schemes, where $_{\rm b}$ represents an attractive energy barrier which prevents the reference atom 1) from di using into its neighbouring site within the super uid when locally perturbed, due to therm all uctuation or an external incidence such as a neutron, and, 2) from transform ing into the norm all uid state when globally perturbed, e.g. by bulk heating-up between 0.6 2.17 K.

W here, U_{s0} is the ground-state cohesive energy (per atom) of the super uid, representing the depth of the potential well in which a He atom is con ned (FIG. 4a1); $U_{s0} = 7.2$ K/atom as given by thermal measurements at SVP.^{88;18} < $_n$ > is the per-atom kinetic energy of super uid atom s and is << U_{s0} as will be verified in Sec. IX. \overline{u}_s (< 0) represents the "long range" attraction energy by atom s in the entire uid bulk, so an atom in (\overline{u}_s , 0) can di use virtually freely. The super uid atom is, as Sec. V A will show, localized with respect to a kinetic energy even up to U_{s0} , thus one can expect $\overline{u}_s << _b$; hence we have




FIG.4. (a1). The potential energy V (u) for a super uid atom at X $_1$ and for one separated at a distance a at X_{l+1} , solid parabolic curves, theoretically constructed as in Eq. (20)" illustrated for the mode K a = 0.5; see FIG.8 for V (u) at di erent K values. In the potential wells, the super uid atom sperform independent harm onic oscillations in the relative coordinates . The potential well depth V_0 is given by the experimental ground state energy $U_{0s} = 72$ K/atom 88. The activation of an atom from the bottom of the well to just above zero, at a energy cost s = b + v, represents the excitation of a super uid bond $_{\rm b}$, with a site creation energy $_{\rm v}$. < > represents the average kinetic energy per super uid atom, and by Sec. IX $< > < < U_{0s}$, hence $_{b}$ ' U_{0s} . The dashed lines indicate the repulsive part of the potential, V (u) > 0, and is associated with the phonon excitation within 0:6 K 1:4 (1/A) where E(K) > $_{\rm b}$; cf. FIG.1. (a2) The ground state wavefunctions (solid curves) resulting from the solution of equation of m otion of super uid atom s. The dotted curves show wavefunctions for Ar atom ic mass. (b). Illustration of the norm al uid potential energy for two adjacent atom s. $E = U_n - U_{on}$ ' 3:1 K for T just below T is the kinetic energy, and v dw the average Van der W aals bonding energy. The di usion barrier height between the adjacent atom s, being about 1.6 K relative to E, is estim ated such that it produces a di usion constant in the order of 10 4 cm²/sec at 1 K, a typical value for liquids. V = $_{cn}$ is the energy region in which the atom s are free atom s throughout the bulk. $U_{on} = U_{os}$ is assumed.

Cases (i)-(iii) below show further experimental indications of the super uid bond.

(i). The speci c heat The super uid bond excitation upon a global perturbation is directly indicated by the experim entally observed $-C_V$ of He II between about 0.6 to 2.17 K (circles, FIG. 3b).^{85;86} For if the super uid to norm all uid conversion, which occurs in large quantity here, energetically involves the conversion of $_b$ to the qualitatively sm aller vdW bond of the norm all uid (FIG. 4a,b), then inevitably a large excess of heat supply is required. The activation energy, denoted by $_{sn}$, is thus consumed mainly for $_b$ and, additionally for a site creation energy $_{vn}$ and the kinetic energy E of a norm all uid He atom . Hence,

U sing (2a), the therm odynamic evaluation in Sec. IX will justify the excitation scheme above to actually reproduce the experimentally observed $-C_V: / \exp((\frac{1}{|k|=T}))$.

Furtherm ore, the b excitation scheme is supported by the observation that, a qualitative bonding change when transforming from one phase to the other is the common underlying excitation scheme for the second order phase transitions of a variety of systems (e.g. alloy) with a specic heat.

(ii). The dynam ic structure factor about q. The super uid bond excitation upon a local perturbation is directly pointed to, in the rst instance, by the peculiar features in the S (q_b;!), at q_b ' 1:93 A 1 , of the super und (FIG. 1b).^{15;67;70;89;90} Two of these are: 1) it peaks at a nite !, ! $(q_b) = s' 8:6$ K which is basically independent of T. 2) its peak width is qualitatively narrow and on the T axis exhibits a sharp edge at T .⁶⁷ By contrast, the peak of S (q; !) of H e I is broad, and its position dim in ishes towards zero as T rises, e.g. to 4.5 K/atom at T = 2.9 K.⁷⁰ On the other hand, a simple cubic crystalline solid, for example, would show a zero frequency at q. The underlying b dynamics for the above is explained below. At q_0 , which reciprocal being ' 3:3 = a A as noted earlier, the solution for the equation of motion (Eq. 12) relative to , the dotted line in FIG. 1b, gives no phonon excitation. And, in real space, as viewed by a neutron committing a momentum exchange of $q_b = K_{b}$, all atom s are located at the bottom s of their potential wells; cf. Sec. V B (ii). As the super uid atom s are localized, _b and _s are therefore relatively sharply de ned except for a nite smearing, primarily in _s, due to the short-range-ordering resultant uctuations in the instantaneous atom ic con guration. This therefore necessarily explains the qualitatively narrow er peak in S (q;!). On the other hand, a nite sm earing in plied above is indeed supported by neutron scattering experiments which have shown the S (q;!) peak { though narrow { has a nite width (e.g. system atically presented in FIG.8 of Ref. 67), being a couple of times the instrumental resolution as used e.g. in Ref. 73, and being also at least several times wider than Landau's theoretical prediction based on roton-roton collisions. In contrast, in a norm al uid the essentially free atom is di usion results in a signi cantly broad peak in the S (q;!).

The $_{\rm b}$ dynam ic scheme is further supported by the third feature in the S (q₅;!), namely that its intensity is the highest compared to at other q values. From the experimental data of Refs. 70, 68, the relative intensity, i.e. the ratio of the intensities, I₁ and I₂, below and above T respectively is estimated to be 14 at q_b (FIG.1c), which is about two times the second highest intensity, I₁=I₂ ' 7, at q = 1:1 A ¹. An amplication of the scattering amplitude at q_b is to be expected, if an incident beam of monochrom atic neutrons are indeed scattered by single atoms from an array of plans at a mean separation a, at which the condition q_b = 2 = a implies an elective B ragg scattering (see further Sec. V III).

That the same dynamics underlies both the specic heat and the excitation at q_b , as implied in (i) and (ii), can be justified by the fact that the latter indeed constitutes the major contribution to the former, as is shown both by our thermodynamic result, Sec. IX, and by the accurate numerical calculations of Yamell⁹¹ and others.⁹² It is noteworthy that, a frequency dispersion with such a minimum at q_b was initially devised by Landau in his well known 1941 paper, in order to yield a specic heat. We here see that, the correspondence between the C_V and the ! (q) does not necessarily imply "which" dynamics.

(iii). The ion mobility The $_{\rm b}$ dynamics scheme upon local perturbation is indicated, in the second instance, by the experimentally observed behaviour of the He ion mobility in He $\rm II_{*}^{93}\{^{95}$ which obeys

Hence in the ion drifting process, the ion is essentially not subject to a many-quantum -atom correlation; and also the ion principally will transfer its energy and momentum to the super uid, sim ilar to the thermal neutron scattering.




FIG.5. (a). A snapshot of the schem atic composition structure of He II at a T at which both uids have a signi cant fraction. Each super uid aggregate, a dotted region, represents a momenton; the momentons are random ly distributed through a norm al uid background. (b). In a momenton region, out of the thick framed region in (a), the absolute coordinates r of a super uid atom is represented by the vector sum of four relative coordinates: u describes the atom ic oscillation relative to R, R the translation of the equilibrium position of the atom viewed from , the coordinates of the center-ofm ass of the momenton, the oscillation of the momenton relative to , and the translation of the equilibrium position of the momenton.

The realization of the relative localization of the super uid atoms (Sec. IIA), and the formation and preservation of their large bonding (to be justiled in Sec. IIB) and its

m any-atom correlation origin (Sec. III), all point to a composition structure of the two-uid coexistent as described with a m om enton m odel (FIG. 5):

A momenton is rstly an aggregation of a large number of super uid atoms, of an irregular shape and size of macroscopic scale. The motions of the atoms in it are primarily the u (R) - oscillations as described in Sec. IIA, which are about sites R's xed in the center-of-mass coordinates of the momenton, , here. The two-uid coexistent of He II consists of trem endously many momentons adjacent to the normal uid regions, or within large (pure) super uid regions. Dynam ically as a whole, in a He II in therm al equilibrium at rest, each momenton oscillates slow ly with an amplitude (), about its equilibrium position, ; this motion is equivalent to the simultaneous and in-phase oscillations of all of the atoms in it, which (being of a small proportion) are superposed to the prominent coherent, not-in-phase u oscillations of the single atoms of Sec. IIA. Under a pressure di erence, describes the translation of a momenton, and hence the steady ow motion in the absence of convection. Finally, the excitation of a momenton occurs via the creation/annihilation of collective phonons, giving rise to the momenton waves.

In contrast, a mixture of two uids which are intermingled on an atomic scale, as is assumed in all of the existing models (or, the LLBF theory), lacks the mechanism for the preservation of the interaction of the respective uids. The formation of momentons also is energetically favourable in two ways: 1) given the large super uid atom ic binding originates from a many-quantum atom correlation (Sec. III), the gathering together of the super uid atom s will allow an optimum atom ic attraction, thus yielding the lowest energy of the system . 2) it requires less energy to turn a normal uid atom into a super uid atom, if the former is at the edge of the existing super uid region rather than inside the normal uid. Furthermore, based on the momenton model of composite structure, the two-uid fractions can be quantitatively predicted with only the experimental density of liquid helium as an input data (Sec. IV), in satisfactory agreement with the statistical therm odynamics treatment in Sec. IX.

D irect experimental indications of the momenton wave include: (i) A slow propagation of the elastic wave { the so-called second sound wave { has been observed, e.g. by Peshkov et al.⁶⁵ and Atkins et al.⁹⁶ in therm alpulse transmission measurements of H e II. It occurs only at low frequency (less than 1000 cycle/sec); it has a slow propagation velocity, c_2 ' 20 m/sec within 2:17 1 K, and from about 1 K downwards, c_2 increases rapidly and the pulse becomes substantially broadened. Despite the broadening, a nite width of the pulse is observed even with T being as low as 0.7 K, which tends to suggest a nite size of the momenton in the super uid. (ii). The therm al conductivity in H e II¹⁶ is observed to be abnorm ally large and not de ned by a temperature gradient. The momenton wave essentially describes the phenom ena of (i)-(ii). For instance, the simultaneous and in-phase oscillation of many atom s (of a momenton) in e ect will produce the instant propagation of a heat pulse; in other words, the pulse is at once carried forward by a distance having the dimension of a momenton.

III. THE ORIG IN OF THE SUPERFLUID BOND

The experimental evidence of Secs. IIA -IIB together points to the cooccurrence of the large atom ic bonding and the (relative) localization of the atom s in the super uid. Such a cooccurrence commonly takes place in such processes as liquid solidi cation, for which the physics is generally understood. On the other hand, the physics for the super uid atom ic localization, which occurs uniquely as a result of the transform ation from the classical state He I to the quantum uid He II, appears specic. From the basic fact that the super uid atom s are quantum m echanical, we can infer their enhanced bonding m echanism as follows. A quantum (uid) atom is marked by a broadly spread wavefunction (r), through a volum e at least a few times greater than a (see Sec. V). In this volume, at any location we will nd a fractional density of atom A, $\frac{2}{A}$ ($r_{A_{i}}$) and that of atom B, $\frac{2}{B}$ ($r_{B_{i}}$); for simplicity, we call them partial atom A_i and partial atom B_j. Each partial atom consists of a fractional nucleus (of a charge 2 (r)Z $^{2+}$) and a fractional electron cloud (of a charge 2 (r)Z $^{2-}$) in just the way as the complete He atom, except for each being weighted by the fractional density ² (r) $\left(\frac{1}{v} \right)^2$ (r) dr = 1.) The above yield three characteristics in the atom ic interaction. 1). the exchange-correlation is am ongst all of the partial-electrons of all of the partial-atom s, as well as am ong all of the partial nuclei, that tend to approach the sam e locations. In this complicated correlation process, the surrounding atom s extending to many neighbors are strongly involved with one another. 2). given an AB atom pair (meaning A sitting to the left of B), some of the partial atom pairs can assume the $B_{i}A_{i}$ congurations. These $B_{i}A_{i}$ pairs will repel with each other when A and B are tending to part. Both of the above aspects will lead to the observation that the atom s are prohibited from separating from one another and are thus driven into a (relative) localization. 3). the interaction strength between a pair of partial atom s is only a fraction of that of the total AB interaction. This will particularly a ect, actually soften, the short-range repulsion.

In addition, the localization allows a cooperative motion of many helium atoms, the LAO scheme. The atom ic polarizations are therefore induced system atically, which essentially corresponds to the London or dispersion energy,^{97;98} of the form $e^4h_0=2^2r^6$, rather than random ly as with the normal uid van der W aals interaction.

IV. QUANTITATIVE DESCRIPTION OF THE COMPOSITION STRUCTURE OF He II, THE TW O FLUID FRACTIONS

Consider a He II bulk at a given T of the composite structure as depicted in Sec. IIC; let the (th super uid (s) or normal uid (n) region in it be denoted by V_{si} or V_{ni} . Then one expects that the s and n component each has its own speci c density, denoted by $_{s}$ and $_{n}$. Incorporating further the factor that the atom s of the normal uid are classical and of the super uid are quantum mechanical, the local density of He II, i.e. the num ber of atom s per unit volume at r is thus

Based on Eqs. (5)–(7) we now determ ine $f_s(T)$ and $f_n(T)$ using only the experimental densities of liquid ${}^{4}\text{H}\,e^{99}$ as input data. Based on the close resemblance of the super uid to a solid in a few important ways, e.g. as is shown by the essentially T independent therm odynamic functions (Sec. IX), we can assume that $_s$ is basically independent of T on the scale of concern, and can then write $_s$ (0), (0) (= 0.1450 g=cm³) being the H e II density at zero K elvin. To obtain the $_n$ of H e II, we next extrapolate $_n(T)$ of the H e I phase region using the therm al expansion function:




FIG.6. (a). The density $_n$ (T) of the norm al uid component of HeII, solid line within T < T , as is extrapolated using the therm al expansion function Eq. (9). The coe cients are determined by a least squares t to the experimental data of $_n$ (T) (circles) 99 between 2.6–4.4 K. (b). The volume fractions f_s (T) and f_n (T) of the super uid and the norm al uid of HeII, dashed curves, as given by Eq. (10), Sec. IV, established based on the composite structure of HeII, namely large separate aggregates of the two uids, and with the experimental density of HeII as input. The number fractions x_s and x_n of the super uid and the norm al uid of HeII, solid lines, obtained from therm odynamic evaluation using Eqs. $(70)-(70)^0$, Sec. IX. The lower and upper limits, solid lines 1 and 2, are obtained using T_o = 2:17 and 3.0 K, and the optimum values, solid lines in the upper graph and solid lines-3 in the lower graph of (b), are obtained using T_o = 2:6 K.

where all densities are in g/cm^3 . The resulting $f_s(T)$ and $f_n(T)$ (dashed lines in FIG.6b) vary rapidly with T from about 50 % to 100 % and conversely between 2.17 -0.6 K, and approach to constant below 0.6 K. In comparison, by Eq. (9) $_n(T)$ and $_s(T)$ vary by less than 4 % across the entire T range of He II. C om bining the above features with (7), we therefore obtain that the T-dependence of (T) throughout the transition in 0.6-2.17 K is principally determined by the variations in $f_s(T)$ and $f_n(T)$ with T. It is further particularly noticeable that at T, $f_s(0.5)$ and $f_n(0.5)$ are not zero and one. The approximations involved would not cause any significant error as has been tested; rather, the non-unity of the fractions at the T is plausibly as a consequence of the second order

phase transition. For, in such a transition a measurable n to s conversion begins to occur at a T, denoted by T_o , well above T; that is, $f_s(T_o) = 0$ and $f_n(T_o) = 1$. The physics involved willbe further clari ed in Sec. X. The $f_s(T)$ and $f_n(T)$ obtained above are in good agreem ent with the therm odynam ic results for $x_s; x_n$ in Sec. IX, the resulting speci c heat and entropy obtained based on which are in good agreem ent with experimental data; and these are consistent with the characteristic variation across the H e II tem peratures exhibited by a variety of properties of H e II, including speci c heat, and second sound.

V. EQUATIONS OF MOTION, THE SOLUTIONS, AND THEIR USE FOR DIRECTLY PREDICTING PROPERTIES OF HE II

A . The equations of m otion via coordinate decom position

The experimental evidence discussed in the preceding sections has pointed to the separate manifestations of the super uid atom ic dynamics with di ering time and energy scales. Namely, a momenton oscillation, being of the scale of 10^3 cycles/sec, is negligibly slower compared to the single atom ic oscillation with respect to , typically of the scale of 10^{11} cycles/sec, so that the former can be regarded as being stationary within the oscillation cycle of the latter. Furthermore, the di usion rate of the helium II atoms, with a di usion constant 10^8 cm²/sec. (cf. Sec. V C), is negligibly slower compared to the single atom oscillation attended neither e ect the momenton oscillation. We now establish the equations of motions accordingly via decomposing the totalm otion in a similar way to the above. First, we may express the absolute position r of an atom with the vector sum

In Secs. V B –V E we set up explicitly for the above equations and solve, and based on the solutions predict a few immediate properties of the system .

B. Cooperative oscillation of single atom s and single phonon excitation

1. Set-up of Eqs. (12a)-(12b)

Consider in the coordinates the super uid atom s are, as discussed in Sec. IIA, localized and each oscillates about its equilibrium site R (X;Y;Z) along a chain of atom s say in the X direction, in a potential well V (X) (FIG. 4a). 


FIG. 7. (a) Theoretical total excitation energy "(K) versus phonon wavevector K of the super-=2 is due to the creation uid of H e II, solid and dashed curves. The excitation at a K $\,<\,$ K $_{\rm b}$ of a single phonon, E (K) (solid curve 1), as predicted from the solution (26a-b) of the equation of motion of the He atom s performing independent harmonic oscillations relative to in the potential wells V (u) shown in FIG.4. The above K region further divides into K < 0:6 A 1 (Eq. 26a) and < 0:6K < K $_{\rm b}$ =2 A 1 (Eq. 26b), where the apparent parameter a = 3:3 A and the elective $a_r = 2:64$ A are, respectively, used as the interatom ic spacing. In the vicinity of $K_{b} = 1.93 \text{ A}^{-1}$, i.e. $K_{b}j < =2$, "(K) (solid curve 2) primarily results from the excitation of a super uid bond, of an activation energy $\$ s, superposed with a sm all single phonon excitation energy: "(K) = $_{s}$ (K) + E(K), where "(K_b) = $_{s}$. Neutron di raction data points at 1.12 $^{\circ}$ K 67 are represented by circles. (b) Potential enenrgy of a super uid atom, V (u), as a function of K , Eq. $(20)^0$ with u = a_r=2, plotted for several a_r values from 2.5 to 3.3 A.Ata xed a_r, V $(\frac{1}{2}a_r)$ has a positive peak in a certain K region which shifts towards the higher K end with decreasing a_r . Only if $a_r = 2.64 \text{ A}$, the K region where $V(\frac{1}{2}a_r) > 0$ (dashed curve) coincides with the K region where E (K) > $_{\rm s}$ (dashed curve, FIG. 7a); this K region is bounded between (0.51, 1.87) A 1 as indicated by the two dotted vertical lines.




FIG.8. Potential energy V (u) versus u a of super uid atom centered at X₁ or X₁₊₁, Eq. (20)⁰ with $a_r = 2.64 \text{ A}$, plotted for several K values as indicated in the inset. For K = 0.51 A⁻¹, from which towards higher K values "(K) > $_{\text{s}}$ (see FIG.7), the potential turns to be repulsive, i.e. V (u) > 0, at the elective border u $\frac{a_r}{2}$ (curve 3). a is the apparent interatom ic distance of H e II as given by the reciprocal of K_b: $a = 2 = K_b = 3.3 \text{ A}$.

Furthermore, the repulsive feature of V (u) with K in (0.51;1:87) A ¹ is also precisely as expected from the excitation scheme derived in Sec. II. The oscillations at the other norm alm odes would cause, with respect to the neutron, a snapshot of som ewhat irregularly displaced "equilibrium sites" of the atom s which will add to their already irregularity due to a short range ordering.

F inally, the character of the localized oscillation of the helium atom s, being clearly distinct from that in solids, has up to now been represented in the form all treatments and are reemphases as follows: it is relative to rather than , it is in cages uctuating in location and dimension, and it is in a shallow potential well which switches to repulsion at larger oscillation amplitudes.

C. Single atom translation and excitation of the super uid bond

1. The sem i-classical representation Eq. (13a), excitation of the super uid bond

Equation (13a) describes, in a super uid equilibrium in the absence of a pressure and composition gradient, the therm all uctuation resultant translation (self-di usion) of the equilibrium position R of a helium atom. This motion can be tracked by solving the simultaneous equations of motion for N atom s with an interatom ic potential V_0 , e.g. num erically with the help of computer. M acroscopically, the motion of, say, N⁰ tagged atoms form a therm all di usion ux of a concentration c(R); the di usion equation e.g. along X axis is

The numerical value of D is obtained using the previous values for a, and ! (= 10 9 1/sec), with $\frac{C}{2}$ 1 and T = 1 K. This D value is as low as that of di usion in a solid, informing that a super uid atom is virtually localized. A coordingly the solutions of (13a) and (13a)⁰, of which c(r) is known to be a G aussian function, are not of interest here. D represents the probability for an helium atom to translate from its bonding state at R to that at a neighboring site at R⁰ (which can statistically also be R), by overcom ing an energy barrier height b + v (FIG. 4a):

The resultant "(K) (solid line-2 in FIG.7a and also FIG.1b) agrees fairly wellw ith the experimental curve, except for its hard turn at K_b as contrasted to the experimental smooth turn. This di emece is as expected, since the theoretical treatment does not include the e ect of the uctuation (resulting from a short range ordering) in the super uid bond length which occurs in the real super uid. Indeed, experimental excitation data at high pressure (25 atm)¹⁰⁰, which causes a "solidi cation" e ect, has shown a sharp turn at K $_{\rm b}$ sim ilar to the theoretical description. (There are also shifts of the dispersion curve to a higher frequency and to a larger period, which can be understood sim ilarly.)

As K departs from $(K_b - \frac{1}{2}; K_b + \frac{1}{2})$ to low er K values, the probability of the $_b$ excitation will drop rapidly, for the liquid density n (r) drops as r departs from R. So that "(K) = E(K), which is the purely phonon excitation energy as of Eqs. (26a)-(26b).

From the super uid bonding character we can infer: 1). The substantial super uid bond, being larger than the van der W aals "bond" of He I (quantitative evaluation given in Sec. IX), in plies a substantial internal viscosity, larger than that of He I. Thus the super uid is not an assembly of non-interacting atom s and hence cannot be of a zero internal viscosity { as portraved in London's BEC and in the uni ed LLBF theory as well. Meanwhile, the "weakly" (or som etim es referred to as "substantially") interacting super uid atom s" and the "zero viscosity" which are simultaneously held in the LLBF theory, are two inevitable selfcontradictory aspects. 2). Now that the viscosity of liquid He I can sustain a non-turbulent m acroscopic rotation (below certain velocity) of HeIwhich is a commonplace experimental observation, the larger internal viscosity of the super uid He II can therefore certainly ensure a (m ore robust) non-turbulent m acroscopic rotation of H e II. The super uid is thus not irrotational. 3). It therefore also follows that for the super uid a zero total circulation, tot = 0, is not a necessary condition for non-turbulence; instead tot is nite and quantized, as has been experimentally demonstrated and to which a consistent theoretical grounding is provided in Sec. VII. 4). A coordingly, no boal vorticity needs be in posed on the super uid, as the Stoke's theorem, ¹⁰³ applying for a viscous-less uid, does not apply to the super uid. 5). It also follows from points 1)-3) that the grounds for proposing the "absence" of internal viscosity as an explanation for the non-dissipative super uidity motion are lacking. (This is in addition to the fact that an internal viscosity does not necessarily im ply which " ow -wall" viscosity, which we are how ever not to expand on here.)

VII. THE QUANTIZATION OF CIRCULATION

Consider a super uid bulk in steady rotational ow motion with a tangential velocity v_s . The trajectory of a ow atom $\langle r \rangle$, Eq. (38), can be now conveniently projected onto the circular coordinate 'along the ow stream line, $\langle \rangle$ being here for simplicity om itted. The atom ic wave, assuming being localized relative to the rotational frame and hence not to swapped o the stream line, in the circular loop, of a circum ference \overline{L} , must satisfy according to quantum mechanics the continuity condition:

A lternative to the above, to exam ine its m icroscopic detail we below look at the process from the standpoint of wave interference. We set determ ine an important parameter, the length of the rotational wave train of a helium atom, and this in theory is $\sin ply$

We can then think of the total atom ic wave train now rotating along ` as the stationary therm all de Broglie wave train of a helium atom as being superposed in the rotational frame onto the purely rotational wave train of length $_{\rm s}$ N. The form er, having a wavelength of typically nano meters, will not contribute to the interference of a macroscopic length period. Consider now only the latter; its N is evidently determ ined by the interaction time, w, taken for creating the purely rotational wave train. That is,

Given m, of the helium atom here, is large compared to that of the usual quantum particles such as the electron, an (arbitrarily) large $_{\rm s}$ (= h=m v_{\rm s}) can be achieved by compensatorily making the ow velocity v_s (arbitrarily) small, thus the T_s and $\rm L$ being accordingly large. In experimentation, for instance, a large T_s value ranging 30 600 seconds, with a $\rm L$ 0.0025 cm were achieved. ¹¹ Furtherm ore, to achieve n = N > 2 or >> 2, the $_{\rm w}$ should > 2T or >> 2T .

The signal of a measurement, if being in proportion to the total amplitude of the atom ic waves, will then inform a circulation quantization.

The physical process described above, which can be term ed the circular atom ic wave self-interference, provides a mechanism for the circulation quantization that has been experimentally demonstrated.^{11{13;31}</sup>

V III. THE DYNAM IC STRUCTURE FACTOR ABOUT $Q_{\rm B}$ AS DUE TO THE SUPERFLU ID BOND EXCITATION




FIG.9. Schem atic diagram of the relationship between neutron wavevectors k_6 and k_6^0 before and after an inelastic scattering, and the momentum loss q_b that is associated with the energy loss s. The B ragg condition is approximately met given that $s << e_6$ (the incident neutron kinetic energy) and k_6^0 k_6 $s=he_6 << k_6$, therefore k_6 k_6^0 . The closed vector-loop ending with q_b^{e1} represents the exact B ragg condition.

(58) is the scattering function due to the super uid bond excitation. Fixing ! ' !s, we expect to see S (q; !) to peak on the q axis; although, there is no experimental data available to us for comparison. Two further remarks can be m ade. First, insofar as the "Bragg" scattering is concerned, it is only meaningful to compare the $S_{b}(q; !) j_{=!s}$ of Eq. (58) with the zero temperature $S^{cry}(q)$ of Eq. (52a) and not with the nite temperature $S^{T}(q) (= {}_{1}^{T} S^{T}(q; !) d!)$ of the super uid; the $S^{cry}(q)$ of a solid at zero K only involves the ! = 0 scattering, whilst the $S^{T}(q)$ of the super uid, viewed in , are localized as in a solid except that they present no long range ordering. As a basic di erence from that of a norm al liquid, on the other hand, the nite peak width in g(r) of the super uid is primarily due to the disordering of the atom ic equilibrium positions but not atom ic di usion.

Through steps (a)-(c), the neutron scattering from the super uid about q_b emerges to be an inelastic dam ped-B ragg scattering due to the excitation of the super uid bond, form ally described by Eq. (58).

IX . THERM ODYNAM ICS OF HE II

A. The partition function of the respective uids

We consider a bulk of super uid He II in them all equilibrium at T, having a volume V and number of atom s N. Employing the canonical ensemble of the independent variables (T;V;N), the total partition function of the uid formally is

The resulting C_V (T) (solid line in FIG.3a) shows a remarkable D ebye T³ behaviour; this has been used as a fed-back information in Sec. IIA. A least squares t to the experimental data between 0 0.6 K using Eq. $(74)^0$ gives $c_1 = 241$ m/sec and $_D = 20$ K. We furtherm one observe that, the D ebye region in the experimental C_V ends at about 0.6 K, which is in rough accordance with the usual T³ law validity criterion,¹¹¹ T $_D = 50'$ 0.4 K. A nom alously, the proleim mediately above 0.6 (1) K results from the second order phase transition and should not be confused with a regular ending of the T³ region. It also is anom alous that, at T (= 2.17 K) far below $_D$ (20 K), the super uid has already transform ed to a norm al liquid.

C. The norm al super uid

For the norm al uid of N identical, distinguishable and weakly interacting classical H e atom s, the Boltzm ann statistical mechanics expressions can be readily written down. The total partition function is

As to T_o , we here only look at its limits. By the free energy function of Sec. X, the onset of n s conversion would not occur until $A_s = A_n$, which begins at T ' 3.0 K (see the context of Eq. 77). On the other hand, T_o would not be lower than T which is 2.17 K from experiment. That is, 2.17 $T_o = 3.0$ K; the evaluation of C_V in Sec. IX D 2 will show, optimally, $T_o = 2.6$ K. W ith $T_o = 2.17$, 2.6 and 3.0 K in equations (70)–(70)⁰, and with the s_n in (2)⁰, we obtain three sets of x_n (T; T_o) and x_s (T; T_o) functions (solid lines in FIG. 6b). $T_o = 2.6$ K yields indeed the optimum fractions (solid lines 3 and 3⁰ in the lower graph) which agree remarkably well with the f_s (T) and f_n (T) (dashed lines) obtained in Sec. 


FIG.10. Theoretical them odynam ic functions of the super uid (s), the norm al uid (n) and their coexistent H e II (w ithout subscript) (solid lines): (a) internal energies U_s , U_n , and U as given by Eqs. (60a,b), $(71)^{(0)}$, (b) entropies S_sT , S_nT , and ST as given by Eqs. (62a,b) and $(73)^{(0)}$, and (c) free energies A_s , A_n , and A as given by Eqs. (61a,b) and $(72)^{(0)}$. C incles in (b) represent experimental calorimetric entropy data ??. Them aximum of A of graph (c) yields the theoretical super uid phase transition temperature $T^{(2)}$. T = 2:17 K is the experimental phase transition temperature at SVP. For the super uid component of H e II, the functions are each given by a canonical ensemble average over the states, with a D ebye type of density of states, of the independent, indistinguishable single phonons, which are produced due to in real space the harm onic oscillations in the norm al coordinates of the (N) independent, localized super uid atom s relative to . For the norm al uid, the functions are each a Boltzm ann statistic mechanics result. The total functions result each as the weighted sum of the respective functions of the super uid and the norm al uid, where the weighting function is given by the probability for the excitation of the super uid bonds.

We rst evaluate C_V . Using in Eq. (74)⁰⁰ the two limiting values 2.17 and 3 K for T_0 as discussed in the beginning of this section and sn of Eq. (2b), we obtain two C_V (T) limits (solid lines -1 and -2 in FIG. 3b), which fall near to, actually enclosing in the middle, the experimental -proble (circles), therefore de ning a region of uncertainty in the theoretical C_V (T). W ithin the limits, we nd at $T_o = 2.6$ K the C_V (T) (solid line -3) optimally matches the experimental C_V data (circles). The remarkably good prediction of C_V and similarly x_s (x_n) earlier both with $T_o = 2.6$ K, although being fortuitous in principle, can however nd the following physical explanation. First, an elective T_o interm ediate between

2.17 and 3.1 K is expected to exist as discussed earlier. Second, it can be shown that the -pro le is primarily sensitive to the exponent, in which, the only other parameter $_{\rm s}$, thus $_{\rm sn}$, is given consistently by various experiments (cf. Sec. II).

N ear T , from F IG .10 we observe that the storder functions of each pure uid component all su er discontinuous changes on transforming from one (normal) component to the other (super uid). However, as the phase transition involves a gradual conversion from one (the normal) component to the other (the super uid), from x_n (T_o) = 1 to x_n (0) = 0, the storder total therm odynam ic functions of the coexistent, H e II, are continuous; this is as expected for the second order phase transition here.

Furtherm one, from FIG.10 the onset of the n-s conversion can clearly be seen to occur near to 3.0 K, where a lower A_n switches to a lower A_s :

It is noteworthy that this T⁽¹⁾, as a direct statistical therm odynam ic result for the two uids of H e II, is basically identical to the T given by London,^{18,34} although London's T was obtained, whilst lacking a direct therm odynam ic scheme, by imposing a limitation in the therm alwavelength obtained for the norm al uid based on Boltzm ann statistical mechanics.

P lacing now in Eq. (78) the experim ental critical density of H e II, $n = \frac{N}{V} = 2.182 = 10^{28}$ atom s/m³, and the values for the other constants as previously specified, we obtain

However, theoretically the initial n-s conversion under the condition (77), onsetting at T⁽¹⁾, does not lead the total free energy A to maximum until T⁽²⁾, as can be seen in FIG.10c (solid curve). It is the A maximum which resembles the critical instability of the system in the second order phase transition, and where a qualitative n s conversion will occur. This critical condition form ally writes:

Here the rst order term of $(A_n A_s)$ represents just the condition (77), and the rst and second derivative terms of $(A_n A_s)$ are additional; (79)⁰ is a complex second order di erential equation of $A_n A_s$. Now instead of seeking an analytical solution of Eq. (79), we can readily graphically locate, as we just actually did, the critical temperature from the A maximum in FIG.10c to be:

C on pared to T $^{(1)}$, T $^{(2)}$ is seen to be lowered in value in closer agreement with the experimental value 2.17 K, although with still a quite large discrepancy. The major error source may be the neglect of a strong atom ic correlation which anticipates to present already in the normal uid in this T range, in presumably a similar way as in its destination state { the super uid; indeed previous studies²⁴ have actually shown that the normal liquid He I deviates from ideal gas when nearing T . Correlation will suppress the A_n value, thereby yield a lowered value for T $^{(2)}$. If assuming across the transition T region A_n is uniform by modiled to A_n^0 and hence A to A^0 and letting the maximum of A^0 yield the experimentally observed T, we mod A_n^0 A_n 0:7 K and $A^0 = A$ 0:7 K (dashed curve in FIG.10).

APPENDIX A: DISTINCTION OF CONDITIONS FOR "FLUIDITY" AND "DIFFUSIVITY".

The preceding discussions in e ect imply that with the super uid He II uidity is not accompanied by any discernible atom ic di usion. In combination with the equations of motions and their solution in Secs. V B and V C, and, based on the well-understood characteristics of the liquid and solid systems, we now elucidate that these two kinds of phenomena do not need co-occur. Fluidity is a phenomenon that any part of the uid can move relative to another, in a exible manner and under a small degree of shear stress. In respect of motion, the realization of a " ow " only requires the collective translation of all of the atom s concerned; there is nothing speci c about whether the individual atom s di use in the same time. In respect of the atom ic interaction, uidity results from the absence of shear elasticity, or, the condition that the shear attraction between the atom s is so weak such that the system is unable to resist any shearing pressure. This character, in the matrix form of the interaction force F below, is represented by that the shear (tangential) attraction force terms { the o diagonal components { are zero (cf. also Eq. (22)):

For the liquid at rest as of (A 1), all the o -diagonal force term s are zero, and the diagonal components $F_x = F_y = F_z$ consist of the tensile attraction force (F^a) and repulsion force (F^r), where = x;y;z; the equality of the diagonal term s represents the isotropy of the liquid. W hen in ow motion as of (A 2), the shear repulsion force term s, i.e. the o -diagonals, are nite and this leads to viscosity. On the other hand, as of Eq. (A 1) or (A 2), for the liquid either at rest or in ow motion, the tensile attraction force term s are nite and this represents that the atom s are attracted to each other (true for all liquids). The above are to be contrasted to the force condition for an elastic solid:

where, the diagonal terms are generally not zero, whence yielding the rigidity. Dision, on the other hand, is produced if the gradients of some of the tensile force terms { the diagonal terms { are nite; e.g. dision in x direction results from $@F_{xx}=@x \notin 0$ which leads to a density ux D $@F_{xx}=@x; cf. Eq. (13b)$. The tensile force term s exist for both solid and liquid, this feature corresponding to the characteristically nite values of the diagonals in all the above matrices. Hence dision can identically occur in both the system s; or, they may identically not occur if the kinetic energy of the atoms. It is true that, in regular uids, a trivial shearing elasticity is often accompanied by a high mobility of the single atoms. This is nevertheless not so in the super uid, where the many quantum atom correlation (Sec. III) produces a contrast in the tensile and shearing interactions, and the signi cantly large tensile attraction prevents the atom s from dission.
