N on-analyticity in the distribution of conductances in quasi one dim ensional wires

A b stract. { We show that the distribution P (g) of conductances g of a quasione dimensional wire has non-analytic behavior in the insulating region, leading to a discontinuous derivative in the distribution near g = 1. We give analytic expressions for the full distribution and extract an approximate scaling behavior valid for dimensional strengths of disorder close to g = 1.

It is wellknown that the probability distribution P (g) of the (dimensionless) conductances g of a disordered conductor is G aussian in the deeply m etallic regime and log-norm al in the deeply insulating regim e [1]. It has been proposed recently [2] that for a quasione dimensional (1D) wire with mean dimensionless conductance g 1, P (g) has a sharp cut-o beyond g = 1. To be sure, in one dimension, when g 1, P (g) drops discontinuously to zero at g = 1. In higher dimensions the discontinuity will be smeared in some way, but it is dicult to say how much of it will survive. U sing the saddle point method developed in [2], we are able to show here that nonanalytic behavior remains near g = 1 at least in quasi-1D system s. One should note that the exact results for the m ean and variance of the conductance, obtained within the non-linear sigm a model β , do not give any clue on the abrupt change of P (g) near g = 1. The existence of the sharp cuto for all q 1 has recently been con rm ed num erically, while the exact shape of the distribution very close to g = 1 seem s to be di erent from a log-norm al distribution [4{8].

In the present work, we focus on the insulating region in quasi 1D near jg 1 j 1, in order to understand better the nature of the unexpected sharp feature in the distribution. For sim plicity, we will restrict our discussions to the unitary case of broken time reversal sym m etry. We propose from a simple generalization of [2] that for large enough disorder the distribution has a non analyticity near g = 1, giving rise to large discontinuities in its derivatives. We obtain e.g. that in the insulating limit, the leading contribution to the distribution P (g) at

jg 1j 1, is given by

where is the error function, $= \cosh^{-1} P_{1=(g-1), 1} = \cosh^{-1} P_{2=g}$, and $= 1 = \cosh^{2} (3=2)$ [9]. The disorder parameter = = L, where is the localization length and L is the system size (1 would correspond to metals and 1 corresponds to insulators). The term C is independent of g, but depends on . The discontinuity is at g = 1 + . For the case considered here, 1 and $e^{-3^{-1}}$. From (1) it follows that $P^{0} = dP$ (g)=dg has a discontinuity at g = 1 + . with $P^{0} = e^{-1}$ very large for g & 1 + . (growing exponentially with increasing disorder) and $p^{0}j = 1$ for g < 1 + . Note that in the limit ! 0, the distribution would have an essential singularity at g = 1.

The above results are obtained assuming 1, describing the insulating limit. As increases, but still in the insulating regime, the dominant contribution remains the same with renorm alized parameters, and our results remain qualitatively valid. In the metallic limit the singularity is absent, giving rise to the possibility that the singularity disappears across the crossover region (1=2), where our current approximations are not valid.

In addition to the sharp structure, our results suggest an approximate scaling behavior for di erent strengths of disorder near g 1. As is evident from (1), in the expression for the ratio P (g)=P (1), the dom_inant dependence on the disorder parameter and on g 1 appears only in the combination (1=2). Our numerical results agree with this approximate scaling. We also not that the distribution P (g) for g . 1 is a slow ly varying function of g, which is approximately constant close to g = 1. This leads to an exponential distribution for P (ln g) in this region, rather than the log-norm aldistribution proposed in [2], and agrees with various existing numerical results [4,6]. For 1, the numerical results suggest that the exponential form crosses over to the log-norm alform for g 1.

We now brie y discuss the details of the m ethod which is based on a simple generalization of [2]. The probability distribution p() of the N variables $_i$, where $_i$ are related to the transm ission eigenvalues T_i of an N-channel quasild wire by $_i = (1 T_i)=T_i$, satisfy the well known DMPK equation [10], whose solutions in the metallic and insulating regimes can be written in the general form [11]

where $Z = {}^{R} Q_{i} d_{i} exp[H]$ is a norm alizing factor independent of i, H() may be interpreted as the Ham iltonian function of N classical charges at positions i, and = 2 for the unitary case. Since the dimensionless conductance is given by

the probability distribution P (g) can be written as

Following [2], we de ne a Free energy"

such that the distribution can be written as

It has been shown in [2] that separating out the low est eigenvalue $_1$ and treating the rest of the eigenvalues as a continuum beginning at $_2$, the distribution can be obtained within a generalized saddle point approximation, given by

The insulating region in this model is given by $x_2 = 1$, and also $x_2 = x_1$, where $\sinh^2 x_1 = \frac{1}{2}$. The saddle point free energy terms in this lim it were calculated to be [12]

Since $1=2 \text{ }\text{F}^{00}$ j is exponentially large in the insulating regime, the saddle point solution is given by putting the coecient of the term in the action S equal to zero, namely $g = F^{0}$, which then gives

As pointed out in [2], the saddlepoint solution is valid only for g < 1 since $\cosh x_1 = 1$, while the g > 1 region is determined by the boundary values of $x_1 = 0$ and $x_2 = 2 = ...$ While this is a good approximation on both sides of g = 1, the fact that the boundary of the saddle point solution is at g = 1 makes it possible that the approximation is not accurate enough very close to g = 1. We will show below that at the next level of approximation suggested in [2], the region close to g = 1 can be better described by saddle point solutions valid on both sides. This is proved approximation is mediately leads to the non-analyticity mentioned before.

It was shown in [13] that while separating out the lowest eigenvalue gave qualitatively good results both in the metallic and insulating regimes, it is important to separate out one

additional eigenvalue to obtain good agreem ent with num erical and available exact results in the insulating and crossover regim as because the separation between the eigenvalues becom as large. The extension is straightforward, and the distribution P (g) now has an additional integral over $_3$, which is the beginning of the continuum that represents the rest of the eigenvalues. It is clear that the insulating limit is characterized by $x_3 = x_2 = 1$ for typical values of x_1 , and that F⁰ in this limit will now be given by [13]

 F^{00} now has the same expression as (12), with x_2 replaced by x_3 , while F^{0} is given by (10) with x_1 ; x_2 replaced by x_2 ; x_3 plus additional term s involving x_1

The saddle point solutions for x_3 and x_2 are now given by $x_{\rm 3sp}$ = 3=2 , which is independent of g and

obtained again from $g = F^0$. Since $x_2 = 1$, the additional term in F^0 is exponentially small, and usually negligible. However, close to g = 1, this is the term that allows the saddle point solution to be valid on both sides of g = 1. The uctuation correction to the x_2 integral contributes an additional factor $e^{2x_{2sp}}$, and we are left with the nalintegral

We have used nite limits in the integral because the saddle point solution of x_2 must be real and also we require that $x_{3sp} > x_{2sp}$. This gives $x_{1m in} = \text{Re}[\cosh^{-1}P_{-1}] = (g_{-1})$], = $1 = \cosh^2(3=2)$, and $x_{1m ax} = \cosh^{-1}P_{-2}$. The crucial point is that the restriction $x_{1m in}$ is zero for all $g_{-1} + g_{-1}$, but becomes nite for $g < 1 + g_{-1}$, with a discontinuous slope. It is the universal nature of this constraint which will eventually lead to the sharp changes in P (g) at $g = 1 + g_{-1}$.

In the lim it g ! 1 and 1, the upper lim it of the integral $x_{1m ax}$ 1. We can therefore neglect the x_1^2 term in (17). Changing variables to x_2 and rew riting $\ln x_1$, we obtain a simple integral Z




Fig.1 { P(g)=P(1) from Eq. (1) for dierent values of .

with 1 as de ned after (1), and $x_{2m ax} = \text{ for } g > 1 + \text{, but } 3=2 \text{ for } g < 1 + \text{. The integral immediately leads to Eq. (1). It is easy to see from (1) that the rst derivative has a discontinuity at g = 1 + and is large, of order e²⁼ for g > 1 + . Figure 1 shows the sharp changes at g = 1 + according to Eq. (1). Since 1 in this region is only weakly dependent on g, this also leads to an approximate scaling behavior of P (g) as a function of z = (1=2).$

W hile the g-dependent contribution comes from the x_2 integral where $x_{2sp} < x_{3sp}$, there is a contribution to P (g) from integral over $x_2 > x_{3sp}$. The x_3 integral in this case is given by the boundary value at $x_3 = x_2$, and the uctuation correction to the x_2 integral becomes of order unity. The resulting integral leads to a g independent but dependent term giving C $e^{3} = [1 \quad (2 = 5)]$.

In the above, we considered the case 1, where $x_3 x_2$ 1 and only the leading order term swere kept in the free energy. For weaker disorder but still in the insulating side, the next leading order term swill become important. First of all, the ln x_2 term arising from $F^0(x_2;x_3)$ in (15) will start to contribute. Second, the next leading order contributions to F^0 will contribute som em ore x_2 and ln x_2 term s. In general, as long as the lim it $x_3 x_2$ 1 rem ains valid, and the perturbative expansion of the free energy remains a good approximation, the integral (18) can be generalized to be of the form

where a, b and p are parameters which in principle can be calculated within our fram ework by keeping higher order terms in the free energy. For p = 0 we get back (1) with renormalized parameters. For nite integer p the integral can again be evaluated simply in terms of the error function. For non-integer values of p, the integral is m ore complicated but it is clear that the qualitative features of the results will remain the same. We expect that our results will remain qualitatively valid near the crossover region on the insulating side (. 1=2).




Fig. 2 { Numerical data for N = 5 with dimensionder compared with theoretical predictions using (19). Data for g 0.3 were t (solid line) with $_{e} = a = 0.292$ and b = 2;g 0.4 were t (dot-dashed line) with $_{e} = 0.346$ and b = 1.8;g 0.5 were t (long dashed line) with $_{e} = 0.391$ and b = 1.6. In all plots, p = 2.

In order to check som e of our approxim at eexpressions, we have calculated P (g) num erically for a quasi 1D wire. Recent techniques [4] allow us to obtain reasonable statistics for N = 5. Unfortunately, it was not possible to obtain enough data for either 1 or 1 < g < 1:01.Nevertheless, (19) should be approximately valid in the region numerically accessible to us and the data can be used to check if the approximate scaling expected from (19) holds qualitatively. In Fig. 2, circles and squares show the num erical results for di erent values of average conductance g. W e use p = 2, e = a and b as thing parameters to t the data for di erent g using (19) (for our range of param eters, the constant C of (1) turns out to be negligible). A greem ent with the data is good for g $1_{\rm p}$ < 0:15. In Fig. 3 the same data are plotted as a function of the scaling variable $s = \exp[$ $_{\rm e}$ (b=2 $_{\rm e}$] shifted by s(1 +), taking into account the fact that the singularities occur at g = 1 + (e). Again the scaling is quite good. We have checked that the scaling fails for larger values of e, which is expected because it is close to the crossover regin e (1=2) where our perturbative expansion of the free energy starts to becom e invalid.

A non-analyticity in P (g) was obtained in [4] within R andom M atrix Theory (RM T), based

on the assumption that contributions from only the smallest two eigenvalues are important in the insulating regime. All derivatives of P (g) in such a model diverge at g = 1. However, a two-eigenvalue calculation within DMPK (obtained by neglecting the continuum in our model) gives rise to an essential singularity at g = 1, so that there is no discontinuity in the derivatives at that point. Therefore, it is not simple to see if the trivial discontinuity in the derivative mentioned in the introduction will persist beyond 1D. We emphasize that our present results for quasi 1D are fundamentally di erent from both of the above models: whereas all derivatives of P (g) diverge for the RMT model and vanish for the two-eigenvalue DMPK model, they are nite for our quasi 1D system. Also, in contrast to the above cases, the singularity for the quasi 1D system is not exactly at g = 1, but is shifted as a function of disorder. Finally, the RMT results do not satisfy the approximate scaling of Fig.3.

We note that there is no phase transition in quasi 1D. It is therefore important to ask if a non-analyticity in P (g) in the absence of a true phase transition violates any fundamental principle. Our framework can be considered as an electrostatic problem in one dimension involving charges with repulsive interactions and con nement potentials. Our free energy and the density of charges are all analytic, ensuring that e.g. the total energy will be an analytic function of disorder. However, the conductance is a complicated function of the charge distribution, and the non-analyticity appears only in the distribution of the conductances where the charges have to satisfy certain constraints. There is no restriction on the analyticity of such a distribution.

In sum m ary, we have shown that the distribution of conductances in quasi 1D systems in the insulating regime has a non-analytic behavior near g = 1. The non-analyticity gives rise to very sharp structures close to g = 1, with nite discontinuities in its derivatives. The presence of similar structures in higher dimensions in numerically studied systems [6{8] gives rise to the possibility that such non-analyticity might be present in the conductance distribution in higher dimensions as well, having important consequences for the Anderson transition. W hether the non-analyticity discussed here disappears abruptly at some critical value of , or sm oothly, as is increased beyond 1/2 remains to be claried. It is conceivable that an



abrupt disappearance of the non-analyticity is a signature of the Anderson transition.
