The m id-infrared AC Halle ect in optimally-doped $B_{i_2}Sr_2CaCu_2O_{8+}$

A novel heterodyne polarom etry system determ ines the frequency dependence from 900 to 1100 cm 1 and tem perature dependence from 35 to 330 K of the H all transport in single crystal, optim ally doped $B_{12}Sr_2CaCu_2O_{8+}$. The results show a signi cant disconnect from the behavior of the H all angle in the existing data for YBCO in the far-infrared, which indicate a negative value for the real part of the H all angle above 250 cm⁻¹, whereas that of the current work at 1000 cm⁻¹ is positive. The current work when analyzed using an extended D rude form alism results in a H all m ass com parable to the ARPES Ferm im ass and a scattering rate com parable to the low frequency conductivity and H alle ect scattering rates, which, how ever, are only 1/4 of the m inimum ARPES values.

W hile the DC and infrared conductivities reveal the overall response of a system to an electric eld, the H all e ect reveals the sign of the carriers as well as some inform ation as to the path taken by them. It essentially probes the ability of the carriers to veer or bend their course. Quantities frequently used to represent the e ect are the H all angle $_{\rm H}$ or the longitudinal and transverse conductivities $_{\rm XX}$ and $_{\rm XY}$ with

$$\tan_{\rm H} = \frac{xy}{xx} \tag{1}$$

These quantites become complex response functions for AC elds. The collection of existing measurements of the DC and AC Halle ect in high temperature superconductors has revealed a most curious behavior, whose description de es all current models, while, how ever, apparently falling short of suggesting a com prehensive theortical approach on its own. Some of the di culty of identifying patterns which can be simply expressed by m eans of som e phenm enology arises from the fact that one is hesitant to make direct comparisons between the the existing AC Hall measurements conducted on epitaxial lm s of YBCO with thoses of results of ARPES and STM on single crystalBSCCO.The YBCO Im s are twinned on a micron scale and the conductivity is further complicated by the existance of CuO_2 chains. The m id-infrared Hallm easurm ents reported here are the st on BSCCO single crystal and should cover some of the distance in rem edying this predicam ent.

To appreciate the present state of the search for patterns and phenom enology consider the rst of the earlier work [1, 2, 3], which to an extent indicated that $\cot_{\rm H}$ followed squared tem perature behavior:

$$\cot_{\rm H} = A + B T^2 \tag{2}$$

with A proportional to Zn doping. The T^n behavior, for n=2, supported two models such as those asso-

ciated with spin-charge separation in the cuprates [4]. However, later system atic studies of both single layer $B_{i_2}Sr_{1:6}La_{0:4}CuO_y$ and bilayer $B_{i_2}Sr_2CaCu_y$ [5] have revealed that n = 1.78 for optim al doping and n clearly depends on oxygen doping, approaching n = 2 only in the underdoped regime. The far-infrared extension of the Halle ect explored in YBCO [6, 7] suggests a di erent phenom enology involving a squared Lorentzian with a scattering rate linearly proportional to tem perature [8]. A theoretical justic cation for this response has been obtained by Varma and Abraham s in terms of marginal Ferm i liquid model in the form [9]:

$$\tan_{\rm H} = \frac{!_{\rm H}}{_{\rm H}} + \frac{!_{\rm H}}{_{\rm H}^2}$$

is related to Ferm i surface averages of derivawhere tives of the elastic scatteering and $_{\rm H}$ is the inelastic relaxation rate proportional to tem perature and which is replaced with $_{\rm H}$ i! for ac. In the dc lim it this form accomm odates the revised exponent of 1.78 and the Zn doping. This far-infrared behavior contrasts sharply with that suggested by the mid-infrared data for YBCO [10] obtained using the spectral lines of a CO_2 laser. W hen the cotangent of the Hallangle is tted to a D rude m odel the resulting Hallm ass and the Hall scattering rate, to within the accuracy of the data, display no frequency dependence within the range from 949 to 1079 cm¹. How – ever, the Hall frequency displays a slight decrease with increasing tem perature, whereas the H all scattering rate increases linearly with tem perature from near zero at T $_{\rm c}$ to over 300 cm 1 at 250 K. However, the chain contributions to the conductivity for these twinned samples, grown by pulsed laser deposition, introduces considerable uncertainty in these results for the scattering rates and Hallm ass.

In developing an understanding of transport in the cuprates the relation between the transport properties and the Angle-Resolved Photoem ission Spectra (ARPES) will be important. In the past several years ARPES has mapped the Ferm i surface and identi ed the d-wave symmetry of the order parameter. Using $k_{\rm F}$ = 0:446A 1 and $v_{\rm F}$ = 1:8eVA [11, 12] the ARPES Ferm i surface mass is

$$m_{\rm F} = \frac{hk_{\rm H}}{v_{\rm F}} = hk_{\rm H} - \frac{1}{h@k} \frac{0}{2} \left(\frac{1}{2}\right)^{-1}$$

where $k_F = 0.69A$ is the Ferm i wavenum ber for the holelike surface. The quasiparticle relaxation rate is related to the width of the ARPES spectral density function at the Ferm i energy. W ithin many body perturbation theory the low frequency current relaxtion rate is given directly by the EDC line widths or from the MDC line widths, k, as $_F V_F k$, where v_F is the measured Ferm i velocity. The existing ARPES data on BSCCO

nds that / T.However, the minimum values for deduced from ARPES corresponding to the (;) or nodal direction on the Ferm i surface are four times larger than the measured IR relaxation rates. It is not yet known whether this discrepancy can be reconciled in terms of small angle scattering issues or Ferm i liquid e ects or if it requires a more exotic interpretation.

A dditionally ARPES m easurem ents have revealed that there is a kink in the quasiparticle dispersion curve, which for $B_{12}Sr_2CaCu_2O_{8+}$ occurs at about 50 15 m eV [13]. The change in slope results in a reduction in velocity of around a factor of two above the kink. Z.X. Shen et al. [14] also report this kink occurring in LSCO at around 70 m eV. The interpretation of this feature is controversial and includes electron-phonon interaction, the opening of a 50 m eV superconducting gap, a spin excitation, or som e type of interaction with the theorized stripe phase.

The experim ental system of the current work m easures the very sm all complex Faraday angle imparted to CO_2 laser radiation traveling perpendicular to and transm itted by the sample imm ersed in a perpendicular magnetic

eld. The system is the same as that used by in the earlier YBCO study [10] with the addition of an inline calibration system and a continuous stress-free temperature scan provision, and further modi ed to place a diffraction-limited spot on the sample with post-sample spatial litering [15].

The sam ple of the current work was cleaved or rather, peeled from a single bulk crystal of $B_{12}Sr_2CaCu_2O_{8+}$ grown by the oating zone method and then placed in therm al contact with a wedged BaF_2 crystal. Measurement of the AC magnetic susceptance of this mounted peeled segment revealed a T_c of 92 K with a width of less than 1K. This measurement, performed after all of the H allmeasurements had been completed, establish the integrity of the sample and recommend the H all data as representative of optim ally doped BSCCO. Infrared conductivity data from measurements performed on bulk




FIG.1: The realand imaginary parts of $\frac{1}{H^1}$ for 2212 BSCCO versus tem perature. The inset displays $\frac{1}{H^1}$ at 300K and versus wavenum ber.

crystals from the same batch supplied the real and in aginary parts of $_{xx}$ required to obtain the Hall angle from the Faraday angle data. The calculation of $_{xy}$ considered the multilayer rejection elects within the BSCCO Im [15].

To form $_{\rm H}$ one divides $_{\rm xy}$ by $_{\rm xx}$ corresponding to the same temperature and frequency. Since we wish to exam ine that part of the H all angle related to the free carriers it is necessary to remove the contributions to $_{\rm xx}$ coming from interband transitions which occur above 1 volt. These transitions contribute essentially nothing to $_{\rm xy}$ at the frequencies of these experiments. Therefore, before taking the ratio, we removed their contribution to the in aginary part of $_{\rm xx}$ using the value in nity = 4.6 from Quijada [16]. This increases Re(H) by about 5% and reduces Im (H) by about 5%.

Figure 1 displays the resulting values of $_{\rm H}^{-1}$. The most striking feature of the mid-infrared Hall angle response is its strong tem perature dependence in com parison with the temperature dependence of $_{\rm xx}$ at these frequencies [17]. The observed response is not consistent with the Lorentzian squared form found in YBCO at far-infrated frequencies which, in particular, implies a positive Re(H) at these frequencies. Indeed the response in them id-infrared is found to be close to that of a Drudemodel H = H = (1). The Re (H^{1}) in Fig.1 is nearly frequency independent but strongly tem perature dependent. The Im $\left(\begin{array}{c} 1 \\ H \end{array} \right)$ is only weakly tem perature dependent and has a power law frequency dependence at 300 K but is of som ew hat low er degree than the linear dependence ! expected for a D rude m odel. This suggests that by 1000 cm⁻¹ the system is approaching but has not yet reached the high frequency asym ptotic D rude form. The condition for achieving this asymptotic form are that the frequency must be higher than all the charac-




FIG.2: Im ($_{xx}$)=Re($_{xx}$) vs. frequency for single crystal 2212 BSCCO at di erent tem peratures.

teristic frequencies of the system , including the quasiparticle relaxation rate. W hile 100 m eV is higher than the superconducting gap, the phonon energies and the neutron m agnetic resonance it is still below the estimated antiferrom agnetic coupling energy J 200m eV for the cuprates. Indeed the longitudinal conductivity has not achieved the widely reported asymptotic behavior as can be seen in Fig. 2, where by 1000 cm⁻¹ Im ()=Re() has become nearly frequency independent in contrast to the linear frequency dependence for a D rude response.




FIG. 3: The real and imaginary parts of $_{\rm H}$ =T esla versus temperature for 2212 BSCCO. Them id-infrared data is shown in the inset with expanded axes. The brown points in the inset correspond to 300 K. The other colors of the points at 950 cm⁻¹ within the inset correspond to the same temperatures as in the main plot.

Figure 3 com pares the realpart of the Hallangle with that from the far-infrared data [7]. We observe a disconnect between the behavior of the far- and m id-infrared Hallangle. Starting at about 230 cm 1 the real part of the Hallangle for low tem peratures appears to be negative. However, as noted above it is positive at all tem peratures above T $_{\rm c}\,$ in the m id-infrared. The thin lines are ts of the full complex far-infrared Hall angle data to squared Lorentzians. However, the extension of the real part into the mid-infrared remains negative unlike the data which are positive. There are num erous ways to accomm odate this plunge in the real part of the Hall angle at 300 cm 1 and to join these results with those of the mid-infrared of the current work. All would require at least one minimum and at least one maximum between 300 and 1000 cm⁻¹ suggesting a resonance in this frequency interval. No such feature is seen in the data for $_{xx}$ [17]. However, a peak is present at 300 cm 1 in the phase of xx in the plot of Im (xx) = Re(xx) at 100 K shown in Fig. 2. It is interesting to note that this feature in the phase is not predicted by most models that have been proposed for the conductivity in the cuprates, for example, the coldspot m odel [18]. Further, its frequency roughly corresponds to num erous other phenom ena including the 41 m eV spin resonance, the 50 15 m eV phonon interaction [13], the superconducting gap, and the quasiparticle band width of the three band Hubbard m odel.




FIG. 4: The mid-infrared Hall mass (thin line) and the ARPES Ferm i surface mass (thick line) both versus temperature. The mid-infrared Hall mass is also shown in the inset versus frequency.




FIG.5: The scattering rates from di erent measurements compared. The thick black line demonstrates the temperature dependence of the Hall scattering rate in the mid-infrared region. The mid-infrared Hall scattering rate is also shown in the inset versus frequency.

In view of the near D rude behavior of the m id-IR Hall data we have used the D rude m odel to extract the param eters of the model $!_{H}$ and $_{H}$ and to exam ine their frequency and tem perature dependence. W e express ! H in term softhe Hallm ass de ned $asm_{H} = eB = !_{H}c$. The data are shown in Figs. 4 and 5. The Hallmass is seen to be in rem arkably good agreem ent, especially at T_c, with the hole e ective mass at the Ferm i level deduced from ARPES measurements. The inset data in Fig. 4 indicates a decreasing m ass with frequency in accord with the general expectation that it approach the band value estimated at about half the value at E_F . The data also indicate an increasing mass with temperature, which is quite counter to the expectations for strongly interacting system s. However, we note that $_{\rm H}$ and the carrier relaxation rate in general is an increasing function of T achieving its sm allest value at T_c. As the Hall angle (or inverse Hallangle) can be expanded asym ptotically as a series in z = n = ! (where n are various averages of the scattering rates) the asym ptotic behavior is most closely achieved at the low est tem peratures where z is sm all. Indeed it is seen that m_{H} is in excellent agreement with ARPES at low T and deviates as T is increased.

Figure 4 displays a H all m ass, which is roughly twice the value of the longitudinal m ass calculated from $_{\rm XX}$ in the m id-infrared. The frequency dependences for the H all m ass and longitudinal m ass are sim ilar displaying a slow decrease with increasing frequency. However, the tem perature dependences of the m asses are opposite each other with the H all m ass actually increasing about 20% over the tem perature range of 100 to 300K . Finally, the sam e A R P E S m easurem ents which im ply a very di erent scattering rate nd a full dressed m ass at the Ferm i level which is nearly equal to the m easured m id-infrared H all m ass.

The linear tem perature dependence of the Hall scattering rate in the mid-infrared also disagrees with the ARPES results for Im [12], which imply a decreasing tem perature dependence with increasing frequency as is also seen in xx. Also marginal Fermi liquid theory, which posits a linear tem perature dependence of the scattering is at odds with the lack of frequency dependence. Any signi cant frequency dependence would cause a signi cant positive intercept in the zero tem perature projection of the norm al state scattering rate in Fig. 5. The lack of frequency dependence of the scattering rate of the current work on the other hand contravenes both Ferm i liquid and marginal Ferm i liquid theories, which claim a strong frequency dependence for the scattering rate at tem peratures low com pared to the photon energies of the experiment. We nd little or no frequency dependence of the scattering rate at ! = 1000125m eV. The farinfrared scattering rate when compared to that of the m id-infrared exhibits the same linear increase with tem perature. However, the projection of the norm al state m id-infrared scattering rate to zero tem perature is negative. This feature was also observed for YBCO [10].

Figure 5 also shows the relaxation rates deduced from m easured quantities from the mid-IR Hall data and a number of other experiments. These include IR conductivity for BSCCO [17] determined from the slope in Fig. 2 extrapolated to zero frequency :

A lso included are: the relaxation rate deduced from $_{xx}$ for YBCO extrapolated to zero frequency designated \Q uijada " [16]; the Hall relaxation rates designated \G rayson $_{\rm H}^2$ " and \G rayson $_{xy}$ " both for YBCO in the far-infrared, the rst using using the squared Lorentzian analysis and the second using a sim ple D rude applied to

 $_{\rm Xy}$ [7]; the terahertz relaxation rate designated \C orson " [19] deduced from for BSCCO at 0.2–1.0 THz; the H all relaxation rate for YBCO designated \R igal $_{\rm H}$ " deduced from $_{\rm H}$ [20]; and the ARPES zero frequency value for for BSCCO designated \Valla " [11]. Except for the ARPES result, the di erent relaxation rates are in rem arkable agreem ent with each other, especially at low T. How ever, they are all signi cantly sm aller than the hole scattering rates at ${\rm E_F}$ deduced from ARPES in the (;) direction where the linew idths take on their m inimum values.

These results suggest a universal linear T relaxation rate in the hole doped cuprates. More remarkably they also suggest that the transport relaxation rate is temperature dependent but not frequency dependent. In this case the apparent frequency dependence of the infrared relaxation rate deduced from may not represent an inelastic scattering e ect but drives instead from some other mechanism such as that suggested by Io e and M illis. Therefore these results suggest that current relaxation in the optim ally doped cuprates is quasi-elastic.
