# Competition between adaptive agents: from learning to collective e ciency and back

ABSTRACT We use the M inority G am e and some of its variants to show how e ciency depends on learning in m odels of agents competing for limited resources. Exact results from statistical physics give a clear understanding of the phenom enology, and opens the way to the study of reverse problem s.W hat agents can optim ize and how well is discussed in details.

Designed a simpli cation of Arthur's ElFarolbar problem [], the M inority G ame [2, 3] provides a natural fram ework for studying how sel sh adaptive agents can cope with competition. The major contribution of the M inority G ame is not only to sym metrize the problem, which physicists like very much, but also to introduce a wellparametrized set of strategies, and m ore generally to provide a well de ned and workable family of models.

In this game, N agents have to choose one between two choices at each time step; those who are in the m inority w in, the other lose. Obviously, it is easier to lose than to w in, as the number of w inners cannot exceed that of the losers. If the game is played once, only a random choice is reasonable, according to G am e Theory [4]. When the game is repeated, it is sensible to suppose that agents will try to learn from the past in order to outperform the other agents, hence, the question of learning arises, as the m inority m echanism entails a never-ending competition.

Let me is introduce the game and the needed form alism. There are N agents, agent itaking action  $a_i 2 = f = 1; + 1g$ . A game master aggregates the individual actions into  $A = \prod_{i=1}^{P_{A}} a_i$  and gives private payoes ag(A) to each agent i = 1;; N. The minority structure of the game is mplies that g must be an odd function of A. The simplest choice for g may seem to be g(A) = sgn(A), but a linear function is better suited to mathematical analysis. The MpG is a negative sum game, as the total payoe given to the agents, is  $\prod_{i=1}^{N} a_i g(A) = g(A)A < 0$ , since g is an odd function. In particular, the linear payoe function gives a total loss of  $A^2$ ; when the game is repeated, the average total loss is nothing else than the uctuations of

the attendance  $^{2} = hA^{2}iw$  here the average is over time.

From the point of view of the agents, it is a measure of payo wastage. That is why many papers on the MG consider it as the global utility of the system (world utility hereafter), and try, of course to minimize it (forward problem). I shall review the quest for small <sup>2</sup>, focusing on exact results, and show that all proposed mechanisms lead essentially to the same results.<sup>1</sup> A particular emphasis will be put on inductive behavior, as it gives rise to particularly rich phenomenology while being well understood. Finally, the reverse problem is addressed, by deriving what private payo function g to use given a world utility W to minimize.

# 1 No public information

### 1.1 \If it ain't broke, don't x it"

The arguably simplest behavior is the following [B]: if agent i wins at time t, she sticks to her choice  $a_i$  (t) until she looses, when she takes the opposite choice with probability p. The dynamics is M arkovian, thus can be solved exactly [B]. When N is large, the uctuations <sup>2</sup> are of order (pN)<sup>2</sup>: indeed, as the num ber of losers is N, the average num ber of agents changing their m inds at time t is pN. Therefore, one can distinguish three regimes

pN = x = cst; this leads to small uctuations<sup>2</sup> = 1 + 4x (1 + x=3), which tend to the absolute minimum <sup>2</sup> = 1 when x ! 0, The time needed to reach the stationary state is typically of order N.

p = 1 = N; this yields <sup>2</sup> N, which is the order of m agnitude of produced by agents m aking independent choices.

pN 1. In this case, a nite fraction of agents change their m ind at each time step and  $^2 = N (N p^2 + 4 (1 p)) = (2 p^2) N^2$ .

The major problem here is that p needs to be tuned in order to reach high e ciency. But it is very easy to design a feedback from the uctuations on p [9], that lowers p as long as the uctuations are too high, and to use the above results in order to relate the uctuations to p(t ! 1). M athem atically, this amounts to take p(t = 0) = 1, dp=dt = f(p; N; t). For instance, f(t) = t seems appropriate as long as is small enough. Note that p(t) ! 0 as t ! 1, in words, the system eventually freezes. From the optimization point of view, this is a welcom e, but as for agents, com plete freezing, although being a N ash equilibrium [4], is not satisfactory. as it may be better for an agent sitting on the losing side to provoke an gam e-quake

and to pro t from a re-arrangement of the winners/losers. Therefore, an unanswered question is where to stop the time evolution of p.

N evertheless, this sim ple exam ple illustrates well what happens in M G s: the e ciency essentially depends on the opinion switching rate, which itself depends on the learning rate. It has to be small in order to reach good level of e ciency.

# 1.2 Inductive behavior

Inductive behavior can remedy the problem softhe previous learning scheme if, as we shall see, agents know the nature of the gam e that they are playing. This subsection is a simpli ed version of the simplest setting for inductive agents of ref. [10]. At time t, each agent i= 1; ;N plays + 1 with probability i(t), and  $1 \text{ with probability } 1 \quad i(t)$ . Learning consists in changing ; given the outcom e of the gam e at time t. For this purpose, each agent i has a num erical register  $_{i}$  (t) which rejects her perception at time t of the relative success of action + 1 versus action 1. In other words,  $_{i}(t) > 0$ m eans that she believes that action + 1 has been m ore successful than 1. The idea is the following: if agent i observes A (t) < 0 she will increase iand hence her probability of playing  $a_i = +1$  at the next time step. Reinforcem enthere means that i is an increasing function of i. For reasons that will become obvious later, it is advisable to take  $i = (1 + m_i) = 2$  and  $m_i = (i)=2$ , where is an increasing function and (1) = 1. The way in which  $_{i}$  (t) is updated is the last and most crucial element of the learning dynamics to be speci ed:

The term above describe the fact that agent i m ay account for her own contribution to A (t). When = 0, she believes that A (t) is an external process on which she has no in uence, or does not know what kind of game she is playing. She may be called naive with this respect. For = 1, agent i considers only the behavior of other agents A <sub>i</sub> (t) = A (t) <sub>a</sub> (t) and does not react to her own action  $a_i$  (t). A s we shall see, this subtlety is the key to high e ciency. The private utility of sophisticated agents correspondsmore or less to what is called A ristocrat U tility (AU) in CO IN 's nom enclature [11].

#### N aive agents = 0

It is possible to show that agents m in in ize the predictability  $H = hA i^2 \cdot A s$ a consequence H vanishes in the t! 1 lim it. There are of course m any states with H = 0 and the dynam ics selects that which is the \closest" to the initial condition. To be m one precise, let i(0) be the initial condition (which encodes the a priori beliefs of agent i on which action is the best one).Ast! 1,  $hAi_t = P_im_i(t)! 0$  and i converges to

The condition  $hAi_1 = 0$  provides an equation for A

By the monotonicity property of  $% \mathcal{A}$  , this equation has one and only one solution.

The asymptotic state of this dynamics is information (e cient (H = 0), but it is not optimal, as, in general, this state is not a N ash equilibrium . The

uctuations are indeed determ ined by the behavior of (x). This is best seen with a particular example: assume that the agents behave according to a Logit m odel of discrete choice [12] where the probability of choice a is proportional to the exponential of the \score"  $U_a$  of that choice: (a) /  $e^{U_a=2}$ . With only two choices a = 1, (a) = (1+am)=2 and =  $U_t$  U, we obtain <sup>2</sup>

Here is the learning rate, which measures the scale of the reaction in agent's behavior (i.e. in m<sub>i</sub>) to a change in  $_{i}$  [14]. We also assume that agents have no prior beliefs:  $_{i}(0) = 0$ . Hence  $_{i}(t) \quad y(t) = is$  the same for all agents. From the results discussed above, we expect, in this case the system to converge to the symmetric N ash equilibrium m<sub>i</sub> = 0 for all i. This is not going to be true if agents are too reactive, i.e. if  $> _{c}$ . Indeed,  $y(t) = _{i}(t)$  satis es the equation

where the approximation in the last equation relies on the law of large numbers for N 1.Eq. (5) is a dynamical system. The point  $y^0 = 0$  is stationary, but it is easy to see that it is only stable for  $< _c = 2.$  For




FIGURE 1.G raphical iteration of the map y (t) for  $= 1.8 < _{c}$  and  $= 2.5 > _{c}$

> 2, a cycle of period 2 arises, as shown in Fig.1. This has dram atic e ects on the optim ality of the system. Indeed, let y be the two values taken by y(t) in this cycle<sup>3</sup>. Since y(t + 1) = y(t) = y we still have hAi = 0 and hence H = 0.0 n the other hand  $^2 = N^2 y^2$  is of order N<sup>2</sup>, which is even worse than the symmetric N ash equilibrium  $_i = 1=2$  for all i, where  $^2 = N$ .

Hence, one nds again a transition from  $^2$  / N to  $^2$  / N  $^2$  when the learning rate is too large.

# Sophisticated agents > 0

It is easy to check that with > 0, following the same steps as in the previous section, the learning dynamics of agents m inim ize the function

Since H is a harm onic function, H attains its minim a on the boundary of the domain  $[1;1]^N$ . In other words,  $m_i = 1$  for all i which means that agents play pure strategies  $a_i = m_i$ . The stable states are optimal N ash equilibria for N even. By playing pure strategies agentsminimize the second term of H . O fall corner states where  $m_i^2 = 1$  for all i, agents select those with Ai = 0 by dividing into two equal groups playing opposite actions. All these states have minimal \energy" H = N . Which of these states is selected depends on the initial conditions i(0), but this has no in uence on the outcom e, since Ai = 0.

Note that the set of stable states is disconnected. Each state has its basin of attraction in the space of  $_{i}(0)$ . The stable state changes discontinuously as  $_{i}(0)$  is varied. This contrasts with the case = 0 where Eq.  $\beta$ ) in plies that the stationary state changes continuously with  $_{i}(0)$  and the set of stationary states is connected.

For N odd, sim ilar conclusions can be found. This can be understood by adding a further agent to a state with N 1 (even) agents in a N ash equilibrium. Then H = (1 ) $m_N^2$ , so for < 1 the new agent will play a mixed strategy m<sub>1</sub> = 0, whereas for > 1 it will play a pure strategy. In both cases other agents have no incentive to change their position. In this case we nd <sup>2</sup> 1.

It is remarkable how the addition of the parameter radically changes the nature of the stationary state. Most strikingly, uctuations are reduced by a factor N .From a design point of view, this means that one has either to give a personalized feedback to autonom ous agents, or to make them more sophisticated, for instance because they need to know the functional form of the payo  $\cdot$ 

# 2 Public information

As each agent has an in uence on the outcom e of the game, the behavior of particular agent m ay introduce patterns that the other agents will try to exploit. For instance, if only one agent begins to think that the outcom e of next game depends on some external state, such as the present weather of 0 xford, and behave accordingly, then indeed, the outcom e will depend on it.<sup>4</sup> But this means that other agents can exploit this new pattern by behaving conditionally on the same state. O ne exam ple of public inform ation state family that agents m ay consider as relevant is the past w inning choices, for instance a window of size M of past outcom es [2]. Each such state can be represented by a bit-string of size M , hence there are 2<sup>M</sup> possible states of the world. This kind of state has a dynam ics of its ow n: it di uses on a so called D e Bruijn G raph [5]. Another state dynam ics consists sim ply in drawing at random the state at time t from some ensem – ble [16] of size P (e.g. P = 2<sup>M</sup>). All exact results below are obtained with this setup.

# 2.1 NeuralNetworks

Two types of neural networks have been studied in the context of the MG [17, 18, 19]. Beyond the mere academ ic question of how well or badly they can perform, it is worth noting that these papers were interested for the rst time in interacting neural networks.

Refs [17, 18] introduced simple perceptrons playing the m inority game. Each perceptron i = 1; ;N is made up of M weights w( $w_1^1$ ;  $M_1^M$ ; w which are drawn at random before the game begins. The decision of network

i is  $a_i = sgn (w \approx)$ , where ~ is the vector containing the M last m inority signs. The payo was chosen to be asgn (A). Neural networks are trained following the usual Hebbian rule, that is,

Under som e sim plifying assumptions, it is possible to nd that the uctuations are given by [17, 18]

where  $K = \frac{2}{16} + \frac{1}{1 + \frac{16(-2)}{2}}$ . The best e-ciency, obtained in the limit ! 0, is given by

This means that the uctuations are at best of order N , and at worst of order N  $^2$  when the learning rate is too high. This is likely to be corrected for neural networks with sophisticated private utility.

# 2.2 Inductive behavior

ElFarol's problem was introduced with public information and inductive behavior [1], but with no precise characterization of the strategy space. In most MG-inspired models, a strategy is a lookup table a, or a map, or a function, which predicts the next outcome a for each state , and whose entries are xed for the whole duration of the game. Each agent i has a set of S strategies, say S = 2 (a<sub>i;1</sub> and a<sub>i;2</sub>), and use them essentially in the same way as before [2].

#### N aive agents

To each of her strategies, agent i associate a score  ${\rm U}_{\,\rm i;s}$  which evolves according to

Since we consider S = 2, only the di erence between  $_{\rm i}$  = U  $_{\rm i,2}$  ~ U  $_{\rm i,1}$  m atters, and

Note that now  $_{i}$  encodes the perception of the relative perform ance of the two strategies of agent i,  $_{i} > 0$  m eaning that the agent i thinks that strategy 2 is better than strategy 1, and m<sub>i</sub> is the frequency of use of

strategy 2. As before, we consider  $(x) = \tanh(x)$ . This kind of agents m inim izes the predictability, which has now to be averaged over the public information states

where  $\overline{Q} = P_{e_{1}}^{P} Q$  is a useful shortcut for the average over the states of the world. In contrast with the case with no information, H is not always canceled by the agents. This is due to the fact that the agents are faced to P possible states, but their control over their behavior is limited: when they switch from one strategy to another, they change their behavior potentially for all states. In fact all m acroscopic quantities such as H=N and <sup>2</sup>=N depend of the ratio = P=N [20, 21, 22], which is therefore the control parameter of the system . Solving this model is m uch m ore com plex and requires tools of Statistical Physics of disordered system s [23]. The resulting picture is that for in nite system size (P, N ! 1 with P=N = e cst) [22] (see also F ig 2),

H > 0 if  $= N = P > _{c} = 0.3374 :::.$  In this region, the system is not informationally e cient. It tends to a stationary state which is unique and stable, and does not depend either on or on initial conditions. is a time scale [4].

H = 0 when  $< {}_{c}$ . Since agents succeed in m inimizing H, the question for them is what should they do? They do not known, and as a result, the dynamics of the system is very complex: it depends on initial conditions<sup>5</sup> [10, 24, 26, 25], and on 13, 26, 25]. Any value of the uctuations can be obtained, from  $^{2} = 1$  for very heterogeneous initial conditions  $_{i}(t = 0)$  to  $^{2}$  N<sup>2</sup> for = 1 and hom ogeneous initial conditions, including  $^{2}$  N for = 0 and any initial conditions. Two alternative theories have been proposed, one which is exact, but which has to be iterated [25], and another one which rests on a closed form for the uctuations 26]. Iterating the exact theory is hard, since the t th iteration is obtained by inverting t t m atrices, and one has to average of several realizations. N evertheless, a hundred num erical iterations bring prom ising results [27].

The origin of the phase transition can easily be understood in terms of linear algebra: canceling H = 0 means that hA j i = 0 for all . This is nothing else than a set of P linear equations of N variables fm ig. As the variables are bounded (0  $m_i^2$  1), one needs more that P of them, N = P =  $_c > P$  to be precise [28].




FIGURE 2. Fluctuations and predictability produced by naive agents P = 64, 300P iterations, average over 100 realizations. This kind of gure is rst found in ref. [20].

In fact, the transition from low to high (anomalous) uctuations does not occur at  $_{\rm c}$  for nite system size as it clearly appears on Fig2. This

can be traced back to a signal to noise ratio transition [29]: the system is dynamically stable in the phage of H > 0 as long as the signal to noise ratio  $H = {}^{2}$  is larger than K = P for some constant K. This transition is universal for naive competing agents. Hence in this kind of interacting agents system s, the ultimate cause of large uctuations is this signal-to-noise transition and high learning rate. Sophisticated agents are not a ected by this problem, as explained below.

#### Sophisticated agents

A s before, a sophisticated agent is able to disentangle her own contribution from g(A). Eq (10) becomes [22, 30]:




FIGURE 3.F luctuations produced by sophisticated agents  $P\ =\ 64, N\ IT\ =\ 100P$  , average over 100 realizations.

When the payo is linear g(A) = A, the agents also minimize the uctuations  ${}^2 = hA^2i$ . Similarly, they end up using only one strategy, which implies that  $H = {}^2$ . In this case, they cannot cancel A for all at the same time, hence  ${}^2=N > 0$ . How to solve exactly this case is known in principle [22, 30]. 'In principle' here means that the minimization of  ${}^2$ is hard from an technical point of view; how much harder is also a question hard to answer. A rst step was done in ref. [1], which is able to describe reasonably well the behavior of the system. Interestingly, in this case the signal-to-noise ratio transition does not exist, as the signal is also the noise (H =  ${}^2$ ), hence, there is no high volatility region (see Fig. 3).

Therefore, the uctuations are again considerably reduced by introducing sophisticated agents. An important point here is that the number of stable

nal states fm<sub>i</sub>g [31] grows exponentially when N increases. W hich one is selected depends on the initial conditions, but the e ciency of the nal state greatly uctuates. As the agents (and the program m er) have no clue of which one to select, the system ends up having non-optim al uctuations of order N , as seen of Fig. 3.

# 3 Forward/reverse problem s

Inductive agents m inim ize a world utility whose determ ination is the step in solving the forward problem . Finding analytically its m inimum is then possible in principle thanks to methods of Statistical Physics [23]. The reverse problem consists in starting from a world utility W and noting the appropriate private payo .

# 3.1 Naive agents

The case with no information (P = 1) is trivial, since Ai = 0 in the stationary state, hence all functions  $H_{2n} = hAi^{2n}$  (n integer) are minimized by a linear payo .W hen the agents have access to public information (P > 1), the world utility W given any private payo function g(A) is 26]

where g(x) = dG(x)=dx and  $D = {}^{2}$   $H = (N {}^{p}_{i}m_{i}^{2})=2$ . In other words, the agents select the set of strategy usage frequencies fm ig that m inim izes U. The nal state is unique and does not depend on the initial conditions. Note that in Eq (14), only powers of hA j i (= 1; ;P) appear, which m eans that naive agents are only able to m inim ize world utility that only depend on these quantities. This im plies that a phase transition always happen if the agents are naive, and even m ore, that it always happen at the same  $_{c} = 0.3374::$ ; as seen conjecture from numerical simulations in [32]. A sexplained above,  $_{c}$  is the point where it is algebraically possible to cancel all hA j i [28]. The above theory also m eans that the stationary state depends only weakly on the payo , which can be seen numerically by com paring the m<sub>i</sub> of a given set of agents for di erent payo s.

The reverse problem is now to nd g given W. Let us focus on the particular example W =  $hA i^{2n}$ , (n integer). First, one determ ines the world utility W <sup>(2k)</sup> associated with  $g(x) = 2kx^{2k-1}$ , where k is an integer,

where  $X_1 = {R \atop exp} (x^2=2)x^1 = {p \over 2}$  is the 1-th moment of a Gaussian distribution of unitary variance and zero average, and  $H_{21} = hAi^{21}$  is the 21 norm of the vector (hA j i). Suppose now that one wishes to minimize  $W = H_{2n}$ . This can be done in principle with a linear combination of the  $W^{(2k)}$

The condition on the  $fa_kg$  is that the coe cient of  $H_{2k}$  be 0 for k = 0; ;n 1, and the coe cient<sub>2</sub> $\rho$ filie 1, that is

and  $a_n = 1$ . Then the problem is solved by nding the solution of these n 1 linear equations of  $a_k$ , k = 1; ; n 1, and taking  $g(x)_{k=1}^n a_k x^{2k-1}$ . Note that the set of the problem s that naive agents can solve is of limited practical interest.

# 3.2 Sophisticated agents

Sophisticated agents have instead

where D<sub>i</sub> =  $[(N \ 1)$   $\stackrel{P}{\underset{j \in i}{}} m_{i}^{2} = 2$ . This case is much simpler than the previous one, as all agents end up playing only one strategy [22], that is, D<sub>i</sub> = 0. Therefore, in this case, if  $g(A) = 2kA^{2k+1}$ ,

Interestingly, sim ilar functions are well-studied in Statistical Physics, where they usually represent the energy of interacting magnetic moments called "spins" [33]; a (classical) spin can have two values 1 or + 1, which is the equivalent of choosing strategy 1 or 2. A well-known qualitative change occurs between k = 2 and k > 2, where the mathematical minimization of W is somehow less problematic; this may also be the case in such MGs. The nal state is not unique, and depends on initial conditions, im plying that agents cannot are not particularly good at minimizing such functions.

### 3.3 Example: agent-based optim ization

Some optim ization problem s are so hard to solve that they have a name: they are hard, NP-hard [34]. There is no algorithm that can nd the optimum of this kind of problem s in polynom ial time. One of them consists in

nding am ongst N either analogic or binary components the combination that is the least defective [35]: in the problem with analogic components, one has a set of N m easuring devices; instead of A, each of them records the wrong value A +  $a_i$  with a constant bias  $a_i$ , i = 1; ; N, drawn from a given probability function. The problem is to nd a subset such that the average bias

ism inim al. Here  $n_i = 0$ ; 1 depending on whether component <u>i</u> is included in the subset. Statistical Physics shows that  $h_{opt}i = C 2^N = N$  for large N, with C ' 4:6 (the average is over the samples). In order to nd the optim al subset, one cannot do better than enumerating all the  $2^N$  possibilities. This makes it hard to tackle such problem s for N larger than 40 with now adays computers. A gent-based optimization on the other hand needs typically O (N) iterations and can be used with much larger samples. It is clear that one cannot expect this method to perform as well as the enumeration, still how well it perform as a function of the setup is a valuable question. Ref [37] compares a set of private payo s and concludes that agent-based optimization is better than simulated annealing for short times and large samples, provided that the agents' private utility is \aristocratic".

Optim izing  $h = j \prod_{i=1}^{N} n_i a_i j$  and then dividing by the number of com – ponents used in the chosen subset leads to almost optim all subsets [35]. Hence, we can use sophisticated MG -agents in order to optim ize  $h^2$  [38], which plays the role of the uctuations in the MG. The most straightforward application of the MG is to give two devices to each agents, which are




FIGURE 4.A verage error versus the size N of the defective component set for MG with S = 2 (circles), and S = 1 (squares), S = 2 with rem oval (stars) and S = 1 with rem oval (full squares. 500N iterations per run, averages over 1000 sam ples.

their strategies. Each agent ends up playing with only one strategy. This setup constraints the use of N =2 devices in the optim all subset, and gives an error of order N<sup>1:5</sup>, to be compared with the exponential decay of the optim all average error  $_{opt}$ . One can unconstrain the agents by giving only one component to each agent, and letting them decide whether to include their components or not into , making the gam e 'grand canonical' 39, 40]. This is achieved by the following score evolution

$$U_{i}(t+1) = U_{i}(t) \quad a_{i}[A \quad n_{i}(t)a_{i}]$$
 (21)

and  $n_i(t) = [U_i(t)]$ . The  $n_i a_i$  term makes the agents sophisticated. This gives similar results as those of ref [37], as indeed the Aristocrat Utility is essentially the same concept as sophisticated agents. But in any case, it minimizes the uctuations, but does not optimize them. The resulting error

is much better with S = 1 than with S = 2: it decays  $N^2$  (Fig 3.3). Therefore, as in the optim alcase, unconstraining the problem by not xing the num ber of selected components leads to much better e ciency.

At this stage, one can improve substantially the error, still remaining in the O (N) complexity regime. First, since the agents update their behavior simultaneously, they may be unable to distinguish whether removing only one component improves the error. We can do it by hand at the end of the simulations, repeatedly. This is a kind of greedy algorithm. On average, about 1.5 components are removed. In both the S = 2 and S = 1 cases, this results into a large improvement (see Fig. 3.3), and curioulsy produces the same error, with a decay N<sup>2:3</sup>. Nevertheless, the nalerror is still




FIGURE 5. A verage error versus the number of runs for each sample of the defective component set for MG with S = 2 (circles), and S = 1 (squares), S = 2 with rem oval (stars) and S = 1 with rem oval (full squares). Left panel: N = 20, averages over 1000 samples; right panel: N = 50, average over 200 samples.

far from optimality. This illustrates how hard this optimization problem is. Much better results can be obtained by removing a group of 2, or 3 components, ad libitum, but of course, this needs much more computing resources (O (N<sup>2</sup>), O (N<sup>3</sup>), ...), and eventually amounts to enumerating all possibilities.

Here is the second trick that keeps the complexity with the 0 (N) regime. As mentioned, the nalstate depends on the initial conditions, and is often not optim alor not even near optim al. But it is still a local minimum of h<sup>2</sup>. Therefore the idea is to do T runs with the same set of defective devices, changing the initial condition  $U_i$  (t = 0), and to select the best run. It is a kind of simulated annealing [36] with zero tem perature, or partial enum eration where repetition would be allowed. Interestingly, Figure 5 reports that the decay is apparently a power-law rst, and then begins to saturate. For S = 1, the exponent is about 0:5, and 0:4 for S = 2; it depends weakly on N.Rem arkably, the error decreases faster with S = 1 agents than S = 2. Note that the optim alvalue is at about 10  $^6$ , hence, agents are far from it. This is due to the fact that the agents use too m any components. Nevertheless, the improvem entbrought by this methods is impressive, and increases as N increases, but cannot keep up with the exponential decay of opt: the di erence becom es m ore and m ore abysm al. The com ponent rem oval further lowers the error (same gure), and more in the S = 2 that in the S = 1 one. This advantage is reversed for T large enough when N is larger, as reported by the right panel Fig. 5).

The other optimization problem recycles binary components [35]: one has a set of N partially defective processors, each of them able to perform




FIGURE 6. Fraction of samples for which a perfectly working subset of components can be found. f = 0.2, average over 1000 runs.

P di erent operations. The manufacturing process is supposed to be fault with probability f for each operation of each component. M athem atically, the operation of processor a is permanently defective (a = 1) with probability f and works permanently with probability 1 f (a = 1). The probability that a component is working become svanishingly small when P grows at xed f. The task consists in nding a subset such that the majority of its components gives the right answer, that is,

$$\sum_{i=1}^{N} n_i a_i > 0 \quad \text{for all} = 1; \quad ;P \quad (22)$$

Surprisingly, the fraction of sam ples in which a perfectly working subset of components can be found increases very quickly as N grows at xed P and f [35] (see also g.6). Finding a subset that perfectly works is an easy problem when it is possible, but noting the one which has the least components is a hard problem [35]. By contrast with the minimization of uctuations, here one wishes to maximize A given , that is, the predictability H. Since all the agents eventually use only one strategy in majority gam es [21], H = <sup>2</sup>, hence, the uctuations <sup>2</sup> are also maximized: naive agents are also sophisticated in this case. A simple majority gam e does not favor any particular sign of A a priori. How ever, iff 1=2 the sign + , hence mostly working combinations, are favored. In practice, a majority gam e agent that here one has

$$U_{i}(t+1) = U_{i}(t) + a_{i}^{(t)} A(t)$$
 (23)

M a prity gam es with S = 1 turn out to be better than those agents with S = 2, as shown in Fig. 6, where the results of enum eration are also displayed. As the problem to nd a working subset is easy for N large enough, the agents are successful.

# 4 Conclusions

The e ciency of M inority G am es seem s to be universal with respect to agents' learning rate: if the latter is too high, anom alous uctuations, hence sm alle ciency arise. However, these are totally suppressed if the agents are sophisticated, who can optim ally coordinate if there is no public inform ation. A n unexplored issue is what happens with neural networks taking into account their im pact on the gam e.B ased on this 'universality', it would be tem pting to study neural networks with the sophisticated payo .

The study of forward/reverse problem s showed the limitations of agentbased optim ization in hard cases, which leaves the interesting open question of how to improve the overall performance, and how the setup of agentbased models can and must be tuned for individual cases.
