Critical temperature of Bose { Einstein condensation in trapped atom ic Bose { Fermim ixtures

Abstract

We calculate the shift in the critical temperature of Bose-Einstein condensation for a dilute Bose-Fermim is ture conned by a harmonic potential to lowest order in both the Bose-Bose and Bose-Fermicoupling constants. The relative importance of the election the critical temperature of the boson-boson and boson-fermion interactions is investigated as a function of the parameters of the mixture. The possible relevance of the shift of the transition temperature in current experiments on trapped Bose-Fermim importance is discussed.

I. IN TRODUCTION

The achievement of Bose-Einstein condensation in ultracold, trapped dilute alkaligases, beyond realizing a striking and spectacular experimental con mation of a long-standing,

fundam ental prediction of quantum theory, has initiated and stimulated as well a whole new eld of research in the physics of quantum gases in conned geometries [1,2]. Nowaday, many dierent atomic species and isotopes can be successfully cooled and trapped in the gaseous state, to investigate in exceptional conditions of purity and isolation the properties of interacting Bose and Fermisystems, or Bose-Fermin intures.

In particular, the experimental realizations of trapped gaseous mixtures of bosons and ferm ions are both an interesting new instance of a quantum many-body system and a very useful tool to reach the regime of quantum degeneracy for a Fermigas via sympathetic cooling of the fermions by the bosons [3{7]. From a theoretical point of view, dilute Bose-Fermim ixtures have been the object of recent investigations addressing, for example, the determination of the density proles of the two components in trapped systems [8], the problem of stability and phase separation [9], and the elect of boson-fermion interactions on the dynamics [10] and on the ground-state properties [11] of the mixture.

Boson-ferm ion interactions in a Bose-Ferm im ixture can induce a net attractive interaction between the ferm ions, thus introducing a further mechanism toward the achievement of the BCS transition in trapped Ferm i gases [12]. In this paper we address the reverse problem, i.e. how the transition temperature of Bose-E instein condensation is a ected by the presence of the fermions in a trapped mixture. The shift of the transition temperature T_c due to interactions in a pure trapped Bose system has been calculated within the mean-eld approximation in Ref. [13]. In the present work we extend the perturbative methods of Ref. [13] to obtain the shift of T_c to lowest order in both the Bose-Bose and Bose-Ferm i coupling constants. To this order the election T_c of boson-boson and boson-fermion interactions are independent and add linearly. The relative importance of the two elects depends on the relevant parameters of the trapped mixture: number of bosons and fermions in the trap, ratio of the masses and of the oscillator frequencies for the two species and the ratio of the Bose-Bose and Bose-Fermicoupling constants. The calculation is carried out in local density approximation which is valid provided that the number of bosons and fermions in the trap is large. Finite size elects have not been included in the present treatment.

The plan of the paper is as follows: in Section II we generalize the scheme derived for pure Bose systems in Ref. [13], to include the elects of boson-ferm ion interactions. In Section III we derive analytical results for the shift of T_c in the limits of a highly degenerate (Thomas-Fermi) and a classical (Boltzmann) Fermigas, and we provide the full numerical solution for the intermediate regimes. We nally compare the theoretical predictions with the current experimental situations and we draw our conclusions.

TT. THEORY

In a non-interacting Bose gas con ned by the external harmonic potential $V_{\rm ext}^B(r) = m_B (!_x^2 x^2 + !_y^2 y^2 + !_z^2 z^2) = 2$, the critical temperature for Bose-Einstein condensation (BEC) is given by

where $!_B = (!_x!_y!_z)^{1=3}$ is the geom etric m ean of the oscillator frequencies and m_B, N_B are respectively the particle m ass and the number of bosons in the trap. The above result is obtained using the local density approximation (LDA), where the temperature of the gas is assumed to be much larger than the spacing between single particle levels: $k_B T$ h!_{x,y,z}. In this case the density of therm all atoms can be written as

where $_{\rm T}^{\rm B}=h\,(2\,$ =m $_{\rm B}\,k_{\rm B}\,T\,)^{1=2}$ is the boson therm alwavelength, and $g_{3=2}\,(x)=\frac{P}{n=1}\,x^n=n^{3=2}$ is the standard Bose function of order 3=2. At $T=T_c^0$ the boson chem ical potential takes the critical value $_{\rm B}=\frac{0}{c}=0$, corresponding to the bottom of the external potential, and the density $n_{\rm B}^0$ (0) in the center of the trap satis es the critical condition $n_{\rm B}^0$ (0) ($_{T_c^0}^{\rm B}$) $^3=(3=2)$ ' 2:61 holding for a homogeneous system .

Finite size e ects modify the prediction of the critical temperature (1) resulting in a reduction of T_c^0 . The rst correction due to the nite number of atoms in the trap is given by [14]:

where $!_B = (!_x + !_y + !_z)=3$ is the arithmetic mean of the oscillator frequencies.

Interparticle interactions have an election the BEC transition temperature as well. The presence of repulsive interactions has the elect of expanding the atom ic cloud, with a consequent decrease of the density. Lowering the peak density has then the elect of lowering the critical temperature. On the contrary, attractive interactions produce an increase of the density and thus an increase of T_c . This elect, which is absent in the case of a uniform gas where the density is kept in xed, can be easily estimated within mean-eld theory. For pure bosonic systems the shift $T_c = T_c$ T_c^0 has been calculated in Ref. [13],

to lowest order in the coupling constant $g_{B\,B}=4~h^2a_{B\,B}=m_B$. In the above equation $a_{B\,B}=4~h^2a_{B\,B}=m_B$. In the above equation $a_{B\,B}=4~h^2a_{B\,B}=m_B$ is the boson-boson s-wave scattering length and $v_B=4~h^2a_{B\,B}=m_B$ is the harm onic oscillator length. Result (4) has been obtained within LDA and neglects nite size e ects.

In the case of trapped Bose-Ferm im ixtures the shift of $T_{\rm c}$, due to both Bose-Bose and Bose-Ferm i couplings can be calculated in mean-eld approximation using the methods of Ref. [13]. The transition temperature $T_{\rm c}$ of a trapped Bose gas is dened by the normalization condition

where n_B is the therm aldensity of bosons and $_c$ is the critical value of the boson chem ical potential. W ithin LDA the boson density above T_c is given by

is the elective potential acting on the bosons which is generated by the external eld $V_{\rm ext}^B$ and by the mean eld produced by interactions with the other bosons and with the ferm ions. Notice the factor 2 present in the Bose-Bose contribution and absent in the Bose-Ferm i term due to exchange elects. In the above equation n_F (r) is the ferm ion density and $g_{BF} = 2 h^2 a_{BF} = m_R$ is the Bose-Ferm i coupling constant, xed by the boson-ferm ion s-wave scattering length a_{BF} and by the reduced mass $m_R = m_B m_F = (m_B + m_F)$, where m_F is the ferm ion mass.

For a xed value of the boson chem ical potential $_{\rm B}$ and a xed temperature T, the boson density (6) can be expanded to $\,$ rst order in $\,$ g $_{\rm B\,B}$ and $\,$ g $_{\rm B\,F}$ as

In the above equation $_{T}^{F} = h (2 = m_{F} k_{B} T)^{1=2}$ is the ferm ion therm alwavelength, and $f_{3=2}(x)$ is the Ferm i function of order 3=2 de ned as

Result (9) has been obtained in LDA for a Fermigas in the trapping potential $V_{\rm ext}^{\rm F}(r)=m_{\rm F}(!_{\rm x}^{02}{\rm x}^2+!_{\rm y}^{02}{\rm y}^2+!_{\rm z}^{02}{\rm z}^2)=2$. The fermion chemical potential $_{\rm F}$ is xed by the normalization condition

where N $_{\rm F}$ is the total number of ferm ions in the trap. The condition of validity for LDA requires the Ferm item perature of the ferm ionic system to be much larger than the harm onic oscillator energies $k_B T_F$ $h!_{x,y,z}^0$. For a non-interacting trapped Ferm i system the Ferm i tem perature, or equivalently the Ferm ienergy, is given by $k_B T_F = _F = h!_F (6N_F)^{1=3}$, where $!_F = (!_x^0!_y^0!_z^0)^{1=3}$ is the geom etric mean of the ferm ion oscillator frequencies.

To rst order in $g_{B\,B}$ and $g_{B\,F}$, the critical value $_{c}$ of the boson chem ical potential can be written as

By writing $T_c = T_c^0 + T_c$, one can expand Eq. (5) obtaining the following result for the total relative shift of the condensation temperature:

where the derivatives of the non-interacting boson and ferm ion densities n_{B}^{0} and n_{F}^{0} are evaluated at the ideal critical point $_{\rm c}^{\rm 0}=$ 0, T = $\rm T_{\rm c}^{\rm 0}$. The rst term ($\rm T_{\rm c}=T_{\rm c}^{\rm 0})_{\rm B\,B}$ in the above equation accounts for interaction e ects among the bosons and coincides with the shift (4). The second term ($T_c = T_c^0$) $_{\rm B\,F}$ accounts instead for interaction e ects between bosons and ferm ions, and its determ ination will constitute the main result of the present paper. Som e com m ents are in order here. (i) The shift T_c derived above is a mean-eld e ect which originates from the fact that in a trapped Bose-Ferm imixture the total number of bosons and the total number of fermions are xed, but not the density pro les of the two species. This e ect is peculiar of trapped systems, since it vanishes identically in the case of uniform systems, and should not be confused with the shift of $T_{
m c}$ occurring in homogeneous Bose systems, which is instead due to many-body e ects [15]. (ii) The shift originating from the Bose-Ferm i coupling, sim ilarly to the one arising from the Bose-Bose one, is negative if $g_{BF} > 0$ and is positive if $g_{BF} < 0$. If a_{BB} and a_{BF} have opposite sign, the corresponding shifts of T_c go in opposite directions. (iii) Result (13) holds to lowest order in $g_{B\,B}$ and $g_{B\,F}$ and, since it has been obtained using LDA, is exact if the number of bosons and ferm ions is large. Finite-size corrections are not included in (13). For a nite system, a reasonable estimate of the total shift of the critical temperature can be obtained by adding to result (13) the nite-size correction (3) of the non-interacting model.

III. R E SU LT S

We now concentrate on the relative shift ($T_c=T_c^0$) $_{\rm B\,F}$ due to the boson-ferm ion interaction. First of all we observe that

In the following we shall assume that even if the trapping potentials of bosons and ferm ions can have dierent oscillator frequencies, nevertheless $!_x = !_y = !_y = !_y = !_z =$

where we have introduced the reduced chem ical potential $\sim_F = _F = k_B T_c^0$ and the reduced Ferm i tem perature $T_F = T_F = T_c^0$. Eq. (16) reveals that \sim_F is only a function of T_F , which in turn is a measure of the degeneracy of the Ferm i gas at $T = T_c^0$. In terms of \sim_F and T_F Eq. (15) then becomes

In writing Eq. (17) we have rescaled each integration coordinate by the appropriate T hom as Ferm i radius of the ferm ion cloud $R_i^0 = (2_F = m_F!_i^{02})^{1=2}$. We have then introduced the mean Ferm i radius $R_F = (R_x^0 R_y^0 R_z^0)^{1=3}$ and named $= m_B!_B^2 = m_F!_F^2$. Since \sim_F depends only on T_F through Eq. (16), the integral in Eq. (17) above depends only on the values of the two parameters T_F and .

The system of Eqs. (17) and (16) for general T_F and can only be solved numerically, and later we shall present the full numerical results for some species choices of the parameters. However, analytical solutions exist in two limits: when T_F 1 (i.e. T_F T_c^0) where the Fermi gas is completely degenerate at $T = T_c^0$ (Thomas-Fermi regime), and when T_F 1 (i.e. T_F T_c^0) so that at T_c^0 fermions behave as a classical gas (Boltzmann regime).

In order to clarify the connection between the two limits and the general numerical solution, it is useful to further manipulate Eq. (17). By explicitly evaluating the prefactor, it can be nally recast in the convenient form

and $_F' = 0$ $_{h=m_F!_F}'$ is the ferm ionic oscillator length. Notice the form all analogy between Eq. (18) and Eq. (4) for the shift ($T_c=T_c^0$)_{BB} due to the boson-boson interactions alone.

Let us begin by considering the Thom as-Ferm i lim it (T_F 1). In this lim it the chem ical potential of the ferm ions $_F$ tends to the Ferm i energy $_F$ = $k_B T_F$. Thus \sim_F ' T_F 1. The lim it of the Ferm i functions in Eq. (10) for x! 1 is $f_{3=2}(x)$ 4 ($\ln x$) $^{3=2}=3^{p}$. This

We obtained Eq. (21) in the lim it T_F 1. Therefore, if is not too small (so that T_F 1 still holds), then, for every n in the series, the exponential is non-vanishing only for values of s 1, and we can adopt the expansion 1 (1 2 s)³⁼² / 3s²=2. We notice that f() in Eq. (25) is a monotonically decreasing function of . In particular, one nds the following behaviours: $f(!0) = ^2=6$, f(1)'0:85, and f(!1) = 3 (3)=2 . As one should expect, in the Boltzmann limit (Γ_F 1), the Bose-Ferm is hift is negligible.




FIG. 1. D im ensionless function F (T_F ;) as a function of T_F for the values = 0:1 (dotted line), = 1:0 (dashed line), and = 10 (solid line).

We now turn to the full numerical solution of Eqs. (18), (19), and (16) form one general values of the degeneracy parameter T_F . In Fig. 1 we show the dimensionless function $F(T_F; \cdot)$ as a function of T_F for three dimensionless of the parameter $P_F = P_F = P_F$

The physically relevant regimes in current experiments fall roughly around ' 1 and T_F ' 1. In this respect, a particularly interesting situation is the one realized in the Florence experiment [7], where a quantum degenerate trapped atom ic mixture of fermionic 40 K and bosonic 87 Rb has been recently produced. One of the appealing features of this system is that the measured boson-fermion scattering length is large and negative: $a_{BF} = 22 \text{ nm}$, giving rise to a fairly strong attractive boson-fermion interaction. The shift ($T_c = T_c^0$)_{BF} is thus positive and opposite to the shift ($T_c = T_c^0$)_{BB}, since for pure 87 Rb the boson-boson scattering length is $a_{BB} = 6 \text{ nm}$, giving rise to a repulsive boson-boson interaction. In the F brence experiment the two atom is species are magnetically trapped, and are both prepared in their doubly polarized spin state.




FIG. 2. Boson-ferm ion relative shift $T_c=T_{c-BF}^0$ from Eq. (18) (solid line) as a function of the ratio $N_F=N_B$. Horizontal dashed line: value of the modulus j $T_c=T_{c-BB}^0$ jof the boson-boson shift (4). All other parameters, except the number of fermions N_F , have been xed at the values of the Florence experiment.

($T_c = T_c^0$)_{BB} ′ 0.937, and is comparable with the shift (3) due to nite size elects, which is given by: ($T_c = T_c^0$)_{fs} = 0.944. For = 1 at T_F ′ 2.3 the function F is at about 1/3 of its asymptotic value in the Thomas-Fermi regime, resulting in a Bose-Fermi shift considerably smaller than the Bose-Bose one: ($T_c = T_c^0$)_{BF} ′ 0.912. In Fig. 2 we show the shift ($T_c = T_c^0$)_{BF} as a function of the ratio $N_F = N_B$, with all the other parameters entering Eq. (18) xed at the values of the Florence experiment [7]. In the same gure we include as a reference value the modulus of the boson-boson relative shift j ($T_c = T_c^0$)_{BB} j calculated using the values of the parameters given by the Florence experiment.

From Fig. 2 we see that, while in the present experim ental situation the boson-ferm ion shift is about 1=3 of the boson-boson one, by increasing the number of trapped ferm ions the two shifts become comparable at N $_{\rm F}$ ' $5{\rm N}_{\rm B}$. The boson-ferm ion shift is instead dominant at still larger values of N $_{\rm F}$. It is important to remark that, even if the Bose-Ferm i shift of

the critical tem perature is a smalle ect for the present experimental conditions, it might be observable. Since the ferm ions can be eliminated from the trap, one can look for the dierences in the transition temperature with and without ferm ions.

In conclusion, we have determ ined the relative shift of the critical tem perature of Bose-E instein condensation in a trapped atom ic Bose-Ferm im ixture to lowest order in both the boson-boson and the boson-ferm ion coupling constants. We have determ ined numerically the general behaviour of the boson-ferm ion shift, and we have provided full analytical solutions in the quantum degenerate Thomas-Ferm i regime and in the classical Boltzmann regime. We have applied our predictions to a specie experiment (the Florence experiment [7], chosen for the interesting value of the Bose-Ferm i scattering length), and discussed the relative importance of the shifts due to boson-boson and boson-ferm ion interactions.
