Som e exact results for Boltzm ann's annihilation dynam ics

The problem of ballistic annihilation for a spatially hom ogeneous system is revisited within Boltzmann's kinetic theory in two and three dimensions. A nalytical results are derived for the time evolution of the particle density for some isotropic discrete bim odal velocity modulus distributions. A coording to the allowed values of the velocity modulus, di erent behaviors are obtained: power law decay with non-universal exponents depending continuously upon the ratio of the two velocities, or exponential decay. When one of the two velocities is equal to zero, the model describes the problem of ballistic annihilation in presence of static traps. The analytical predictions are shown to be in agreement with the results of two-dimensional molecular dynamics simulations.

I. IN TRODUCTION

In ballistically controlled reactions, particles with a given initial velocity distribution m ove freely (ballistic m otion) in a d-dimensional space. W hen two of them meet, they annihilate and disappear from the system. This apparently simple problem has attracted a lot of attention during the past years [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14] for the following reasons. First, this is one of the few problems of nonequilibrium statistical physics that can be exactly solved in some cases, and second it m odels some grow th and coarsening processes [15].

This eld was entered with the pioneering work by Elskens and Frisch [1], where a one-dimensional system with only two possible velocities + c or c was studied. U sing combinatorial analysis, they showed that the density of particles was decreasing according to a power law (t¹⁼²) in the case of a symmetric initial velocity distribution. The investigation of this one-dimensional problem was generalized by D roz et al. [6] to the three-velocity case where the initial velocity distribution is given by ' (v;0) = p_+ (v c) + p_- (v) + p (v + c) with p_- = p (symmetric case) and $p_{+} + p_{0} + p_{-} = 1$. It turns out that the decay of the particle density depends on the details of the initial velocity distribution. The following analytical results were obtained. For $p_0 < 1=4$, the density n(v;t) of particles with velocity v = f0; +c; cg, behaves in the long-time lim it as n(0;t)t¹; n(c;t) $t^{1=2}$. W hen $p_0 = 1=4$, n (0;t) $t^{2=3}$. Finally, for $p_0 > 1=4$, one nds that n (0;t) saturates to a nonzero stationary value, while n(c;t) n (c;t) decays faster than a power law . M oreover, it was shown that in one dimension, annihilation dynam ics creates strong correlations between the velocities of colliding particles, which excludes a Boltzm ann-like approximation. Pairs of nearest neighbor particles have the tendency to align their velocities and propagate in the same direction [6].

A n analytical investigation of the one-dimensional case with a continuous velocity distribution is much more di cult. A dynamical scaling theory, whose validity was supported by extensive numerical simulations for several velocity distributions, led R ey et al. [7] to the conjecture that all the continuous velocity distributions ' (v) that are symmetric, regular and, such that ' (0) \notin 0 are attracted in the long-time regime towards the same G aussian-like distribution and thus belong to the sam e universality class.

For higher dimensions, most of the studies are based on an uncontrolled Boltzm ann-like description [2, 3, 11] or numerical simulations [12]. However, based on phenom enological mean-eld-like arguments, K rapivsky et al. have studied the annihilation kinematics of a bim odal velocity modulus distribution in d > 2 dimensions [4]. In the case of a mixture of moving and motionless particles they showed that the stationary particles always persist, while the density of moving particles decays exponentially. This approach contains unknow n phenom enological parameters, and thus a complete comparison with the results obtained by numerical simulation is not possible.

In a recent paper, P isseckiet al. [14] gave an analytical derivation of the hierarchy equations obeyed by the reduced distributions for the annihilation dynamics. In dimension d > 1 for a spatially hom ogeneous system, and in the limit (the so-called G rad limit) for which the particle diameter ! 0, and the particle density n(t) ! 1 such that $n(t)^{d-1} = {}^{-1}$, where is the mean free path, the hierarchy reduces to the Boltzm ann-like hierarchy. This hierarchy propagates the factorization of the reduced k-particle distribution in term sofone-particle distribution functions. Thus, if the initial state is factorized, the whole hierarchy reduces to one nonlinear equation for the one-particle Boltzm ann distribution. For annihilation kinetics, the ratio of particle diameter to mean free path vanishes in the long-time limit and the situation becomes similar to the G rad limit discussed above for ! 1. Thus the long-time limit of the annihilation dynamics (for d > 1) is likely to be adequately described by the nonlinear Boltzm ann equation.

A scaling analysis of the nonlinear B oltzm ann equation led to analytical expressions for the exponents describing the decay of the particle density and of the root-m ean-square velocity in the case of continuous velocity distributions [14].

In view of the di erent behaviors observed in one dimension for discrete or continuous velocity distributions, it is

relevant to study the case of distributions with discrete m odulus spectrum in dimensions higher than 1. The goal of this paper is to investigate simple examples of this kind in three dimensions for which the non linear Boltzm ann equation derived in Ref. [14] can be exactly solved. The generalization of this approach to an arbitrary dimension is straightforward, and for the sake of comparison with numerical simulations, we shall also consider the two-dimensional situation in some detail.

The validity of the Boltzm ann description in the long-time limit will be con rm ed by comparing our analytical predictions with the results obtained by a molecular dynam ics simulation.

The paper is organized as follows. In Sect. II we denote the model. In Sect. III the three-dimensional Boltzmann equation is solved analytically for a two velocity modulus (c_1 and c_2) isotropic distribution. For simplicity we rst consider the one velocity model $c_1 = c_2 > 0$ that allows to draw interesting comparisons with the same model in one dimension. Then the implicit solution for the particle densities in the general case $c_1 > c_2 > 0$ is established. It is shown analytically that in the long-time limit the particle densities decay according to power laws, with exponents depending continuously on the value of the velocity modulus ratio. We also nd upper and lower bounds to the particle densities decay exponentially to zero for the moving particles, and to a nonzero value for the motion less ones. This phenom enology is independent of space dimension, and in Sect. IV, it will be shown explicitly to hold in two dimensions by implementing molecular dynam ics and, therefore, provides an interesting test for the analytical predictions. Section V contains our interpretations and conclusions.

II. THE MODEL

We consider a system made of spheres of diameter moving ballistically in three-dimensional space. If two particles touch each other, they annihilate and thus disappear from the system. We consider only two-body collisions. The initial spatial distribution of particles is supposed to be uniform, therefore it remains uniform during the evolution. Indeed, if the state is initially translationally invariant, then the free evolution preserves this symmetry. A nnihilation dynam ics adds the elect of binary collisions that depends only on the distance between particles, thus preserving the translational invariance. Finally, existing numerical simulations seem to be compatible with this assumption of hom ogeneity [14]. We are interested in the time evolution of the number density of particles with a given velocity modulus.

Let $f_1(v;t)$ be the distribution function of the density of particles in \mathbb{R}^3 with velocity v 2 \mathbb{R}^3 at time t. For spatially hom ogeneous states, the distribution function has the form

where ' (v;t) is the velocity probability density. In the long-time limit, P iasecki et al. [14] have shown that the hierarchy satis ed by the reduced distributions approached the Boltzm ann hierarchy. If the initial state is factorized, the nonlinear Boltzm ann equation provides then the complete description of annihilation dynam ics,

Here is the Heaviside function, $v_{12} = v_1$ v_2 the relative velocity of two particles, $b_{12} = v_{12} = v_{12} = v_{12}$ a unit vector, $v_{12} = jv_{12}j$ and the integration with respect to db is the angular integration over the solid angle.

We consider spherically symmetric initial conditions $f_1(v;0)$, v = jvj. This symmetry property is propagated by the dynamics. The Boltzmann equation (2) then takes the form

Equation (3) is a nonlinear hom ogeneous integral equation for the distribution function f_1 (v;t). A simplication arises if the initial velocity distribution has a discrete modulus spectrum. This spectrum is preserved by the annihilation dynamics as no new velocities are created. A simple case is provided by the bim odal distribution

where $c_2 > c_1 = 0$ and A denotes the fraction of particles with velocity modulus q.

Before addressing the general case, we rst consider the single-species problem where $c_2 = c_1 > 0$.

A. Single-velocity m odulus distribution

Setting $c_2 = c_1 = c > 0$ in Eq. (4), one obtains from Eq. (1)

where $n(0) = n_0 \cdot A$ striking observation is that, in the lim it t ! 1, the density (7) becomes independent of its initial value $n_0 \cdot N$ one that the same phenomenon is also present for simple direction limited annihilation such as A + A ! 0, when the dimension of the system is larger than 2 [16].

C ontrary to the one-dimensional case for which it has been rigorously shown that the density decays proportionally to t¹⁼² [L], one sees from Eq. (7) that in three dimensions, Boltzm ann's dynam ics is faster as the density decays according to t¹, which is the mean-eld value [4]. We note, however, that the same behavior n (t) / 1=t holds in all dimensions within Boltzm ann's kinetic theory (and in fact, more generally within the framework of a scaling analysis of the hierarchy governing the dynam ics of ballistic annihilation [14]). This discrepancy between Boltzm ann's prediction and the exact result in one dimension illustrates the crucial importance of dynam ical correlations when d = 1. On the other hand, as suggested in Ref. [14] and explicitly shown below by molecular dynam ics simulations, the nonlinear Boltzm ann equation is relevant for describing the long-time dynam ics of ballistic annihilation when d 2. In this case the particles are very diluted and no dynam ical correlations can develop during the time evolution, which would violate the molecular chaos hypothesis.

B. M ixture of particles with two nonzero velocity m oduli

Consider the case where particles with velocities $c_1 > 0$ and $c_2 > c_1$ are initially present. Thus $f_1(v;t)$ is of the form

where X (t) and Y (t) are, respectively, the densities of particles with velocities c_1 and c_2 . They add up to the total density X (t) + Y (t) = n (t). Upon rescaling the time according to = tq 2 =3, it follows from Eq. (3) that

where $0 = q = c_2 < 1$, and the overdot denotes time derivative with respect to .

The set of equations (9) is a nonlinear hom ogeneous system of coupled di erential equations with constant coe - cients. An implicit solution can be obtained by introducing the function V () de ned as V () = Y ()=X (). From Eq. (9) we get

Multiplying the right-hand side (RHS) of Eq. (13a) by X $_0$ and equating it with the derivative of the RHS of Eq. (12), one obtains upon integration from 0 to the relation

Equation (14) implicitly de nes the time dependence of the function V(). The procedure to obtain the densities X() and Y() from Eq. (14) is as follows. The integration in Eq. (14) leads to Appel functions, that may be inverted (at least num erically) in order to give V(). The insertion of V() in Eq. (12) then gives X(). It is then straightforward to obtain Y(), having determ ined V() and X(). The structure of the implicit relation (14) perm its us to establish interesting analytical results.

First, let us investigate the long time behavior of the particle densities X () and Y (). When ! 1, the LHS of Eq. (14) diverges linearly which implies that $\lim_{t \to 1} V() = 0$. So, in the long-time limit, the implicit relation (14) leads to the asymptotic form ula

Note that the exponent for the density Y () is a function of the ratio $= q = c_2$ and thus is nonuniversal. In the limit

! 1 one recovers the asymptotic behavior of the single-velocity modulus distribution (see Sect. IIIA).

Second, we may nd analytical upper and lower bounds for X () and Y (). Granted that > 0 and > 0, the integrand of Eq. (14) is a strictly monotonic decreasing positive function of u, therefore V () < V_0 for all > 0. Considering that (4)¹ [4 + (3 + ²)u]¹ for u 0, the insertion of Eq. (12) in Eq. (14) provides the inequality X₀ (X₀=X 1)=4, which leads to an upper bound for X (). On the other hand, the inequality (4 + (3 + ²)u)¹ [4 + (3 + ²)V₀]¹ yields a lower bound, so that we nally get




FIG.1: Upper and low er bounds (20) (dotted lines) as well as the num erical solution of the set of equations (9) for X () with $X_0 = Y_0$, = 0.2 (continuous line). The inner logarithm ic plot shows indeed the power law behavior X () ¹ for ! 1, where the asymptotic solution (17) is represented by the dashed straight line. Moreover, in this regime the solution converges to the upper bound (20).




FIG.2: Upper bound (22) (dashed lines) as well as the num erical solution of the set of equations (9) for Y () with $X_0 = Y_0$, = 0.2 (continuous line). The inner logarithm ic plot of the num erical solution shows indeed the power law behavior Y ()

The width de ned by the di erence of the bounds in both cases (20) and (22) is 0 1 . Figures 1 and 2 show the num erical solution for X (), Y (), the bounds (20) and (22), as well as their asymptotic behaviors (17) and (19) on a logarithm ic scale.

The know ledge of the num erical solution (see Figs. 1 and 2) allows to determ ine the crossover time, separating the early and long-time (power law) regimes.

C. M ixture of m oving and m otion less particles

We now consider a particular case of Sec. IIIB that we solve exactly in the asymptotic limit ! 1. The system is now characterized by a certain number of motionless particles (zero velocity, $c_1 = 0$) whereas the rest of the particles have a given nonzero velocity modulus. Thus, setting = 0 in Eq. (12), inverting the relation in order to nd V = V (X), then making use of Eq. (13a) with = 0 leads to

(3+2)=4 for ! 1, where the asymptotic solution (19) is represented by the dashed straight. Furtherm ore, the use of both the upper bound (17) and the asymptotic form (19) allows to nd an analytical approximation for Y (), which turns out to be exact in both limits ! 0 and ! 1.

The integration of Eq. (23) yields

For ! 1, all terms on the RHS of Eq. (24) but the logarithm ic one approach a nite limit. This im plies the asymptotic behavior




FIG. 3: Linear-logarithm ic plot of the num erical solution of the set of equations (9) for $X_0 = Y_0$, = 0 (continuous lines). The asymptotic relations (26) and (28) are shown by the dashed lines, and the asymptotic limit (25) by the dotted line.

There is a qualitative di erence from the case $c_1 > 0$. As shown in Fig. 3, the density of particles at rest approaches the asymptotic value $X_1 > 0$ exponentially fast, while the density of moving particles goes to zero exponentially. Table I sum marizes the long-time behavior for the di erent cases.

Note that generalizing our results to any dimension d 2 is straightforward (see below for the case d = 2). The algebraic or exponential decay of the particle densities hold irrespective of d. In particular, for the general case $c_1 > 0$ the exponent of the density of \slow " particles is independent of d so that X () ^{! 1} ¹. Finally the relation (29) still holds.

IV. COMPARISON W ITH NUMERICAL SIMULATIONS

The analytical predictions obtained in the preceding section rely on the validity of the m olecular chaos assumption, leading to the Boltzm ann equation. It is therefore instructive to compare these predictions to the results of m olecular dynam ics (M D) simulations, where the exact equations of m otion of the particles are integrated (see R ef. [14] form ore details concerning the m ethod).

A. A nalytical results in two dim ensions

M D simulations are most e ciently performed in two dimensions, where the best statistical accuracy can be achieved. We consequently repeat the analysis of Secs. II and III for a two-dimensional system. Introducing the rescaled time = 2 gt, one obtains the counterpart of Eqs. (9) in the form

B. M olecular dynam ics sim ulations

M D simulations have been implemented with systems of typically $N = 10^5$ to $4 - 10^5$ spheres in two dimensions (discs). Periodic boundary conditions were enforced, and low densities considered, in order to m inimize the excluded volume e ects discarded at the Boltzm ann level (note that these e ects are necessarily transient since the density decreases with time).




FIG.4: Log-log plot of the densities X (upper curve) and Y (lower curve) as a function of rescaled time, as obtained in the MD simulations of a two-dimensional system with = 0.1. The initial condition corresponds to an equim olar mixture (X₀ = Y₀) of N = 2 10⁵ particles, with reduced density (X₀ + Y₀)² = 0.1 at = 0 (both species have the same diameter). The dashed lines have slopes 1 and 7:9 [as predicted by Eqs. (31)]. Inset: log-log plot of Y as a function of X, where the broken line has slope 7:9.

Figure 4 compares the MD results obtained with = 1=10 to the predictions of Eqs. (31) (for = 1=10, the time decay of the \fast" particles is governed by the exponent =4 ' 7:9). A lthough the large-time behaviors for X and Y are compatible with those given by Eqs. (31), it may be observed that the corresponding asymptotic regime is di cult to probe, even for large system s. The parametric plot [or \trajectory" Y (X)] shown in the inset is however in agreement with the relation Y / X ⁼⁴ deduced from Eq. (31).




FIG.5: Linear-logarithm ic plot of the density of moving particles. Here, $= 0, X_0 = Y_0 = 5$ 10³ = ² [corresponding to a very low total initial packing fraction ₀ (X₀ + Y₀)²=4 = 0:0078]. The initial number of particles is N = 4 10⁵. The results of M D simulations (continuous curve) are compared to the predictions of Eqs. (32), shown by the broken line. The inset shows that X X₁ and Y (obtained in M D) have asymptotically the same time decay [see Eqs. (32)].

We have also performed MD simulations for a mixture of moving and motionless particles (= 0), where it is expected that the density X of particles at rest decreases down to a nonvanishing value X_1 . In the situation of an equim olar mixture ($X_0 = Y_0$), we have $V_0 = 1$ so that according to Eq. (33), $X_1 = X_0'$ 0.414. The MD simulations are in agreement with this scenario, and we nd $X_1 = X_0'$ 0.408 irrespective of the initial conditions for a system with initially N = 2 10⁶ particles. The results for the time dependence of X and Y are displayed in Fig. 5. We conclude that the num erical simulations are again in agreement with the prediction of Boltzm ann's kinetic theory.

V. CONCLUSIONS

We have shown that for some simple spatially hom ogeneous systems, characterized by a velocity distribution with a discrete velocity modulus spectrum, it is possible to nd the exact solution for the nonlinear integral equation describing the dynamics of ballistic annihilation. These results, obtained at the level of a Boltzm ann equation, have been validated by explicit comparison with molecular dynamics simulations in two dimensions.

For a single-velocity m odulus distribution, the particle density of the m odel decays asymptotically as $n(t) = t^{1}$, irrespective of space dimension. It was however rigorously shown that in one dimension, the decay is slower, $n(t) = t^{1-2}$. This dimension is a consequence of the fact that in one dimension strong dynam ical correlations are created [6], which invalidate the approximation underlying Boltzm ann's dynam ics. In higher dimensions, the Boltzm ann equation become sexact in the long-time limit.

In the case of a distribution with two di erent nite nonzero velocity moduli, we found that both particle densities decay for a large time according to a power law. The interesting feature is that the density of the slow particles decays as t⁻¹, while the density of the fast particles decays more rapidly (e.g., as t⁻²)⁻⁴ in three dimensions), with a nonuniversal exponent depending continuously on the velocity modulus ratio = $q = c_2$. A rough criterion for the crossover time separating the short- and long-time regimes has been given in Eq. (21).

F inally, the case $c_1 = 0$ leads to a particularly interesting behavior. Independently of the initial conditions, the densities of the moving and the motionless particles both decrease exponentially fast; however down to a nonzero

value for particles at rest. This behavior is quite di erent from that observed in the one-dimensional case where the initial value of the density of motionless particles plays an important role in the long-time regime. This di erence between one dimension and higher dimensions rejects once again the important role played by the dynam ically created correlations for d = 1.

The case with motionless particles can be viewed as a problem of ballistic annihilation of particles with one-velocity modulim oving in a random medium containing in mobile traps (the motionless particles) that can capture a moving particle and then disappear. Here again, the situation can be compared to similar problems in di usion limited annihilation where the presence of traps can modify the long-time dynamics from a power law to an exponential decay [17].

It would be interesting to compare the above theoretical predictions with some experimental data. Besides grow the and coarsening problems, ballistic annihilation could model other physical systems such as, for example, the uorescence of laser excited gas atoms with quenching on contact [18]. However, the correspondence between such experimental situations and our model is not yet close enough to allow comparison. We would be highly interested in the know ledge of other physical systems that could be described by the models studied here.
