# Som e exact results for Boltzm ann's annihilation dynam ics

#### Abstract

T he problem ofballistic annihilation for a spatially hom ogeneous system is revisited within Boltz$m$ ann's kinetic theory in two and three dim ensions. A nalytical results are derived for the tim e evolution of the particle density for som e isotropic discrete bim odal velocity m odulus distributions. A ccording to the allow ed values of the velocity m odulus, di erent behaviors are obtained: pow er law decay w ith non-universal exponents depending continuously upon the ratio of the two velocities, or exponential decay. W hen one of the tw o velocities is equal to zero, the m odel describes the problem of ballistic annihilation in presence of static traps. The analytical predictions are show $n$ to be in agreem ent w ith the results of tw o-dim ensional molecular dynam ics sim ulations.


## I. INTRODUCTION

In ballistically controlled reactions, particles $w$ ith a given initial velocity distribution $m$ ove freely (ballistic $m$ otion) in a d-dim ensional space. W hen tw o of them $m$ eet, they annihilate and disappear from the system. This apparently sim ple problem has attracted a lot of attention during the past years $\left[\begin{array}{ll}1 \\ 1\end{array}\right.$, the follow ing reasons. $F$ irst, this is one of the few problem s of nonequilibrium statistical physics that can be exactly solved in som e cases, and second it m odels som e grow th and coarsen ing processes [1] $\left.{ }^{-1}{ }^{1}\right]$.

This eld was entered w ith the pioneering work by Elskens and Frisch ${ }^{1} 1$, where a one-dim ensional system w ith only two possible velocities + c or c was studied. U sing com binatorial analysis, they showed that the density of particles was decreasing according to a power law ( $t^{1=2}$ ) in the case of a sym m_etric in itial velocity distribution. The investigation of this one-dim ensional problem was generalized by D roz et al. [G] $\overline{[1]}$ to the three-velocity case where the initial velocity distribution is given by ${ }^{\prime}(v ; 0)=p_{+} \quad(v \quad c)+p(v)+p \quad(v+c) w$ ith $p_{-}=p \quad$ (symmetric case) and $p_{+}+p_{0}+p=1$. It tums out that the decay of the particle density depends on the details of the in itial velocity distribution. The follow ing analytical results w ere obtained. For $p_{0}<1=4$, the density $n(v ; t)$ of particles $w$ ith velocity $v=f 0 ;+c ; \quad c g$, behaves in the long-time lim it as $n(0 ; t) \quad t^{1} ; n(c ; t) \quad t^{1=2} . W$ hen $p_{0}=1=4$, $\mathrm{n}(0 ; \mathrm{t}) \mathrm{n}(\mathrm{c} ; \mathrm{t}) \quad \mathrm{t}^{2=3}$. Finally, for $\mathrm{p}_{0}>1=4$, one nds that $\mathrm{n}(0 ; \mathrm{t})$ saturates to a nonzero stationary value, while n ( $\mathrm{c} ; \mathrm{t}$ ) decays faster than a pow er law. M oreover, it w as show n that in one dim ension, annihilation dynam ics creates strong correlations betw een the velocities of colliding particles, which excludes a B oltzm ann-like approxim ation. P airs of nearest neighbor particles have the tendency to align their velocities and propagate in the sam e direction [ $[\bar{G}]$.

A $n$ analyticalinvestigation of the one-dim ensionalcase $w$ ith a continuous velocity distribution ism uch m ore di cult. A dynam ical scaling theory, whose validity was supported by extensive num erical sim ulations for several velocity distributions, led R ey et al. [1] 1 to the con jecture that all the continuous velocity distributions' (v) that are sym $m$ etric, regular and, such that '(0) 0 are attracted in the long-tim e regim e tow ards the sam e $G$ aussian-like distribution and thus belong to the sam e univensality class.

For higher dim ensions, $m$ ost of the studies are based on an uncontrolled B oltzm ann-like description $\left[\begin{array}{l}\overline{2} \\ \hline\end{array}\right.$ num erical sim ulations [12]. H ow ever, based on phenom enologicalm ean-eld-like argum ents, K rapivsky et al. have studied the annihilation kinem atics of a bim odal velocity modulus distribution in $d>2$ dim ensions [iti]. In the case of a $m$ ixture of $m$ oving and $m$ otionless particles they showed that the stationary particles alw ays persist, while the density ofm oving particles decays exponentially. This approach contains unknown phenom enologicalparam eters, and thus a com plete com parison $w$ ith the results obtained by num erical sim ulation is not possible.

In a recent paper, P iaseckiet al. [1] ] gave an analyticalderivation of the hierarchy equations obeyed by the reduced distributions for the annihilation dynam ics. In dim ension $d>1$ for a spatially hom ogeneous system, and in the $\lim$ it (the so-called G rad lim it) for which the particle diam eter ! 0 , and the particle density $n$ ( $t$ )! 1 such that $n(t){ }^{d}{ }^{1}=1$, where is the $m$ ean free path, the hierarchy reduces to the B oltzm ann-like hierarchy. T his hierarchy propagates the factorization of the reduced $k$-particle distribution in term sofone-particle distribution functions. Thus, if the initial state is factorized, the whole hierarchy reduces to one nonlinear equation for the one-particle B oltzm ann distribution. For annihilation kinetics, the ratio of particle diam eter to $m$ ean free path vanishes in the long-tim elim it and the situation becom es sim ilar to the $G$ rad $\lim$ it discussed above for ! $1 . T$ hus the long-tim e lim it of the annihilation dynam ics (for $d>1$ ) is likely to be adequately described by the nonlinear Boltzm ann equation.

A scaling analysis of the nonlinear B oltzm ann equation led to analyticalexpressions for the exponents describing the decay of the particle density and of the root-m ean-square velocity in the case of continuous velocity distributions [141].

In view of the di erent behaviors observed in one dim ension for discrete or continuous velocity distributions, it is
relevant to study the case of distributions with discrete $m$ odulus spectrum in dim ensions higher than 1. The goal of this paper is to investigate sim ple exam ples of this kind in three dim ensions for which the non linear Boltzm ann equation derived in $R$ ef. [14] can be exactly solved. The generalization of this approach to an arbitrary dim ension is straightforw ard, and for the sake of com parison w ith num ericalsim ulations, we shallalso consider the tw o-dim ensional situation in som e detail.

The validity of the Boltzm ann description in the long-tim e lim it will be con m ed by com paring our analytical predictions w th the results obtained by a m olecular dynam ics sim ulation.

The paper is organized as follow s. In Sect. II we de ne the m odel. In Sect. 'ITI', the three-dim ensional B oltzm ann equation is solved analytically for a two velocity modulus ( $c_{1}$ and $c_{2}$ ) isotropic distribution. For sim plicity we rst consider the one velocity $m$ odel $c_{1}=c_{2}>0$ that allow $s$ to draw interesting com parisons $w$ th the sam e $m$ odel in one dim ension. Then the implicit solution for the particle densities in the general case $c_{1}>c_{2}>0$ is established. It is show $n$ analytically that in the long-tim e lim it the particle densities decay according to power law s , w ith exponents depending continuously on the value of the velocity m odulus ratio. We also nd upper and lower bounds to the particle densities that are com pared w th the num erical solution of the dynam ical equation. The particular case of a $m$ ixture of $m$ oving ( $c_{2}>0$ ) and $m$ otionless ( $c_{1}=0$ ) particles is also investigated. It tums out that the particle densities decay exponentially to zero for the $m$ oving particles, and to a nonzero value for the $m$ otionless ones. $T$ his phenom enology is independent of space dim ension, and in Sect. 'iv- ${ }_{-}^{\prime}$, it $w$ ill be shown explicitly to hold in two dim ensions by im plem enting $m$ olecular dynam ics sim ulations. T his num ericalm ethod has the advantage ofbeing free of the approxim ations underlying Boltzm ann's dynam ics and, therefore, provides an interesting test for the analytical predictions. Section N', contains our interpretations and conclusions.

## II. THEMODEL

W e consider a system $m$ ade of spheres ofdiam eter $m$ oving ballistically in three-dim ensionalspace. Iftw o particles touch each other, they annihilate and thus disappear from the system. W e consider only twobody collisions. The initial spatial distribution of particles is supposed to be uniform, therefore it rem ains uniform during the evolution. Indeed, if the state is initially translationally invariant, then the free evolution preserves this sym m etry. A nninilation dynam ics adds the e ect of binary collisions that depends only on the distance betw een particles, thus preserving the translational invariance. Finally, existing num erical sim ulations seem to be com patible w ith this assum ption of hom ogeneity $\left[1 \overline{1}_{1}^{1}\right]$. W e are interested in the tim e evolution of the num ber density of particles with a given velocity m odulus.

Let $f_{1}(v ; t)$ be the distribution function of the density ofparticles in $R^{3} w$ ith velocity $v 2 R^{3}$ at tim et. For spatially hom ogeneous states, the distribution function has the form

where' $(v ; t)$ is the velocity probability density. In the long-time lim it, $P$ iasecki et al $\left.{ }^{[11} \underline{1}_{1}^{-1}\right]$ have shown that the hierarchy satis ed by the reduced distributions approached the Boltzm ann hierarchy. If the in itial state is factorized, the nonlinear Boltzm ann equation provides then the com plete description of annihilation dynam ics,

$H$ ere is the $H$ eaviside function, $v_{12}=v_{1} \quad v_{2}$ the relative velocity of two particles, $\delta_{12}=v_{12}=v_{12}$ a unit vector, $v_{12}=j_{12} j$ and the integration $w i t h$ respect to $d b$ is the angular integration over the solid angle.
$W$ e consider spherically sym $m$ etric in itial conditions $f_{1}(v ; 0), v=j j$. This sym $m$ etry property is propagated by the dynam ics. The Boltzm ann equation $\overline{(\underline{1})}$ ) then takes the form

Equation $(\overline{3} \overline{-1})$ is a nonlinear hom ogeneous integralequation for the distribution function $f_{1}(v ; t)$. A simpli cation arises if the initial velocity distribution has a discrete m odulus spectrum. This spectrum is preserved by the anninilation dynam ics as no new velocities are created. A sim ple case is provided by the bim odal distribution

where $C_{2}>C_{1} \quad 0$ and $A$ denotes the fraction of particles $w$ th velocity $m$ odulus $q$.

## III. EXACT RESULTS

Before addressing the general case, we rst consider the single-species problem where $c_{2}=c_{1}>0$.

> A. S ingle-velocity m odulus distribution

where $n(0)=n_{0}$. A striking observation is that, in the lim 止t! 1 , the density $\left(\bar{T}_{1}\right)$ becom es independent of its in itial value $n_{0}$. N ote that the sam e phenom enon is also present for simple di usion lim i्ted annihilation such as A $+A!0$, when the dim ension of the system is larger than 2 [1] $\left.{ }^{[ }\right]$.

C ontrary to the one-dim ensional case for which it has been rigorously show $n$ that the density decays proportionally
 according to $t^{1}$, which is the $m$ ean-eld value "4.'. W e note, how ever, that the sam e behavior $n$ ( $t$ ) / $1=t$ holds in all dim ensions w thin Boltzm ann's kinetic theory (and in fact, m ore generally w thin the fram ew ork of a scaling analysis of the hierarchy goveming the dynam ics of ballistic annihilation [14']). This discrepancy betw een Bollm ann's prediction and the exact result in one dim ension illustrates the crucial im portance of dynam ical correlations when $d=1.0 n$ the other hand, as suggested in Ref. [12'] and explicitly show $n$ below by molecular dynam ics sim ulations, the nonlinear Boltzm ann equation is relevant for describing the long-tim e dynam ics of ballistic annihilation when d 2. In this case the particles are very dihuted and no dynam icalcorrelations can develop during the tim e evolution, which would violate the $m$ olecular chaos hypothesis.
B. $M$ ixture of particles $w$ ith tw o non zero velocity m oduli
$C$ onsider the case where particles with velocities $c_{1}>0$ and $c_{2}>c_{1}$ are initially present. Thus $f_{1}(v ; t)$ is of the form

The set of equations ( $\left(\underline{1}_{1}\right.$ ) is a nonlinear hom ogeneous system of coupled di erential equations w ith constant coe cients. An implicit solution can be obtained by introducing the function $V()$ de ned as $V()=Y()=X()$. From Eq. $\left.(\underline{\underline{9}})_{1}\right)$ we get

Equation (14-1) im plicitly de nes the tim e dependence of the function $V()$. The procedure to obtain the densities X ( ) and $Y()$ from Eq. (14) is as follow s . The integration in Eq. (14) leads to A ppel functions, that $m$ ay be inverted (at least num erically) in order to give $V()$. The insertion of ( ) in Eq. (12 ) then gives X ( ) . It is then straightforw ard to obtain $Y()$, having determ ined $V()$ and $X()$. The structure of the im plicit relation $n^{\prime \prime}\left(l_{1}^{1} 4\right)$ perm its us to establish interesting analytical results.

First, let us investigate the long tim e behavior of the particle densities $X()$ and $Y() . W$ hen ! 1 , the LH $S$ of

$N$ ote that the exponent for the density $Y()$ is a function of the ratio $=\Phi=C_{2}$ and thus is nonuniversal. In the lim it ! 1 one recovers the asym ptotic behavior of the single-velocity $m$ odulus distribution (see Sect.'IIIAI).

Second, we may nd analytical upper and lower bounds for X ( ) and Y ( ). Granted that > 0 and $>0$, the integrand of Eq. (14) is a strictly monotonic decreasing positive function of $u$, therefore $V()<V_{0}$ for all

W e now consider a particular case of Sec. 'IIIB' that we solve exactly in the asym ptotic lim it ! 1 . The system is now characterized by a certain num ber ofm otionless particles (zero velocity, $c_{1}=0$ ) whereas the rest of the particles have a given nonzero velocity moduhus. Thus, setting $=0$ in Eq. (12 $\left.\mathbf{1}_{2}\right)$, inverting the relation in order to nd $\mathrm{V}=\mathrm{V}(\mathrm{X})$, then m aking use of Eq . (İ3a) w th $=0$ leads to

Furtherm ore, the use ofboth the upper bound ( $1-1$ ) and the asym ptotic form (191) allows to nd an analytical approxim ation for $Y$ ( ), which tums out to be exact in both lim iss ! 0 and ! 1 .

$T$ here is a qualitative di erence from the case $c_{1}>0$. A s show $n$ in $F$ ig. $\overline{3}$, 1, the density of particles at rest approaches the asym ptotic value $X_{1}>0$ exponentially fast, while the density of $m$ oving particles goes to zero exponentially. $T$ able
$N$ ote that generalizing our results to any dim ension $d \quad 2$ is straightforw ard (see below for the case $d=2$ ). The algebraic or exponentialdecay of the particle densities hold irrespective ofd. In particular, for the generalcase $c_{1}>0$ the exponent of the density of \slow " particles is independent of $d$ so that $X()^{1}{ }^{1}$. Finally the relation (2"d) still holds.

## IV. COM PARISON W ITH NUMERICALSIMULATIONS

T he analyticalpredictions obtained in the preceding section rely on the validity of the m olecular chaos assum ption, leading to the B oltzm ann equation. It is therefore instructive to com pare these predictions to the results ofm olecular dynam ics (MD) sim ulations, where the exact equations ofm otion of the particles are integrated (see Ref. [14] form ore details conceming the $m$ ethod).

## A. A nalytical results in two dim ensions

MD sim ulations are most e ciently perform ed in two dim ensions, where the best statistical accuracy can be achieved. W e consequently repeat the analysis of Secs. II and IIIF for a two-dim ensional system. Introducing the rescaled time $=2 \varepsilon t$, one obtains the countenpart of Eqs. $(\underset{1}{(\underline{9})})^{-}$in the form

B. M olecular dynam ics sim ulations

M D sim ulations have been im plem ented with system sof typically $N=10^{5}$ to $4 \quad 10^{5}$ spheres in two dim ensions (discs). P eriodic boundary conditions w ere en forced, and low densities considered, in order to $m$ in im ize the exchuded volum e e ects discarded at the Boltzm ann level (note that these e ects are necessarily transient since the density decreases with tim e).

Figure ' $\overline{4}$ ' 1 com pares the M D results obtained w ith $=1=10$ to the predictions of Eqs. $\left(3 \bar{n}_{1}^{1}\right)$ (for $=1=10$, the tim e decay of the \fast" particles is govemed by the exponent $=4,7: 9$ ). A lthough the large-tim e behavions for X and $Y$ are com patible w ith those given by Eqs. (3 $\mathbf{3 I}_{1}^{\prime}$ ), it $m$ ay be observed that the corresponding asym ptotic regim e is di cult to probe, even for large system $s$. The param etric plot [or \tra jectory" $Y(X)$ ] show $n$ in the inset is how ever in agreem ent $w$ th the relation $Y / X{ }^{=4}$ deduced from Eq. (311).
$W$ e have also perform ed MD simulations for a $m$ ixture of $m$ oving and $m$ otionless particles ( $=0$ ), where it is expected that the density $X$ of particles at rest decreases dow $n$ to a nonvanishing value $X_{1}$. In the situation of an equim olarm ixture ( $X_{0}=Y_{0}$ ), we have $V_{0}=1$ so that according to Eq. ( 3 Jin), $X_{1}=X_{0}{ }^{\prime} 0: 414$. The M $D$ sim ulations are in agreem ent with this scenario, and we nd $X_{1}=X_{0}{ }^{\prime} \quad 0: 408$ irrespective of the initial conditions for a system $w$ ith initially $N=2 \quad 10^{5}$ particles. The results for the tim e dependence of $X$ and $Y$ are displayed in $F$ ig. ${ }^{\prime} \mathrm{I}_{1}$.. W W conclude that the num erical sim ulations are again in agreem ent with the prediction of B oltzm ann's kinetic theory.

## V. CONCLUSIONS

W e have shown that for som e sim ple spatially hom ogeneous system s , characterized by a velocity distribution w ith a discrete velocity m odulus spectrum, it is possible to nd the exact solution for the nonlinear integral equation describing the dynam ics of ballistic annihilation. T hese results, obtained at the level of a B oltzm ann equation, have been validated by explicit com parison with molecular dynam ics sim ulations in two dim ensions.

For a single-velocity m odulus distribution, the particle density of the m odel decays asym ptotically as $n(t) \quad t^{1}$, irrespective of space dim ension. It w as how ever rigorously show $n$ that in one dim ension, the decay is slow er, $n$ ( $t$ ) $t^{1=2}$. This di erence is a consequence of the fact that in one dim ension strong dynam ical correlations are created [佔], which invalidate the approxim ation underlying B oltzm ann's dynam ics. In higher dim ensions, the B oltzm ann equation becom es exact in the long-tim e lim it.

In the case of a distribution $w$ ith tw o di erent nite nonzero velocity $m$ oduli, we found that both particle densities decay for a large tim e according to a pow er law. T he interesting feature is that the density of the slow particles decays ast ${ }^{1}$, while the density of the fast particles decays m ore rapidly (e.g., ast ${ }^{\left(3+{ }^{2}\right)=4}$ in three dim ensions), with a nonuniversal exponent depending continuously on the velocity $m$ odulus ratio $=q_{1}=c_{2}$. A rough criterion for the crossover tim e separating the short-and long-tim e regim es has been given in Eq. (211).
$F$ inally, the case $c_{1}=0$ leads to a particularly interesting behavior. Independently of the initial conditions, the densities of the $m$ oving and the $m$ otionless particles both decrease exponentially fast; how ever dow $n$ to a nonzero

value for particles at rest. This behavior is quite di erent from that observed in the one-dim ensional case where the intial value of the density of $m$ otionless particles plays an im portant role in the long-tim e regim e. This di erence betw een one dim ension and higher dim ensions re ects once again the im portant role played by the dynam ically created correlations for $\mathrm{d}=1$.

T he case w ith $m$ otionless particles can be view ed as a problem ofballistic annihilation of particles with one-velocity $m$ odulim oving in a random $m$ edium containing im $m$ obile traps (the $m$ otionless particles) that can capture a $m$ oving particle and then disappear. H ere again, the situation can be com pared to sim ilar problem s in di usion lim ited annihilation where the presence of traps can modify the long-tim e dynam ics from a power law to an exponential decay $\overline{11} \bar{I}_{1}^{\prime}$.

It w ould be interesting to com pare the above theoretical predictions w ith som e experim ental data. B esides grow th and coarsening problem $s$, ballistic annihilation could model other physical system $s$ such as, for exam ple, the uorescence of laser excited gas atom $s$ w ith quenching on contact [1\$]. H ow ever, the correspondence betw een such experim ental situations and our m odel is not yet close enough to allow com parison. W e would be highly interested in the know ledge of other physical system s that could be described by the $m$ odels studied here.
