# A logarithm ic contribution to the density of states of rectangular A ndreev billiards

#### Abstract

W e dem onstrate that the exact quantum mechanical calculations are in good agreem ent with the sem iclassical predictions for rectangular A ndreev billiards and therefore for a large num ber of open channels it is su cient to investigate the Bohr-Som m erfeld approxim ation of the density of states. W e present exact calculations of the classical path length distribution $P$ ( $s$ ) which is a nondi erentiable function of $s$, but whose integral is a sm ooth function $w$ ith logarithm ically dependent asym ptotic behavior. C onsequently, the density of states of rectangular A ndreev billiards has tw o contributions on the scale of the $T$ houless energy: one which is well-known and it is proportional to the energy, and the other which shows a logarithm ic energy dependence. It is shown that the prefactors of both contributions depend on the geom etry of the billiards but they have universal lim iting values when the w idth of the superconductor tends to zero.

W hen a norm al-m etallic dot is placed in contact w ith a superconductor, the low -energy density of states $n(\mathbb{E})$ of the resulting A ndreev billiard is strongly m odi ed com pared with the nom al state $[\overline{1}]$. The energy dependence ofn $(E)$ is highly non-trivial and provides a testing ground for current understanding of proxim ty e ects of hybrid superconducting nanostructures and for theoreticaltools such as sem iclassicaltheory. Recently a num ber of con icting results have been obtained for the density of states ( $\mathrm{D} O$ S ) of ballistic A ndreev billiards (AB). O ne exam ple is show $n$ in gure 1, which in the separable lim it $\mathrm{W}=\mathrm{a}$ was studied long ago in [1] 1 , where it w as found that for sm all $\mathrm{E}, \mathrm{n}(\mathrm{E})$ is proportional to E . In contrast for $W$ _ $a_{2}$, the problem has only recently been studied
 where is a universal constant, independent of $E$ and W . In contrast [ili] predicted di erent values for .

In this paper we resolve this discrepancy by show ing that neither of these results is strictly correct in the lim it E ! 0 and instead predict that $\mathrm{n}(\mathrm{E})$ diverges logarithm ically. This generic logarithm ic contribution is signi cant for energies less than or of order the $T$ houless energy.

To address this problem, we use both exact and sem iclassical techniques to analyze the AB of gure 1. The exact calculation starts $w$ th a ballistic tw o dim ensional norm al dot of area A, described by a scattering $m$ atrix $S_{0}(E)$ and $w$ ith a $m$ ean levelspacing for the isolated norm al system $=\frac{2 \tilde{\sim}^{2}}{\mathrm{~mA}}$ at the Ferm i energy $\mathrm{E}_{\mathrm{F}}$. Then, a superconductor of $w$ idth $W$ and bulk order param eter is placed in contact w th such a billiard. The num ber of open channels in the $S$ region is the integer part of $M=\frac{k_{F} W}{}$, and the energy levels of AB are the positive eigenvalues $E$ ( $m$ easured from the Ferm i energy) of the B ogoliubov-de $G$ ennes equation $\bar{\eta} \overline{1} 1$. A secular equation of the exact energy levels of $A B$, in term $s$ of the
scattering $m$ atrix $S_{0}(E)$ of the norm al region, is derived by $m$ atching the $w$ ave functions at the interface of the norm al-superconductor $(\mathbb{N}-S)$ system s . The energy levels are exact in the sense that no A ndreev approxim ation ( =E $\quad 1$ and quasi-particles whose incident/re ected directions are approxim ately perpendicular to the $\mathrm{N}-\mathrm{S}$ interface) [id $[$ is assum ed.

W e also give the sem iclassical Bohr-Som merfeld approxim ation of the density of states (DOS) n(E) expressed by the classical retum probability $P$ ( $s$ ) of the electron. O ur exact and sem iclassical calculations are applied to the integrable A B shown in F ig. ${ }^{\prime} 11.1$. W e dem onstrate that the integrated D O S agrees very well w ith the exact calculations. $W$ e nd that the integral of the retum probability $P(s)$ has a contribution depending on s logarithm ically in the asym ptotic lim it, $s$ ! 1 , which has to-date been overlooked. A s a consequence, the sm all energy dependence of the DOS n (E) has also a logarithm ic factor in addition to a contribution which depends linearly on the energy $E$ as predicted in Ref.

In our earlier work $\left.\overline{5}_{1}^{1}\right]$ we found that the exact energy levels of AB w ith arbitrary shape of nom al region are the solutions of the follow ing secular equation:

$=\mathrm{p}$. It is assum ed that the Ferm i wavenum ber, $\mathrm{k}_{\mathrm{F}}=\overline{2 m \mathrm{E}_{\mathrm{F}}=\sim^{2}}$ is the same in the S and N regions. All the $m$ atrioes are $M$ by $M$ dimensional. All the inform ation on the nom al region are incorporated in the $m$ atrix $G$ via the scattering $m$ atrix $S_{0}(E)$. N ote that the secular equation ( 1 - ${ }^{-1}$ ) is an extension of that derived for box and disk geom etries in Ref. 1 G.

The density of states in the sem iclassical BohrSom $m$ erfeld approxim ation is w ritten as $[\underline{1}$

d. In that case, the energy dependent phase shiff $\arccos (\mathrm{E}=)$, due to A ndreev re ections, w as approxim ated by $=2$. H ow ever, our expression is valid $w$ thout such an approxim ation, and essentially im proves the agreem ent betw een the exact and the Bohr-Som m erfeld approxim ation of the DOS (see also Ref. 'riti).

where $F$ ( $s$ ) is the integrated distribution fiunction of the retum probability of the electron. N ote that $P(s)$ is nor$m$ alized to one, i.e., $F(1)=1$.

To obtain the exact energy levels of the AB shown in $F$ ig. $\overline{1}_{1}^{1}$, we need to calculate the scattering $m$ atrix $S_{0}(E)$ of the $N$ region. Follow ing the sam e approach
as M ortensen and co-w orkers [1]

Here X is a diagonal m atrix w th elements $\mathrm{X}_{\mathrm{mn}}=$ $m_{n} \exp \left(i k_{n} d\right), Q=\frac{\circ}{\circ} \%$, and $\%$ is a $\left.k_{F} W=\right]$ by $\mathbb{k}_{F} a=$ ] dim ension $m$ atrix $w$ ith elem ents given by the overlap integrals de ned in $R$ ef. $10-101]$ ([:] stands for the integerpart). N otice that if $\mathrm{W}=$ a then $\%=1$ and the scattering m atrix $S_{0}(E)=X^{2}$ is a diagonalm atrix. In this case, we obtain the sam e secular equation for $A B$ as that in $R$ ef. ${ }^{-}$' $\overline{1}$ for box geom etries.

In Fig. $\overline{12}$ the exactly (num erically) com puted integrated density of states obtained from Eq. (11) and its evaluation in Bohr-Som $m$ erfeld (BS) approxim ation using E q. ( $\overline{1} \mathbf{1}$ ) are shown for di erent $w$ idths $W$ of the lead (for the calculation of $P$ (s) see below). This show $s$ that

the exact calculations and the sem iclassical predictions are in very good agreem ent.
$C$ alculations for $P$ ( $s$ ) and $F$ (s) start w ith unfolding the tra jectory of the electron, i.e. using the fact that the free $m$ otion of the particle in the billiard is equivalent to its ight in a lattice of vertical intervals $w$ ith length $W$ and w ith lattice constant 2d (a) in the horizontal (vertical) direction. In general, one can calculate $P(s)$ by using a
large num ber of trajectories and determ ining the distri－ bution of their path lengths．An analytic form of $P$（s） and $F$（s）can be derived for $W \quad a=2$ ．As an exam ple， these functions are plotted for $d=a$ and $W=a=2$ in F ig．$\overline{3} 1$ for largers it is a non－di erentiable function possessing a singularity at $s=2 d$ and peaks at multiples of $2 \mathrm{~d} . \mathrm{Us} \mathrm{s}^{-}$ ing Eq．$(\overline{1})$ ）one can calculate the DOS and pronounced peaks（indeed singularities）arise due to the singularity of $P(s)$ at $s=2 d$ ．The positions of these singularities in the DOS are in perfect agreem ent with that obtained from the general expression derived in Ref．$\overline{1} \mathbf{6}$ ．

The integrated path length distribution $F(s)$ is a sm ooth function of $s$ allow ing one to obtain its asym $p-$ totic form $\mathrm{F}_{\mathrm{a}_{2}}(\mathrm{~s})$ for s ！ 1 （see the inset of the top
 $s$ behavior of $P(s)$ is related to the low energy depen－ dence of the DOS．Due to the rapid variation of $(s)$ ，it is di cult to de ne its asym ptote．To avoid this prob－ lem we rst calculate the asym ptotic behavior of $F$（s） and the asym ptotic form ofP（ $s$ ）is then calculated from
 For $s!1$ analytical form of the asym ptote of $F(s)$ is found by considering how particles can travela large dis－ tance $s$ w ithout hitting the vertical intervals of length $W$ in the unfolded space．Such trajectories lie only in cer－ tain directions form ing corridors $w$ ith slopes $u$ that are m ultiples of $\mathrm{a}=(2 \mathrm{kd})$ ，where $\mathrm{k}=[\mathrm{W}=\mathrm{a}]$ ．The probabil－ ty that a particle runs in such a corridor is proportional to $1=\left(u s^{2}\right)$ for large $u$ but $j u<u_{m a x}=s=x_{m}$ in，where $\mathrm{x}_{\mathrm{m}}$ in is a m inim al displacem ent in the horizontal direc－ tion．Sum $m$ ation of the probabilities for these corridors yields a term proportionalto $s^{2} \ln u_{m a x}$ ．D irectionsw ith slopes larger than $u_{m}$ ax should be treated separately and the result contains a term $s^{2} \ln x_{m}$ in．The above term $s$ from the two regions sum up to $s^{2} \ln s$ ，and nally we nd

for large $s$ ．$H$ ere $C_{1}$ and $C_{2}$ are functions of $d=a$ and $W=a$ ．For the case $W \quad a=2$ the detailed calculation gives analytic expressions also for $\mathrm{C}_{1}$ and $\mathrm{C}_{2}$ ：

H ere is the Euler－M ascheroni constant and $K_{0}$ is the $m$ odi ed B essel function of the second kind．Therefore， $C$ is a weakly dependent function of d ford $a$ ．

In the case of $W$＜$a=2$ additionalpassages $w$ th slopes corresponding to nonintegerm ultiples ofa＝（2d）open and

U sing the sm ooth asym ptote off（s）given by Eq．$\left.{ }^{[-1}\right)$ and Eqs．（了ָ닌），an analytic expression can be found for the low energy behavior of the DOS：

and $\mathrm{E}_{\mathrm{T}}=\mathrm{M}=(4)$ is the T houless energy［［了］$]$ ．Besides the term proportional to the energy（which was also pre－ dicted in Refs．$\overline{\overline{3}}, \overline{1},(\overline{1} 1$,$) ，there is an additional logarithm ic$ factor．M oreover，in contrast to the abovem entioned ref－ erences the coe cient depends on $W$ ；$a$ and d．H ow ever，
depends only on $W=a$. N ote that $W=a$ is a special case corresponding to the system studied by de Gennes and Saint-Jam es $\left[\begin{array}{l}-2 \\ ]\end{array}\right]$. Then, $\mathrm{C}_{2}=0$ and no logarithm ic factor appears in the D OS and the result is the sam e as in Ref. ${ }^{\prime}{ }_{6}^{1}$.

It is interesting to see the $W$ a lim it for which one would expect that $P(s)$ has a universal lim iting form, nam ely it is only a function of $W^{2}=A$. In this case, the electron has enough tim e to explore the whole available phase space before escaping (even in an integrable billiard) and P (s) looses any detailed dependence on the geom etry of the billiard. Therefore, tw o billiardsw ith the sam e $W^{2}=A$ but di erent aspect ratio ( $\mathrm{d}=\mathrm{a}$ ) should have the sam e path length distribution for $s m$ all enough $W$. From num erical calculations we found that for $W$ ! 0 , converges to a value 3:62 independent of the aspect ratio, i.e., it becom es a universalconstant. Sim ilarly we nd that when $W$ ! 0 , also tends to a universal constant ! $8={ }^{2}$. These results are dem onstrated in Fig. 'I'I'. In the inset of the top panelofF ig. 'İ' the asym p-

O ur results are in the sam e order ofm agnitude as that found in $M$ elsen et al [l] Thra et al. [4, $\hat{1}_{1}^{1}$. H ow ever, from our analysis it tums out that the functional form of the asym ptotic DOS is not just a linear function but involves a logarithm ic factor.

In conclusion, we have show $n$ that exact quantum $m e-$ chanical calculations for the integrated DOS of rectangular A ndreev billiards agrees w ell (for the whole energy
range below the gap) w ith that obtained from the B ohrSom $m$ erfeld approxim ation provided the energy dependent phase shift is taken into account. From the exact analytic form of the asym ptote of the integrated retum probability, we predict a new, logarithm ic contribution to the DOS on the scale of the Thouless energy. In contrast to earlier results, we show that the DOS at this energy range explicitly depends on $W$;a and d but it has a universal lim iting form for sm all enough $W$. W e also investigated the case when the superconductor is placed anyw here at the side of the rectangle and found that the logarithm ic contribution in the DOS is generic for rectangular A ndreev billiards.
