Sharing data between facilities: using the NeXus tim e-of-ight powder di ractom eter le form at - NOBUG S2002/036

N eX us is an international standard data form at intended to reduce the need for redundant software developm ent e orts in the neutron and x-ray scattering communities. As the N eX us standard m atures it is starting to be used at laboratories for storing raw data. The M anuel Lujan Jr. N eutron Scattering Center (M LN SC) at Los A lam os N ational Laboratory and the Intense P used N eutron Source (IPNS) at Argonne N ational Laboratory have been working with N eX us in an e ort to share data and software. M LN SC is now writing les compliant with N eX us and the Integrated Spectral A nalysis W orkbench (ISAW) software from IPNS is being used with this data. P roblem s can arise if the standard is interpreted in di erent ways and inform ation that belongs in the le is not accounted for in the standard. This paper will discuss an inter-laboratory collaboration in relation to a maturing data standard.

I. IN TRODUCTION

U sing an international standard le form at for data storage is very appealing. Rather than having to write, or track down, a conversion utility one can directly use a variety of software packages. For scattering data the clear choice is to use $N \in X \text{ us}^1$ $N \in X \text{ us}$ is a binary le form at built on top of the Hierarchical Data Form at $(HDF)^2$ library. The binary form at allows form ore e cient data storage while the hierarchical nature of HDF allows for intelligent grouping of inform ation to describe what is in the le.

The early development of NeX us concentrated on providing a powerful application program interface (API) im plemented in C with wrappers for FORTRAN 77/90, ID L, and Java. The variety of supported languages sim – pli es the work for those who do want to read or write NeX us les directly. More recently the focus turned to standardizing the organization of the data and associated information. O riginally, the NeX us standard provided a mechanism for storing information in the le, but did not spell out a detailed policy for using that mechanism. Instrument de nitions were incomplete and did not provide enough information to generate truly portable data les. This was the main problem when the authors began to collaborate.




FIG.1: Schem atic of the form at of a general NX entry. The NX data shown is typical of one dimensional id arrays.

NeXus was starting to de ne what constituted a generic compliant le. Each le contains multiple NXentries, and each NX entry is of the form seen in Fig. 1. The key to NeXus is that while very little information is required, if it is to be included in the le it has to be included in the manner speci ed by the standard.

The Integrated Spectral A nalysis W orkbench (ISAW) was designed to visualize and analyze data taken at timeof- ight neutron sources. In order to appeal to a broader community it looked to support the NeX us form at. The data acquisition system (DAS) team at the M anuelLujan

Jr. Neutron Scattering C enter (M LN SC) was working on an upgrade of their system which included moving to a more widely used le form at to reduce some of the work involved in analyzing data. Im mediately the two groups tried to share les and found that, while the data could be written by one system and loaded into the other, much inform ation was lost due to organizational di erences. To solve this problem the authors decided to specify what needed to be included in a time-of- ight neutron pow der di ractom eter (TOFNPD) le. W hile this is a conceptually simple instrum ent, inform ation such as detector position is needed by m any other instrum ents. This paper will discus several of the decisions made during a meeting at Los A lam os N ational Laboratory concerning the description of detectors.

II. IDENTIFYING DETECTOR PIXELS

In N eX us, data is stored as a multidim ensional rectangular array inside the N X data object as seen in Fig. 1




FIG. 2: Schem atic of an simple tube detector (a), LPSD (b), and area detector (c) split into its component pixels.

with separate arrays for the independent variable and the detector identi ers. For a simple instrument, with only tube detectors (Fig. 2(a)), the data is two dimensional (data[i, j]) with the rst axis being time-of-ight (time_of_flight[i]) and the second axis being detector num ber (id[j]). New er pow der di ractom eters tend to use linear position sensitive detectors (LPSD) (Fig. 2(b)) which would store data in a three dimensional data array, (data[i,j,k]) with the rst axis being the same as the sim ple tube (time_of_flight [i]) and the other axes representing the detector and pixel num ber (id[j,k]). The case for area detector (Fig. 2(c)) is easy to extend from these two cases with a four dimensional data array (data[i, j, k, l]), with the axes being time-of-ight (time_of_flight[i]), detector num ber, row, and column (id[j,k,l]). Since NeXus only provides for rectangular arrays the case of an instrum ent with more than one type of detector must store the data in multiple NX data. This is also the case when there is more than one tim e-of- ight range. To this end the group decided that if two data arrays have the same name attribute then they are intended to be part of the same data set.

III. DESCRIBING DETECTORS

A rguably the most important information, after the data, is a description of the detector conguration. The detector's position is needed for conversions to wavelength (), d-spacing, and momentum transfer (Q) as well as data corrections such as inelastic scattering. The solid angle covered is needed to normalize the spectra for measurement area e ects. O ther information is useful for diagnostics such as physical size (length, width, and depth), orientation, electronics conguration, and type (such as ³He or scintillator). Some information about the detector is redundant as well. For example if the size and orientation is known then the solid angle covered is straightforward to calculate and does not need to be explicitly included. This section will discus some of the properties of a detector.




FIG.3: Schematic of a detector at a distance r from the center of the instrument. The angles and are arbitrarily labeled and discussed in the text.

A. Specifying Position

Due to the di erences in preferred coordinate system s and the variety of naming conventions, specifying a detector position is more di cult than one would expect. W hile the choice of spherical coordinates is fairly straightforward, the decision of what to call the angles, and what to reference them from , was a long topic of discussion.W ith di raction experim ents the beam direction is always special since things such as the B ragg angle³ are with respect to it. Due to this symmetry the preferred coordinate system is spherical with the pole coinciding with the beam direction. This is shown in Fig. 3 with the azim uthal angle being zero at the horizontal plane of the instrum ent. The zero point for the azim uthal angle was chosen to be in the horizontal plane, to coincide with the location of detectors on m any di ractom eters and to be consistent with the traditional labeling of detector position. The angles labeled in the gure are some of the standard choices used with spherical coordinates. The one way that the group could speak and not have any inconsistencies was discussing the angle as the polar angle and as the azim uthal angle. O ther possibilities for were Bragg angle, 2 , , and . was also possibly or . All greek labels are used in most mathematics texts, (except 2) how ever, their interpretations vary greatly. For this reason we decided that the most precise way to refer to the angles were as polar_angle and

azimuthal_angle.




FIG. 4: Schem atic of specifying the orientation of a detector with various possible frames of reference. The labels $(d_0, d_1, and d_2)$ are described in the main text.

A nother in portant correction in data analysis is to normalize the detectors by the solid angle they cover. Therefore, the information needed is either the solid angle itself, or the physical size (length, width, and depth) and orientation of the detector so the solid angle can be calculated. In Fig. 4 a couple of the ways of determining

the detector orientation are shown. d_0 is the coordinates of the center of the instrum ent, shown for clarity. The second frame of reference, d_1 , is parallel to d_0 but shifted

to the position of the detector. d_2 is coincident with the major symmetry axes of the detector. Looking at this picture the simplest description of the orientation is the Euler angles to rotate d_1 to d_2 .

IV. SUMMARY

This paper reviewed the results of discussions concerning storing data in a N eX us le. We described the form at for the data itself as well as specifying the layout of the detectors that measured the data.
