openDaVE -a data visualisation and transform ation fram ework

At present each neutron scattering facility has its own set of data treatment software, normally based on a proprietary data format. The travelling scientist is either forced to continually learn new software or to write conversion routines for his own software tools.

During software development most of the time is spent on routines connected with leinput and output or visualisation. Our aim is to relieve the scientist from such tedious work to allow maximum e ort to be spent on data processing routines.

I present an "Open Source" component based, extendable, platform independent fram ework for visualisation and transform ation of data.

M ost of the existing software appears as a monolithic block. In contrast openD aV E is built up in a modular design. It consists of three parts: the kernel, a lot of modules, and some dierent front-ends. The actual functionality of the fram ework is done by the modules. The kernel provides the creation, the destruction of the modules, and the interaction between them, whereas the front-end interacts with the user.

The modules are divided into three classes: sources, liters, and sinks. Each of the module consists of two dierent parts: the module logic and one or more interfaces which set the module parameters. The interfaces are front-end specic.

1 Introduction

A lot of scientists in the neutron scattering community is travelling from one neutron source to another. Most of them spent only some days at a certain instrument.

During their work at dierent experiments at the various neutron sources they have to learn continually the use of the species software packages for the pre-analysis of the data. To overcome this constant learning process they may use their own software, but they have to write new modules for accessing the data in the experiment species data format.

For analysis and interpretation they get the experimental data in electronic form (on disc, by email, direct access, etc) mostly in an instrument specic data format, whereas the own software at home uses a signicantly dierent data format.

That means for a large amount of time a scientist is occupied by learning the handling of new software or by writing routines for data conversions. This problem s lead to a project in the FRM -II software group to give all users a tool solving this problem s:

openDaVE (open Data V isualization Environment).

2 Features

The main goal during the development was to achieve exibility in many elds, which is provided by the following design rules:

sim ple extensibility
replaceable front-ends
replaceable data types
```

The openD aV E fram ework was written in C++ using the Qt library [1] under Linux. This decision allows a simple porting to other operating systems such as W indows and the dierent avors of UNIX. The current version runs under Linux and W indows.

openD aV E supports a lot of data form ats, but one of the most interesting data form ats is N eX us [2]. The N eX us support includes:

selection of data from a complex NeXus le containing more than one NX data entry

In contrast to most of the existing software, openD aV E was not designed as a monolithic program. It was built in a modular fashion, consisting of three parts:

the front-ends

the modules

the kemel

This modularity is one most powerful features of openDaVE. It neither restricts the data used inside and outside openDaVE nor restricts anybody in the selection of functionality and user interface.

The dierent set-up's of openDaVE are saved in XML les.

3 System Design

The collaboration of the three parts of openD aV E is shown in gure 1.




Figure 1: Schem atic layout of the components of openD aV E.

3.1 Front-ends

The main aspect of the front-end in view of architecture is its exchangeability. It has access to the application via the module and kernel interface. These two interfaces are designed to implement a wide variety of front-ends.




Figure 2: Screenshot from a running qdave

At this time we have implemented these types of front-ends:

Qtbased front-end (see gure 2) qdave

Text based front-end tdave

Python bases front-end (under developm ent)

3.2 The Modules

The actual functionality of the fram ework is incorporated into the modules. That means an extension of the functionality of the whole fram ework is done by developing a new module.

A module is realised as a shared library being loaded dynam ically by the kernel at runtime, on request of the user. This library provides a well de ned interface to the kernel (the kernel accesses the module logic through this interface), the module logic (functionality), and one or more interfaces to the user which may be used by

the front-ends to control the behaviour of the m odule logic. So the user m ay set and get the m odule param eters.

The creation and deletion of a module instance is done by the kernel. If a module instance is created by the kernel, exactly one user interface is provided although the library may provide more than one.

3.2.1 M odule functionality

There exist three types of modules:

Sources

Filters

Sinks

The di erences between these types are the following:

a source has only output data in the meaning of the openD aV E architecture (for example reading the NeX us data le)

a sink has only input data (e.g. writing the data into a NeXus le, display the data)

whereas a liter has input as well as output data (for example smoothing a spectrum).

Each module has a certain input and output type which may dier inside one module.

The data in openDaVE may only ow from a source trough one or more liters to a sink. One may consider the data ow as a chain of modules which has to start with a source (or liter) and has to end with a sink (or liter) (see gure 3). The kernel ensures that only modules with the same output and input parameter may be connected.

The functionality of a module is encapsulated in a single function call. This function is always called when the kernel decides that a module has to recalculate its data. It receives the data from all in-links as parameters. The calculated data of the module must be returned at the end of the function call. So the data can be delegated by the kernel to all out-links of the module. The number of in-links can be restricted by the developer of the module.

The data ow may be initialized by a source (a source module creates new output data, which should be processed by the following module chain) via liters to the sink in the so-called real-time mode, or from a sink (the user wants to reprocess the data with changed module parameters) via liters to the source. In any case the data ow from source to sink.




Figure 3: Some examples for the data ow in openDaVE

The mode may be set separately for each module, and the modules may be used also in a mixed mode. However, a source initiated data ow breaks at a module which is not set to the real-time mode.

3.3 The Kernel

The kernelm ay be considered as the heart of openD aV E. Itsm ain task is to manage the modules, meaning that it has to create and delete some instances of the modules. Additionally it has to establish and remove the data ow between the modules. Let's have a deeper look into the kernel.

Through the front-end instructs the user the kernel to create or to delete a m odule instance. Let's consider the creation process. The kernel needs an information about the type of module to be created, the interface the module has to provide, and the name of the module instance. In its table of modules the kernel looks for the type of module which it may create (This table is led up when the kernel loads the dierent module libraries). If the type was found the kernel creates a module instance. The module itself tests the existence of the desired interface. If all searching was successful the module instance is created and may be used trough the interface by the user.

A fler creating of the module instances they have to connect among them selves. This connection will be established by the kernel on request of the user. It checks whether the connection (link) is going from a source/liter to a liter/sink (see gure

3). Futherm ore it checks, whether the output and input data types are the same, and that the maximum number of input links to the ending module is not reached.

The deletion of a module requires some works of the kernel. At static that to check the input and output links to this module. If there exist any, it has to stop the data ow between the modules through them. A fterwards it removes these links before it removes the module itself.

4 Sum m ary

This paper gives an overview on openD aV E, am odular, open, extensible fram ework for data analysis and data interpretation. It is shown how the several parts of the fram ework collaborate.
