# Statistical m echanics in the context of special relativity

In ref. Physica A 296, 405 (2001)], starting from the one parameter deformation of the exponential function  $\exp_{f_g}(x) = \frac{p}{1+2x^2} + x^{1=}$ , a statistical mechanics has been constructed which reduces to the ordinary Boltzmann-G ibbs statistical mechanics as the deformation parameter approaches to zero. The distribution  $f = \exp_{f_g} E +$  obtained within this statistical mechanics as the deformation parameter approaches to zero.

calmechanics shows a power law tail and depends on the non-speci ed parameter , containing all the information about the temperature of the system. On the other hand, the entropic form  $S = d^3p \, (c \, f^{1+} \, + \, c \, \, f^1 \, )$ , which after maximization produces the distribution f and reduces to the standard Boltzm ann-Shannon entropy  $S_0$  as  $\, ! \, 0$ , contains the coe cient c whose expression involves, beside the Boltzm ann constant, another non-speci ed parameter .

In the present e ort we show that S is the unique existing entropy obtained by a continuous deform ation of  $S_0$  and preserving unaltered its fundam ental properties of concavity, additivity and extensivity. These properties of S perm it to determ ine unequivocally the values of the above m entioned parameters and . Subsequently, we explain the origin of the deformation mechanism introduced by and show that this deform ation emerges naturally within the Einstein special relativity. Furtherm ore, we extend the theory in order to treat statistical system s in a time dependent and relativistic context. Then, we show that it is possible to determ ine in a self consistent scheme within the special relativity the values of the free parameter which results to depend on the light speed c and reduces to zero as c! 1 recovering in this way the ordinary statistical mechanics and therm odynam ics. The novel statistical mechanics here presented preserves unaltered the mathem atical and epistem ological structure of the ordinary statistical mechanics and is suitable to describe a very large class of experim entally observed phenom ena in low and high energy physics and in natural, econom ic and social sciences. Finally, in order to test the correctness and predictability of the theory, as working example we consider the cosm ic rays spectrum, which spans 13 decades in energy and 33 decades in ux, nding a high quality agreem ent between our predictions and observed data.

#### I. IN TRODUCTION

The following one-parameter deformations of the exponential and logarithm functions

 $\exp_{f_{g}}(x) = \frac{p_{1}}{1 + 2x^{2}} + x^{1}; \quad (1.1)$ 

$$\ln_{f_{g}}(x) = \frac{x - x}{2}; \qquad (1.2)$$

which reduce to the standard exponential and logarithm respectively as the real deformation parameter approaches to zero, has been introduced recently in R ef. [1]. The above functions have many very interesting properties [1, 2, 3, 4] (some being identical to the ones of the undeformed functions) that perm it to construct a statistical mechanics (and thermodynamics) which generalizes the standard Boltzmann-G ibbs one. This -deformed statistical mechanics preserves unaltered the structure of the ordinary one and can be used to explain a very large class of experim entally observed phenom ena described by distribution functions exhibiting power law tails. The areas where this form alism can be applied include among others, low and high energy physics, astrophysics, econophysics, geology, biology, m athem atics, inform ation theory, linguistics, etc. [5, 6, 7, 8, 9].

In ref. [1] it has been shown that the statistical distribution

which generalizes the Boltzm ann-G ibbs distribution, can be obtained also by maximizing, after properly constrained, the entropy

which reduces to the standard entropy  $S_0$  as the deformation parameter approaches to zero. The coecient c, which also absorbs the Boltzm ann constant  $k_{_{\rm B}}$ , depends on a free parameter (see Eq. (65) of ref. [1]) which remains to be determined together with the parameter which contains the information about the tem perature T of the system .

A rst question which arises naturally is if it is possible and how to nd any criterion which allows us to x the parameters and or at least express these in terms of the deform ation parameter , in order to reduce the free parameters of the theory.

A second question regards the properties of the entropy S . It is well known that the Boltzm ann-Shannon entropy S<sub>0</sub> is concave, additive and extensive. We know that S is concave with respect to the variable f, but what happens about its additivity and extensivity? More in general, beside the Boltzm ann-Shannon entropy other concave, additive and extensive entropies do exist?

A third question is related to the physical mechanism which originates the deform ation introduced by the param eter . In other words, does a more fundam ental theory exist where this deform ation emerges, or is it simply a purely mathematical tool?

A fourth question is if it is possible to extend the theory originally developed in the fram ework of a classical kinetics to treat statistical systems in the context of a relativistic kinetics.

A ffh question regards the deform ation parameter . This parameter will continue to remain free or is it possible to determ ine its value self consistently within the theory?

The present paper deals with the above questions and its purpose is double. Firstly, we will show that S is the unique existing, concave, additive and extensive entropy, beside the Boltzm ann-Shannon entropy. A swew ill see these properties of S are su cient to determ ine unequivocally the values of parameters and . Secondly, we will show that the deform ation introduced by is a purely relativistic e ect and then we will explain the deform ation mechanism within the Einstein special relativity. Then, we will form ulate a relativistic -kinetics and we will calculate the value of .

F inally, in order to test the predictability and correctness of theory here proposed we will consider two sets of experimental data. In particular we will analyze the cosm ic rays spectrum which spans 13 decades in energy and 33 decades in particle ux that, as it is widely known, violates the Boltzm ann-G ibbs statistics. A s we will see, we have a high quality agreem ent between the theory and the observed data.

The paper is organized as it follows. In Sect. II, generalizing the approach proposed in ref.s [1, 2], we introduce a class of one parameter deformed structures and study their mathematical properties.

In Sect. III, within this context, starting from the Jaynesmaximum entropy principle we consider the most general class of deformed statistical mechanics preserving the main features of the standard Boltzmann-G ibbs one.

In Sect. IV, we show that the entropy S introduced in ref. [1] is the only one existing beside the Boltzm ann-Shannon entropy  $S_0$  which is simultaneously concave, additive and extensive. Then the statistical mechanics and therm odynamics based on S can be viewed as a natural extension of the Boltzm ann-G ibbs one, recovering this last as the deform ation parameter approaches to zero.

In Sect. V, we consider the mean properties of - exponential and -logarithm which have a fundam ental role in the formulation of the new statistical mechanics.

In Sect. VI, we extend the formalism to a time dependent and relativistic context. In particular after introducing the relativistic -kinetic evolution equation we study its stationary state and prove the H-theorem.

In Sect. V II, we explain the origin of the -deform ation and show that it emerges naturally within the Einstein special relativity.

In Sect. V III, we propose an approach which perm its to determ ine within the special relativity the value of the parameter  $\ .$ 

In Sect. IX, we compare two sets of experimental data with the predictions of the present theory.

Finally in Sect. X, some concluding remarks are reported.

# II. DEFORMED MATHEMATICS

#### A. Generator of the Deform ation

Let g(x) be an arbitrary real function of the real variable x, that we call generator of the deform ation, having the following properties

#### B. Deform ed algebra

Eq. (2.41) de nes a very large class of deform ed logarithm s varying the arbitrary function g(x). These deform ed logarithm s can depend on m any other param eter (through the generator g(x)) besides the param eter . W e recallbrie y that in literature one can nd other one [10, 11] or two [12] param eter deform ations of the exponential and logarithm functions. A nyway in following we will consider the deform ed logarithm s de ned through Eq. (2.41) and depending only on the param eter .

# F. Deform ed trigonom etry

The relations given by Eq.s (2.61) and (2.62), which express two m athem atical properties of the -logarithm, will be very useful in the next section in de ning a new additive and extensive entropy.

We observe that when = 0 it results  $J_0(n) = n \ln n$ and the information content  $I_0$  is the mean value of the ordinary logarithm. In this case the above variational equation expresses the Jaynes maximum entropy principle which conducts to the Boltzman-G ibbs statistical mechanics. In the following, in analogy with the standard statistical mechanics, we require that I must be expressed as the mean value of  $\ln_{r_g} n$ . To do so we must consider the subclass of the deformed logarithm sobeying the condition

The above variational equation can be viewed as de ning a maximum entropy principle analogous of the Jaynes principle of the standard Boltzm ann-G ibbs statistical mechanics [13]. We remark that this maximum entropy principle, in the form given by Eq. (3.11), holds only and exclusively for the subclass of -logarithms, which are solutions of the integral equation (3.10).

We show now that the families of entropies, de ned through (3.12) and involving the -logarithm swhich are solutions of Eq. (3.10), have two important properties typical of the Shannon entropy. To do so we consider the properties (2.61) and (2.62) of -logarithm, which rearrange as

Eq.s (3.18) and (3.19) say that the entropies S de ned starting from the -logarithms which are solutions of Eq. (3.10) are additive and extensive just as the Shannon entropy. # IV. THE NEW ADDITIVE AND EXTENSIVE ENTROPY

We consider Eq. (3.10) which, after performing a derivation with respect to n, assumes the form

The above entropy is contained, as a particular case, in the class of entropies introduced previously in ref. [1] (In Eq. (65) of this reference it appears the non speci ed parameter , while the Boltzm m ann constant is absent because setted to have  $k_{\mu}$  (1 + ) = 1).

W e recall that the entropy given by Eq. (4.20) is different from the nonextensive entropy introduced in ref.s [14, 15]. Of course the statistical distribution de ned through Eq.s (3.1) and (4.19), introduced previously in ref. [1], is also di erent from the distribution of the nonextensive statistics [15] and of the plasm as physics [16].

#### V. THE -EXPONENTIAL AND -LOGARITHM

Let us report here the main mathematical properties, some of these reported in refs [1, 2, 3], of the functions  $\exp_{f_g}(x)$  and  $\ln_{f_g}(x)$  de ned through Eq.s (4.18) and (4.19), respectively.

W e start by observing that the generator of the deform ation is the function g(x) = x and then from (2.1) and (2.2) we obtain

In g.1, the function  $\exp_{f_g}(x)$  for a xed value of is plotted. We note that the bulk of this function is very close to the standard exponential. Indeed the Taylor expansion of  $\exp_{f_g}(x)$  is the same, up to second order, of the one of  $\exp(x)$ . The tail of  $\exp_{f_g}(x)$  behaves as a power law. Between the bulk and the tail an interm ediate region whose extension depends on the value of exists.




FIG.1: P lot of the function  $\exp_{f_g}(x)$  versus x for = 0.3. This function is compared with the ordinary exponential and with a pure power law.




FIG.2: Plot of the function  $\exp_{f_g}(x)$  versus x for some di erent values of . The case = 0 corresponds to the ordinary exponential.

# VI. RELATIVISTIC KINETICS

In the present section we treat the statistical system, considered previously in stationary conditions, within a relativistic and kinetic framework. The new relativistic kinetics here presented, in the limit c ! 1, reduces to the classical kinetics considered in [1].

By using the standard notation of the relativistic theory we denote with x = x = (ct;x) the four-vector position and with  $p = p = (p^0;p)$  the four-vector momentum, being  $p^0 = p^2 + m^2c^2$  and employ the metric g = diag(1; 1; 1; 1) [20].

Let us consider the following relativistic kinetic equation

where the distribution f is a function of the four-vectors x and p, namely f = f(x;p). We note that the left hand side of Eq. (6.1) is the same of the standard relativistic Boltzm ann equation but the collision integral in the right hand side results to be more complicated, containing the deform ed product and the arbitrary function a (f) which we suppose to be positive and increasing. The factor G is the transition rate which depends only on the nature of the two body particle interaction.

The above equation in the case = 0 and a(f) = f reduces to the already known relativistic Boltzm ann equation describing the standard relativistic kinetics [20]. Clearly in the case  $\notin$  0 and  $a(f) \notin$  f, the above equation describes a new relativistic kinetics, radically dilement from the standard one.

W e anticipate that this new relativistic kinetics, which we will consider here, de nes a statistics resulting to be independent on the particular form of the function a (f).

Steady states: We consider now the steady states of Eq. (6.1) for which the collision integral becomes equal to zero. Then we have

[20] it is shown that in presence of external electrom agnetic elds the more general microscopic relativistic invariant has the form (p + qA =c) U + constant, being U the hydrodynamic four-vector velocity with U U =  $c^2$ . Then we can pose

H-theorem : In the standard relativistic kinetics it is well known from the H-theorem that the production of entropy is never negative and in equilibrium conditions there is no entropy production. In the following we will demonstrate the H-theorem for the system governed by the kinetic equation (6.1). For sim plicity of the notation, hereafter we om it the letter in the sym bolof -entropy. We de ne the four-vector entropy S = S = (S<sup>0</sup>;S), in term s of the distribution n = f, as follow s

A filter in posing that a (h) is an increasing function, it results  $[a(h_1) \ a(h_2)] [ln_{f_g}(h_1) \ ln_{g_g}(h_2)] 0.8h_1;h_2$  and then we can conclude that

This last relation is the local form ulation of the relativistic H-theorem which represents the second law of the therm odynamics for the system governed by the evolution equation (6.1).

C oncerning the arbitrary positive and increasing function a (f) appearing in the collision integral of the evolution equation, we note that, if we suppose that obeys to the follow ing condition

## VII. PHYSICAL MEAN ING OF THE -DEFORMATION

In the present section we will show that the deform ation introduced by the parameter emerges naturally within the Einstein's special relativity, so that one can see the -deformation as a purely relativistic e ect.

Let us consider in the one-dimensional frame S two identical particles of rest m ass m. We suppose that the rst particle m oves toward right with velocity  $v_1$  while the second particle m oves toward left with velocity  $v_2$ . The relativistic m omenta of the particles are given by  $p_1 = p(v_1)$  and  $p_2 = p(v_2)$  respectively, being

$$p(v) = \frac{m v}{1 - v^2 = c^2}$$
 : (7.1)

W e consider now the same particles in a new frame S  $^0$  which m oves at constant speed  $v_2$  tow and left with respect to the frame S. In this new frame the particles have velocities given by  $v_1^0 = v_1 \quad {}^cv_2$  and  $v_2^0 = 0$  respectively, being

$$v_1 = v_2 = \frac{v_1 + v_2}{1 + v_1 v_2 = c^2}$$
 (7.2)

the well known relativistic additivity law for the velocities. In the same fram e S<sup>0</sup> the particle relativistic momenta are given by  $p_1^0 = p (v_1^0)$  and  $p_2^0 = 0$ , respectively. Up to now, we have simply recalled some well known concepts of the special relativity [21].

Let us pose the follow ing question: if it is possible and how to obtain the value of the relativistic momentum  $p_1^0$ starting directly from the values of the momenta  $p_1$  and  $p_2$  in the frame S. The answer to this apparently innocent question is a mative. One, after straightforward calculations (see the theorem in this section), arrives to the follow ing surprising result

$$p_1^0 = p(v_1) p(v_2)$$
;  $= \frac{1}{mc}$ : (7.3)

In words, the relativistic m om entum  $p_1^0$  of the rst particle in the rest frame of the second particle is the - deformed sum, with = 1=m c, of the m om enta  $p_1$  and  $p_2$  of the particles in the frame S.

Unexpectedly we discover that the -sum is the additivity law for the relativistic momenta. Eq.(7.3) which we write in the form

$$p(v_1) \quad p(v_2) = p(v_1 \ ^c v_2) ; = \frac{1}{mc} ; (7.4)$$

says that the -deform ed sum and the relativistic sum of the velocities are intim ately related and reduce both, to the standard sum as the velocity c approaches to in nity. The deform ations in both the cases are relativistic e ects and are originated from the fact that c has a nite value. Eq.(7.4) follows as a particular case from the following theorem : Theorem : Let

$$p_i(v_i) = \frac{m_i v_i}{1 \quad v_i^2 = c^2}$$

be the relativistic momenta of two particles (i = 1;2) of rest m ass m<sub>1</sub> and m<sub>2</sub> which move in the one dimensional frame S with speed v<sub>1</sub> and and v<sub>2</sub> respectively. If we indicate with the -sum de ned through Eq. (5.11) and with <sup>c</sup> the velocity relativistic additivity law de ned through Eq. (7.2), it results that

P roof: W e start by using the de nition of the -sum, subsequently we use the explicit form of the relativistic m om entum and nally we use the de nition of the velocity relativistic additivity law

Trivially from Eq. (7.6) one obtains Eq.(7.4) as particular case, when  $m_1 = m_2 = m$ . Note that the parameter has di erent values in these two equations because the sum med quantities in the two cases are di erent.

We can easily explain the meaning of the deform ed derivative. We indicate with p the relativistic momentum in the frame S, and with dG =dp the derivative with respect to p of the Lorentz invariant scalar G. The same quantities in the frame S<sup>0</sup> are indicated with p<sup>0</sup> and dG =dp<sup>0</sup>, respectively. It is trivial to verify that

and then we can conclude that the -deform ed derivative can be viewed as a standard derivative in an appropriate fram e.

In the next section we will consider, in the fram ework of the special relativity, the -statistics of N -identical particles, where is a dimensionless parameter and we will determ ine its value. To do so, it is more convenient to write Eq. (7.4) in the form

## VIII. DETERM INATION OF THE PARAMETER

In the present section we calculate the value of the parameter which, due to the symmetry \$ of the theory, we consider positive, namely 0 < 1. C learly if we start from the -statistical distributions  $f_1$  and  $f_2$ describing two independent statistical systems, we can construct the distribution  $f_1 = f_2$  which describes a new composite system. This system in the case = 0 reduces to the one described through the distribution  $f_1 f_2$ . In the following we will assume that the distribution  $f_1 f_2$ describes a state also in the case 60.0 by joursly this state is di erent from the one described by  $f_1$   $f_2$ . As wew ill see, this simple but meaningful hypothesis is su cient to determ ine the value of in the case of relativistic system s.

Taking into account the form of the distributions  $f_1$ and  $f_2$  given by Eq. (6.6) (for simplicity we pose = 0), and the property (2.28) of the -exponential one can write im mediately

W e assume now that the -exponential in the right hand side of the Eq. (8.2) has the same structure of the one given by Eq. (6.6). C learly we must im pose that  $E_0$  be exclusively expressed in term s of non statistical parameters. In the following we will show that  $E_0 = mc^2$ . To do this we exploit Eq. (7.9) obtained within the special relativity. Starting from this equation and taking into account the property (2.28) of the -exponential we obtain

Recall that we wish to calculate the parameter which has a value that does not depend on the particle energy. Then, without bosing generality, we can consider Eq. (8.4) in the ultrarelativistic region (v ! c) where it results p (v) E(v)=c:

It is important to emphasize that this expression of the parameter holds only under the above mentioned hypothesis and imposes that jj < 1. This condition on the value of coincides with the one expressed by Eq. (4.15) and obtained in a completely di erent way. We have = 0 only if T = 0 or if c = 1. The limiting case = 1 is obtained if T = 1 or if  $m c^2 = 0$ .

At this point one can write the distribution (6.6) in the form

Note that the statistical information of the system, namely the temperature is hidden exclusively in the parameter . When E ! 1 the distribution (8.9) shows a power law asymptotic behavior

In g. 3, the distribution function given by Eq. (8.16) (after normalization) versus v=c for di erent values of and then for di erent values of m  $\hat{c}$ =k<sub>b</sub> T according to Eq. (8.8), is plotted.

#### $\tt IX$ . $\tt EXPERIMENTALEVIDENCES$

Since long time it is known that the cosm ic rays spectrum, which extends over 13 decades in energy, from a few hundred of M eV ( $10^8$  eV) to a few hundred of E eV ( $10^{20}$  eV) and spans 33 decades in particle ux, from  $10^4$  to  $10^{-29}$  [m<sup>-2</sup> srsG eV]<sup>-1</sup>, is not exponential and then it violates the Boltzmann equilibrium statistical distribution / exp( E = k T) [22, 23, 24]. Approximately this spectrum follows a power law E <sup>a</sup> and the spectral index a is near 2.7 below 5  $10^{45}$  eV, near 3.1 above 5  $10^{45}$  eV and again near 2.7 above 3  $10^{48}$  eV. On the other




FIG.3: Plot of the distribution function (after norm alization) given by Eq. (8.16) versus v=c for some di erent values of .

hand it is known that the particles composing the cosm ic rays are essentially the norm alnuclei as in the standard cosm ic abundances of matter. Then the cosm ic rays can be viewed as an equivalent statistical system of identical relativistic particles with masses near the mass of the proton (938 M eV).

These above characteristics (relativistic particles with a very large extension both for their ux and energy) yield the cosm ic rays spectrum an ideal physical system for a prelim inary test of the correctness and predictability of the theory here proposed.

W e consider the statistical distribution f (E) given by Eq. (6.6) or (8.9). The particle ux (E) /  $\hat{p}f(E)$ can be calculated trivially if we take into account the relativistic expression linking E and p obtaining

We use these two theoretical distributions of particle ux to t the cosm ic rays data reported in ref. [24]. In g.

4, we show the observed data together with the theoretical curves (E) (solid line) and  $_0$  (E) (dotted line). The curve (E) corresponding to A =  $10^5$  [m  $^2\,\rm{sr\,sG\,eV}$ ]  $^1,$  m  $c^2$  = 938 M eV, = 375 M eV, and = 0.2165 provides a high quality agreem ent with the observed data. This agreem ent over so m any decades is quite remarkable. From the value of and m  $c^2$  and adopting Eq. (8.7) we obtain that  $k_{\rm B}\,\rm{T}$  = 208 M eV.




FIG.4: Plot of the cosm ic rays ux versus energy. The solid line is the curve obtained within the present theory and is given by Eq. (9.1) with A =  $10^5 \text{ [m}^2 \text{ srsGeV} \text{]}^1$ , m  $c^2$  = 938M eV, = 375M eV, = 0.2165 and k B T = 208M eV. The dotted line represents the theoretical curve obtained within the standard Boltzm an-G ibbs statistics given by Eq. (9.4) with A 0 = 1.3  $10^4 \text{ [m}^2 \text{ srsGeV} \text{]}^1$ , m  $c^2$  = 938M eV and k T = 208M eV. The observational data are collected by S.P.Swordy [24].

In the same gure the curve  $_0$  (E) (with  $A_0 = 1:3$  1<sup>4</sup>0 [m<sup>2</sup> srsGeV]<sup>1</sup>, m c<sup>2</sup> = 938 M eV and k<sub>B</sub> T = 208 M eV) which decays exponentially and can not t the observed data violating the Boltzm ann-G lbbs statistics, is reported.

A short rem ark must be made at this point. C learly, the power law asymptotic behavior of the spectrum (E) is imposed by the -exponential whose origin is the sum. But the -sum emerges naturally within the special relativity as the composition law of the relativistic momenta. Then we can conclude that the power law asymptotic behavior of the cosm ic rays ux is simply the signature of the particle relativistic nature.

It is widely known that the Boltzm ann-G ibbs distribution  $\exp(E = k_{\rm B} T)$  originally proposed to describe a classical particle gas in them odynam ic equilibrium can be adopted to describe an enorm ous am ount of phenom – ena in nature. On the other hand the power law tails

have been observed experimentally in several elds of science. Some times in particular elds, this power law has a name (e.g. Pareto law in econophysics, Gutenberg-Richter law in seism ology etc). Furtherm ore the power law tail is preceded by an exponential region and between the two regions exists a third intermediate region. It is worth remarking that the exponential de ness a distribution which can describe simultaneously the three above regions (see g.1) and then is particularly suitable to describe the above mentioned phenomena.

As a working example we analyze the experimental data reported in ref. [8] related to the rain events in meteorology. In g. 5 is plotted the number density N [events/(yearmm)] of rain events versus the event size M [mm] on a double logarithm ic scale. We note that the data have a large extension (the abscissa spans 7 decades and the ordinate 5) and remark that its behavior is typicalofa class of experimental data which we nd in several areas of science. In order to t the experimental data we adopt the distribution

$$N = A \exp_{f_{a}} M ; \qquad (9.5)$$

and, as one can see in g. 5, a rem arkable agreem ent is obtained with A = 8 1<sup>4</sup>0 [events/(year mm)], = 75 [mm<sup>1</sup>] and = 0:7.




FIG. 5: P lot of the number density N [events/(year m m)] of rain events versus the event size M [m m]. The solid line is the curve obtained within the present theory and is given by Eq. (9.5) with A = 8  $10^4$  [events/(year m m)], = 75 [m m<sup>1</sup>] and = 0.7. The dotted line corresponds to the ordinary exponential function ( = 0). The experimental data are from ref. [8].

C learly, one can hunt other mechanism s, di erent from the relativistic one, leading to -statistics. B eside the im portant problem of the agreem ent between the theoreticalcurve and the observational data one does not neglect the epistem obgical problem concerning the structure of the theory which must be able both to explain the origin and to determ ine the value of any parameter appearing within the theory.

## X. CONCLUSIONS

We summarize brie y the results obtained in the present e ort. We have shown that beside the Boltzm ann-Shannon entropy, the quantity

$$S = K_{B} n_{i} \ln_{f_{g}} n_{i} ;$$

with  $\ln_{r_g} x = (x + x)=2$  and 1 < < 1, is the only existing entropy, simultaneously concave, additive and extensive. Starting from this entropy it is possible to construct a generalized statistical mechanics (and therm odynamics) having the same m athem atical and epistem ological structure of the Boltzm ann-G ibbs one, which is recovered when the deform ation parameter approaches to zero. Within this generalized statistics the distribution function assumes the form

$$n_i = \exp_{f_{\alpha}}((E_i));$$

with  $\exp_{f_g}(x) = \frac{p_{1+2x^2} + x^{1}}{1 + 2x^2 + x^{1}}$  while the constants  $p_{and}$  are given by  $= [(1 )=(1 + )]^{1-2}$ ,  $1 = \frac{p_{1-2}}{1 + 2x^2} k_{B}T$ . The chemical potential can be xed by the norm alization condition. This distribution has a bulk very close to the exponential one while its tail decays following a power law  $n_{i} / E_{i}^{1}$ .

The origin of the deform ation has its roots in the E instein special relativity and the relativistic statistical system s are governed by a kinetics obeying the H-theorem.

We have shown that, within the special relativity, it is possible to determ ine the value of , obtaining in this case

$$\frac{1}{2} = 1 + \frac{m c^2}{k_{\rm B} T}^2$$
;

so that the relativistic statistical m exchanics does not contain free param eters.

The theory can describe observational data in many edds. In particular we nd a high quality agreement in analyzing the spectrum of the cosm ic rays which violates manifestly the Boltzmann-Gibbs statistics. This is an important test for the theory because the cosm ic rays are relativistic particles and their spectrum has a very large extension (13 decades in energy and 33 decades in ux).
