# Statisticalm echan ics <br> in the context of special relativity

In ref. Physica A 296, 405 (2001)], starting from the one param eter deform ation of the exponential function $\exp _{f}(x)=P \overline{1+{ }^{2} x^{2}}+x^{1=}$, a statistical m echanics has been constructed which reduces to the ordinary Boltzm ann-G ibbs statisticalm echanics as the deform ation param eter approaches to zero. The distribution $f=\exp _{f} \quad E+\quad$ obtained $w$ ith in this statistical mechanics show s a power law tail and depends on the non speci ed param eter, containing all the $\mathrm{R}^{\text {in form }}$ ation about the tem perature of the system. On the other hand, the entropic form $S=d^{3} p\left(c f^{1+}+c f^{1}\right)$, which after $m$ axim ization produces the distribution $f$ and reduces to the standard B oltzm ann-Shannon entropy $S_{0}$ as ! 0 , contains the coe cient $c$ whose expression involves, beside the Boltzm ann constant, another non speci ed param eter.

In the present $e$ ort we show that $S$ is the unique existing entropy obtained by a continuous deform ation of $S_{0}$ and preserving unaltered its fundam entalproperties of concavity, additivity and extensivity. These properties of $S$ perm it to determ ine unequivocally the values of the above $m$ entioned param eters and . Subsequently, we explain the origin of the deform ation m echanism introduced by and show that this deform ation em erges naturally with in the E instein special relativity. Furthem ore, we extend the theory in order to treat statistical system $s$ in a tim e dependent and relativistic context. T hen, we show that it is possible to determ ine in a self consistent schem e with in the special relativity the values of the free param eter which results to depend on the light speed c and reduces to zero as c! 1 recovering in this way the ordinary statisticalm echanics and therm odynam ics. The novel statisticalm echan ics here presented preserves unaltered the $m$ athem atical and epistem ological structure of the ordinary statistical m echanics and is suitable to describe a very large class of experim entally observed phenom ena in low and high energy physics and in natural, econom ic and social sciences. F inally, in order to test the correctness and predictability of the theory, as working exam ple we consider the cosm ic rays spectrum, which spans 13 decades in energy and 33 decades in ux, nding a high quality agreem ent between our predictions and observed data.

## I. IN TRODUCTION

T he follow ing one-param eter deform ations of the exponential and logarithm functions

which reduce to the standard exponential and logarithm respectively as the real deform ation param eter approachesto zero, hasbeen introduced recently in $\mathrm{Ref}$. [1] $\underline{1}_{1}^{1}$. The above functions have $m$ any very interesting proper-
 deform ed functions) that perm it to construct a statistical $m$ echanics (and them odynam ics) which generalizes the standard B oltzm ann-G ibbs one. T his -deform ed statistical m echanics preserves unaltered the structure of the ordinary one and can be used to explain a very large class

[^0]of experim entally observed phenom ena described by distribution functions exhibiting power law tails. T he areas where this form alism can be applied include am ong others, low and high energy physics, astrophysics, econophysics, geology, biology, m athem atics, inform ation the-


In ref. [1] [1t has been show $n$ that the statistical distribution

w hich generalizes the B oltzm ann-G ibbs distribution, can be obtained also by $m$ axim izing, after properly constrained, the entropy

which reduces to the standard entropy $S_{0}$ as the defor$m$ ation param eter approaches to zero. The coe cientc , which also absonbs the B oltzm ann constant $k_{B}$, depends on a free param eter (see Eq. (65) of ref. rem ains to be determ ined together $w$ ith the param eter which contains the inform ation about the tem perature T of the system .

A rst question which arises naturally is if it is possible and how to nd any criterion which allows us to $x$ the param eters and or at least express these in term $s$ of the deform ation param eter, in order to reduce the free param eters of the theory.

A second question regards the properties of the entropy $S$. It is well known that the Boltzm ann-Shannon entropy $S_{0}$ is concave, additive and extensive. W e know that $S$ is concave $w$ ith respect to the variable $f$, but what happens about its additivity and extensivity? M ore in general, beside the B oltzm ann-Shannon entropy other concave, additive and extensive entropies do exist?

A third question is related to the physicalm echanism which originates the deform ation introduced by the param eter. In otherw ords, does a $m$ ore fiundam ental theory exist where this deform ation em erges, or is it sim ply a purely $m$ athem atical tool?

A fourth question is if it is possible to extend the theory originally developed in the fram ew ork of a classical kinetics to treat statistical system $s$ in the context of a relativistic kinetics.

A th question regards the deform ation param eter. $T$ his param eter w ill continue to rem ain free or is it possible to determ ine its value self consistently w ithin the theory?
$T$ he present paper deals $w$ ith the above questions and its purpose is double. Firstly, we will show that $S$ is the unique existing, concave, additive and extensive entropy, beside the B oltzm ann-Shannon entropy. A swew ill see these properties of $S$ are su cient to determ ine unequivocally the values of param eters and. Secondly, we will show that the deform ation introduced by is a purely relativistic e ect and then we will explain the deform ation $m$ echanism $w$ ithin the Einstein special relativity. Then, we will form ulate a relativistic kinetics and we will calculate the value of .

F inally, in order to test the predictability and correctness of theory here proposed we will consider tw o sets of experim entaldata. In particular we will analyze the cos$m$ ic rays spectrum which spans 13 decades in energy and 33 decades in particle ux that, as it is widely known, violates the B oltzm ann-G ibbs statistics. A s we w ill see, we have a high quality agreem ent betw een the theory and the observed data.

The paper is organized as it follow s. In Sect. II, generalizing the approach proposed in ref.s [1] a class of one param eter deform ed structures and study their $m$ athem atical properties.

In Sect. III, within this context, starting from the Jaynesm axim um entropy principle we consider the most generalclass of deform ed statisticalm echanics preserving the $m$ ain features of the standard B oltzm ann-G ibbs one.

In Sect. IV, we show that the entropy $S$ introduced in ref. [ill is the only one existing beside the B oltzm annShannon entropy $S_{0}$ which is sim ultaneously concave, additive and extensive. Then the statisticalm echanics and therm odynam ics based on $S$ can be view ed as a natural extension of the Boltzm ann-G ibbs one, recovering this
last as the deform ation param eter approaches to zero.
In Sect. $V$, we consider the $m$ ean properties of exponential and -logarithm which have a fundam ental role in the formulation of the new statisticalm echanics.

In Sect. VI, we extend the form alism to a tim e dependent and relativistic context. In particular after introducing the relativistic -kinetic evolution equation we study its stationary state and prove the $H$-theorem .

In Sect. V II, we explain the origin of the -deform ation and show that it em erges naturally $w$ thin the $E$ instein special relativity.

In Sect. V III, we propose an approach which perm its to determ ine w ithin the special relativity the value of the param eter .

In Sect. IX, we com pare tw o sets of experim entaldata w ith the predictions of the present theory.

Finally in Sect. X , som e concluding rem arks are reported.
II. DEFORMEDMATHEMATICS
A. G enerator of the $D$ eform ation

Let $g(x)$ be an arbitrary real function of the real variable $x$, that we call generator of the deform ation, having the follow ing properties

In the follow ing, in analogy w ith the standard statistical mechanics, we require that I must be expressed as the $m$ ean value of $\ln _{f} n$. The new relativistic kinetics here presented, in the lim $\underset{\underline{t}}{ } \mathrm{c}!1$, reduces to the classicalkinetics considered in [1]

By using the standard notation of the relativistic theory we denote w th $\mathrm{x}=\mathrm{x}=$ (ct; x ) the four-vector position and w ith $p \overline{\bar{p}} p=\left(p^{0} ; p\right)$ the four-vector $m o^{-}$ $m$ entum, being $p^{0}=\overline{p^{2}+m^{2} c^{2}}$ and em ploy the $m$ etric $\mathrm{g}=\operatorname{diag}(1 ; 1 ; 1 ; 1){ }_{2}^{[170]}$.

W e anticipate that this new relativistic kinetics, which we w ill consider here, de nes a statistics resulting to be independent on the particular form of the function a (f).

VII. PHYSICALMEANINGOFTHE - EFORMATION

In the present section we will show that the deform ation introduced by the param eter em erges naturally within the E instein's special relativity, so that one can see the -deform ation as a purely relativistic e ect.

U nexpectedly we discover that the -sum is the additivity law for the relativistic m om enta. Eq.(7) which we w rite in the form

$W$ e can easily explain the $m$ eaning of the deform ed derivative. $W$ e indicate $w$ th $p$ the relativistic $m$ om entum in the frame $S$, and $w$ ith $d G=d p$ the derivative $w$ ith respect to $p$ of the Lorentz invariant scalar $G$. T he sam e quantities in the frame $S^{0}$ are indicated w ith $p^{0}$ and $d G=d p{ }^{0}$, respectively. It is trivial to verify that

> VIII. DETERMINATION OF THE PARAMETER

In the present section we calculate the value of the param eter which, due to the symmetry $\$$ of the theory, we consider positive, nam ely $0<1$. C learly if we start from the -statistical distributions $f_{1}$ and $f_{2}$ describing two independent statistical system $s$, we can construct the distribution $f_{1} \quad f_{2}$ which describes a new com posite system. This system in the case $=0$ reduces to the one described through the distribution $f_{1} f_{2}$. In the follow ing we w ill assum $e$ that the distribution $f_{1} f_{2}$ describes a state also in the case $\in 0$. Obviously this state is di erent from the one described by $f_{1} \quad f_{2}$. As wew illsee, this sim ple butm eaningfulhypothesis is su cient to determ ine the value of in the case of relativistic system s.

## IX. EXPERIMENTALEVIDENCES

Since long tim e it is known that the cosm ic rays spectrum, which extends over 13 decades in energy, from a few hundred of $\mathrm{M} \mathrm{eV}\left(10^{8} \mathrm{eV}\right)$ to a few hundred of EeV ( $10^{20} \mathrm{eV}$ ) and spans 33 decades in particle ux, from 10 to $\left.10^{29} \mathrm{~m}^{2} \mathrm{srsGeV}\right]^{1}$, is not exponential and then it violates the Boltzm ann equilibrium statistical distribution $/ \exp \left(\mathrm{E}=\mathrm{k}_{\mathrm{B}} \mathrm{T}\right)[22,123,1]$. A pproxim ately this spectrum follow sa pow er law E a and the spectralindex $a$ is near 2.7 below $5 \quad 10^{45} \mathrm{eV}$, near 3.1 above $5 \quad 10^{5}$ eV and again near 2.7 above $3 \quad 10^{18} \mathrm{eV}$. On the other

hand it is know $n$ that the particles com posing the cosm ic rays are essentially the norm al nuclei as in the standard cosm ic abundances ofm atter. T hen the cosm ic rays can be viewed as an equivalent statistical system of identical relativistic particles $w$ th $m$ asses near the $m$ ass of the proton ( 938 M EV ).

T hese above characteristics (relativistic particles w ith a very large extension both for their $u x$ and energy) yield the cosm ic rays spectrum an ideal physical system for a prelim inary test of the correctness and predictability of the theory here proposed.
$W$ e consider the statistical distribution $f(\mathbb{E})$ given by Eq. (6.eq) or (8.9). The particle ux (E)/ $\overline{\mathrm{p}} \mathrm{f}(\mathrm{E})$ can be calculated trivially if we take into account the relativistic expression linking E and p obtaining

W e use these two theoretical distributions of particle ux to $t$ the cosm ic raysdata reported in ref.' [2] 4]. In

4, we show the observed data together w ith the theoreticalcurves (E) (solid line) and 0 ( $E$ ) (dotted line). The curve (E) corresponding to $A=10^{5}\left[\mathrm{~m}^{2} \mathrm{srsGeV}\right]^{1}$, $\mathrm{mc}^{2}=938 \mathrm{M} \mathrm{eV},=375 \mathrm{M} \mathrm{eV}$, and $=0.2165 \mathrm{pro}-$ vides a high quality agreem ent w th the observed data. This agreem ent over so many decades is quite rem ankable. From the value of and $\mathrm{m} \mathrm{c}^{2}$ and adopting Eq. (8.7.1) we obtain that $\mathrm{k}_{\mathrm{B}} \mathrm{T}=208 \mathrm{M} \mathrm{eV}$.

In the same gure the curve $0(E)$ (w ith $A_{0}=1: 3 \quad I^{4} 0$ $m^{2}$ srsGeV ] ${ }^{1}, \mathrm{~m} \mathrm{c}^{2}=938 \mathrm{MeV}$ and $\mathrm{k}_{\mathrm{B}} \mathrm{T}=208 \mathrm{M} \mathrm{eV}$ ) which decays exponentially and can not $t$ the observed data violating the Boltzm ann-G ibbs statistics, is reported.

A short rem ark $m$ ust be $m$ ade at this point. $C$ learly, the pow er law asym ptotic behavior of the spectrum ( $\mathbb{E}$ ) is im posed by the -exponential whose origin is the sum. But the sum em erges naturally $w$ thin the special relativity as the com position law of the relativistic m om enta. Then we can conclude that the power law asym ptotic behavior of the cosm ic rays ux is sim ply the signature of the particle relativistic nature.

It is w idely known that the Boltzm ann-G ibbs distribution $\exp \left(\mathrm{E}=\mathrm{k}_{\mathrm{B}} \mathrm{T}\right.$ ) originally proposed to describe a classical particle gas in them odynam ic equilibrium can be adopted to describe an enorm ous am ount of phenom ena in nature. On the other hand the power law tails
have been observed experim entally in several elds ofscience. Som e tim es in particular elds, this power law has a name (e.g. Pareto law in econophysics, $G$ utenberg$R$ ichter law in seism ology etc). Furthem ore the power law tail is preceded by an exponential region and betw een the tw o regions exists a third interm ediate region. It is worth rem arking that the exponential de nes a distribution which can describe sim ultaneously the three above regions (see g.1) and then is particularly suitable to describe the above $m$ entioned phenom ena.

As a working exam ple we analyze the experim ental data reported in ref. [id related to the rain events in $m$ eteorology. In $g$. 5 is plotted the num ber density N [events/ (yearm m) ] of rain events versus the event size M [mm] on a double logarithm ic scale. W e note that the data have a large extension (the abscissa spans 7 decades and the ordinate 5) and rem ark that its behavior is typicalofa class ofexperim entaldata which we nd in several areas of science. In order to $t$ the experim entaldata we adopt the distribution

and, as one can see in g. 5, a rem arkable agreem ent is obtained w ith $\mathrm{A}=8 \quad 1^{40}[$ events/ (year mm)], $=75$ $\left[\mathrm{mm}^{1}\right]$ and $=0: 7$.

C learly, one can hunt otherm echanism s , di erent from the relativistic one, leading to -statistics. Beside the im portant problem of the agreem ent betw een the theoreti-
calcurve and the observationaldata one does not neglect the epistem ological problem conceming the structure of the theory which $m$ ust be able both to explain the origin and to determ ine the value of any param eter appearing w thin the theory.

> X. CONCLUSION S

We summarize brie $y$ the results obtained in the present e ort. $W$ e have shown that beside the Boltzm ann-Shannon entropy, the quantity

Starting from this entropy it is possible to construct a generalized statistical m echanics (and ther$m$ odynam ics) having the sam em athem atical and epistem ologicalstructure of the B oltzm ann-G ibbs one, which is recovered when the deform ation param eter approaches to zero. W ithin this generalized statistics the distribution function assum es the form

xed by the norm alization condition. This distribution has a bulk very close to the exponential one while its tail decays follow ing a pow er law $\mathrm{n}_{\mathrm{i}} / \mathrm{E}_{\mathrm{i}}{ }^{1=}$.
$T$ he origin of the deform ation has its roots in the $E$ instein special relativity and the relativistic statistical system s are govemed by a kinetics obeying the $H$ theorem.

W e have shown that, within the special relativity, it is possible to determ ine the value of , obtaining in this case

so that the relativistic statistical $m$ eechanics does not contain free param eters.

The theory can describe observational data in $m$ any elds. In particular we nd a high quality agreem ent in analyzing the spectrum of the cosm ic rays w hich violates m anifestly the Boltzm ann-G ibbs statistics. This is an im portant test for the theory because the cosm ic rays are relativistic particles and their spectrum has a very large extension (13 decades in energy and 33 decades in ux).
