Statistical theory of the continuous double auction

Most modern nancial markets use a continuous double auction mechanism to store and match orders and facilitate trading. In this paper we develop a m icroscopic dynam ical statistical m odel for the continuous double auction under the assumption of IID random order ow, and analyze it using simulation, dimensional analysis, and theoretical tools based on mean eld approximations. The m odel m akes testable predictions for basic properties of m arkets, such as price volatility, the depth of stored supply and dem and vs. price, the bid-ask spread, the price in pact function, and the tim e and probability of lling orders. These predictions are based on properties of order ow and the lim it order book, such as share volum e of market and lim it orders, cancellations, typical order size, and tick size. Because these quantities can all be measured directly there are no free param eters. We show that the order size, which can be cast as a nondimensional granularity parameter, is in m ost cases a more signi cant determ inant of market behavior than tick size. We also provide an explanation for the observed highly concave nature of the price impact function. On a broader level, this work suggests how stochastic models based on zero-intelligence agents may be useful to probe the structure of m arket institutions. Like the m odel of perfect rationality, a stochastic-zero intelligence model can be used to make strong predictions based on a compact set of assumptions, even if these assumptions are not fully believable.

I. INTRODUCTION

This section provides background and motivation, a description of the model, and some historical context for work in this area. Section II gives an overview of the phenom enology of the model, explaining how dimensional analysis applies in this context, and presenting a sum mary of numerical results. Section III develops an analytic treatment of model, explaining some of the numerical ndings of Section II. We conclude in Section IV with a discussion of how the model may be enhanced to bring it closer to real-life markets, and some comments comparing the approach taken here to standard models based on information arrival and valuation.

A. M otivation

In this paper we analyze the continuous double auction trading mechanism under the assumption of random order ow, developing am odel introduced in [1]. This analysis produces quantitative predictions about the most basic properties of markets, such as volatility, depth of stored supply and dem and, the bid-ask spread, the price impact, and probability and time to 11. These predictions are based on the rate at which orders ow into the m arket, and other param eters of the m arket, such as order size and tick size. The predictions are falsi able with no free param eters. This extends the original random walk model of Bachelier [2] by providing a basis for the di usion rate of prices. The model also provides a possible explanation for the highly concave nature of the price im pact function. Even though some of the assumptions of the model are too simple to be literally true, the model provides a foundation onto which more realistic assum ptions m ay easily be added.

The model demonstrates the importance of nancial institutions in setting prices, and how solving a necessary econom ic function such as providing liquidity can have unanticipated side-e ects. In a world of imperfect rationality and imperfect information, the task of dem and storage necessarily causes persistence. Under perfect rationality all traders would instantly update their orders with the arrival of each piece of new information, but this is clearly not true for realm arkets. The lim it order book, which is the queue used for storing unexecuted orders, has long m em ory when there are persistent orders. It can be regarded as a device for storing supply and dem and, som ew hat like a capacitor is a device for storing charge. W e show that even under com pletely random IID order ow, the price process displays anom alous di usion and interesting tem poral structure. The converse is also interesting: For prices to be e ectively random , incom ing order ow must be non-random, in just the right way to compensate for the persistence. (See the remarks in Section IV C .)

This work is also of interest from a fundam ental point of view because it suggests an alternative approach to

doing econom ics. The assumption of perfect rationality has been popular in econom ics because it provides a parsim onious model that makes strong predictions. In the spirit of G ode and Sunder [3], we show that the opposite extrem e of zero intelligence random behavior provides another reference model that also makes very strong predictions. Like perfect rationality, zero intelligence is an extrem e sim pli cation that is obviously not literally true. But as we show here, it provides a usefultool for probing the behavior of nancial institutions. The resulting m odelm ay easily be extended by introducing simple boundedly rational behaviors. We also dier from standard treatments in that we do not attempt to understand the properties of prices from fundam entalassum ptions about utility. Rather, we split the problem in two. We attempt to understand how prices depend on order ow rates, leaving the problem of what determ ines these order ow rates for the future.

One of our main results concerns the average price impact function. The liquidity for executing a market order can be characterized by a price impact function p = (!; ;t). p is the shift in the logarithm of the price at time t + caused by a market order of size ! placed at time t. Understanding price impact is important for practical reasons such as minimizing transaction costs, and also because it is closely related to an excess dem and function¹, providing a natural starting point for theories of statistical or dynamical properties of markets [4, 5]. A naive argument predicts that the price impact

(!) should increase at least linearly. This argument goes as follows: Fractional price changes should not depend on the scale of price. Suppose buying a single share raises the price by a factor k > 1. If k is constant, buying ! shares in succession should raise it by $k^!$. Thus, if buying ! shares all at once a ects the price at least as much as buying them one at a time, the ratio of prices before and after in pact should increase at least exponentially. Taking logarithms in plies that the price in pact as we have de ned it above should increase at least linearly.²

In contrast, from empirical studies (!) for buy orders appears to be concave [6, 7, 8, 9, 10, 11]. Lillo et al. have shown for that for stocks in the NYSE the concave behavior of the price impact is quite consistent across di erent stocks [11]. Our model produces concave price impact functions that are in qualitative agreement with these results.

Our work also dem onstrates the value of physics techniques for econom ic problem s. Our analysism akes exten-

sive use of dim ensional analysis, the solution of a m aster equation through a generating functional, and a mean eld approach that is commonly used to analyze nonequilibrium reaction-di usion systems and evaporationdeposition problem s.

B. Background: The continuous double auction

Most modern nancial markets operate continuously. The m ism atch between buyers and sellers that typically exists at any given instant is solved via an order-based market with two basic kinds of orders. Impatient traders subm it market orders, which are requests to buy or sell a given num ber of shares im m ediately at the best available price. M ore patient traders subm it lim it orders, or quotes which also state a lim it price, corresponding to the worst allow able price for the transaction. (Note that the word \quote" can be used either to refer to the lim it. price or to the lim it order itself.) Lim it orders often fail to result in an immediate transaction, and are stored in a queue called the lim it order book. Buy lim it orders are called bids, and sell lim it orders are called o ers or asks. We use the logarithm ic price a (t) to denote the position of the best (lowest) o er and b(t) for the position the best (highest) bid. These are also called the inside quotes. There is typically a non-zero price gap between them, called the spread s(t) = a(t)b(t). Prices are not continuous, but rather have discrete quanta called ticks. Throughout this paper, all prices will be expressed as logarithms, and to avoid endless repetition, the word price will mean the logarithm of the price. The minimum interval that prices change on is the tick size dp (also dened on a logarithm ic scale; note this is not true for real markets). Note that dp is not necessarily in nitesimal.

A sm arket orders arrive they are m atched against lim it orders of the opposite sign in order of rst price and then arrivaltime, as shown in Fig. 1. Because orders are placed for varying numbers of shares, matching is not necessarily one-to-one. For example, suppose the best o er is for 200 shares at \$60 and the the next best is for 300 shares at \$60,25; a buy m arket order for 250 shares buys 200 shares at \$60 and 50 shares at \$60,25, m oving the best o er a (t) from \$60 to \$60.25. A high density of lim it orders per price results in high liquidity for market orders, i.e., it decreases the price movem ent when a market order is placed. Let n (p;t) be the stored density of lim it order volum e at price p, which we will call the depth pro le of the lim it order book at any given time t. The total stored lim it order volum e at price level p is n (p;t)dp. For unit order size the shift in the best ask a (t) produced by a buy market order is given by solving the equation

instantaneous price in pact for buy market orders. A similar statement applies for sell market orders, where the price in pact can be de ned in terms of the shift in the best bid. (A lternatively, it is also possible to de ne the price in pact in terms of the change in the midpoint price).

W e will refer to a buy lim it order whose lim it price is greater than the best ask, or a sell lim it order whose lim it price is less than the best bid, as a crossing lim it order or m arketable lim it order. Such lim it orders result in im m ediate transactions, with at least part of the order im m ediately executed.

C. The model

This model introduced in reference [1], is designed to be as analytically tractable as possible while capturing key features of the continuous double auction. All the order ows are modeled as Poisson processes. We assume that market orders arrive in chunks of shares, at a rate of shares per unit time. The market order may be a buy' order or a bell' order with equal probability. (Thus the rate at which buy orders or sell orders arrive individually is =2.) Limit orders arrive in chunks of shares as well, at a rate shares per unit price and per unit time for buy orders and also for sell orders. 0 ers are placed with uniform probability at integer multiples of a tick size dp in the range of price b(t) , andsimilarly for bids on 1 . When a marketorder arrives it causes a transaction; under the assum ption of constant order size, a buy market order rem oves an o er at price a (t), and if it was the last o er at that price, moves the best ask up to the next occupied price tick. Sim ilarly, a sellm arket order rem oves a bid at price b(t), and if it is the last bid at that price, moves the best bid down to the next occupied price tick. In addition, lim it orders m ay also be rem oved spontaneously by being canceled or by expiring, even without a transaction having taken place. We model this by letting them be rem oved random ly with constant probability per un it time.

W hile the assumption of lim it order placem ent over an in nite interval is clearly unrealistic, it provides a tractable boundary condition for modeling the behavior of the limit order book near the midpoint price m(t) = (a(t) + b(t)) = 2, which is the region of interest since it is where transactions occur. Lim it orders far from the m idpoint are usually canceled before they are executed (we demonstrate this later in Fig. 5), and so far from the m idpoint, lim it order arrival and cancellation have a steady state behavior characterized by a simple Poisson distribution. A lthough under the lim it order placem ent process the total num ber of orders placed per unit time is in nite, the order placem ent per unit price interval is bounded and thus the assumption of an in nite interval creates no problem s. Indeed, it guarantees that there are always an in nite number of limit orders of both signs stored in the book, so that the bid and ask are always well-de ned and the book never empties. (Under other assumptions about lim it order placem ent this is not necessarily true, as we later dem onstrate in Fig. 30.) We are also considering versions of the model involving more realistic order placem ent functions; see the discussion in Section IV B.

In this model, to keep things simple, we are using the conceptual simpli cation of e ective market orders and e ective limit orders. When a crossing limit order is placed part of it may be executed in mediately. The e ect of this part on the price is indistinguishable from that of a market order of the same size. Sim ilarly, given that this market order has been placed, the remaining part is equivalent to a non-crossing limit order of the same size. Thus a crossing limit order can be modeled as an e ective market order followed by an elective (non-crossing) limit order.³ W orking in terms of elective market and limit orders a ects data analysis: The elective market orders

and the immediately executed components of crossing limit orders, and similarly the limit order arrival rate corresponds only to the components of limit orders that are not executed immediately. This is consistent with the boundary conditions for the order placement process, since an o erwith p b(t) or a bid with p a(t) would result in an immediate transaction, and thus would be effectively the same as a market order. Dening the order placement process with these boundary conditions realistically allows limit orders to be placed anywhere inside the spread.

A nother sim pli cation of this model is the use of logarithm ic prices, both for the order placem ent process and for the tick size dp. This has the important advantage that it ensures that prices are always positive. In real markets price ticks are linear, and the use of logarithm ic price ticks is an approximation that makes both the calculations and the simulation more convenient. We nd that the limit dp ! 0, where tick size is irrelevant, is a good approximation for many purposes. We nd that tick size is less important than other parameters of the problem, which provides some justication for the approximation of logarithm ic price ticks.

A ssum ing a constant probability for cancellation is clearly ad hoc, but in simulations we nd that other assumptions with well-de ned timescales, such as constant duration time, give similar results. For our analytic model we use a constant order size . In simulations we also use variable order size, <u>e.g.</u> half-norm aldistributions with standard deviation =2, which ensures that the mean value remains . As long as these distributions have thin tails, the di erences do not qualitatively affect most of the results reported here, except in a trivial way. As discussed in Section IV B, decay processes without well-de ned characteristic times and size distributions with power law tails give qualitatively di erent results and will be treated elsew here.

Even though this model is simply de ned, the time evolution is not trivial. One can think of the dynam ics as being composed of three parts: (1) the buy market order/sell lim it order interaction, which determ ines the best ask; (2) the sell market order/buy lim it order interaction, which determ ines the best bid; and (3) the random cancellation process. Processes (1) and (2) determ ine each others' boundary conditions. That is, process (1) determ ines the best ask, which sets the boundary condition for limit order placement in process (2), and process (2) determines the best bid, which determ ines the boundary conditions for lim it order placem ent in process (1). Thus processes (1) and (2) are strongly coupled. It is this coupling that causes the bid and ask to remain close to each other, and quarantees that the spread s(t) = a(t) b(t) is a stationary random variable, even though the bid and ask are not. It is the coupling of these processes through their boundary conditions that provides the nonlinear feedback that makes the price process com plex.

³ In assigning independently random distributions for the two events, our m odel neglects the correlation between m arket and lim it order arrival induced by crossing lim it orders.

D. Sum mary of prior work

There are two independent lines of prior work, one in the nancial econom ics literature, and the other in the physics literature. The models in the econom ics literature are directed tow ard empirical analysis, and treat the order process as static. In contrast, the models in the physics literature are conceptual toy models, but they allow the order process to react to changes in prices, and are thus fully dynam ic. O urm odelbridges this gap. This is explained in more detail below.

The rst model of this type that we are aware of was due to M endelson [12], who m odeled random order placement with periodic clearing. This was developed along di erent directions by Cohen et al. [13], who used techniques from queuing theory, but assumed only one price level and addressed the issue of time priority at that level (motivated by the existence of a specialist who e ectively pinned prices to make them stationary). Dom ow itz and W ang [14] and Bollerslev et al. [15] further developed this to allow more general order placem ent processes that depend on prices, but without solving the full dynam icalproblem. This allows them to get a stationary solution for prices. In contrast, in our model the prices that emerge make a random walk, and so are much more realistic. In order to get a solution for the depth of the order book we have to go into price coordinates that comove with the random walk. Dealing with the feedback between order placem ent and prices makes the problem much more di cult, but it is key for getting reasonable results.

The models in the physics literature incorporate price dynam ics, but have tended to be conceptual toy models designed to understand the anom alous di usion properties of prices. This line of work begins with a paper by Bak et al. [16] which was developed by E liezer and K ogan [17] and by Tang [18]. They assume that lim it orders are placed at a xed distance from the midpoint, and that the lim it prices of these orders are then random ly shufed until they result in transactions. It is the random shu ing that causes price di usion. This assumption, which we feel is unrealistic, was made to take advantage of the analogy to a standard reaction-di usion m odel in the physics literature. M aslov [19] introduced an alterative m odel that was solved analytically in the mean-eld lim it by Slanina [20]. Each order is random ly chosen to be either a buy or a sell, and either a lim it order or a m arket order. If a lim it order, it is random ly placed within a xed distance of the current price. This again gives rise to anom alous price di usion. A model allowing limit orders with Poisson order cancellation was proposed by Challet and Stinchcombe [21]. Iori and Chiarella [22] have num erically studied a m odel including fundam entalists and technical traders.

The model studied in this paper was introduced by Daniels et al. [1]. This adds to the literature by introducing a model that treats the feedback between order placem ent and price movem ent, while having enough realism so that the parameters can be tested against real data. The prior models in the physics literature have tended to focus primarily on the anom abus di usion of prices. W hile interesting and important for rening risk calculations, this is a second-order e ect. In contrast, we focus on the rst order e ects of primary interest to market participants, such as the bid-ask spread, volatility, depth pro le, price impact, and the probability and time to ll an order. We demonstrate how dimensional analysis becomes a useful tool in an economic setting, and develop mean eld theories in a context that is more challenging than that of the toy models of previous work.

Subsequent to reference [1], Bouchaud et al. [23] dem onstrated that, under the assumption that prices execute a random walk, by introducing an additional free param eter they can derive a simple equation for the depth prole. In this paper we show how to do this from rst principles without introducing a free param eter.

II. OVERVIEW OF PREDICTIONS OF THE MODEL

In this section we give an overview of the phenom enology of the model. Because this model has ve parameters, understanding all their e ects would generally be a complicated problem in and of itself. This task is greatly simplied by the use of dimensional analysis, which reduces the number of independent parameters from ve to two. Thus, before we can even review the results, we need to rst explain how dimensional analysis applies in this setting. One of the suprising aspects of this model is that one can derive several powerful results using the simple technique of dimensional analysis alone.

Unless otherwise mentioned the results presented in this section are based on simulations. These results are compared to theoretical predictions in Section III.

A. D im ensional analysis

Because dimensional analysis is not commonly used in economics we rst present a brief review. For more details see Bridgm an [24].

D in ensional analysis is a technique that is commonly used in physics and engineering to reduce the number of independent degrees of freedom by taking advantage of the constraints in posed by dimensionality. For sufciently constrained problem s it can be used to guess the answer to a problem without doing a full analysis. The idea is to write down all the factors that a given phenomenon can depend on, and then nd the combination that has the correct dimensions. For example, consider the problem of the period of a pendulum : The period T has dimensions of time. O bvious candidates that itm ight depend on are them assofthe bob m (which has units of mass), the length 1 (which has units of distance), and the acceleration of gravity g (which has units

of distance=tim e^2). There is only one way to combine these to produce som ething with dim ensions of time, i.e. Т l=g. This determ ines the correct form ula for the period of a pendulum up to a constant. Note that it makes it clear that the period does not depend on the mass, a result that is not obvious a priori. We were lucky in this problem because there were three param eters and three dimensions, with a unique combination of the param eters having the right dim ensions; in general dim ensional analysis can only be used to reduce the num ber of free param eters through the constraints in posed by their dim ensions.

For this problem the three fundam ental dim ensions in them odelare shares, price, and time. Note that by price, we mean the logarithm of price; as long as we are consistent, this does not create problem swith the dimensional analysis. There are ve parameters: three rate constants and two discreteness parameters. The order ow rates are , the market order arrival rate, with dimensions of shares per time; , the limit order arrival rate per unit price, with dimensions of shares per price per time; and , the rate of lim it order decays, with dim ensions of 1/time. These play a role similar to rate constants in physical problem s. The two discreteness parameters are the price tick size dp, with dimensions of price, and the order size

, with dimensions of shares. This is summarized in table I.

D in ensional analysis can be used to reduce the num ber of relevant parameters. Because there are ve param eters and three dim ensions (price, shares, tim e), and because in this case the dimensionality of the parameters is su ciently rich, the dimensional relationships reduce the degrees of freedom, so that all the properties of the lim it-order book can be described by functions of two param eters. It is useful to construct these two param eters so that they are nondim ensional.

We perform the dimensional reduction of the model by guessing that the e ect of the order ow rates is prim ary to that of the discreteness param eters. This leads us to construct nondim ensional units based on the order ow param eters alone, and take nondim ensionalized versions of the discreteness param eters as the independent param eters whose e ects remain to be understood. As we will see, this is justied by the fact that many of the properties of the model depend only weakly on the discreteness param eters. W e can thus understand much of the richness of the phenom enology of the model through

nondim ensional order size

dim ensional analysis alone.

There are three order ow rates and three fundam entaldimensions. If we tem porarily ignore the discreteness param eters, there are unique combinations of the order ow rates with units of shares, price, and time. These de ne a characteristic num ber of shares N $_{\rm c}$ = =2 , a characteristic price interval $p_c = =2$, and a characteristic tim escale $t_{\rm c}$ = 1= $% t_{\rm c}$. This is sum marized in table II. The factors of two occur because we have de ned the market order rate for either a buy or a sell order to be =2. We can thus express everything in the model in nondim ensional term s by dividing by N_c, p_c, or t_c as appropriate, e.g. to m easure shares in nondim ensional units $\hat{N} = N = N_{c}$, or to measure price in nondimensional units $\hat{p} = p = p_c$.




FIG.2: The usefulness of nondim ensional units. (a) W e show the average depth prole for three di erent param eter sets. The param eters = 0.5, = 1, and dp = 0 are held constant, while and are varied. The line types are: (dotted) = 0.001, = 0.2; (dashed) = 0.002, = 0.4 and (solid) = 0.004, = 0.8. (b) is the same, but plotted in nondim ensional units. The horizontal axis has units of price, and so has nondim ensional units $\hat{p} = p=pc = 2 p=$. The vertical axis has units of n shares/price, and so has nondim ensional units $\hat{n} = np_c=N_c = n =$. Because we have chosen the param eters to keep the nondim ensional order size constant, the collapse is perfect. Varying the tick size has little e ect on the results other than making them discrete.

The value of using nondim ensional units is illustrated in Fig. 2. Fig. 2 (a) shows the average depth pro le for three di erent values of and with the other param etersheld xed. W hen we plot these results in dim ensional units the results look quite di erent. How ever, when we plot them in terms of nondimensional units, as shown in Fig. 2(b), the results are indistinguishable. As explained below, because we have kept the nondim ensional order size xed, the collapse is perfect. Thus, the problem of understanding the behavior of this model is reduced to studying the e ect of tick size and order size.

To understand the e ect of tick size and order size it is usefulto do so in nondim ensional term s. The nondim ensional scale param eter based on tick size is constructed by dividing by the characteristic price, i.e. $dp=p_c = 2 dp = .$ The theoretical analysis and the simulations show that there is a sensible continuum lim it as the tick size dp ! 0, in the sense that there is non-zero price di usion and a nite spread. Furtherm ore, the dependence on tick size is weak, and form any purposes the lim it dp! 0 approxin ates the case of nite tick size fairly well. As we will see, working in this lim it is essential for getting tractable analytic results.

A nondim ensional scale param eter based on order size is constructed by dividing the typical order size (which is measured in shares) by the characteristic number of shares N_c, i.e. =N, = 2 = . characterizes the \chunkiness" of the orders stored in the lim it order

book. A swe will see, is an important determ inant of liquidity, and it is a particularly important determ inant of volatility. In the continuum limit ! 0 there is no price di usion. This is because price di usion can occur only if there is a nite probability for price levels outside the spread to be empty, thus allowing the best bid or ask to make a persistent shift. If we let ! 0 while the average depth is held xed the number of individual orders becomes in nite, and the probability that spontaneous decays or market orders can create gaps outside the spread becomes zero. This is veriled in simulations. Thus the limit ! 0 is always a poor approximation to a realmarket. is a more important parameter than the tick size dp=pc. In the mean eld analysis in Section III,

is the lim it order density rate, is the market order rate, and is the spontaneous lim it order removal rate. These estimates are constructed by taking the combinations of these three rates that have the proper units. They neglect the dependence on on the order granularity and the nondimensional tick size dp= p_c . More accurate relations from simulation and theory are given in table IV.

we let $dp=p_c$! 0, reducing the number of independent parameters from two to one, and in many cases nd that this is a good approximation.

The order size can be thought of as the order granularity. Just as the properties of a beach with ne sand are quite di erent from that of one populated by st-sized boukders, a market with m any small orders behaves quite di erently from one with a few large orders. N $_{\rm c}$ provides the scale against which the order size is measured, and

characterizes the granularity in relative term s. A lternatively, 1= can be thought of as the annihilation rate from market orders expressed in units of the size of spontaneous decays. Note that in nondimensional units the number of shares can also be written $\hat{N} = N = N_c = N$ = .

The construction of the nondimensional granularity parameter illustrates the importance of including a spontaneous decay process in this model. If = 0 (which implies = 0) there is no spontaneous decay of orders, and depending on the relative values of and , generically either the depth of orders will accumulate without bound or the spread will become in nite. As long as > 0, in contrast, this is not a problem.

For some purposes the e ects of varying tick size and order size are fairly small, and we can derive approximate form ulas using dimensional analysis based only on the order ow rates. For example, in table III we give dim ensional scaling form ulas for the average spread, the m arket order liquidity (as m easured by the average slope of the depth pro le near them idpoint), the volatility, and the asymptotic depth (de ned below). Because these estim ates neglect the e ects of discreteness, they are only approxim ations of the true behavior of the model, which do a better job of explaining som e properties than others. Our num erical and analytical results show that som e quantities also depend on the granularity parameter and to a weaker extent on the tick size dp=pc. Nonetheless, the dimensional estimates based on order ow alone provide a good starting point for understanding m arket behavior. A comparison to more precise form ulas derived from theory and simulations is given in table IV.

An approximate formula for the mean spread can be derived by noting that it has dimensions of price, and the unique combination of order ow rates with these dimen-

sions is = . While the dimensions indicate the scaling of the spread, they cannot determ ine multiplicative factors of order unity. A more intuitive argument can be made by noting that inside the spread rem oval due to cancellation is dom inated by rem ovaldue to m arket orders. Thus the total lim it order placem ent rate inside the spread, for either buy or sell lim it orders s, must equal the order rem oval rate =2, which implies that spread is s = =2. Aswewillsee later, this argument can be generalized and made more precise within our mean-eld analysis which then also predicts the observed dependence on the granularity parameter . However this dependence is rather weak and only causes a variation of roughly a factor of two for < 1 (see Figs. 10 and 24), and the factor of 1=2derived above is a good rst approximation. Note that this prediction of the mean spread is just the characteristic price $p_{\rm c}$.

It is also easy to derive the mean asymptotic depth, which is the density of shares far away from the midpoint. The asymptotic depth is an articial construct of our assumption of order placement over an in nite interval; it should be regarded as providing a simple boundary condition so that we can study the behavior near them idpoint price. The mean asymptotic depth has dimensions of shares=price, and is therefore given by =. Furthermore, because removal by market orders is insignicant in this regime, it is determined by the balance between order placement and decay, and far from the midpoint the depth at any given price is Poisson distributed. This result is exact.

The average slope of the depth prole near the midpoint is an important determ inant of liquidity, since it a ects the expected price response when a market order arrives. The slope has dimensions of shares=price², which implies that in terms of the order ow rates it scales roughly as 2 . This is also the ratio of the asymptotic depth to the spread. As we will see later, this is a good approximation when 0.01, but for smaller values of the depth prole is not linear near the midpoint, and this approximation fails.

The last two entries in table IV are em pirical estim ates for the price di usion rate D, which is proportional to the square of the volatility. That is, for norm ald i usion, starting from a point at t = 0, the variance v after time t is v = D t. The volatility at any given timescale t is the square root of the variance at tim escale t. The estim ate for the di usion rate based on dim ensional analysis in terms of the order ow rates alone is $2^2 = 2^2$. However, simulations show that short time di usion is much faster than long tim e di usion, due to negative autocorrelations in the price process, as shown in Fig. 11. The initial and the asymptotic di usion rates appear to obey the scaling relationships given in table IV. Though our mean-eld theory is not able to predict this functional form, the fact that early and late time di usion rates are di erent can be understood within the fram ework of our analysis, as described in Sec. IIIE. A nom alous di usion of this type in plies negative autocorrelations in m idpoint prices. Note that we use the term \anom alous di usion" to imply that the di usion rate is di erent on short and long tim escales. W e do not use this term in the sense that it is norm ally used in the physics literature, i.e. that the long-time di usion is proportional to t with 🗧 1 (for long times = 1 in our case).

B. Varying the granularity param eter

We rst investigate the e ect of varying the order granularity in the lim it dp ! 0. As we will see, the granularity has an important e ect on most of the properties of the model, and particularly on depth, price impact, and price di usion. The behavior can be divided into three regimes, roughly as follows:

Large , i.e. > 0:1. This corresponds to a large accumulation of orders at the best bid and ask, nearly linearm arket im pact, and roughly equal short and long time price di usion rates. This is the regime where the mean-eld approximation used in the theoretical analysis works best.

M edium i.e. 0:01. In this range the accumulation of orders at the best bid and ask is small and near the midpoint price the depth prole increases nearly linearly with price. As a result, as a crude approximation the price in pact increases as roughly the square root of order size.

Sm all i.e. < 0.001. The accumulation of orders at the best bid and ask is very sm all, and near the m idpoint the depth prole is a convex function of price. The price in pact is very concave. The short time price di usion rate is much greater than the long time price di usion rate.

Since the results for bids are symmetric with those for o ers about p = 0, for convenience we only show the results for o ers, i.e. buy market orders and sell limit orders. In this sub-section prices are measured relative to the midpoint, and simulations are in the continuum limit where the tick size dp ! 0. The results in this section are from numerical simulations. A loo, bear in mind that far from the midpoint the predictions of this model are not valid due to the unrealistic assumption of an order placement process with an in nite domain. Thus the results are potentially relevant to realmarkets only when the price p is at most a few times as large as the characteristic price p_c .

1. Depth pro le




FIG.3: The mean depth pro le and cum ulative depth versus $p = p=p_c = 2 p=$. The origin $p=p_c = 0$ corresponds to the m idpoint. (a) is the average depth pro le n in nondim ensional coordinates $n = np_c=N_c = n = .$ (b) is nondim ensional cum ulative depth N (p)=N_c. We show three di erent values of the nondim ensional granularity parameter: = 0.2 (solid), = 0.02 (dash), = 0.02 (dot), all with tick size dp = 0.




FIG. 4: Standard deviation of the nondimensionalized cumulative depth versus nondimensional price, corresponding to Fig. (3).

The mean depth pro le, i.e. the average number of shares per price interval, and the mean cumulative depth pro le are shown in Fig. 3, and the standard deviation of the cumulative pro le is shown in Fig. 4. Since the depth pro le has units of shares/price, nondimensional units of depth pro le are $n = np_c=N_c = n = .$ The cumulative depth pro le at any given time t is de ned as

This has units of shares and so in nondimensional terms is $\hat{N}(p) = N(p) = N_c = 2 N(p) = -N(p) = -$

In the high regime the annihilation rate due to market orders is low (relative to), and there is a signi cant accumulation of orders at the best ask, so that the average depth is much greater than zero at the midpoint. The mean depth pro le is a concave function of price. In the medium regime the market order removal rate increases, depleting the average depth near the best ask, and the pro le is nearly linear over the range p=pc 1. In the small regime the market order removal rate increases even further, making the average depth near the ask very close to zero, and the pro le is a convex function over the range p=p_c 1.

The standard deviation of the depth prole is shown in Fig. 4. We see that the standard deviation of the cumulative depth is comparable to the mean depth, and that as increases, near the midpoint there is a similar transition from convex to concave behavior.




FIG. 5: A comparison between the depth pro les and the e ective depth pro les as de ned in the text, for di erent values of . Heavy lines refer to the e ective depth pro les n_e and the light lines correspond to the depth pro les.

The uniform order placement process seems at rst glance one of the most unrealistic assumptions of our model, leading to depth proles with a nite asymptotic depth (which also implies that there are an in nite num ber of orders in the book). However, orders far away from the spread in the asymptotic region almost never get executed and thus do not a ect the market dynam ics. To demonstrate this in Fig. 5 we show the comparison between the lim it-order depth prole and the depth

 $n_{\rm e}$ of only those orders which eventually get executed. The density $n_{\rm e}$ of executed orders decreases rapidly as a function of the distance from the mid-price. Therefore we expect that near the midpoint our results should be similar to alternative order placem ent processes, as long as they also lead to an exponentially decaying prole of executed orders (which is what we observe above). How - ever, to understand the behavior further away from the midpoint we are also working on enhancem ents that include m ore realistic order placem ent processes grounded on empirical measurem ents of market data, as sum marized in section IV B.

2. Liquidity for market orders: The price im pact function

In this sub-section we study the instantaneous price impact function (t; !; ! 0). This is de ned as the (logarithm of the) m idpoint price shift in m ediately after the arrival of a market order in the absence of any other events. This should be distinguished from the asymptotic price impact (t; !; ! 1), which describes the perm anent price shift. W hile the perm anent price shift is clearly very in portant, we do not study it here. The reader should bear in m ind that all prices p, a (t), etc. are logarithm ic.

The price in pact function provides a measure of the liquidity for executing market orders. (The liquidity for lim it orders, in contrast, is given by the probability of execution, studied in section IIB 5). At any given time t, the instantaneous (= 0) price in pact function is the




FIG.6: The average price in pact corresponding to the results in Fig. (3). The average instantaneous m ovem ent of the nondim ensionalm id-price, hdm $i=p_c$ caused by an order of size $N = N_c = N = ... = 0.2$ (solid), = 0.02 (dash), = 0.002 (dot).

inverse of the cumulative depth prole. This follows in – mediately from equations (1) and (2), which in the limit $dp \ ! \ 0$ can be replaced by the continuum transaction equation:

This equation makes it clear that at any xed t the price in pact can be regarded as the inverse of the cum ulative depth pro le N (p;t). W hen the uctuations are su ciently small we can replace n (p;t) by its mean value n(p) = hn(p;t)i. In general, however, the uctuations can be large, and the average of the inverse is not equal to the inverse of the average. There are corrections based on higher orderm om ents of the depth pro le, as given in the moment expansion derived in Appendix A1. Nonetheless, the inverse of the mean cumulative depth provides a qualitative approximation that gives insight into the behavior of the price in pact function. (Note that everything becomes much simpler using medians, since the median of the cumulative price impact function is exactly the inverse of the median price im pact, as derived in Appendix A 1).




FIG.7: The standard deviation of the instantaneous price impact dm = p_c corresponding to the means in Fig.6, as a function of normalized order size N = . = 0.2 (solid), = 0.02 (dash), = 0.02 (dot).

M ean price in pact functions are shown in Fig. 6 and the standard deviation of the price in pact is shown in Fig. 7. The price in pact exhibits very large uctuations for all values of : The standard deviation has the same order of magnitude as the mean or even greater for sm all N = values. Note that these are actually virtual price in pact functions. That is, to explore the behavior of the instantaneous price in pact for a wide range of order sizes, we periodically compute the price in pact that an order of a given size would have caused at that instant, if it had been submitted. We have checked that real price in pact curves are the same, but they require a much longer time to accum ulate reasonable statistics.

⁴ Note that the ratio n_e=n is not the same as the probability of lling orders (Fig. 12) because in that case the price p=p refers to the distance of the order from the m idpoint at the tim e when it was placed.




FIG.8: Derivative of the nondimensional mean mid-price movement, with respect to logarithm of the nondimensional order size N=N $_{\rm c}$ = N = , obtained from the price impact curves in Fig.6.

O ne of the interesting results in Fig. 6 is the scale of the price im pact. The price im pact is measured relative to the characteristic price scale p_c , which as we have mentioned earlier is roughly equal to the mean spread. As we will argue in relation to Fig. 8, the range of nondimensional shares shown on the horizontal axis spans the range of reasonable order sizes. This gure demonstrates that throughout this range the price is the order of magnitude (and typically less than) the mean spread size.

Due to the accumulation of orders at the ask in the large regime, for small p the mean price impact is roughly linear. This follows from equation (3) under the assumption that n (p) is constant. In the medium regime, under the assumption that the variance in depth can be neglected, the mean price impact should increase as roughly $!^{1=2}$. This follows from equation (3) under the assumption that n (p) is linearly increasing and n (0) 0. (Note that we see this as a crude approximation, but there can be substantial corrections caused by the variance of the depth prole). Finally, in the small

regime the price in pact is highly concave, increasing much slower than $!^{1=2}$. This follows because n (0) 0 and the depth pro len (p) is convex.

To get a better feel for the functional form of the price in pact function, in Fig. 8 we num erically di erentiate it versus log order size, and plot the result as a function of the appropriately scaled order size. (Note that because our prices are logarithm ic, the vertical axis a lready incorporates the logarithm). If we were to tallocal power law approximation to the function at each price, this corresponds to the exponent of that power law near that price. Notice that the exponent is alm ost always less than one, so that the price in pact is alm ost always concave. Making the assumption that the elect of the variance of the depth is not too large, so that equation (3) is a good assumption, the behavior of this gure can be understood as follows: For N = N_c 0 the price in pact is dom inated

by n (0) (the constant term in the average depth pro le) and so the logarithm ic slope of the price in pact is always near to one. As N=N_c increases, the logarithm ic slope is driven by the shape of the average depth pro le, which is linear or convex for sm aller , resulting in concave price in pact. For large values of N=N_c, we reach the asym ptotic region where the depth pro le is at (and where our m odel is invalid by design). O f course, there can be deviations to this behavior caused by the fact that the m ean of the inverse depth pro le is not in general the inverse of the m ean, i.e. hN ¹ (p) i \in hN (p) i ¹ (see App.A 1).

To compare to real data, note that $N \Rightarrow N_c = N = .$ N = is just the order size in shares in relation to the average order size, so by de nition it has a typical value of one. For the London Stock Exchange, we have found that typical values of are in the range 0.001 0:1. For a typical range of order sizes from 100 100;000 shares, with an average size of 10;000 shares, the meaning fulrange for $N \Rightarrow N_c$ is therefore roughly 10 ⁵ to 1. In this range, for small values of the exponent can reach values as low as 0.2. This o ers a possible explanation for the previously mysterious concave nature of the price in pact function, and contradicts the linear increase in price in pact based on the naive argum ent presented in the introduction.

3. Spread




FIG.9: The probability density function (a), and cum ulative distribution function (b) of the nondimensionalized bid-ask spread $s=p_c$, corresponding to the results in Fig. (3). = 0.2 (solid), = 0.02 (dash), = 0.022 (dot).

The probability density of the spread is shown in Fig.9. This shows that the probability density is substantial at $s=p_c = 0$. (Remember that this is in the limit dp ! 0). The probability density reaches a maximum at a value of the spread approximately $0.2p_c$, and then decays. It m ight seem surprising at rst that it decays more slow ly for large , where there is a large accumulation of orders at the ask. However, it should be borne in mind

that the characteristic price p_c = = depends on . Since = 2 = , by eliminating this can be written p_c = 2 = (). Thus, holding the other parameters xed, large corresponds to small p_c , and vice versa. So in fact, the spread is very small for large , and large for small , as expected. The gure just shows the small corrections to the large e ects predicted by the dimensional scaling relations.

For large the probability density of the spread decays roughly exponentially moving away from the midpoint. This is because for large the uctuations around the mean depth are roughly independent. Thus the probability for a market order to penetrate to a given price level is roughly the probability that all the ticks smaller than this price level contain no orders, which gives rise to an exponential decay. This is no longer true for small . Note that for small the probability distribution of the spread becomes insensitive to , i.e. the nondim ensionalized distribution for = 0.02 is nearly the same as that for = 0.002.




FIG.10: The mean value of the spread in nondimensional units $\hat{s} = s = p_c$ as a function of . This demonstrates that the spread only depends weakly on , indicating that the prediction from dimensional analysis given in table (III) is a reasonable approximation.

It is apparent from Fig.9 that in nondim ensional units the mean spread increases with . This is con med in Fig.10, which displays the mean value of the spread as a

function of . The mean spread increases monotonically with . It depends on as roughly a constant (equal to approximately 0.45 in nondimensional coordinates) plus a linear term whose slope is rather small. We believe that for most nancial instruments < 0.3. Thus the variation in the spread caused by varying in the range 0 < 0.3 is not large, and the dimensional analysis based only on rate parameters given in table IV is a good approximation. We get an accurate prediction of the dependence across the full range of from the Independent Interval Approximation technique derived in section IIIG, as shown in Fig. 24.

4. Volatility and price di usion

The price di usion rate, which is proportional to the square of the volatility, is in portant for determ ining risk and is a property of central interest. From dimensional analysis in terms of the order ow rates the price diffusion rate has units of price²=time, and so must scale as 2 = 2. We can also make a crude argument for this as follows: The dimensional estimate of the spread (see Table IV) is =2. Let this be the characteristic step size of a random walk, and let the step frequency be the characteristic time 1= (which is the average lifetime for a share to be canceled). This argument also gives the above estimate for the diusion rate. However, this is not correct in the presence of negative autocorrelations in the step sizes. The num erical results make it clear that there are important -dependent corrections to this result, as dem onstrated below.




FIG.11: The variance of the change in the nondimensionalized m idpoint price versus the nondimensional time delay interval . For a pure random walk this would be a straight line whose slope is the di usion rate, which is proportional to the square of the volatility. The fact that the slope is steeper for short times comes from the nontrivial temporal persistence of the order book. The three cases correspond to Fig. 3: = 0.2 (solid), = 0.02 (dash), = 0.002 (dot).

In Fig. 11 we plot simulation results for the variance of the change in the midpoint price at timescale , Var (m (t+) m (t)). The slope is the di usion rate, which at any xed timescale is proportional to the square

of the volatility. It appears that there are at least two tim escales involved, with a faster di usion rate for short tim escales and a slower di usion rate for long tim escales. Such anom alous di usion is not predicted by m ean-eld analysis. Simulation results show that the di usion rate is correctly described by the product of the estimate from dimensionalanalysisbased on order ow parameters alone, $^2 = ^2$, and a -dependent power of the nondimensional granularity parameter = 2 =, as sum marized in table IV. We cannot currently explain why this power is 1=2 for short term di usion and 1=2 for longterm di usion. How ever, a qualitative understanding can be gained based on the conservation law we derive in Section IIIC. A discussion of how this relates to price di usion is given in Section IIIE.

Note that the tem poral structure in the di usion process also im plies non-zero autocorrelations of the m idpoint price m (t). This corresponds to weak negative autocorrelations in price di erences m (t) m (t 1) that persist for tim escales until the variance vs. becomes a straight line. The tim escale depends on parameters, but is typically the order of 50 m arket order arrival times. This tem poral structure im plies that there exists an arbitrage opportunity which, when exploited, would make prices m ore random and the structure of the order ow non-random.

5. Liquidity for lim it orders: P robability and time to 11.

The liquidity for limit orders depends on the probability that they will be lled, and the time to be lled. This obviously depends on price: Limit orders close to




FIG.12: The probability for lling a limit order placed at a price $p=p_c$ where p is calculated from the instantaneous midprice at the time of placement. The three cases correspond to Fig.3: = 0.2 (solid), = 0.02 (dash), = 0.002 (dot).

the current transaction prices are more likely to be led quickly, while those far away have a lower likelihood to be led. Fig. 12 plots the probability of a limit order being led versus the nondimensionalized price at which it was placed (as with all the gures in this section, this is shown in the midpoint-price centered frame). Fig. 12 shows that in nondimensional coordinates the probability of lling close to the bid for sell limit orders (or the ask for buy limit orders) decreases as increases. For large , this is less than 1 even for negative prices. This says

that even for sell orders that are placed close to the best bid there is a signi cant chance that the o er is deleted before being executed. This is not true for smaller values of , where (0) 1. Far away from the spread the ll probabilities as a function of are reversed, i.e. the probability for lling lim it orders increases as increases. The crossoverpoint where the llprobabilities are roughly the same occurs at p $p_{\rm e}$. This is consistent with the depth pro le in Fig. 3 which also show s that depth pro les for di erent values of cross at about p $p_{\rm e}$.




FIG.13: The average time nondimensionalized by the rate , to llalimit order placed at a distance $p=p_c$ from the instantaneous mid-price.

Similarly Fig 13 shows the average time taken to ll an order placed at a distance p from the instantaneous m id-price. Again we see that though the average time is larger at larger values of for small p=p, this behaviour reverses at p p.

C. Varying tick size $dp=p_c$

The dependence on discrete tick size $dp=p_c$, of the cumulative distribution function for the spread, instantaneous price impact, and mid-price di usion, are shown in Fig. 14. We chose an unrealistically large value of the tick size, with $dp=p_c = 1$, to show that, even with very coarse ticks, the qualitative changes in behavior are typically relatively m inor.

Fig. 14(a) shows the cumulative density function of

the spread, com paring dp= $p_c = 0$ and dp= $p_c = 1$. It is apparent from this gure that the spread distribution for coarse ticks \e ectively integrates" the distribution in the lim it dp ! 0. That is, at integer tick values the m ean cumulative depth pro les roughly m atch, and in between integer tick values, for coarse ticks the probability is sm aller. This happens for the obvious reason that coarse ticks quantize the possible values of the spread, and place a low er lim it of one tick on the value the spread can take. The shift in the m ean spread from this e ect is not shown, but it is consistent with this result; there is a constant o set of roughly 1=2 tick.




FIG.14: Dependence of market properties on tick size. Heavy lines are $dp=p_c$! 0; light lines are $dp=p_c = 1$. Cases correspond to Fig.3, with = 0.2 (solid), = 0.02 (dash), = 0.002 (dot). (a) is the cum ulative distribution function for the nondimensionalized spread. (b) is instantaneous nondimensionalized price im pact, (c) is di usion of the nondimensionalized midpoint shift, corresponding to Fig.11.

The alteration in the price impact is shown in Fig. 14(b). Unlike the spread distribution, the average price impact varies continuously. Even though the tick size is quantized, we are averaging over m any events and the probability of a price impact of each tick size is a continuous function of the order size. Large tick size consistently lowers the price impact. The price impact rises m ore slow by for sm all p, but is then sim ilar except for a downward translation.

The e ect of coarse ticks is less trivial for m id-price di usion, as shown in Fig. 14 (c). At = 0.002, coarse ticks remove most of the rapid short-term volatility of the m idpoint, which in the continuous-price case arises from price uctuations smaller than dp=p_c = 1. This lessens the negative autocorrelation of m idpoint price returns, and reduces the anom abus di usion. At = 0.2, where both early volatility and late negative autocorrelation are smaller, coarse ticks have less e ect. The net result is that the m id-price di usion becomes less sensitive to the value of as tick size increases, and there is less anom abus price di usion.

III. THEORETICALANALYSIS

A. Sum m ary of analytic m ethods

W e have investigated this model analytically using two approaches. The rst one is based on a master equation, given in Section IIIF. This approach works best in the midpoint centered frame. Here we attempt to solve directly for the average number of shares at each price tick

as a function of price. The midpoint price makes a random walk with a nonstationary distribution. Thus the key to nding a stationary analytic solution for the average depth is to use com oving price coordinates, which are centered on a reference point near the center of the book, such as the midpoint or the best bid. In the rst approxin ation, uctuations about the mean depth at adjacent prices are treated as independent. This allows us to replace the distribution over depth pro les with a simpler probability density over occupation num bers n at each p and t. W e can take a continuum lim it by letting the tick size dp become in nitesim al. With nite order ow rates, this gives vanishing probability for the existence of more than one order at any tick as dp ! 0. This is described in detail in section IIIF 3. W ith this approach we are able to test the relevance of correlations as a function of the param eter as well as predict the functional dependence of the cum ulative distribution of the spread on the depth pro le. It is seen that correlations are negligible for large 02) while they are very important for values of (smallvalues (0:002).




FIG.15: The price space and order prole.n (p;t) has been chosen to be 0 or 1, a restriction that will be convenient later. Price bins are labeled by their lower boundary price, and intervals x (N) will be dened below.

O ur second analytic approach which we term the Independent Interval Approximation (IIA) is most easily carried out in the bid-centered frame and is described in section IIIG. This approach uses a dierent representation, in which the solution is expressed in terms of the empty intervals between non-empty price ticks. The system is characterized at any instant of time by a set of intervals f:::x 1;x0;x1;x2:::g where for example x0 is the distance between the bid and the ask (the spread), x 1 is the distance between the second buy limit order and the bid and so on (see Fig. 15). Equations are written for how a given interval varies in time. Changes to adjacent intervals are related, giving us an in nite set of coupled non-linear equations. How ever using a mean-

eld approximation we are able to solve the equations, albeit only numerically. Besides predicting how the various intervals (for example the spread) vary with the param eters, this approach also predicts the depth proles as a function of the parameters. The predictions from the IIA are compared to data from numerical simulations, in Section IIIG 2. They match very well for large and less well for smaller values of . The IIA can also be modi ed to incorporate various extensions to the model, as mentioned in Section IIIG 2.

In both approaches, we use a mean eld approximation to get a solution. The approximation basically lies in assuming that uctuations in adjacent intervals (which might be adjacent price ranges in the master equation approach or adjacent empty intervals in the IIA) are independent. A loo, both approaches are most easily tractable only in the continuum limit dp! 0, when every tick has at most only one order. They may how ever be extended to general tick size as well. This is explained in the appendix for the Master Equation approach.

Because correlations are important for small , both methods work well mostly in the large limit, though qualitative aspects of small behavior may also be

gleaned from them. Unfortunately, at least based on our prelim inary investigation of London Stock Exchange data, it seems that it is this small lim it that realm arkets may tend more towards. So our approximate solutions may not be as useful as we would like. Nonetheless, they do provide som e conceptual insights into what determ ines depth and price im pact.

In particular, we nd that the shape of the mean depth pro le depends on a single parameter, and that the relative sizes of its rst few derivatives account for both the order size-dependence of the market im pact, and the renorm alization of the m idpoint di usivity. A higher relative rate of m arket versus lim it orders depletes the center of the book, though less than the classical estim ate predicts. This leads to more concave impact (explaining Fig. 8) and faster short-term di usivity. However, the orders pile up m ore quickly (versus classically nondimensionalized price) with distance from the midpoint, causing the rapid early di usion to su er larger m ean reversion. These are the e ects shown in Fig. 11. We will elaborate on the above remarks in the following sections, how ever, the qualitative relation of im pact to m idpoint autocorrelation supplies a potential interpretation of data, which may be more robust than details of the m odel assumptions or its quantitative results.

Both of the treatments described above are approximations. We can derive an exact global conservation law of order placement and removal whose consequences we elaborate in section IIIC. This conservation law must be respected in any sensible analysis of the model, giving us a check on the approximations. It also provides some insight into the anomalous di usion properties of this model.

B. Characterizing lim it-order books: dual coordinates

W e begin with the assumption of a price space. Price is a dimensional quantity, and the space is divided into bins of length dp representing the ticks, which may be nite or in nitesimal. Prices are then discrete or continuousvalued, respectively.

Statistical properties of interest are computed from tem poral sequences or ensem bles of lim it-order book congurations. If n is the variable used to denote the num ber of shares from lim it orders in some bin (p;p+dp) at the beginning t of an elementary time interval, a conguration is speci ed by a function n (p;t). It is convenient to take n positive for sell lim it orders, and negative for buy lim it orders. Because the model dynam ics precludes crossing lim it orders, there is in general a highest instantaneous buy lim it-order price, called the bid b(t), and a lowest sell lim it-order price, the ask a(t), with b(t) < a (t) always. The midpoint price, de ned as m (t) [a(t) + b(t)] = 2, may or may not be the price of any actual bin, if prices are discrete (m (t) m ay be a halfinteger multiple of dp). These quantities are diagram med




FIG.16: The accumulated order number N (p;t). N (a;t) 0, because contributions from all bins cancel in the two sum s. N remains zero down to b(t) + dp, because there are no uncanceled, nonzero term s. N (b;t) becomes negative, because the second sum in Eq. (4) now contains n (b;t), not canceled by the rst.

An equivalent speci cation of a limit-order book conguration is given by the cumulative order count

where 1 denotes the low erboundary of the price space, whose exact value must not a ect the results. (Because by de nition there are no orders between the bid and ask, the bid could equivalently have been used as the origin of sum m ation. Because price bins will be indexed here by their low er boundaries, though, it is convenient here to use the ask.) The absolute values have been placed so that N, like n, is negative in the range of buy orders and positive in the range of sells. The construction of N (p;t) is diagram m ed in Fig. 16.

In many cases of either sparse orders or in nitesimal dp, with xed order size (which we may as well de ne to be one share) there will be either zero or one share in any single bin, and Eq. (4) will be invertible to an equivalent speci cation of the lim it-order book con guration




FIG.17: The inverse function p(N;t). The function is in general de ned only on discrete values of N, so this domain is only invariant when order size is xed, a convenience that will be assumed below. Between the discrete domain, and the de nition of p as a maximum, the inverse function e ectively interpolates between vertices of the rejected im age of N (p;t), as shown by the dotted line.

shown in Fig. 17. (Strictly, the inversion may be performed for any distribution of order sizes, but the resulting function is intrinsically discrete, so its domain is only invariant when order size is xed. To give p(N;t)the convenient properties of a well-de ned function on an invariant domain, this will be assumed below.)

W ith de nition (5), p(0;t) a (t), p(1;t) b(t), and one can de ne the intervals between orders as

Thus x(0;t) = a(t) b(t), the instantaneous bidask spread. The lowest values of x(N;t) bracketing the spread are shown in Fig. 15. For symmetric order-placement rules, probability distributions over congurations will be symmetric under either n (p;t) !

n (p;t), or x (N;t) ! x (N;t). Coordinates N and p furnish a dual description of con gurations, and n and x are their associated di erences. The M aster E quation approach of section IIIF assumes independent uctuation in n while the Independent Interval Approxim ation of Sec. IIIG assumes independent uctuation in x (In this section, it will be convenient to abbreviate x (N;t) x_N (t)).

C. Fram es and m arginals

The x (N ;t) speci cation of lim it-order book con gurations has the property that its distribution is stationary under the dynam ics considered here. The same is not true forp (N ;t) orn (p;t) directly, because bid, m idpoint, and ask prices undergo a random walk, with a renorm alized di usion coe cient. Stationary distributions for nvariables can be obtained in co-m oving fram es, of which there are several natural choices. The bid-centered con guration is de ned as

The m idpoint-centered con guration has qualitative differences from the bid-centered con guration, which will be explored below. Both give useful insights to the order distribution and di usion processes. The ask-centered con guration, n_a (p;t), need not be considered if order placem ent and rem oval are symmetric, because it is a m irror im age of n_b (p;t).

The spread is de ned as the di erence s (t) a (t) b (t), and is the value of the ask in bid-centered coordinates. In m idpoint-centered coordinates, the ask appears at s (t) =2.

The con gurations n_b and n_m are dynamically correlated over short time intervals, but evolve ergodically in periods longer than nite characteristic correlation times. M arginal probability distributions for these can therefore be computed as time averages, either as functions on the whole price space, or at discrete sets of prices. Their m arginalmean values at a single price p will be denoted m_b (p)i, m_m (p)i, respectively.

These means are subject to global balance constraints, between total order placement and removal in the price space. Because all lim it orders are placed above the bid, the bid-centered con guration obeys a simple balance relation:

Eq. (9) says that buy m arket orders m ust account, on average, for the di erence between all lim it orders placed, and all decays. A fter passing to nondim ensional coordinates below, this will imply an inverse relation between corrections to the classical estimate for di usivity at early and late times, discussed in Sec. IIIE. In addition, this conservation law plays an important role in the analysis and determ ination of the x (N; t)'s, as we will see later in the text.

The m idpoint-centered averages satisfy a di erent constraint:

M arket orders in Eq. (10) account not only for the excess of limit order placement over evaporation at prices above the midpoint, but also the \excess" orders placed between b(t) and m(t). Since these always lead to midpoint shifts, they ultimately appear at positive com oving coordinates, altering the shape of hn_m (p) i relative to hn_b (p) i. Their rate of arrival is hm bi = hsi=2. These results are also con med in simulations.

D. Factorization tests

W hether in the bid-centered frame or the midpoint centered frame, the probability distribution function for the entire con guration n (p) is too di cult a problem to solve in its entirety. However, an approxim ate master equation can be form ed for n independently at each p if all joint probabilities factor into independent m arginals, as

where Pr denotes, for instance, a probability density for n orders in some interval around p.

W henever orders are su ciently sparse that the expected number in any price bin is simply the probability that the bin is occupied (up to a constant of proportionality), the independence assumption implies a relation between the cumulative distribution for the spread of the ask and the mean density pro le. In units where the order size is one, the relation is

This relation is tested against simulation results in Fig. 18.0 ne can observe that there are three regimes.

A high- regime is de ned when the mean density prole at the midpoint $\rm hm_m$ (0)i $^<$ 1, and strongly concave downward. In this regime, the approximation of independent uctuations is excellent, and a master equation treatment is expected to be useful. Intermediate- is dened by $\rm hm_m$ (0)i 1 and nearly linear, and the approximation of independence is marginal. Large- is dened by $\rm hm_m$ (0)i 1 and concave upward, and the approximation of independent uctuations is completely invalid. These regimes of validity correspond also to the qualitative ranges noted already in Sec. IIB.

In the bid centered fram e how ever, Eq. 12 never seem s to be valid for any range of param eters. W e will discuss later why this might be so. For the present therefore, the master equation approach is carried out in the midpointcentered fram e. A liternatively, the mean eld theory of the separations is most convenient in the bid-centered fram e, so that fram e will be studied in the dual basis. The relation of results in the two fram es, and via the two m ethods of treatment, will provide a good qualitative, and for som e properties quantitative, understanding of the depth pro le and its e ect on im pacts.

It is possible in a modi ed treatment, to match certain features of simulations at any , by limited incorporation of correlated uctuations. However, the general master equation will be developed independent of these, and tested against simulation results at large , where its de ning assumptions are wellmet.




FIG.18: CDFsPr(s=2 < p) from simulations (thin solid), mean density pro le hn_m (p)i from simulations (thick solid), and computed CDF of spread (thin dashed) from hn_m (p)i, under the assumption of uncorrelated uctuations, at three values of . (a): = 0.2 (low market order rate); approxim ation is very good. (b): = 0.02 (interm ediate market order rate); approximation ismarginal. (c): = 0.002 (high market order rate); approximation is very poor.

E. Comments on renormalized di usion

A qualitative understanding of why the di usivity is di erent over short and long times scales, as well as why it may depend on , may be gleaned from the following First, global order conservation places a strong constraint on the classically nondimensionalized density prole in the bid-centered frame. We have seen that at

1, the density pro le becom es concave upward near the bid, accounting for an increasing fraction of the allowed \remainder area" as ! 0 (see Figs. 3 and 28). Since this remainder area is xed at unity, it can be conserved only if the density pro le approaches one more quickly with increasing price. Low density at low price appears to lead to more frequent persistent steps in the e ective short-term random walk, and hence large shortterm di usivity. However, increased density far from the bid indicates less in pact from market orders relative to the relaxation tim e of the Poisson distribution, and thus a lower long-tim e di usivity.

The qualitative behavior of the bid-centered density pro le is the same as that of the m idpoint-centered prole, and this is expected because the spread distribution is stationary, rather than di usive. In other words, the only way the di usion of the bid or ask can di er from that of the m idpoint is for the spread to either increase or decrease for several succeeding steps. Such autocorrelation of the spread cannot accum ulate w ith tim e if the spread itself is to have a stationary distribution. Thus, the shift in them idpoint over some tim e interval can only di er from that of the bid or ask by at m ost a constant, as a result of a few correlated changes in the spread. This di erence cannot grow with tim e, how ever, and so does not a ect the di usivity at long tim es.

Indeed, both of the predicted corrections to the classical estim ate for di usivity are seen in simulation results for m idpoint di usion. The simulation results, how ever, show that the implied autocorrelations change the diffusivity by factors of $^{\rm P}$, suggesting that these corrections require a more subtle derivation than the one attempted here. This will be evidenced by the di culty of obtaining a source term S in density coordinates (section IIIF), which satis ed both the global order conservation law, and the proper zero-price boundary condition, in the m idpoint-centered frame.

An interesting speculation is that the subtlety of these correlations also causes the density n (p;t) in bid-centered coordinates not to approxim ate the mean-eld condition at any of the parameters studied here, as noted in Sec.IIID. Since short-term and long-term di usivity corrections are related by a hard constraint, the di culty of producing the late-time density prole should match that of producing the early-time prole. The midpoint-centered prole is potentially easier, in that the late-time complexity must be matched by a combination of the early-time density prole and the scaling of the expected spread. It appears that the complex scaling is absorbed in the spread, as per Fig. 10 and Fig.24, leaving a density that can be approximately calculated with the methods used here.

F. M aster equations and m ean- eld approxim ations

There are two natural lim its in which functional congurations may become simple enough to be tractable probabilistically, with analytic methods. They correspond to mean eld theories in which uctuations of the dual differentials of either N (p;t) or p(N;t) are independent. In the rst case, probabilities may be dened for any density n (p;t) independently at each p, and in the second for the separation intervals x(N;t) at each N. The mean eld theory from the rst approximation will be solved in Subsec. IIIF 1, and that from the second in Subsec. IIIF 1, and that from the second in a midpoint-centered frame, n (p;t) will refer always to this frame. x(N;t) is well-dened without reference to any frame.

1. A num ber density master equation

If share-number uctuations are independent at di erent p, a density (n;p;t) m ay be de ned, which gives the probability to nd n orders in bin (p;p + dp), at time t. The norm alization condition de ning as a probability density is

for each bin index p and at every t. The index t will be suppressed henceforth in the notation since we are looking for tim e-independent solutions.

Supposing an arbitrary density of order-book con gurations (n;p) at time t, the stochastic dynamics of the con gurations causes probability to be redistributed according to the master equation

Here (n;p)=0t is a continuum notation for [(n;p;t+t) (n;p;t)]=t, where t is an elementary time step, chosen short enough that at most one event alters any typical con guration. Eq. (14) represents a general balance between additions and removals, without regard to the meaning of n. Thus, (p) is a function that must be determ ined self-consistently with the choice of frame. As an example of how this works, in a bid-centered frame, (p) takes a xed value

(1) at allp, because the deposition rate is independent of position and frame shifts. The midpoint-centered frame is more complicated, because depositions below the midpoint cause shifts that leave the deposited order above the midpoint. The speci c consequence for

(p) in this case will be considered below. (p)=2 is, similarly, the rate of market orders surviving to cancel limit orders at price p. (p)=2 decreases from (0)=2 at the ask (for buy market orders, because total orders are divided evenly between buys and sells) to zero as p ! 1, as market orders are screened probabilistically by intervening limit orders. (1) and (0) are thus the parameters and of the simulation.

The lines of Eq. (14) correspond to the following events. The term proportional to (p) dp= describes depositions of discrete orders at that rate (because is expressed in shares per price per time), which raise congurations from n to n shares at price p. The term proportional to com es from deletions and has the opposite e ect, and is proportional to n =, the num ber of orders that can independently decay. The term proportional to (p) = 2 describes market order annihilations. For general con gurations, the preceding three e ects m ay lead to shifts of the origin by arbitrary intervals p, and P are for the moment unknown distributions over the frequency of those shifts. They must be determined self-consistently with the con guration of the book which em erges from any solution to Eq. (14).

A limitation of the simple product representation of frame shifts is that it assumes that whole order-book con gurations are transported under p p ! p, independently of the value of n (p). As long as uctuations are independent, this is a good approximation for orders at all p which are not either the bid or the ask, either before or after the event that causes the shift. The correlations are never ignorable for the bins which are the bid and ask, though, and there is some distribution of instances in which any p of interest plays those parts. Approximate methods to incorporate those correlations will require replacing the product form with a sum of products conditioned on states of the order book, as will be derived below.

The important point is that the order- ow dependence of Eq. (14) is independent of these self-consistency requirem ents, and m ay be solved by use of generating functionals at general (p), (p), and P. The solution, exact but not analytically tractable at general dp, will be derived in closed form in the next subsection. It has a well-behaved continuum limit at dp ! 0, how ever, which is analytically tractable, so that special case will be considered in the following subsection.

Far from the m idpoint, where only depositions and cancellations take place, orders in bins of width dp are Poisson distributed with m ean (1) dp=. The reason for grouping the nondimensionalized number density with 1 =, together with the proper norm alization of the characteristic price scale, will come from examining the decay of the dimensionless function (p) = (0).

3. Screening of the market-order rate

In the context of independent uctuations, Eq. (26) im plies a relation between the mean density and the rate at which market orders are screened as price increases. The e ect of a lim it order, resident in the price bin p when a market order survives to reach that bin, is to prevent its arriving at the bin at p + dp. Though the nature of the shift induced, when such annihilation occurs, depends on the com oving fram e being modeled, the change in the num ber of orders surviving is independent of fram e, and is given by

i we are careful with one convention. The integral of the diusion term formally produces the rst derivative $d = d\hat{p}_{J}^{1}$. We must regard this as a true rst derivative,

In the midpoint centered frame, the correct form for the source term should be $(p) = (1^{\circ}) = 1 +$ Pr(s=2 p), whatever the expression for the cumulative distribution function. Recognizing that the integral of the CDF is, by parts, the mean value of s=2, the same integration of Eq. (32) gives

N either of these results required the assumption of independent uctuations, though that will be used below to give a simple approximate form for $\Pr(\$=2 \quad p)$ '(p). They therefore provide a check that the extinction form (33) propagates market orders correctly into the interior of the order-book distribution, to respect global conservation. They also check the consistency of the intuitively plausible form for in the midpoint-centered frame. The detailed form is then justi ed whenever the assumption of independent uctuations is checked to be valid.

5. Self-consistent param etrization

The assumption of independent uctuations of n (p) used above to derive the screening of market orders, is equivalent to a speci cation of the CDF of the ask. M arket orders are only removed between prices p and p + dp in those instances when the ask is at p. Therefore

Self-consistent expressions for and h pi are then constructed as follows. Given an ask at some position a (in the m idpoint-centered fram e), there is a range from а to a in which sell lim it orders m ay be placed, which will induce positive m idpoint-shifts. The shift am ount is half as great as the distance from the bid, so the measure for shifts dP+ (p) from sell lim it-order addition inherits a term 2 (0) (d p) Pr (a p), where the last factor counts the instances with asks large enough to adm it shifts by p. There is an equal contribution to dP from addition of buy lim it orders. Symmetry requires that for every positive shift due to an addition, there is a negative shift due to evaporation with equalm easure, so the contribution from buy lim it order rem oval should equal that for sell lim it order addition. W hen these contributions are sum m ed, the m easures for positive and negative shifts both equal



A t of Eq. (37) to simulations, using these selfconsistent measures for shifts, is shown in Fig. 19. This solution is actually a comprom ise between approximations with opposing ranges of validity. The di usion equation using the mean order depth describes nonzero transport of limit orders through the midpoint, an approximation inconsistent with the correlations of shifts with states of the order book. This approximation is a small error only at ! 0.0 n the other hand, both the form of , and the self-consistent solutions for h β i and , made use of the mean-eld approximation, which we

saw was only valid for < 1. The two approximations appear to create roughly compensating errors in the intermediate range 0.02.

6. Accounting for correlations

The num erical integral in plem enting the di usion solution actually doesn't satisfy the global conservation

condition that the di usion term integrate to zero over the whole price range. Thus, it describes di usive transport of orders through the m idpoint, and as such also doesn't have the right $\beta = 0$ boundary condition. The e ective absorbing boundary represented by the pure diffusion solution corresponds roughly to the approxim ation m ade by Bouchaud et al. [23] It di ers from theirs, though, in that their m ethod of im ages e ectively approxim ates the region of the spread as a point, whereas Eq. (32) actually resolves the screening of m arket orders as the spread uctuates.

Treating the spread region { roughly de ned as the range over which market orders are screened { as a point is consistent with treating the resulting coarse-grained \midpoint" as an absorbing boundary. If the spread is resolved, how ever, it is not consistent for di usion to transport any nite number density through the midpoint, because the midpoint is strictly always in the center of an open set with no orders, in a continuous price space. The correct behavior in a neighborhood of the \ ne-grained midpoint" can be obtained by explicitly accounting for the correlation of the state of orders, with the shifts that are produced when market or lim it order additions occur.

We expect the problem of recovering both the global conservation law and the correct $\hat{p} = 0$ boundary condition to be di cult, as it should be responsible for the non-trivial corrections to short-term and long-term diffusion m entioned earlier. We have found, how ever, that by explicitly sacri cing the global conservation law, we can incorporate the dependence of shifts on the position of the ask, in an interesting range around the m idpoint. At general , the corrections to di usion reproduce the mean density over the main support of the CDF of the spread. W hile the resulting density does not predict that CDF (due to correlated uctuations), it closely enough

resembles the real density that the independent CDFs of the two are sim ilar.

7. Generalizing the shift-induced source term s

N ondim ensionalizing the generating-functionalm aster equation (20) and keeping leading terms in dp at ! 1, get

where dP (p) is the nondimensionalized measure that results from taking the continuum limit of P in the variable p.

Eq. (43) is inaccurate because the number of orders shifted into or out of a price bin p, at a given spread, m ay be identically zero, rather than the unconditional m ean value . We take that into account by replacing the last two lines of Eq. (43) with lists of source term s, whose form s depend on the position of the ask, weighted by the probability density for that ask. Independent uctuations are assumed by using Eq. (36).

It is convenient at this point to denote the replacement of the last two lines of Eq. (43) with the notation S, yielding

The global conservation laws for orders would be satised if $d\beta S = 0$.




FIG.20: Reconstruction with source term sS that approximately account for correlated uctuations near the midpoint. = 0.2. Thick solid line is averaged order book depth from simulations, and thin solid is the mean eld result. Thin dotted line is the simulated CDF for \$=2, and thick dotted line is the mean eld result. Thick dashed line is the CDF that would be produced from the simulated depth, if the meaneld approximation were exact.

The source term S is derived approximately in App. B 2. The solution to Eq. (44) at = 0.2, with the sim ple-di usive source term replaced by the evaluations (B29 - B37), is compared to the simulated orderbook depth and spread distribution in Fig. 20. The sim - ulated hm (p) is at is es Eq. (35), showing what is the correct \remainder area" below the line hmi 1. The numerical integral deviates from that value by the incorrect integral doS \pm 0. However, most of the probability for the spread lies within the range where the source term s S are approximately correct, and as a result the distribution for ± 2 is predicted fairly well.




FIG. 21: Reconstruction with correlated source terms for = 0.02. Line style and thickness are the same as in Fig. 20.




FIG. 22: Reconstruction with correlated source terms for = 0.002. Line style and thickness are the same as in Fig. 20.

Even where the mean-eld approximation is known to be inadequate, the source terms de ned here capture most of the behavior of the order-book distribution in the region that a ects the spread distribution. Fig. 21 shows the comparison to simulations for = 0.02, and Fig. 22 for = 0.002. Both cases fail to reproduce the distribution for the spread, and also fail to capture the large β behavior of . However, they approximate at

small p well enough that the resulting distribution for the spread is close to what would be produced by the simulated if uctuations were independent.

G. A mean-eld theory of order separation intervals: The Independent Interval A pproxim ation

A simplifying assumption that is in some sense dual to independent uctuations of (p), is independent uctuations in the intervals x (N) at di erent N. Here we develop a mean-eld theory for the order separation intervals in this model. From this, we will also be able to make an estimate of the depth pro les for any value of the parameters. For convenience of notation we will use

 x_N to denote x (N).

Lim it order placements are considered to take place strictly on sites which are not occupied. This is the same level of approximation as made in the previous section. The time step is normalized to unity, as above, so that rates are equal to probabilities after one update of the whole con guration. The rates and used in this section correspond to (1) and (0) as de ned earlier.

As shown in Fig. 15 the con guration is entirely speci ed instant by instant if the instantaneous values of the order separation intervals are known.

Consider now, how these intervals m ight change due to various processes. For the spread x_0 , these processes and the corresponding change in x_0 , are listed below.

- $1. x_0 ! x_0 + x_1$ with rate (+ =2) (when the ask either evaporates or is deleted by a market order).
- 2. $x_0 ! x_0 + x_1$ with rate (+ =2) (when the bid either evaporates or is deleted by the corresponding market order).
- 3. x_0 ! x^0 for any value 1 x^0 x_0 1, when a sell limit order is deposited anywhere in the spread. The rate for any single deposition is dp=, so the cumulative rate for some deposition is dp $(x_0 \ 1) = .$ (The 1 comes from the prohibition against depositing on occupied sites.)
- 4. Similarly x_0 ! x_0 x⁰ for any 1 x⁰ x_0 1, when a buy limit order is deposited in the spread, also with cumulative rate dp (x_0 1) = .
- 5. Since the above processes describe all possible single-event changes to the con guration, the probability that it remains unchanged in a single time step is $1 \ 2 = 2 \ \text{dp} (x \ 1) = .$

In all that follows, we will put = 1 without loss of generality. If we know x_0 , x_1 , and x_1 at time t, the

expected value at time t+ dt is then

W ere it not for the quadratic term arising from deposition, Eq. (46) would be a linear function of x_0 , x_1 , and x_1 . However we now need an approximation for x_0^2 , where the angle brackets represent an average over realizations as before or equivalently a time average in the steady state. Let us for the moment assume that we can approximate x_0^2 by $ahx_0 i^2$, where a is some as yet undeterm ined constant to be determ ined self-consistently. W e will make this approximation for all the x_k 's. This is clearly not entirely accurate because the PDF of x_k could depend on k (as indeed it does. W e will comment on this a little later). However as we will see this is still a very good approximation.

W e will therefore m ake this approximation in Eq. (46) and everywhere below, and look for steady state solutions when the x_k 's have reached a time independent average value.

P roceeding to the change of x_1 , the events that can occur, with their probabilities, are shown in Table V, with the remaining probability that x_1 remains unchanged.

The interpretation of S_1 is straightforw and. There are k+1 orders in the price range $\lim_{i=0}^{k} x_i$. Their decay rate is (k+1), and the rate of annihilation from market orders is =2. The rate of additions, up to an uncertainty about what should be considered the center of the interval, is (dp) $\lim_{i=0}^{k} (x_i - 1)$ in the bid-centered frame (where elective is constant and additions on top of previously occupied sites is forbidden). Equality of addition and rem oval is the bid-centered order conservation law (again), in the form

This conservation law is indeed respected to a remarkable accuracy in M onte Carlo simulations of the m odel as indicated in table VI.

In order that the equation for the x's obey this exact conservation law, we require Eq. 56 to be equal to Eq. 58. We can hence now self-consistently set the value of a = 2.




FIG.23: The probability distribution functions $P_x(y)$ vs. y for the intervals $x = x_0$; x_1 and x_5 at = 0.1, on a sem i-log scale. Solid curve is for x_0 , dashed for x_1 , and dot for x_5 . The functional form of the distribution changes from a Gaussian to an exponential.

The value of a implies that we have now set x_k^2 $2hx_k i^2$. This would be strictly true if the probability distribution function of the interval x_k were exponentially distributed for all k. This is generally a good approximation for large k for any . Fig 23 shows the numerical results from M onte C arb simulations of the m odel, for

the probability distribution function for three intervals x_0 , x_1 and x_5 at = 0.1. The functional form for P (x_0) and P (x_1) are better approximated by a G aussian than an exponential. How ever P (x_5) is clearly an exponential.

Eq. (58) has an important consequence for the shortterm and long-term di usivities, which can also be seen in simulations, as mentioned in earlier sections. The nondimensionalization of the di usivity D with the rate param eters, suggests a classical scaling of the di usivity

A sm entioned earlier, it is observed from simulations that the locally best short-time t to the actual di usivity of the midpoint is 1 = times the estimate (59), and the long-time di usivity is 1 = times the classical estimate. W hile we do not yet know how to derive this relation analytically, the fact that early and late-time renorm alizationsm ust have this qualitative relation can be argued from the conservation law (58).

S1 is the area enclosed between the actual density and the asymptotic value. Increases in 1= (descaled marketorder rate) deplete orders near the spread, dim inishing the mean depth at small p, and induce the upward curvature seen in Fig. 3, and even more strongly in Fig. 28 below. As noted above, they cause more frequent shifts (m ore than compensating for the slight decrease in average step size), and increase the classically descaled di usivity . However, as a result, this increases the fraction of the area in S_1 accumulated near the spread, requiring that the m ean depth at larger p increase to compensate (see Fig. 28). The resulting steeper approach to the asymptotic depth at prices greater than the mean spread, and the larger negative curvature of the distribution, are t by an e ective di usivity that decreases with increasing 1= . Since the distribution further from the m idpoint represents the imprint of market order activity further in the past, this e ective di usivity describes the long-term evolution of the distribution. The resulting anticorrelation of the small-p and large-p e ective di usion constants in plied by conservation of the area S_1 is exactly consistent with their respective 1= and scalings. The general idea here is to connect di usivities at short and long time scales to the depth pro le near the spread and far away from the spread respectively. The conservation law for the depth pro le, then implies a connection between these two di usivities.




FIG.24: The mean value of the spread in nondimensional units $\$ = s = p_c$ as a function of . The numerical value above (solid) is compared with the theoretical estimate below (dash).

2. Direct simulation in interval coordinates

The set of equations determined by the general form (53) is ultimately parametrized by the single input x_0 . The correct value for x_0 is determined when the x_k are solved recursively, by requiring convergence to x_1 . We do this recursion numerically, in the same manner as was done to solve the dimensial equation for the normalized mean density (3).

In Fig.24 we compare the numerical result for x_0 with the analytical estimate generated as explained above. The results are surprisingly good throughout the entire range. Though the theoretical value consistently underestimates the numerical value, yet the functional form is captured accurately.




FIG.25: Four pairs of curves for the quantity $\$_k = \$_1$ 1 vs. k. The value of increases from top to bottom (= 0.02;0.04;0.2;0.66). In each pair of curves, the markers are obtained from simulations while the solid curve is the prediction of Eq.53 evaluated num erically. The di erence between num erics and m ean-eld increases as decreases, especially for large k.

In Fig. 25, the values of x_k for all k, are compared to the values determ ined directly from simulations.




FIG.26: Same plot as Fig.25 but on a sem i-log scale to show exponential decay at large k.

Fig. 26 shows the same data on a semilog scale for $\hat{x}_k = \hat{x}_1$ 1, showing the exponential decay at large argument characteristic of a simple di usion solution. The IIA is clearly a good approximation for large . How - ever for small it starts deviating signi cantly from the simulations, especially for large k.




FIG. 27: Three pairs of curves for the quantity h m i=p c vs. N where h m i = $1=2^{P} \sum_{k=1}^{N} x_k$. The value of increases from top to bottom (= 0.002;0.02;0.2). In each pair of curves, the markers are obtained from simulations while the solid curve is the prediction of the IIA. For = 0.002, we show only the theoretical prediction. The theory captures the functional form of the price in pact curves for di erent . Quantitatively, its better for larger epsilon, as remarked earlier.

The values of x_k computed from the IIA, can be very directly used to get an estimation of the price in pact. The price in pact, as de ned in earlier sections, can be thought of as the change in the position of the midpoint (or the bid), consecutive to a certain number of orders being led. W ithin the framework of the sim - pli ed model we study here, this is simply the quantity h m i = 1=2 $k_{0=1}^{k} x_{k^0}$, for k orders. The factor of 1=2 comes from considering the change in the position of the m idpoint and not the bid. Fig 27 shows h m i nondimensionalized by p_c plotted as a function of the number of orders (multiplied by), for three di erent values of A gain, the theory matches quite well with the num erics,

qualitatively. For large the agreem ent is quantitative as well.




FIG.28: Density pro les for di erent values of ranging over the values 0.2;0:02;0:004;0:001, obtained from the Independent Interval Approximation.

The simplest approximation to the density proles in the midpoint-centered frame is to continue to approximate the mean density as $1=x_k$, but to regard that density as evaluated at position $x_0=2+\sum_{k=1}^{i} x_k$. This clearly is not an adequate treatment in the range of the spread, both because the intervals are discrete, whereas mean

is continuous, and because the density pro less tisfy dierent global conservation laws associated with nonconstancy of . For large k however, this approximation might hold. The mean-eld values (only) corresponding to a plot of (\mathfrak{P}) versus \mathfrak{P} , are shown in Fig. 28. Here the theoretically estimated x_k 's at dierent parameter values are used to generate the depth pro le using the procedure detailed above.

A comparison of the theoretically estimated pro les




FIG. 29: Density proles from Monte Carlo simulation (markers) and the Independent Interval Approximation (lines). Pluses and dash line are for = 0.2, while crosses and dotted line are for = 0.02.

with the results from M onte Carlo simulations of the model, is shown in Fig. 29. As evident, the theoretical estimate for the density prole is better for large rather than small \cdot

We can also generalize the above analysis to when the order placem ent process is no longer uniform. In particular it has been found that a power-law order placem ent process is relevant [23, 26]. We carry out the above analysis for when $= _0 = (+ _0)$ where is the distance from the current bid and $_0$ determ ines the 'shoulder' of the power-law. We is no an interesting dependence of the




FIG.30: Density prodes for a power-law order placement process for dimentivalues of $_0$.

existence of solutions on . In particular we nd that for > 1, $_0$ needs to be larger than som e value (which depends on as well as other parameters of the model such as and) for solutions of the IIA to exist. This might be interpreted as a market order wiping out the entire book, if the exponent is too large. When solutions exist, we nd that the the depth prole has a peak, consistent with the ndings of [23]. In Fig. 30 the depth proles for three di erent values of $_0$ are plotted.

IV. CONCLUDING REMARKS

A. Ongoing work on empirical validation

M embers of our group are working on the problem of empirically testing this model. W e are using a dataset from the London Stock Exchange. W e have chosen this data because it contains every order and every cancellation. This makes it possible to measure all the param eters of this model directly. It is also possible to reconstruct the order book and measure all the statistical properties we have studied in this paper. Our empirical work so far shows that, despite its many limitations, our model can act as an elective guide to future research. W e believe that the main discrepancies between the predictions of our model and the data can be dealt with by using a more sophisticated model of order ow. W e sum marize som e of the planned in provements in the following subsection.

B. Future Enhancem ents

A swe have m entioned above, the zero intelligence, IID order ow model should be regarded as just a starting point from which to add more complex behaviors. We are considering several enhancements to the order ow process whose elects we intend to discuss in future papers. Som e of the enhancements include:

Trending of order ow.

We have demonstrated that IID order ow necessarily leads to non-IID prices. The converse is also true: Non-IID order ow is necessary for IID prices. In particular, the order ow must contain trends, i.e. if order ow has recently been skewed toward buying, it is more likely to continue to be skewed toward buying. If we assume perfect market e ciency, in the sense that prices are a random walk, this im plies that there must be trends in order ow.

Power law placement of lim it prices

For both the London Stock Exchange and the Paris Bourse, the distribution of the lim it price relative to the best bid or ask appears to decay as a powerlaw [23, 26]. Our investigations of this show that this can have an important e ect. Exponents larger than one result in order books with a nite num ber of orders. In this case, depending on other param eters, there is a nite probability that a single market order can clear the entire book (see Section IIIG 2).

Power law or log-norm al order size distribution.

R eal order placem ent processes have order size distributions that appear to be roughly like a lognorm aldistribution with a power law tail [27]. This has in portant e ects on the uctuations in liquidity.

Non-Poisson order cancellation process.

W hen considered in realtim e order placem ent cancellation does not appear to be Poisson [21]. How ever, this may not be a bad approximation in event tim e rather than realtim e.

Conditional order placem ent.

A gents m ay conditionally place larger m arket orders when the book is deeper, causing the m arket im pact function to grow m ore slow ly. W e intend to m easure this e ect and incorporate it into our m odel.

Feedback between order ow and prices.

In reality there are feedbacks between order ow and price movements, beyond the feedback in the reference point for lim it order placement built into thismodel. This can induce bursts of trading, causing order ow rates to speed up or slow down, and give rise to clustered volatility.

The last item is just one ofmany examples of how one can surely improve the model by making order ow conditional on available information. However, we believe it is important to rst gain an understanding of the properties of simple unconditional models, and then build on this foundation to get a fuller understanding of the problem.

C . C om parison to standard m odels based on valuation and inform ation arrival

In the spirit of G ode and Sunder [3], we assume a simple, zero-intelligence m odel of agent behavior and show that the m arket institution exerts considerable power in shaping the properties of prices. W hile not disputing that agent behavior m ight be important, our m odel suggests that, at least on the short tim escale m any of the properties of the m arket are dictated by the m arket institution, and in particular the need to store supply and dem and. O urm odel is stochastic and fully dynam ic, and m akes predictions that go beyond the realm of experim ental econom ics, giving quantitative predictions about fundam ental properties of a realm arket. W e have developed w hat were previously conceptual toy m odels in the physics literature into a m odel with testable explanatory power.

This raises questions about the com parison to standard m odels based on the response of valuations to new s. The idea that new s m ight drive changes in order ow rates is compatible with our model. That is, new s can drive changes in order ow, which in turn cause the best bid or ask price to change. But notice that in our model there are no assumptions about valuations. Instead, everything depends on order ow rates. For example, the di usion rate of prices increases as the 5=2 power of market order ow rate, and thus volatility, which depends on the square root of the di usion rate, increases as the 5=4 power. Of course, order ow rates can respond to information; an increase in market order rate indicates added impatience, which might be driven by changes in valuation. But changes in long-term valuation could equally well cause an increase in limit order ow rate, which decreases volatility. Valuation per se does not determ ine whether volatility will increase or decrease. Our model says that volatility does not depend directly on valuations, but rather on the urgency with which they are felt, and the need for in mediacy in responding to them.

Understanding the shape of the price in pact function was one of the motivations that originally set this project into motion. The price in pact function is closely related to supply and dem and functions, which have been central aspects of econom ic theory since the 19th century. Our model suggests that the shape of price in pact functions in modern markets is significantly in uenced not so much by strategic thinking as by an econom ic fundamental: The need to store supply and dem and in order to provide liquidity. A priori it is suprising that this requirem ent alone may be su cient to dictate at least the broad outlines of the price in pact curve.

Our model o ers a \divide and conquer" strategy to understanding fundam ental problems in econom ics. Rather than trying to ground our approach directly on assumptions of utility, we break the problem into two parts. We provide an understanding of how the statistical properties of prices respond to order ow rates, and leave the problem open of how order ow rates depend on more fundam ental assumptions about inform ation and utility. Order ow rates have the signi cant advantage that, unlike inform ation, utility, or the cognitive powers of an agent, they are directly measurable. We hope that by breaking the problem into two pieces, and partially solving the second piece, we can ultim ately help provide a deeper understanding of how markets work.

APPENDIX A:RELATIONSHIP OF PRICE IM PACT TO CUM ULATIVE DEPTH

An important aspect of markets is the immediate liquidity, by which we mean the immediate response of prices to incoming market orders. When a market order enters, its execution range depends both on the spread and on the depth of the orders in the book. These determ ine the sequence of transaction prices produced by that order, as well as the instantaneous market impact. Long term liquidity depends on the longer term response of the limit order book, and is characterized by the price impact function (!;) for values of > 0. Immediate liquidity a ects short term volatility, and long term liquidity a ects volatility measured over longer timescales. In this section we address only short term liquidity. We address volatility on longer timescales in section IIB 4.

W e characterize liquidity in terms of either the depth pro le or the price im pact. The depth pro le n (p;t) is the number of shares n at price p at time t. For many purposes it is convenient to think in term s of the cum ulative depth pro le N, which is the sum of n values up (or down) to some price. For convenience we establish a reference point at the center of the book where we de ne 0 and N (0) 0). The reference point can be eiр ther the m idpoint quote, or the best bid or ask. W e also study the price impact function p = (!; ;t), where p is the shift in price at time t+ caused by an order of size ! placed at time t. Typically we de ne p as the shift in the midpoint price, though it is also possible to use the best bid or ask (Eq. 1).

The price impact function and the depth pro le are closely related, but the relationship is not trivial. N (p) gives us the average total num ber of orders upto a distance paway from the origin. W hereas, in order to calculate the price in pact, what we need is the average shift p caused by a xed number of orders. Making the identi cations p = p, N = !, and choosing a com m on reference point, the instantaneous price im pact is the inverse of the instantaneous cumulative depth, i.e. $(!;0;t) = N^{-1}(!;t)$. This relationship is clearly true instant by instant. However it is not true for averages, since the mean of the inverse is not in general equal to the inverse of the means, i.e. h i for hN i ¹. This is highly relevant here, since because the uctuations in these functions are huge, our interest is prim arily in their statistical properties, and in particular the rst few moments.

A relationship between the moments can be derived as follows:

1. M om ent expansion

There is some subtlety in how we relate the market im pact to the cum ulative order count N (p;t). One eligible de nition of market impact p is the movement of the midpoint, following the placement of an order of size !. If we de ne the reference point so that N (a;t) 0, and the market order is a buy, this de nition puts ! (p;t) = N (a + 2 p;t) N (a;t). In words, the m idpoint shift is half the shift in the best o er. An alternative choice would be to let ! (p;t) = N (p;t), which would include part of the instantaneous spread in the de nition of im pact in m idpoint-centered coordinates, or none of it in ask-centered coordinates. The issue of how im pact is related to N (p;t) is separate from whether the best ask is set equal to the reference point for prices, and m ay be chosen di erently to answer di erent questions.

Under any such de nition, how ever, the impact p is a monotonic function of! in every instance, so either may be taken as the independent variable, along with the index t that labels the instance. We wish to account for the di erences in instance averages hi of! and p, regarded respectively as the dependent variables, in terms of the uctuations of either.

In spite of the fact that the density n (p;t) is a highly discontinuous variable in general, monotonicity of the cumulative N (p;t) enables us to picture a power series expansion for ! (p;t) in p, with coe cients that uctuate in time. The simplest such expansion that captures much of the behavior of the simulated output is

P lugging these into Eq. (A14) gives the predicted m ean price in pact, compared to actual m ean in F ig. 31. Here the m easure used for price in pact is the m ovem ent of the ask from buy m arket orders. The cum ulative order distribution is computed in ask-centered coordinates, elim inating the contribution from the half-spread in the p




FIG.31: C om parison of the inverse m ean cum ulative order distribution p (dot), to the actual m ean im pact (solid), and the second-order uctuation expansion (A 14, dash). (a) : = 0.2. (b): = 0.02. (c): = 0.002.

coordinate. The inverse of the m ean cumulative distribution (dotted), which corresponds to p in Eq. (A14), clearly underestimates the actual m ean impact (solid). However, the corrections from only second-order uctuations in a, b, and c account for much of the di erence at all values of .

2. Quantiles

A nother way to characterize the relationship between depth prole and market in pact is in term softheir quantiles (the fraction greater than a given value, for example the median is the 0.5 quantile). Interestingly, the relationship between quantiles is trivial. Letting $Q_r(x)$ be the r^{th} quantile of x, because the the cumulative depth N (p) is a non-decreasing function with inverse p = (N), we have the relation

This provides an easy and accurate way to compare depth and price in pact when the tick size is su ciently small. However, when the tick size is very coarse, the quantiles are in general not very useful, because unlike the mean, the quantiles do not vary continuously, and only take on a few discrete values.

As we have argued in the previous section, in nondimensional coordinates all of the properties of the limit order book are described by the two dimensionless scale factors and dp=p. (see table (II). When expressed in dimensionless coordinates, any property, such as depth, spread, or price impact, can only depend on these two parameters. This reduces the search space from ve dimensions to two, which greatly simplifies the analysis. Any results can easily be re-expressed in dimensionless parameters.

2. Cataloging correlations

A correct source term S must correlate the incidences of zero occupation with the events producing shifts. It is convenient to separate these into the four independent types of deposition and rem oval.

First we consider rem oval of buy limit orders, which generates a negative shift of the midpoint. Let a^0 denote the position of the ask after the shift. Then all possible shifts p are related to a given price bin p and a^0 in one of three ordering cases, shown in Table V II. For each case, the source term corresponding to [$(p \ p)$ (p)] in Eq. (43) is given, together with the measure of order-book con gurations for which that case occurs. The mean-eld assumption (36) is used to estim ate these measures.

As argued when de ning in the simpler di usion approximation for the source terms, the measure of shifts from removal of either buy or sell limit orders should be symmetric with that of their addition within the spread, which is is 2d p for either type, in cases when the shift

Order addition is treated similarly, except that a denotes the position of the ask before the event. Sell lim itorder additions generate negative shifts, with the cases shown in Table IX. Integration over p consistent with these cases gives the negative-shift contribution to S

The forms (B24) and (B25) do not lead to dpS =0, and correcting this presum ably requires distributing the orders erroneously transported through the m idpoint by the diusion term, to interior locations where they then in uence long-time di usion autocorrelation. These source term s manifestly satisfy S(0) = 0, though, and that determ ines the intercept of the average order depth.

a. Getting the intercept right

Eq. (B27), for the total density, is the same as the form (B6) produced by the diusion solution for the zeroth order density, as should be the case if di usion no longer transports orders through the midpoint. This form is veried in simulations, with midpoint-centered averaging.

Interestingly, the same argument for the bid-centered fram e would simply om it the ' from (0) = (1), predicting that

a result which is not con med in simulations. Thus, in addition to not satisfying the mean-eld approximation, the bid-centered density average appears to receive som e di usive transport of orders all the way down to the bid.

Equations (B 24) and (B 25) are not directly easy to use in a numerical integral. However, they can be Fokker-P lanck expanded to term s with behavior comparable to the di usion equation, and the correct behavior near the m idpoint. Doing so gives the nondimensional expansion of the source term S corresponding to the di usion contribution in Eq. (32):

In the range where the m ean-eld approxim ation is valid, ' is dominated by the constant term (0), and even the factors e $p^{p_0} = e^{p_j}$ can be approxim ated as unity. This leaves the m uch-sim pli ed expansions
