# First-principles calculations of spin spirals in N i2M nG a and N i2M nA 1

W e report here non-collinearm agnetic con gurations in the H eusler alloys N  $i_2$ M nG a and N  $i_2$ M nA l which are interesting in the context of the m agnetic shape m em ory e ect. The total energies for di erent spin spirals are calculated and the ground state m agnetic structures are identi ed. The calculated dispersion curves are used to estim ate the C urie tem perature which is found to be in good agreem ent with experiments. In addition, the variation of the m agnetic m om ent as a function of the spiral structure is studied. M ost of the variation is associated with N i, and sym m etry constraints relevant for the m agnetization are identi ed. B ased on the calculated results, the e ect of the constituent atom s in determ ining the C urie tem perature is discussed.

I. IN TRODUCTION

M aterials showing strong coupling between the magnetic and structural properties are interesting from the technological point of view. Tb-Dy-Fe alloys (Terfenol-D, already in commercial use ) exhibit magnetic eld induced strains of 0.1 % based on the magnetostriction phenom enon<sup>1</sup>. On the other hand, N i-M n-G a alloys close to the N i/M nG a stoichiom etry show strains up to 10 % with m oderate m agnetic  $elds^{2,3,4}$ . The m echanism of this phenom enon, the magnetic shape memory (MSM) e ect, is based on the magnetic-eld-induced movement of structural dom ains (tw in variants) and is di erent from ordinary m agnetostriction<sup>5</sup> . The basic m agnetic properties related to the M SM e ect include the saturation m agnetic m om ent and the m agnetic anisotropy which have been studied earlier for N  $\frac{1}{2}$  M nG  $a^{6,7}$ . Here, we probe deeper into the magnetic properties of Ni2M nG a and an other M SM candidate, N 1/M nA 1, by studying noncollinearm agnetic con gurations which also enables one to consider nite tem perature e ects in a natural way.




FIG.1: Cubic cell of the  $L2_1$  structure, where X is AlorGa. The cubic cell contains four prim it ive cells.

Although one ingredient in the MSM e ect is a structural transform ation (martensitic transform ation) from a cubic structure to a lower-symmetry structure upon cooling, we concentrate here only in the high temperature phase. In this phase N  $i_2$ M nG a has the cubic L2<sub>1</sub> structure (see Fig. 1) as shown by x-ray and neutron di raction m easurem ents<sup>8,9</sup>. The m agnetic order is ferrom agnetic and m ost of the m agnetic m om ent originates from Mn<sup>6,9</sup>. In the stoichiom etric compound the Curie tem perature is about 370 K <sup>9</sup> and decreases when increasing the Nicontent<sup>10</sup>. On the other hand, Ni<sub>b</sub>M nAl is less studied and its structure and magnetic con guration do not seem to be perfectly understood. On the structural side, both L21 and disordered B2 structures are reported<sup>11,12,13,14,15</sup> depending on the therm altreatment. The magnetic con guration is found to be ferromagnetic with Curie temperatures between 300 K and 400 K in Ref. 13 and antiferrom agnetic or spiral in Refs. 11,12. The magnetic moment comes mainly from Mn atom s also in this compound<sup>11,16</sup>. It seems that the

ground state m agnetic con guration depends on the underlying crystal structure. Here we address the possibility of non-collinear m agnetic con gurations in the  $L2_1$  structure.

Although the original formulation of the local-spindensity approximation<sup>17</sup> of density-functional theory allowed non-collinear magnetic order, rst-principles calculations for this aspect have started only recently (for a review see R ef. 18). O ne application has been the study of non-collinear ground states for example in -Fe<sup>19,20,21</sup> or in frustrated antiferrom agnets<sup>22,23</sup>. In addition, the non-collinear formulation enables studies of nite tem perature properties of m agnetic m aterials. As the dom inant magnetic excitations at low temperatures are spin waves which are non-collinear by nature, it is possible to determ ine the magnon spectra and ultim ately the Curie tem perature from st principles<sup>24,25,26,27</sup>. Most of the previous work has been done for elements or com pounds with only one magnetic constituent. We study here system swith severalm agnetic atom s and show how the interaction between di erent magnetic sublattices can give rise to interesting e ects.

The paper is organized as follows. Some general properties of spin spirals are discussed in Sec. II followed by the description of the computational scheme in Sec. III. We study the total energy and magnetization with spiral magnetic orderings and estimate the Curie temperature in Sec. IV and nally we conclude in Sec.V.

### II. GENERAL PROPERTIES OF SPIN SPIRALS

The magnetic conguration of an incommensurate spin spiral shows the magnetic moments of certain atomic planes varying in direction. The variation has a wellde ned period determined by a wave vector q. When the magnetic moment is con ned to the lattice sites the magnetization M varies as

where polar coordinates are used and  $m_n$  is the magnetic moment of atom n with a phase n at the position  $r_n$ . Here, we consider only planar spirals, that is n = -2 which also gives the minimum of the total energy. The magnetization of Eq. (1) is not translationally invariant but transform s as

where R is a lattice translation and D is a rotation around the z-axis. A spin spiral with a magnetization in a general point r in space can be de ned as a magnetic conguration which transforms according to Eq. (2). As the spin spiral describes a spatially rotating magnetization, it can be correlated with a frozen magnon.

Because the spin spiral breaks the translational symm etry, the B bch theorem is no m ore valid. C om putationally, one should use large supercells to obtain total energies spin spirals. However, one can de ne generalized translations which contain translations in real space and rotations in spin space<sup>28,29</sup>. These generalized translations leave the m agnetic structure invariant and lead to a generalized B bch theorem. Therefore the B bch spinors can still be characterized by a k-vector in the B rillouin zone, and can be written as

The functions  $u_k(r)$  and  $d_k(r)$  are invariant with respect to lattice translations having the same role as for norm al B both functions. D ue to this generalized B both theorem the spin spirals can be studied within the chem ical unit cell and no large supercells are needed.

A lthough the chem ical unit cell can be used, the presence of the spin spiral lowers the symmetry of the system. Only the space group operations that have invariant the wave vector of the spiral remain. When considering the general spin space groups, i.e. taking the spin rotations into account, the space group operations which reverse the spiral vector together with a spin rotation of around the x-axis are symmetry operations<sup>29</sup>.

Basically, the spin spiral relates only the magnetizations in the di erent prim itive cells. How ever, the sym metry properties constrain the magnetization which we discuss here in the context of the  $L2_1$  structure. The prim it ive cell of the L21 structure (one fourth of the cubic cell shown in Fig. 1) contains four atoms, two Ni, one M n and one G a or A l atom . In the full cubic sym metry the two Ni atoms are equivalent but this equivalence can be broken when the spin spiral lowers the symmetry of the system. If the spiral wave vector is in the [111] direction the two Ni atoms are no longer equivalent under space group operations. Considering also the spin rotations, the phases n of the two Ni m agnetizations are opposite as the atom s are related by space inversion. If the two Ni atom s are treated equivalent (when allowed by the spiral symmetry) are constrains for the phases of Nim om ents even stronger. If the magnetic moments of N iw ithin the primitive cellare M  $(r_1) = m_1 \cos(1) = M (r_2)$ , the magnetic moment in the neighbouring cell at  $r_1$  is M ( $r_1$ ) = m<sub>1</sub>cos( $_1$ ). On the other hand, the Niatom s at  $r_1$  and at  $r_2$  are connected by a lattice translation, so that according to Eq. (2) M  $(r_2) = m_1 \cos(1 + q R)$  and one has the re- $_1 + q$  R for the phase. In order to obtain lation  $_1 =$ the true m in im um energy con guration it m ay be necessary to treat the Niatom sas inequivalent (i.e. lower the symmetry of the system) so that the above relation for the phase do not have to hold.

#### III. COMPUTATIONALMETHOD

The spin spirals discussed in section II are studied within the density-functional theory. We use the full-potential linearized augmented-plane-wave method (FLAPW ) method<sup>30</sup> in an implementation which allows non-collinear magnetism including spin spirals<sup>31,32</sup>. In addition to the full charge density and to the full potential, the fullm agnetization density is used. The m agnetic m om ent is allowed to vary both in m agnitude and in direction inside the atom ic spheres as well as in the interstitial regions. The plane wave cut-o for the basis functions is  $RK_{max} = 9$ , leading to 350 plane waves with the mu n-tin radii 225 a.u. Brillouin zone integrations are carried out with the special point m ethod using 800 kpoints in the fullB rillouin zone and a Ferm ibroadening of 0.005 Ry. For the exchange-correlation potential we use both the local-spin-density approximation  $(LSDA)^{17}$  and the generalized gradient approximation  $(GGA)^{33}$  which we discuss next in m ore detail.

# A. LSDA vsGGA

It has been pointed out that the use of GGA is bene cial in the context of N  $i_2$ M nG  $a^{6,16}$ . Because there has been some discussion about the di erent exchangecorrelation potentials in the context of non-collinearm agnetism, we present som e com parison also here.

A though there is no global spin quantization axis, one can consider at every point of space a local coordinate system such that the magnetization at that point is in the z-direction. As the LSDA depends only on the magnitude of the magnetization, the exchange-correlation potential can be calculated at every point in the local coordinate system as in the usual collinear case. The noncollinear potential is obtained by rotating back to the global fram e of reference. On the other hand, the GGA depends also on the gradients of magnetization. Because the magnetization direction may vary, only projections of the magnetization on the local quantization axis are used in the standard GGA when evaluating the gradients. If the magnetization direction varies slow ly this should not bring any problem s. Som e previous work has suggested that the disagreem ents between theory and experim ent are due to projection errors in some cases<sup>20</sup>. However, later work has corroborated that the main issue is not the exchange-correlation functional but the actual com putationalm ethod, pointing to the importance of all-electron and full-m agnetization treatm  $\mathrm{ent}^{21,34,35}$  .




FIG.2: Total energy as a function of the spiral vector q in units of 2 = a. LSDA, GGA.

W e have done all the calculations in this work both with LSDA and with GGA. The total energy as a function of the spiral wave vector length in N  $i_2$ M nG a is shown in Fig. 2 for a single direction. One can see that for sm all

q both approxim ations give sim ilar results. W ith larger q the results di er slightly but the sam e qualitative behaviour is seen. For the other results presented in the following sections the qualitative behaviour is also the same for LSDA and GGA, and the quantitative di erences between the two approximations are even smaller. Therefore, only the GGA results are discussed in the following.

#### IV. RESULTS AND DISCUSSION

# A. Total energies




FIG.3: Total energy as a function of the spiral vector q. N  $\rm \dot{k}M$  nA l, N  $\rm \dot{k}M$  nG a.




FIG.4: Total energy as a function of the spiral vector q. Ni2M nAl, Ni2M nGa. a) Ni atom s are equivalent, b) Ni atom s are inequivalent. Vertical line denotes the Brillouin zone boundary.

F irst, we have studied the possibility of non-collinear ordering by studying the energetics of spiral con gurations. This study also provides information about nitetem perature properties. The total energy is calculated as a function of the spiral wave vector q, and the wave vector is varied along the high sym metry directions [001], [110] and [111]. q is given in units of 2 = a where a is the theoretical lattice constant of the L2<sub>1</sub> structure<sup>16</sup>. The corresponding total energies are shown in Figs. 3 and 4.

Fig. 3 shows that the variation of total energy in [001] and [111] directions is sim ilar in N  $\frac{1}{2}$ M nG a and N  $\frac{1}{2}$ M nA l for all values of q. The lowest energy in all cases is at q = 0 w hich is the norm alcollinear ferrom agnetic con guration. Both m aterials have sm all m inim um at the antiferrom agnetic con guration at q = (0 0 1), but at other antiferrom agnetic con guration at q = (0 5 0 5 0 5) there are no m inim a.

The energy in the [110] direction is also sim ilar for both m aterials as seen in Fig. 4. Here, the e ect of sym metry constraints can be seen clearly. If the two N i atom s are equivalent the energy is higher especially around  $q = (0.5\ 0.5\ 0)$ . W hen the magnetic moments of the two N i are allowed to relax independently the energy lowers

and the dispersion becomes at after  $q = (0.5 \ 0.5 \ 0)$ . Near the Brillouin zone boundary at  $q = (0.75 \ 0.75 \ 0)$  both materials show small energy minima corresponding to incommensurate spiral order. At the antiferrom agnetic con gurations at  $q = (1 \ 1 \ 0)$  there are no clear energy minima even though in the case of N i<sub>2</sub>M nA l the dispersion is very at.

Generally, the spin spirals are related to magnons which allows the estimation of magnon-related properties, such as spin sti ness and Curie temperature, from the total energies calculated above. The total energy of the planar spin spiral is related to the magnon energy  $!_q$  as<sup>24,26</sup>

where M is the magnetic moment per unit cell. In the low q lim it the magnon dispersion is quadratic, and one de nes the spin sti ness constant D as

From the calculated total energies in Figs. 3 and 4 we can estim ate the same spin sti ness for both materials which is  $D = 77 \text{ mRy au}^2$ . This in good agreement with the experimental value 79 mRy au<sup>2</sup> measured in N i-M n-G a lm s<sup>36</sup>.

The Curie temperature can be estimated on the basis of the Heisenberg model. By mapping the rst-principles results to the Heisenberg model, the Curie temperature  $T_{\rm C}$  in the random phase approximation is given by<sup>27,37</sup>

where V is the unit cell volume, and the integration is over the Brillouin zone. An estimation can be obtained using the quadratic dispersion, Eq. (5) and carrying out the integration over a sphere having the same volume as the Brillouin zone. This results in

where  $q_i = (6\ ^2\text{=V}\)^{1=3}$ . By using the calculated spin sti ness constant we obtain  $T_C = 830$  K which is clearly an overestimate. As seen in Figs. 3 and 4 the dispersion curve E (q) deviates strongly from the quadratic behaviour with larger q. A better estimate can be obtained by considering the dispersion quadratic up to some radius and constant thereafter. Based on the calculated energies in Figs. 3 and 4 the constant is chosen to be 5 mRy when  $q > 0.7q_i$ . The Curie temperature obtained in this way is  $T_C = 485$  K which compares well with the experimental one 380 K.

### B. M agnetic m om ents




FIG. 5: M agnetic m om ents within the atom ic spheres as a function of the spiral vector q. N  $i_2$ M nA l, N  $i_2$ M nG a.a) N iatom s are equivalent, b) N iatom s are inequivalent




FIG.6: M agnetic m om ents within the N isphere as a function of the spiral vector q. N  $\frac{1}{2}$  M nA l, N  $\frac{1}{2}$  M nG a.

In order to obtain a deeper understanding of the energy dispersion we next look into the behaviour of magnetization. The magnetic moments averaged over the atom ic spheres for di erent q are shown in Figs. 5 and 6. The atom ic magnetizations show that within the M n spheres the magnetization is nearly constant and the variation in the total magnetization is mainly due to Ni. Also, the symmetry consideration of the equivalence of Ni atoms has no e ect on the M n m om ent. This points to a m ore localized character of the magnetic moment of Mn, com pared to a more it inerant character of N i. Because most of the totalm agnetic m om ent com es from Mn, these alloys can be considered as localized-m om ent system s consistent with the traditional view for similar materials<sup>38</sup>. However, despite the relative sm allness of its m agnetic m om ent, N i has signi cant e ect for the energetics as discussed later on. The di erences between N ipM nG a and N 1/M nA lare sm all: the magnetic moment in N 1/M nG a is slightly larger as shown already in previous work<sup>16</sup>.

As the magnetic moment in Nishows a larger variation, the behaviour of the Nimoment is analyzed in m ore detail for several directions. The m agnetization decreases m onotonously both in the [001] and in the [111] directions. D i erences are at the antiferrom agnetic congurations as the magnetic moment of Niremains nite at  $q = (1 \ 1 \ 1)$  but vanishes at  $q = (0 \ 0 \ 1)$ . In the [110] direction, the behaviour of the N im om ent depends strongly on the sym m etry as seen in Fig.5.W hen the two m agnetic m om ents are forced to be the sam e, the m agnetization starts to decrease with increasing g and vanishes to zero value at q = (0.50; 50). For larger q values the m om ent shows a sm all peak before decreasing again to zero in the antiferrom agnetic state at  $q = (1 \ 1 \ 0)$ . In the case of Ni atom s being inequivalent only a monotonous decrease sim ilar to the [001] direction is seen.

Because most of the variation in total magnetization is due to N i, it should have a larger e ect also on the energy dispersion. The importance of N i can be seen most clearly in the [110] direction for the cases of di erent symmetry. The symmetry a ects only N i as seen in the behaviour of the magnetization, F ig. 5. A s the energy dispersion depends on the symmetry, F ig. 4, the importance of N i is clear. It can be noted also that the energy lowers when the N immoment increases. Based on the above reasoning, N i should have an e ect on the C urie tem perature, which indeed is seen in experiments where the increase in N i content decreases the C urie tem perature<sup>10</sup>.




FIG. 7: Schematic view of the magnetic moments in the nearest neighbour Mn atoms of Niata)  $q = (0 \ 0 \ 1) b)$  $q = (0.5 \ 0.5 \ 0.5).$

The variation of the N im om ent can be understood by

considering symmetry arguments and the coordination around Niatoms. In the [001] direction two of the four M n atom s neighbouring N i have the sam e m agnetization direction in the spiral and the other two have di erent direction, as shown schem atically in Fig. 7 (a). The m agnetization in N i favours ferrom agnetic alignm ent with the neighbouring M n m om ents so that part of the N im om ent can be thought to align with one group of the M n neighbours and part with the other group. The totalm om ent within the atom ic sphere is average of these two parts and the N im om ent decreases when the angle between the M n m om ents increases. In the antiferrom agnetic con guration there is a complete frustration of the Niatom s which results in the zero average magnetization within the sphere. For the [111] direction shown in Fig. 7 (b) one group contains three M n atom s and the other group only one. Therefore the variation of the average m om ent in the Nisphere is smaller and the moment remains nite in the antiferrom agnetic con guration.




FIG. 8: Schematic view of the magnetic moments in the nearest neighbour Mn atoms of the two equivalent Ni at q = (0.5 0.5 0).

In the [110] direction the situation is more complex especially when the two N iatom s are treated as equivalent. In the antiferrom agnetic con guration the coordination is sim ilar to the case of the [001] direction. There are two groups of neighbouring M n with antiparallelm agnetization, and the frustration leads to zero average m om ent within the Nisphere. The Nim om ent is, how ever, zero also at  $q = (0.5 \ 0.5 \ 0)$ . At this point there are three groups of equivalent M n neighbours. One group contains two Mn atoms and the other groups contain one M n atom . The magnetic m om ents of single M n atom s are antiparallel to each other and have 90 angle with respect to the moments in the group of the two M n atom s. The other equivalent Ni atom has three similar groups of neighbouring M n as the rst N i. The important point is that the moments in the group with two Mn atoms are antiparallel to those in the corresponding group of the rst Ni, as seen in Fig. 8. There is now frustration for N i, but only when both equivalent N i atom s and their neighbours are taken into account. This frustration causes the magnetic moment around Nito vanish com pletely in contrast to the antiferrom agnetic case, where a small m om ent rem ains near Nibut averages to zero. W hen the Niare inequivalent, they can relax according the local environm ent so that a nite m om ent can rem ain




FIG.9: M agnetization density around N i in the (001) plane with  $q = (1 \ 1 \ 0)$ . The width and the height of the area are 2.5 a.u. while m agnetization is in arbitrary units.

A n example of the magnetization density for the case where nite magnetic moments near the N i atom average to zero is seen in Fig.9. Here the magnetization direction can change its sign within the atom ic sphere. This nding shows the importance of the full magnetization treatment when dealing with several magnetic sublattices.

# V. CONCLUSIONS

W e have studied non-collinearm agnetic con gurations in the temary alloys N  $\frac{1}{2}$ M nG a and N  $\frac{1}{2}$ M nA l with rstprinciples calculations. The calculations show that the m agnetic properties are similar for both m aterials. The ferrom agnetic con guration is the ground state in the L2<sub>1</sub> structure, so that the experim entally observed antiferrom agnetism of N  $_{2}$ M nA l is related to structural disorder. The calculated total energies are used to estim ate the spin sti ness constant and the C urie tem perature which are in good agreem ent with the experim ents. The sim ilarity in the energy dispersion for both m aterials suggests that the C urie tem peratures should be also sim ilar. In the [110] direction N  $_{2}$ M nA l has higher energy, so that the C urie tem perature should be a slightly higher.

The variation of the magnetic moment in the spirals shows that the M n moment is nearly constant while the N i moment varies strongly. The symmetry of the spin spiral constrains the direction of magnetization, and as N i favours ferrom agnetic coupling with M n, there can be frustration at certain wave vectors resulting in the vanishing of the magnetic moment near the N isites. It is also shown how there can be strong variation in the direction of the magnetization near the atom ic sites which points to the relevance of the full magnetization treatment.

Som e conclusions can be made concerning the role of the constituent atom s for the magnetic properties. As the magnetic moment of Nivaries strongly and its symmetry a ects the energy considerably, Nihas probably a strong e ect on the energy dispersion especially when larger wave vectors are involved. Therefore Nialso inuences the Curie tem perature. If one assum es that the spin stiness is mainly due to Mn, and the lowering of the energy with larger wave vectors due to Ni, Nilowers the Curie tem perature from 830 K to 485 K within the present approximations. As the increase in the Ni m om ent decreases the energy it is suggested that in order to increase the Curie tem perature one should replace som e N i, perhaps a little counter-intuitively, with som e non-magnetic element, for example Cu. Further experiments should clarify these issues and con m the above suggestions.
